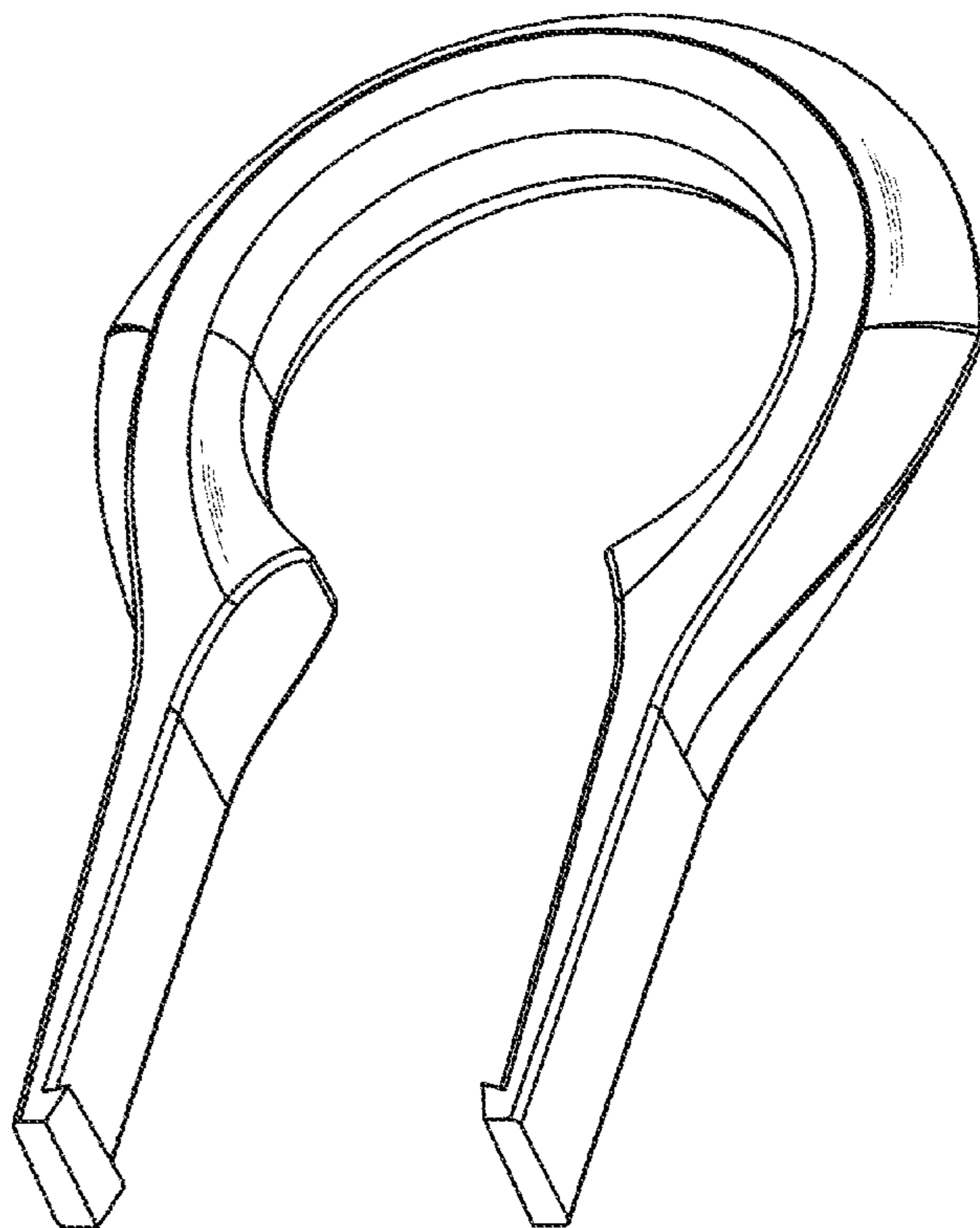
(57) **CLAIM**

We claim an ornamental design for a keycap puller, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a keycap puller showing the claimed design;
FIG. 2 is another perspective view of FIG. 1;
FIG. 3 is a front elevational view of FIG. 1, and a rear elevational view being a mirror image of FIG. 3;
FIG. 4 is a right side elevational view of FIG. 1, and a left side elevational view being a mirror image of FIG. 4;
FIG. 5 is a top plan view of FIG. 1; and,
FIG. 6 is a bottom plan view of FIG. 1.

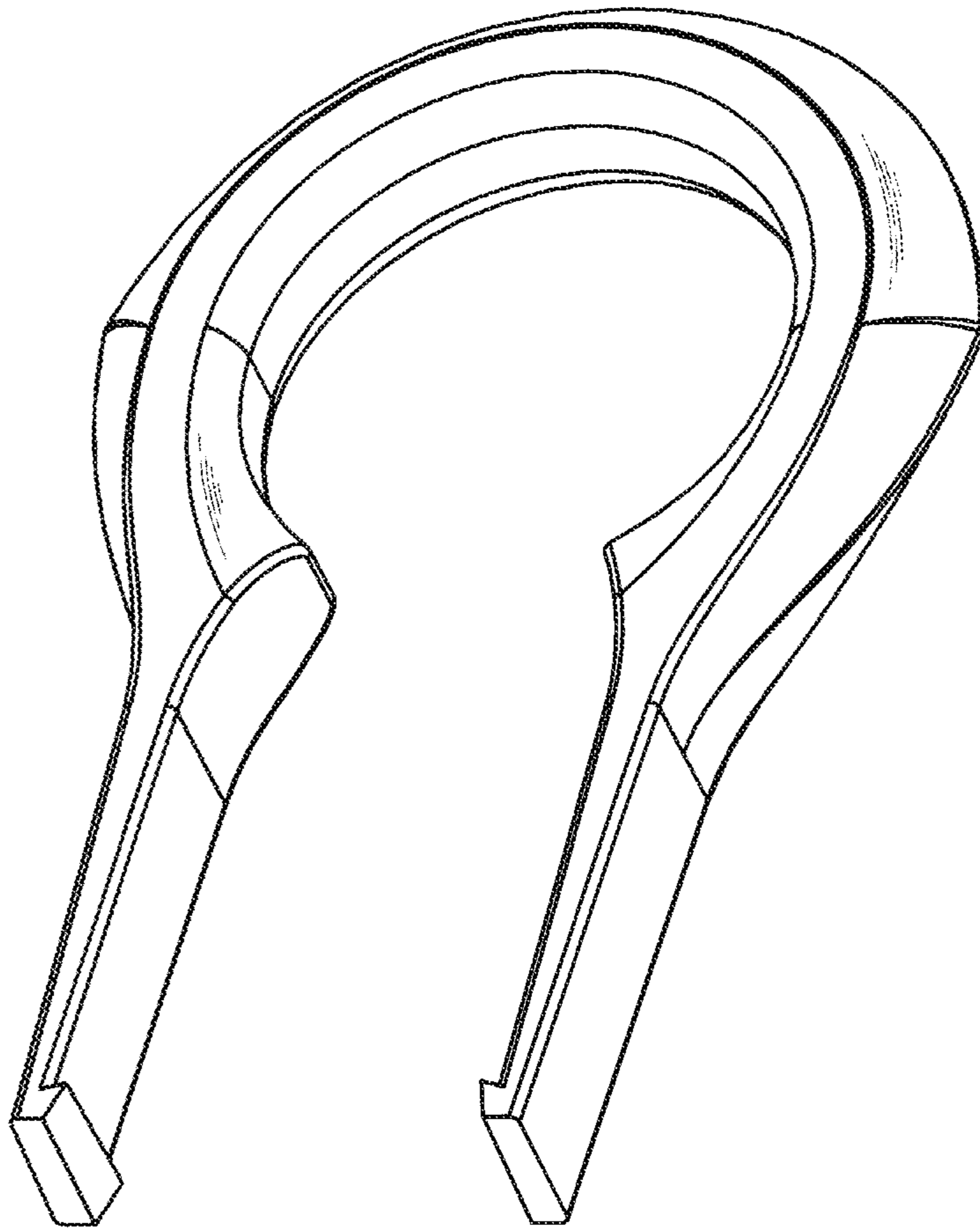

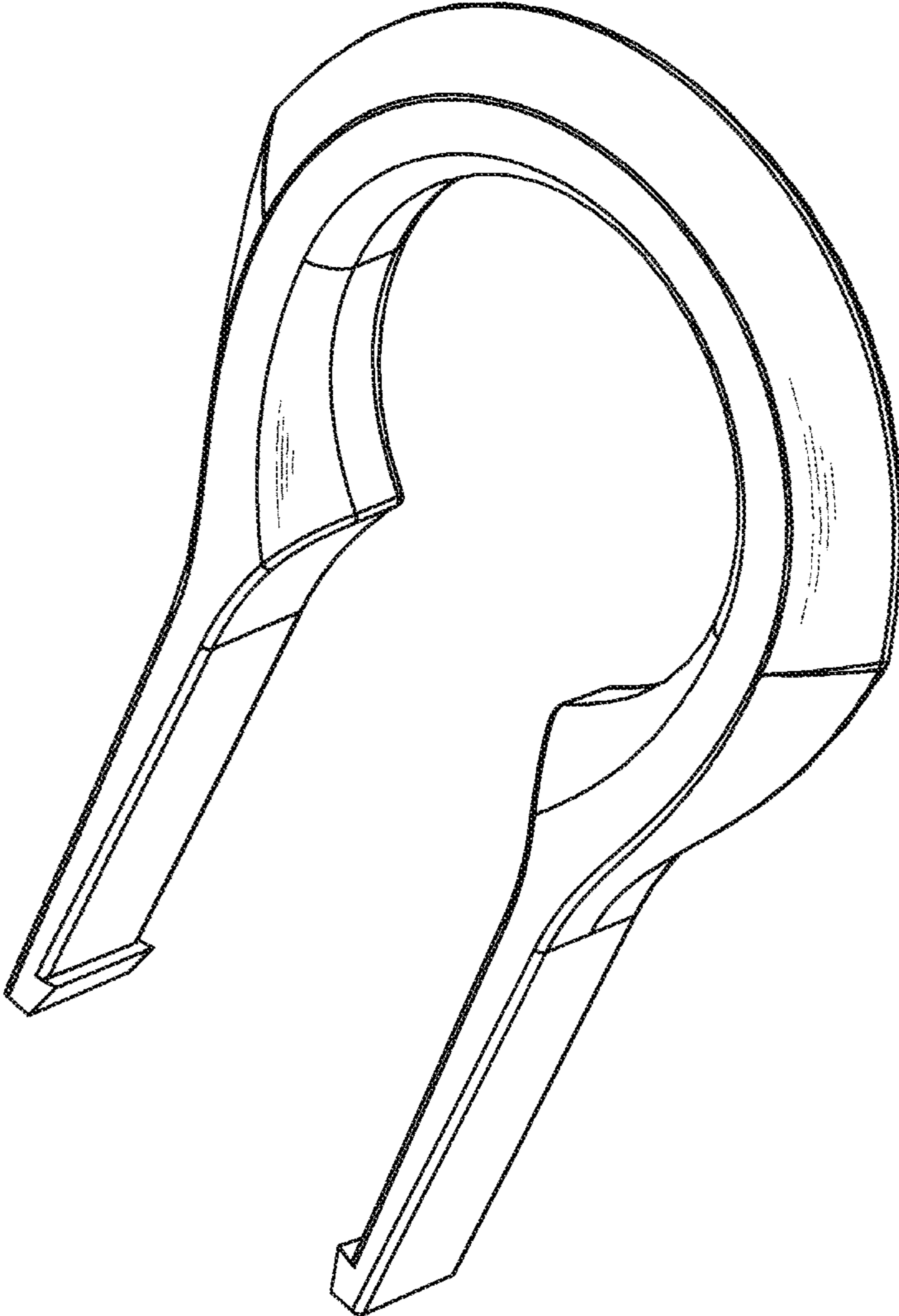

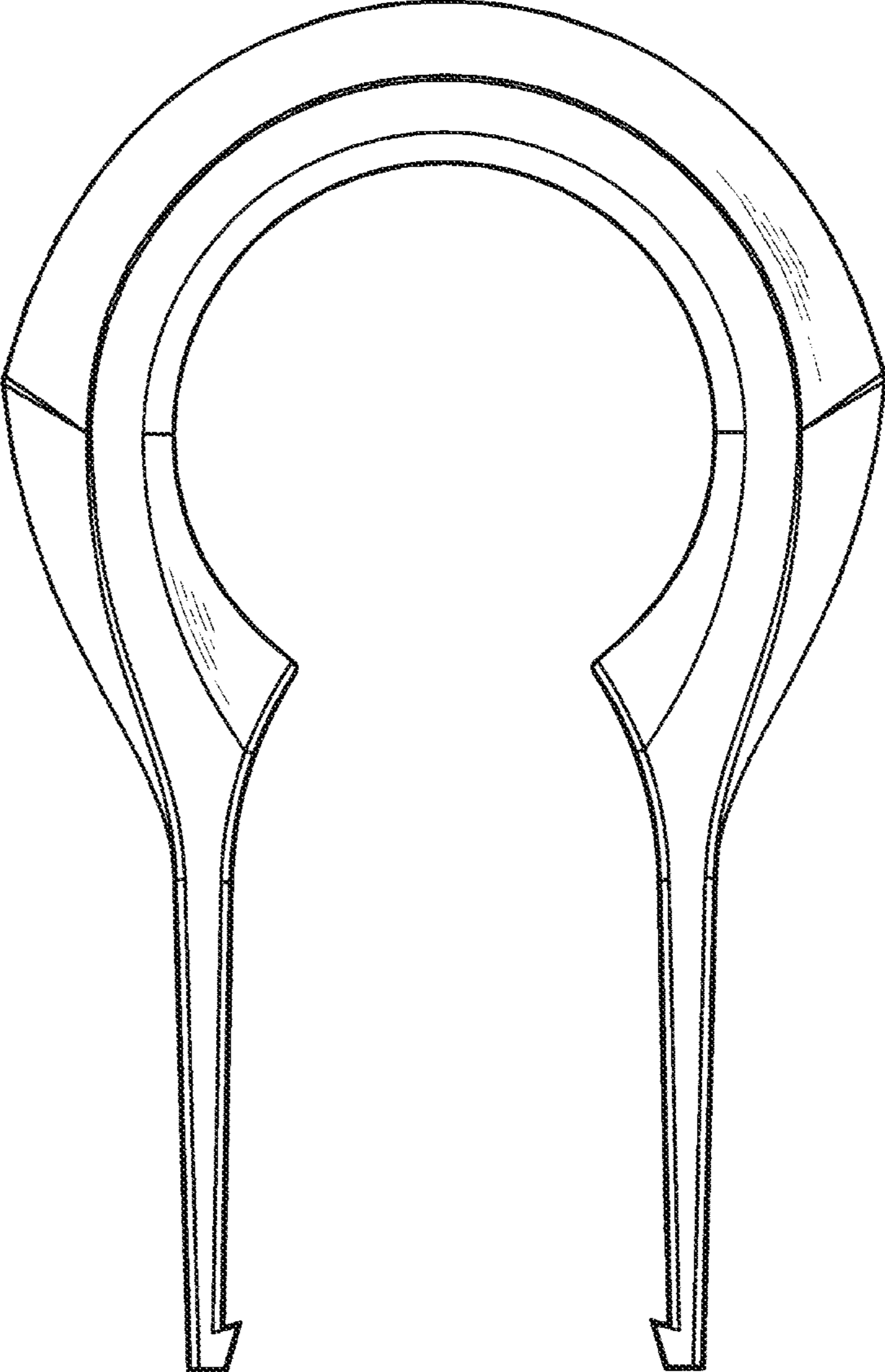

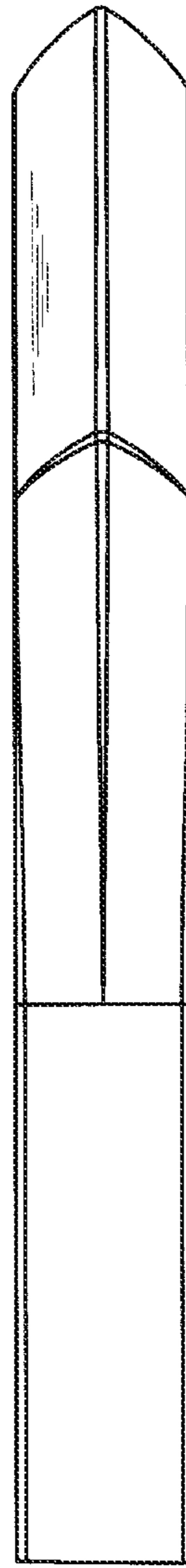

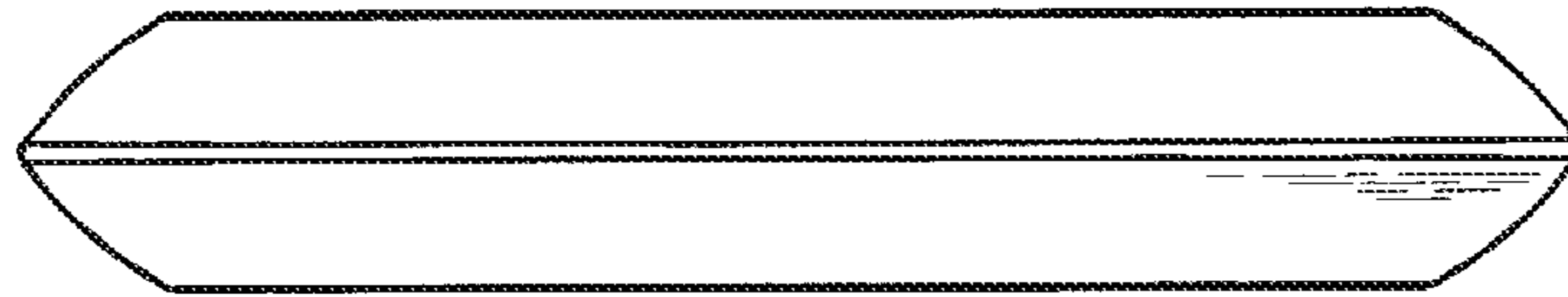

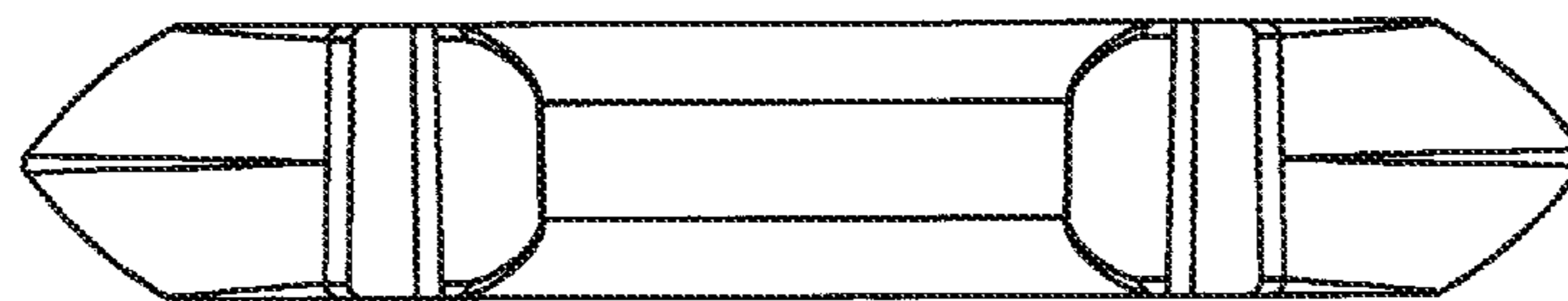
