(57) **CLAIM**

The ornamental design for a tire, as shown and described.

DESCRIPTION

FIG. 1 is a front, left side perspective view of a tire showing our new design;
 FIG. 2 is a front elevation view thereof;
 FIG. 3 is a left side view thereof;
 FIG. 4 is a partial enlarged front view taken from FIG. 2;
 FIG. 5 is an enlarged fragmentary front detail view of the tire of FIG. 2, showing the central circumferential tread rib removed from the tire for clarity of disclosure;
 FIG. 6 is an enlarged fragmentary front detail view of the tire of FIG. 2, showing a central right cleat, shown removed from the tire for clarity of disclosure;
 FIG. 7 is an enlarged fragmentary front detail view of the tire of FIG. 2, showing an exemplary spike hole as found in the central circumferential portion of the tire; and,
 FIG. 8 is an enlarged fragmentary front detail view of the tire of FIG. 2, showing an exemplary spike hole as found in the shoulder block portions of the tire.

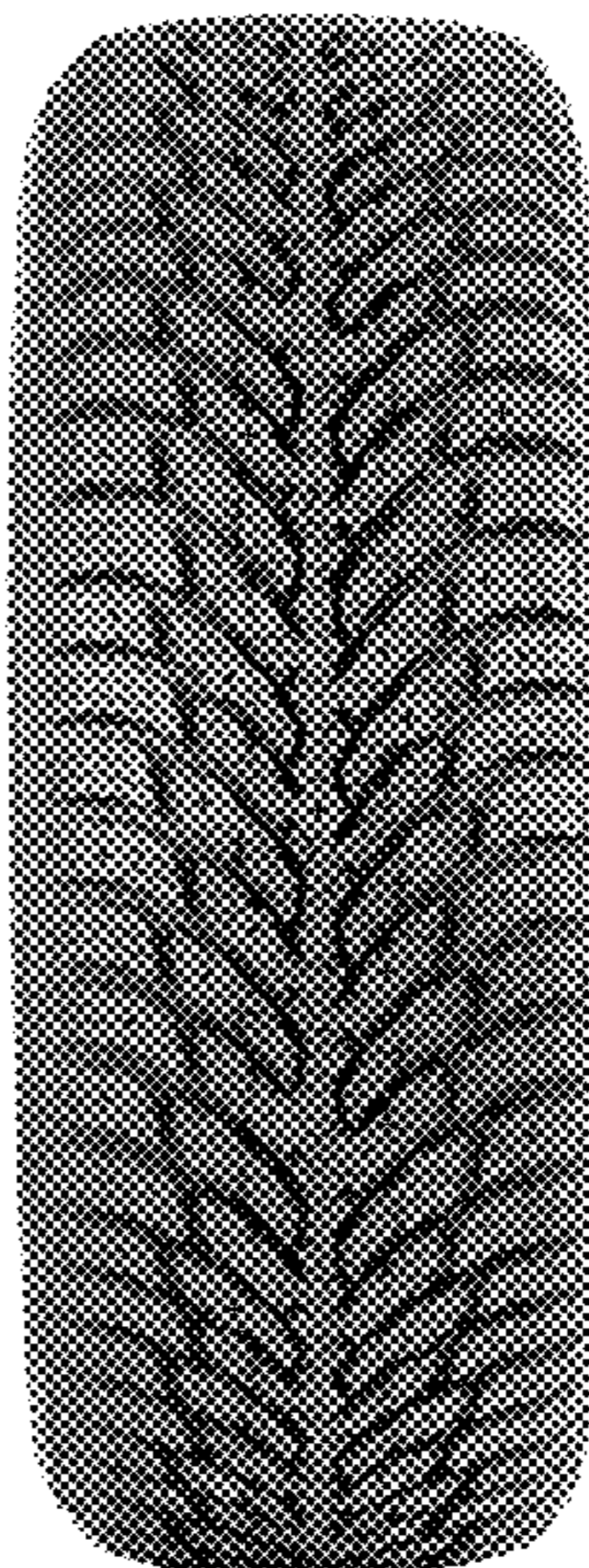

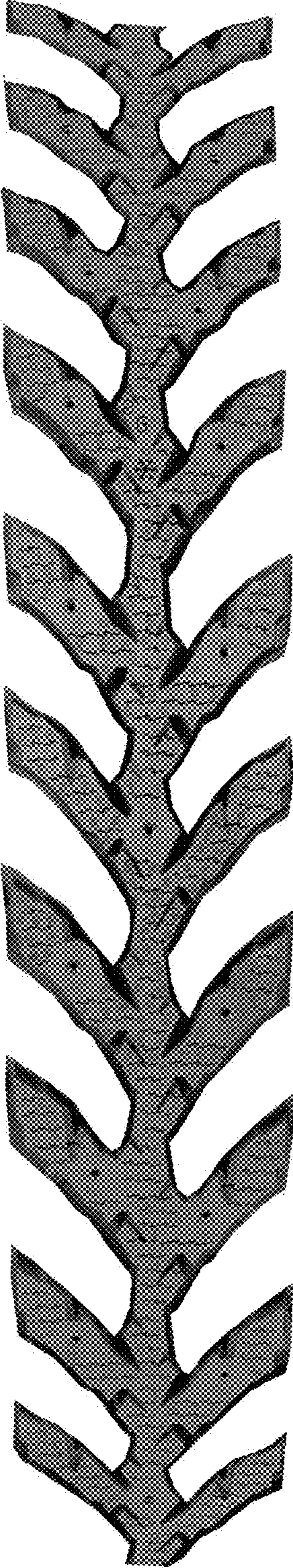

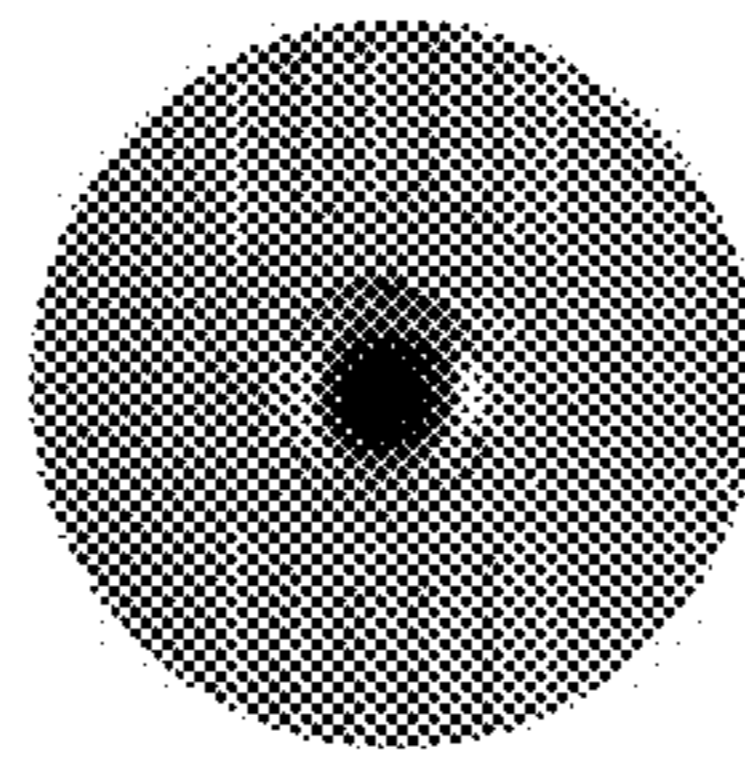
