(57) **CLAIM**

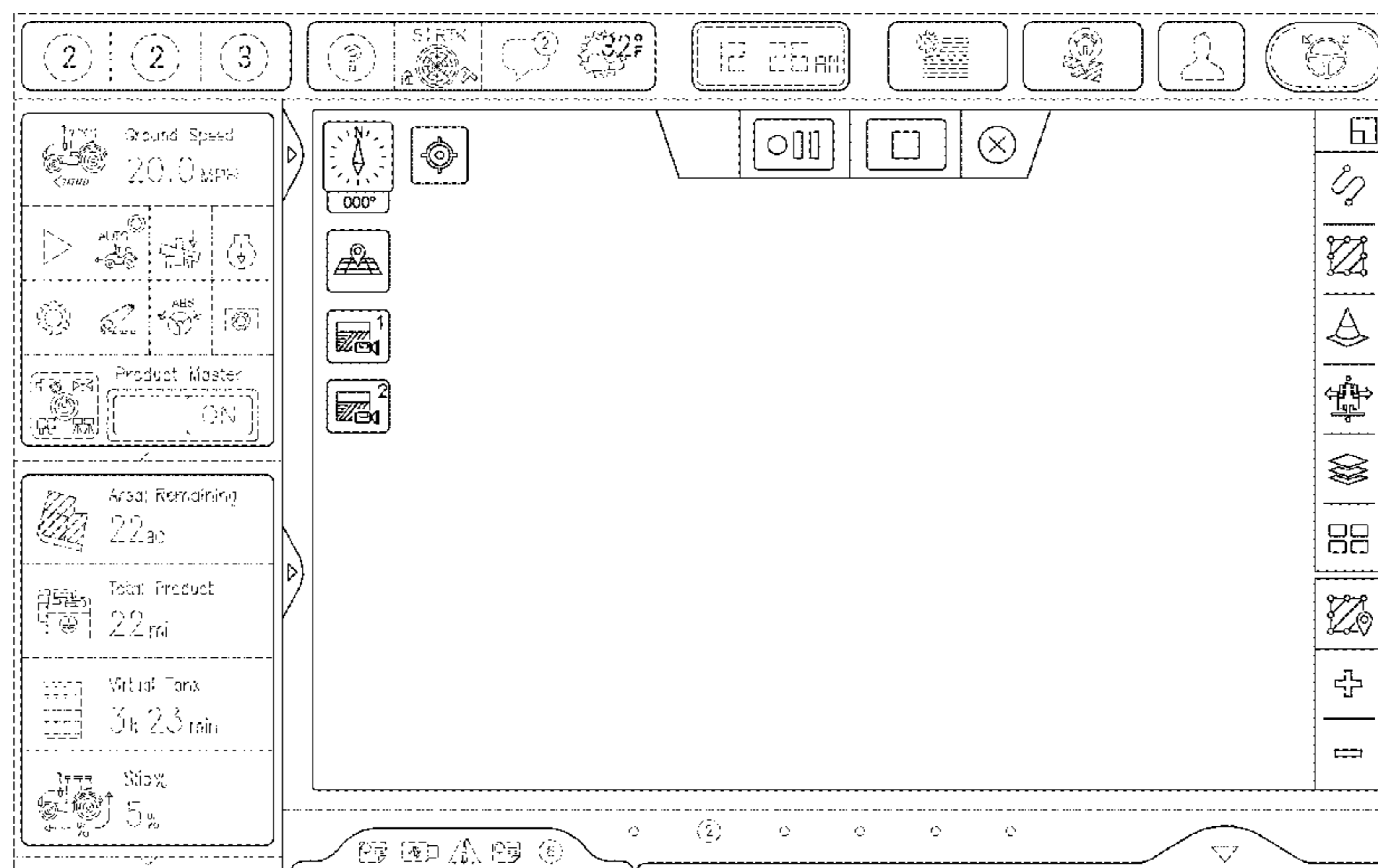
The ornamental design for a display screen with software application graphical user interface window, as shown and described.
