(57) **CLAIM**

The ornamental design for a video book, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the video book showing my new design, the video book shown in a partially open configuration;

FIG. 2 is another front perspective view of the video book shown in a further opened configuration;

FIG. 3 is another front perspective view of the video book shown in a substantially closed configuration;

FIG. 4 is a right side view of FIG. 3;

FIG. 5 is a left side view of FIG. 3;

FIG. 6 is a top plan view of FIG. 3;

FIG. 7 is a bottom plan view of FIG. 3;

FIG. 8 is a front elevational view of FIG. 3; and,

FIG. 9 is a rear elevational view of FIG. 3.

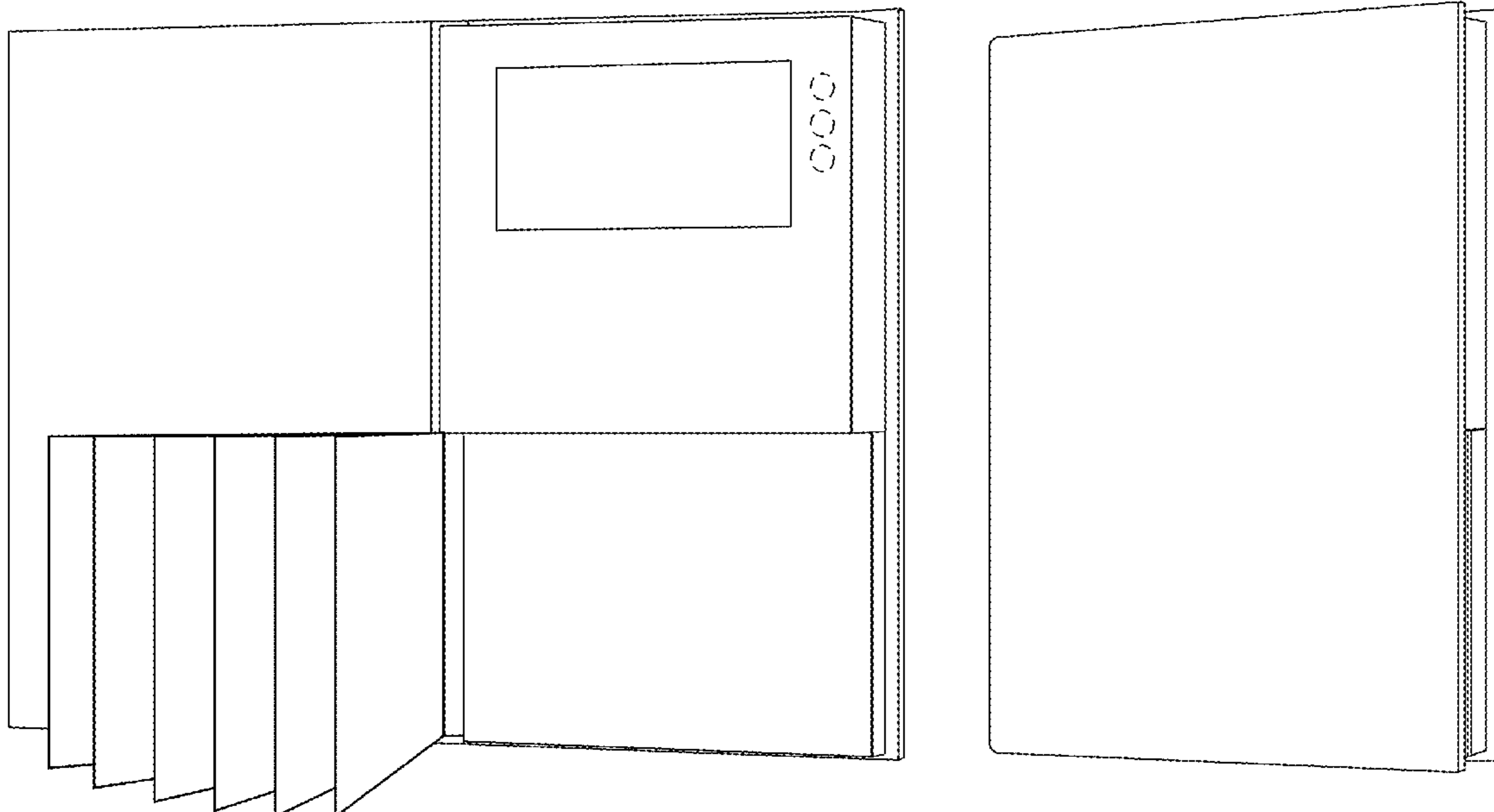

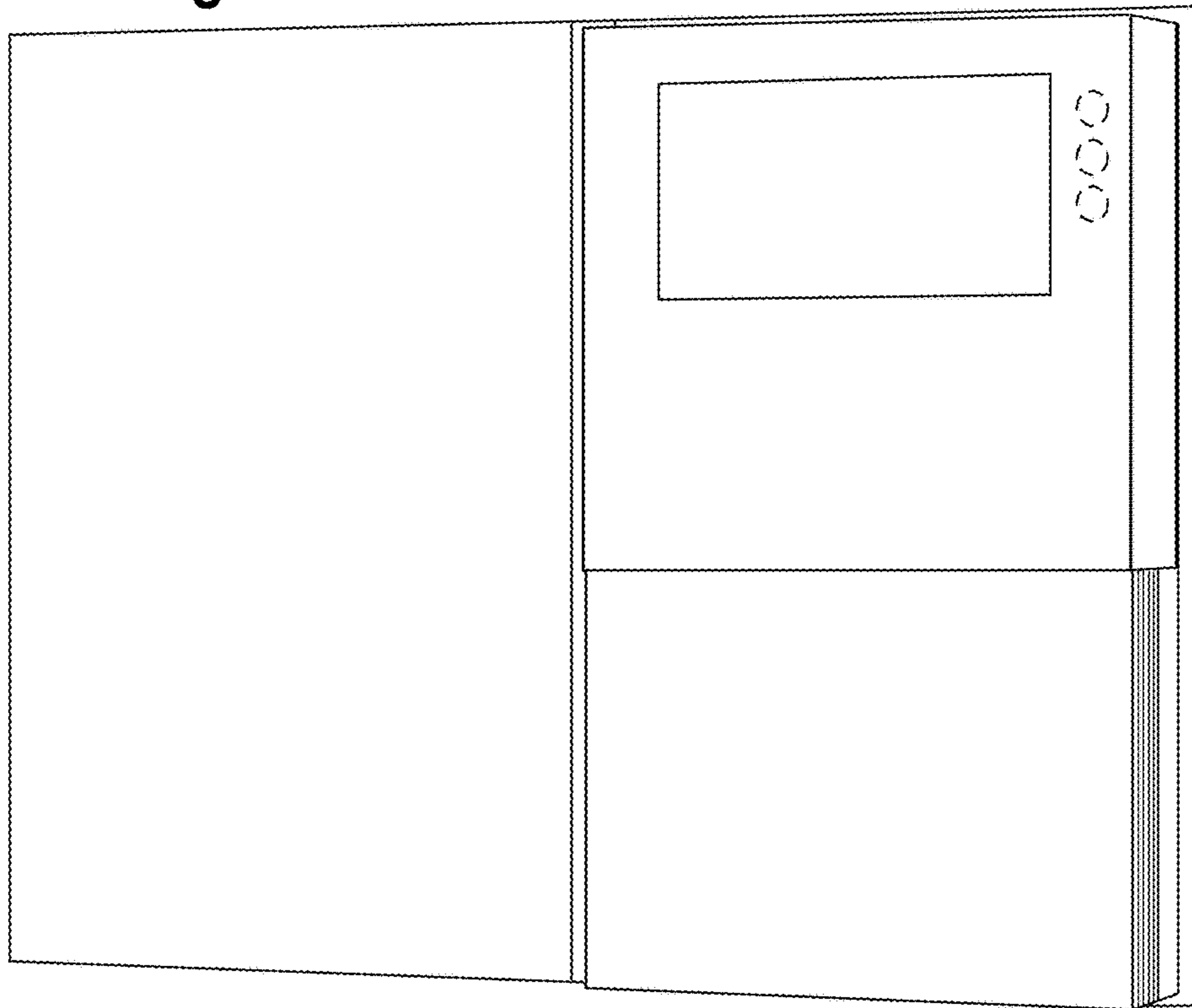

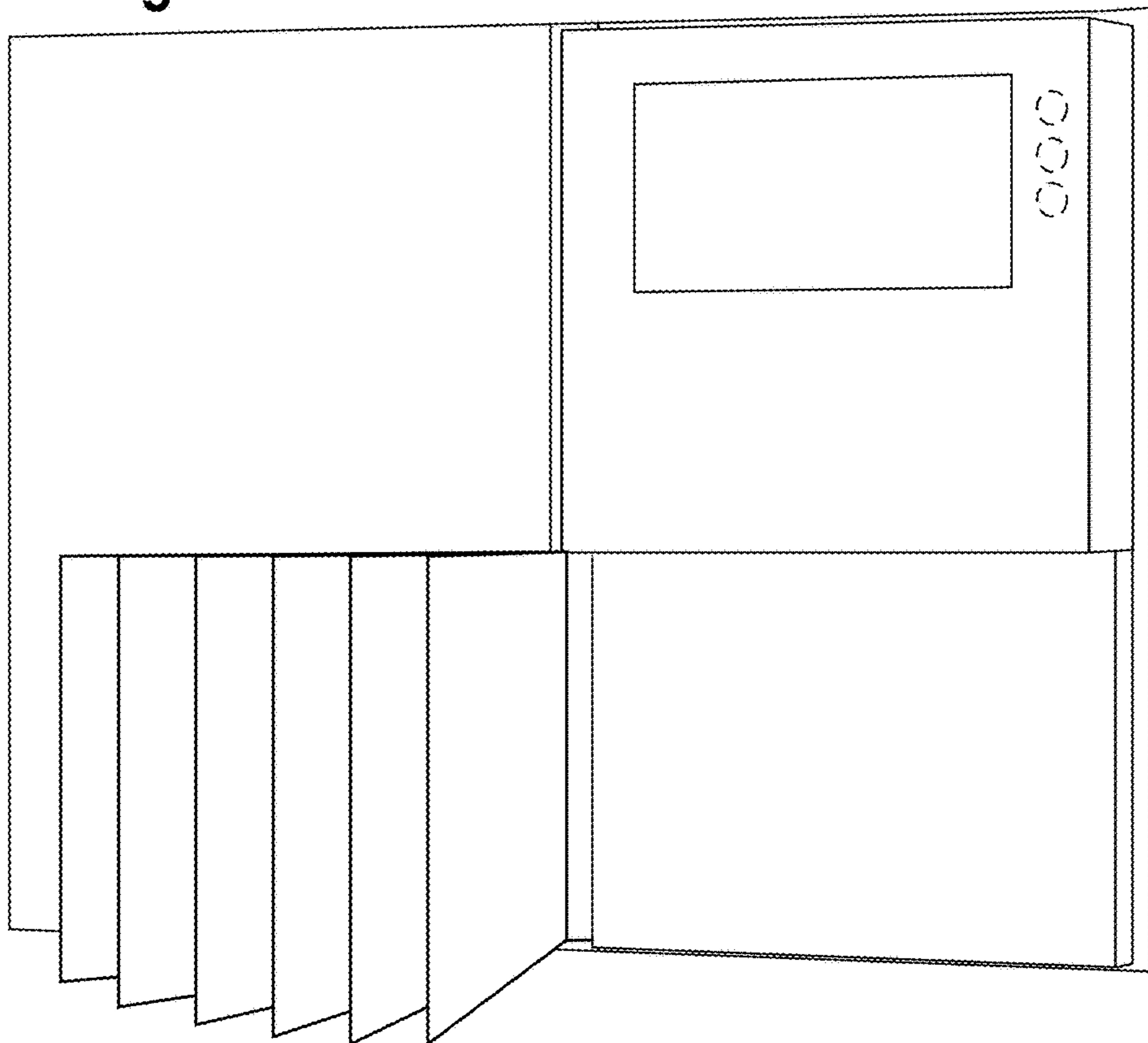

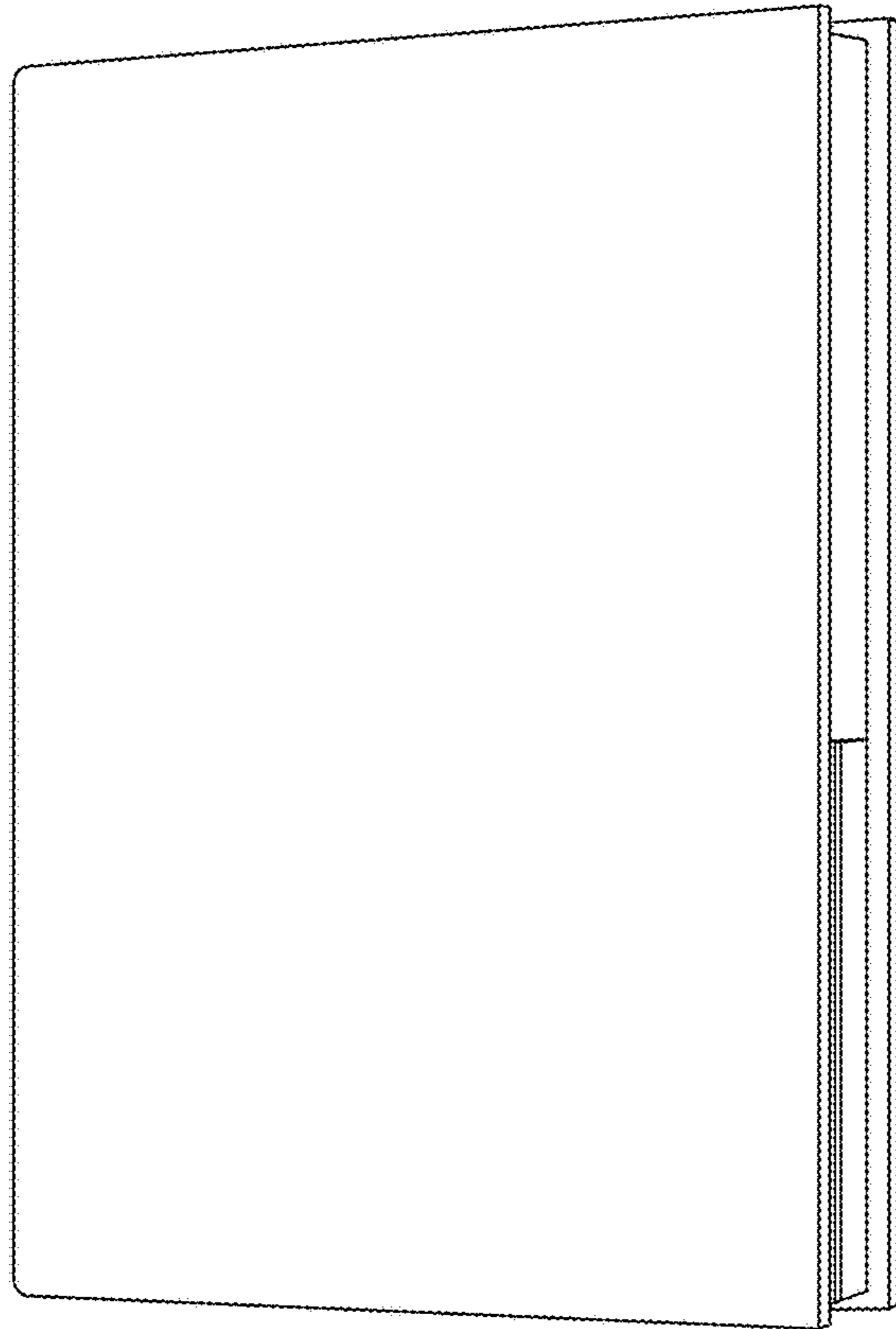

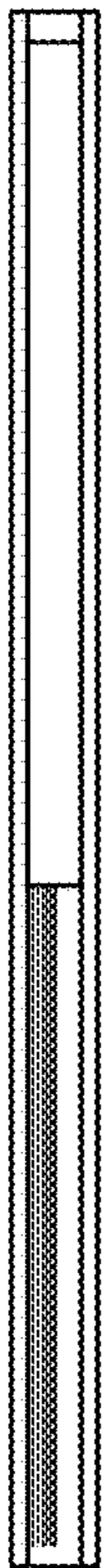

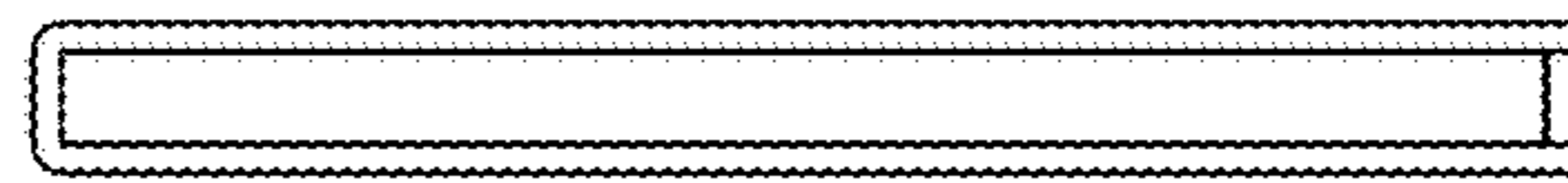

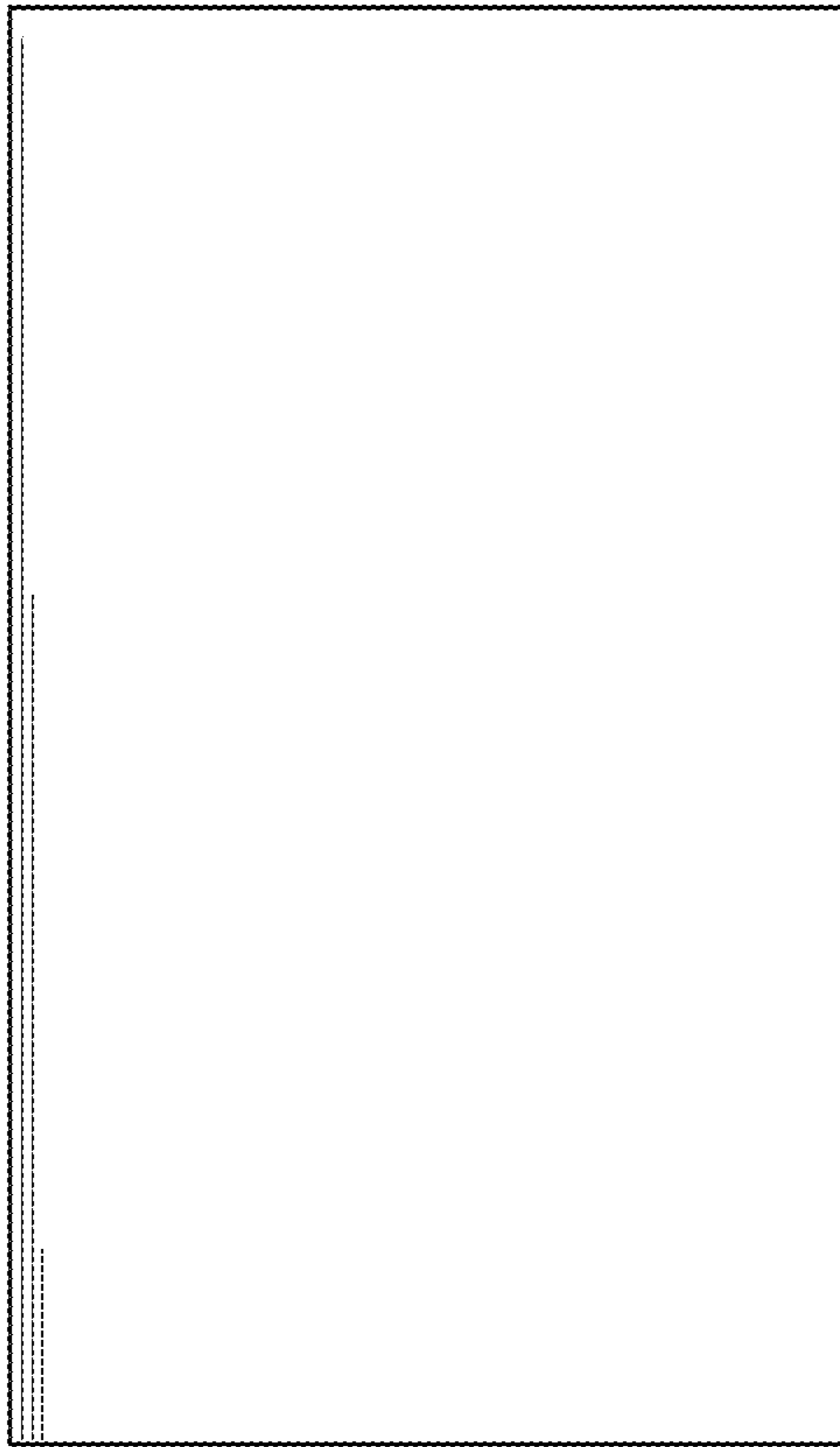
