The ornamental design for a removable patch holder, as shown and described.

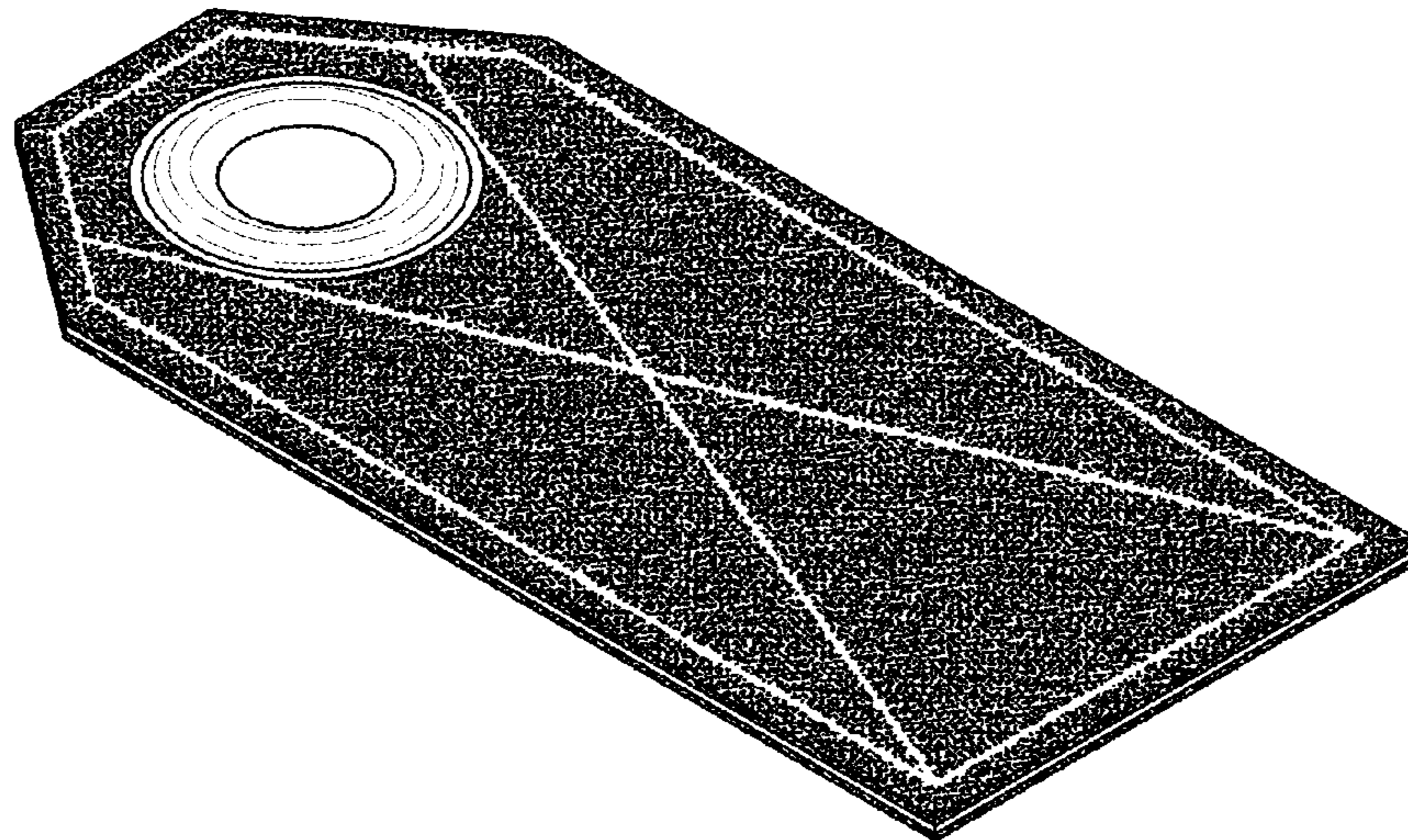
DESCRIPTION

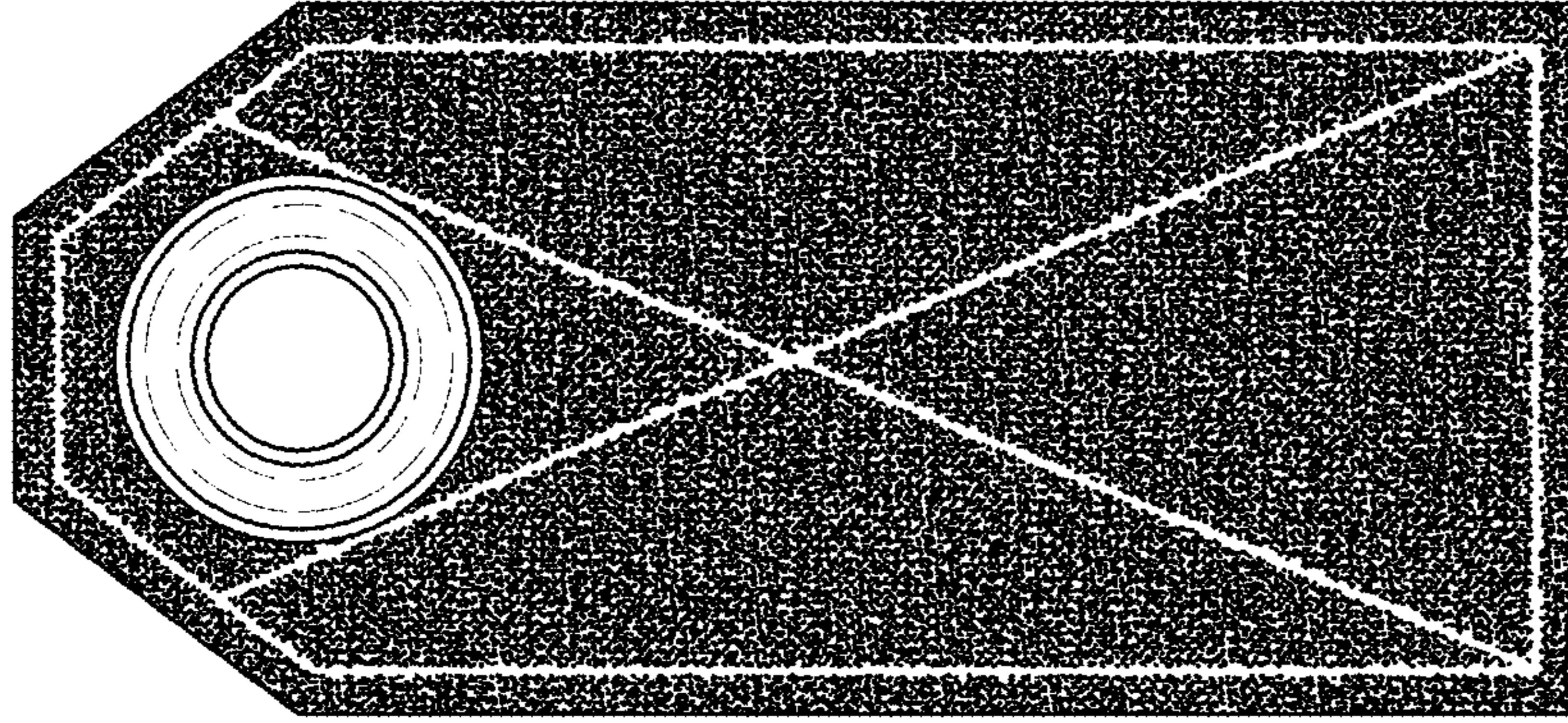

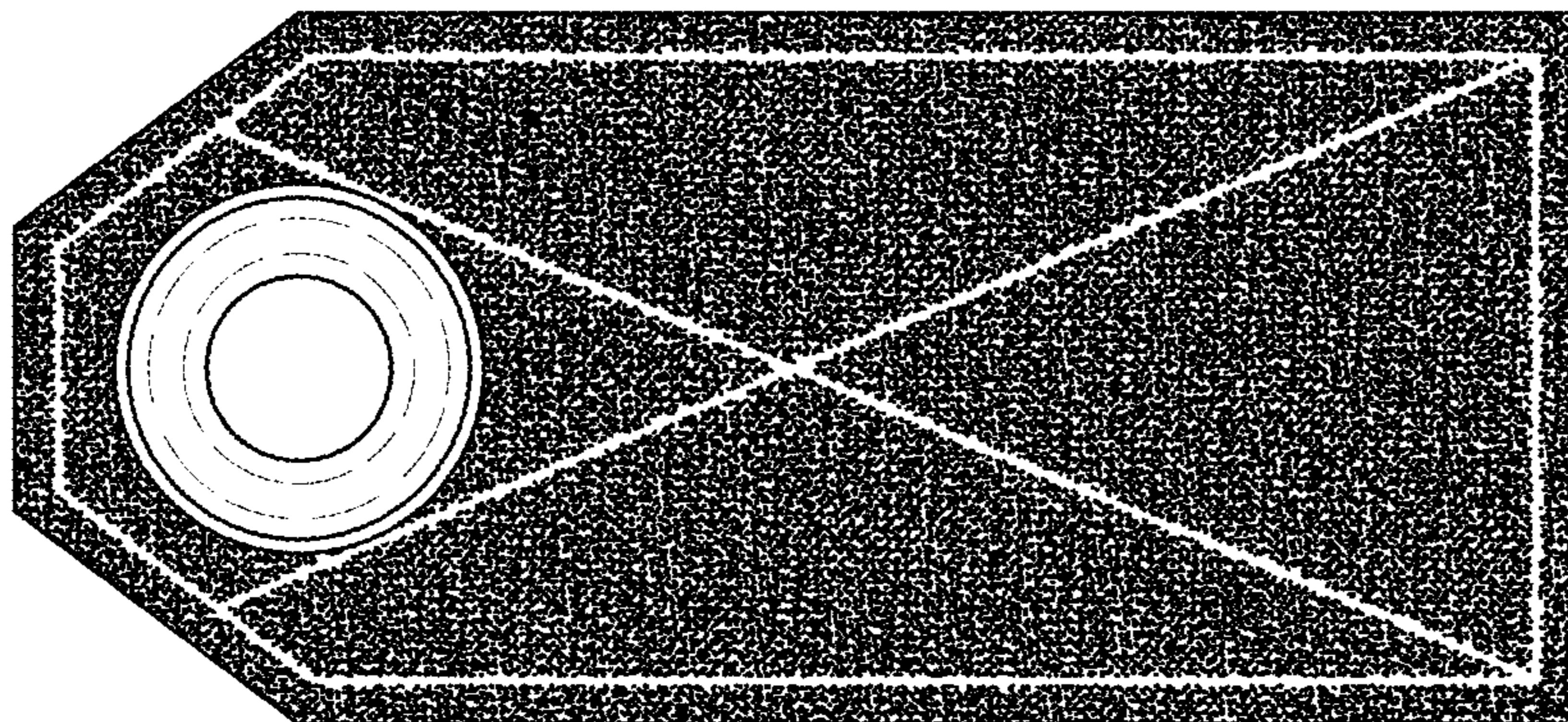

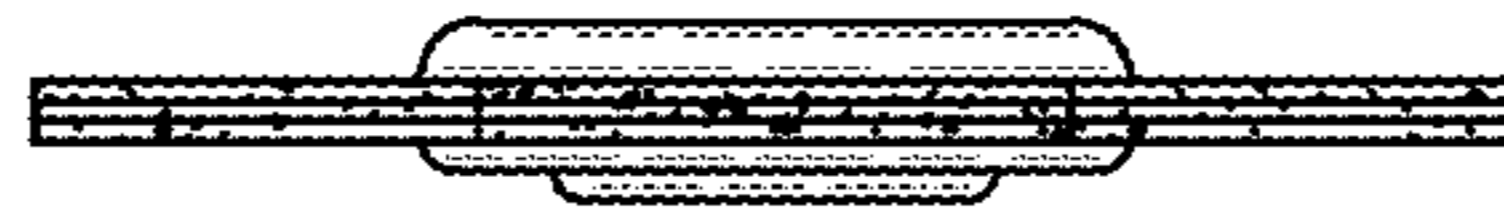

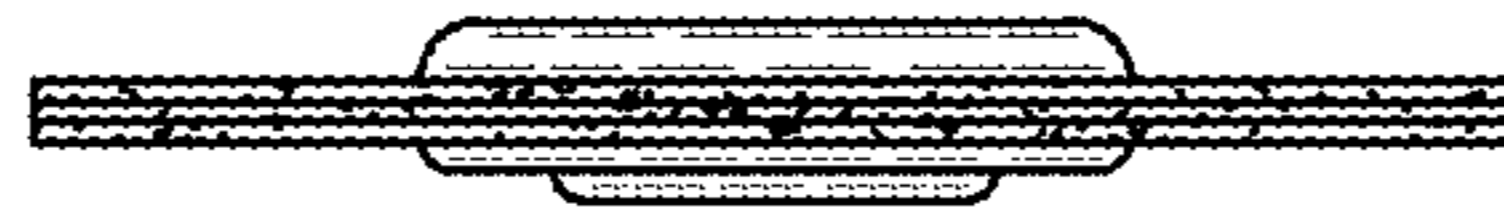

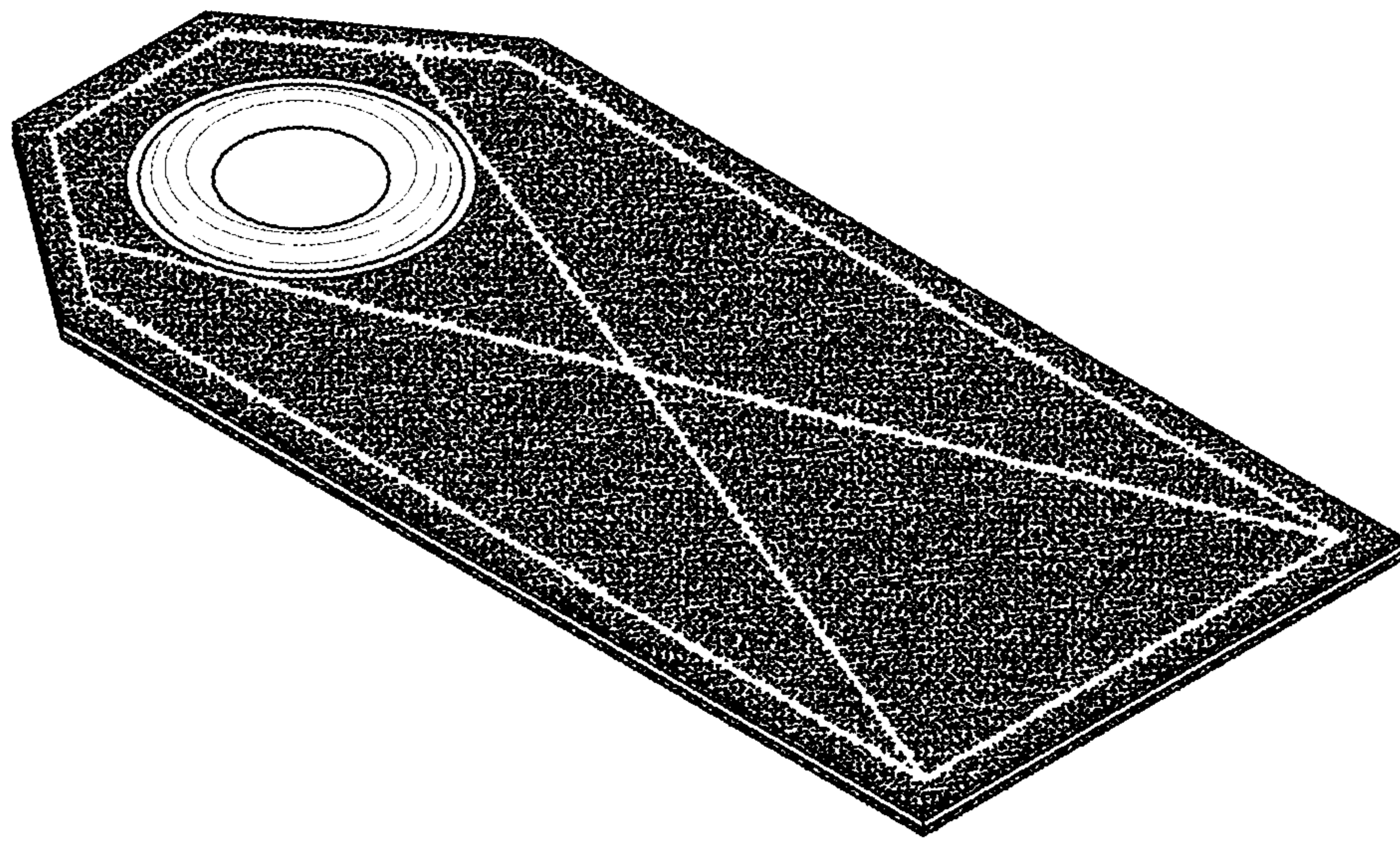

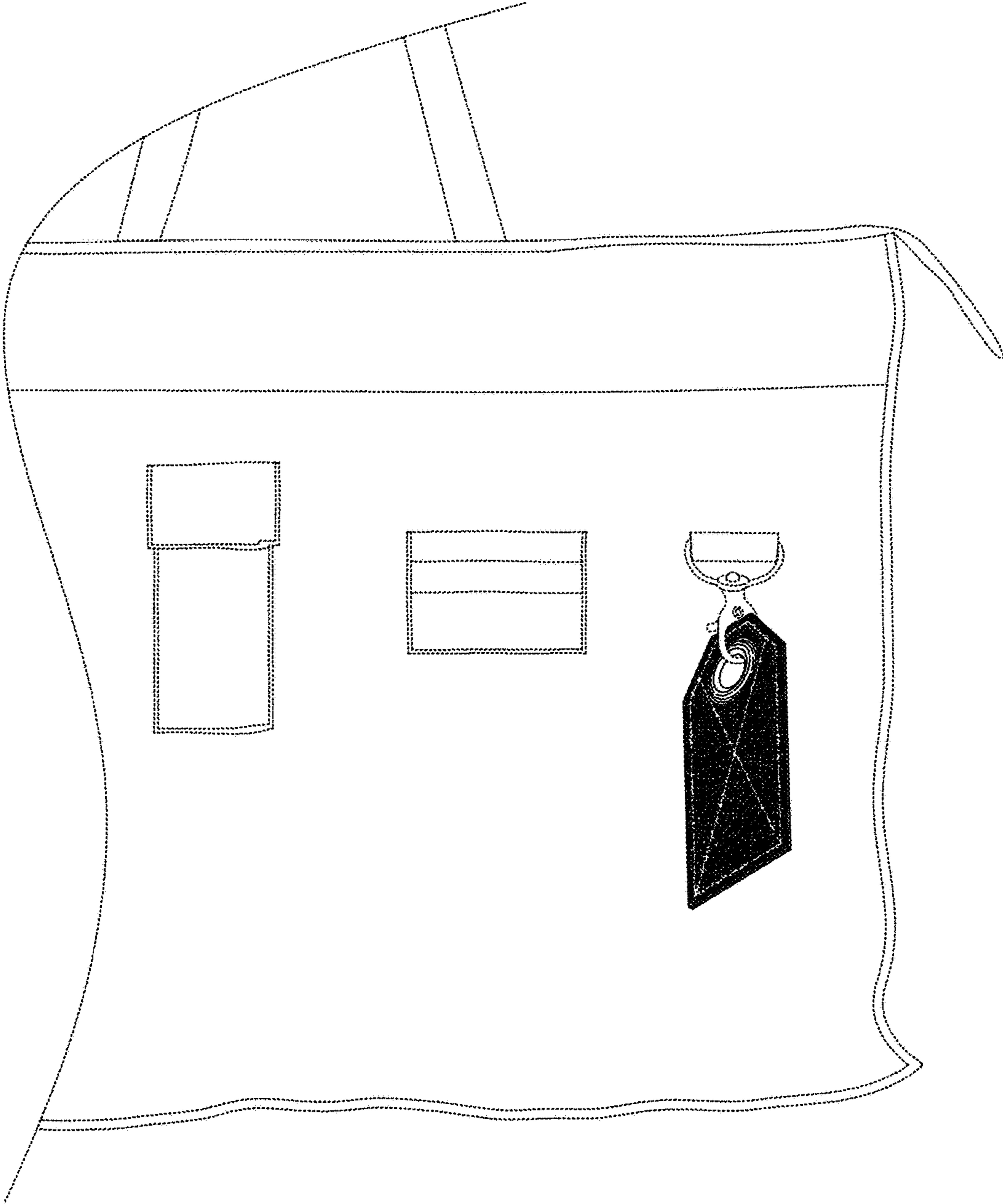
