(57) **CLAIM**

The ornamental design for an atmospheric water generator, as shown and described.

DESCRIPTION

FIG. 1 is a top front right perspective view of the new design for an atmospheric water generator, FIG. 2 is a front view of FIG. 1, FIG. 3 is a back view of FIG. 1, FIG. 4 is a left side view of FIG. 1, FIG. 5 is a right side view of FIG. 1; and, FIG. 6 is a top view of FIG. 1.

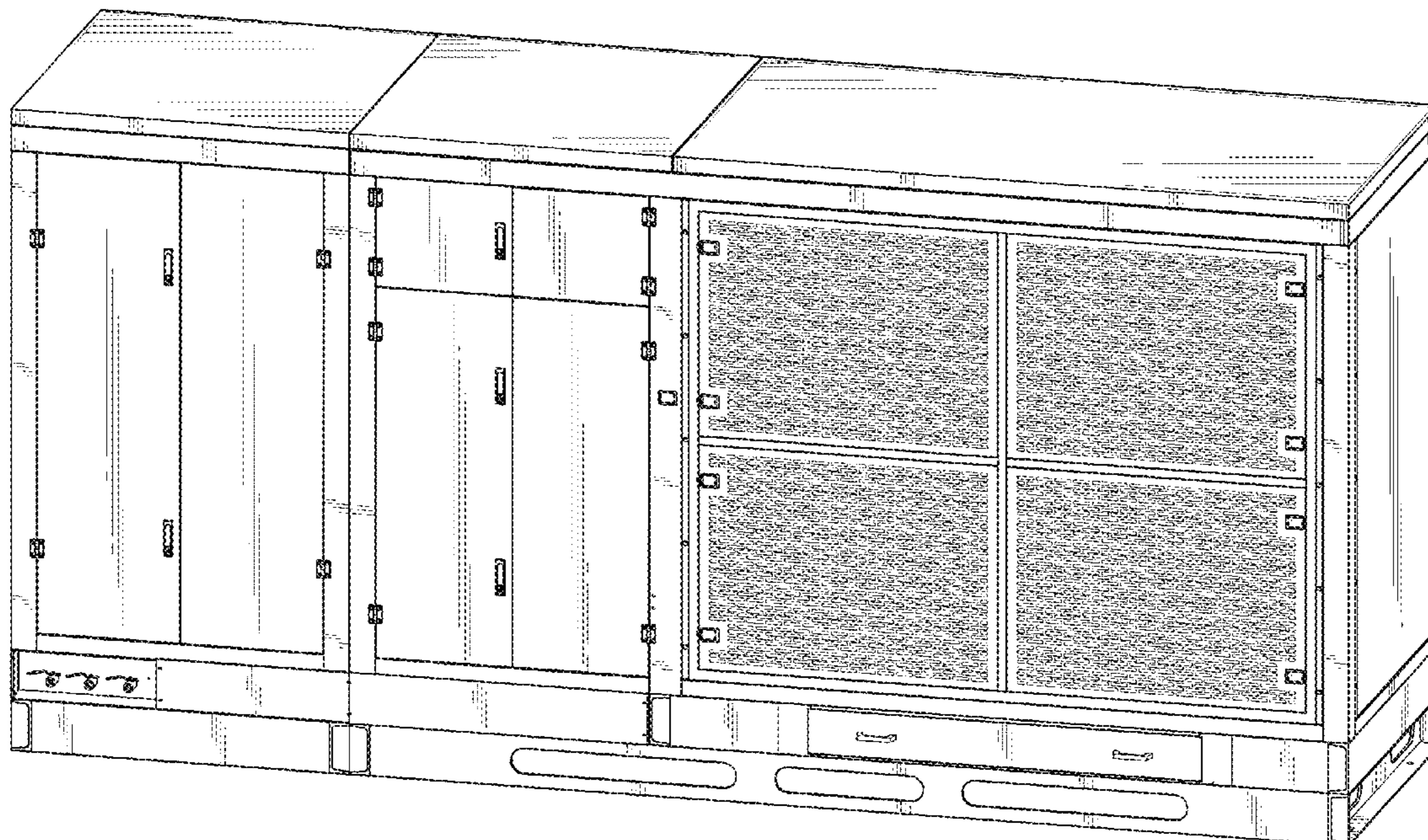
The bottom of FIG. 1, FIG. 2 and FIG. 3 show three slots with rounded corners. These slots are for receiving the forks of a forklift.

The bottom right side of FIG. 1 and the bottom of FIG. 4 and FIG. 5 show two slots with rounded corners. These slots are for receiving the forks of a forklift.

The bottom view which is not shown in the drawings forms no part of the claimed design.

The features shown in broken lines in the drawings form no part of the claimed design.

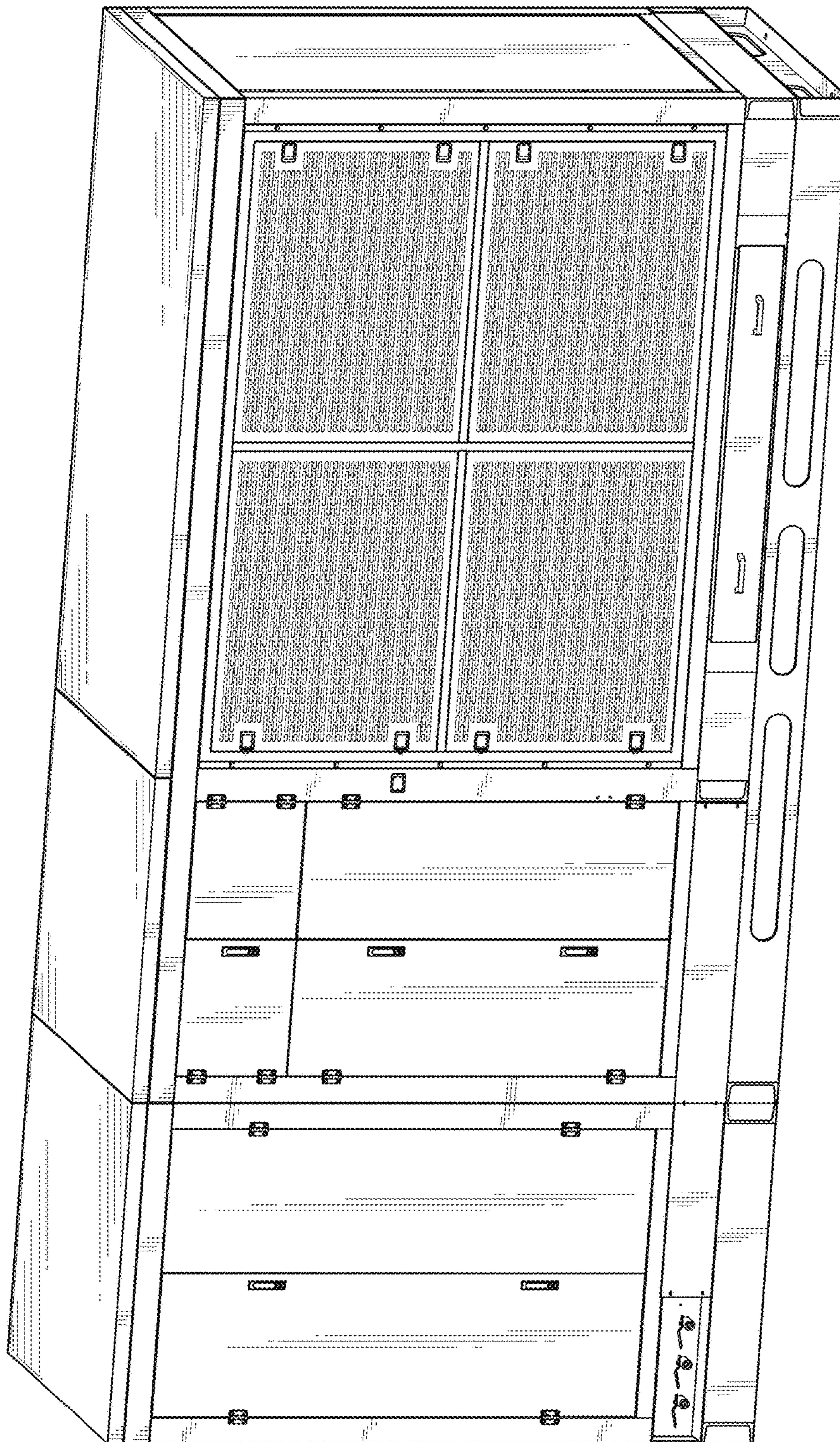

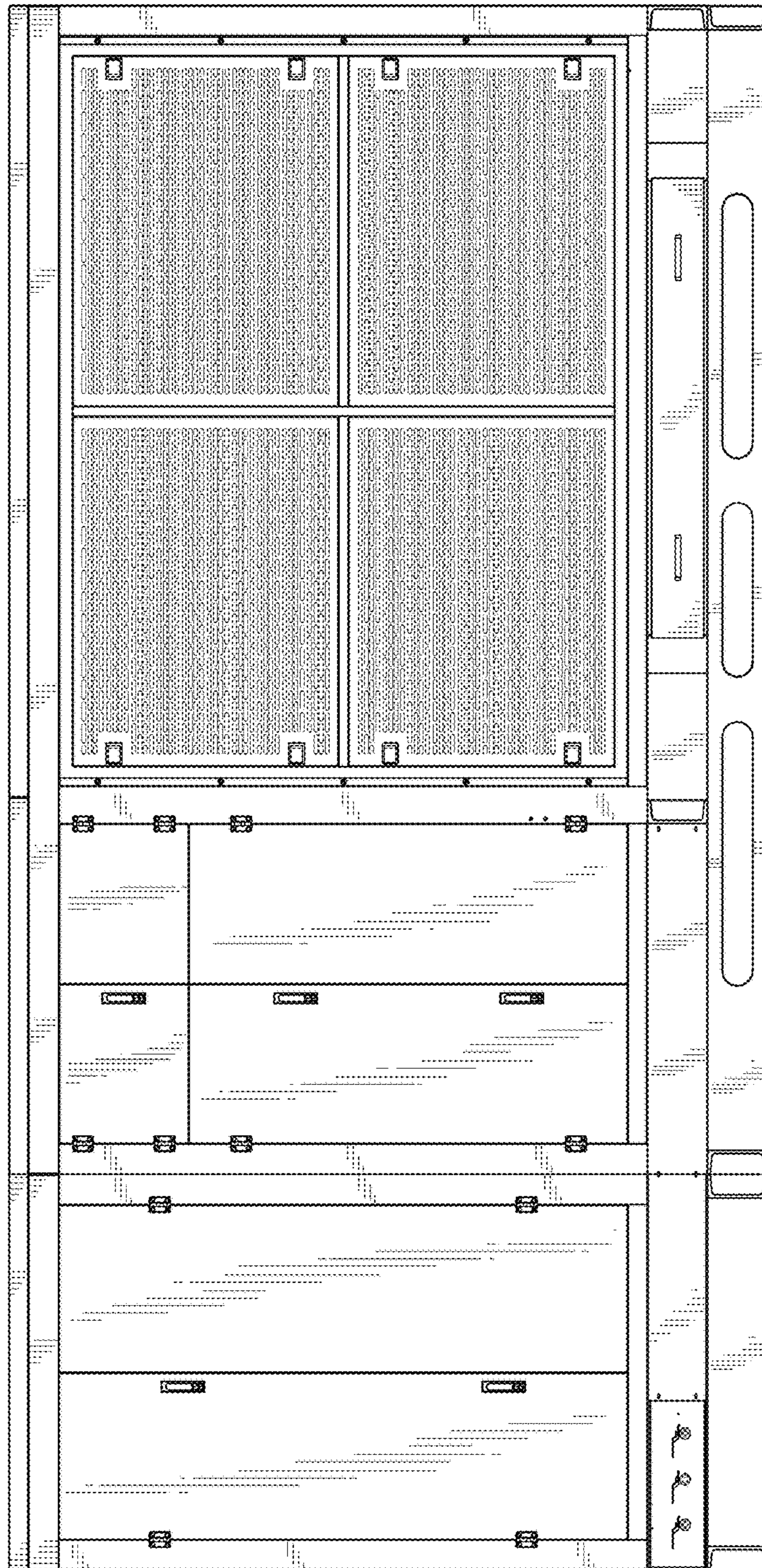

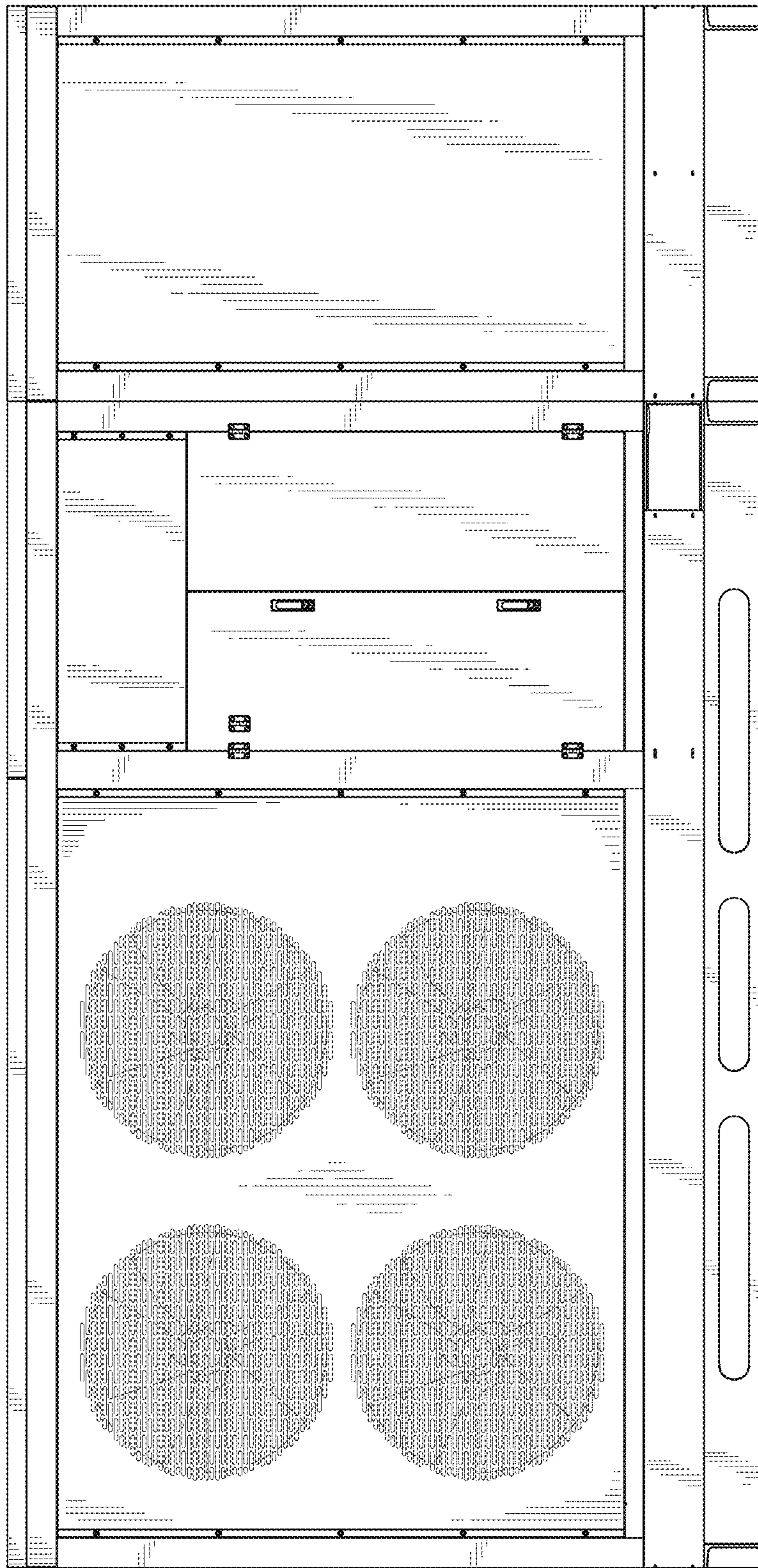

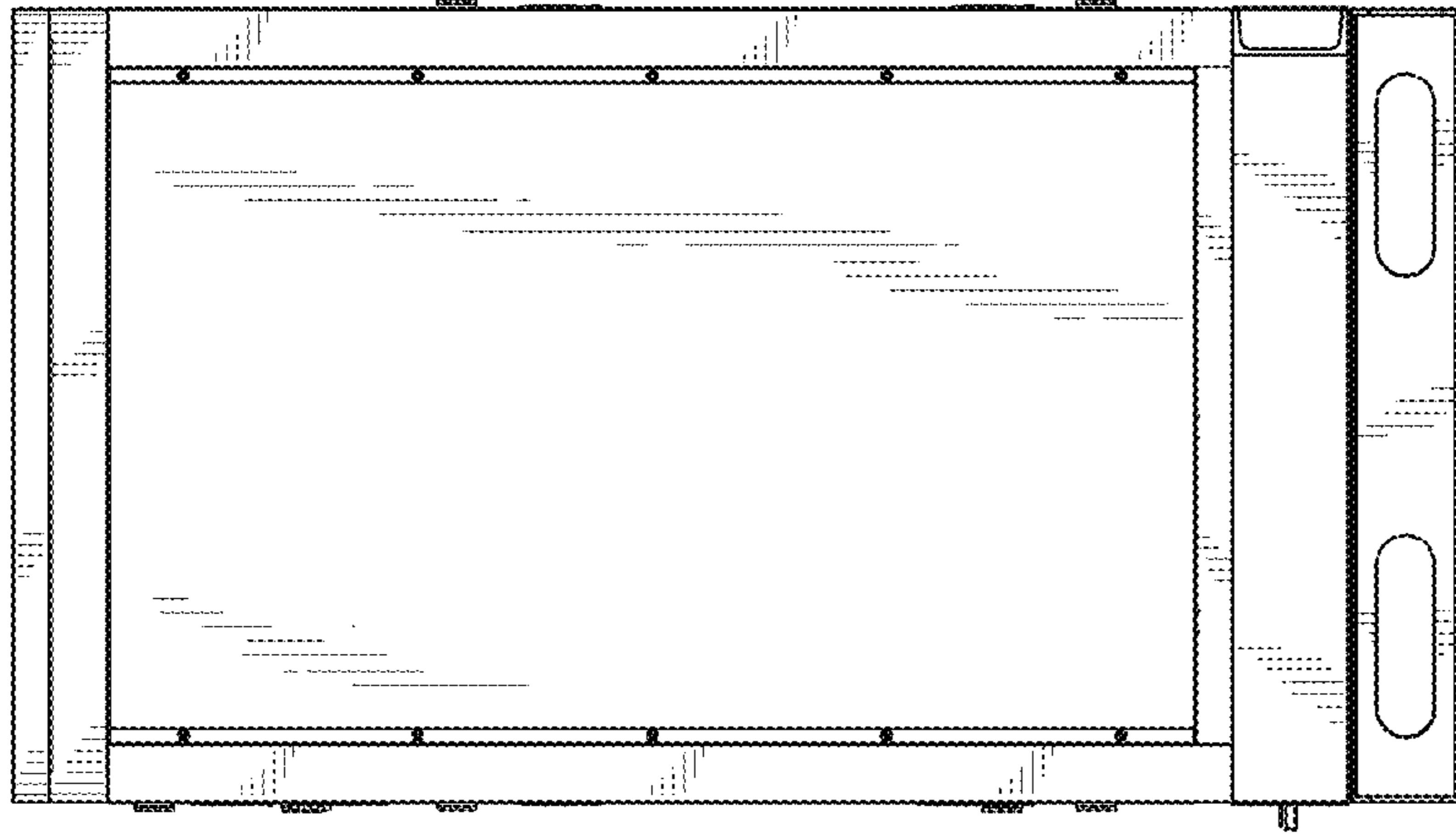

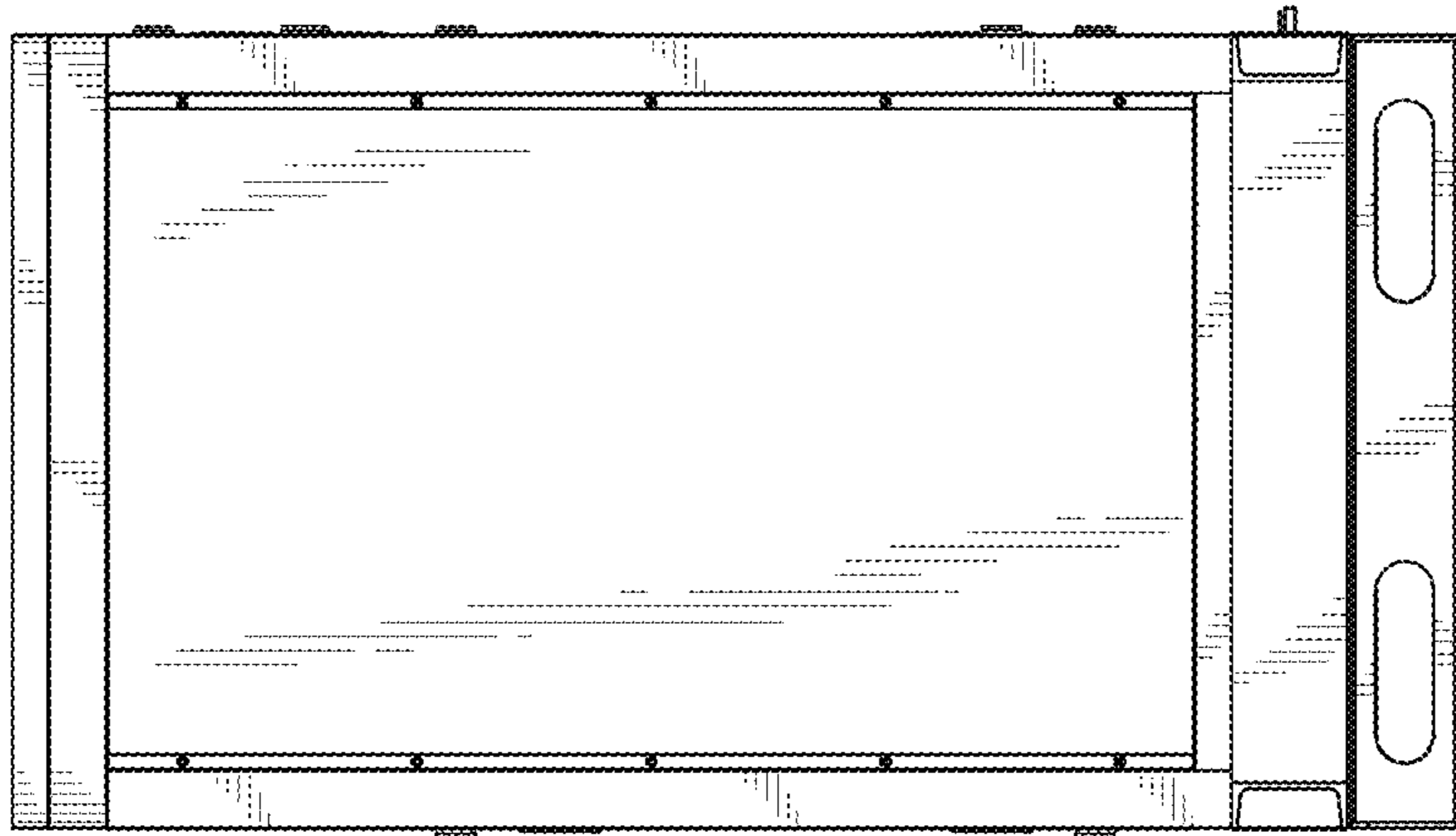

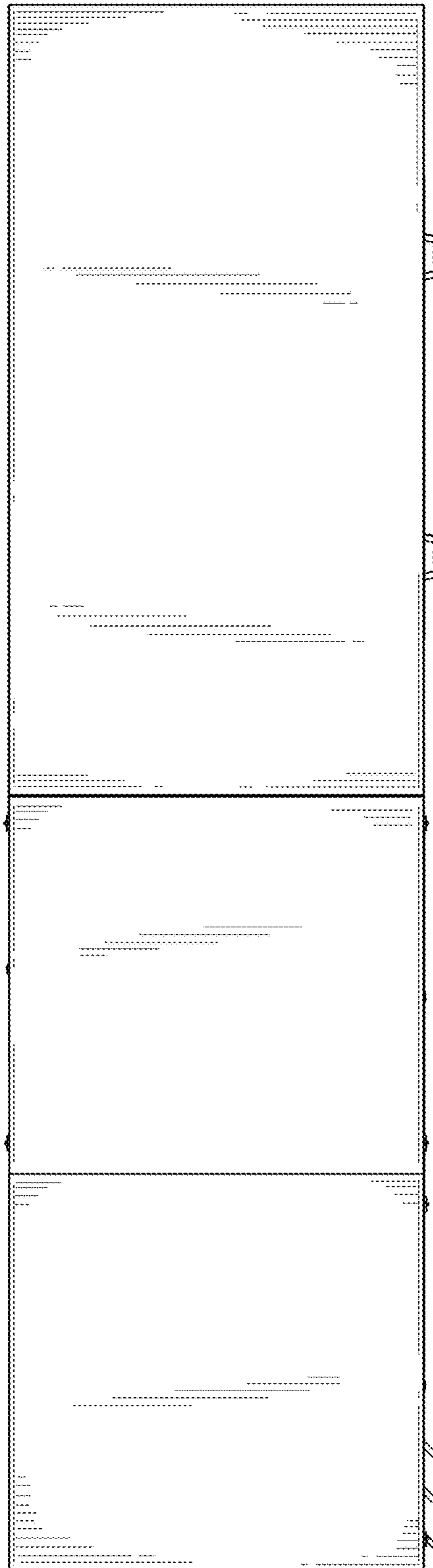
