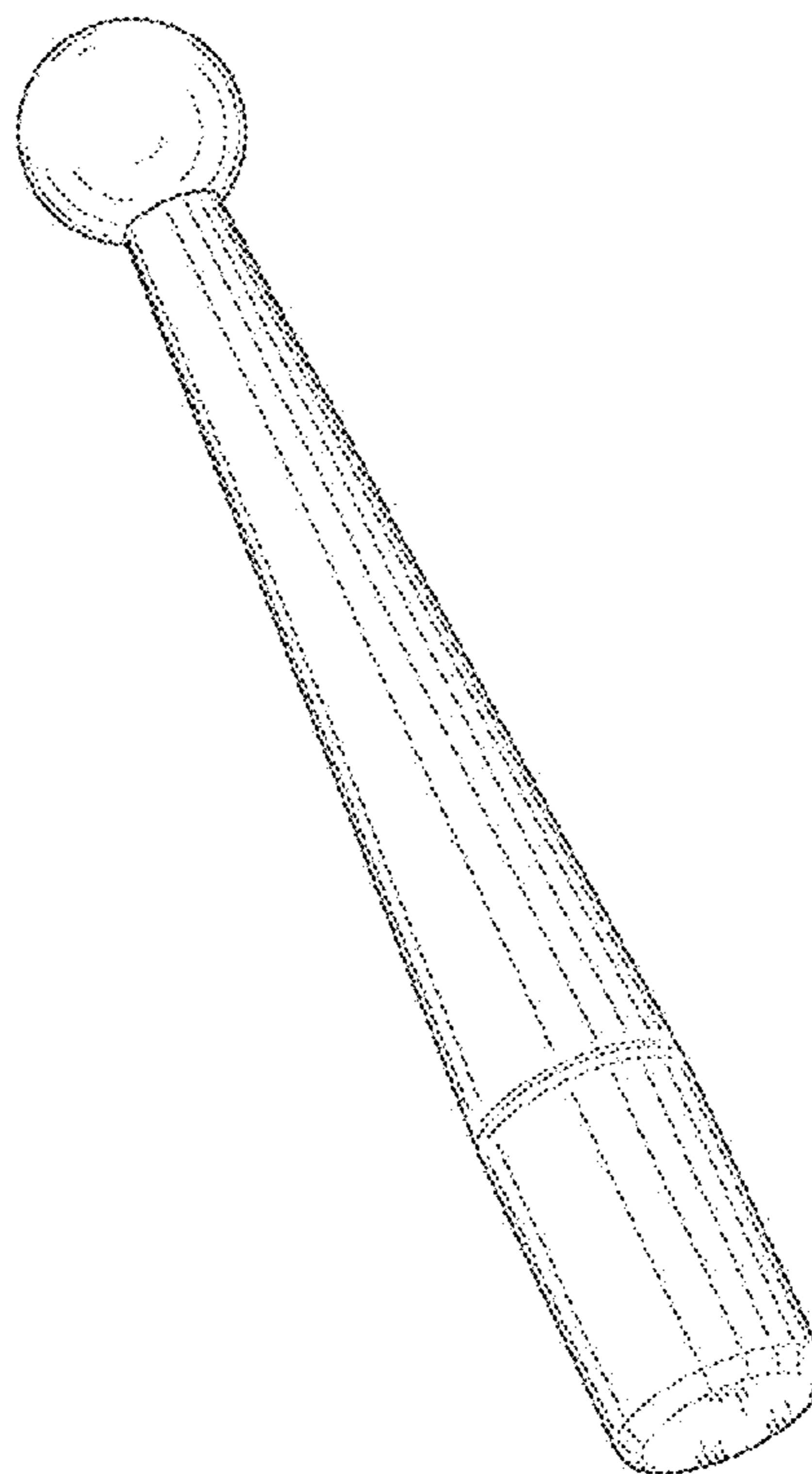
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the skin touch applicator of the present invention.
FIG. 2 is the elevation view of the skin touch applicator of the present invention.
FIG. 3 is the top view of the skin touch applicator of the present invention.
FIG. 4 is the bottom view of the skin touch applicator of the present invention; and,

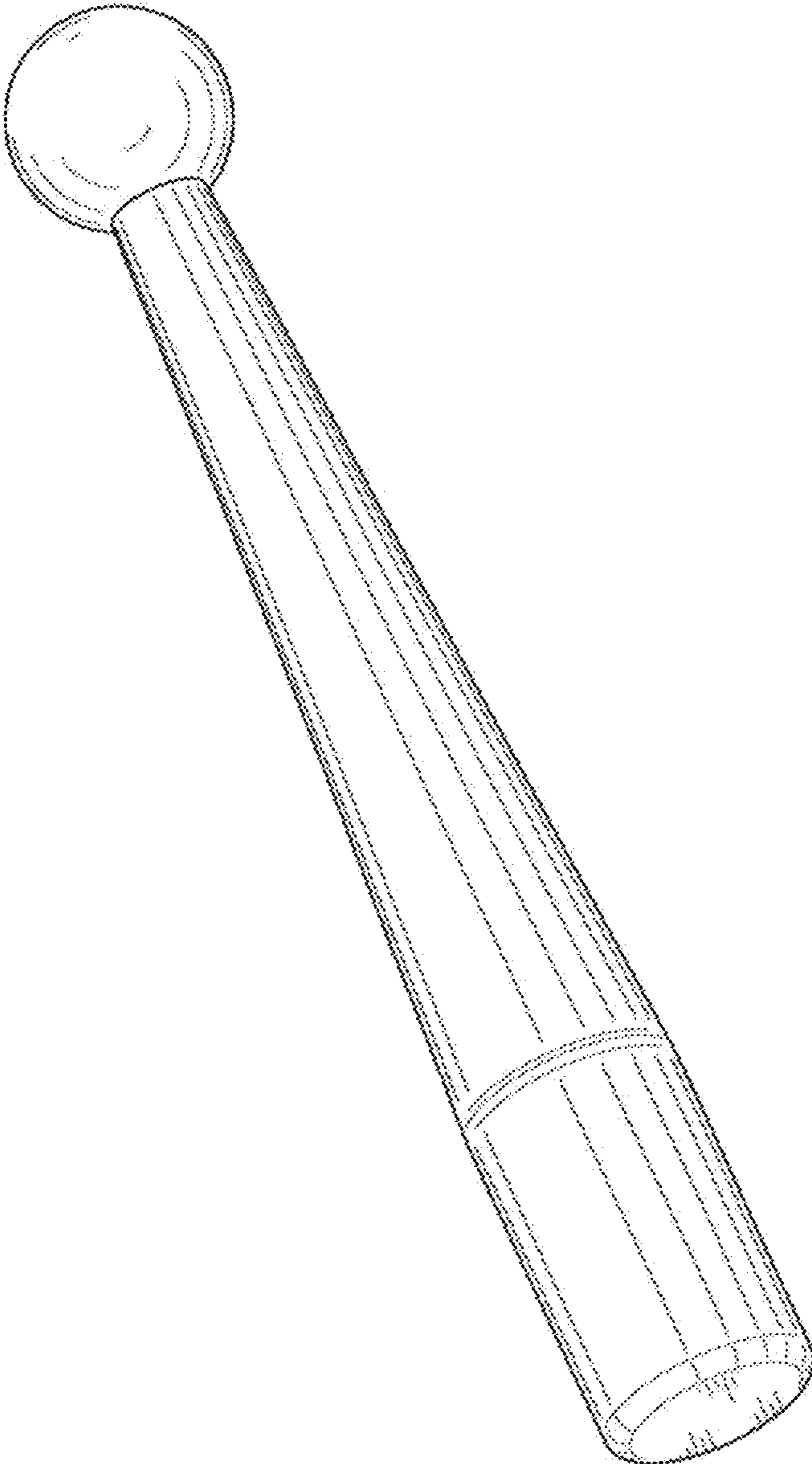

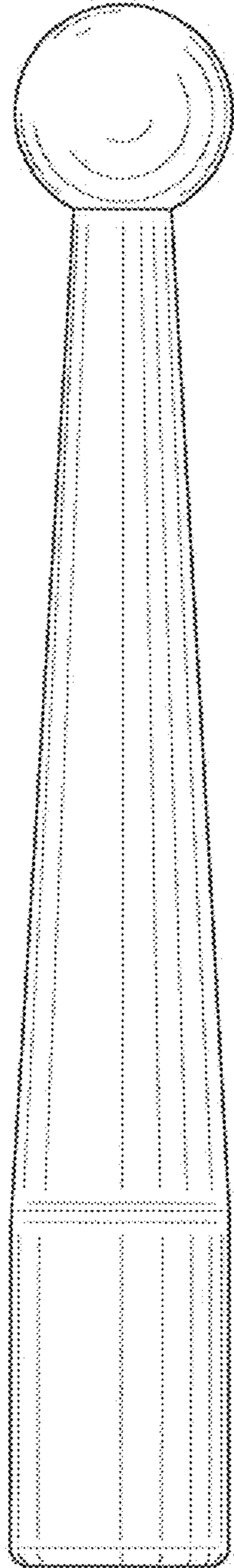

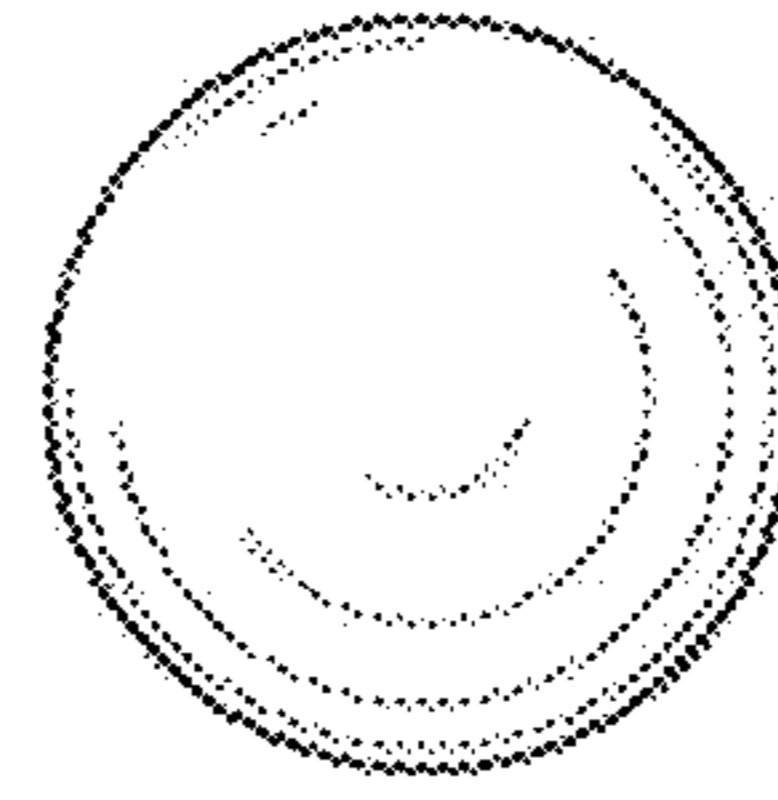

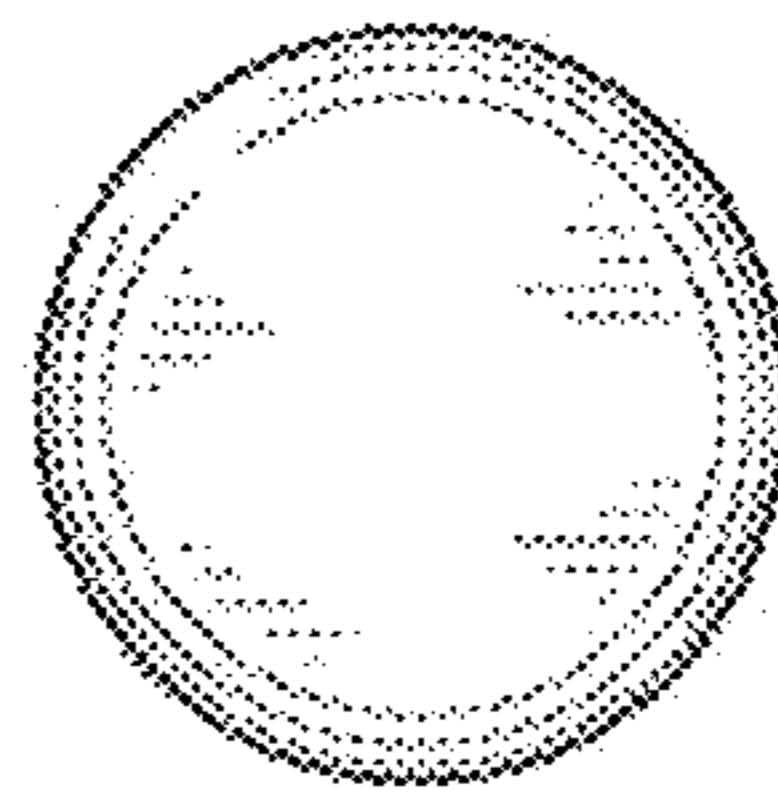

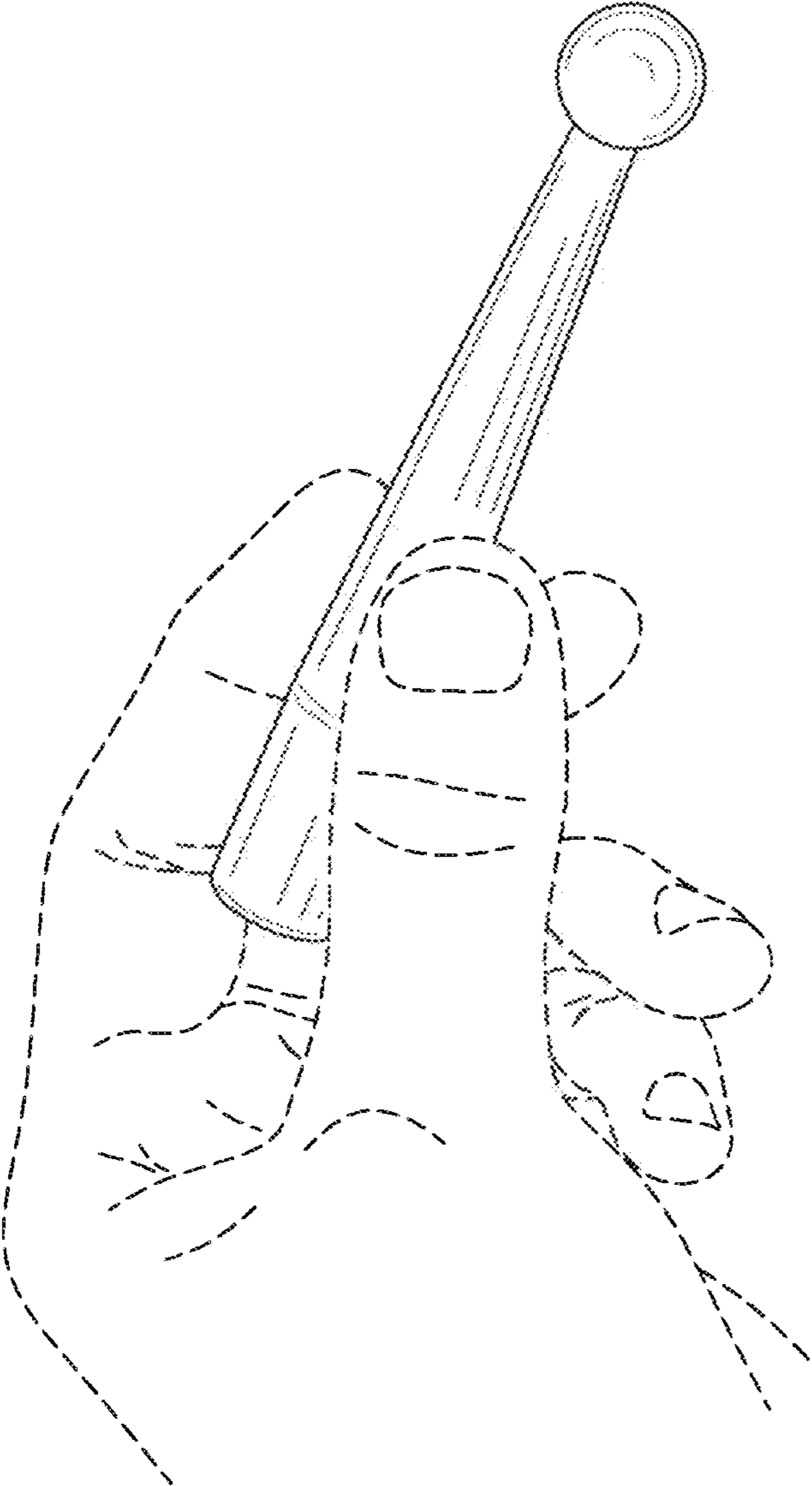
