DESCRIPTION

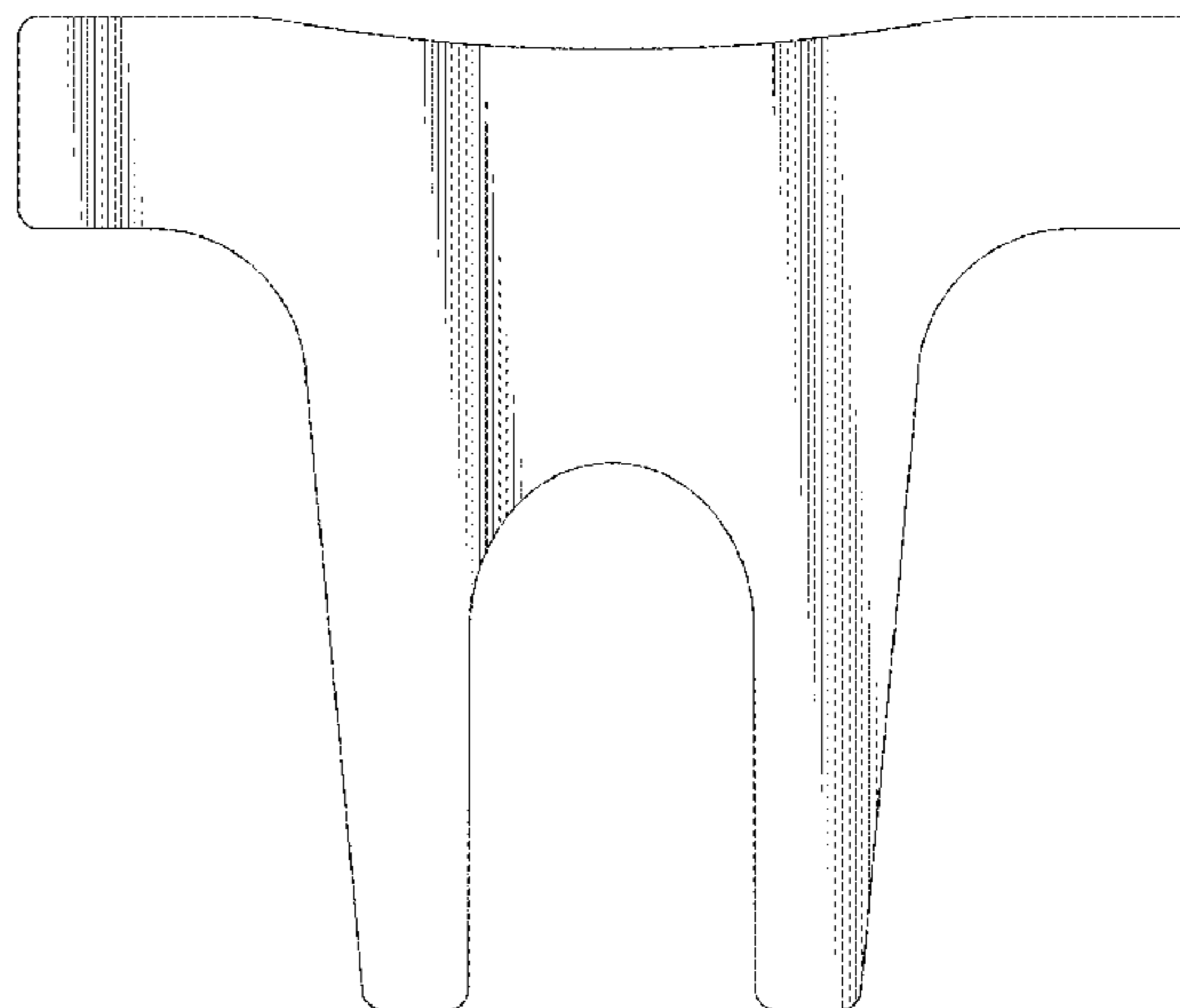
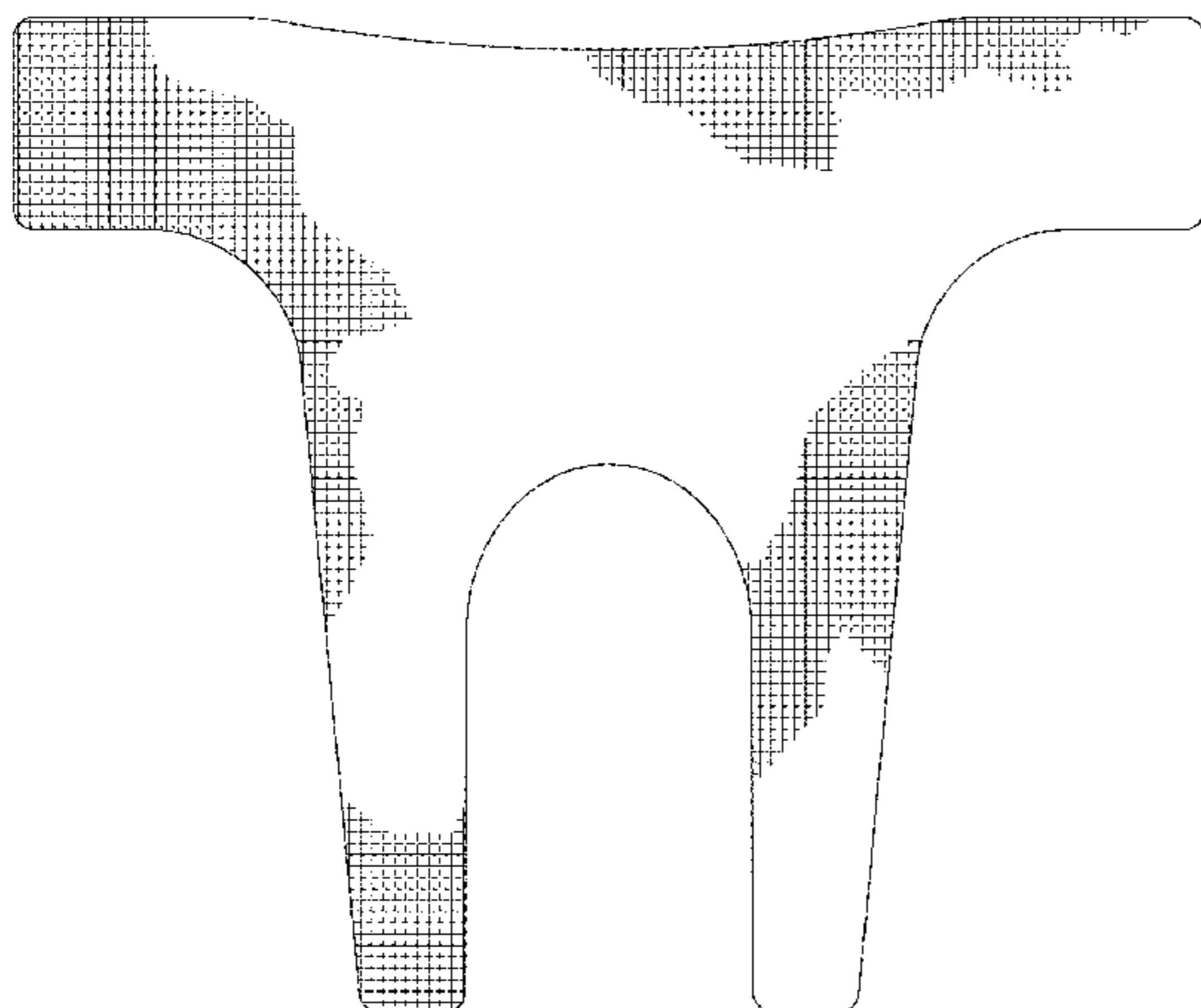
FIG. 1 is an obverse side view, taken looking at the front of
the adhesive foot support strap.
FIG. 2 is a reverse side view, taken looking at the back of the
adhesive foot support strap.
FIG. 3 is a left side view, taken looking at the left side of the
adhesive foot support strap.
FIG. 4 is a right side view, taken looking at the right side of
the adhesive foot support strap.
FIG. 5 is a top plan view taken looking down at the top of
the adhesive foot support strap; and,
FIG. 6 is a bottom plan view taken looking up at the
underside of the adhesive foot support strap.
The broken lines in the figures are for the purpose of
illustrating portions of an adhesive foot support strap and
form no part of the claim.

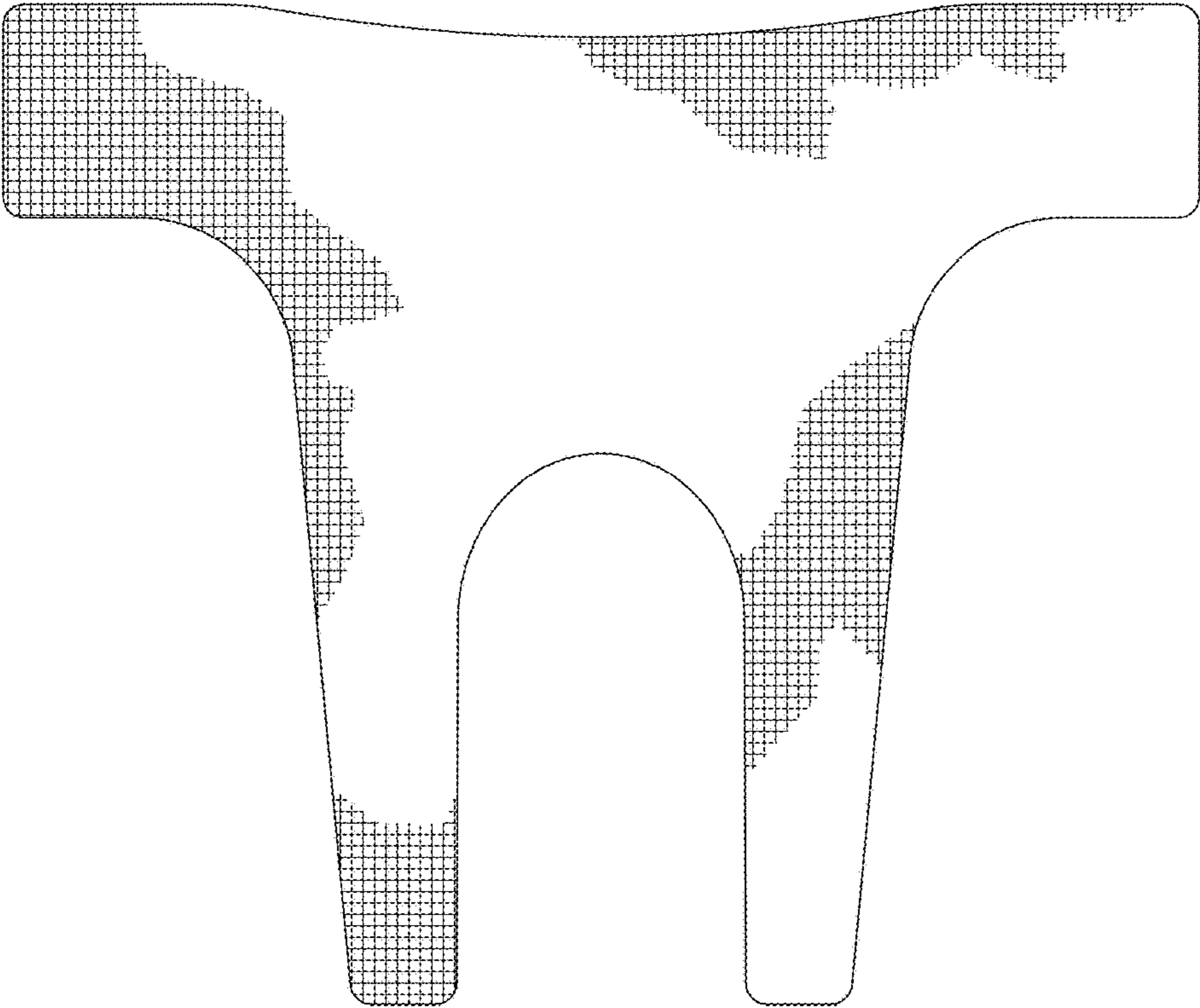

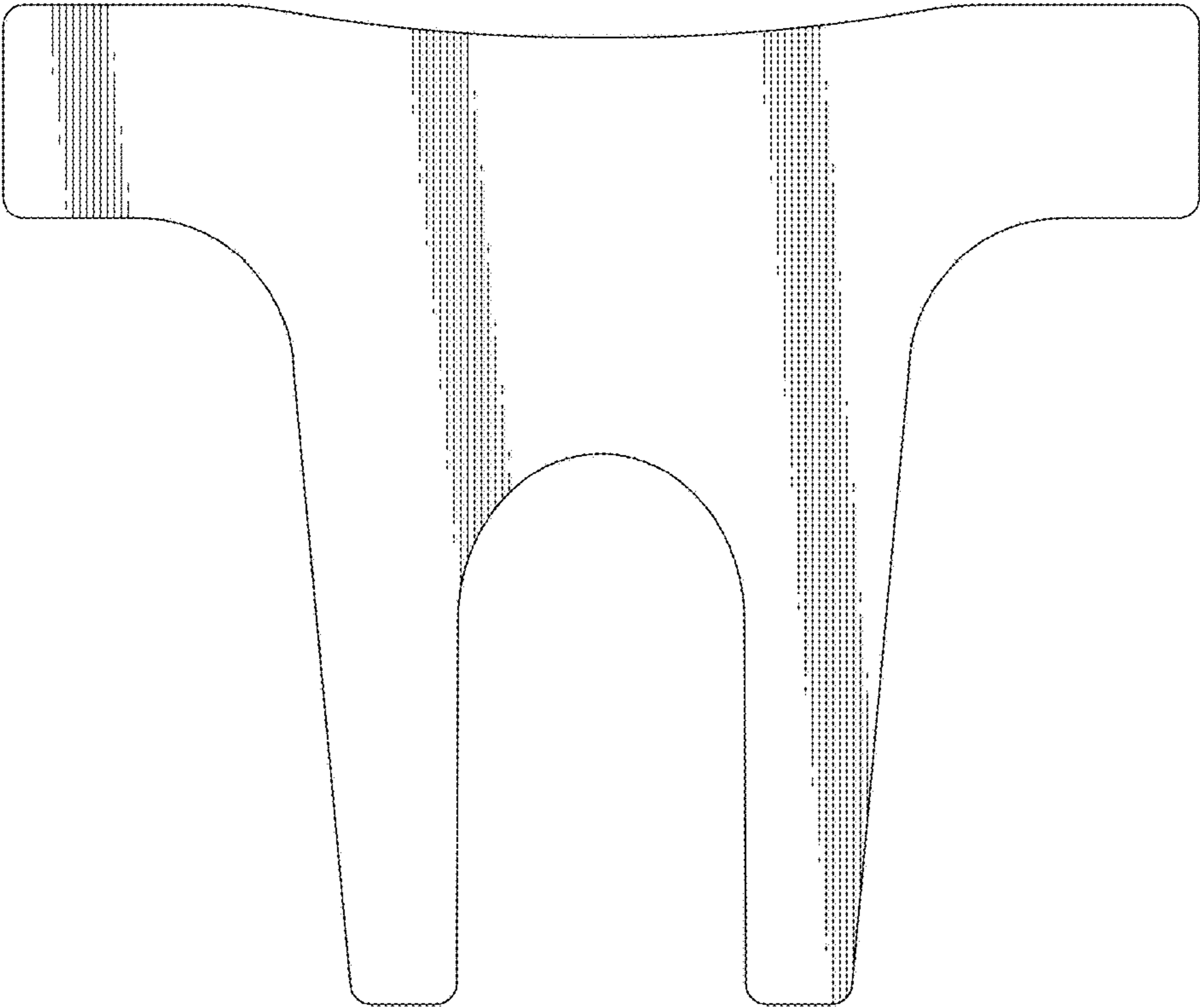

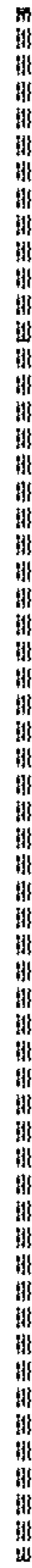

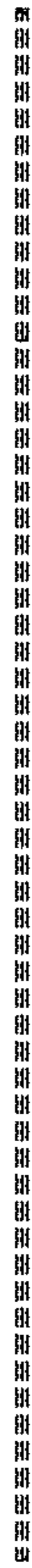

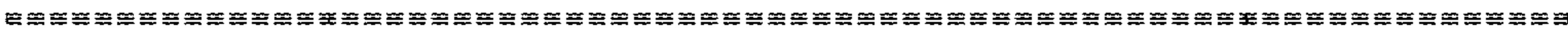
