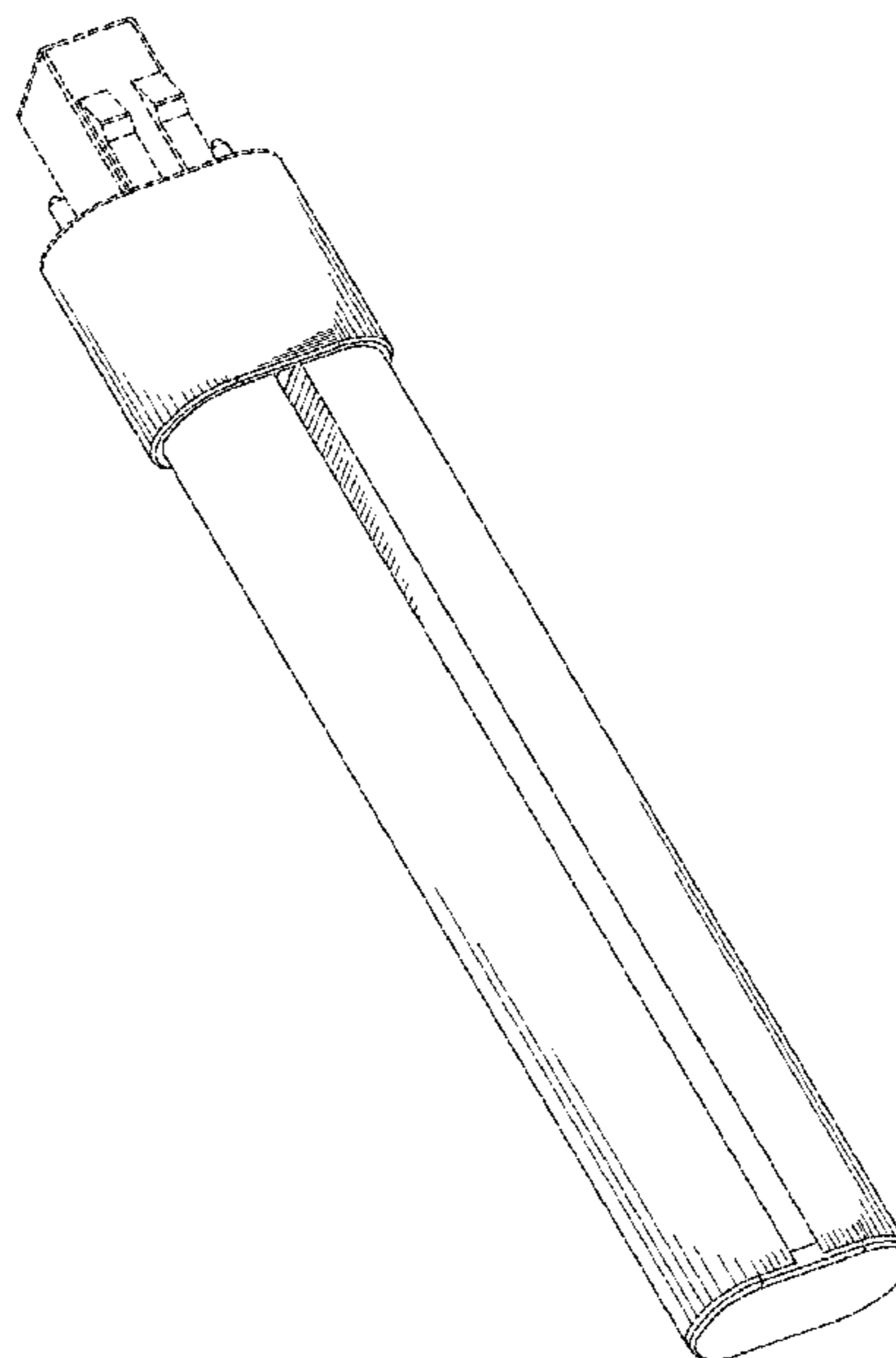
FIG. 1 is a perspective view of a lamp in accordance with a first embodiment of the design;

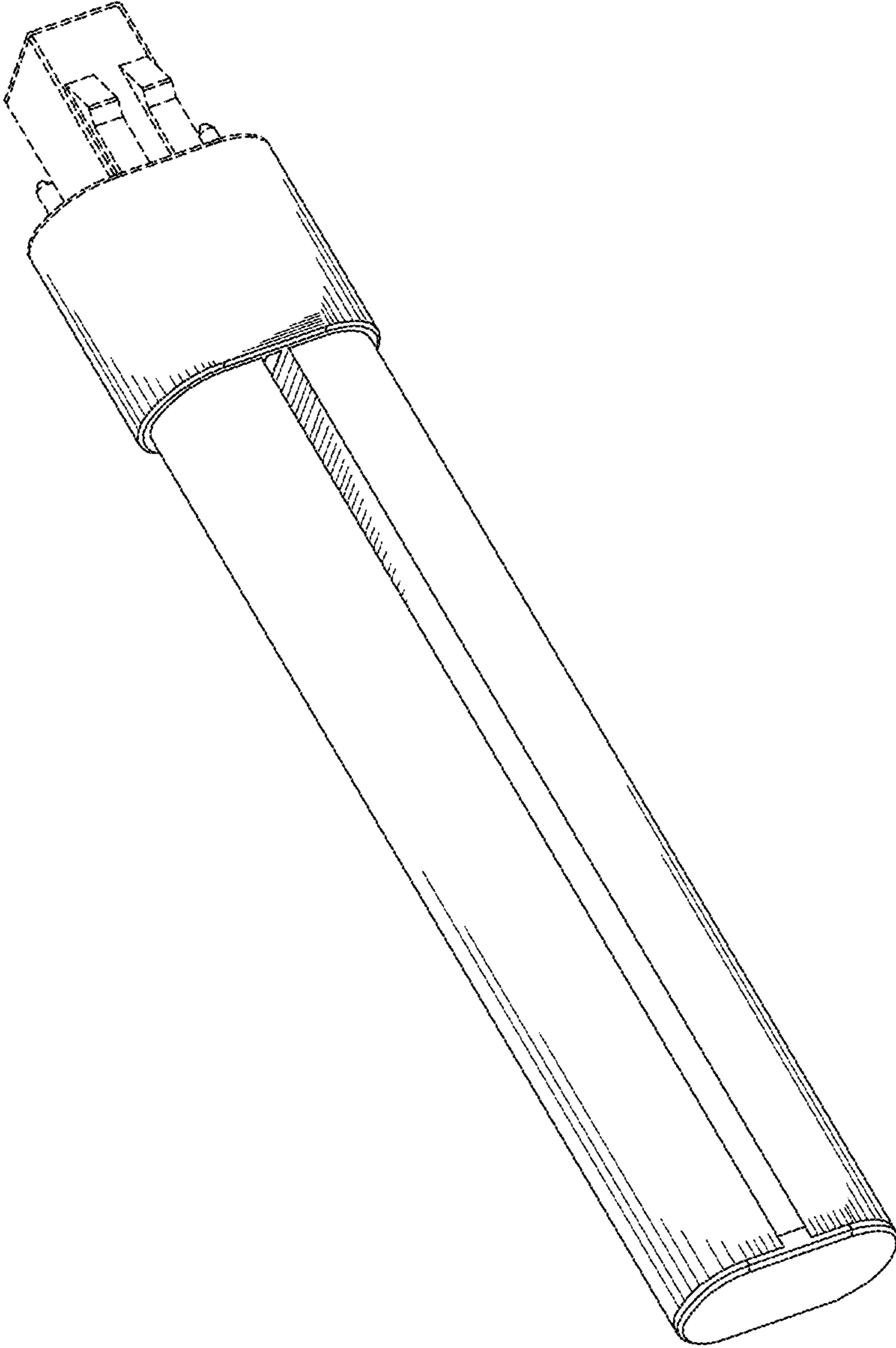

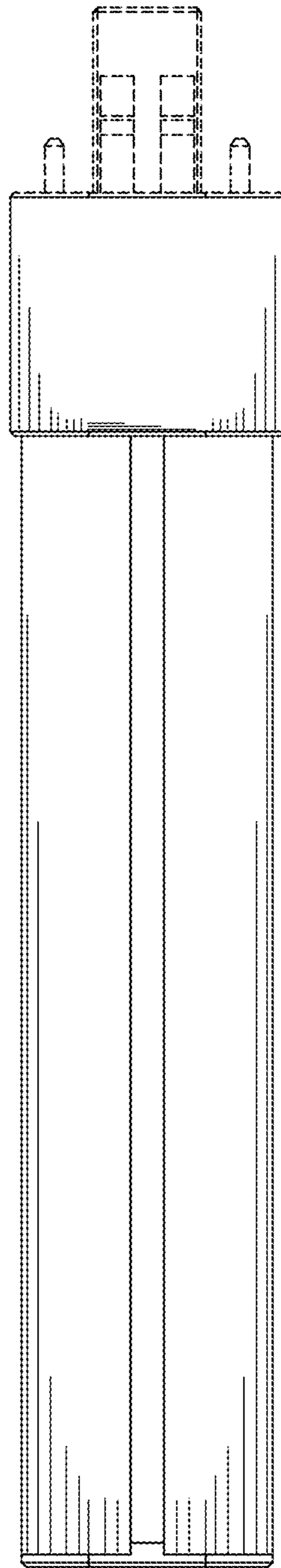

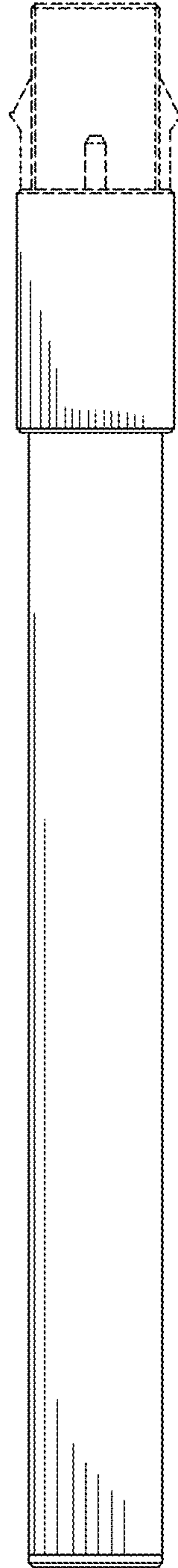

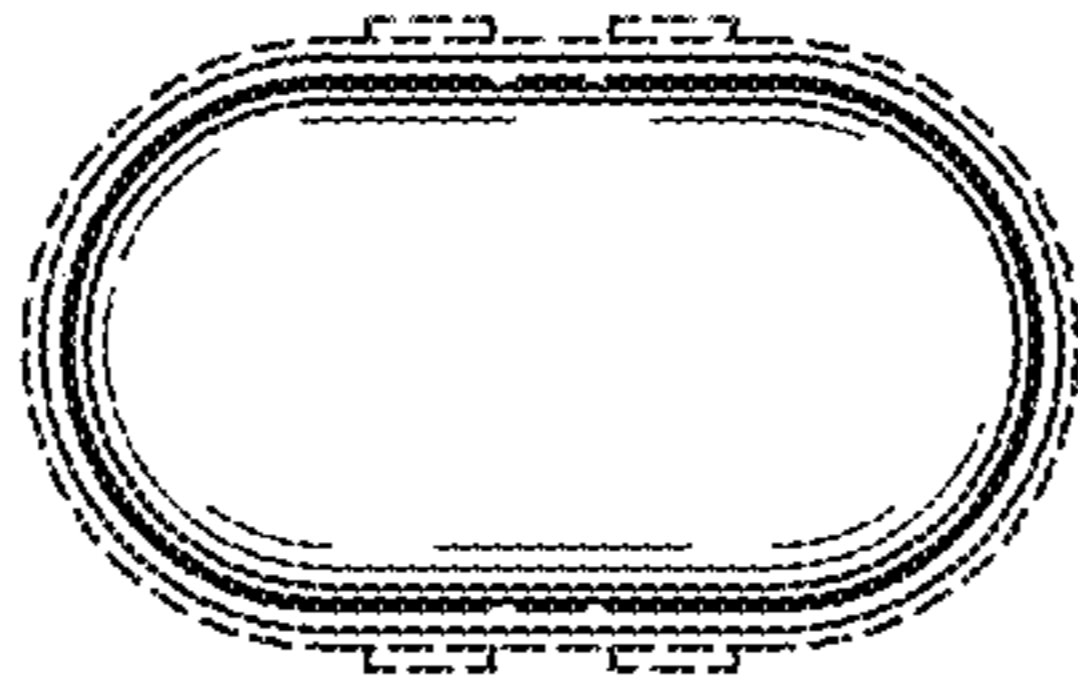

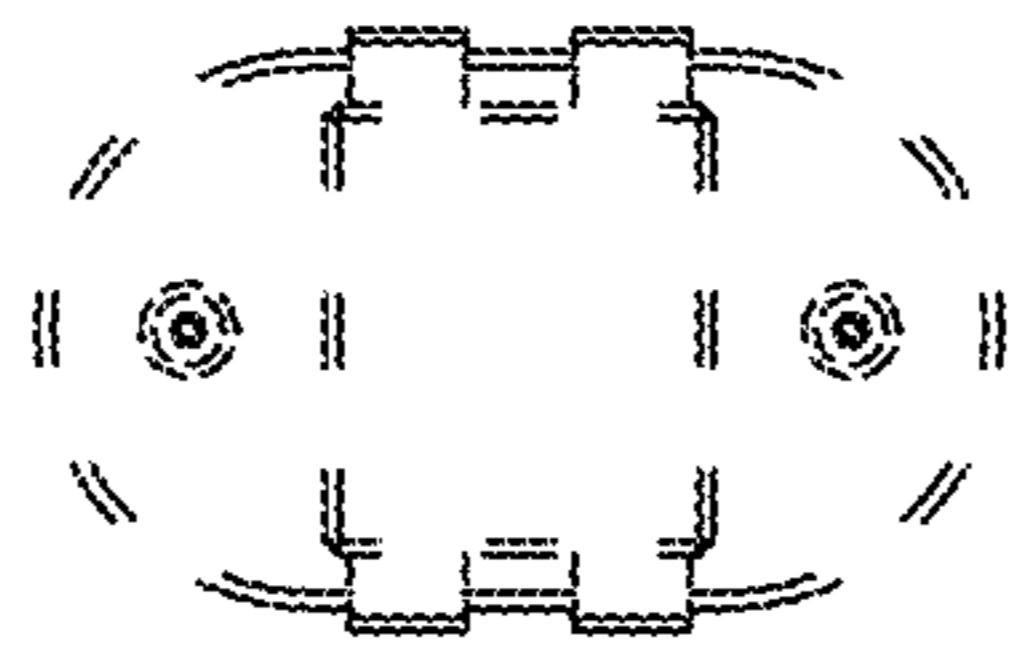

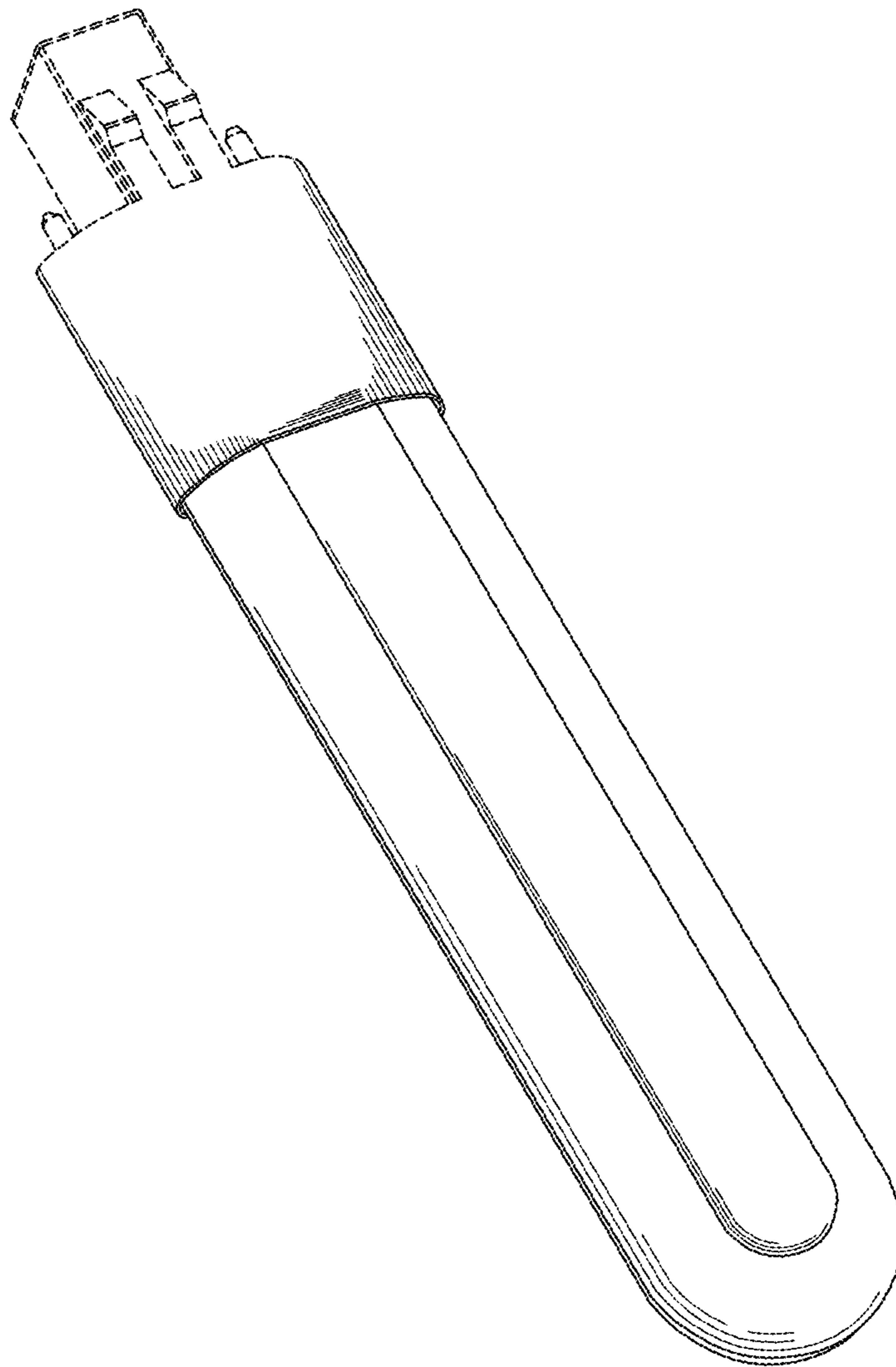

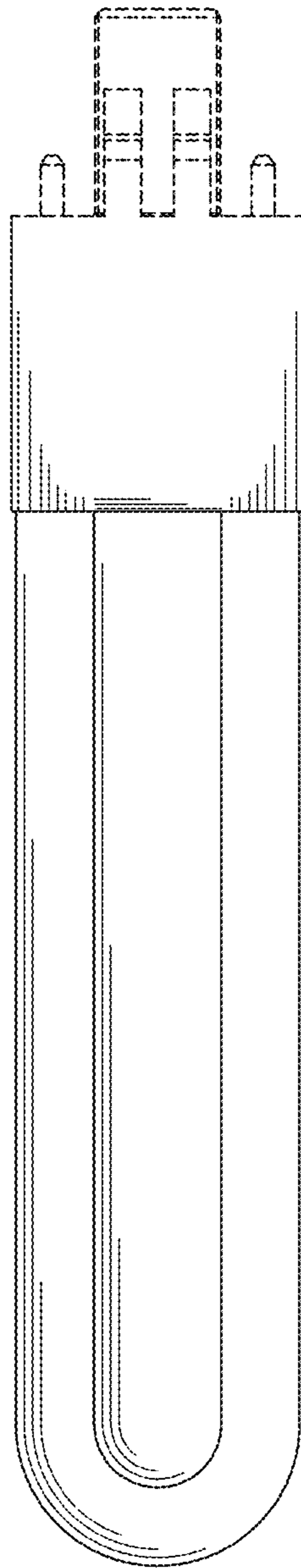

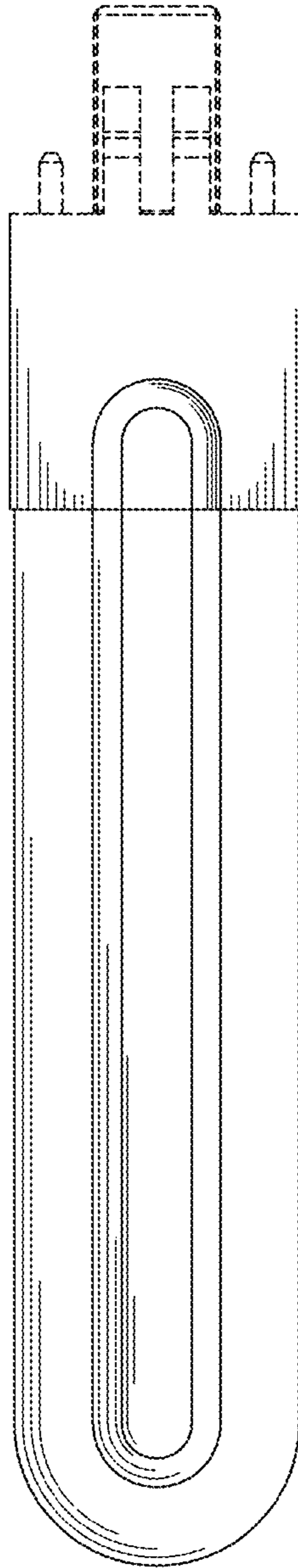

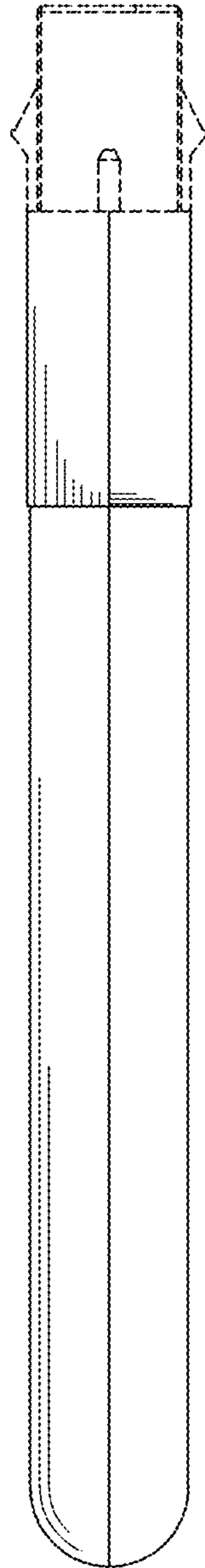

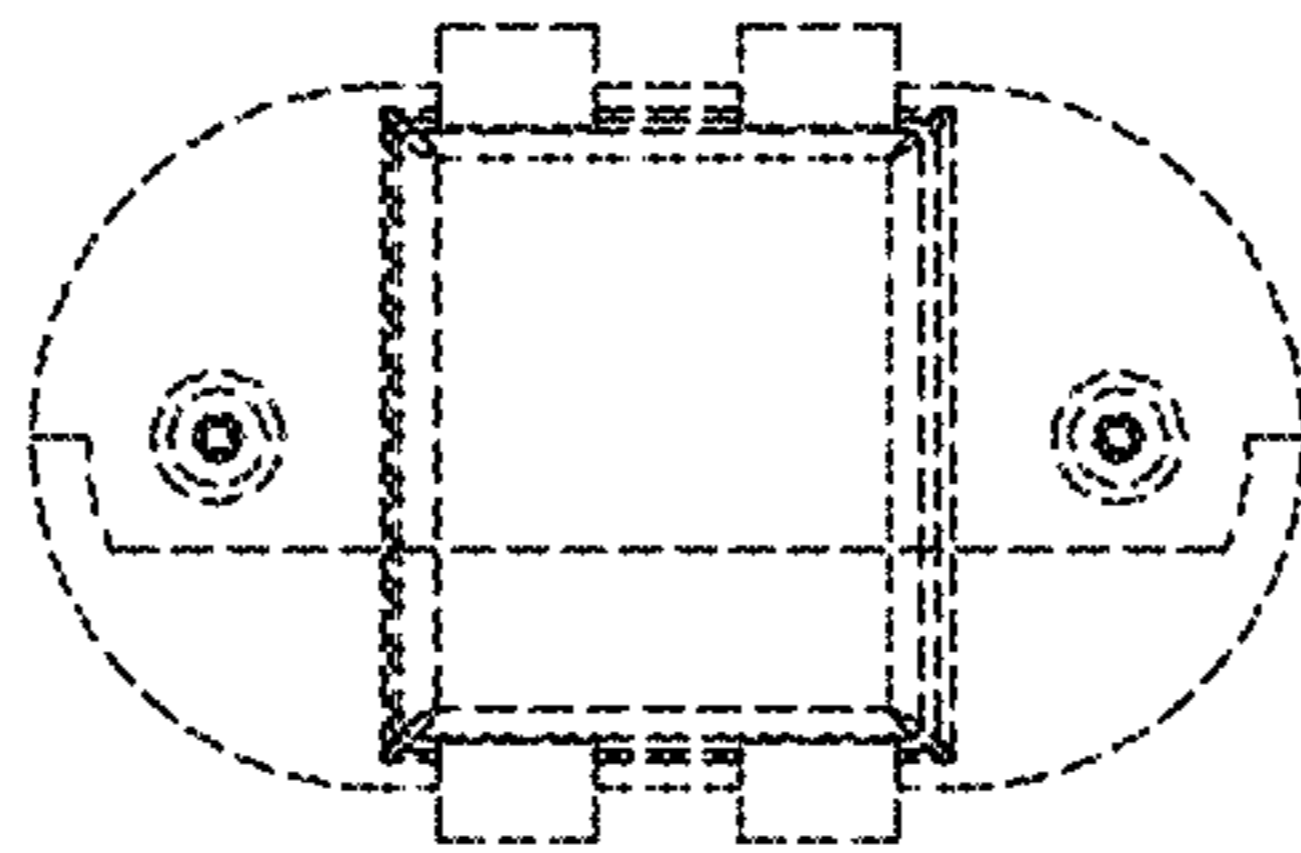

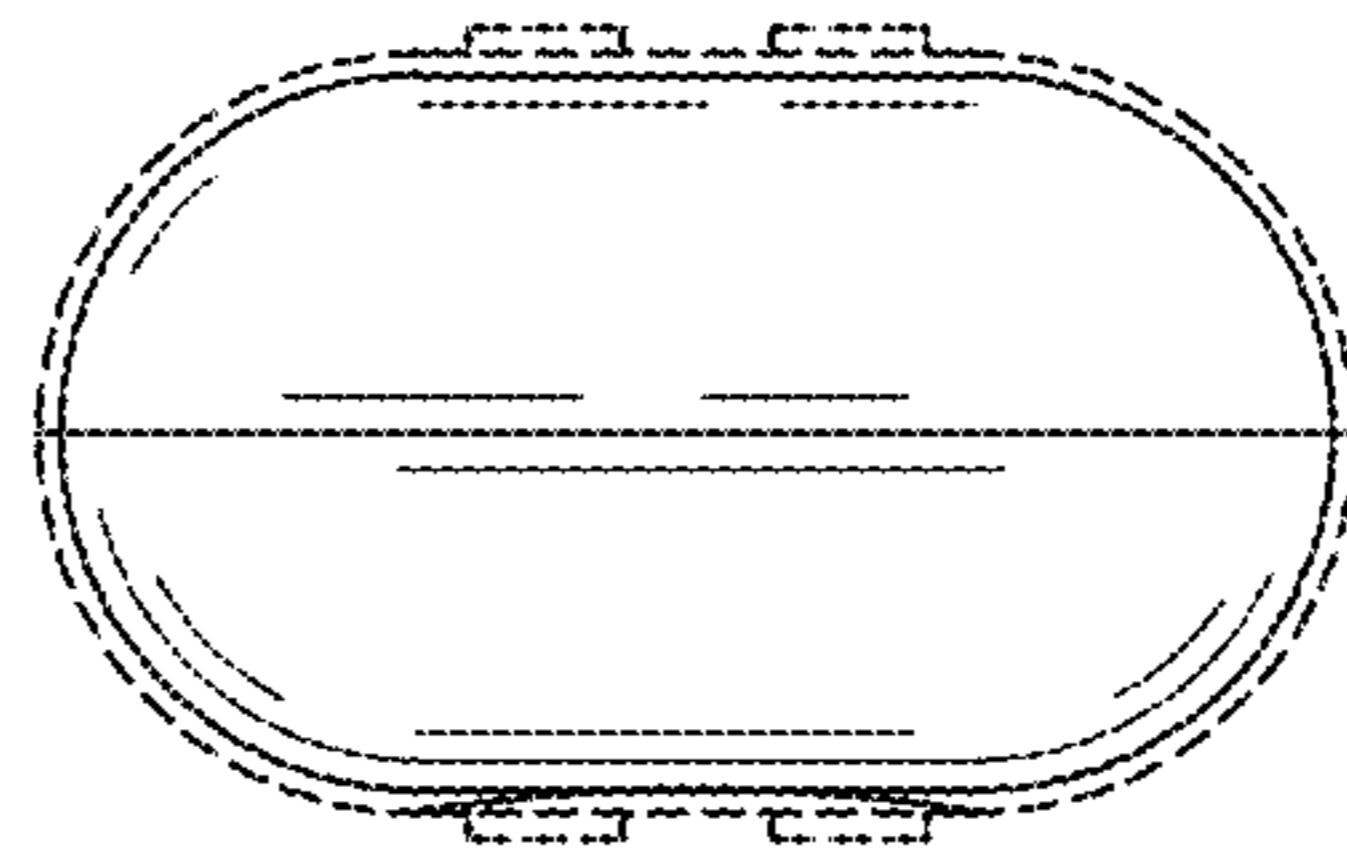
