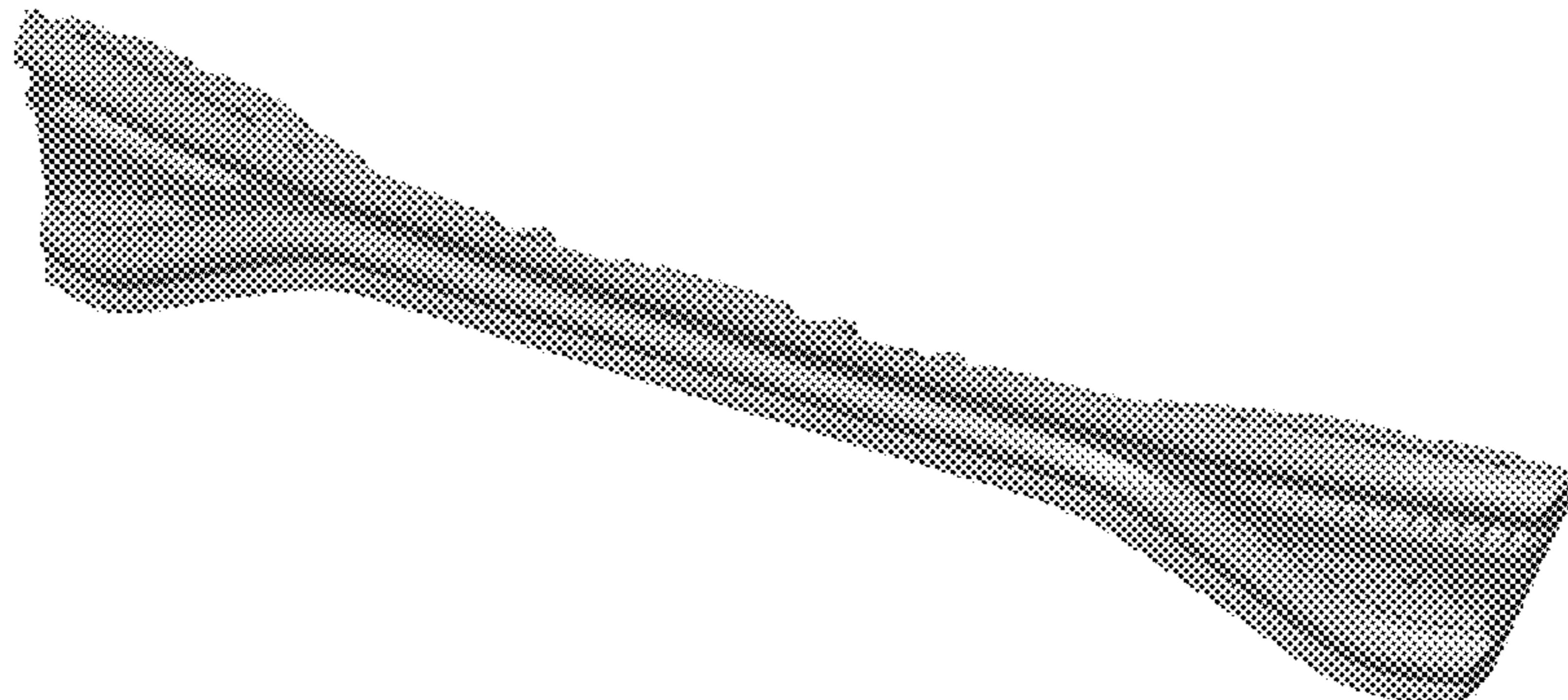
(57) **CLAIM**

The ornamental design for a rear combination lamp for cars, as shown and described.

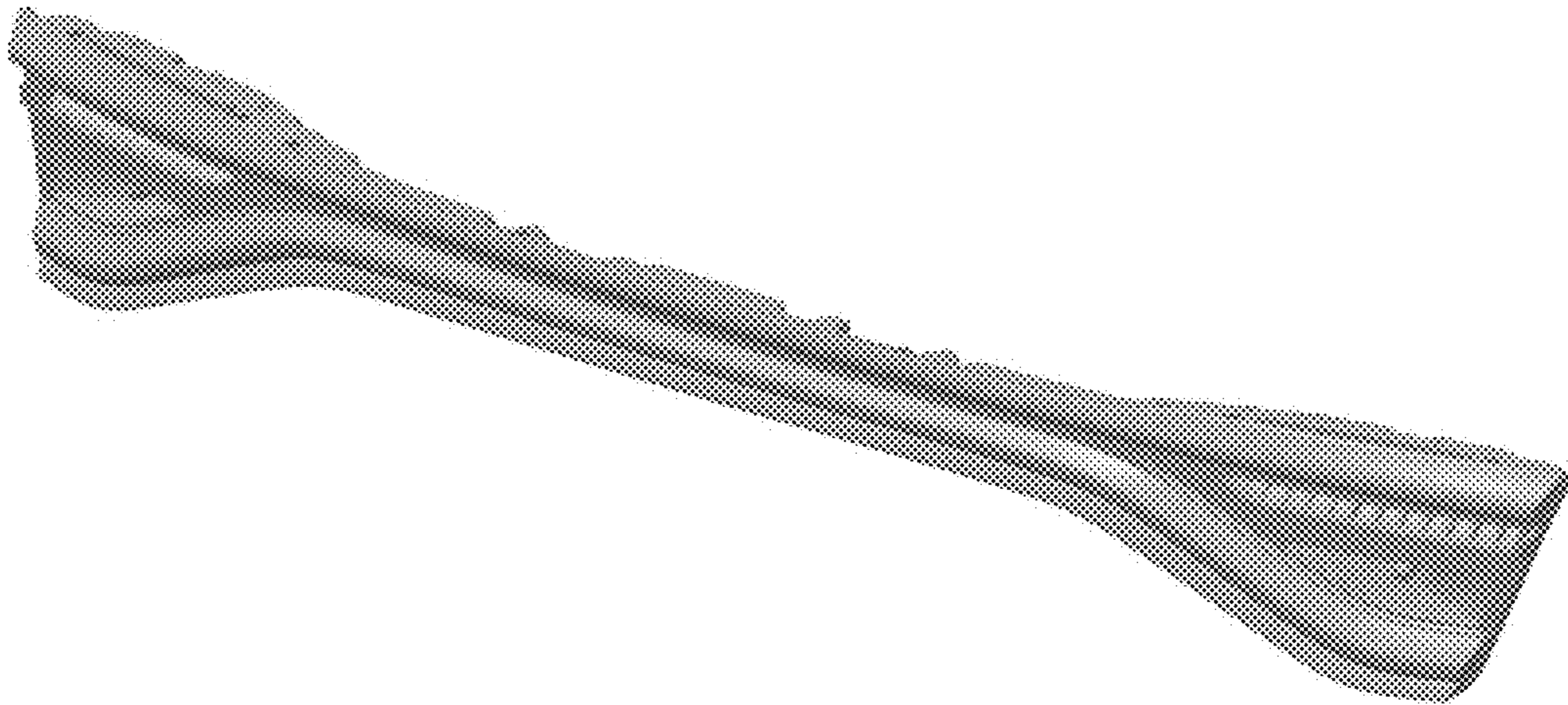
DESCRIPTION

1. Rear combination lamp for cars
- 1.1 is a top, front, and right side perspective view of a rear combination lamp for cars showing our new design;

- 1.7 is a bottom plan view thereof.

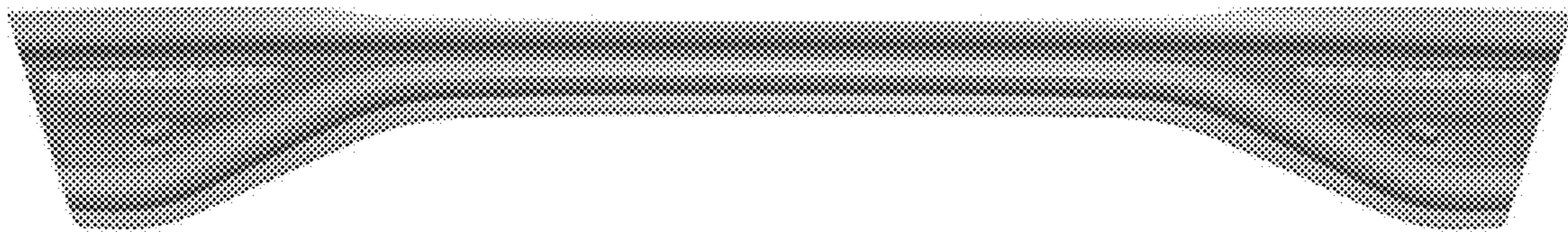

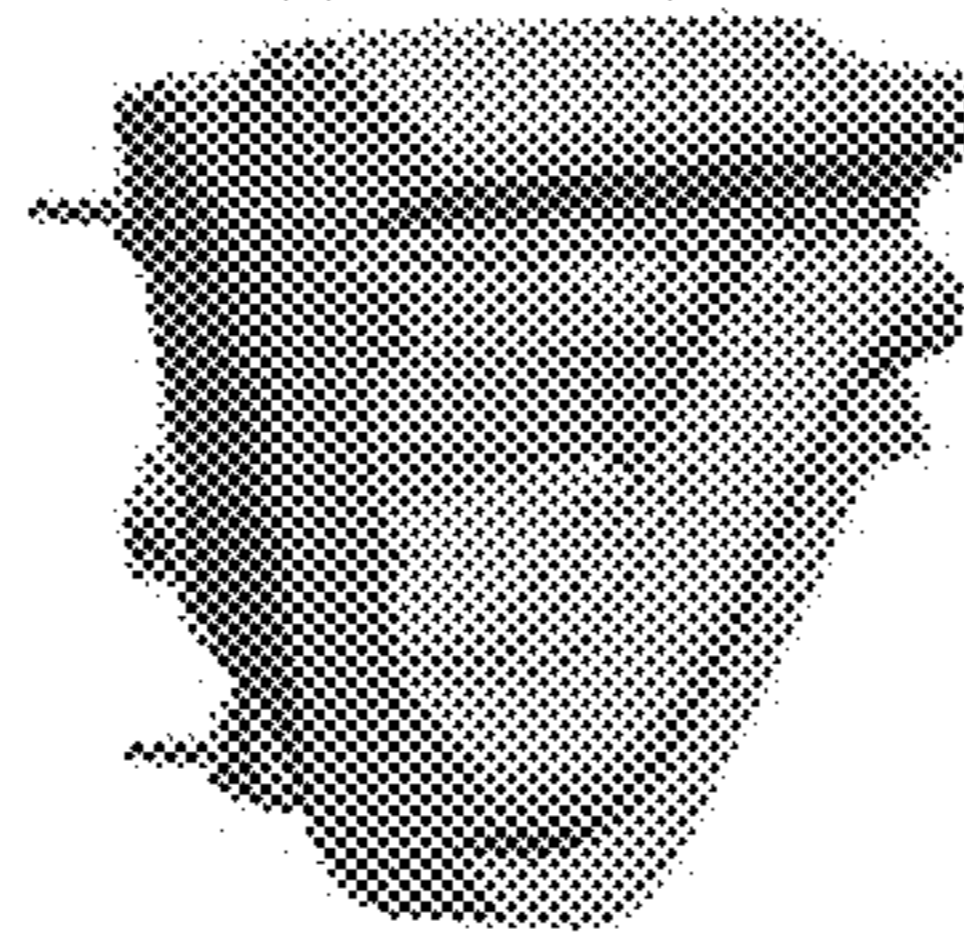

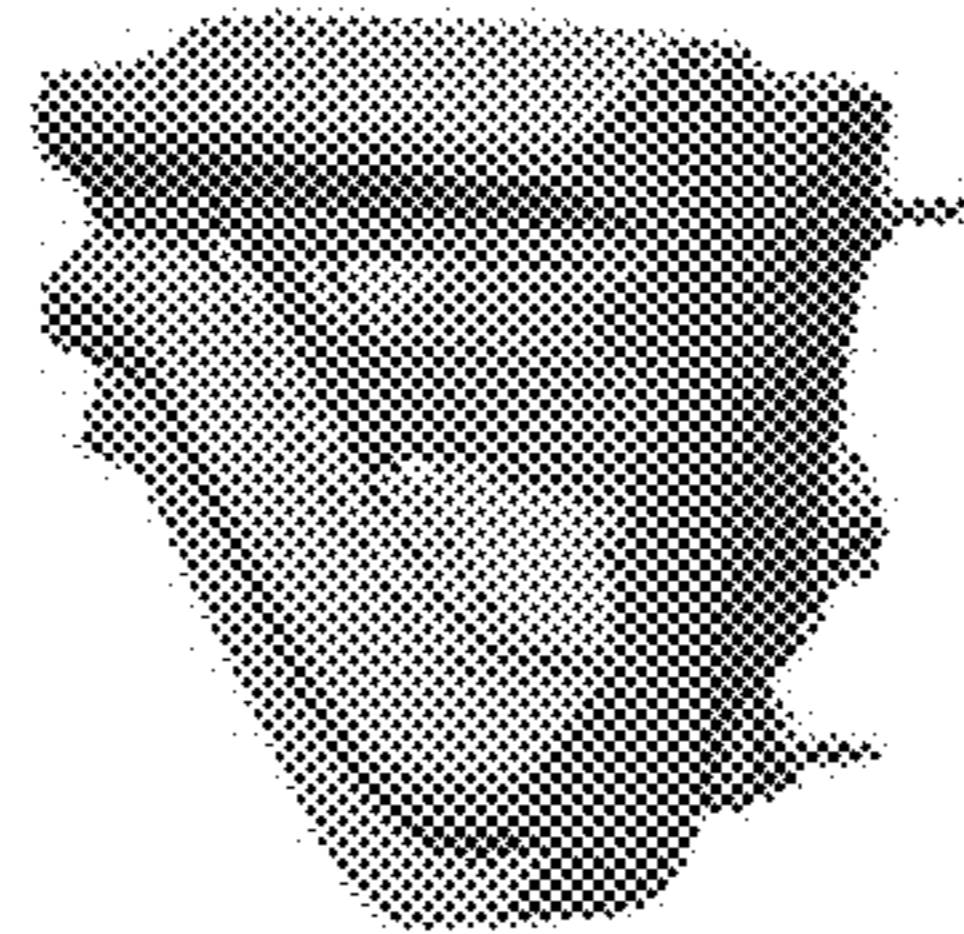

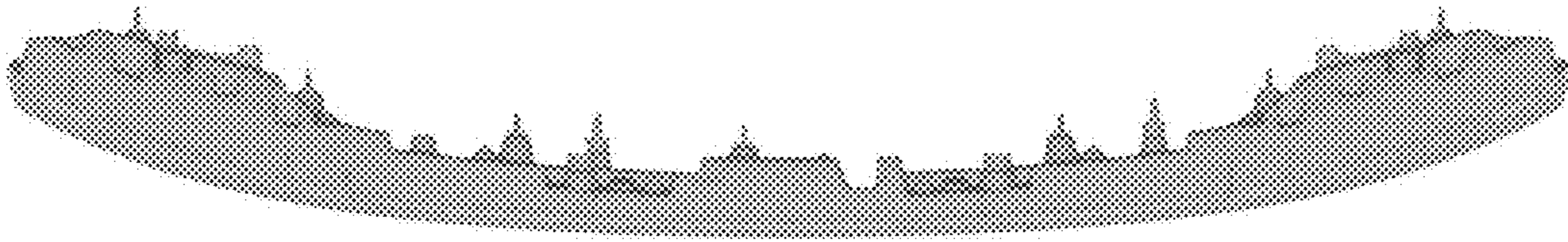
