The ornamental design for a cigar cutter, as shown and described.

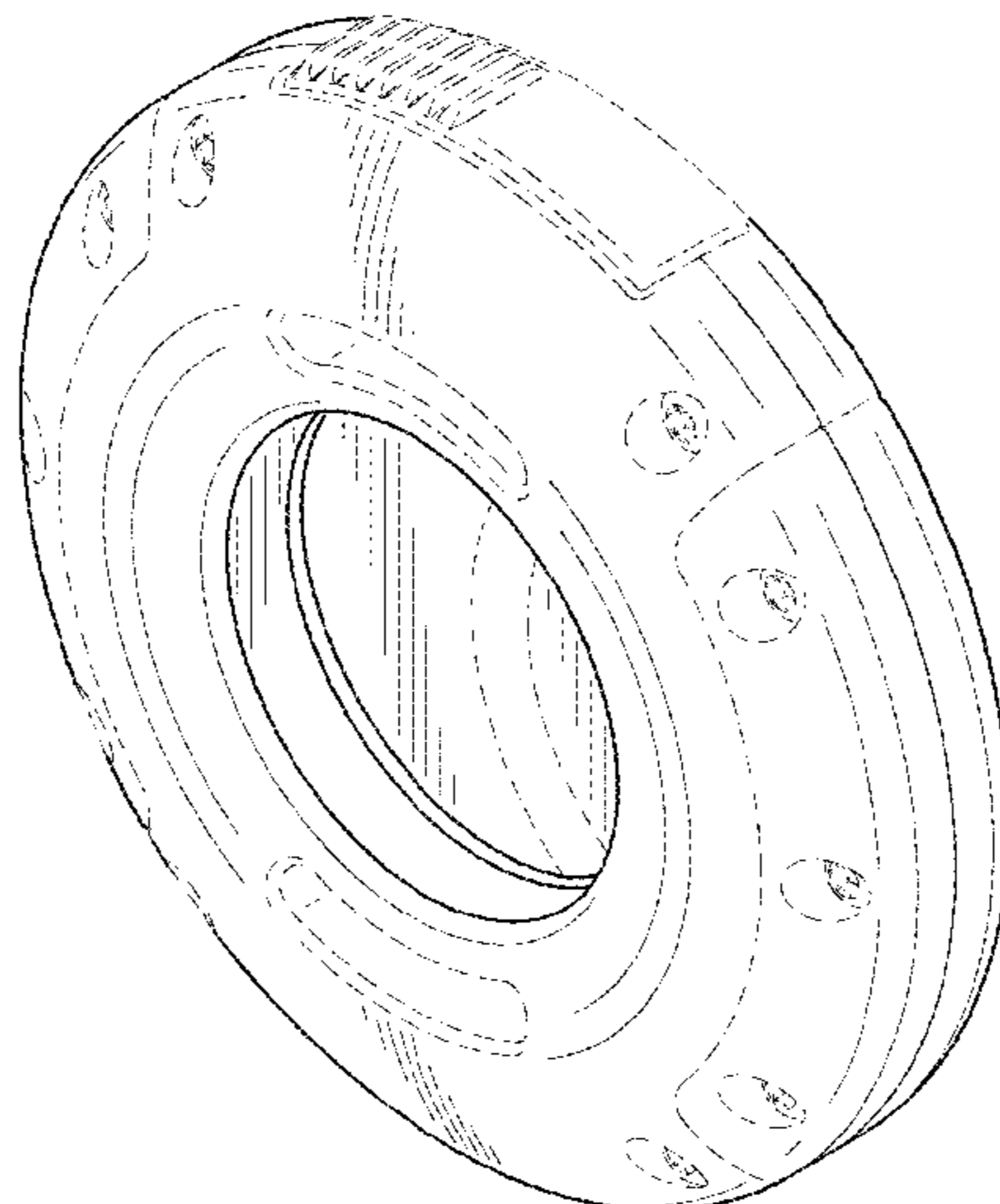
DESCRIPTION

FIG. 1 is a perspective view showing the cigar cutter in accordance with the present invention;
FIG. 2 is a front elevation view of the cigar cutter of FIG. 1;
FIG. 3 is a rear elevation view of the cigar cutter of FIG. 1;
FIG. 4 is a top view of the cigar cutter of FIG. 1;
FIG. 5 is a bottom view of the cigar cutter of FIG. 1;
FIG. 6 is right side view of the cigar cutter of FIG. 1; and,
FIG. 7 is a left side view of the cigar cutter of FIG. 1.
The broken lines in the drawings depict portions of the cutter that form no part of the claimed design.
The broken lines immediately adjacent to shaded surfaces form a boundary of the claim.

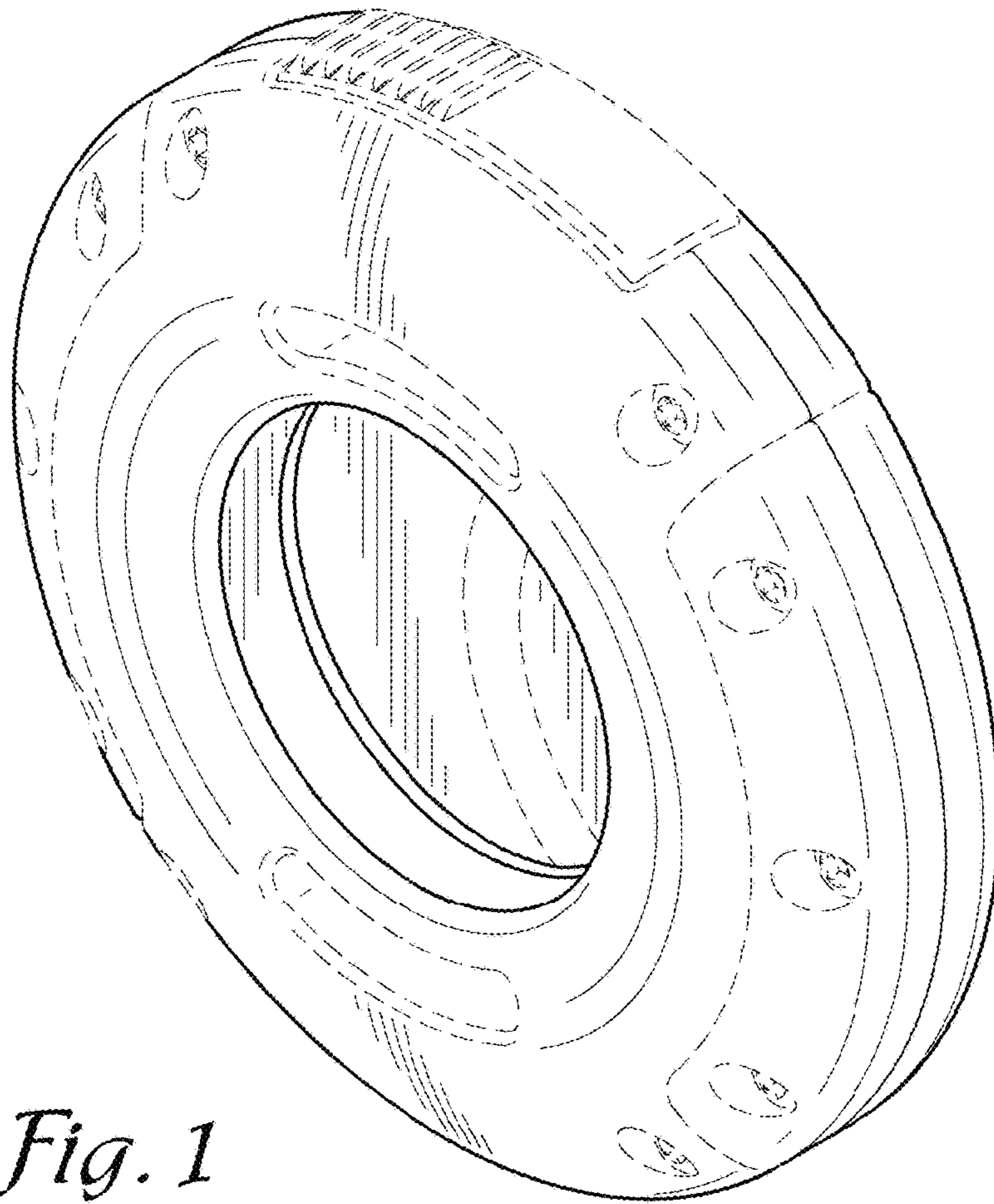

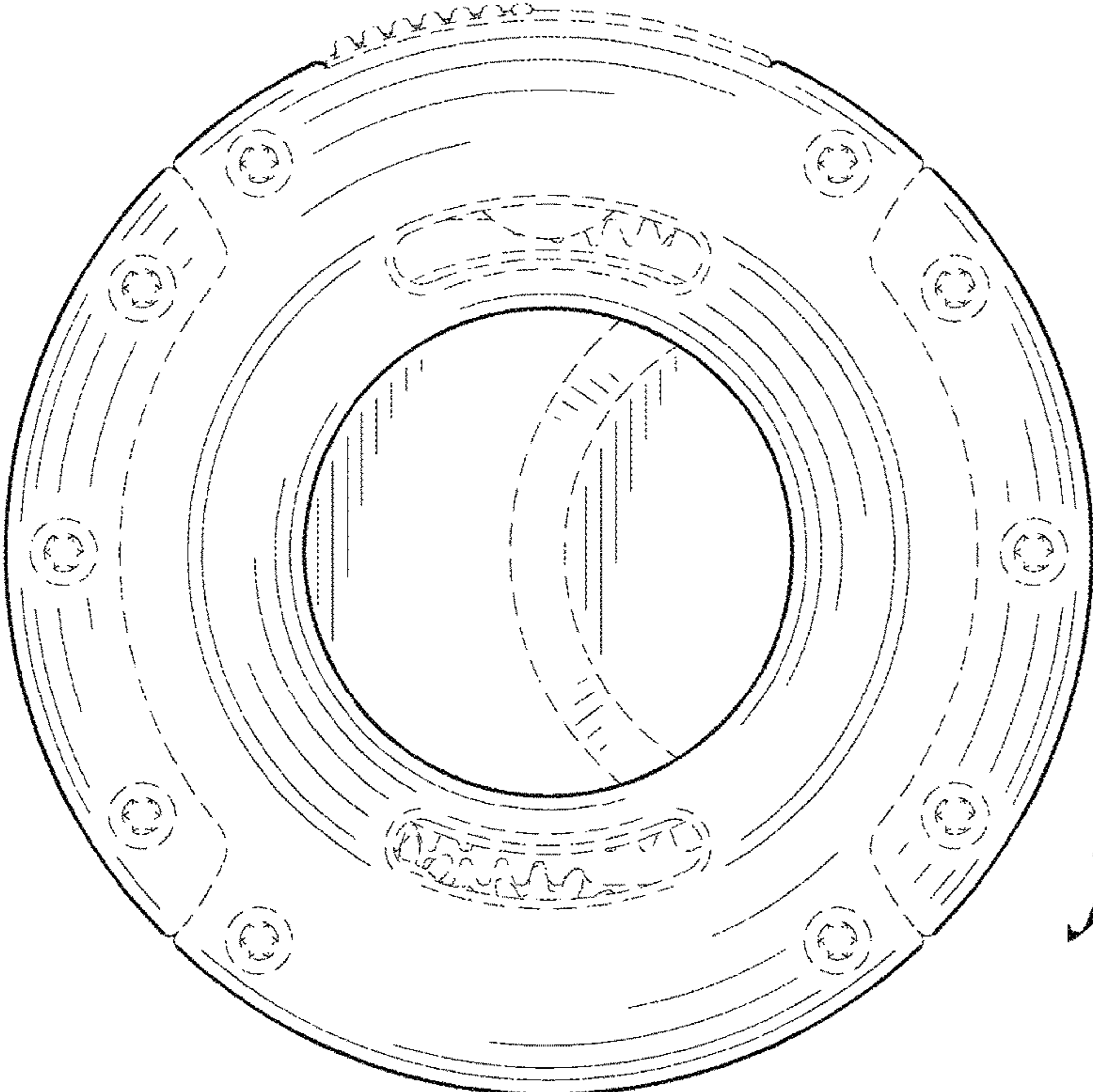

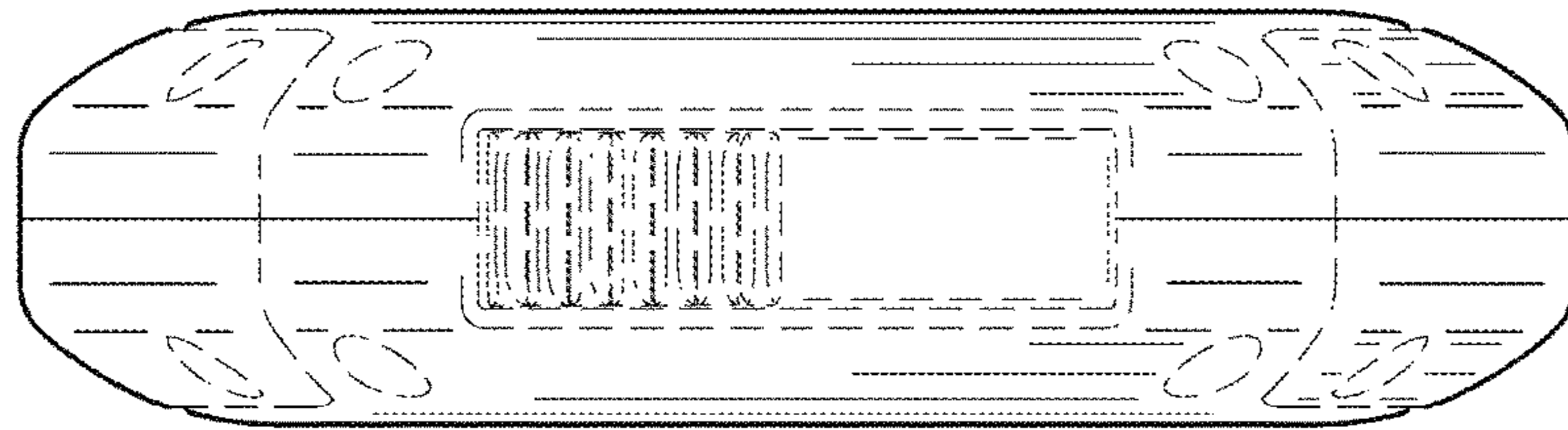

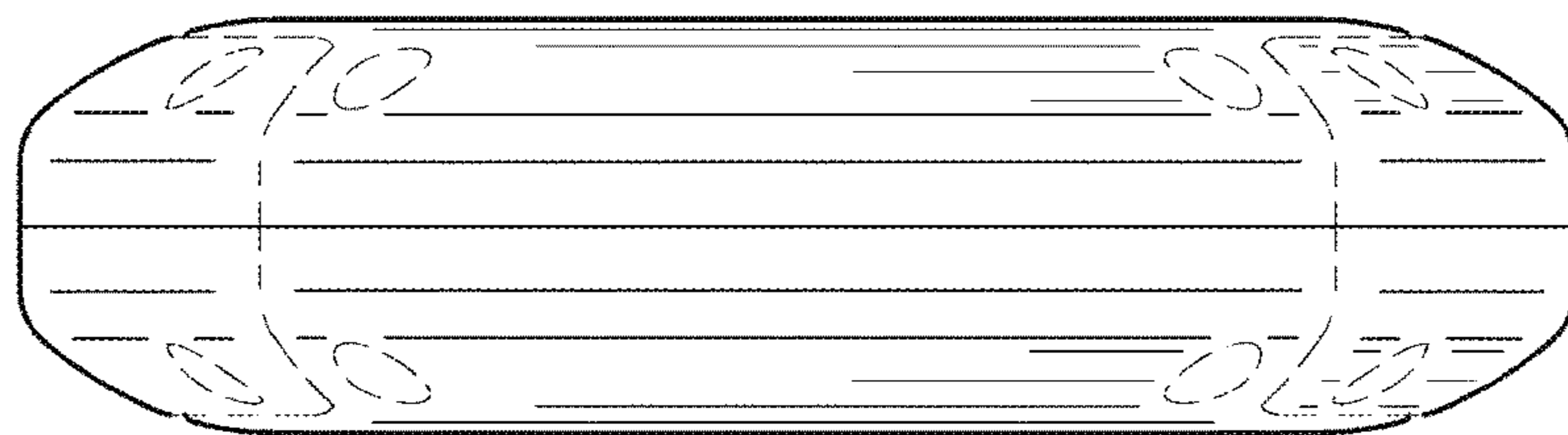

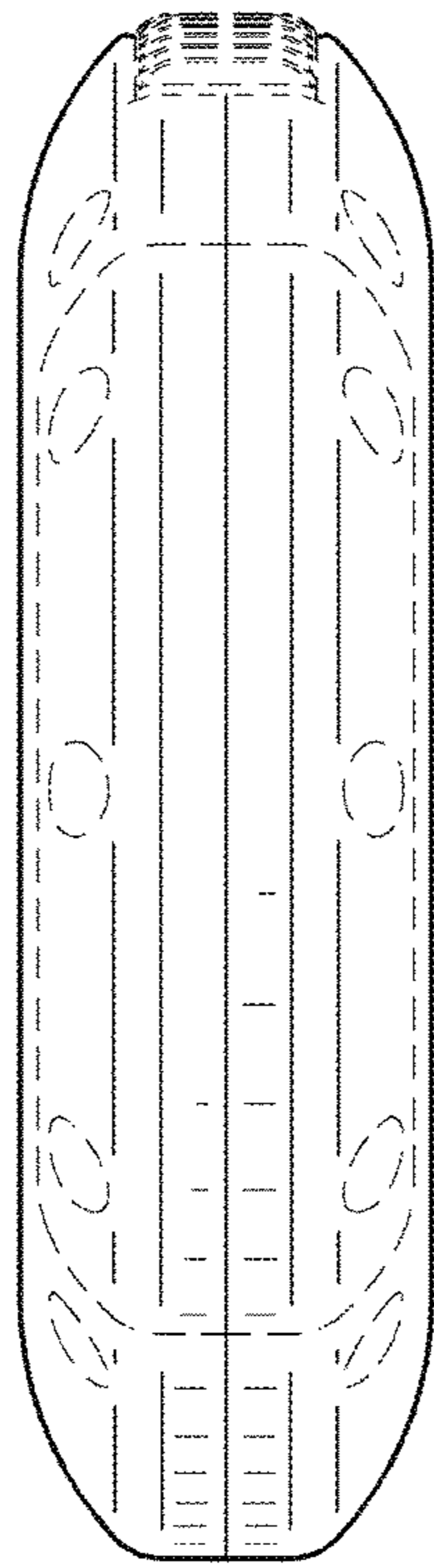

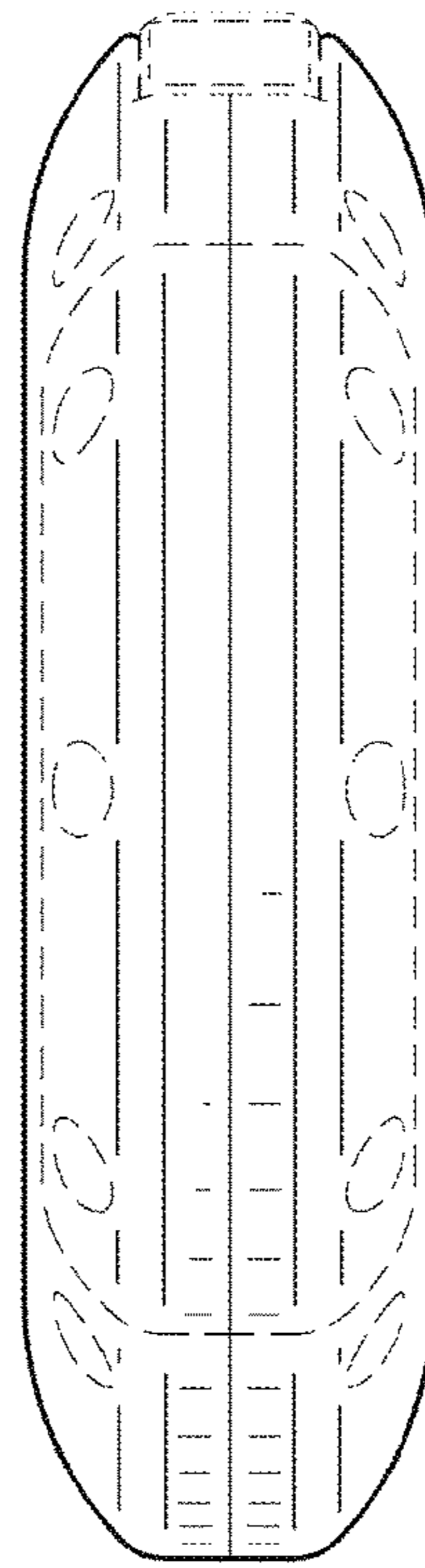
