(57) **CLAIM**

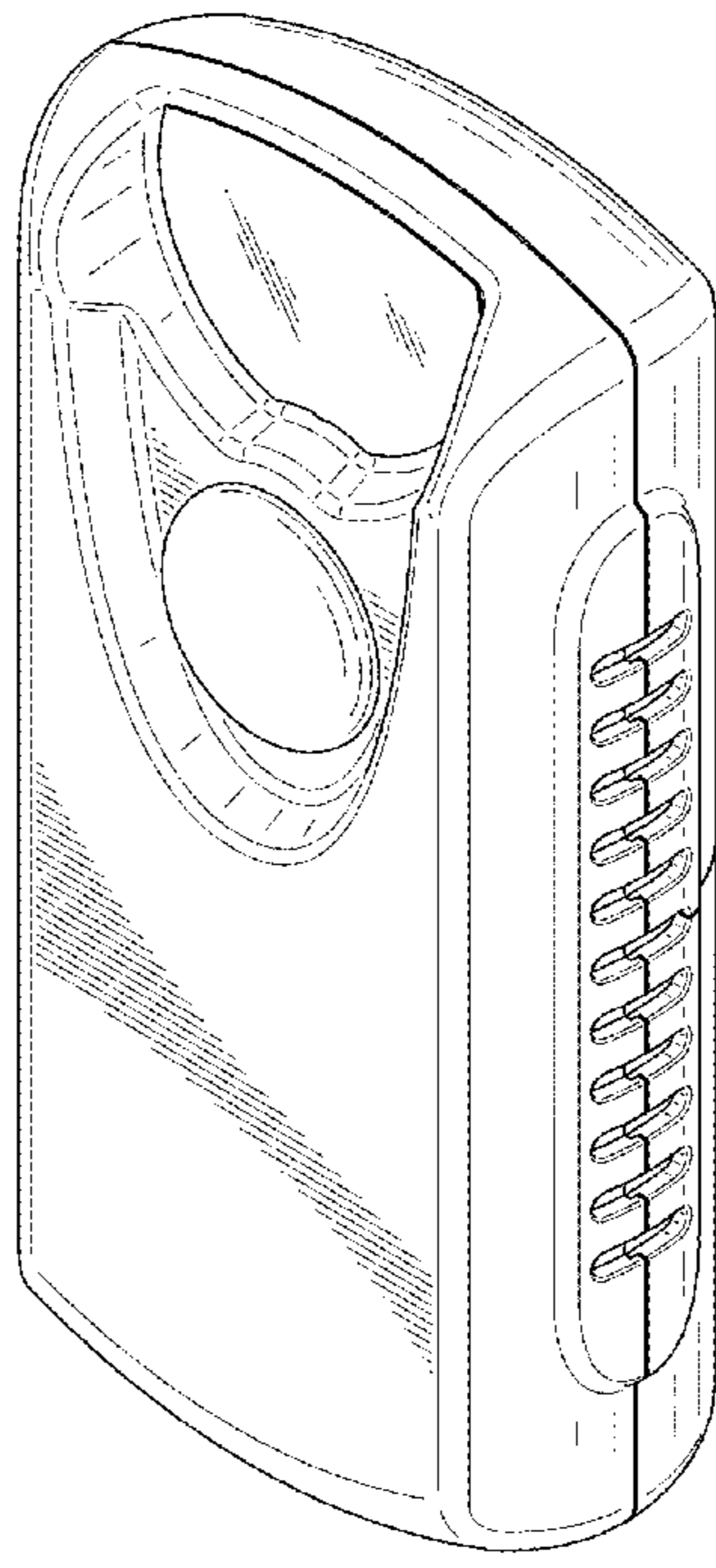
We claim the ornamental design for a nail drill housing, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and right side perspective view of a nail drill housing showing our new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a right side elevation view thereof, the left side elevation view being a mirror image;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.

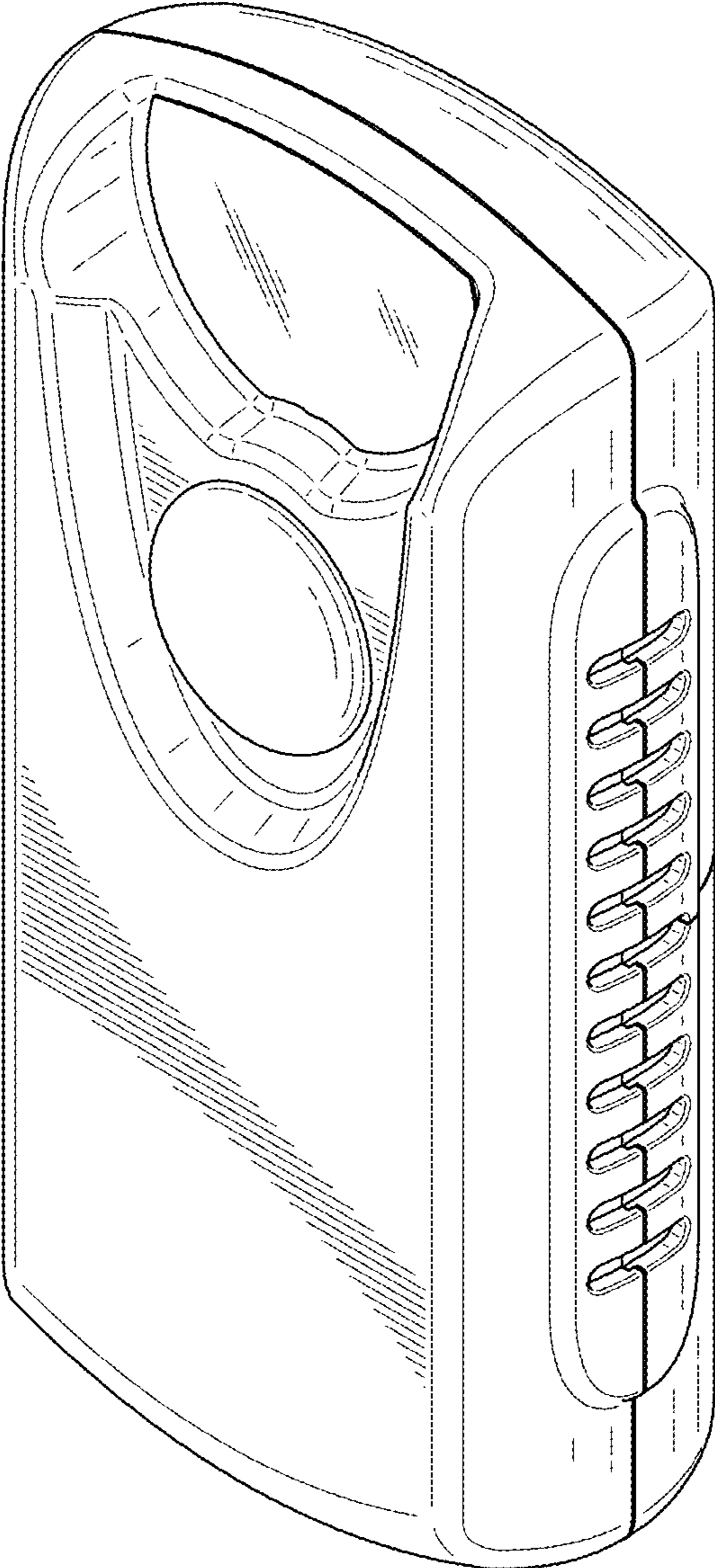

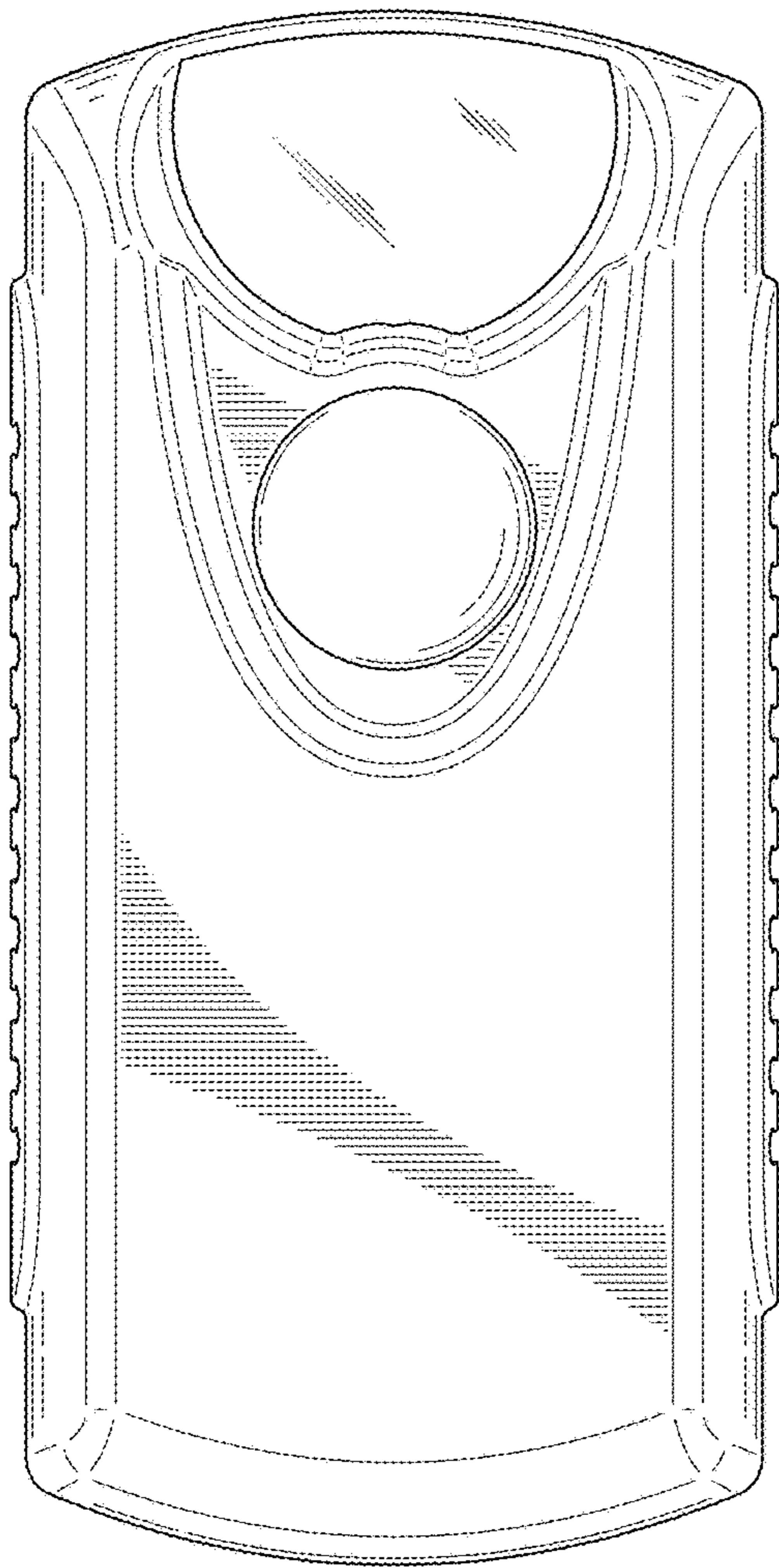

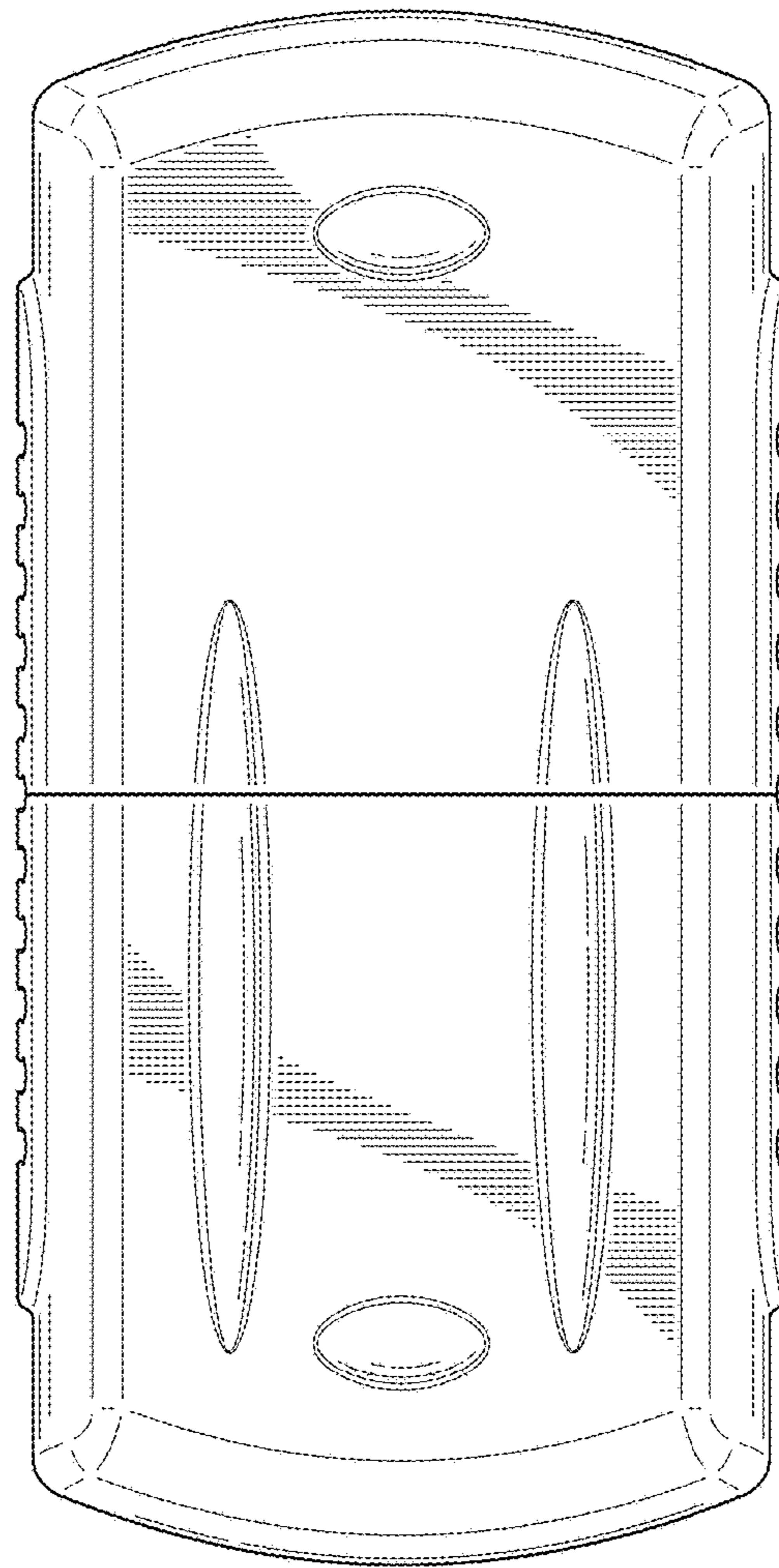

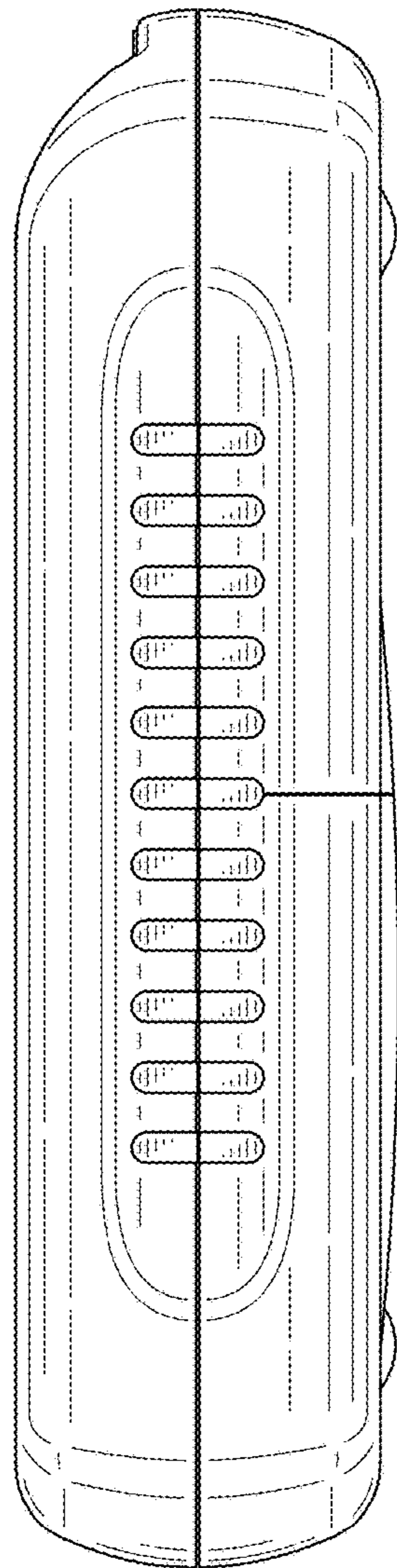

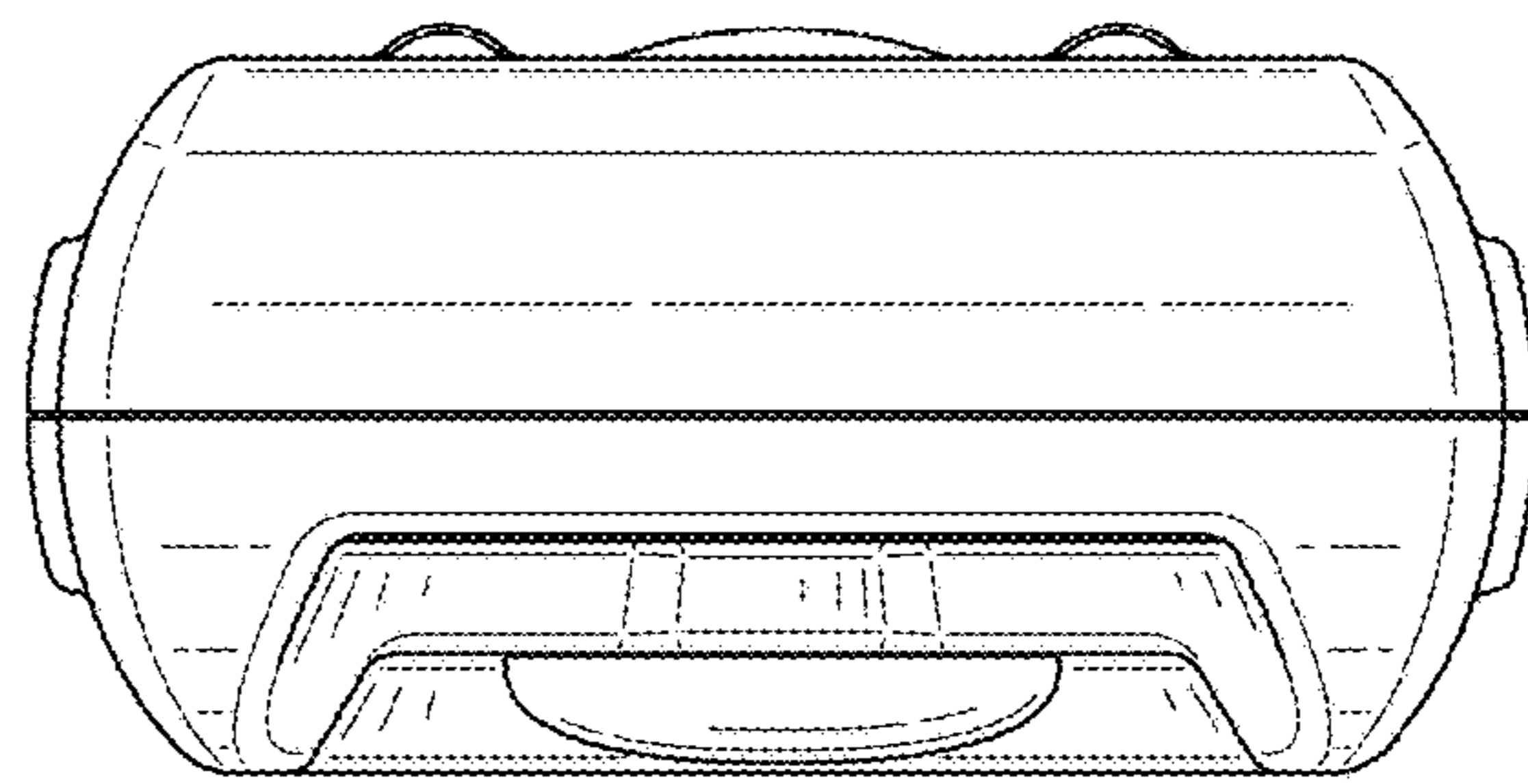

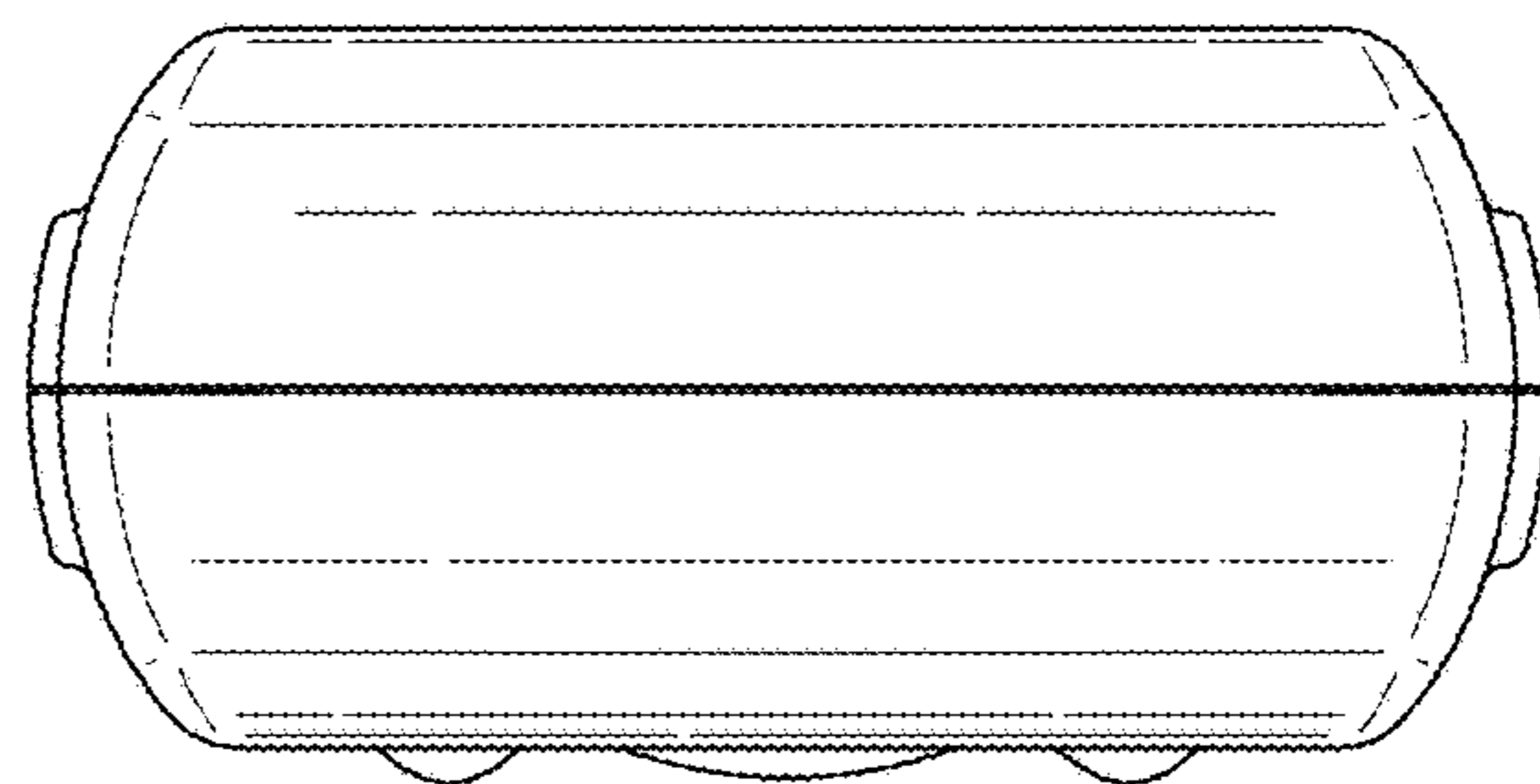
