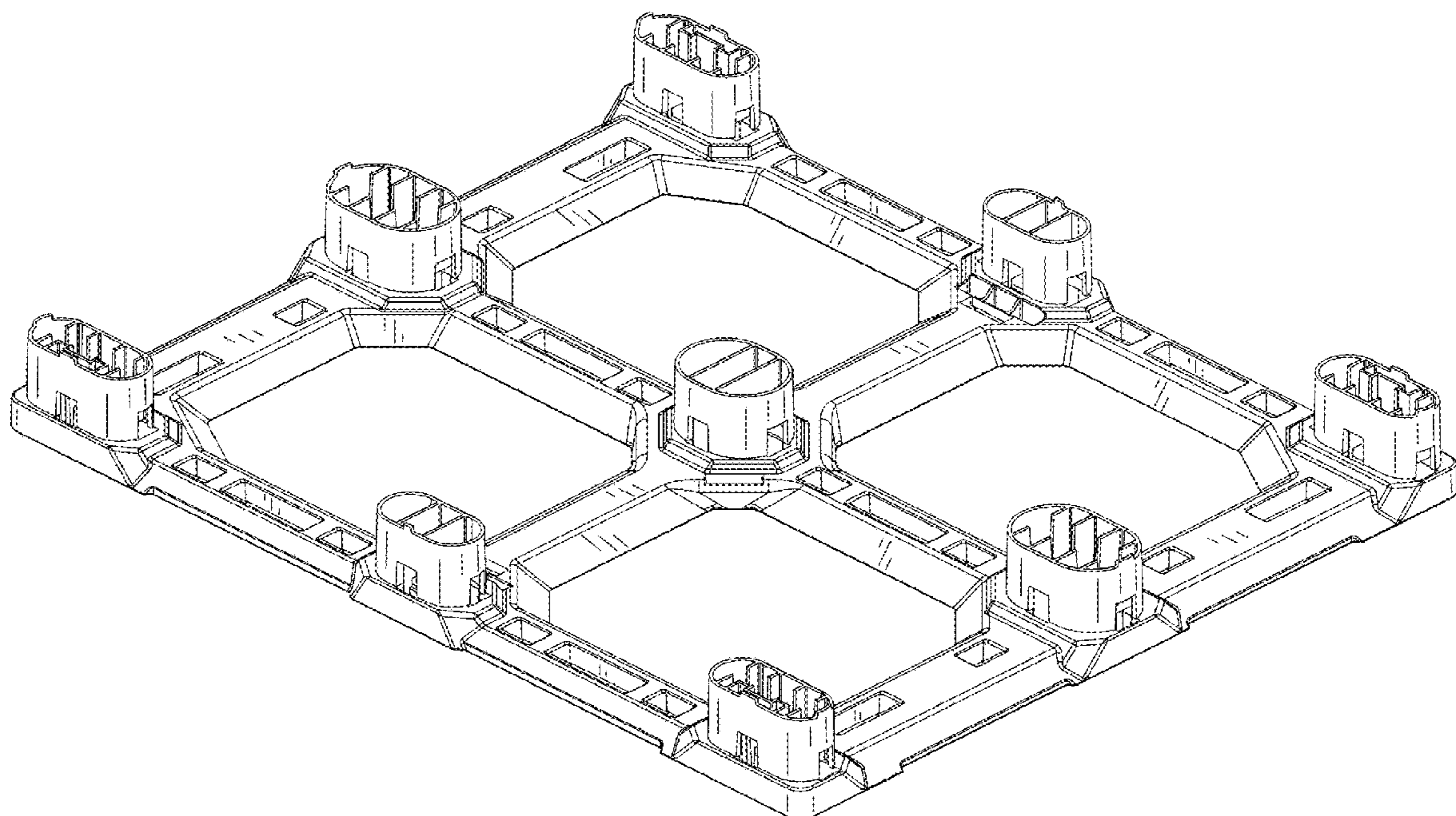
The ornamental design for a bottom deck of a pallet, as shown and described.

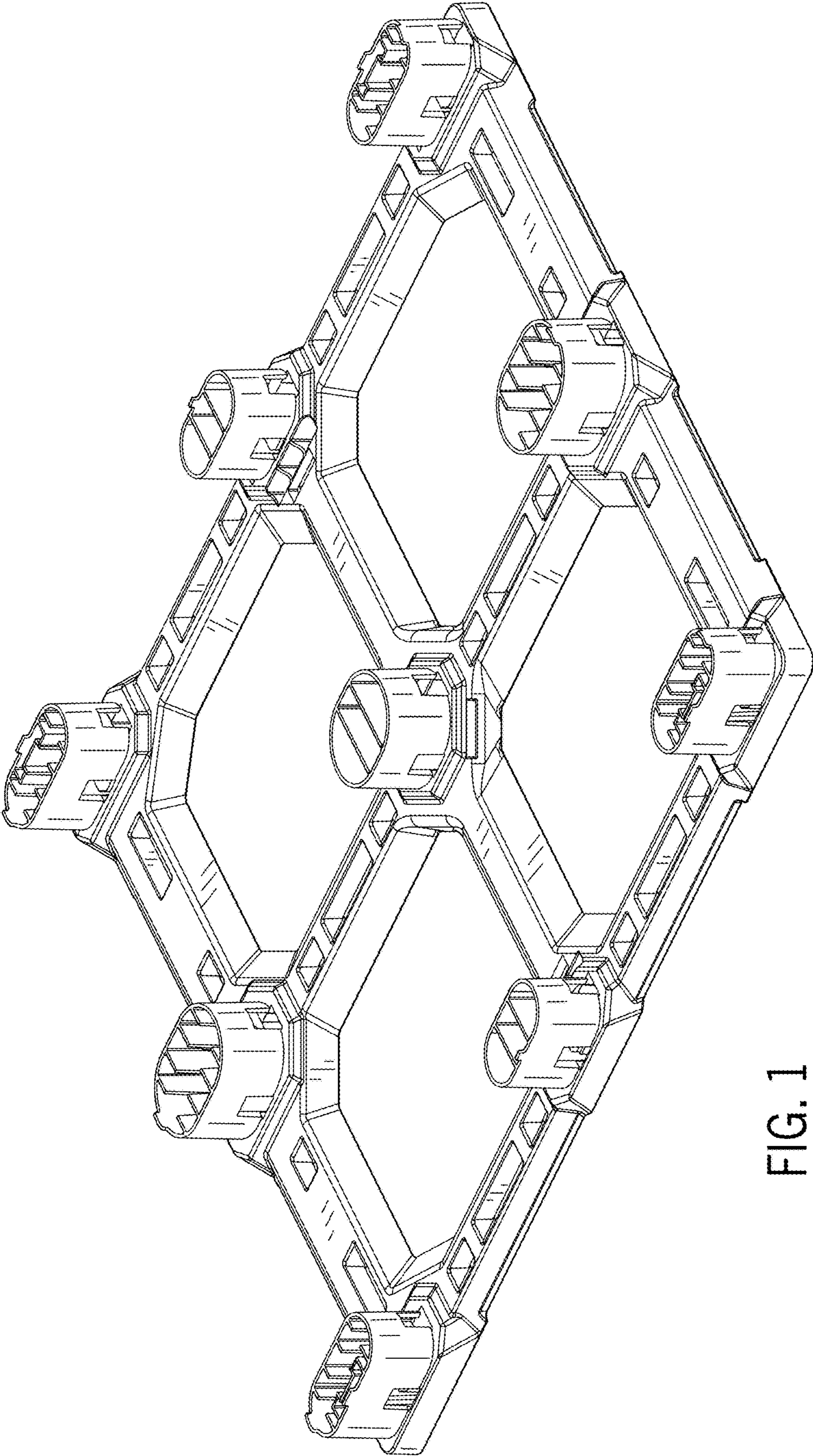

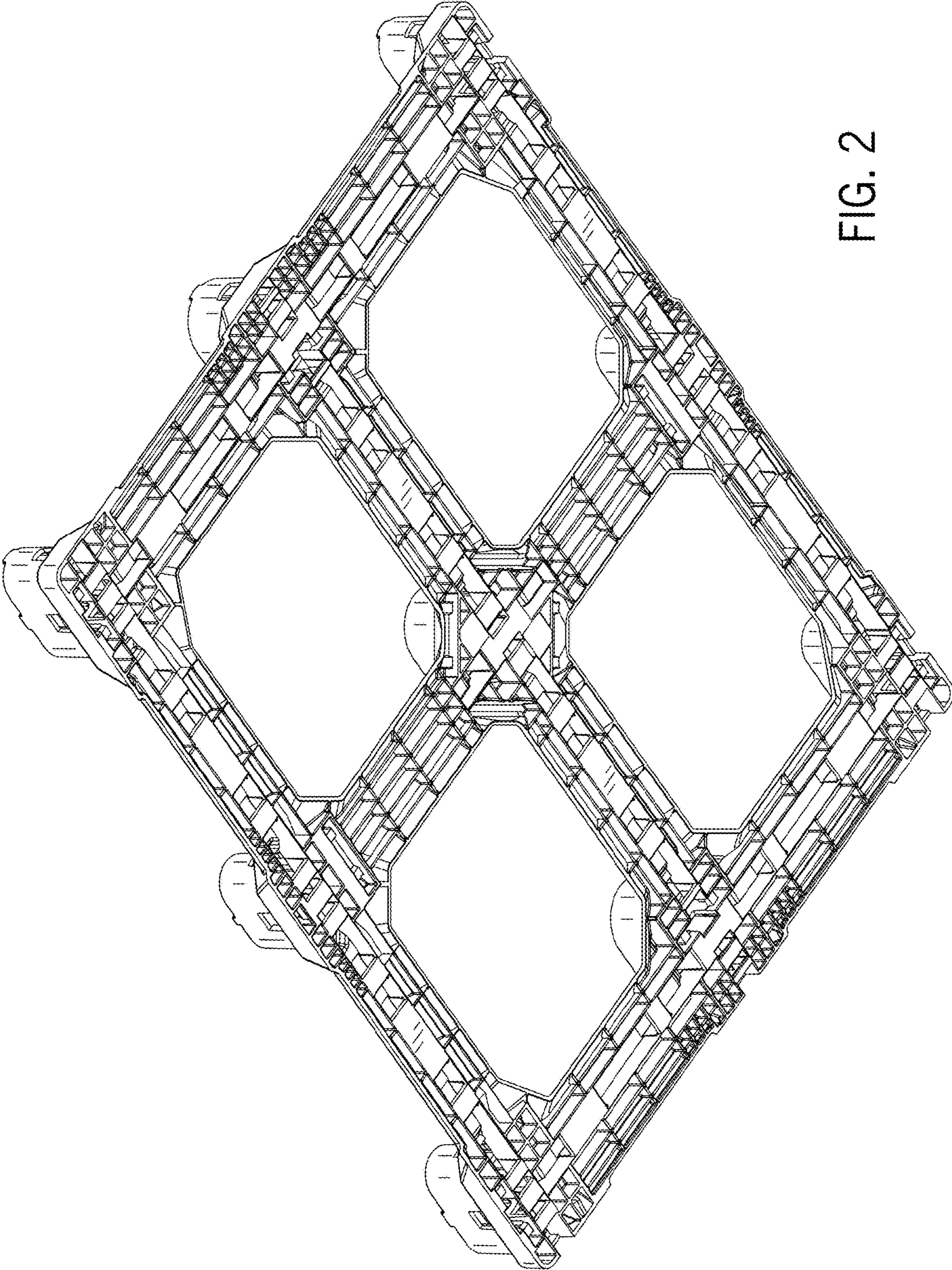

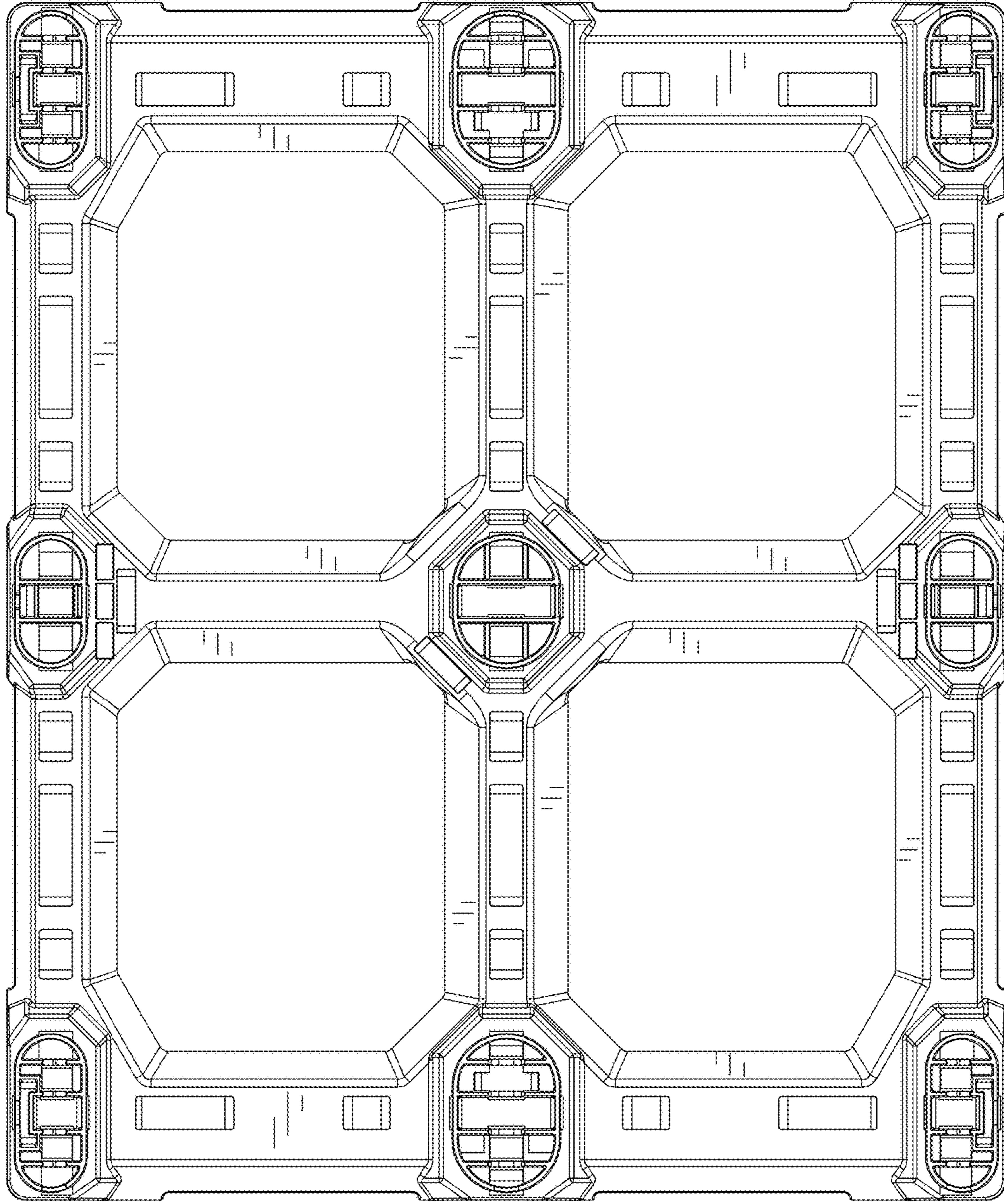

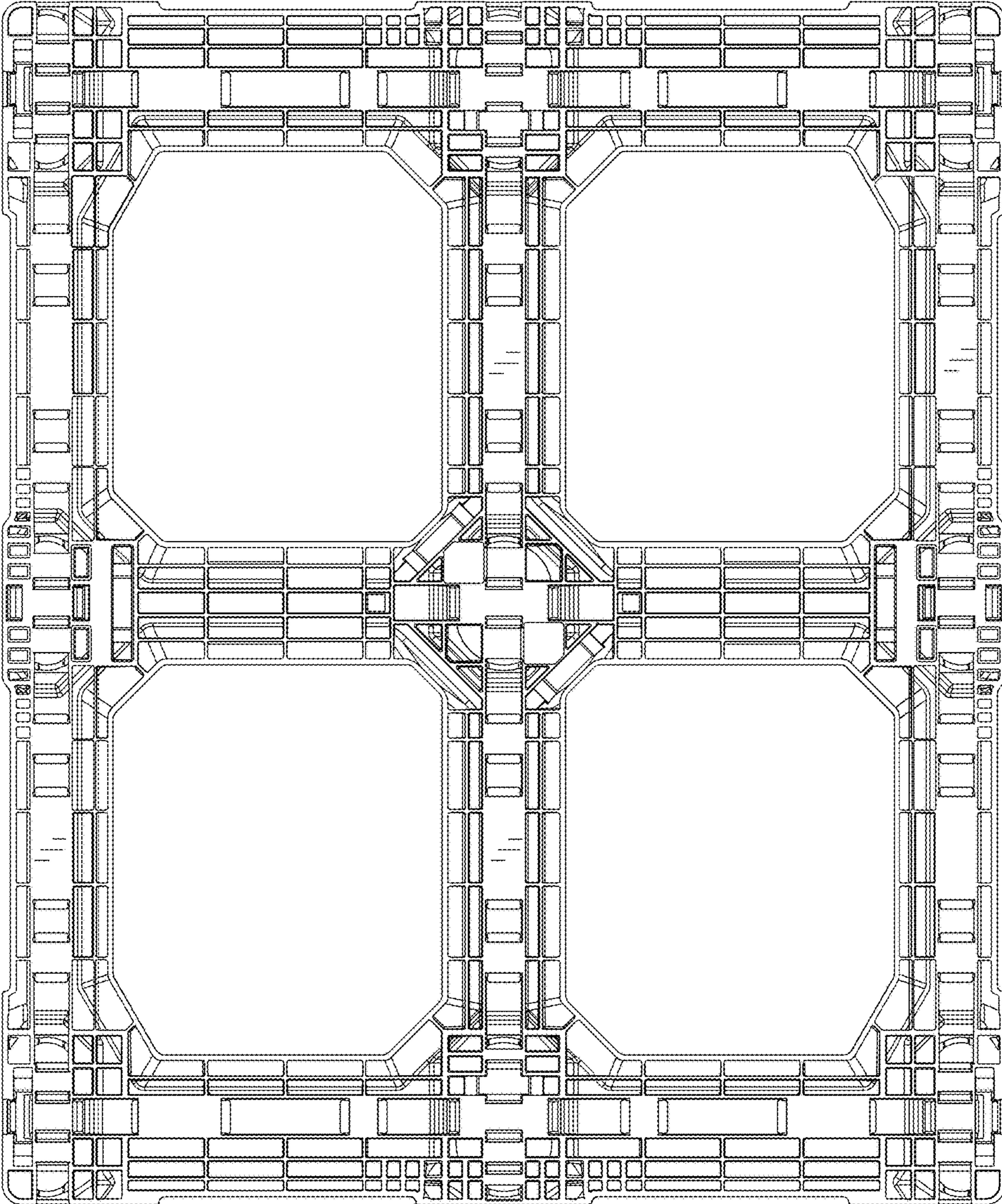

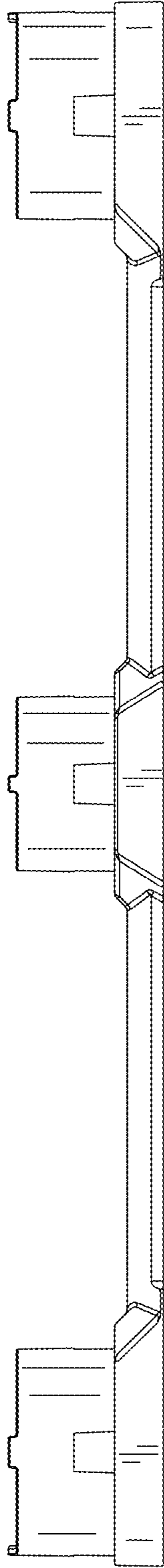

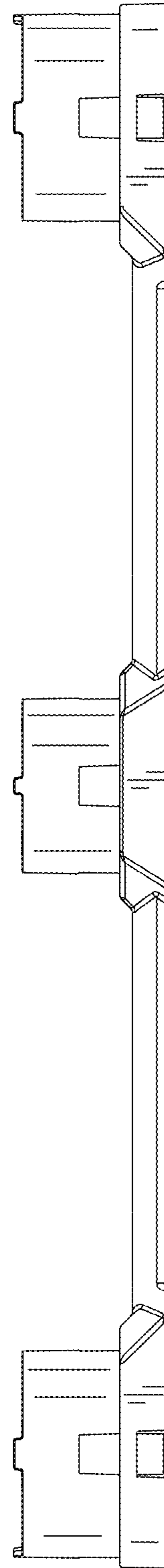

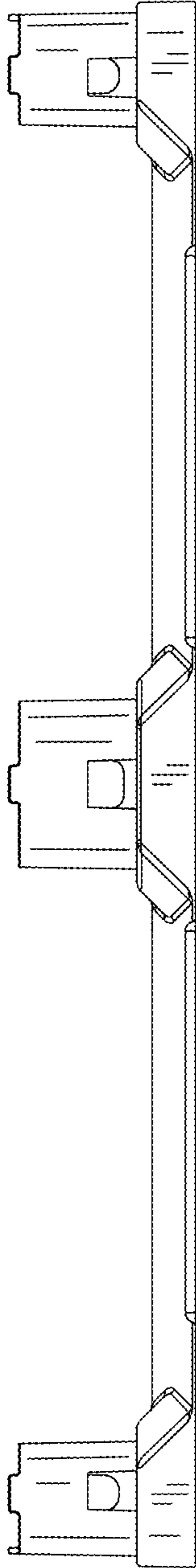

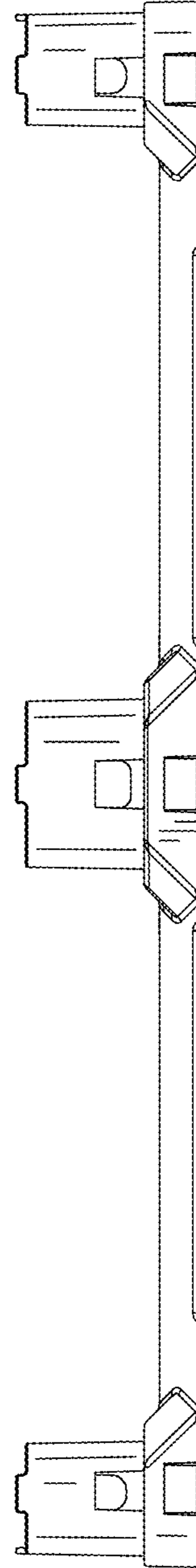
