The ornamental design for a two layers umbrella, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing my new design for a two layers umbrella;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a left side elevation view thereof;
FIG. 5 is a right side elevation view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a bottom perspective view showing the umbrella; and,
FIG. 9 is a plan view showing the two layers umbrella in a windblown condition.
The portions of the umbrella cloth shown in the two layers umbrella in broken lines are the stitching lines for stitching the decoration portion.

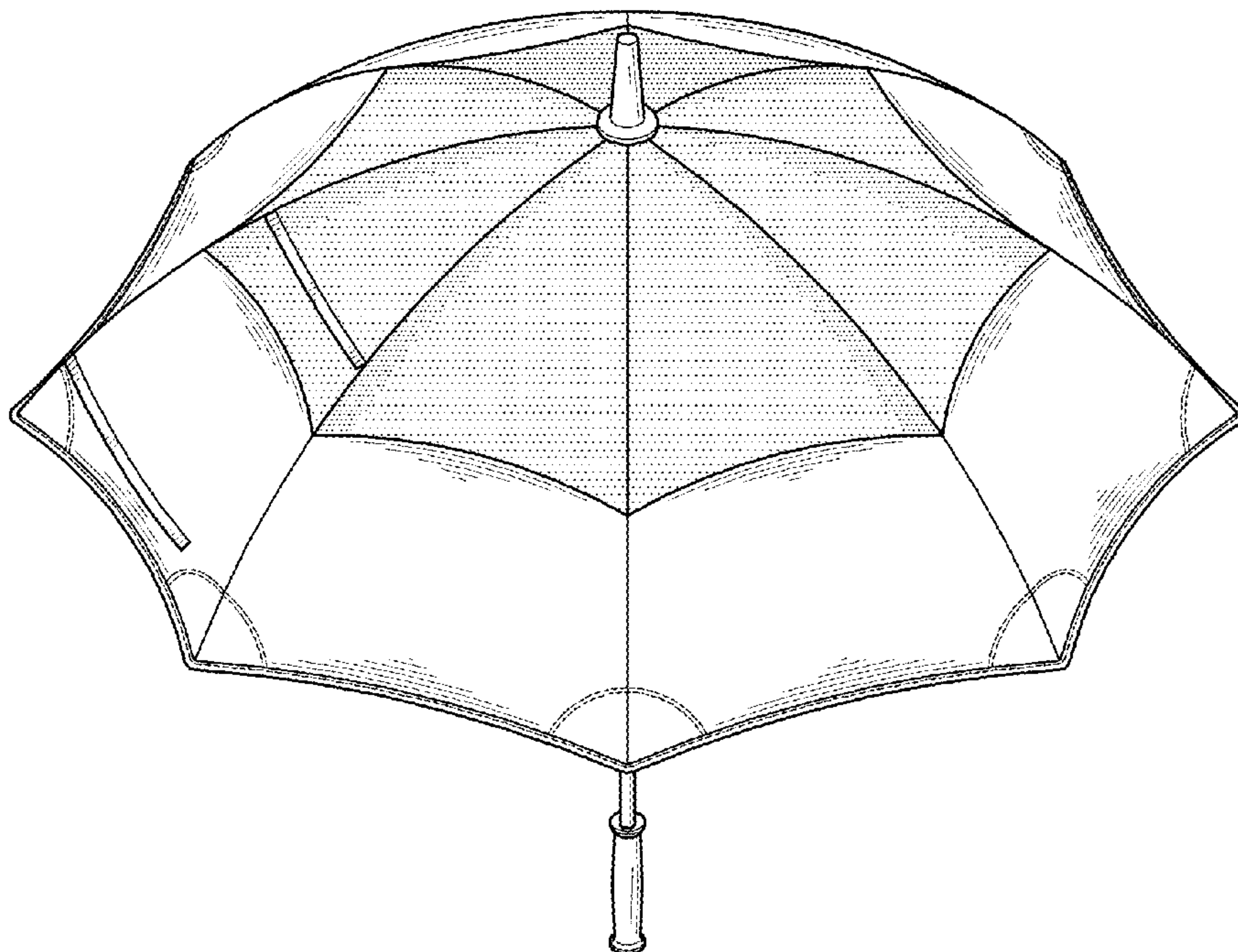

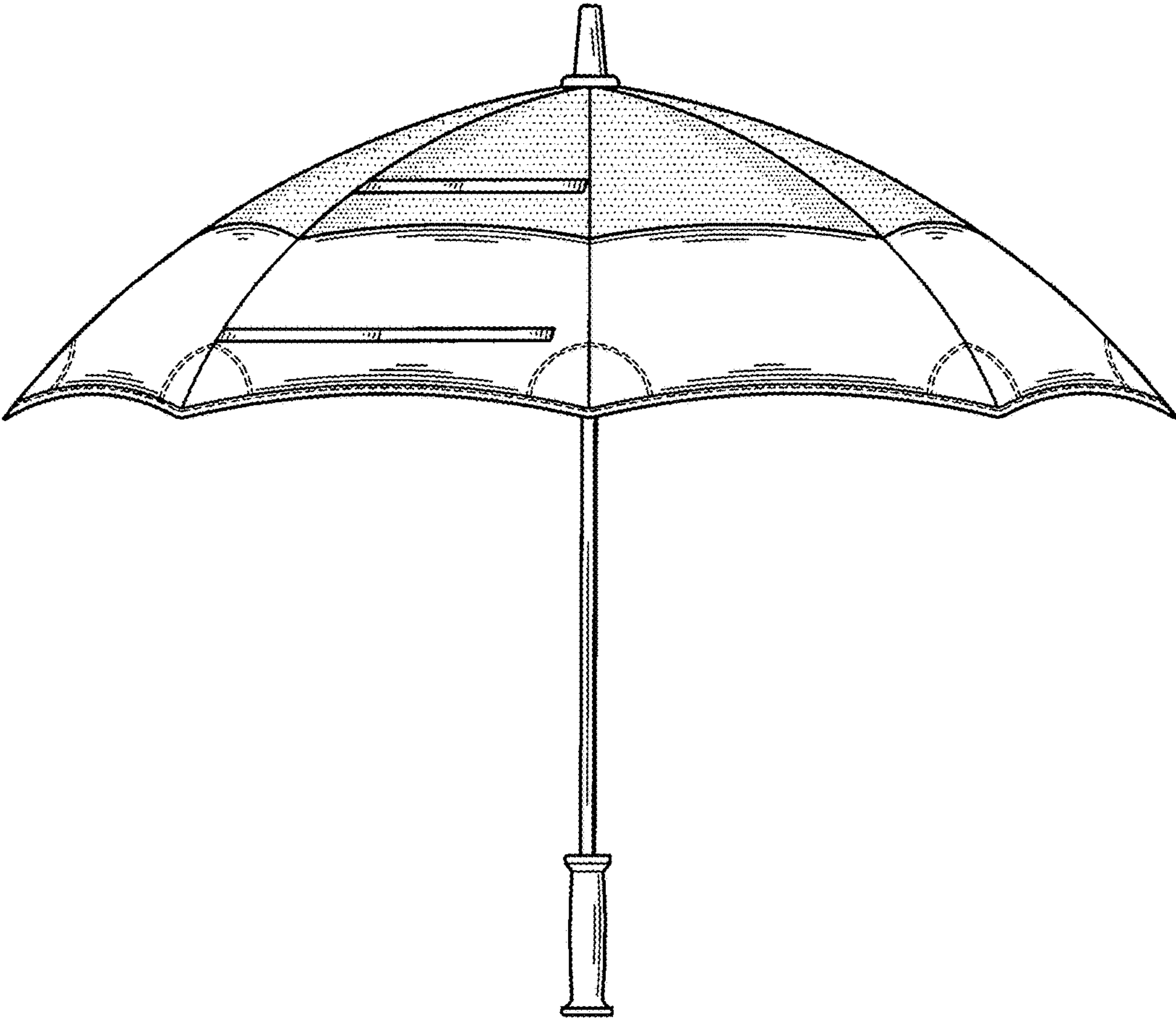

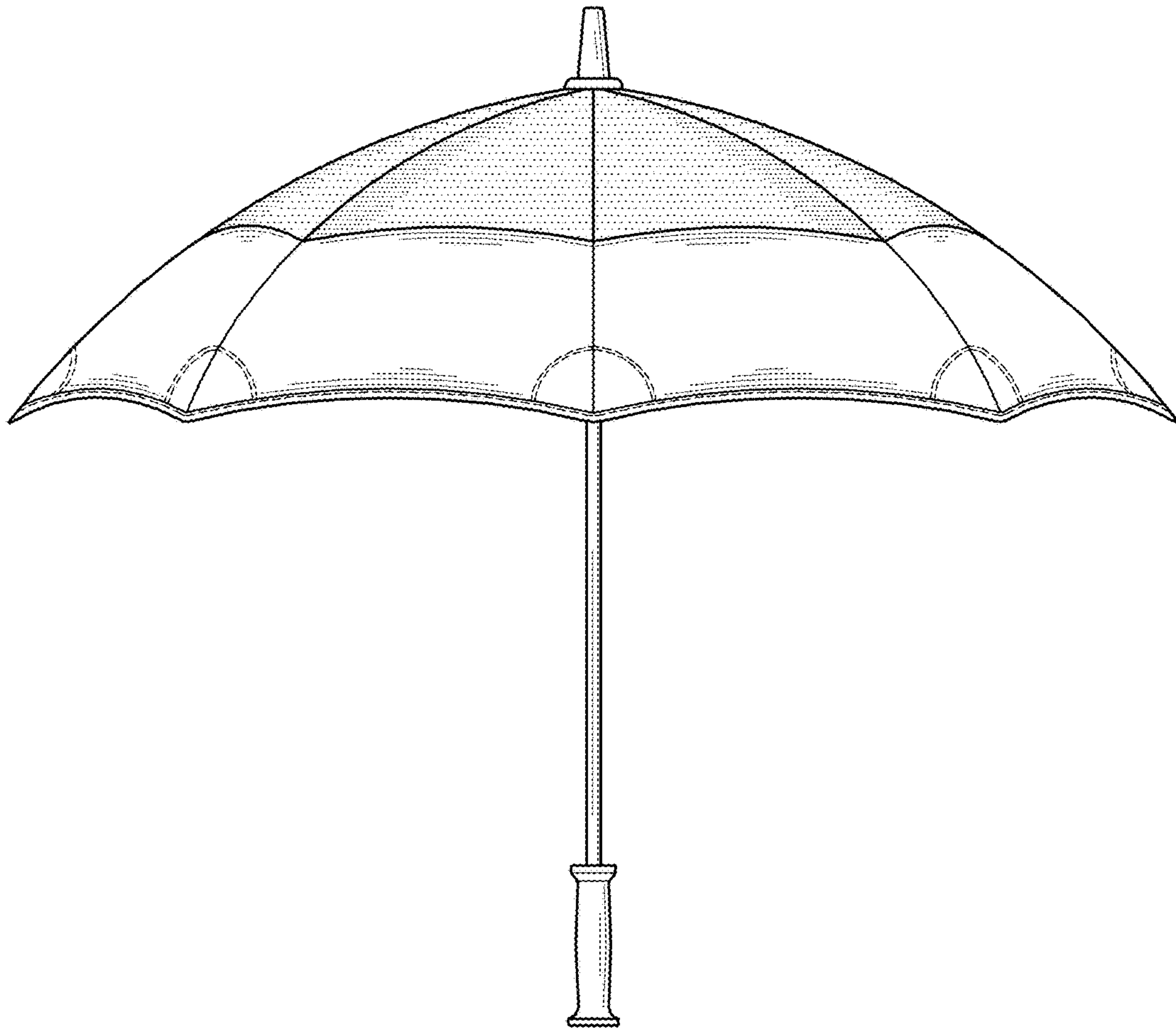

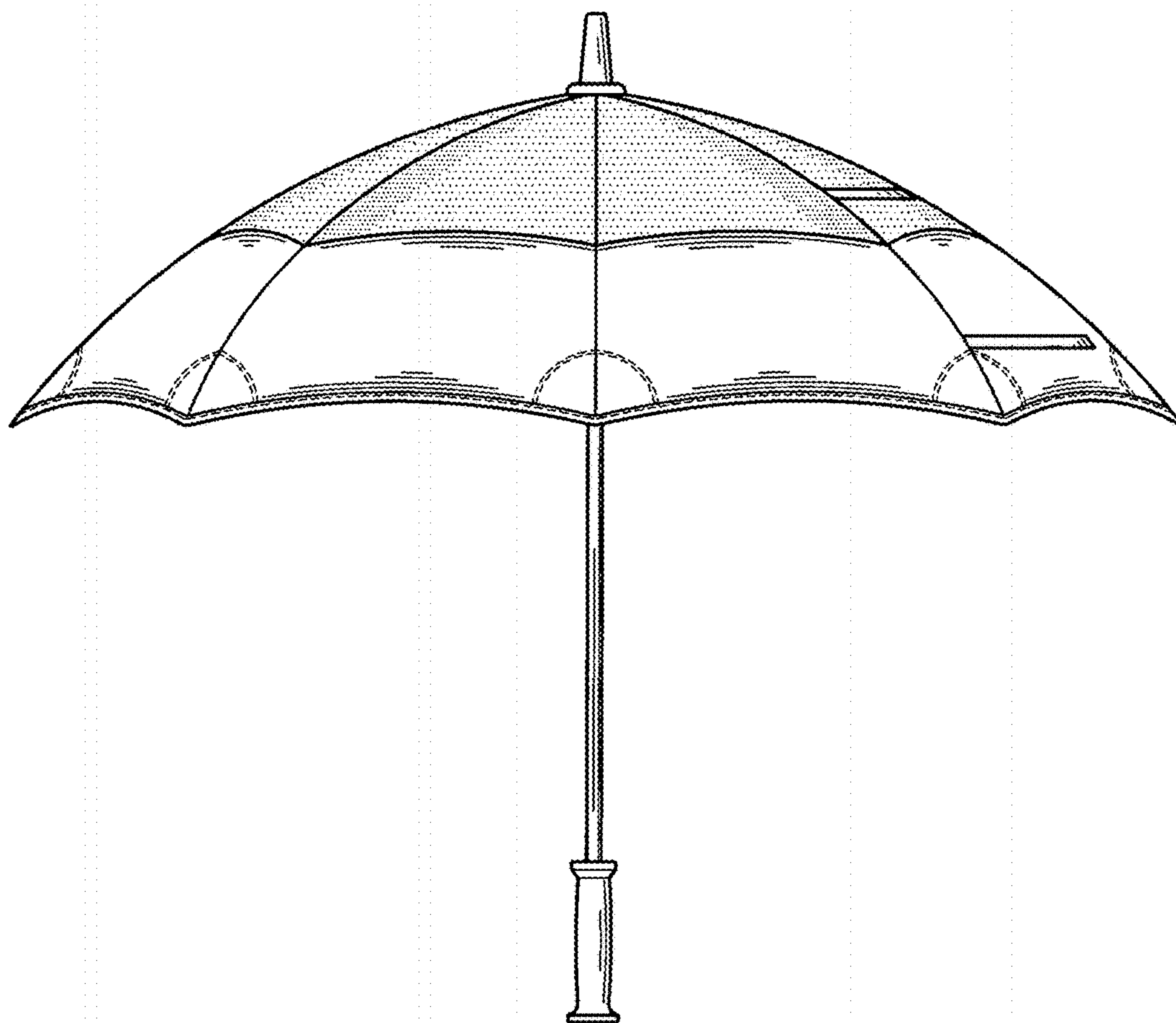

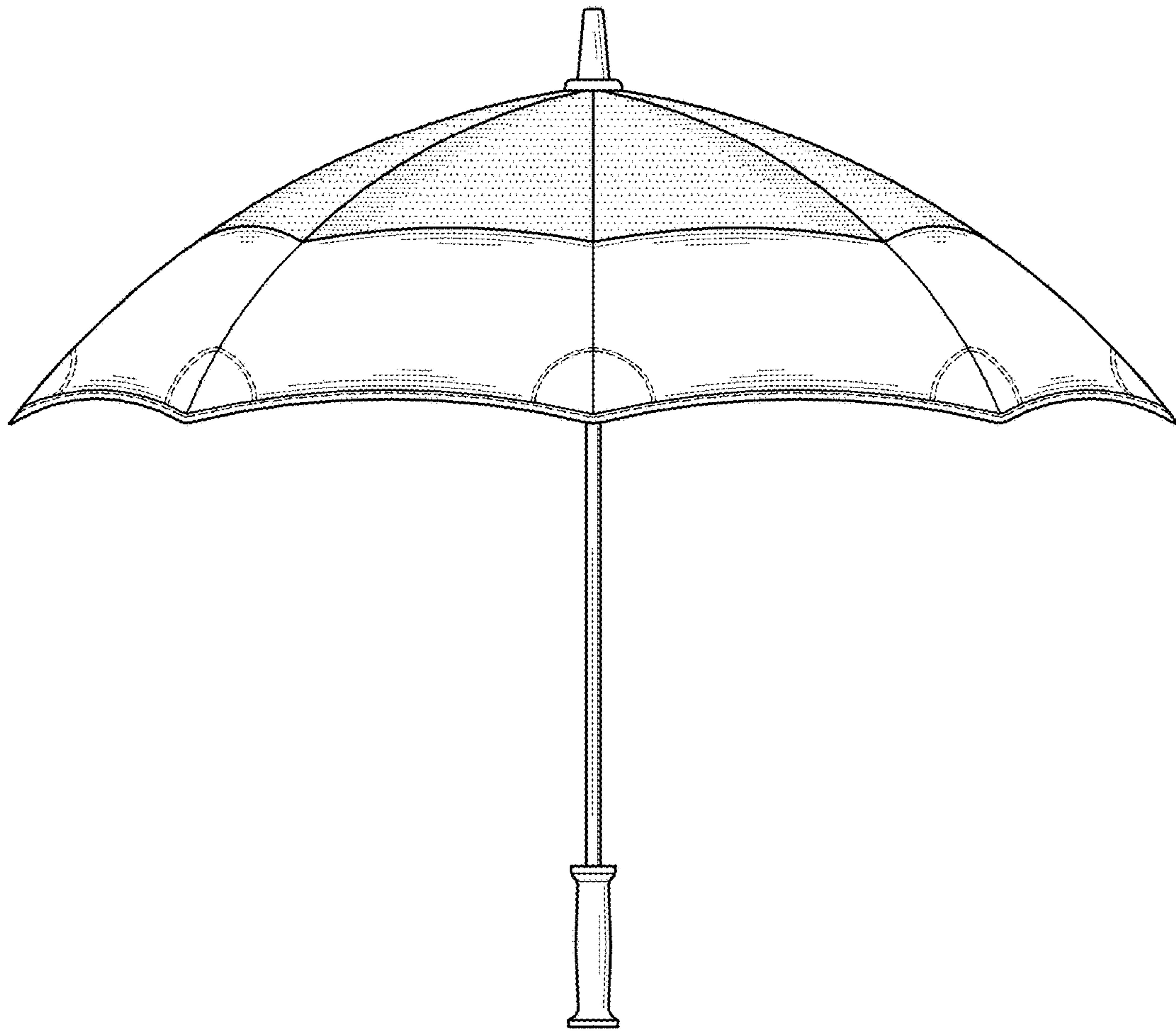

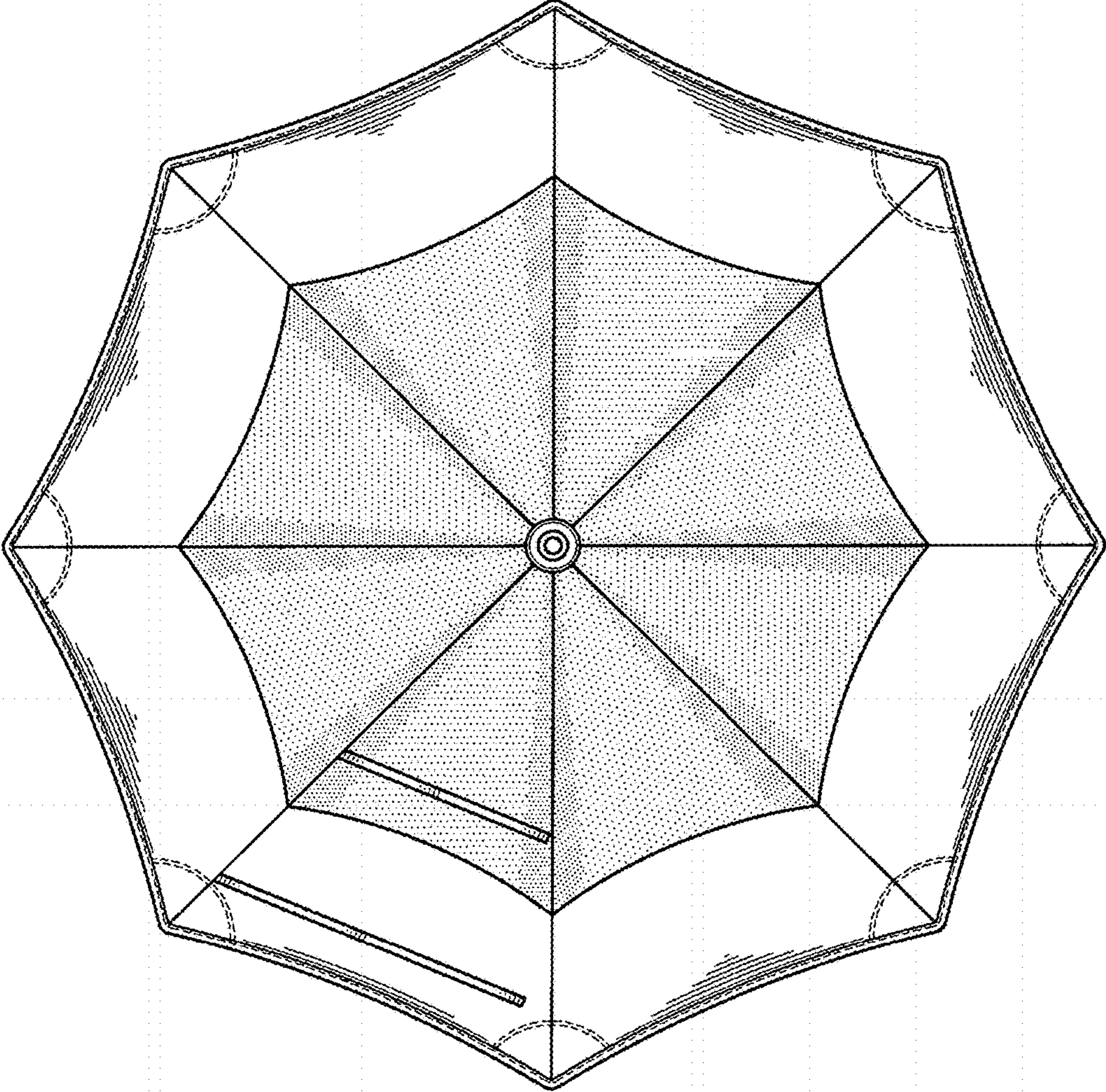

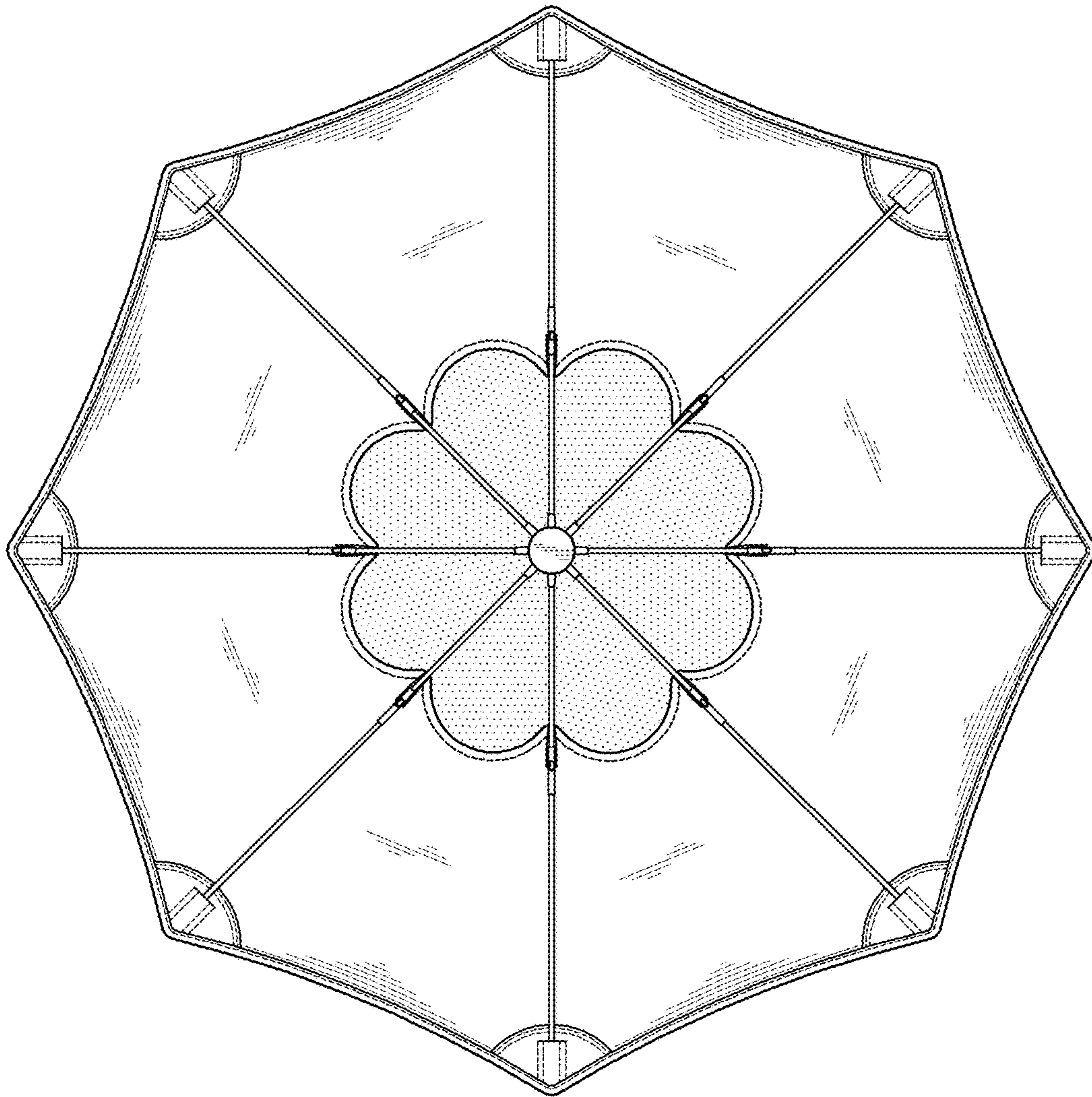

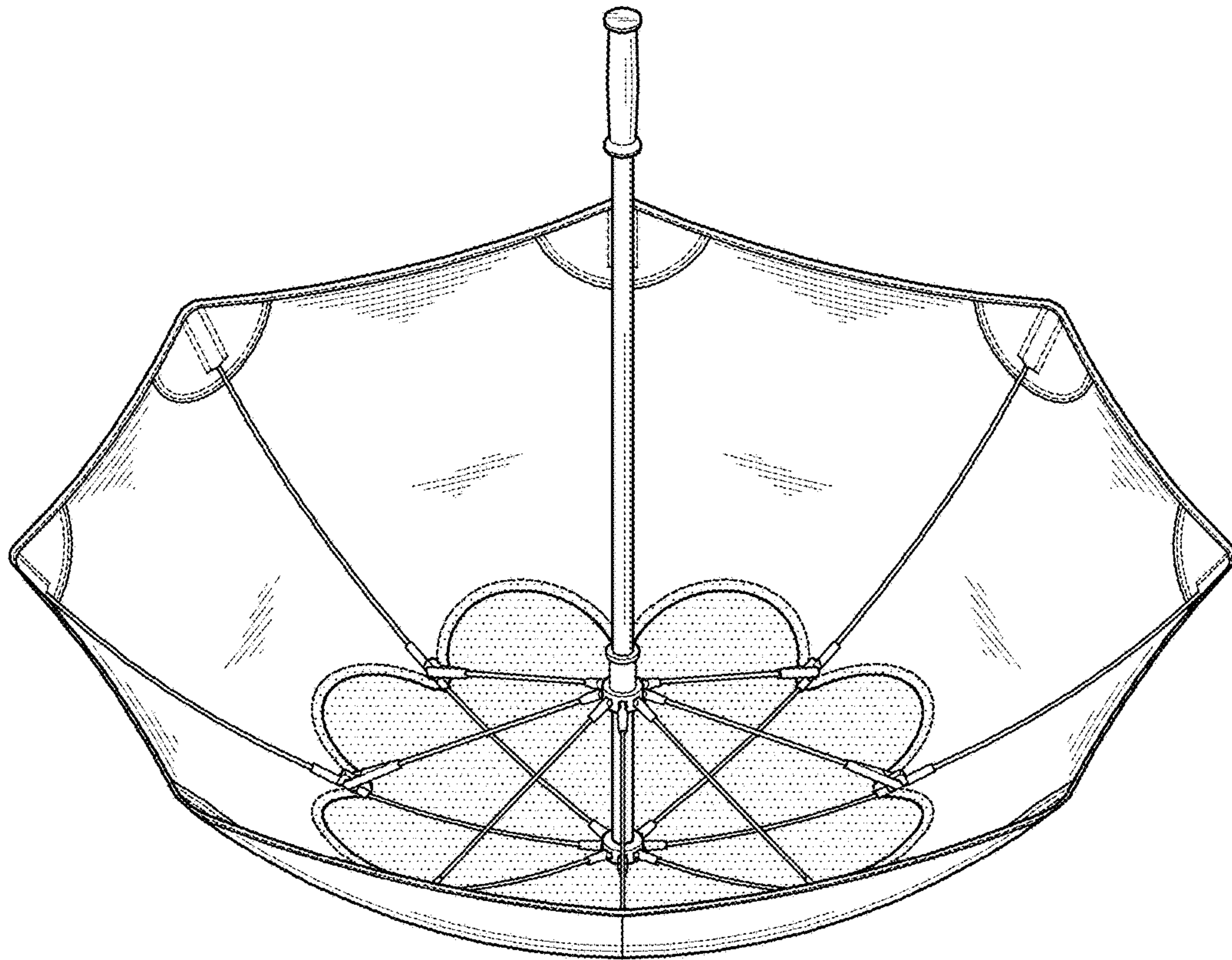

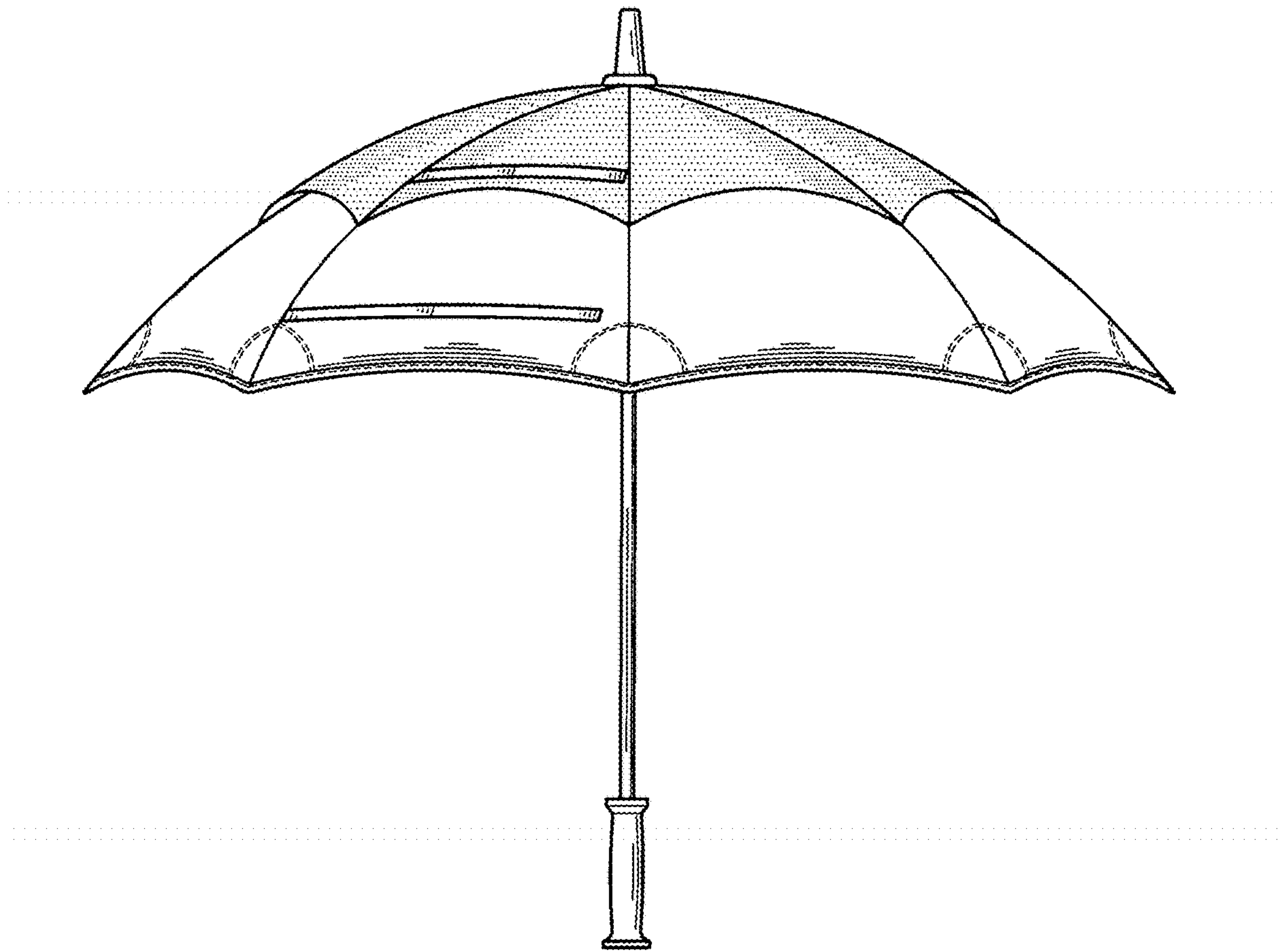
