The ornamental design for a mechanical dispenser, as shown and described.

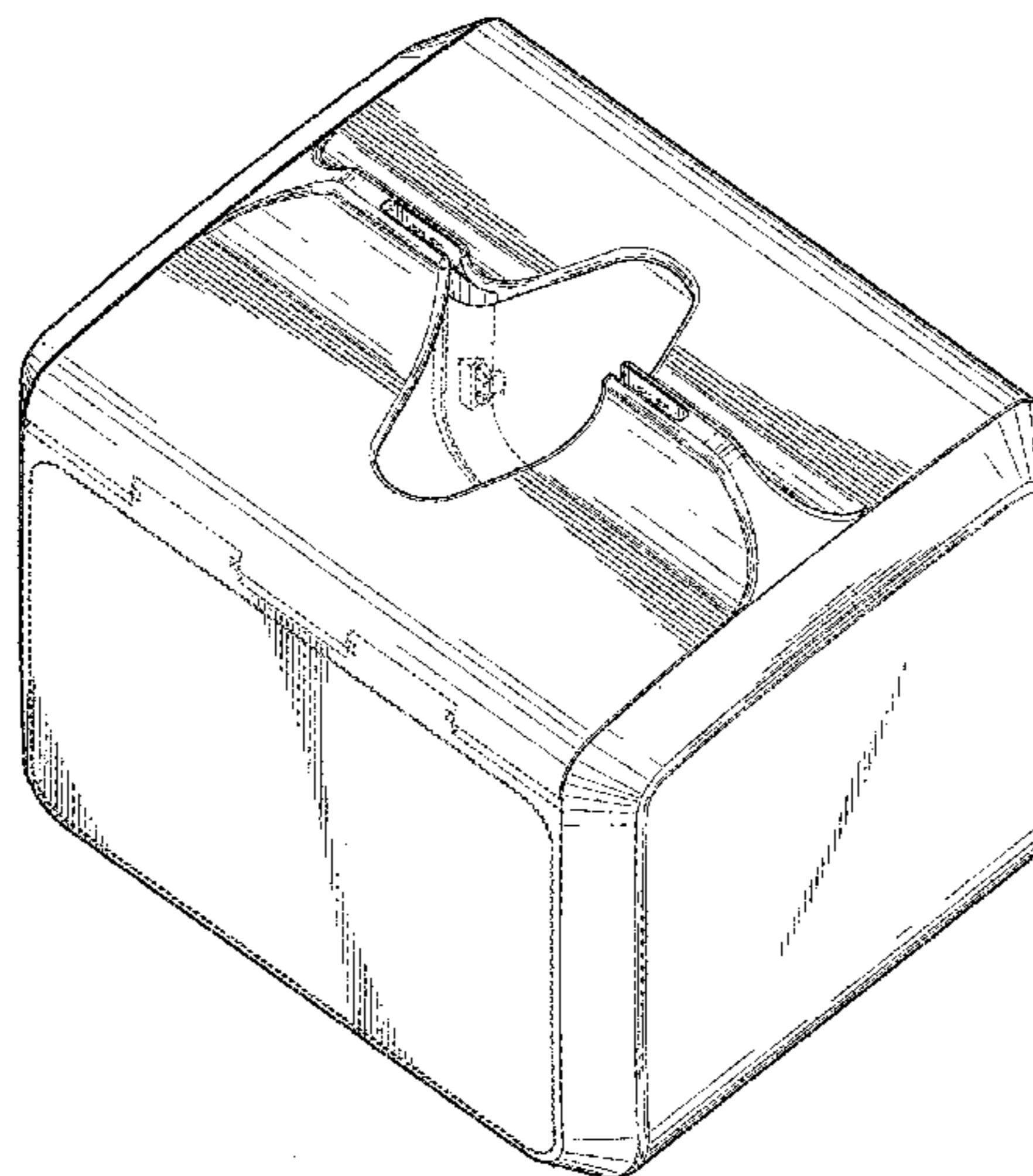
**DESCRIPTION**

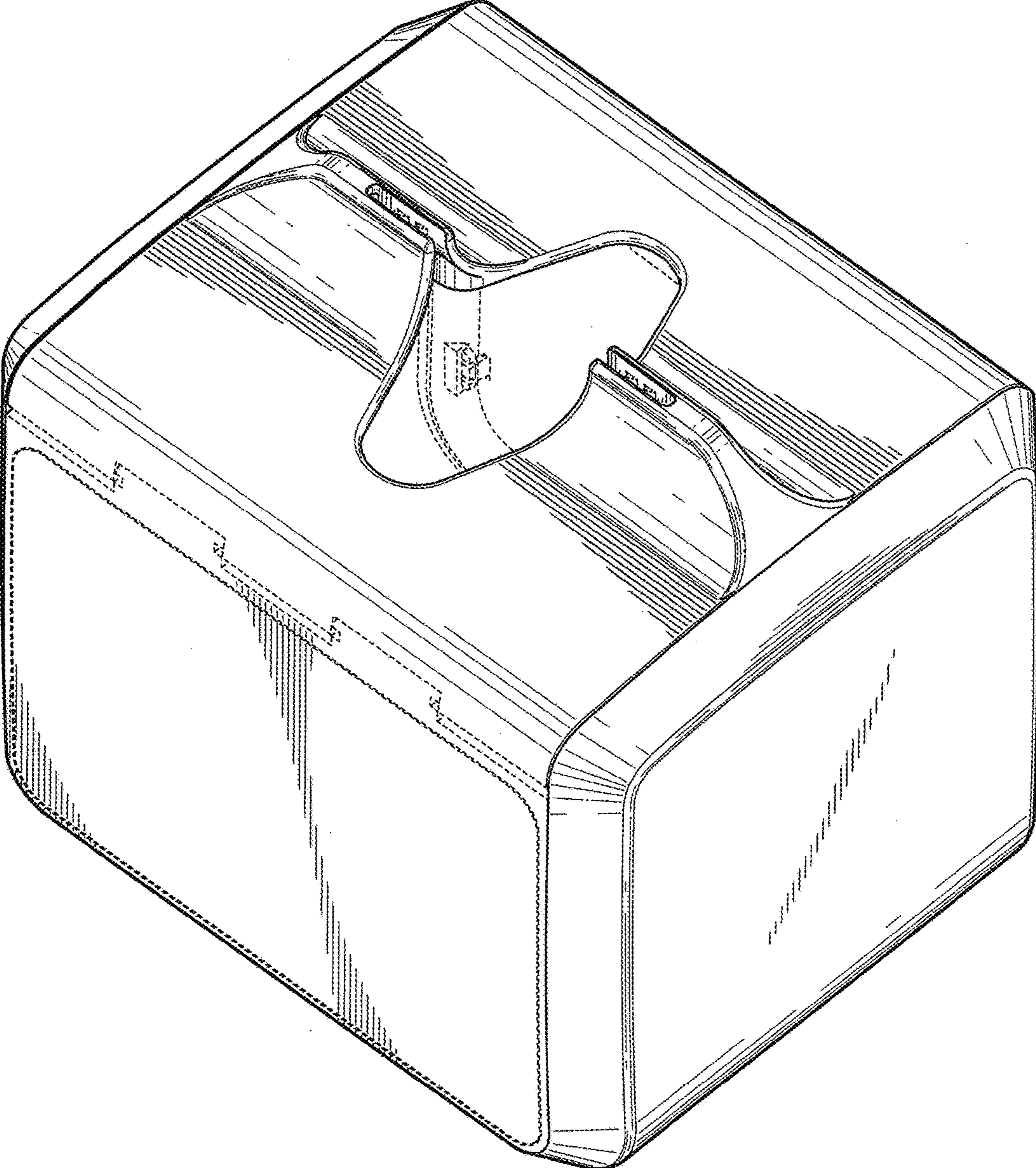

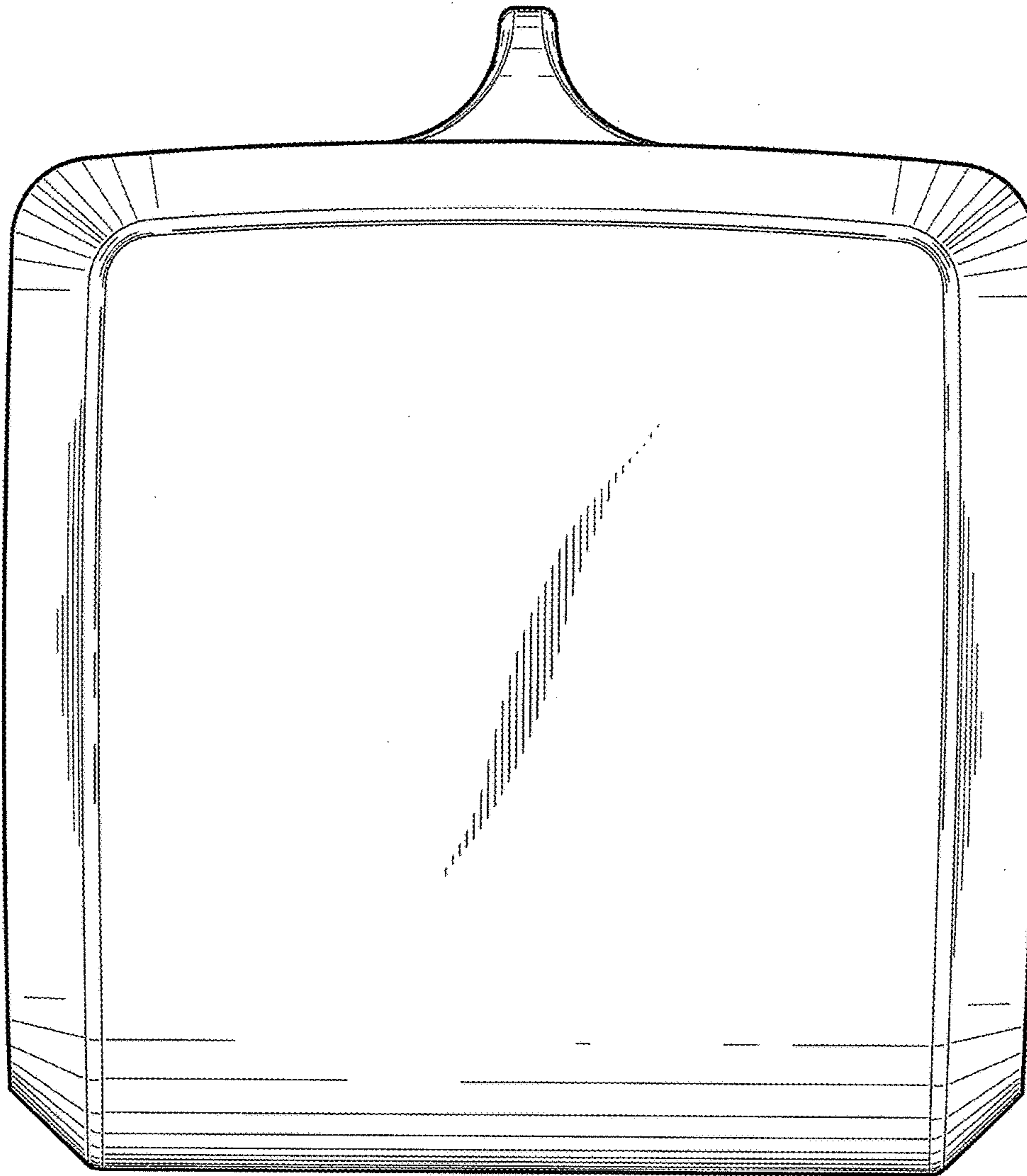

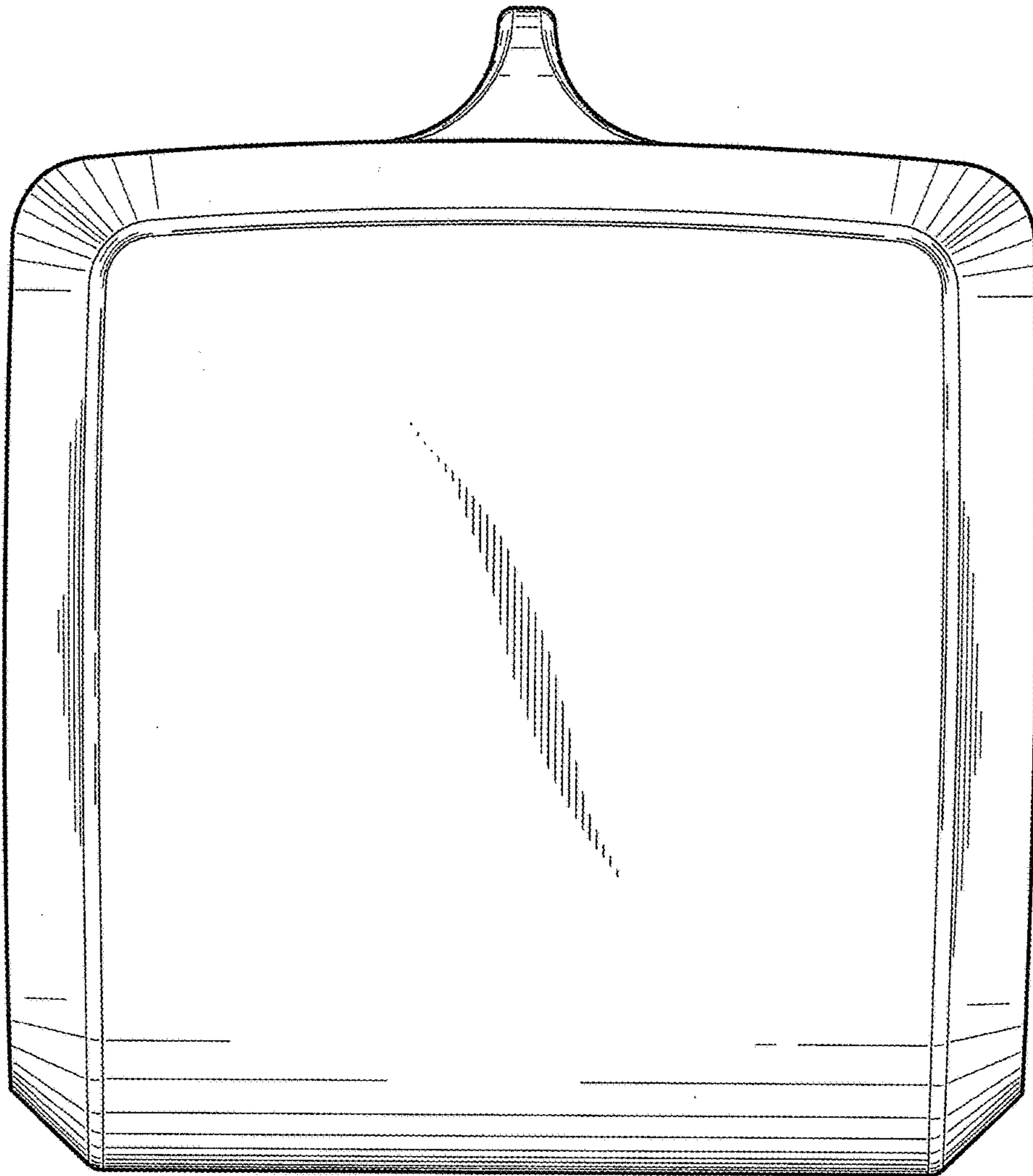

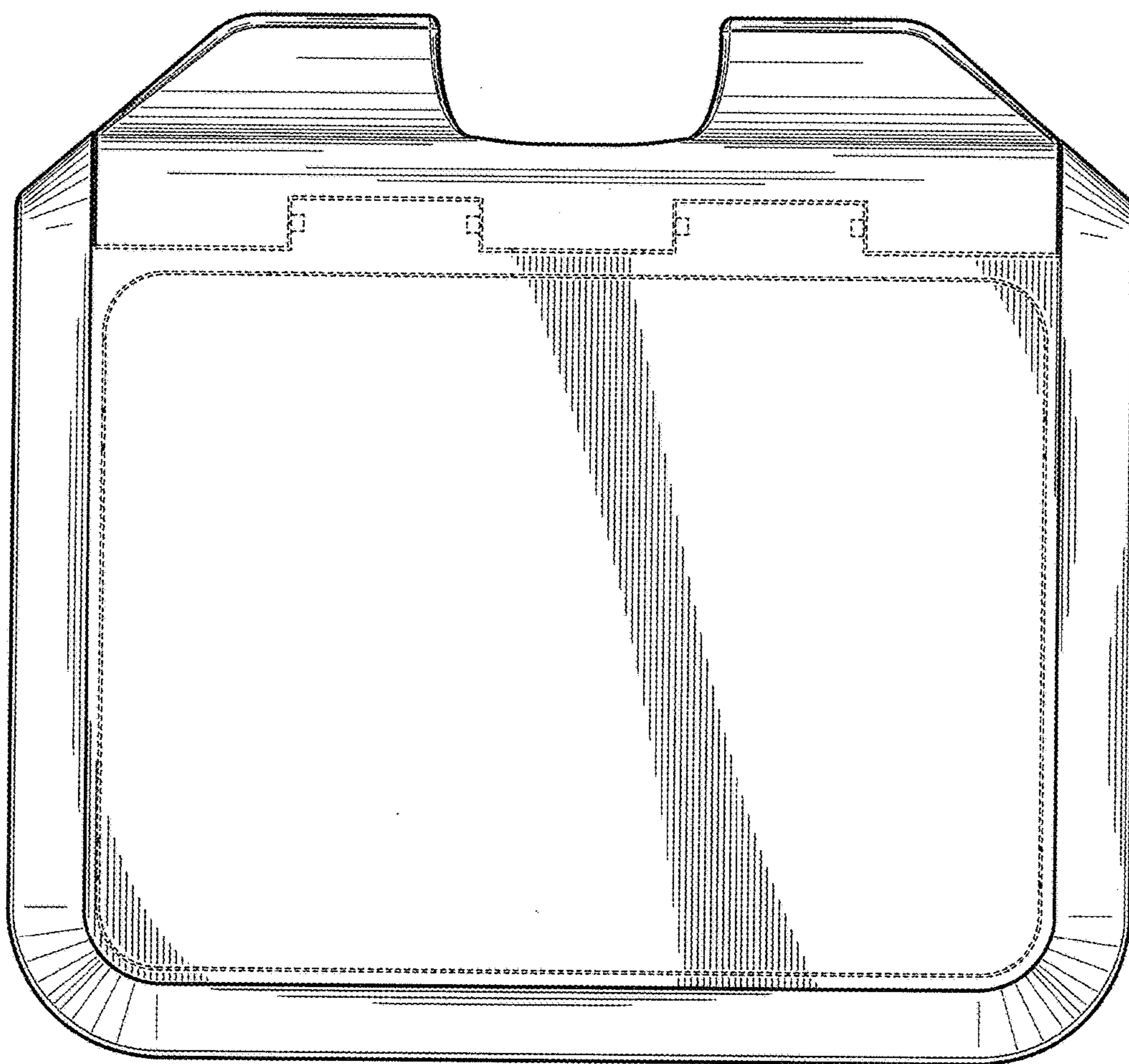

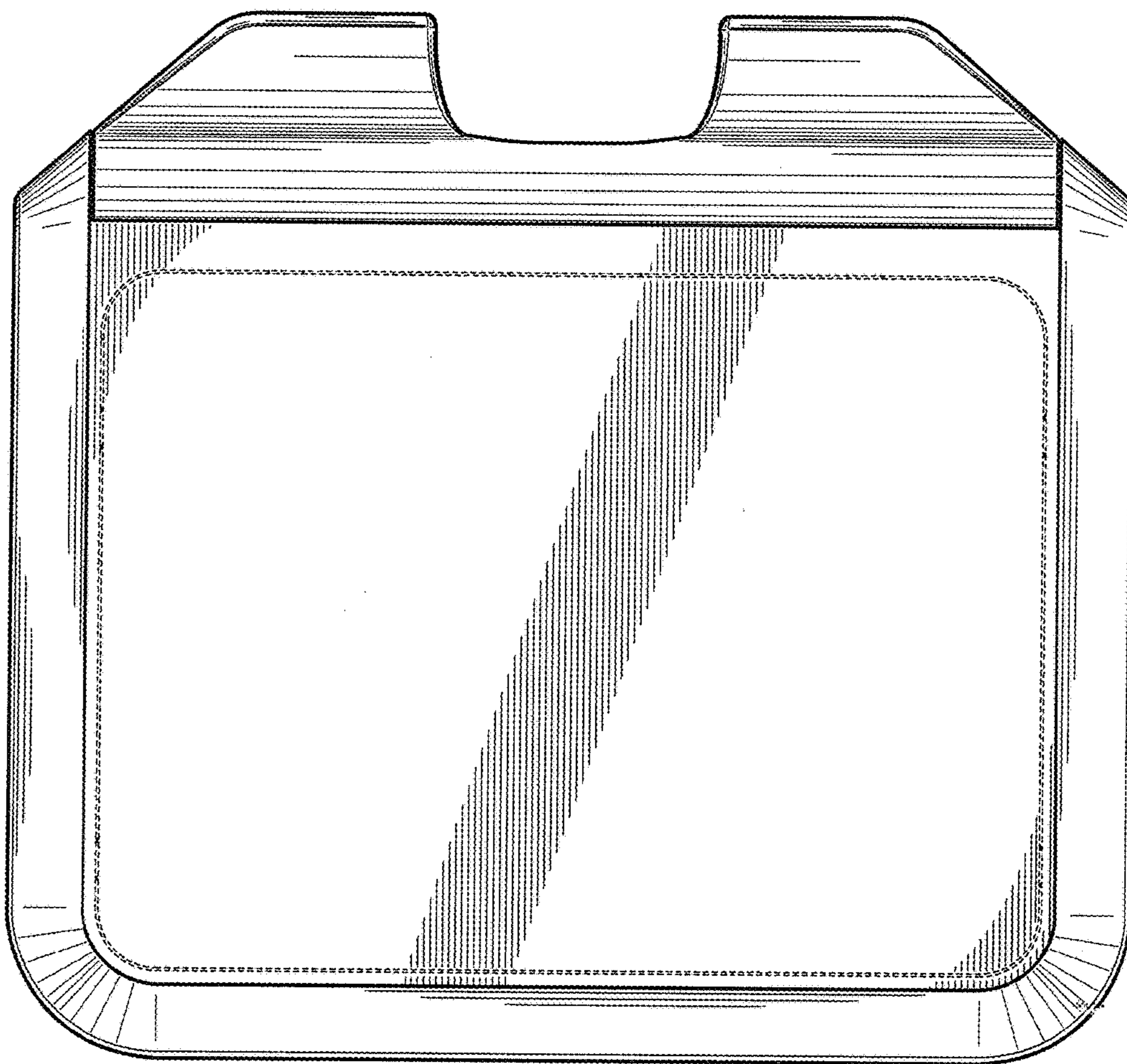

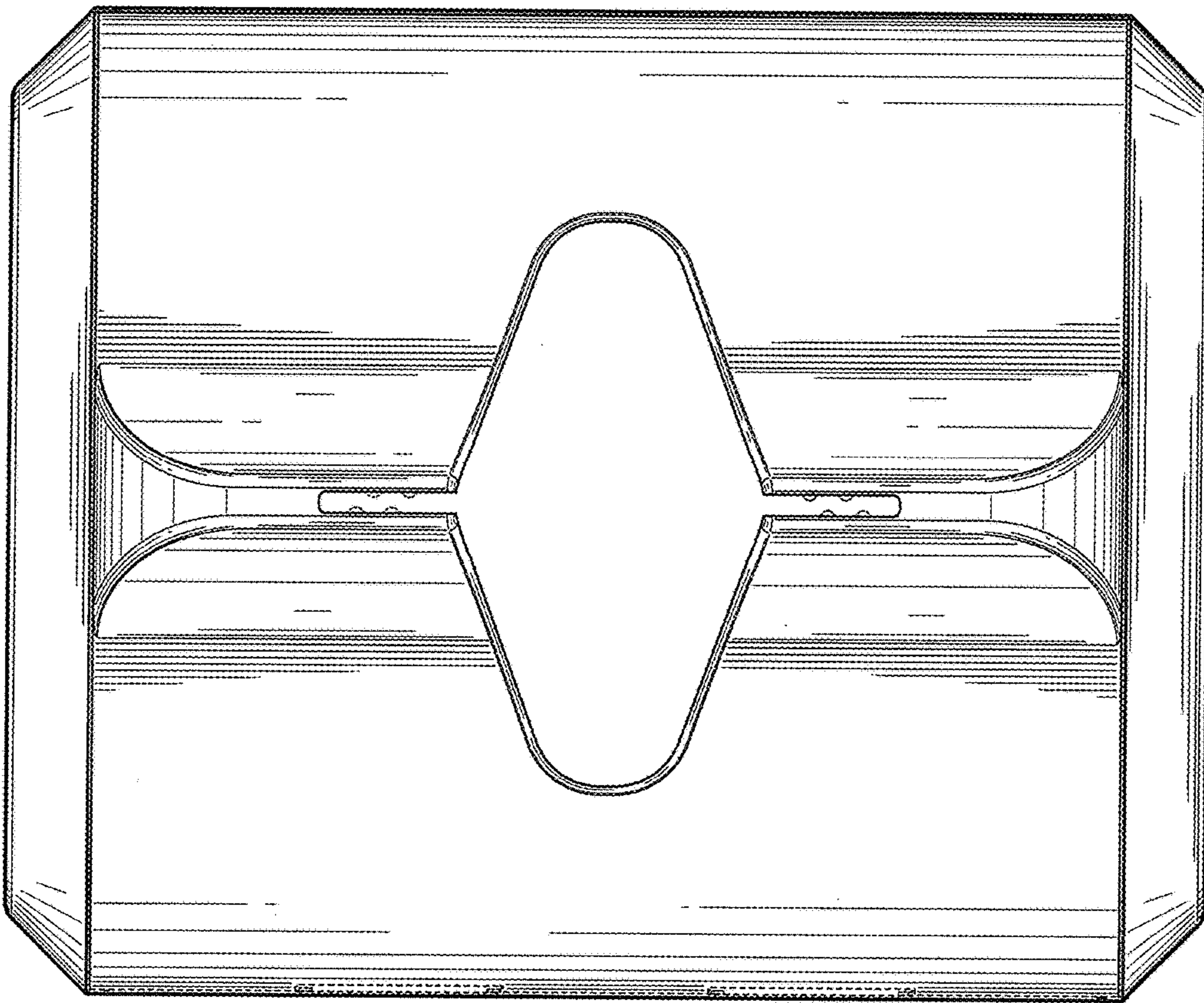

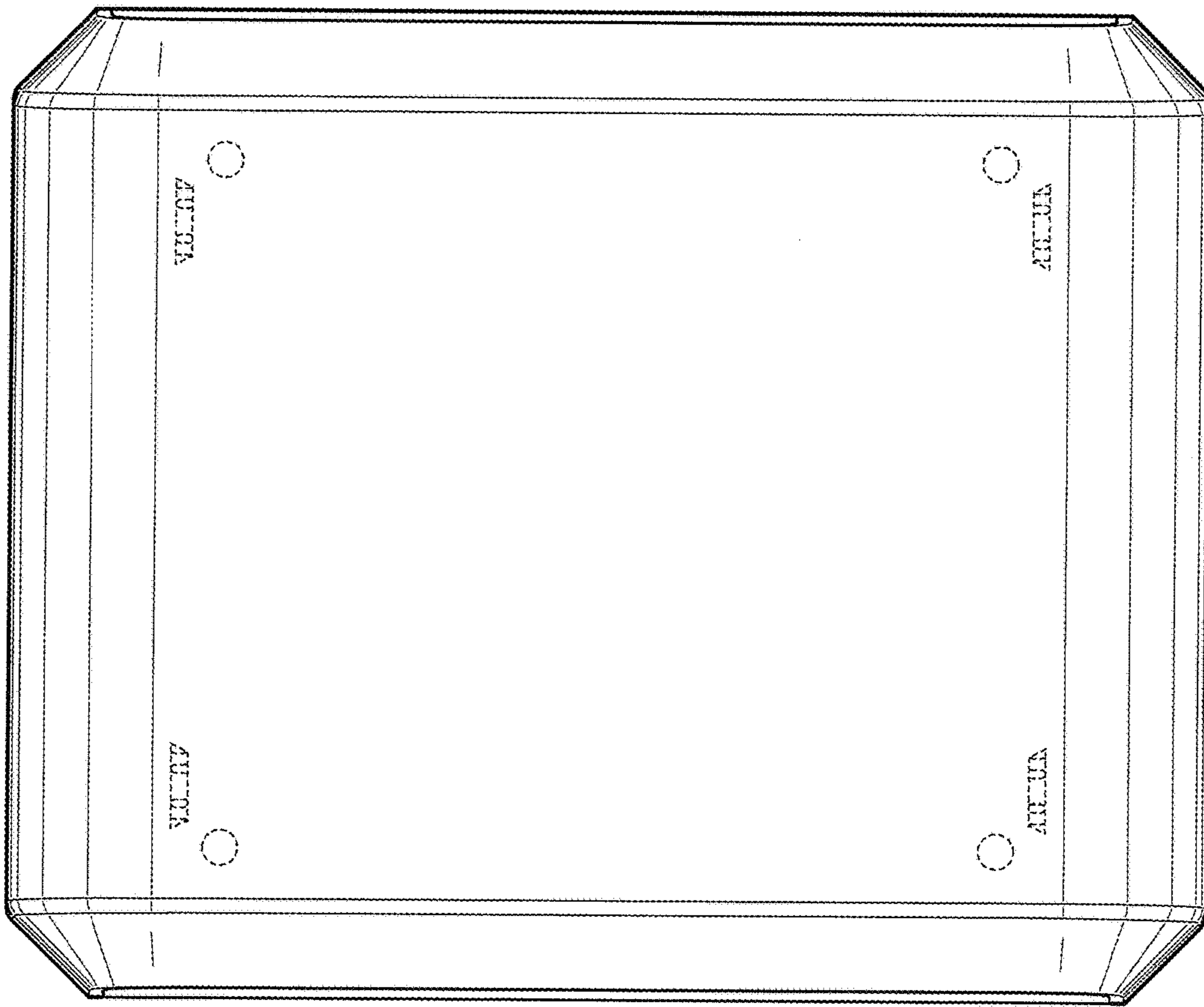
