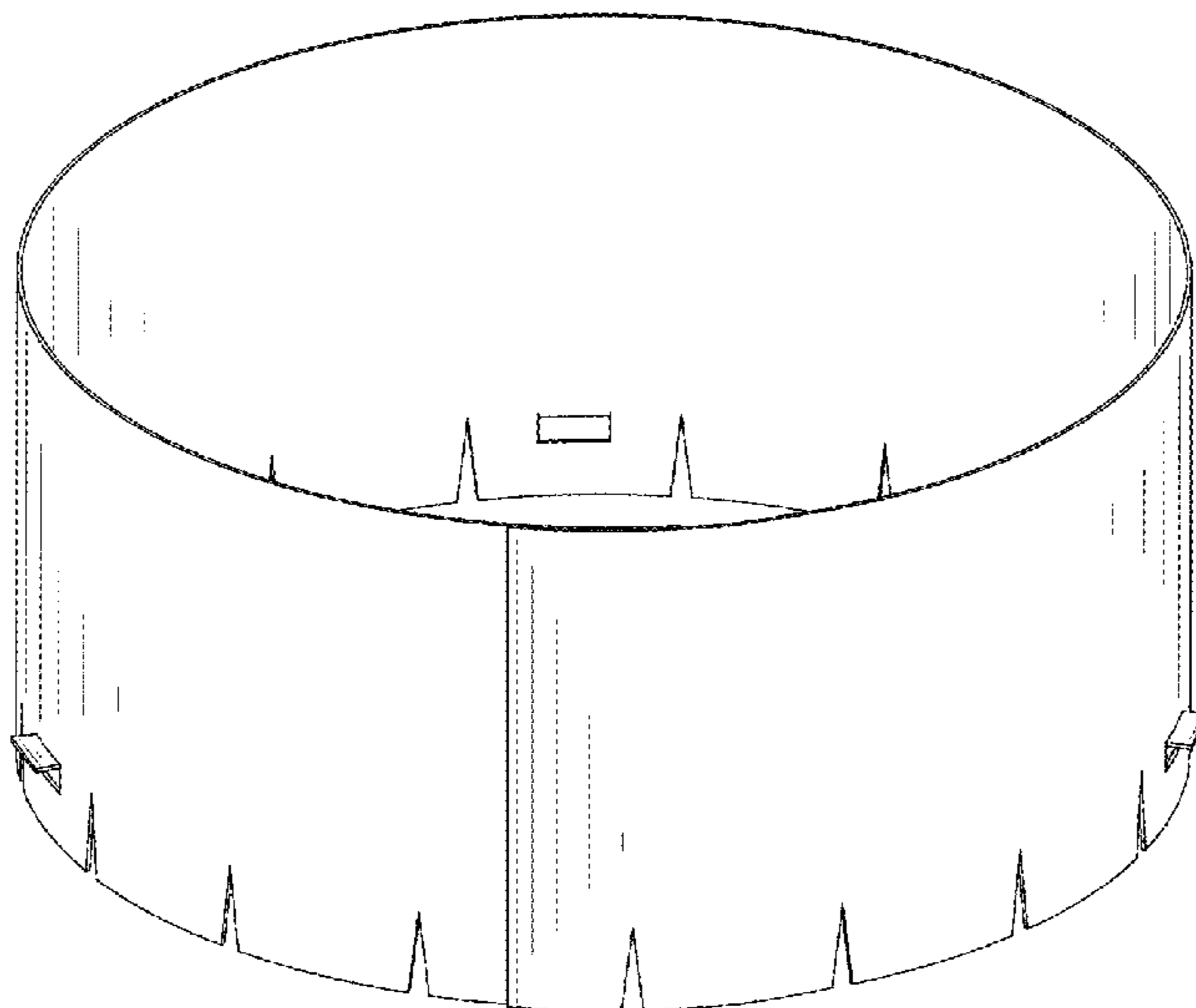
(57) **CLAIM**

The ornamental design for a splattering fender for frypan, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a splattering fender for frypan, showing the new design;
 FIG. 2 is a front view of the splattering fender for frypan of FIG. 1;
 FIG. 3 is a rear view of the splattering fender for frypan of FIG. 1;
 FIG. 4 is a left side view of the splattering fender for frypan of FIG. 1;
 FIG. 5 is a right side view of the splattering fender for frypan of FIG. 1;
 FIG. 6 is a top plan view of the splattering fender for frypan of FIG. 1;
 FIG. 7 is a bottom plan view of the splattering fender for frypan of FIG. 1;
 FIG. 8 is a top plan view of the splattering fender for frypan of FIG. 1, in a flattened configuration; and,
 FIG. 9 is a perspective view of the splattering fender for frypan of FIG. 1 in use with cookware.
 The broken lines are employed to show environmental structure the splattering fender for frypan might be used with, and form no part of the claimed design.

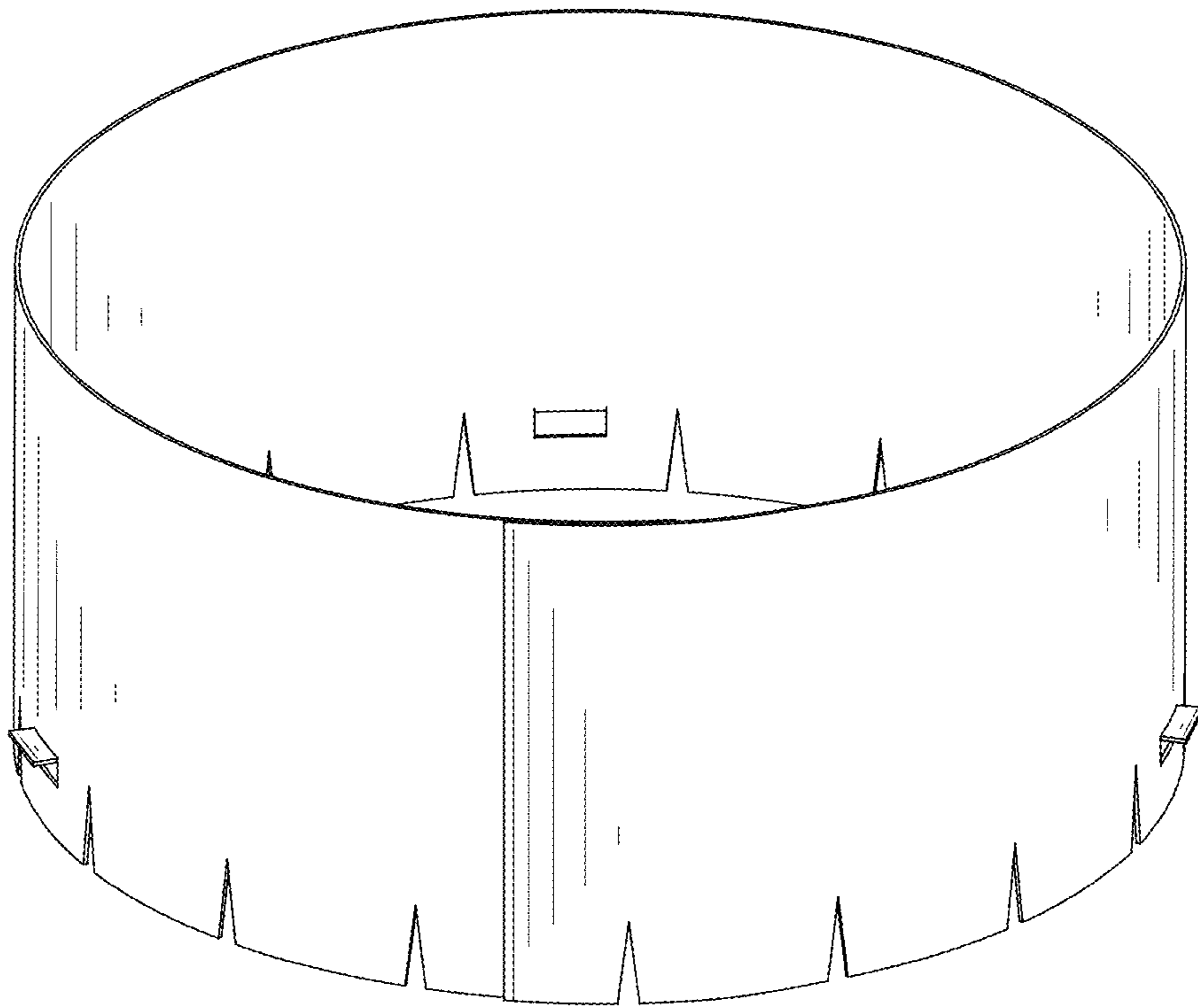

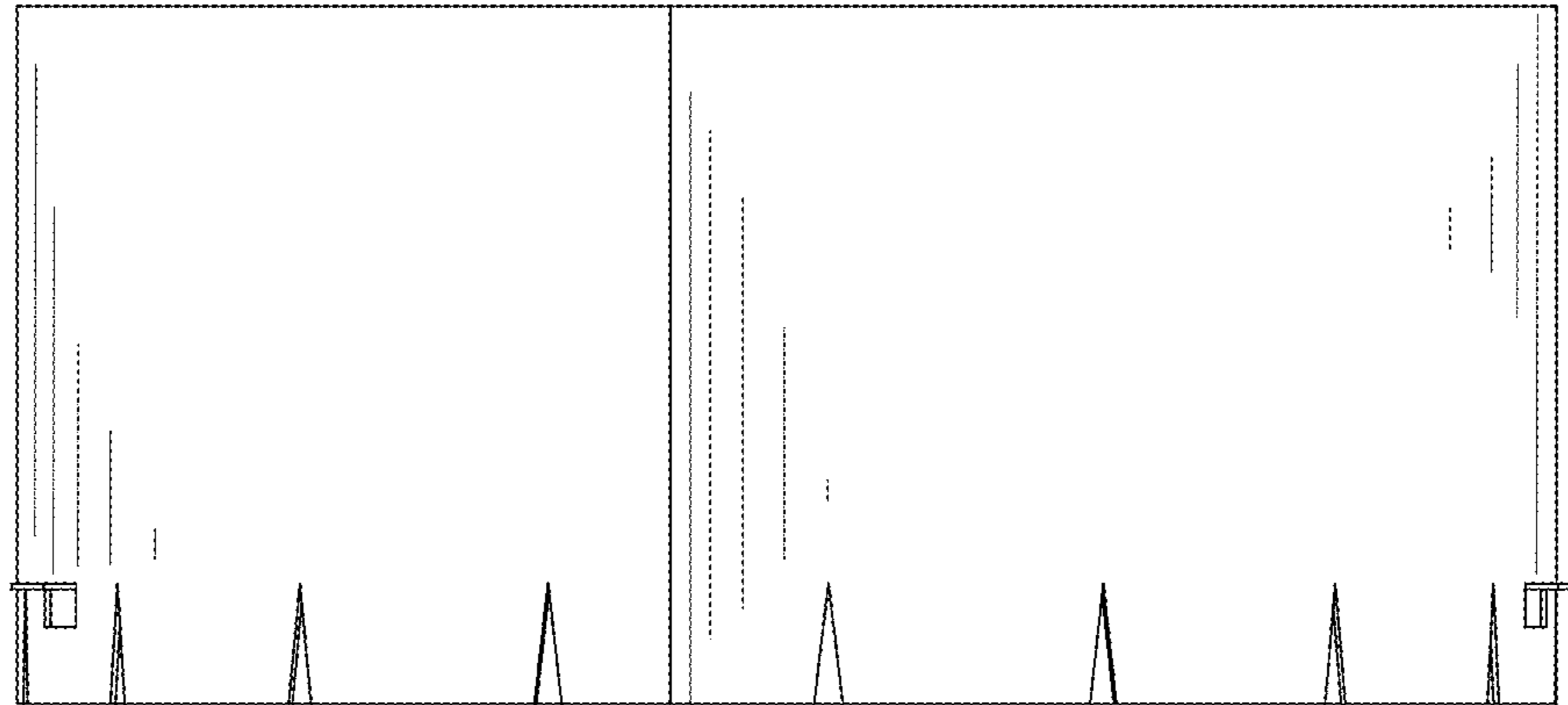

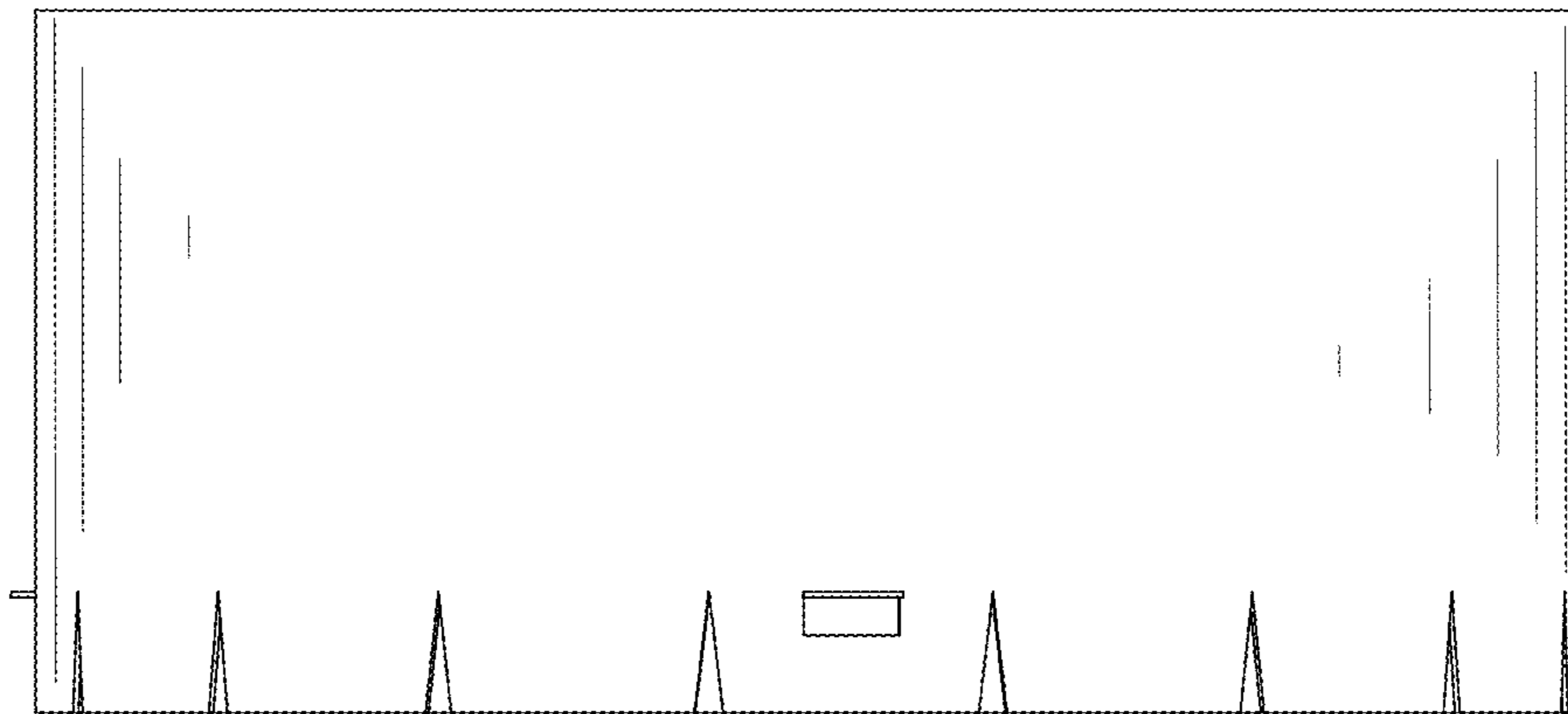

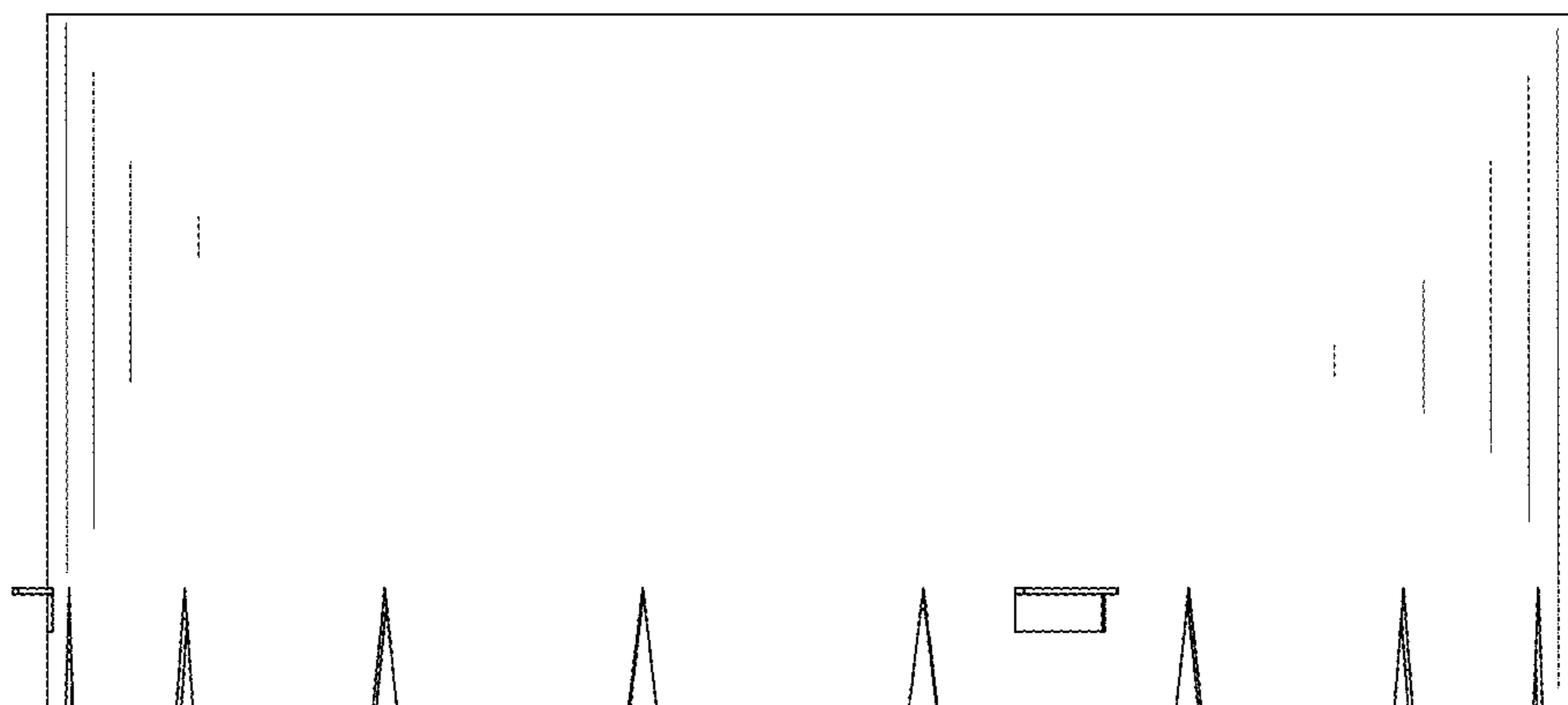

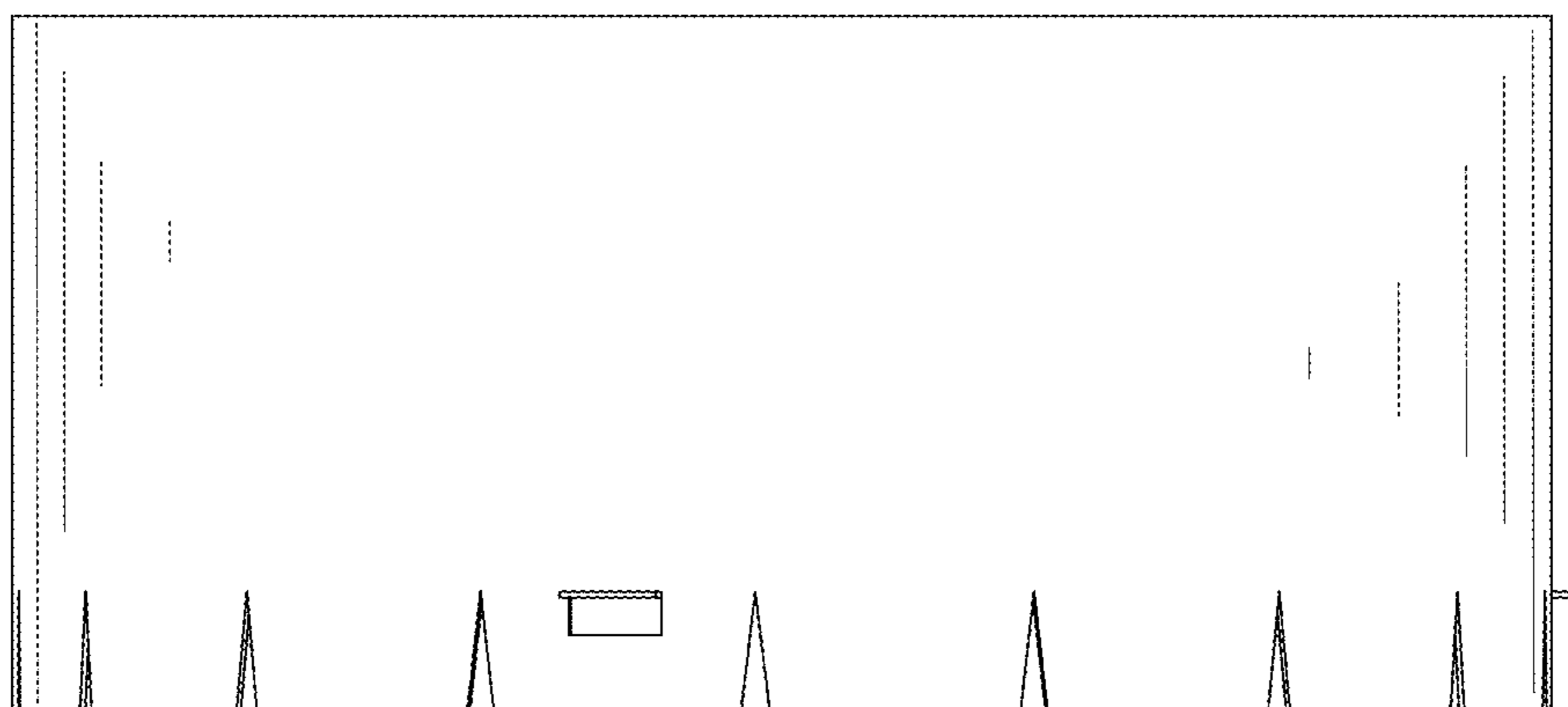

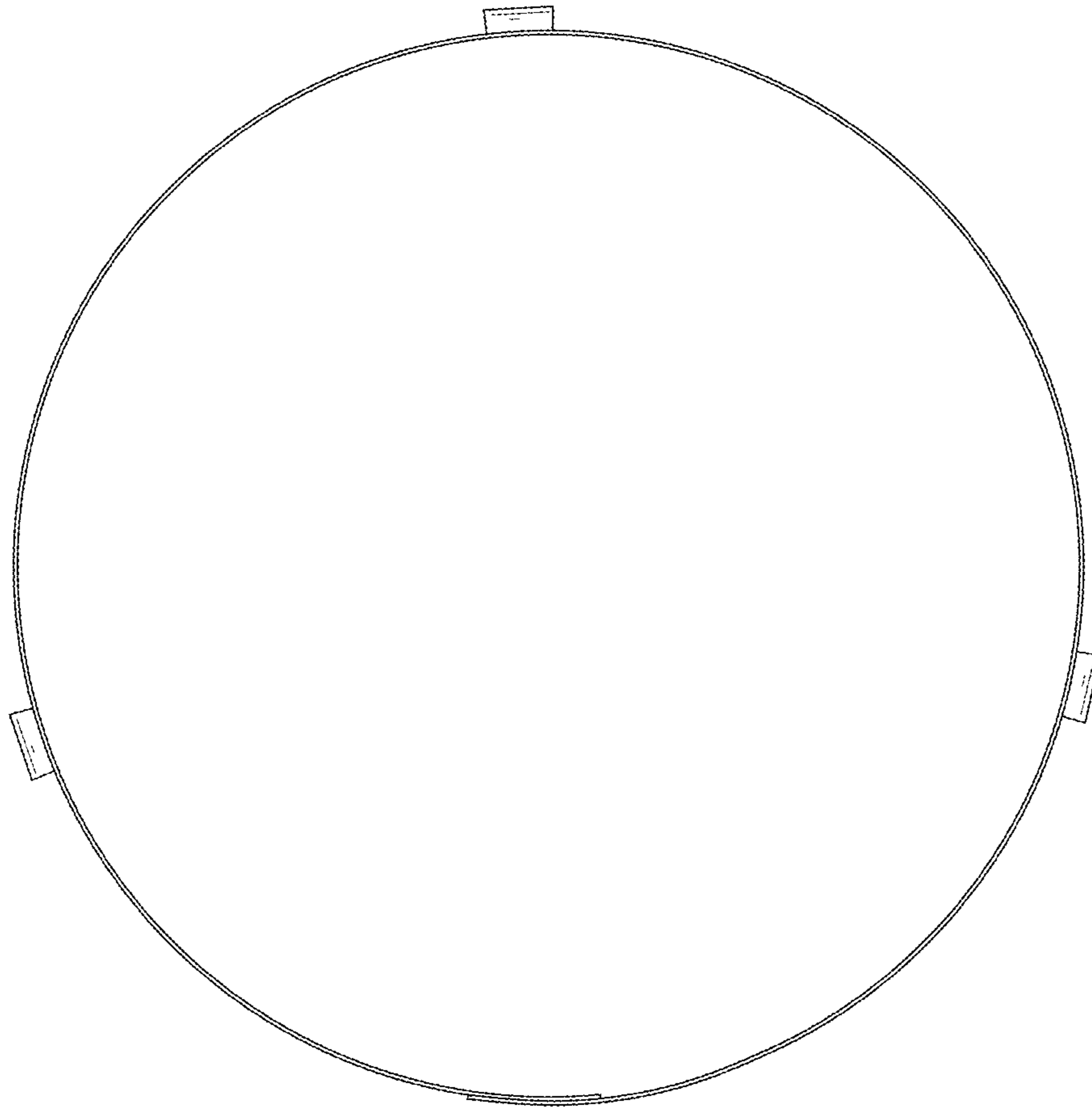

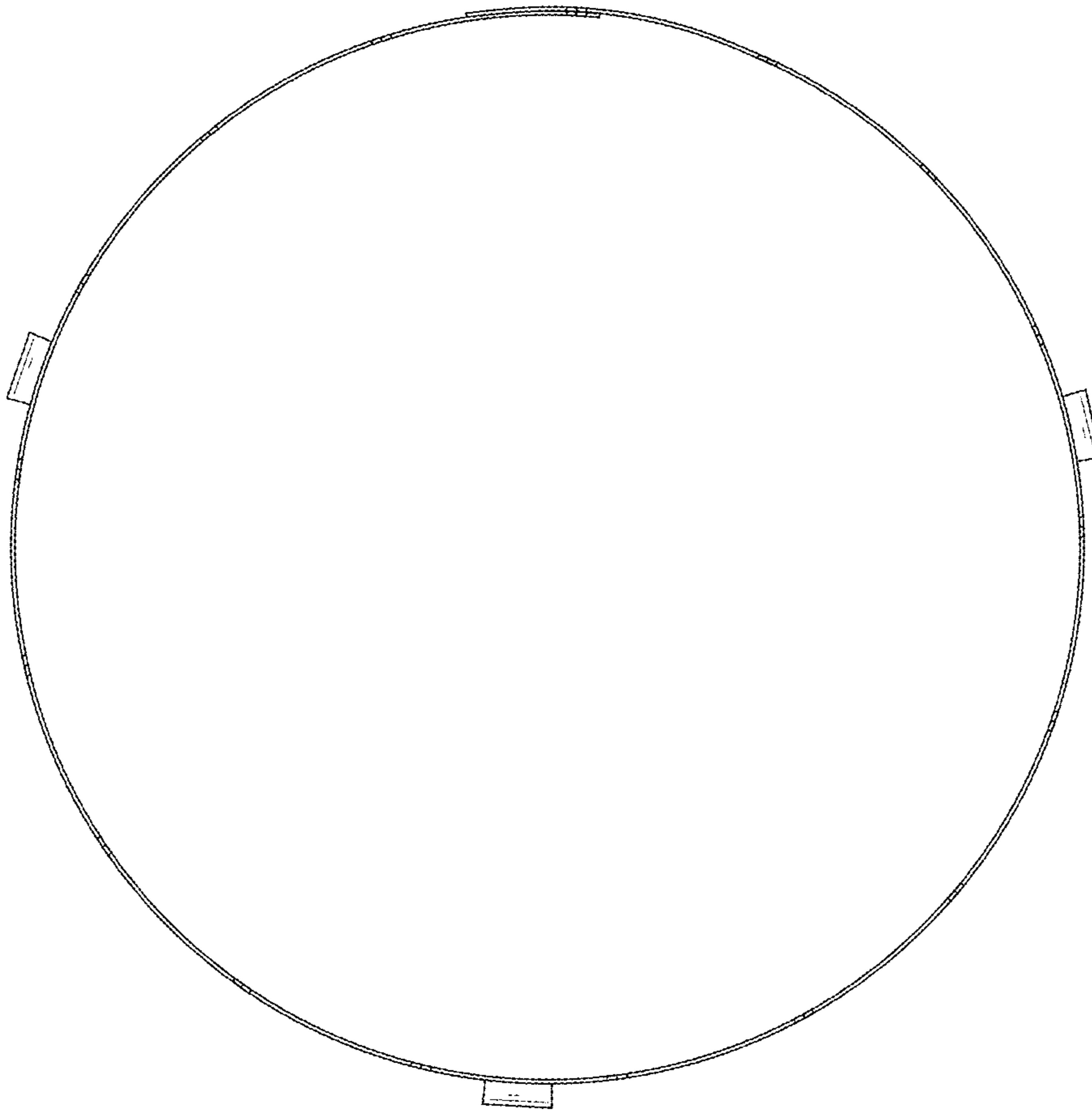

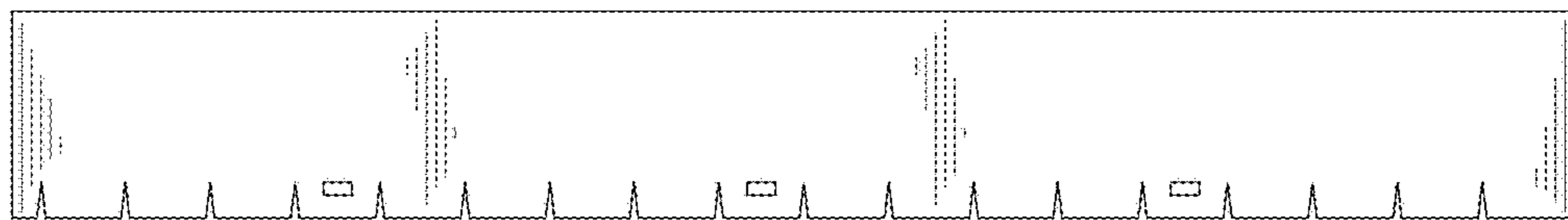

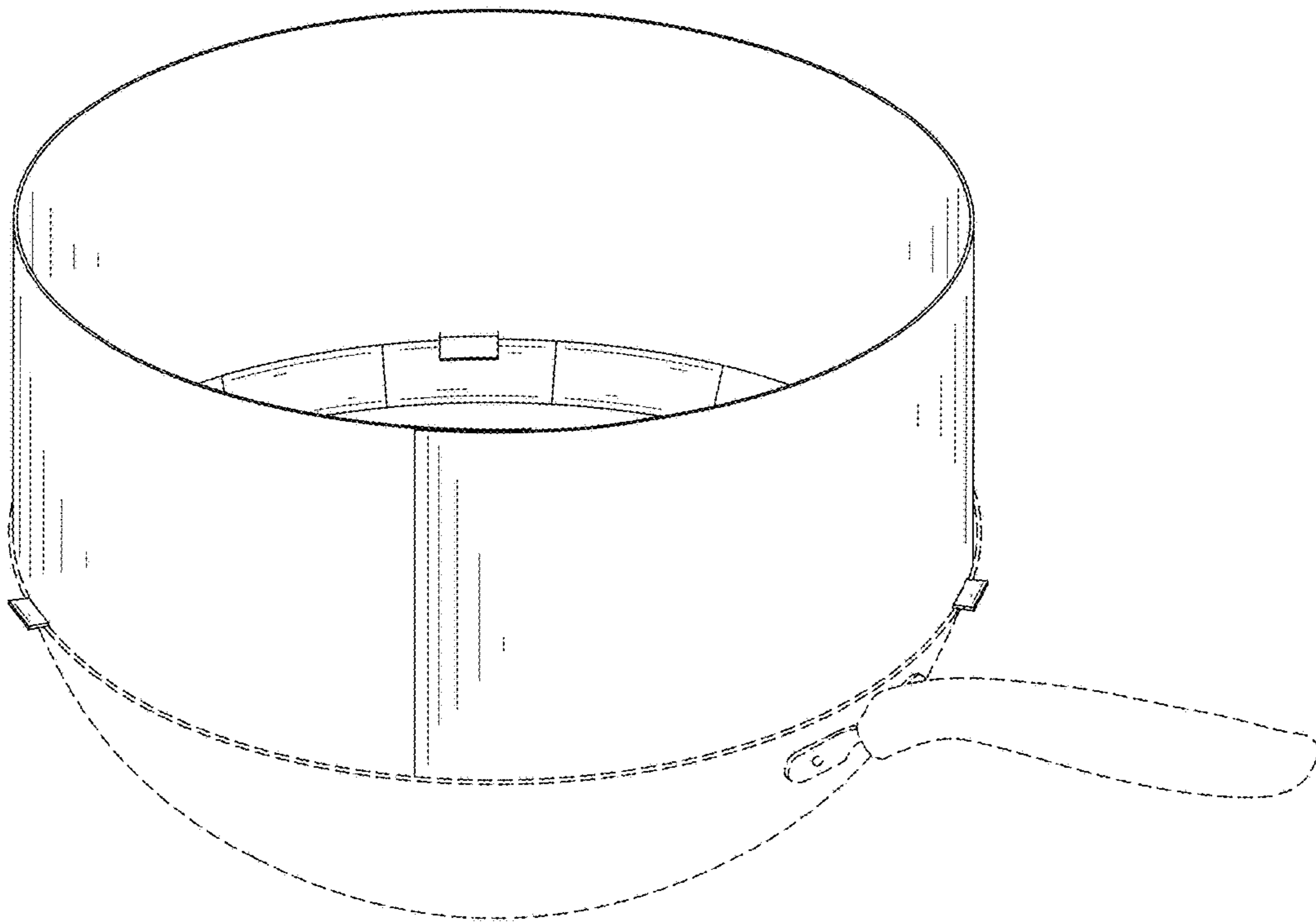
