The ornamental design for a packaging box, as shown and described.

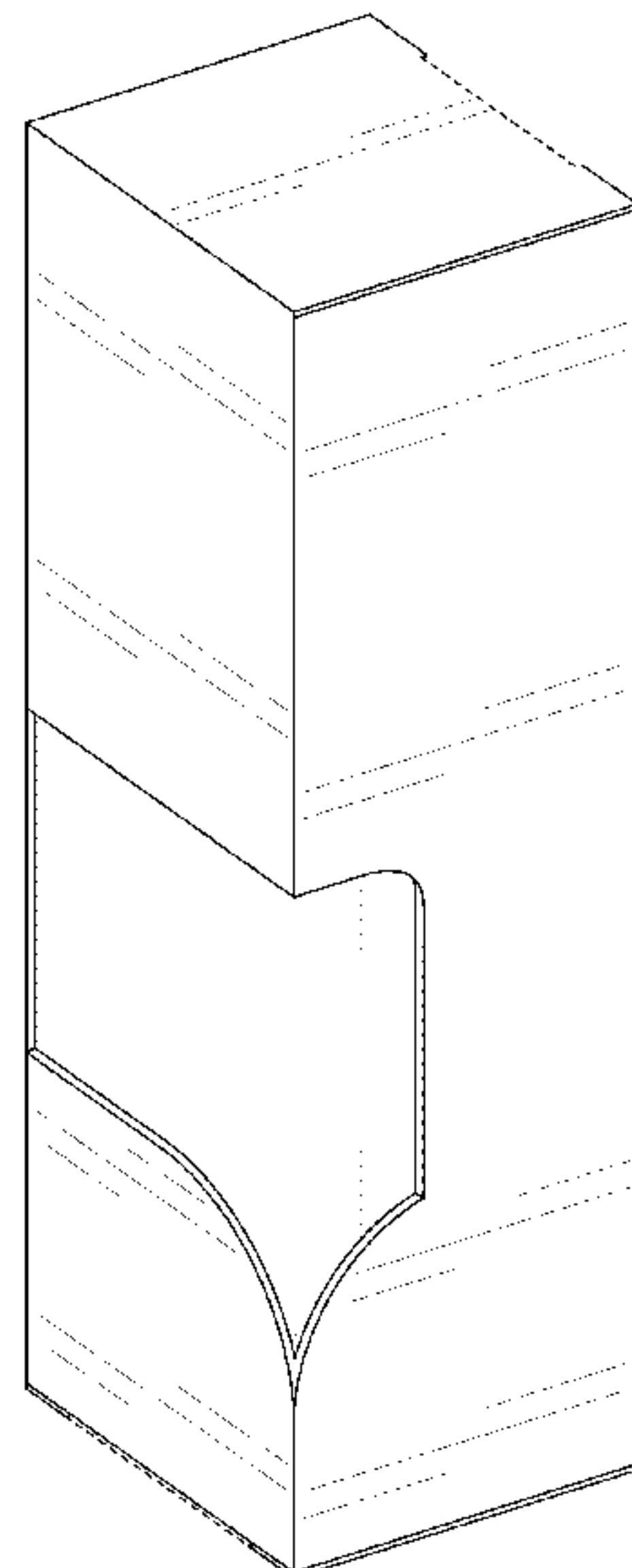
**DESCRIPTION**

FIG. 1 is a front right perspective view of a packaging box showing my new design;  
FIG. 2 is a rear left perspective view of the packaging box;  
FIG. 3 is a front view of the packaging box;  
FIG. 4 is a rear view of the packaging box;  
FIG. 5 is a left view of the packaging box;  
FIG. 6 is a right view of the packaging box;

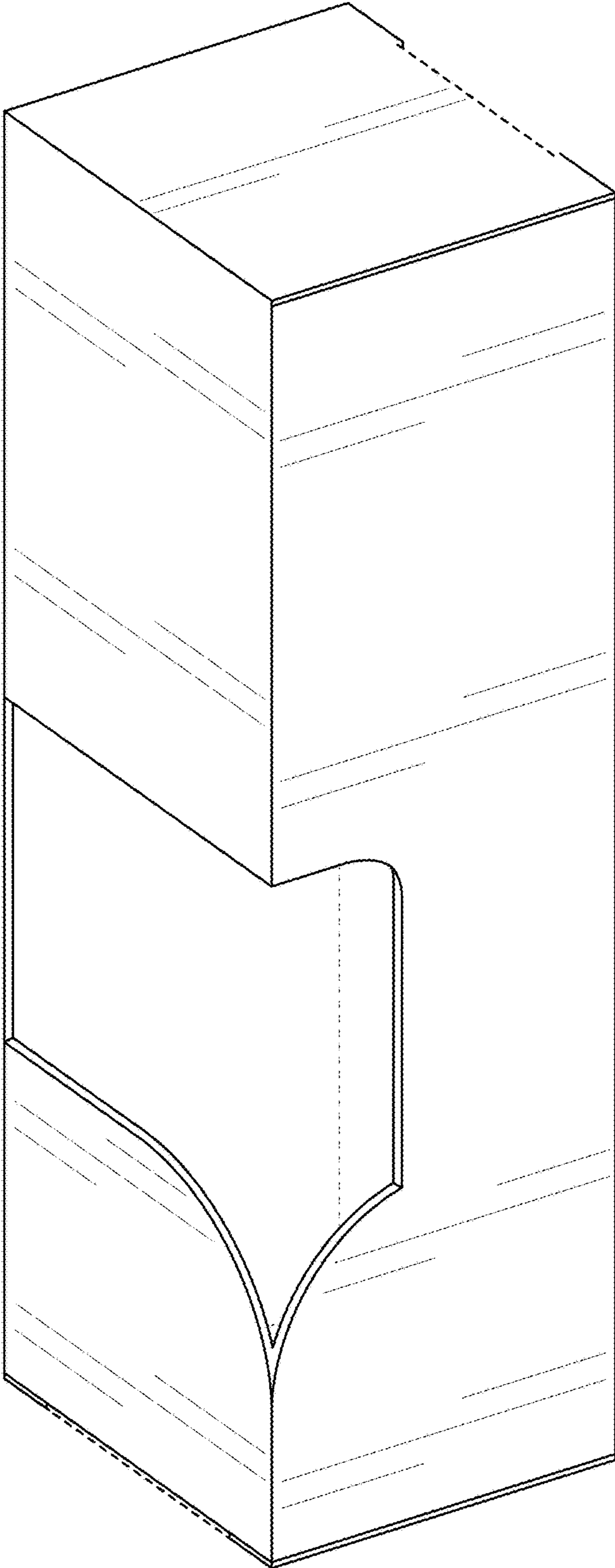

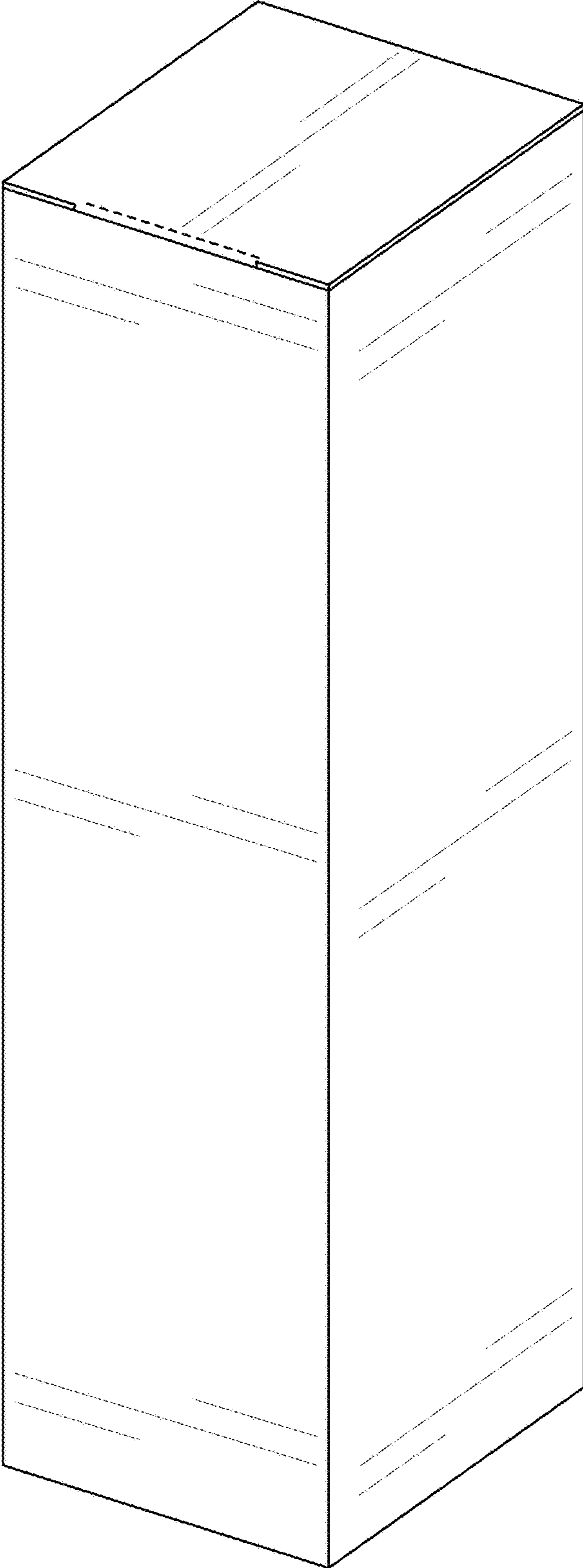

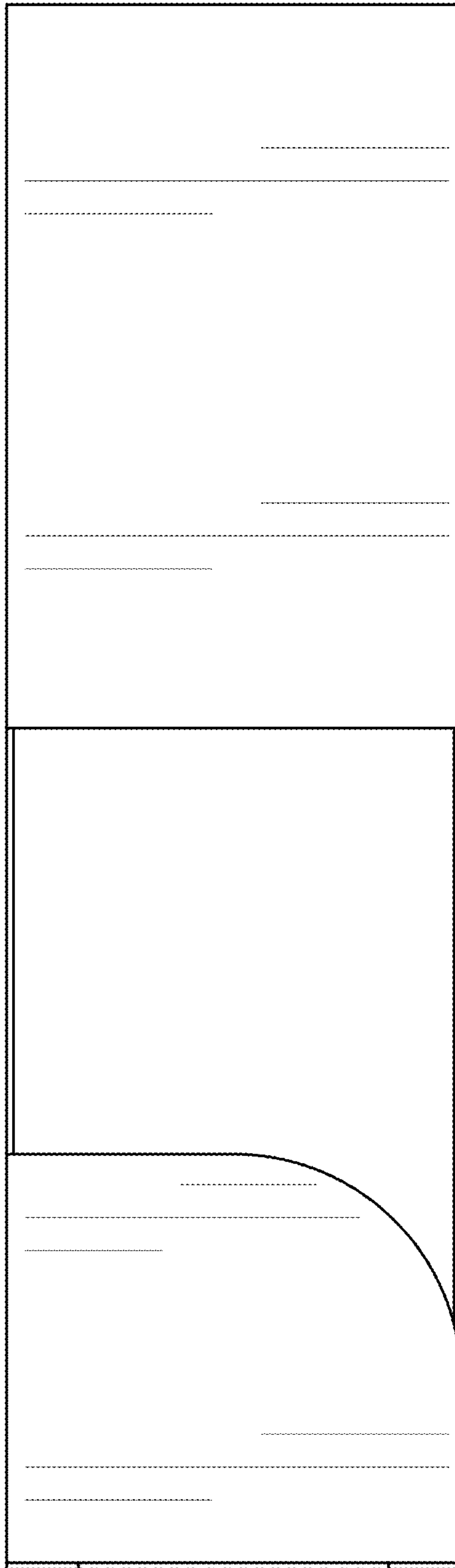

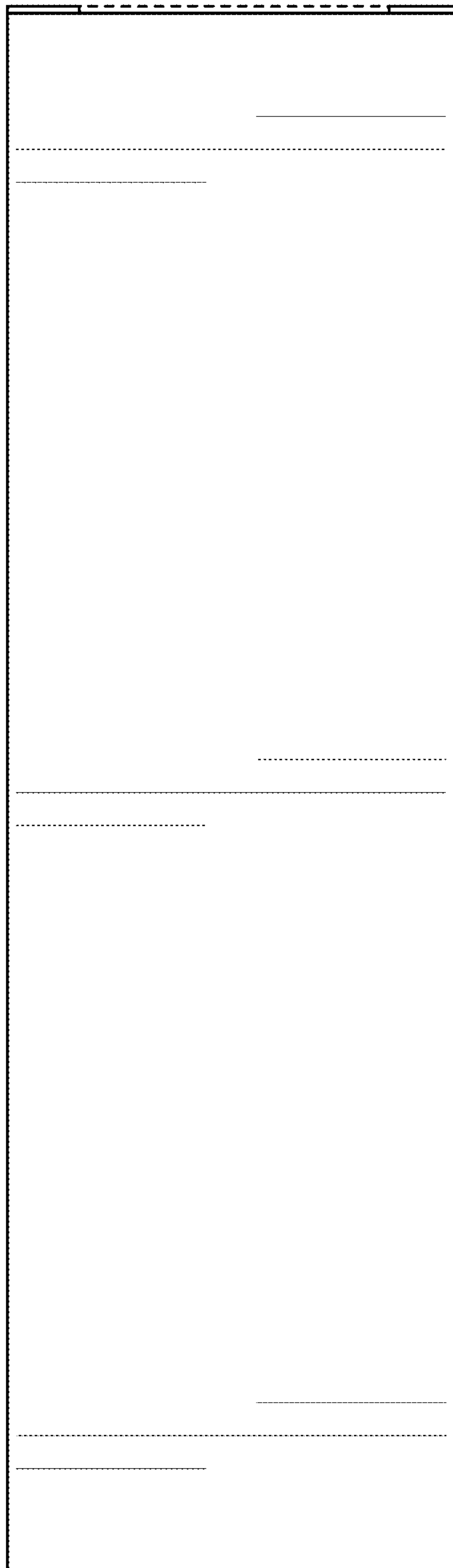

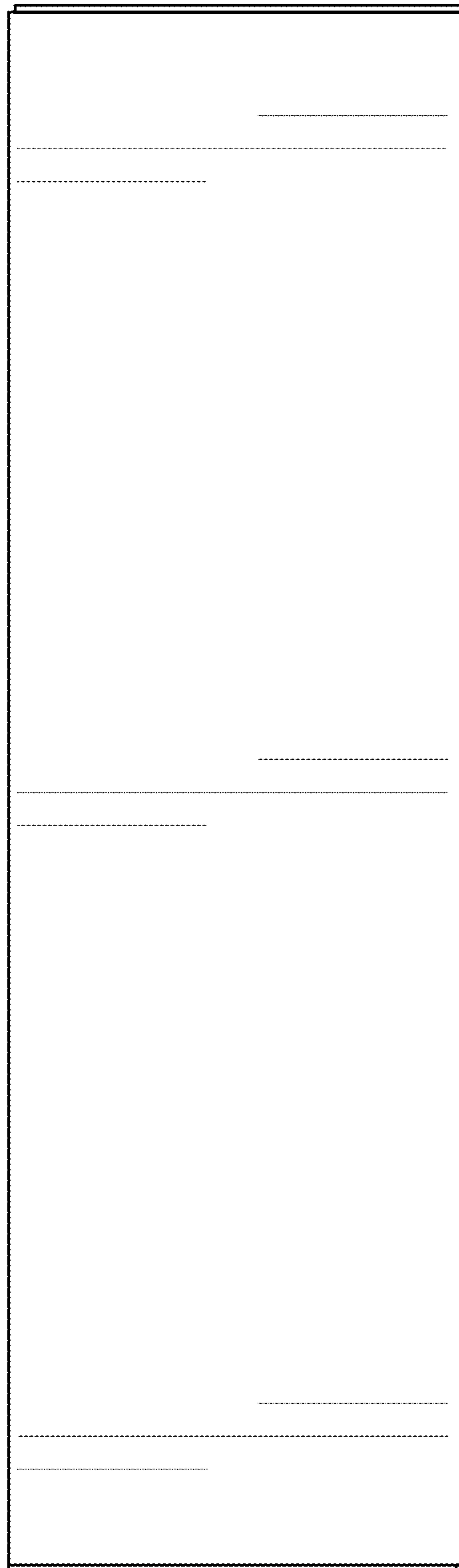

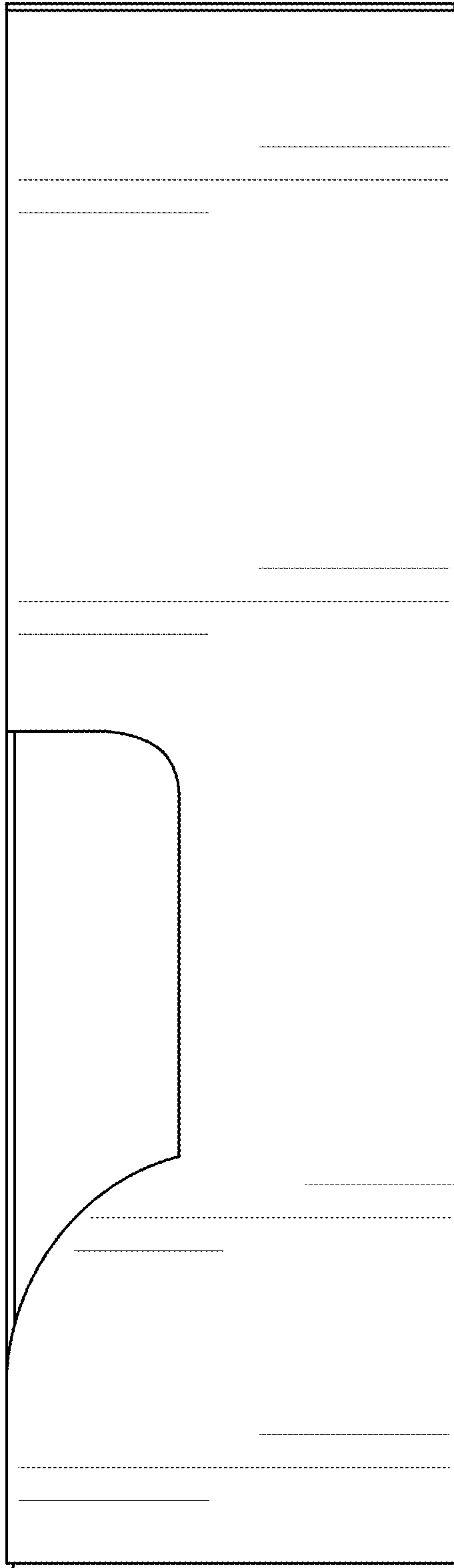

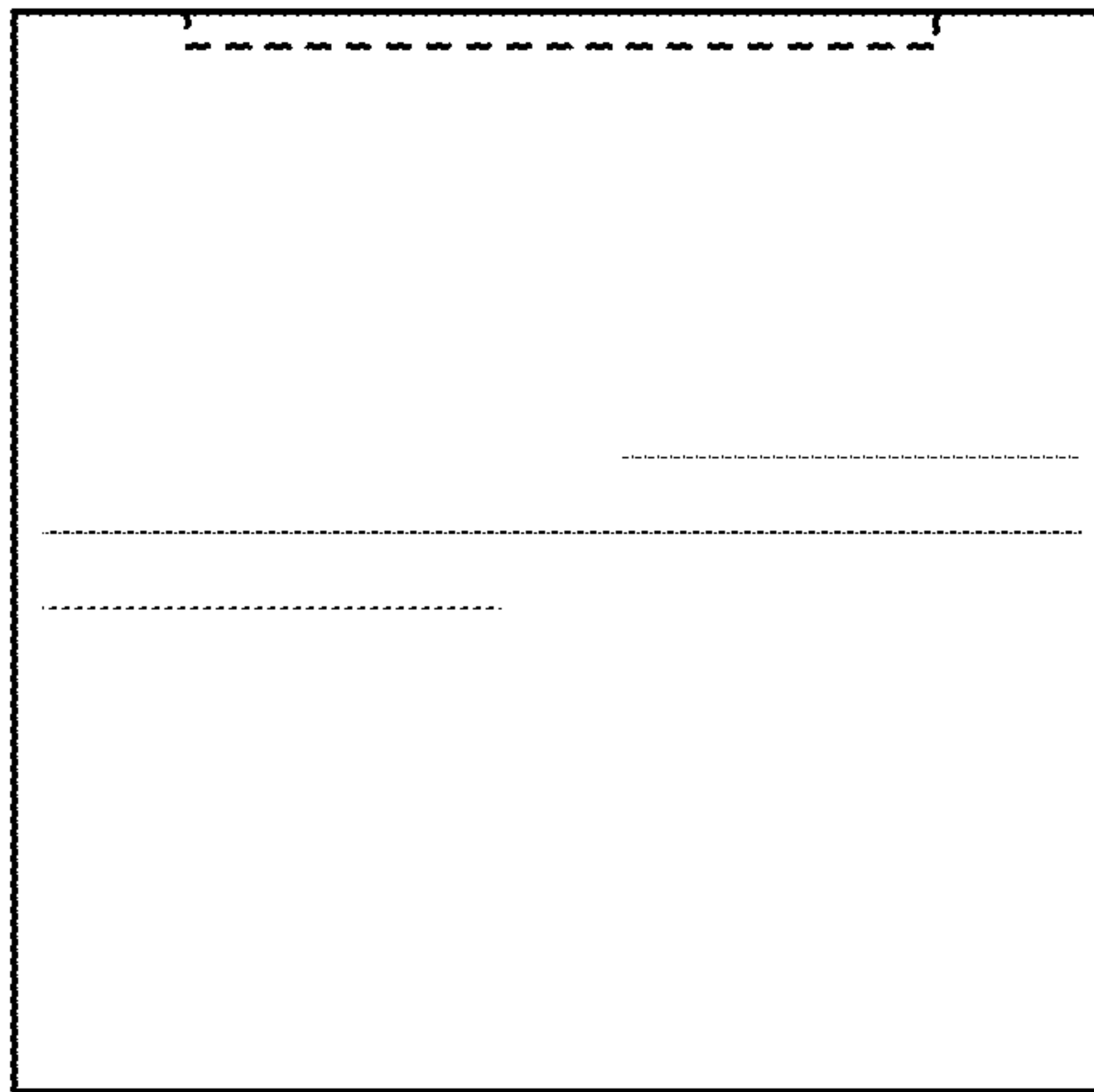

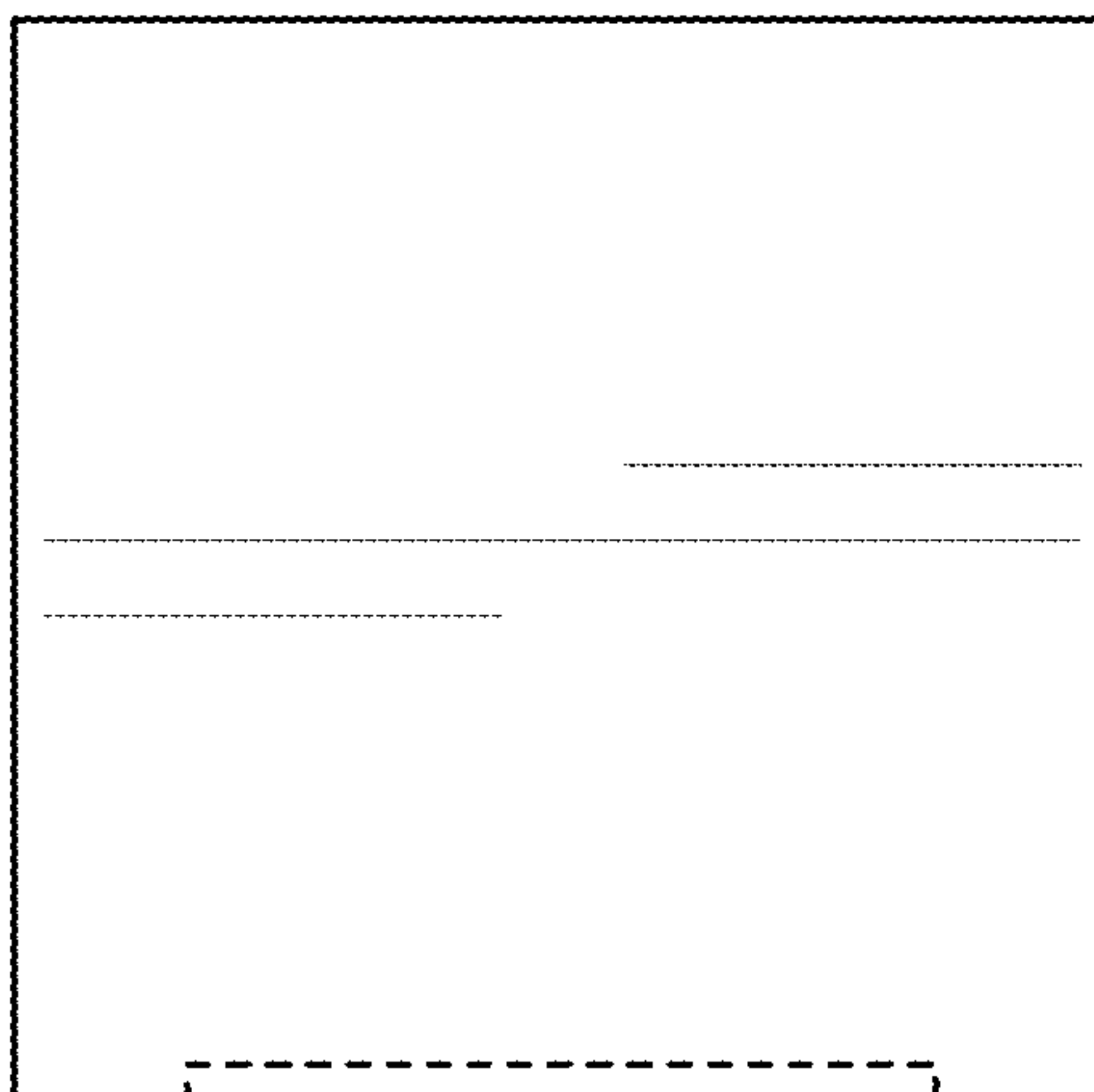
