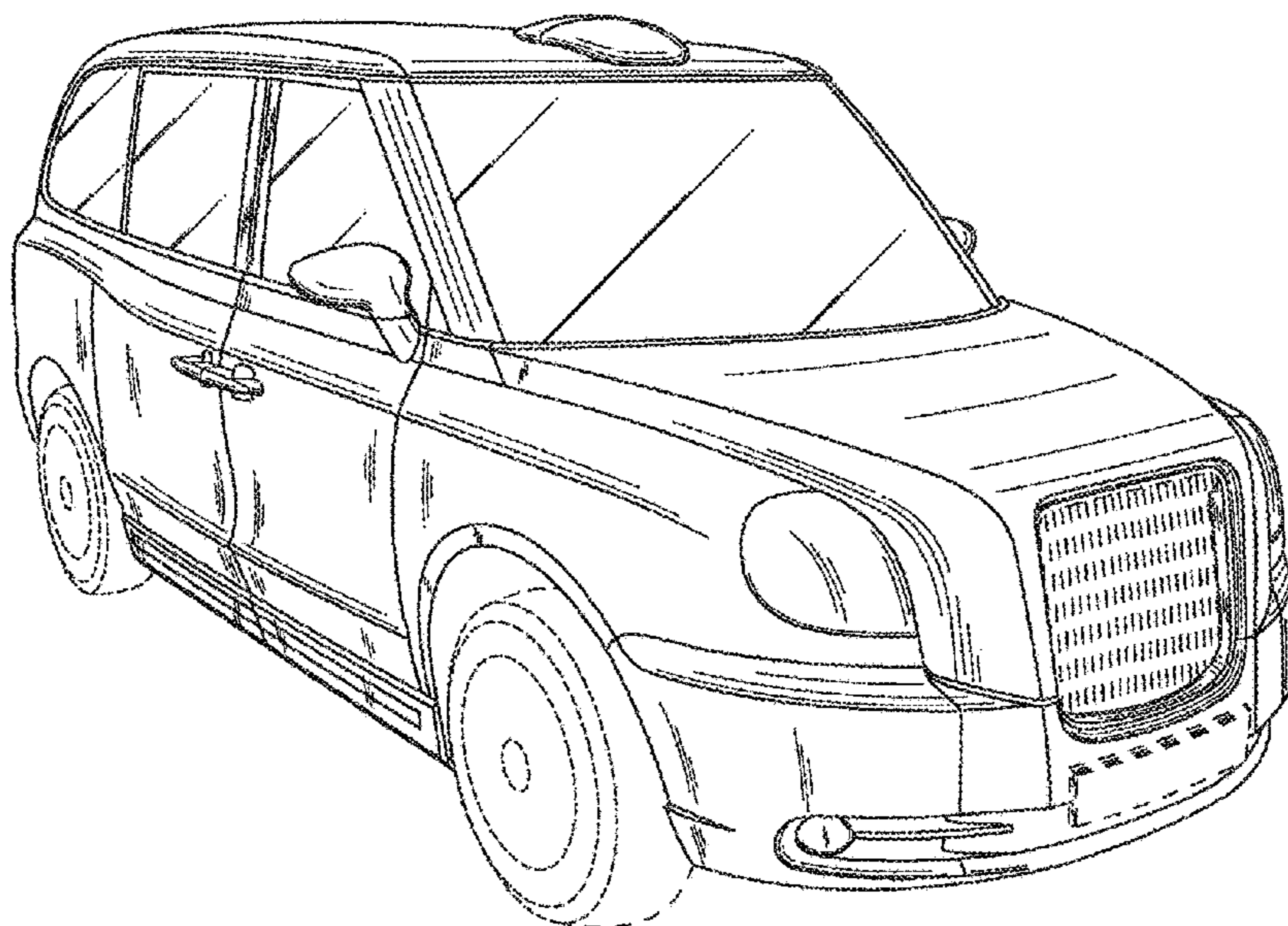
(57) **CLAIM**

The ornamental design for a motor vehicle, as shown and described.

DESCRIPTION

1. Motor vehicles
1.1 is a front and right side perspective of a motor vehicle showing the new design;
1.2 is a rear and right side perspective view thereof;
1.3 is a front elevation view thereof;
1.4 is a rear elevation view thereof;
1.5 is a right side elevation view thereof; and
1.6 is a top plan view thereof.
No protection is sought for the matters shown in dotted lines. The broken lines in the reproductions illustrate portions of the motor vehicle that do not form part of the claimed design.

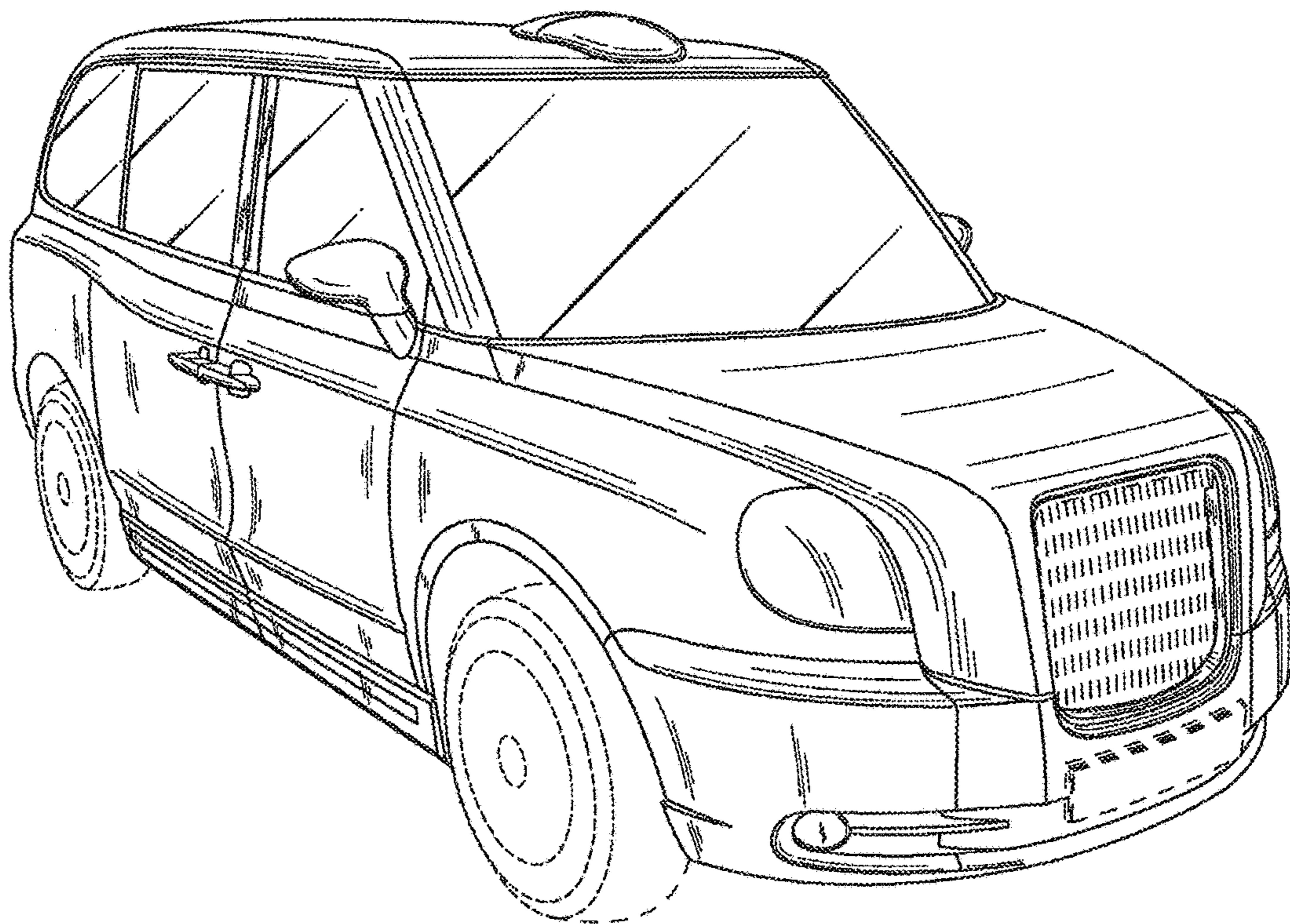

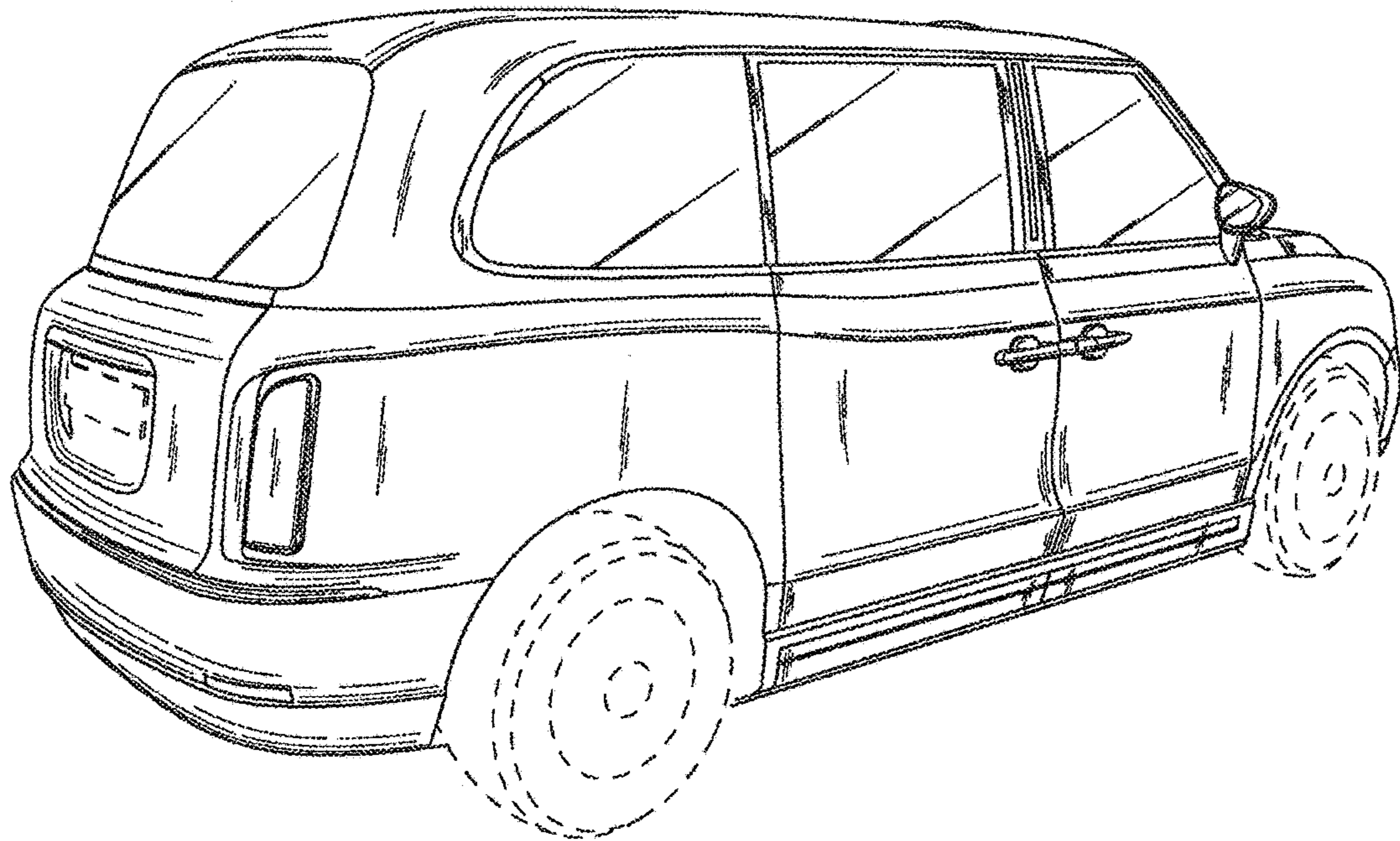

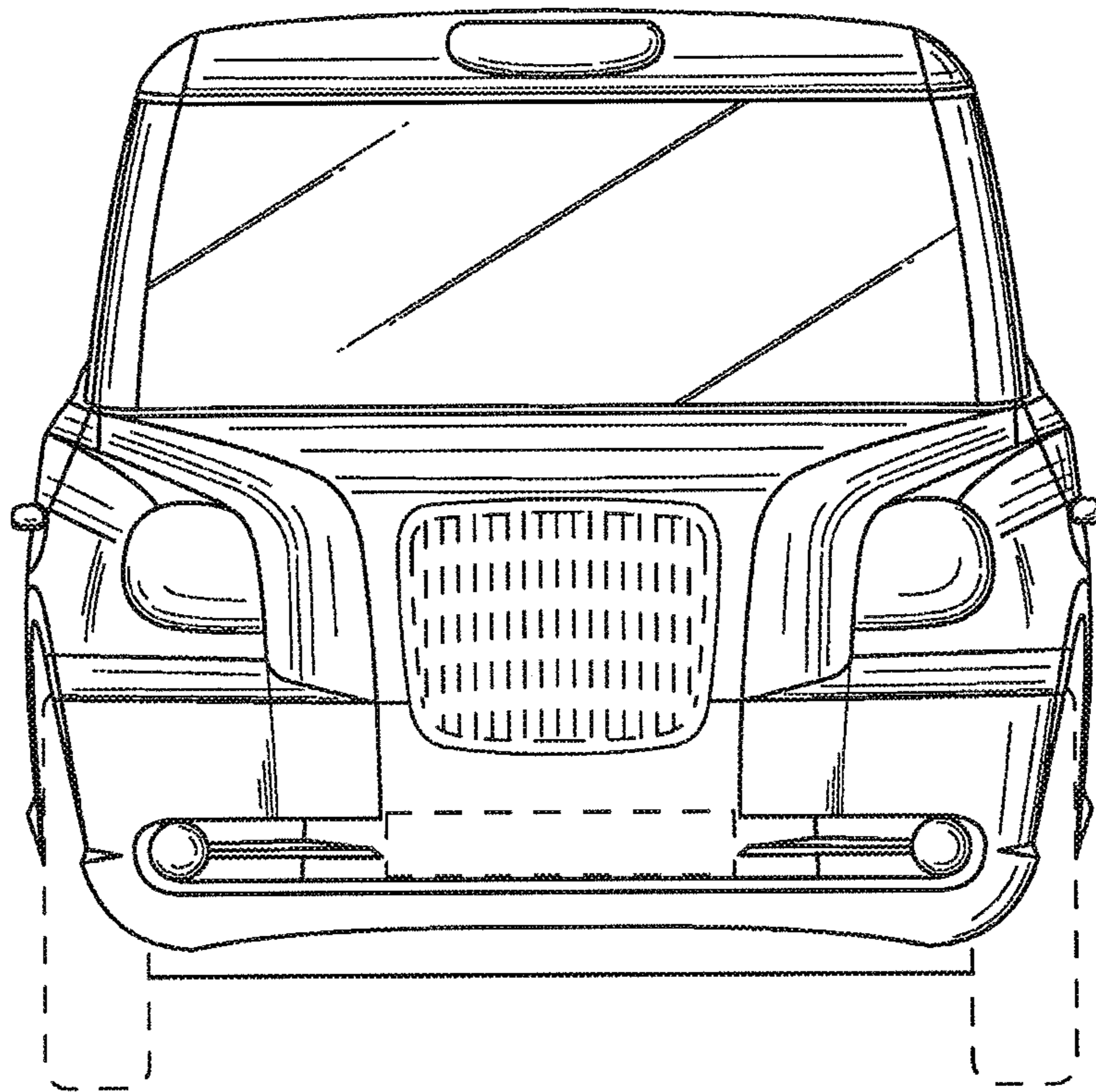

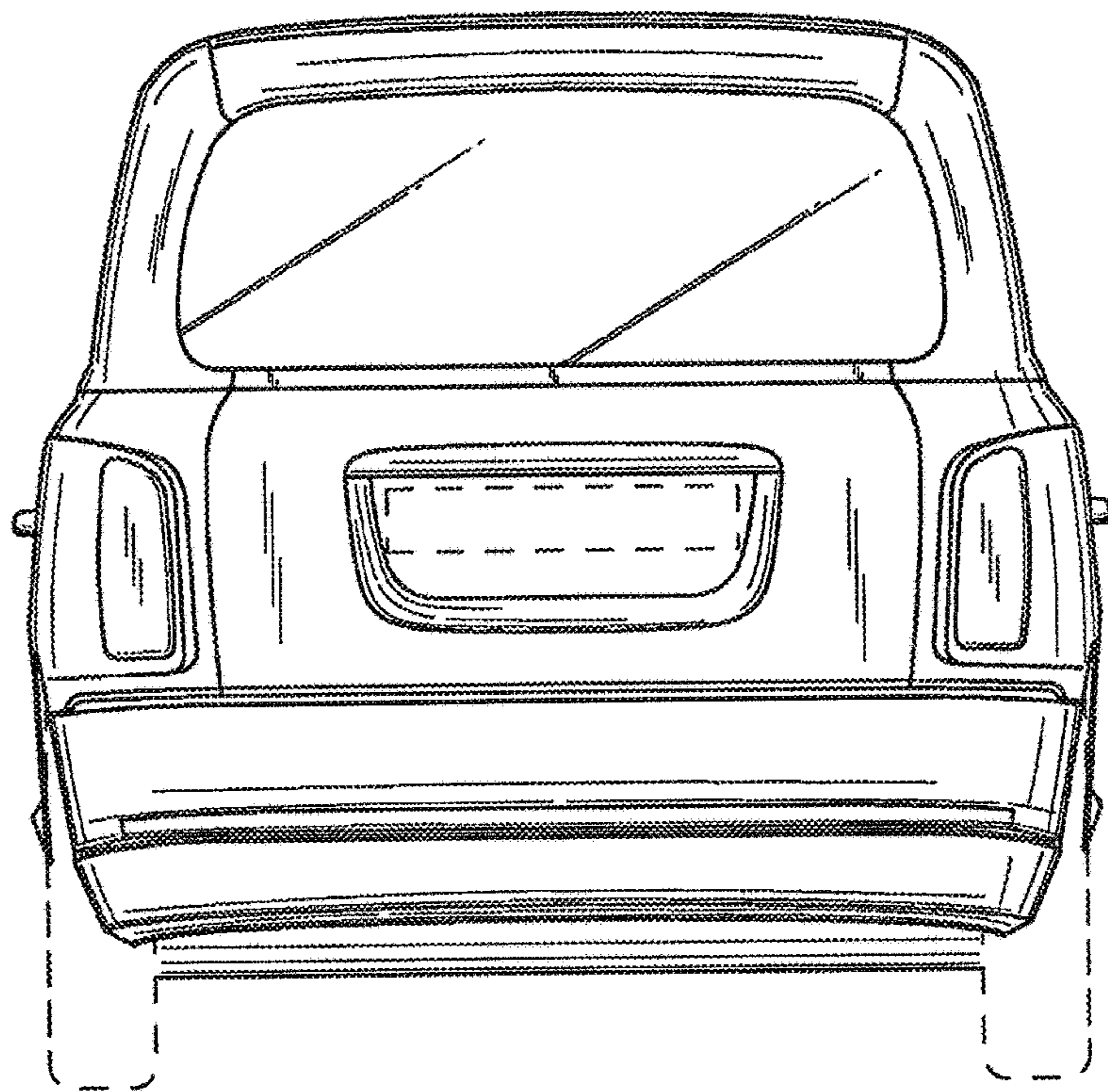

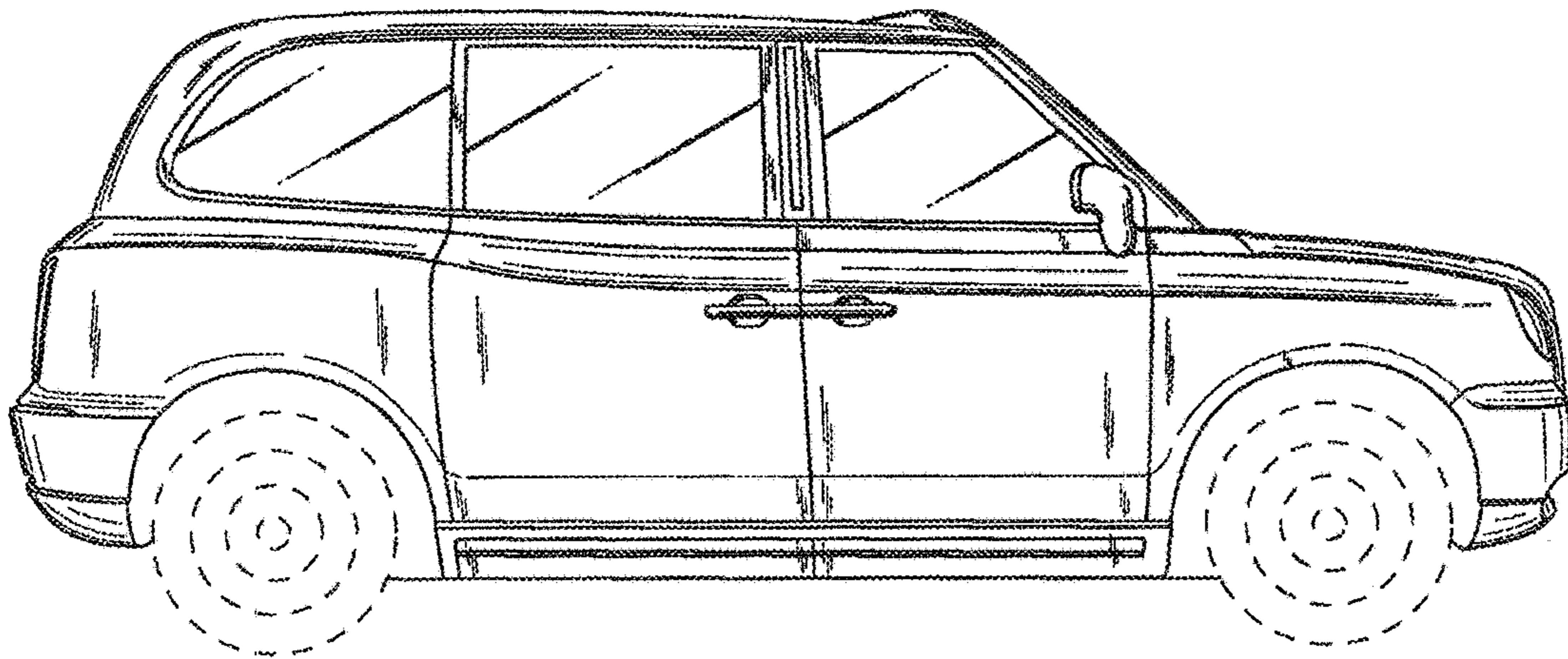

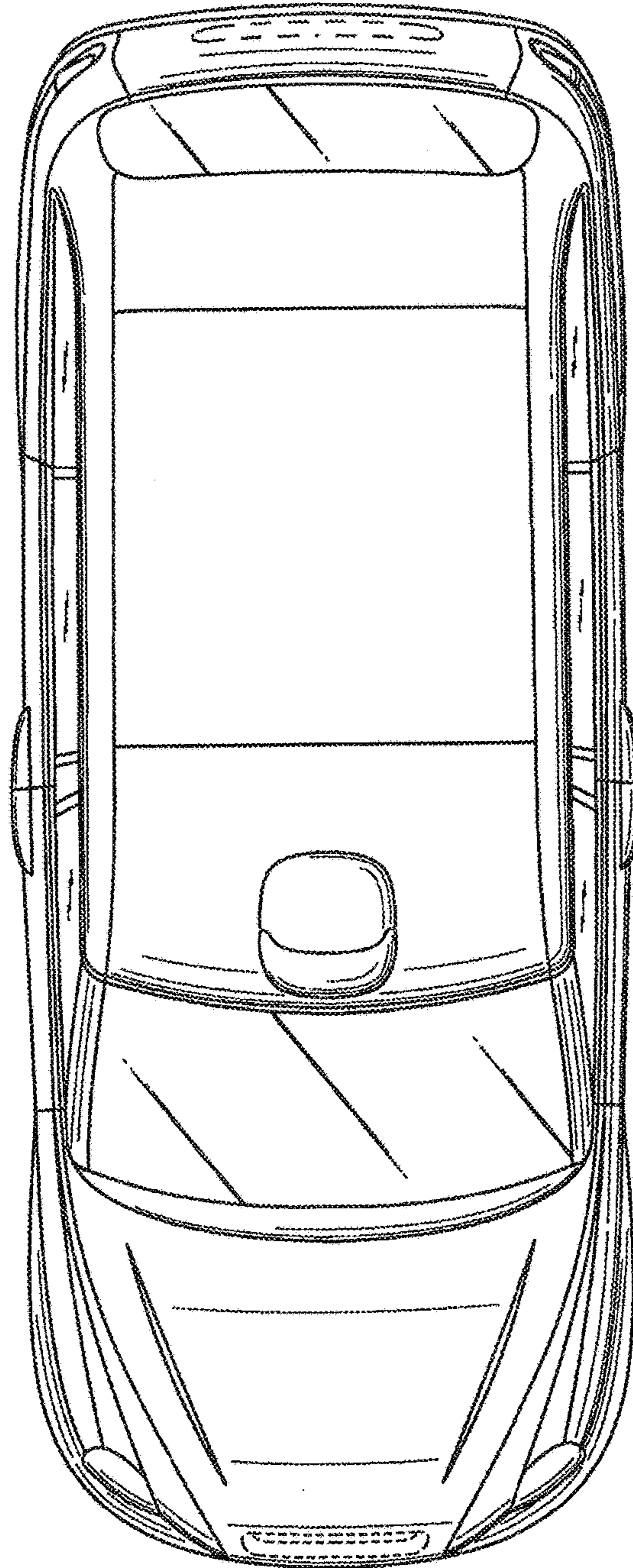
