(57) **CLAIM**

The ornamental design for a vehicle wheel, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a vehicle wheel according to the design;  
FIG. 2 is an additional perspective view thereof;  
FIG. 3 is an additional perspective view thereof;  
FIG. 4 is a front view thereof;  
FIG. 5 is a rear view thereof; and,  
FIG. 6 is a side view thereof.  
The low-contrast rendering in FIG. 5 depicts portions of the vehicle wheel that form no part of the claimed design.

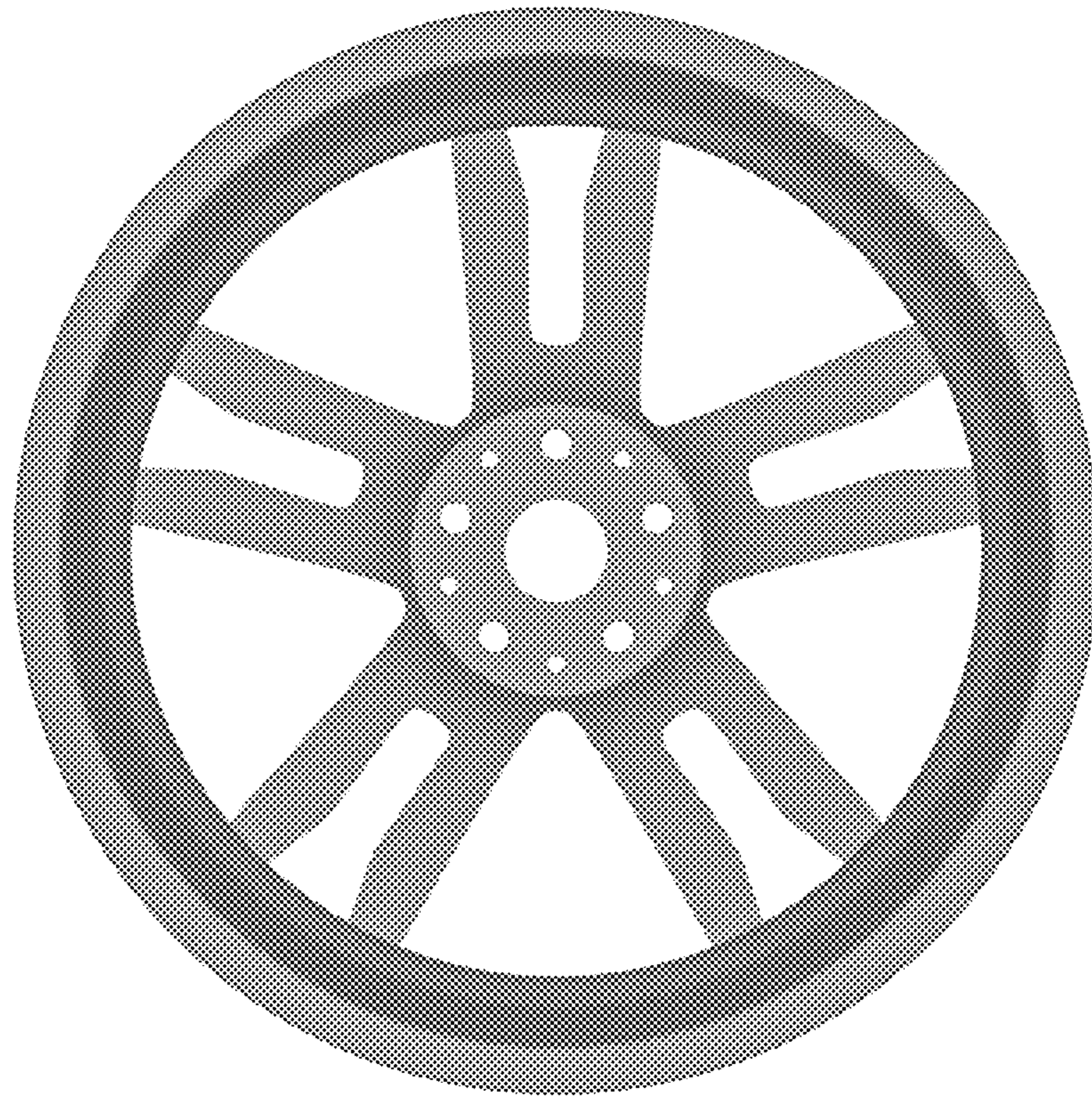

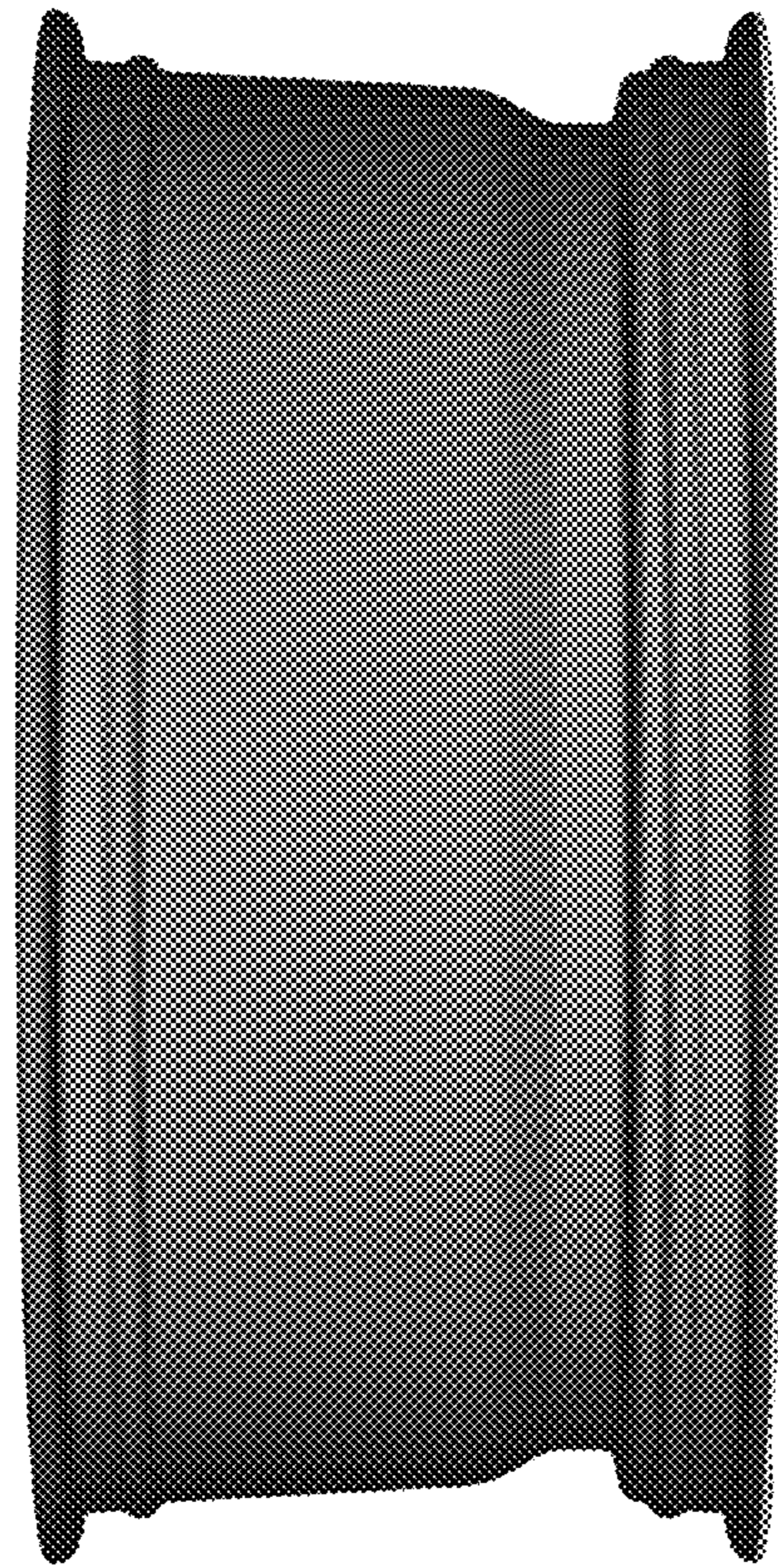
