The ornamental design for a retread band, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a segment of a retread band showing our new design;

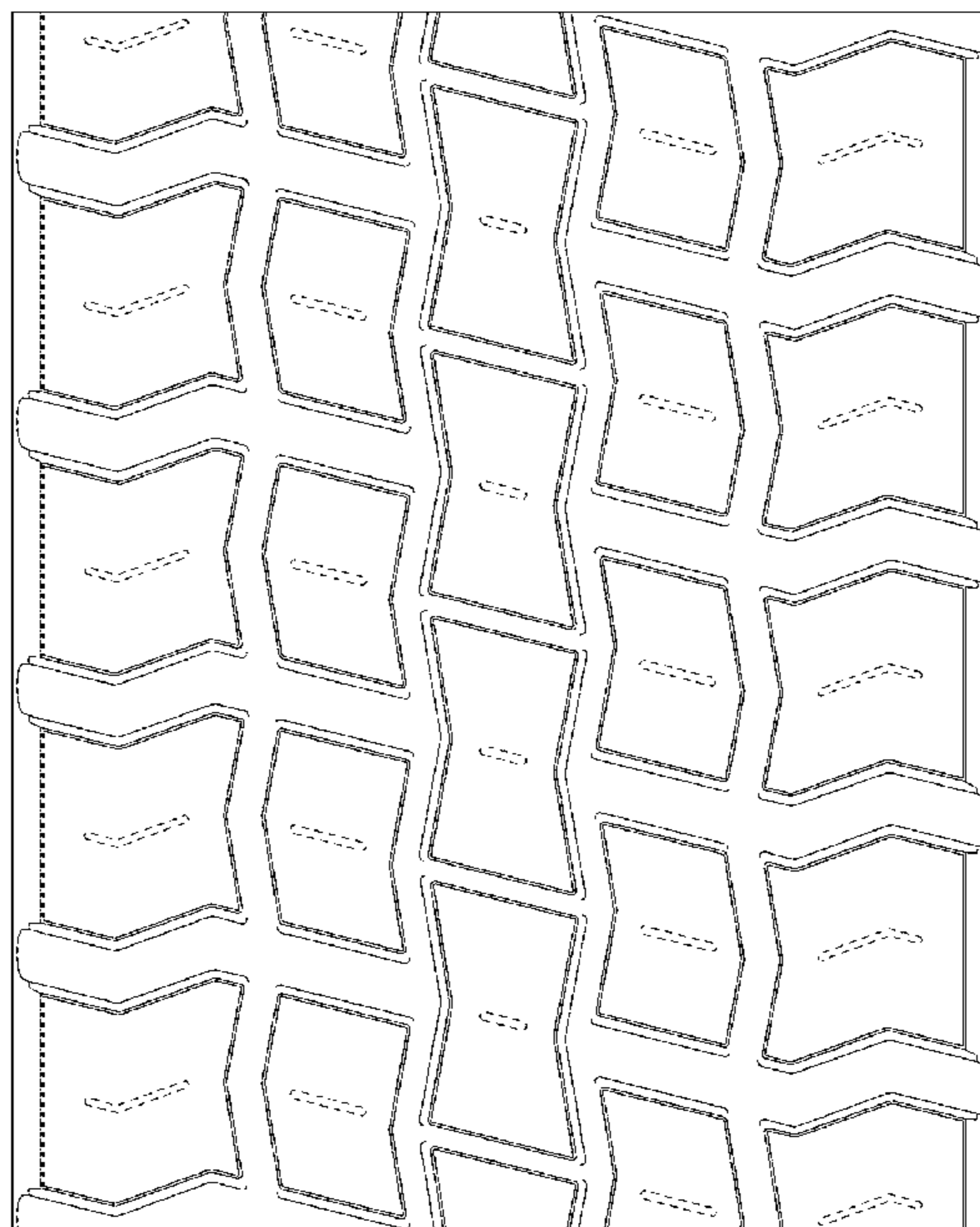
FIG. 2 is a front elevation view of a segment of the retread band of FIG. 1;

FIG. 3 is a portion taken from FIG. 2 to show the section line for FIG. 4; and,

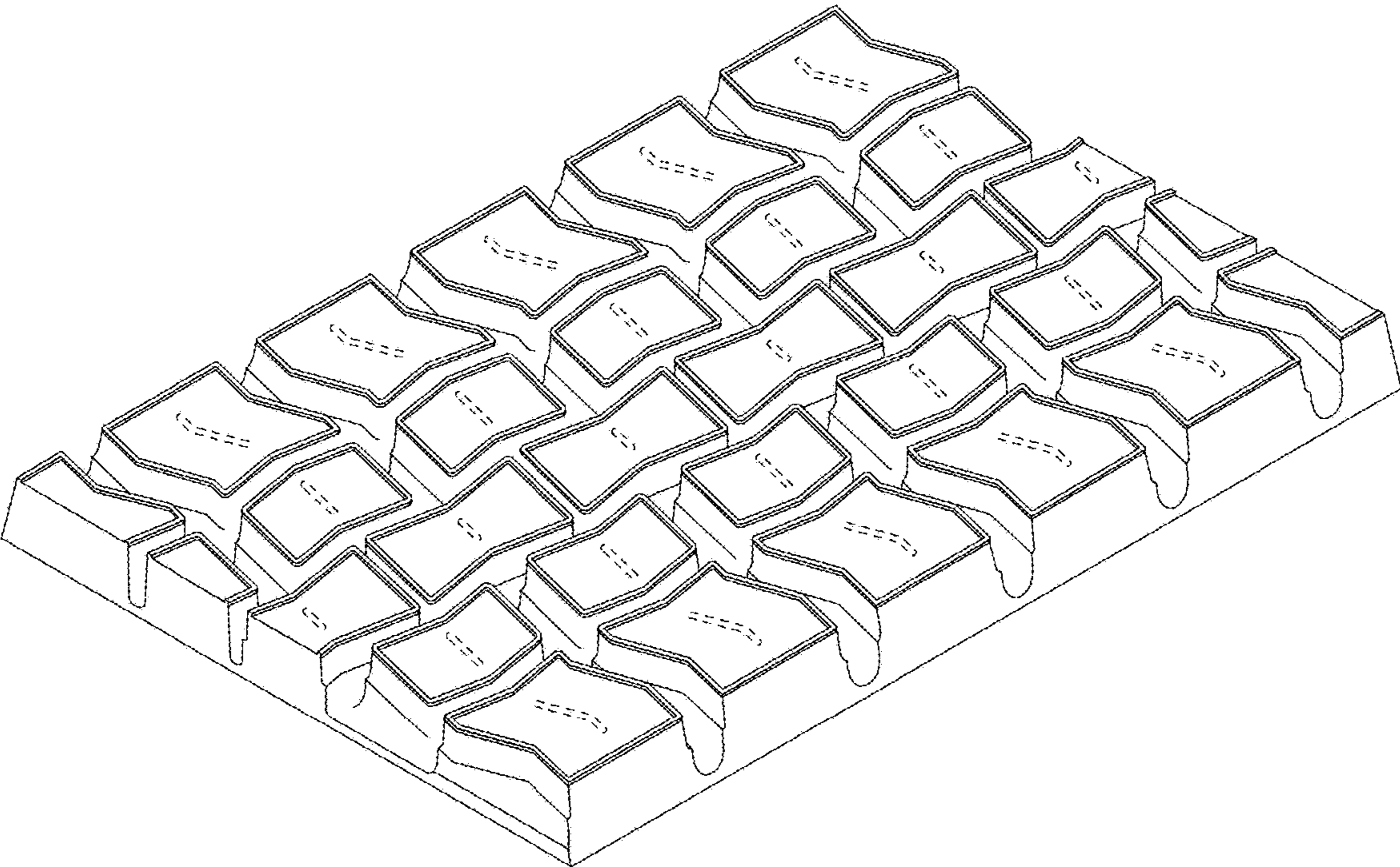

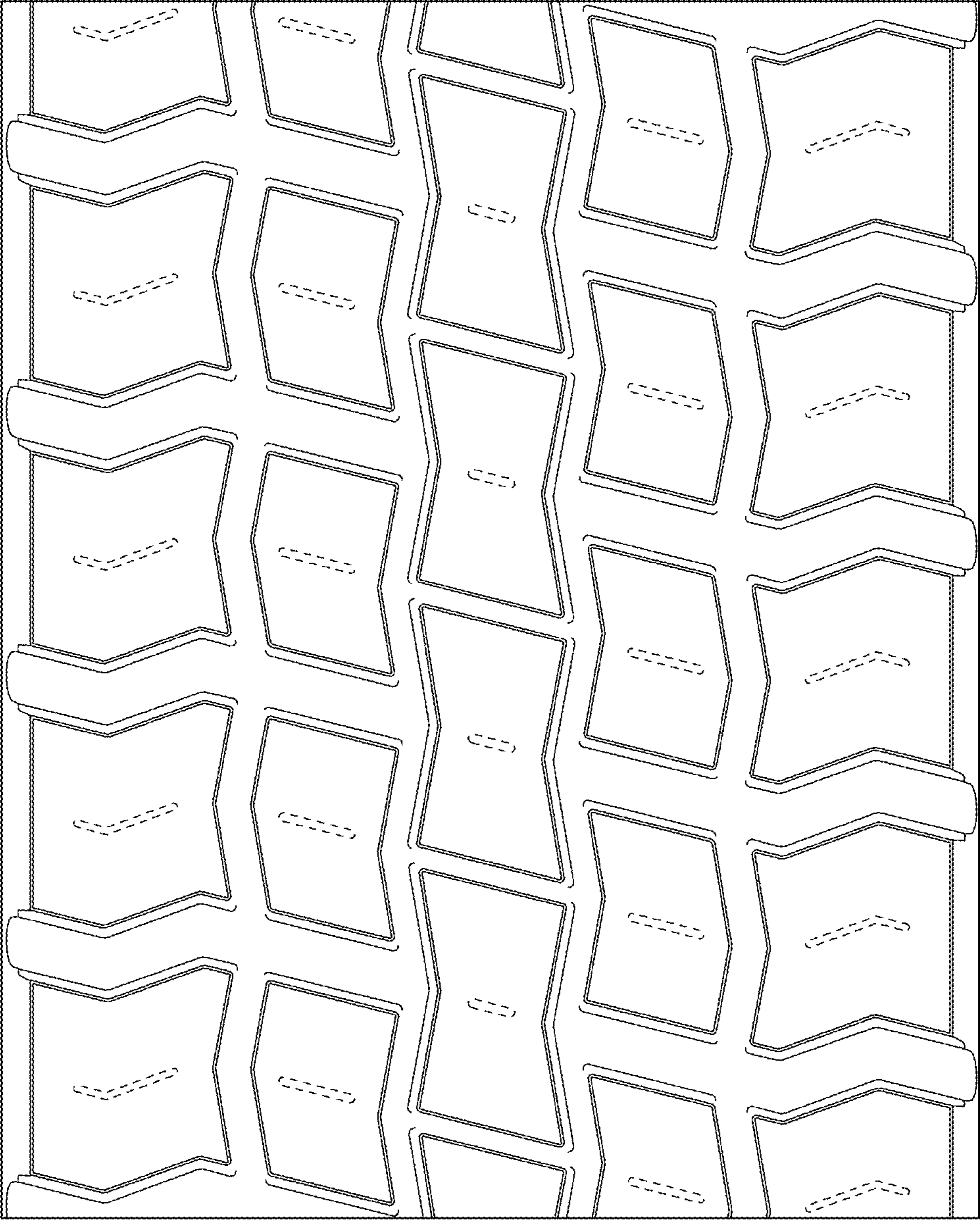

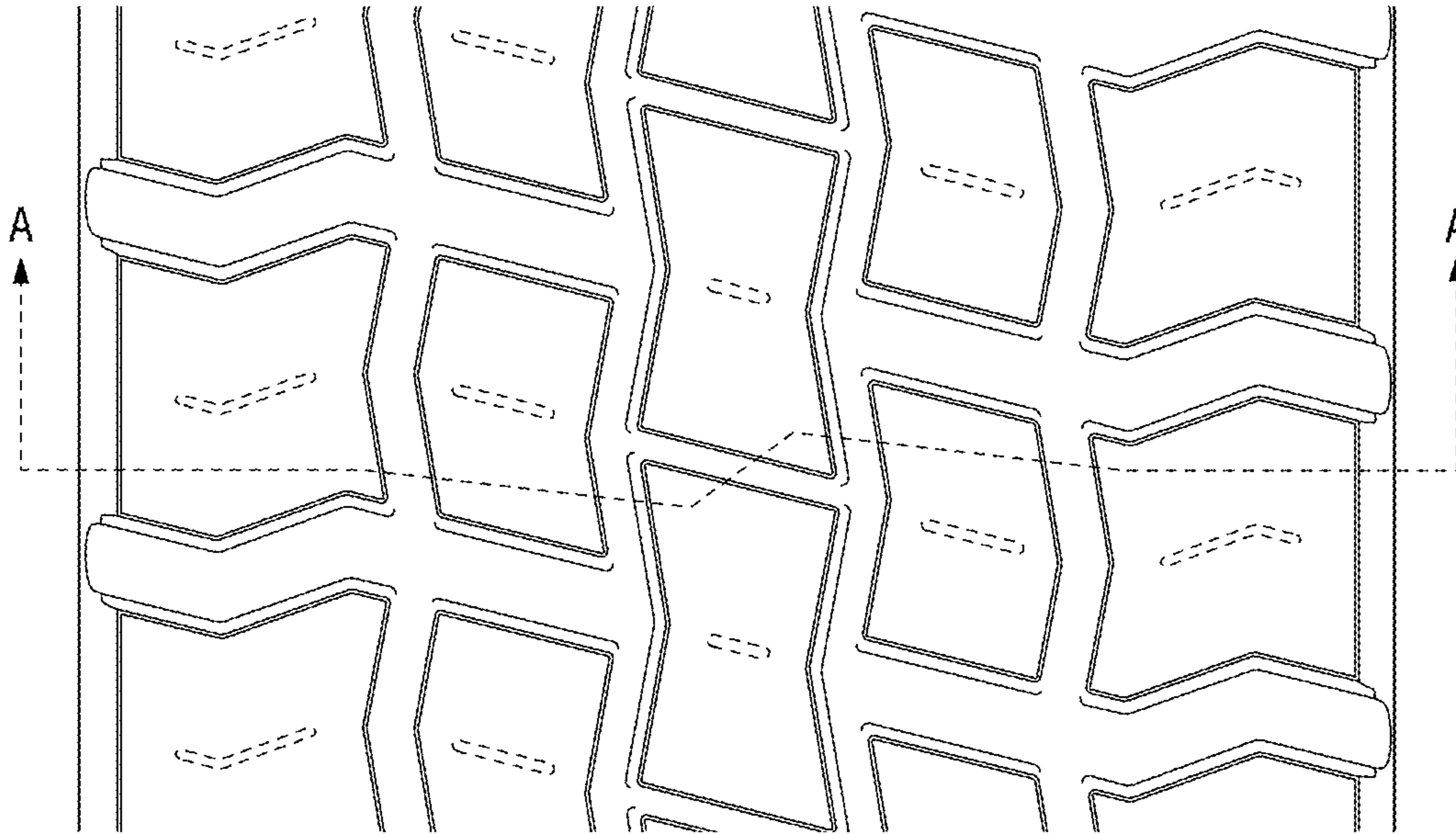

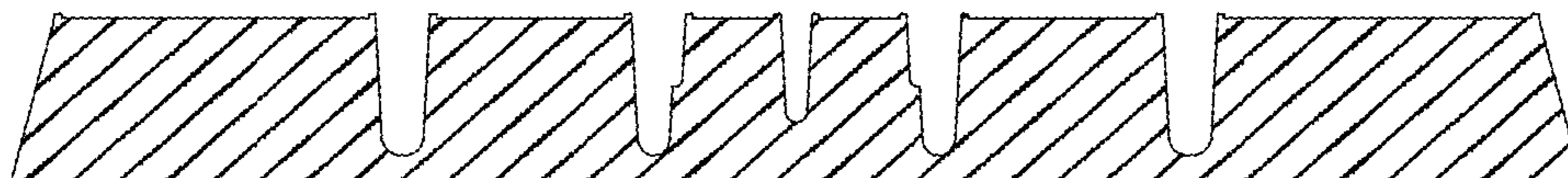
