 The ornamental design for a cable clamping insert, as shown and described.

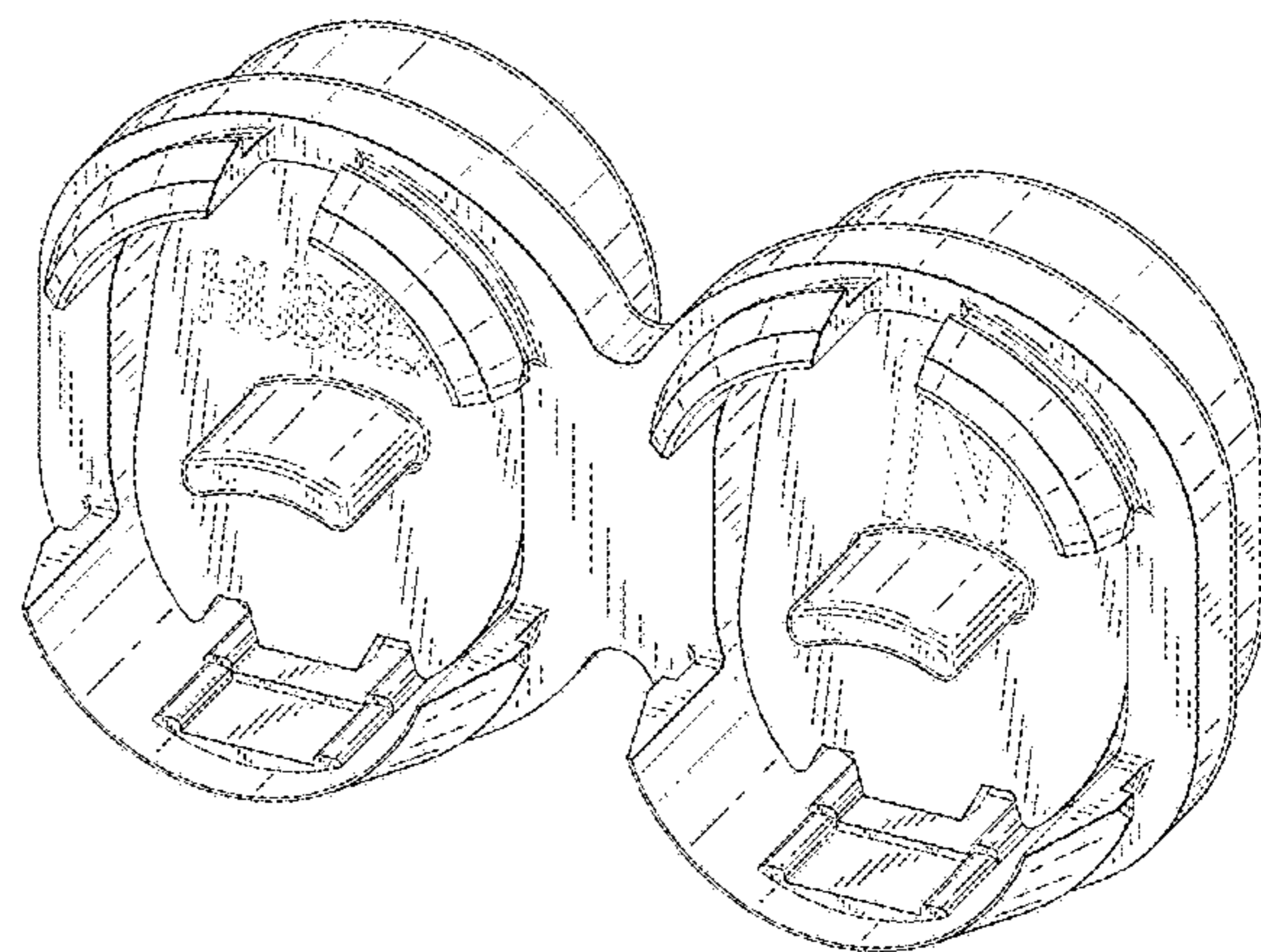
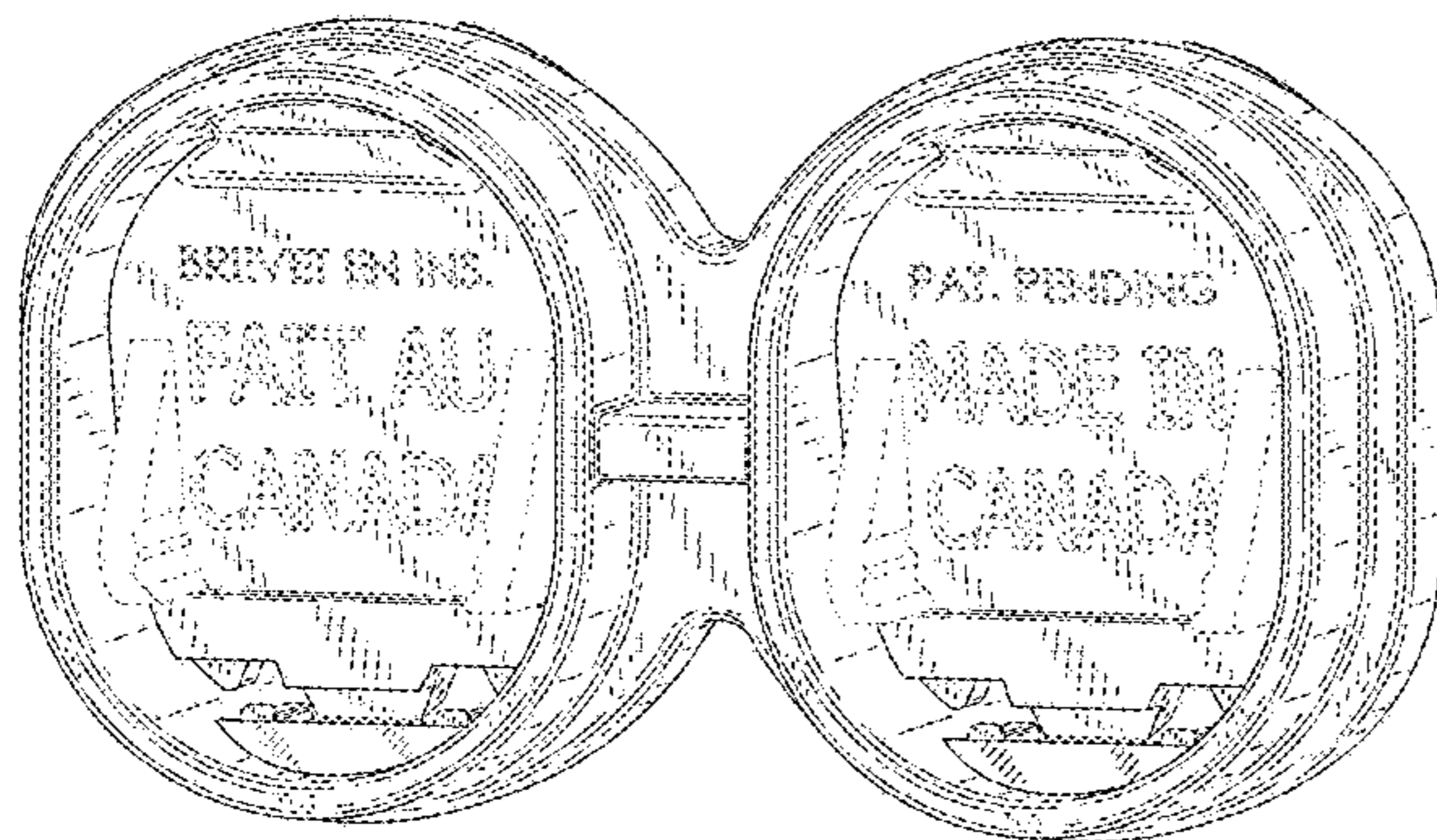
**DESCRIPTION**

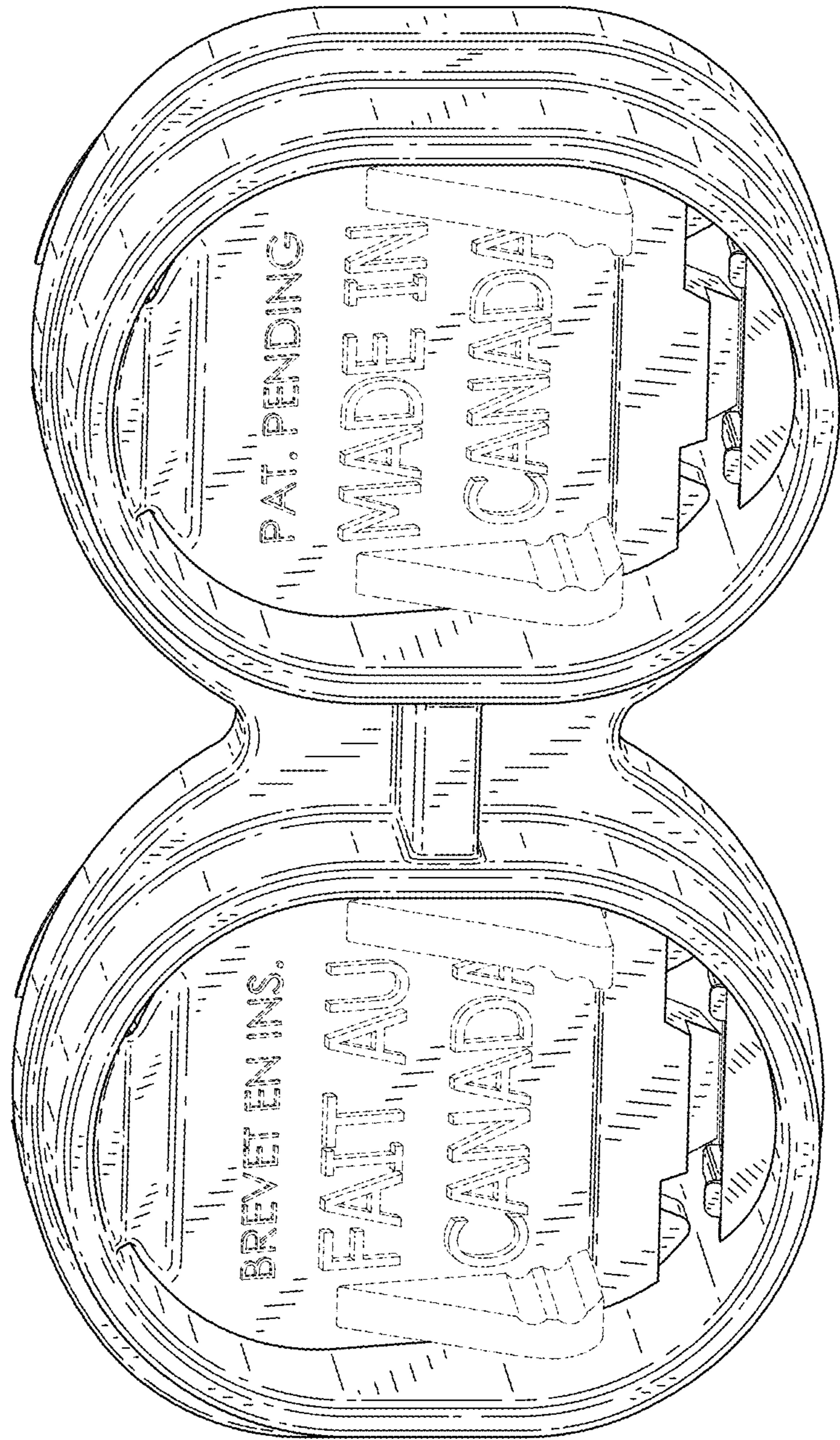

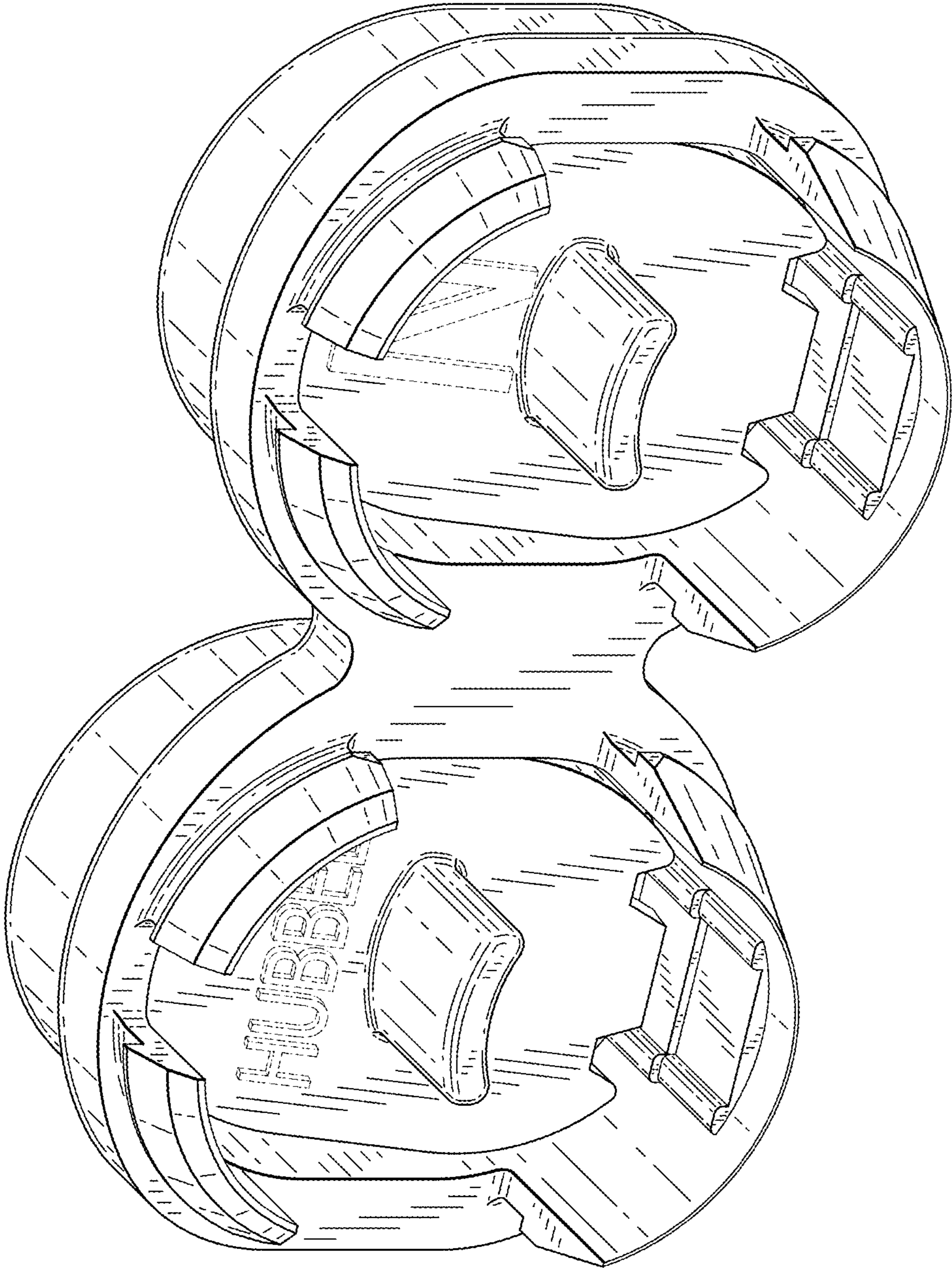

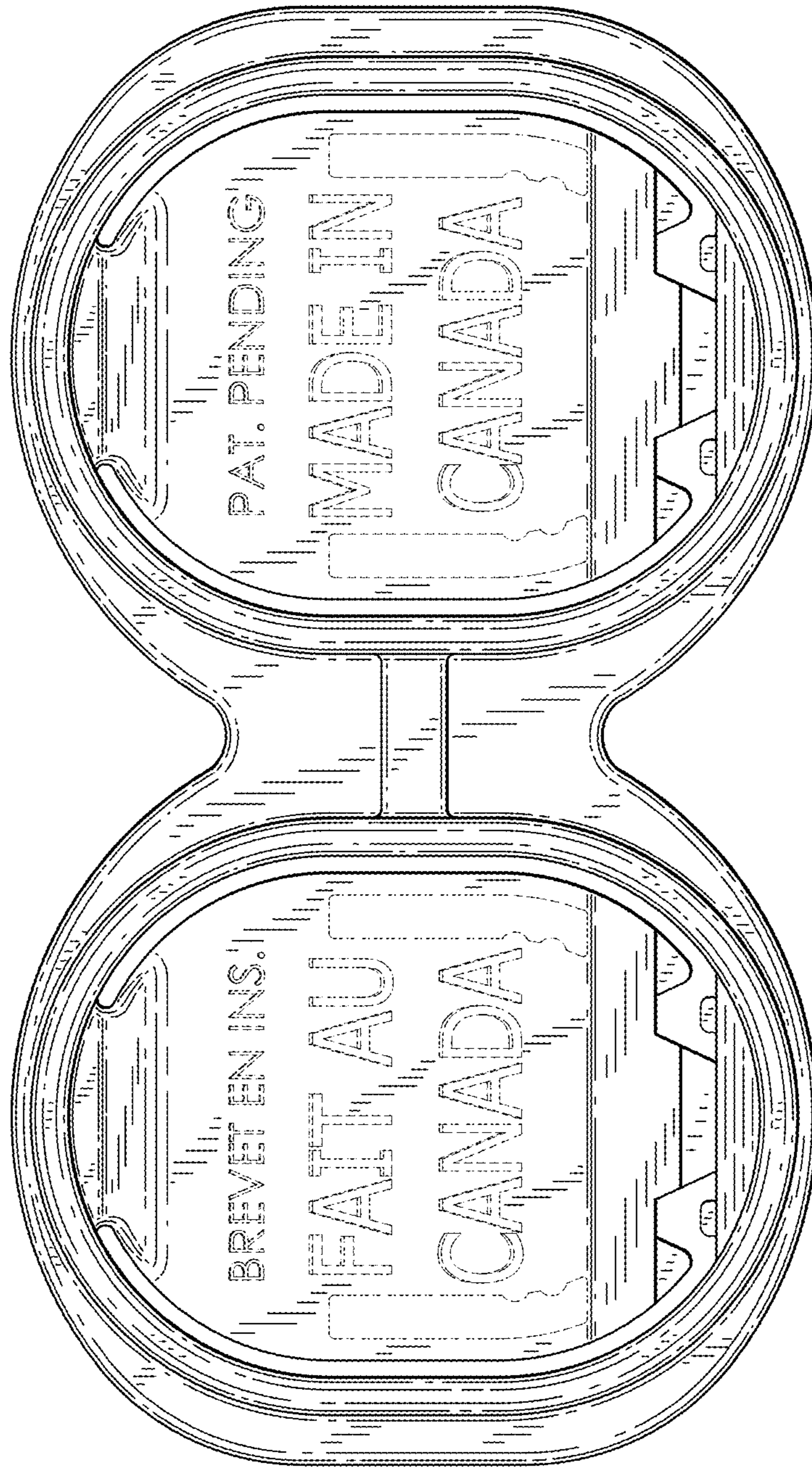

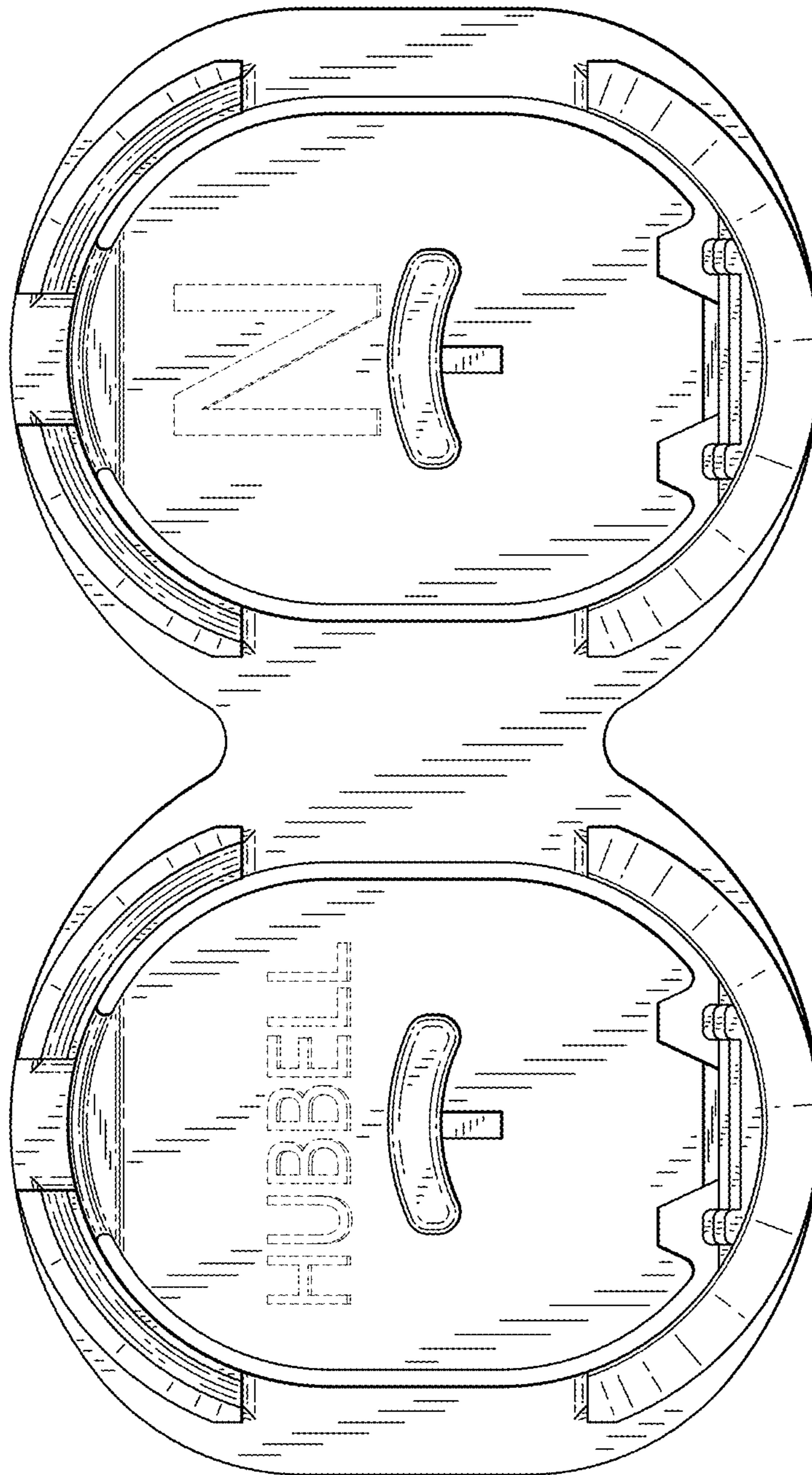

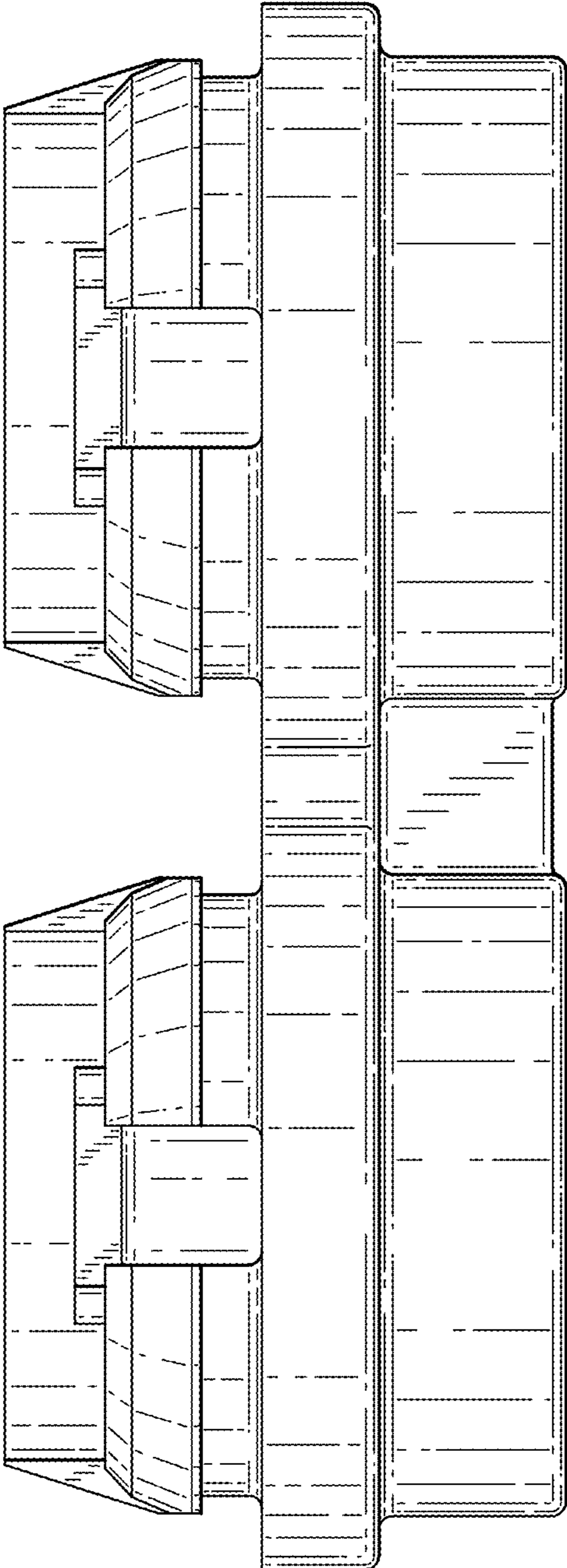

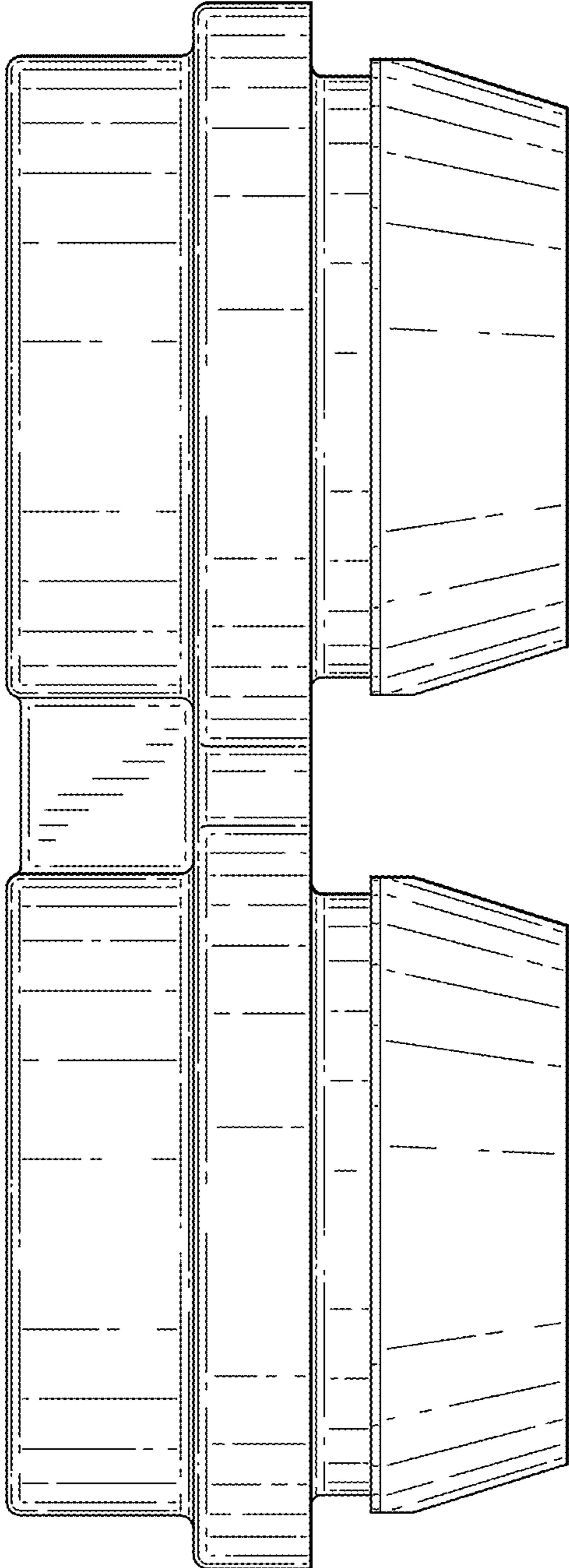

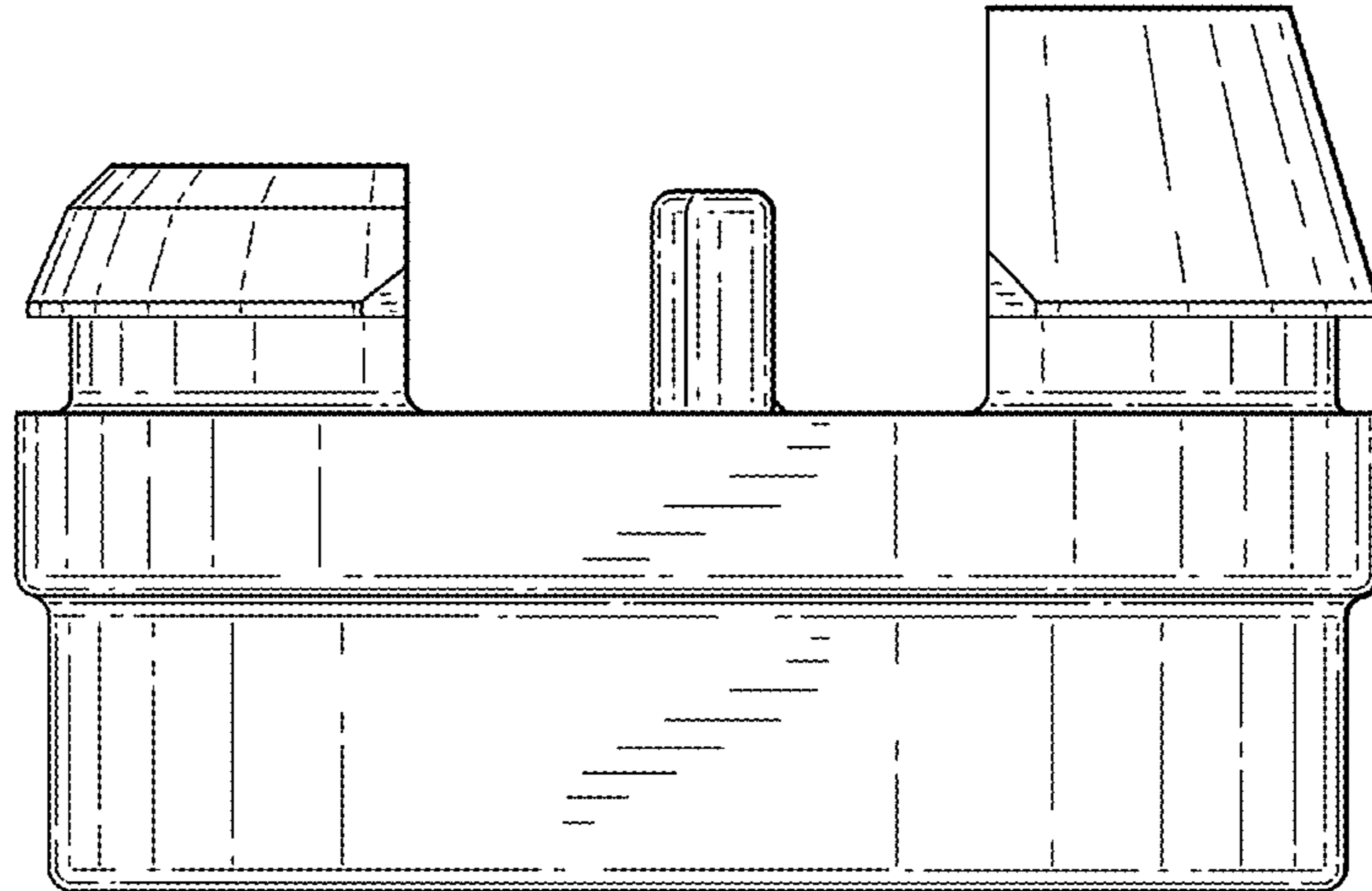
