DESCRIPTION

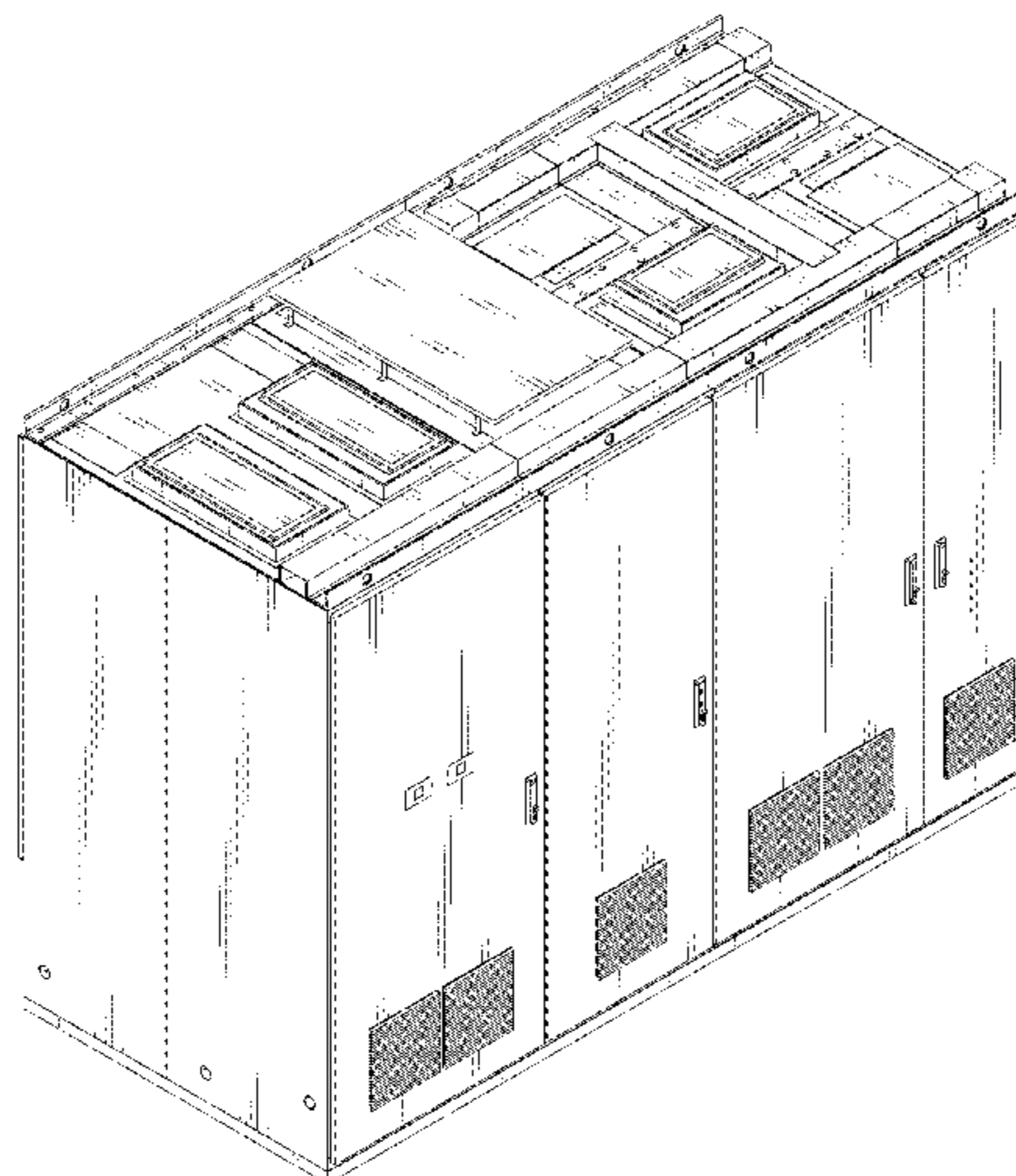

The broken lines in FIG. 8 show portions of the power converter enclosure which form no part of the claimed design.

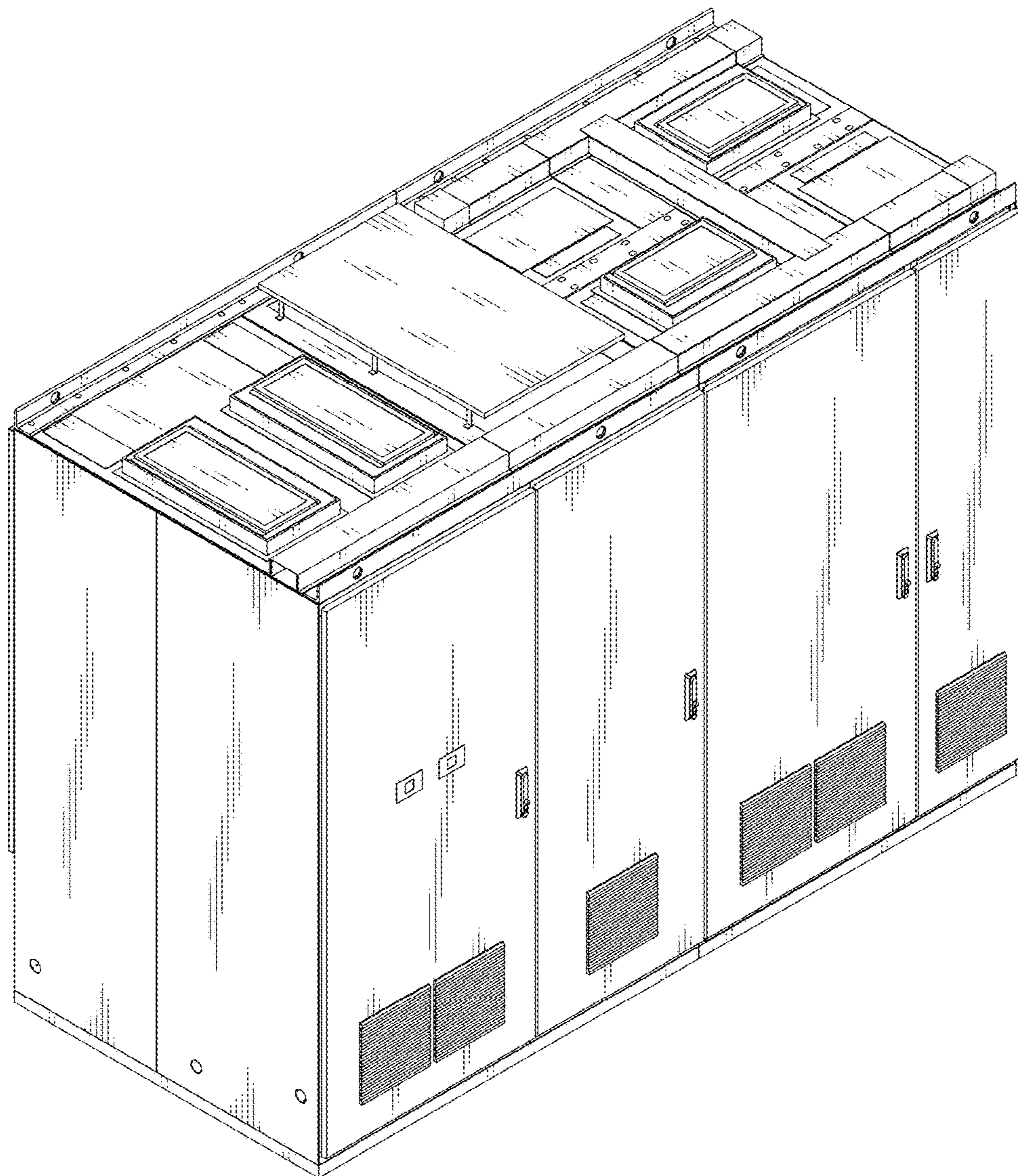

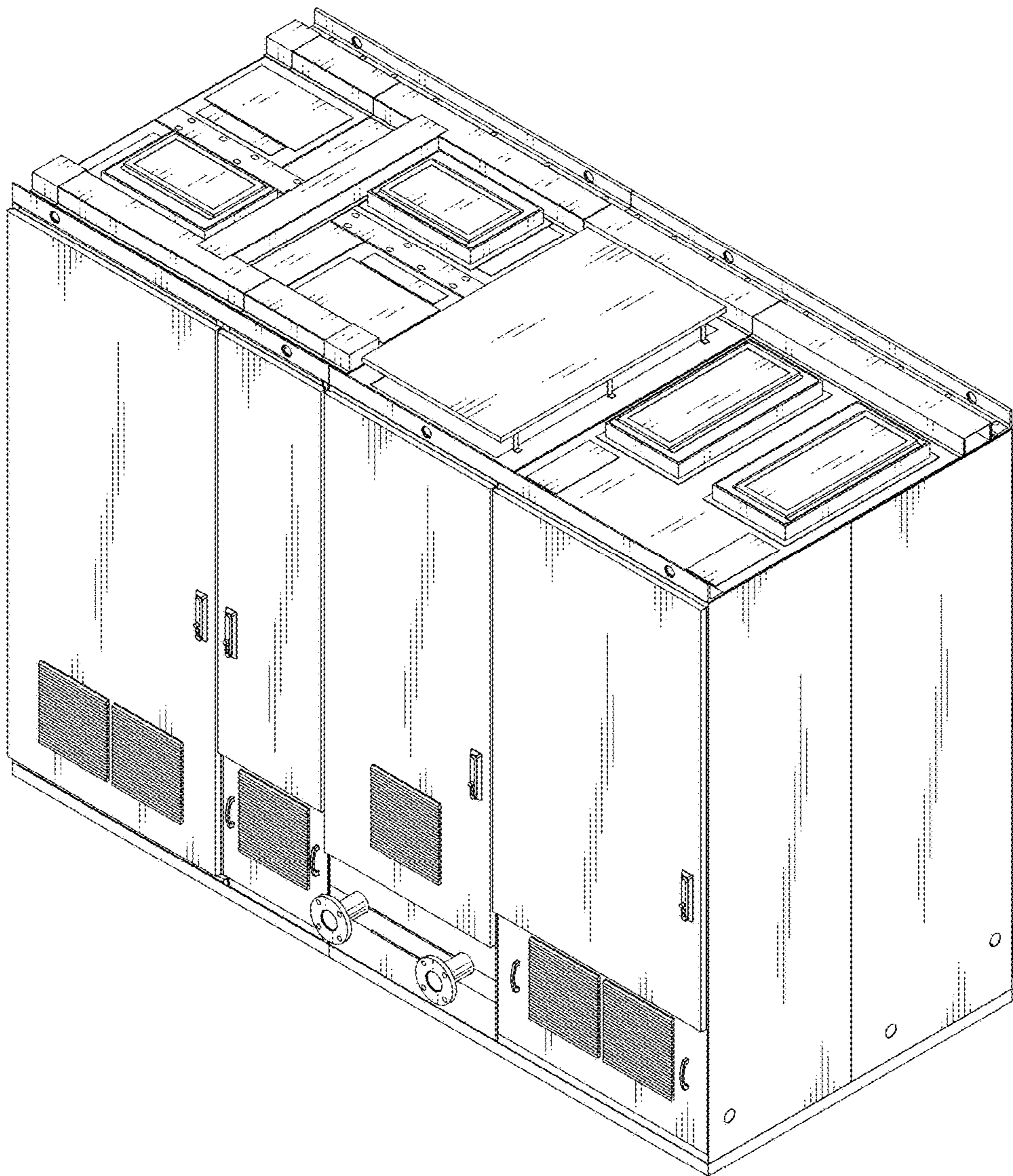

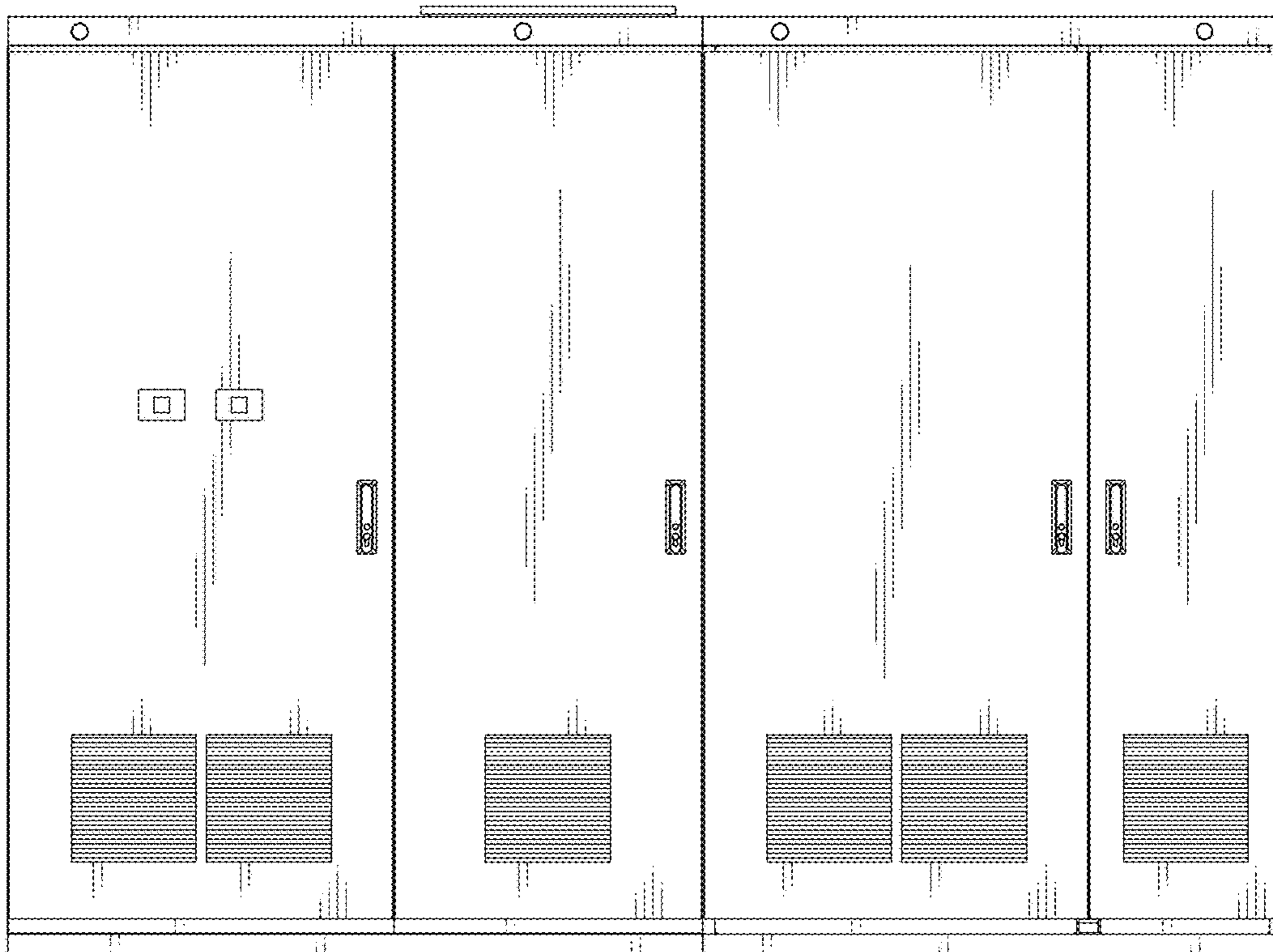

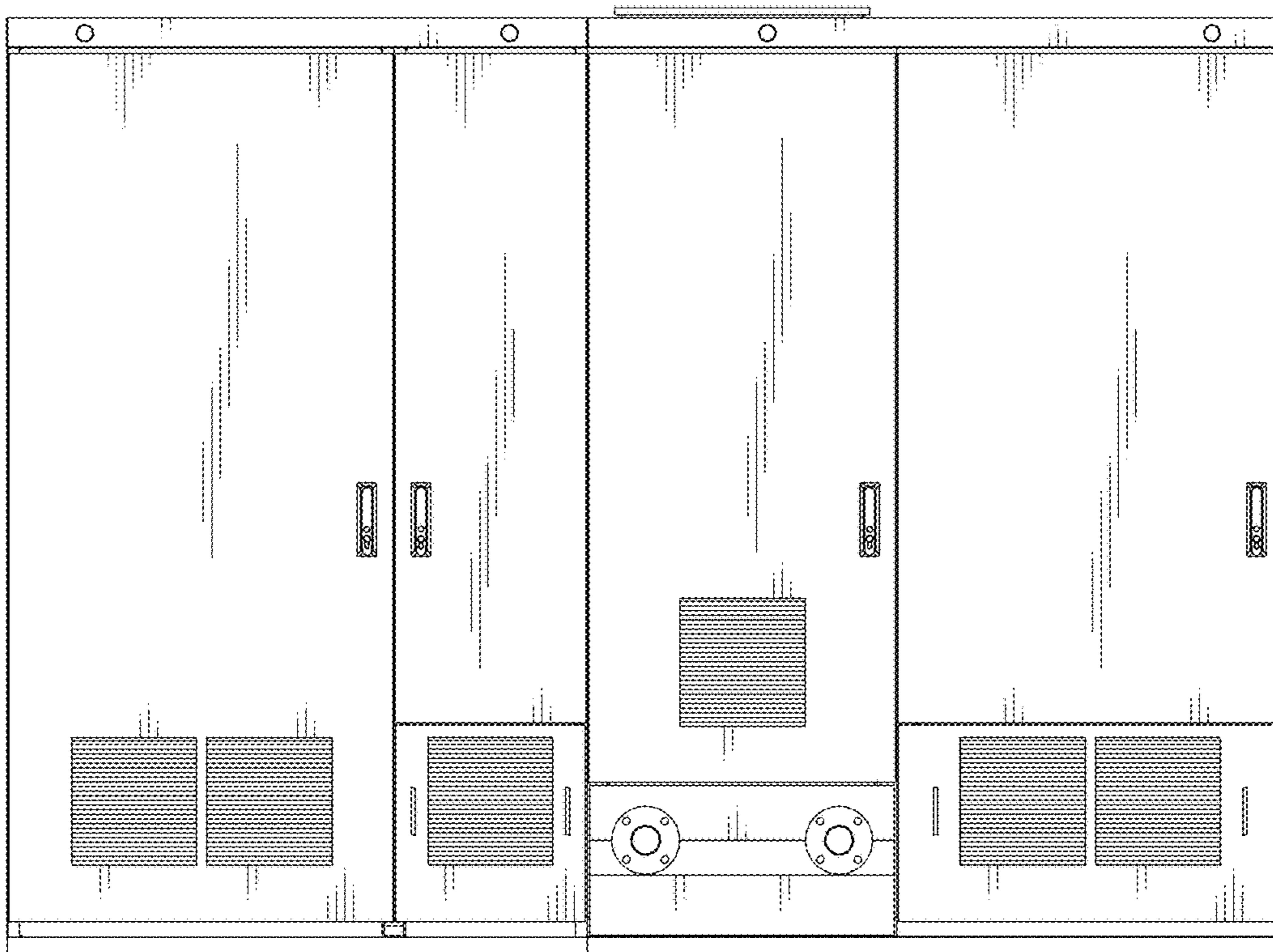

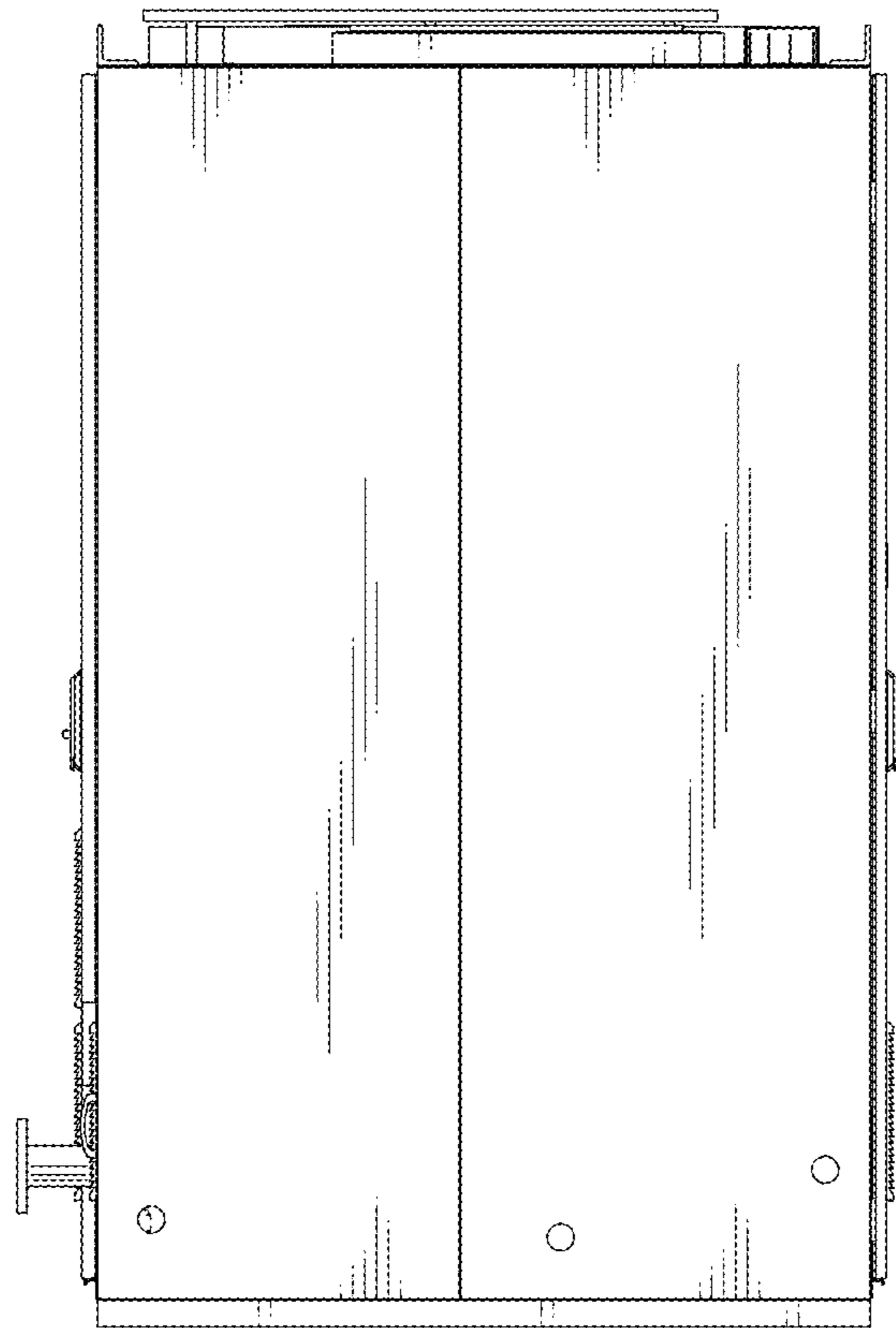

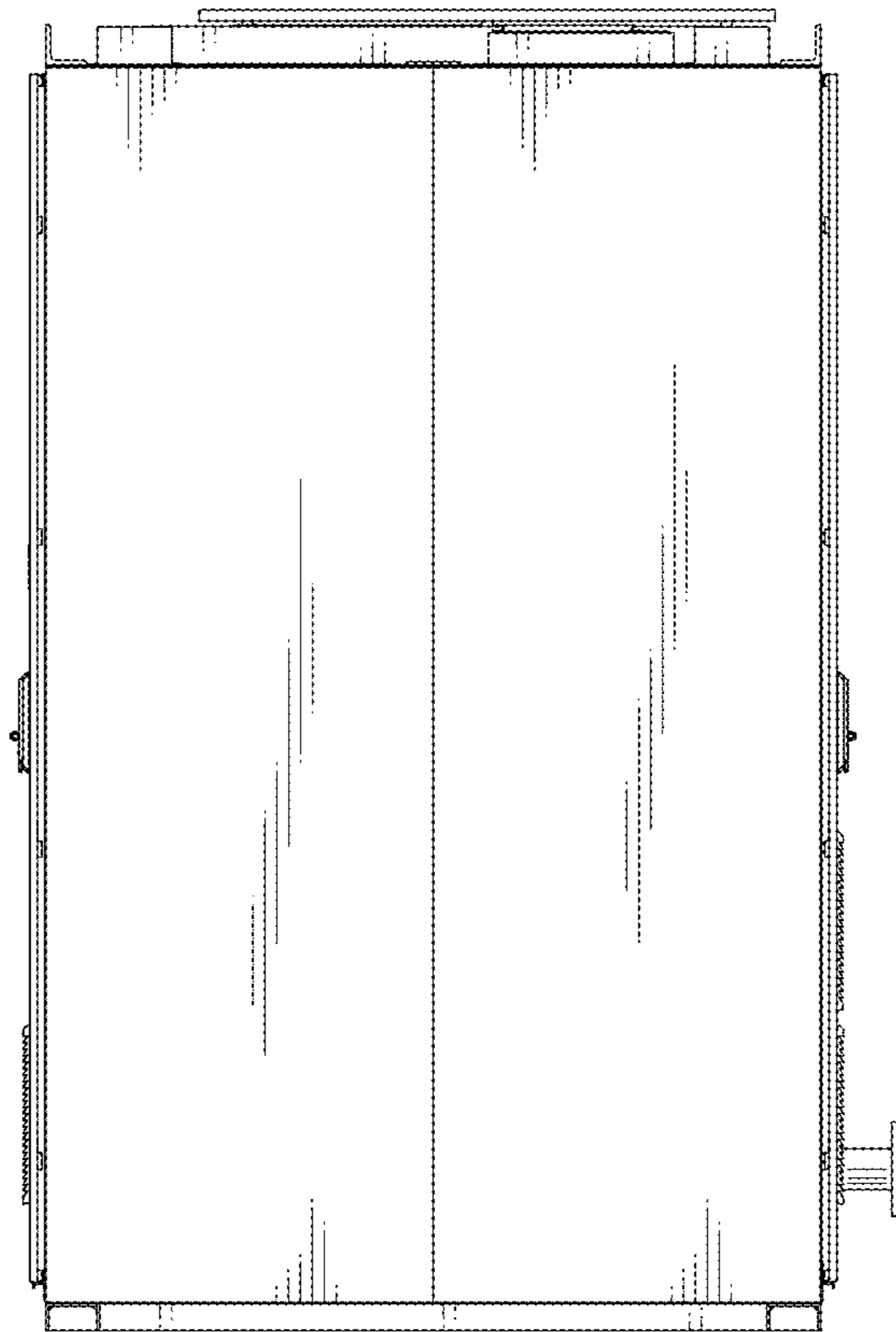

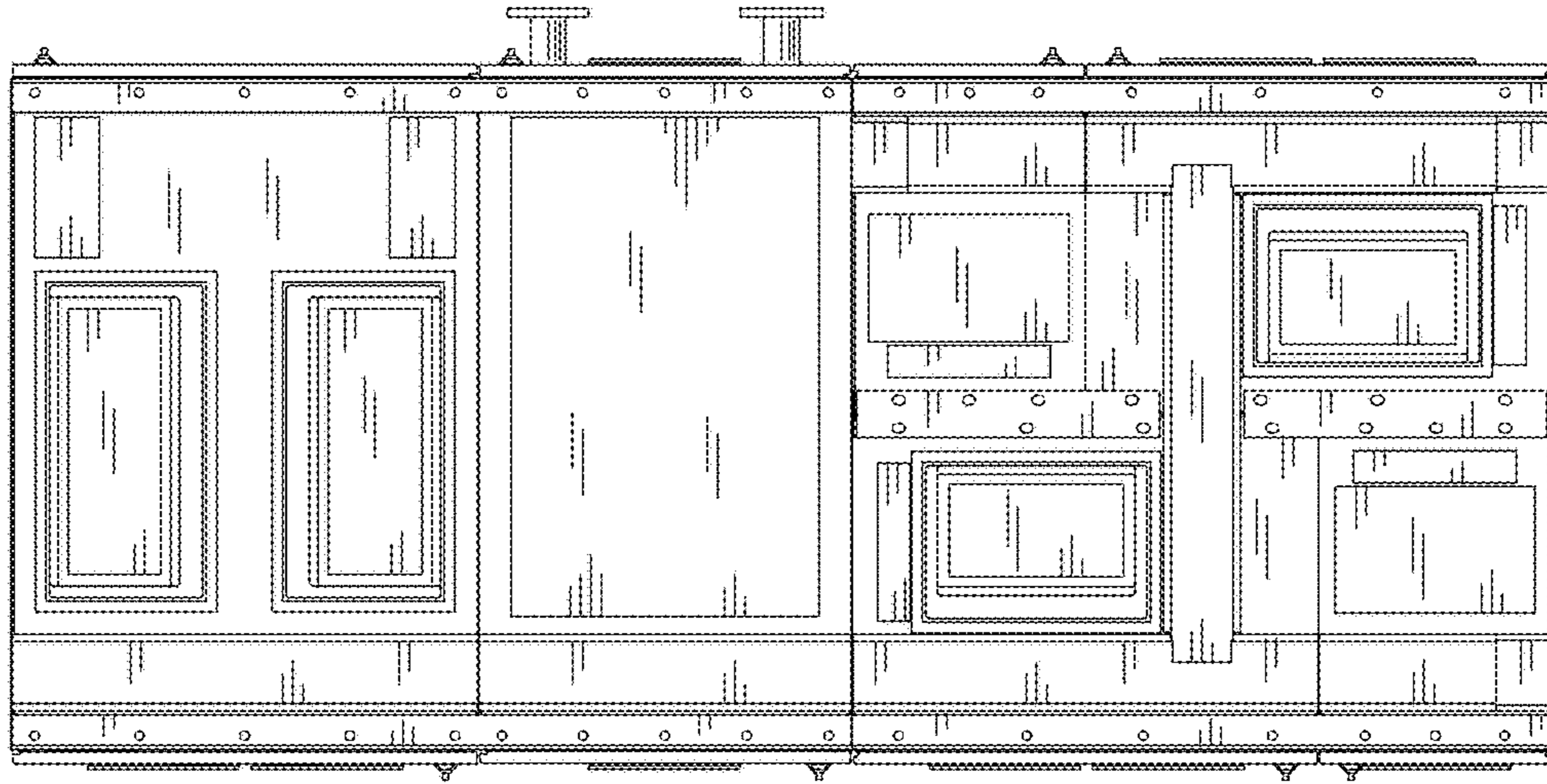
