(57) **CLAIM**

The ornamental design for an engaging member for tool changer, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an engaging member for tool changer showing our new design;
 FIG. 2 is front elevation view thereof;
 FIG. 3 is a rear elevation view thereof;
 FIG. 4 is a top plan view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is a right side elevation view thereof, to which the left side elevation view is a mirror image; and,
 FIG. 7 is a cross-sectional view thereof taken along line 7-7 in FIG. 2.

The broken lines in the drawings illustrate portions of the engaging member for tool changer that form no part of the claimed design.

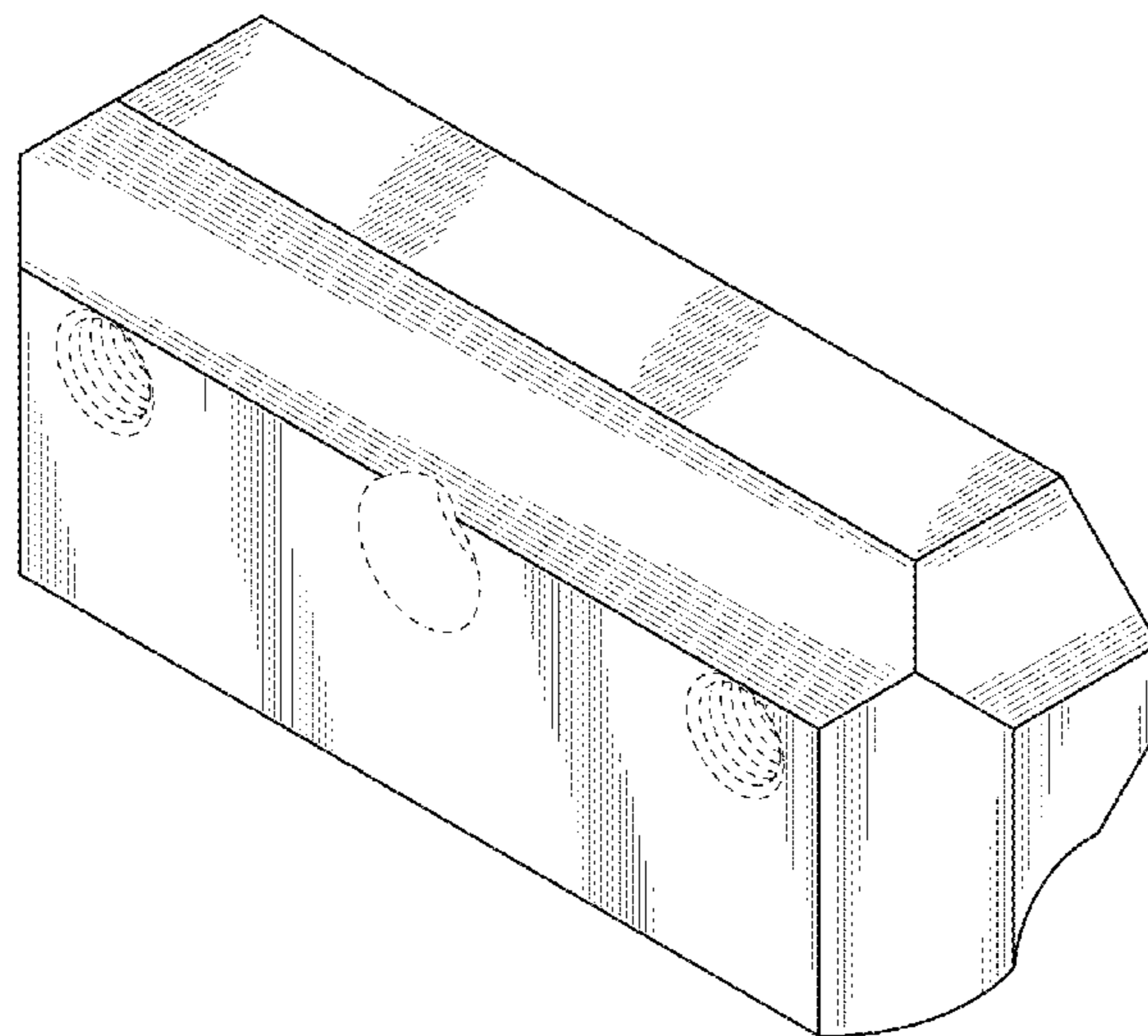

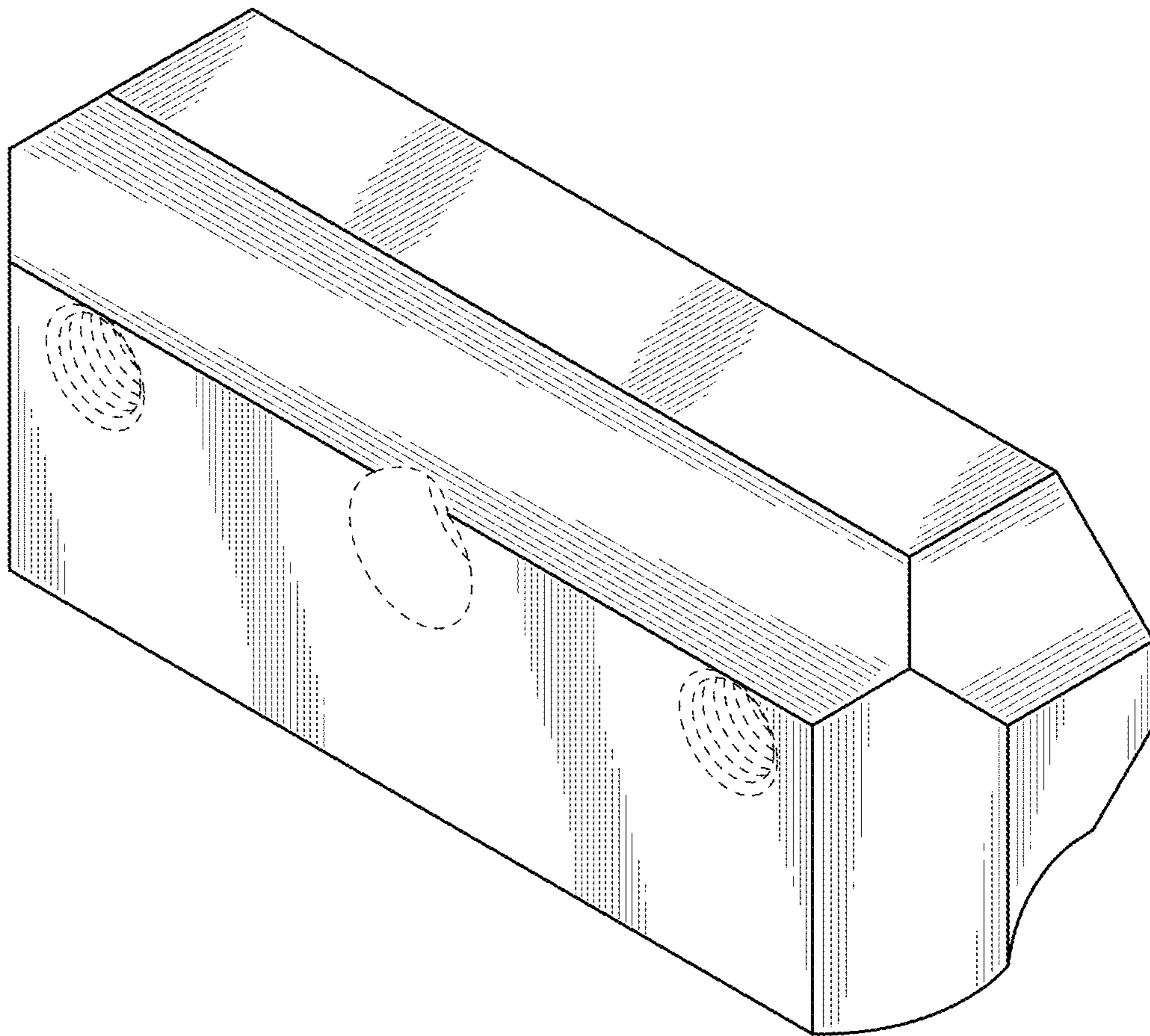

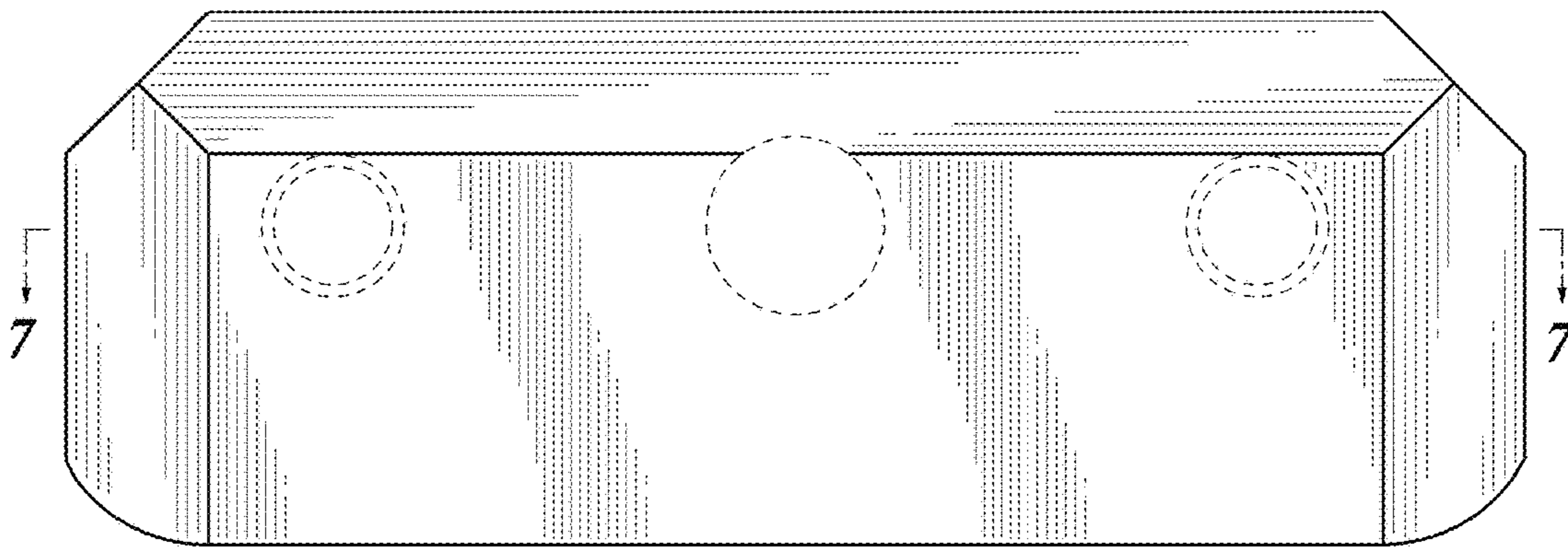

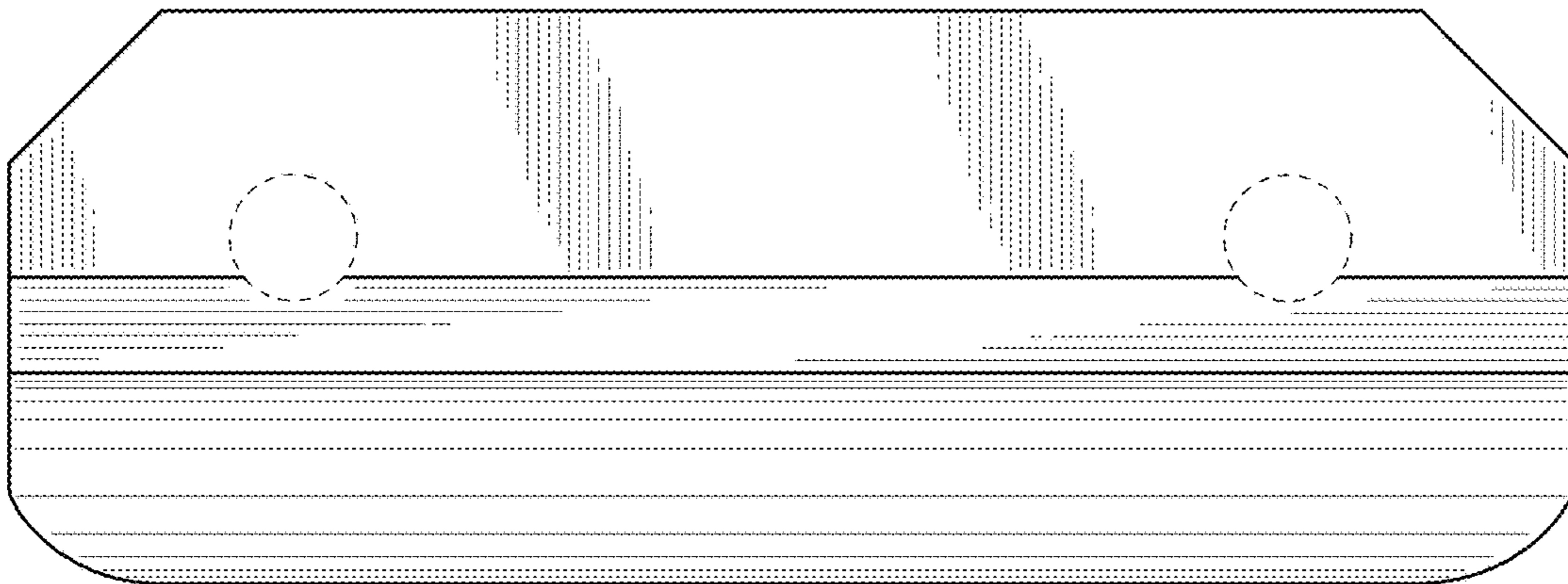

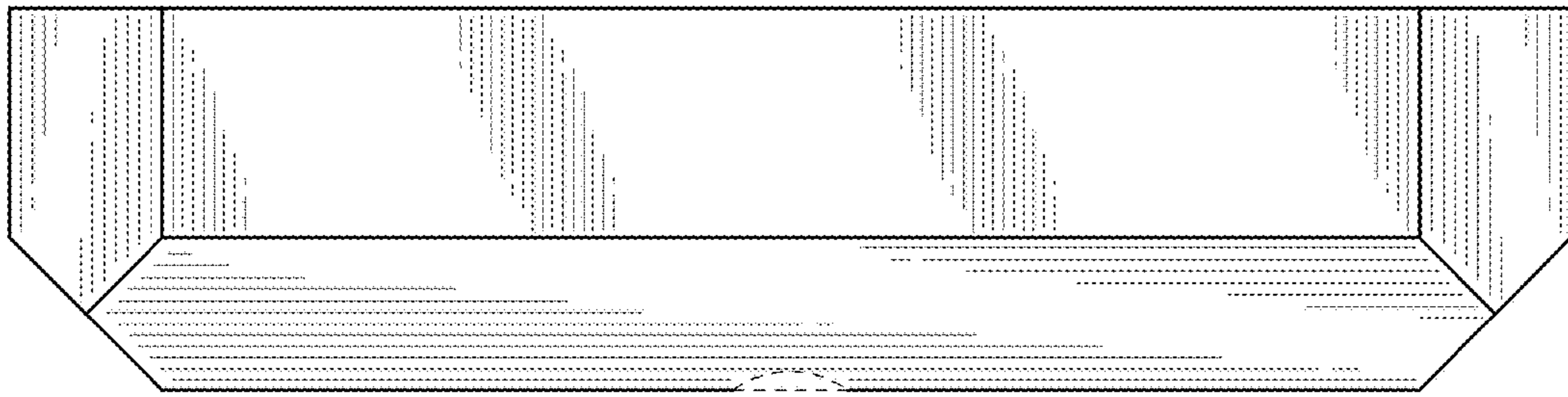

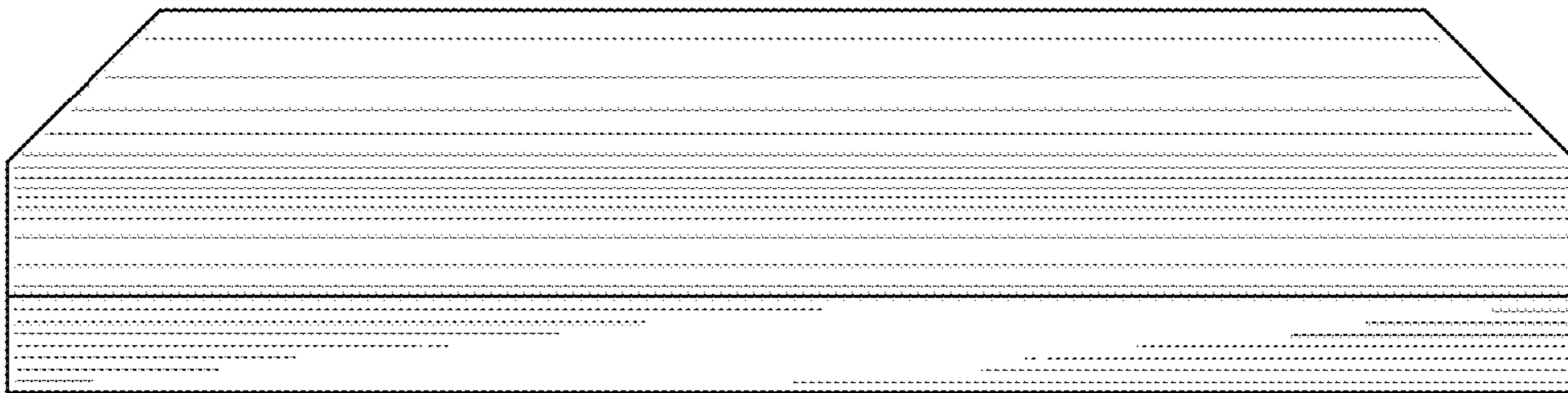

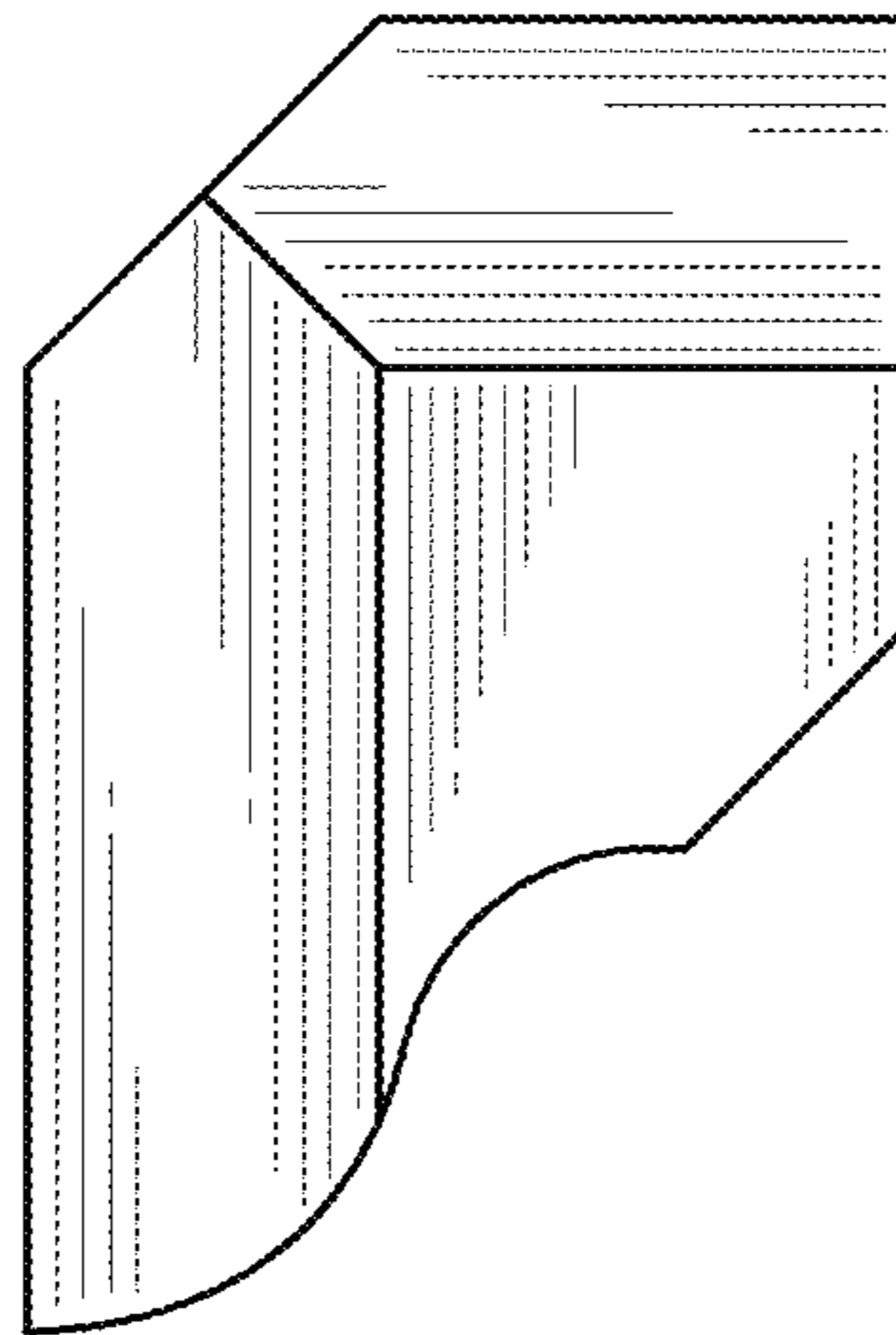
