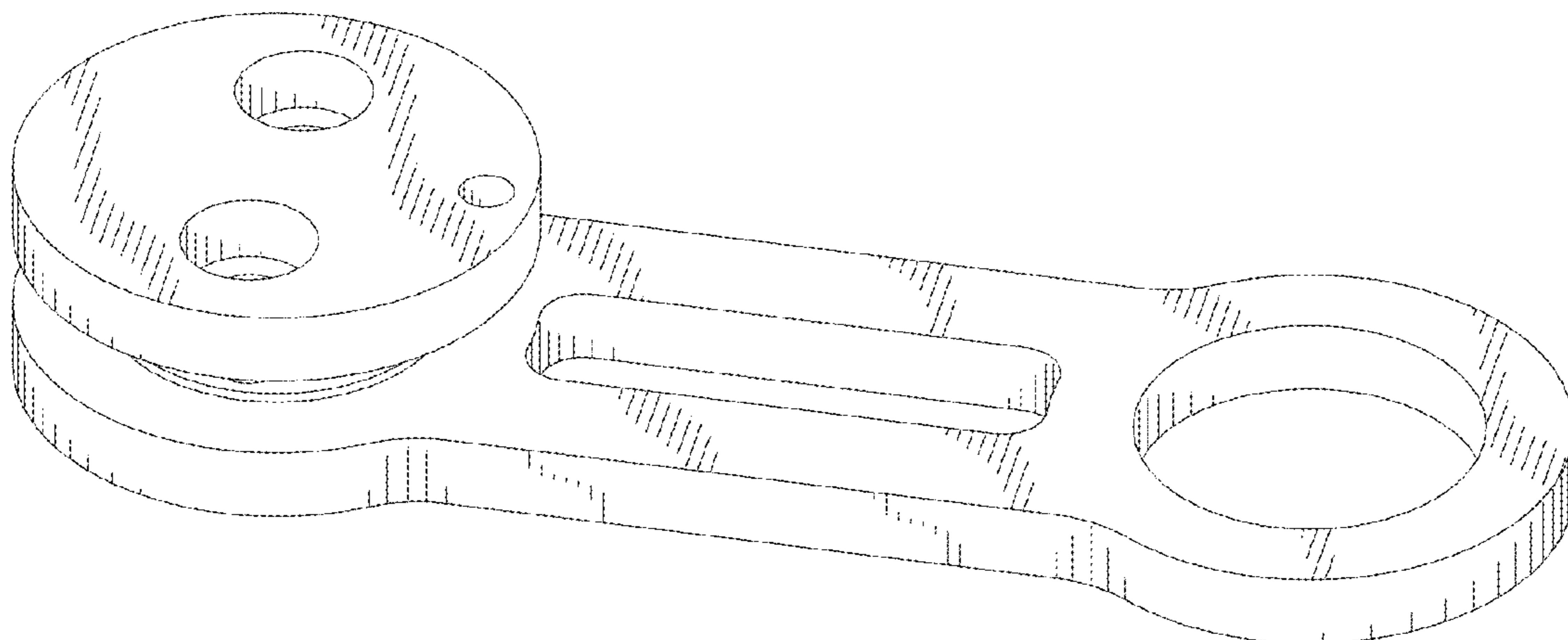
(57) **CLAIM**

The ornamental design for a positionable end effector link, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a positionable end effector link;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a right side elevation view thereof, the left side elevation view being a mirror image thereof;
 FIG. 4 is a front elevation view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is a rear elevation view thereof; and,
 FIG. 7 is a perspective view of the positionable end effector link, shown in use.
 The broken lines showing the other positionable end effector links and attached plate in FIG. 7 depicts environmental subject matter that forms no part of the claimed design.

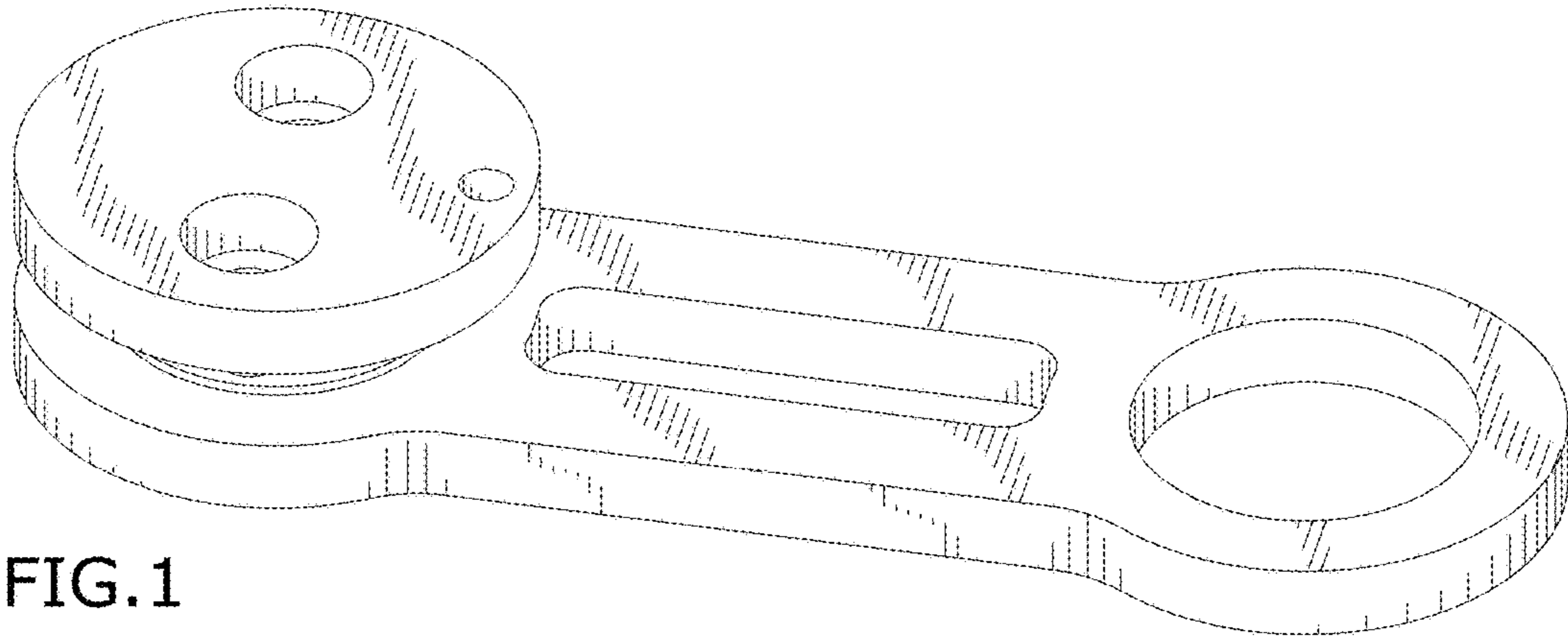

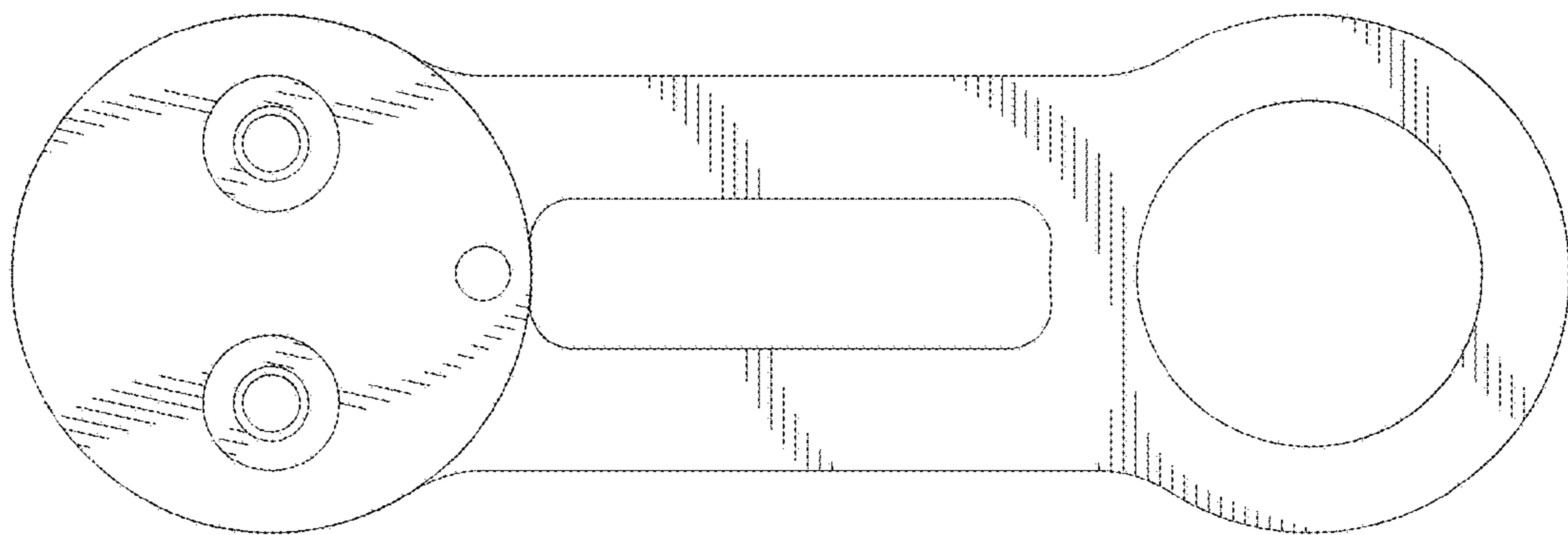

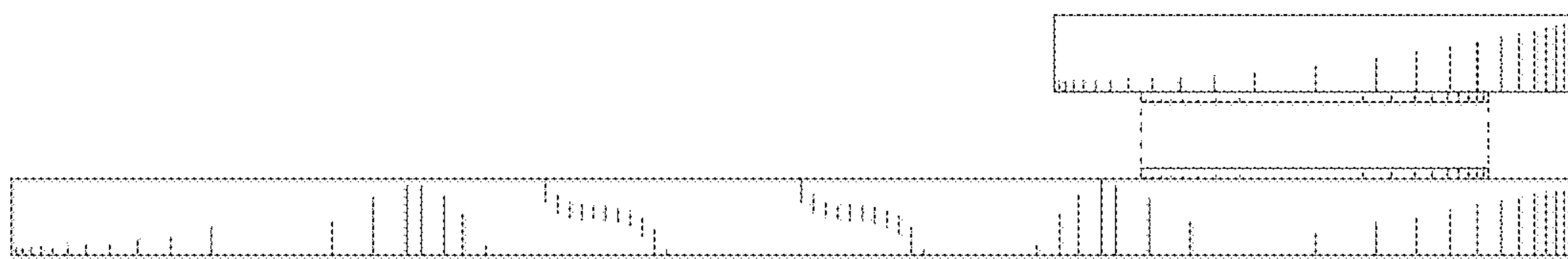

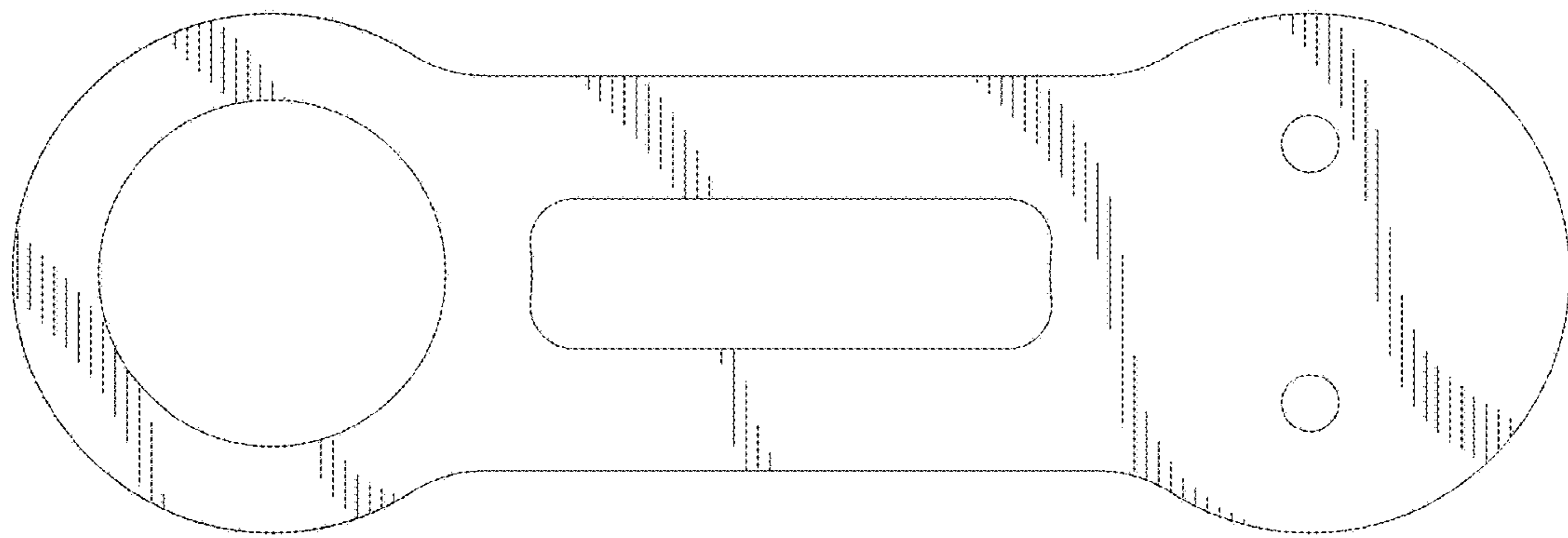
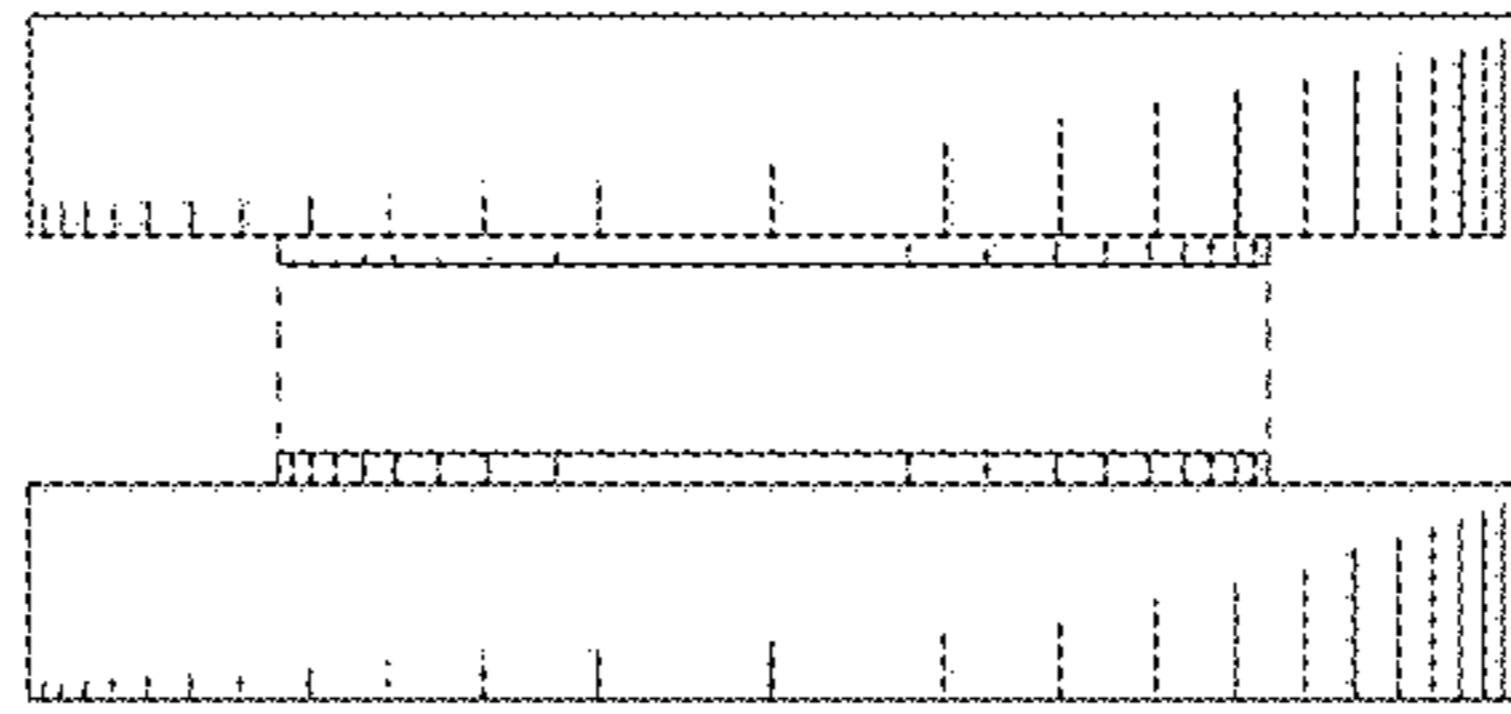
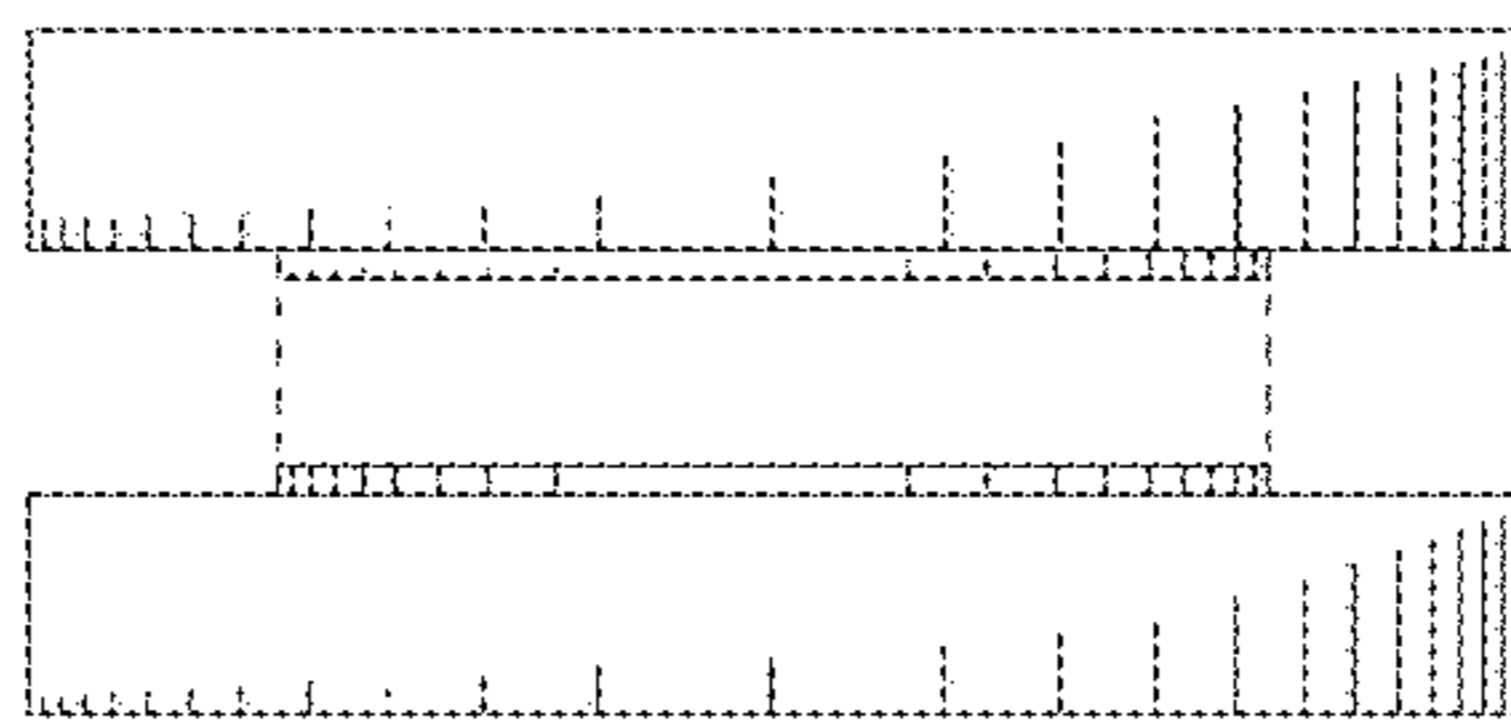

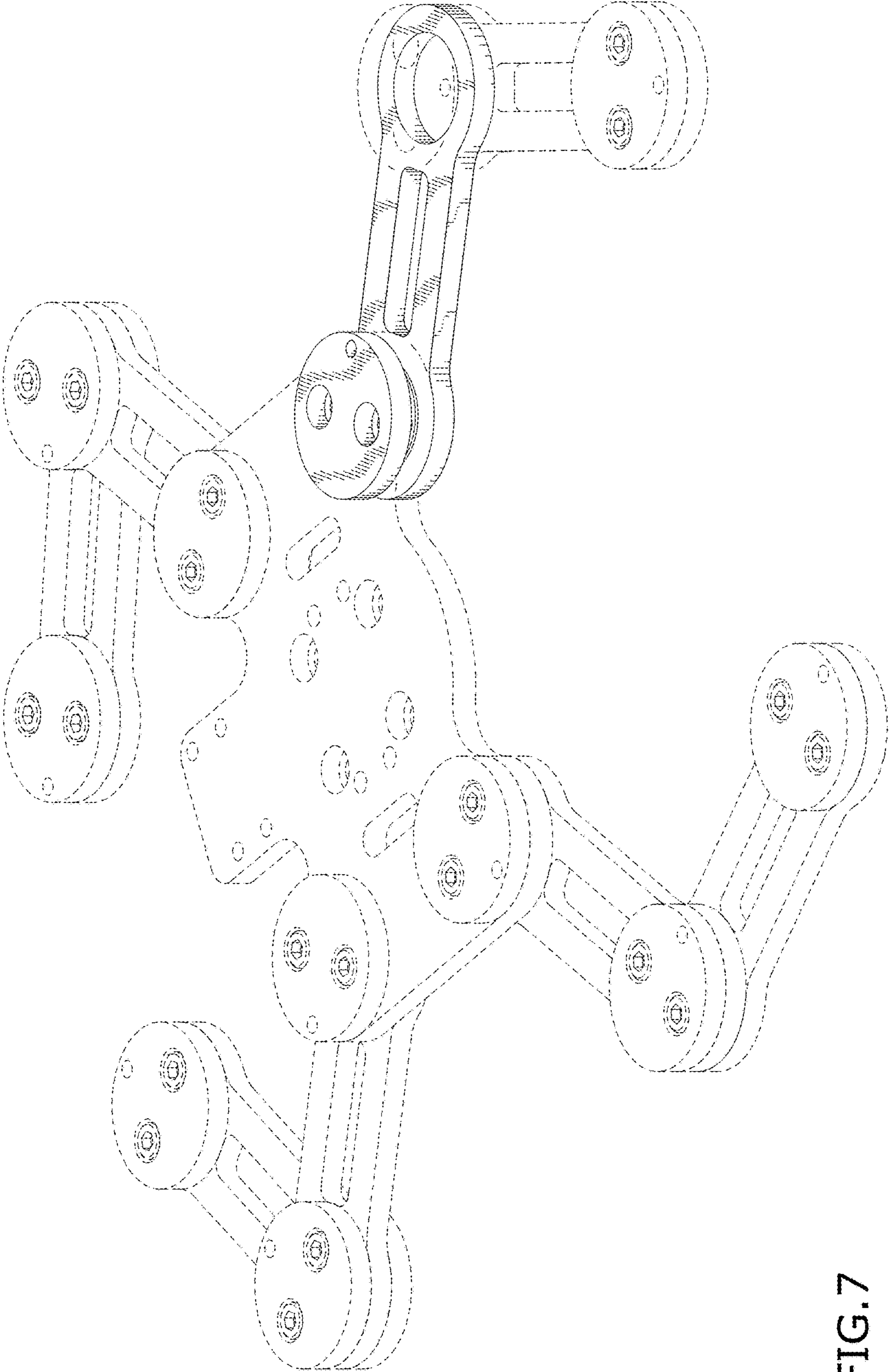
