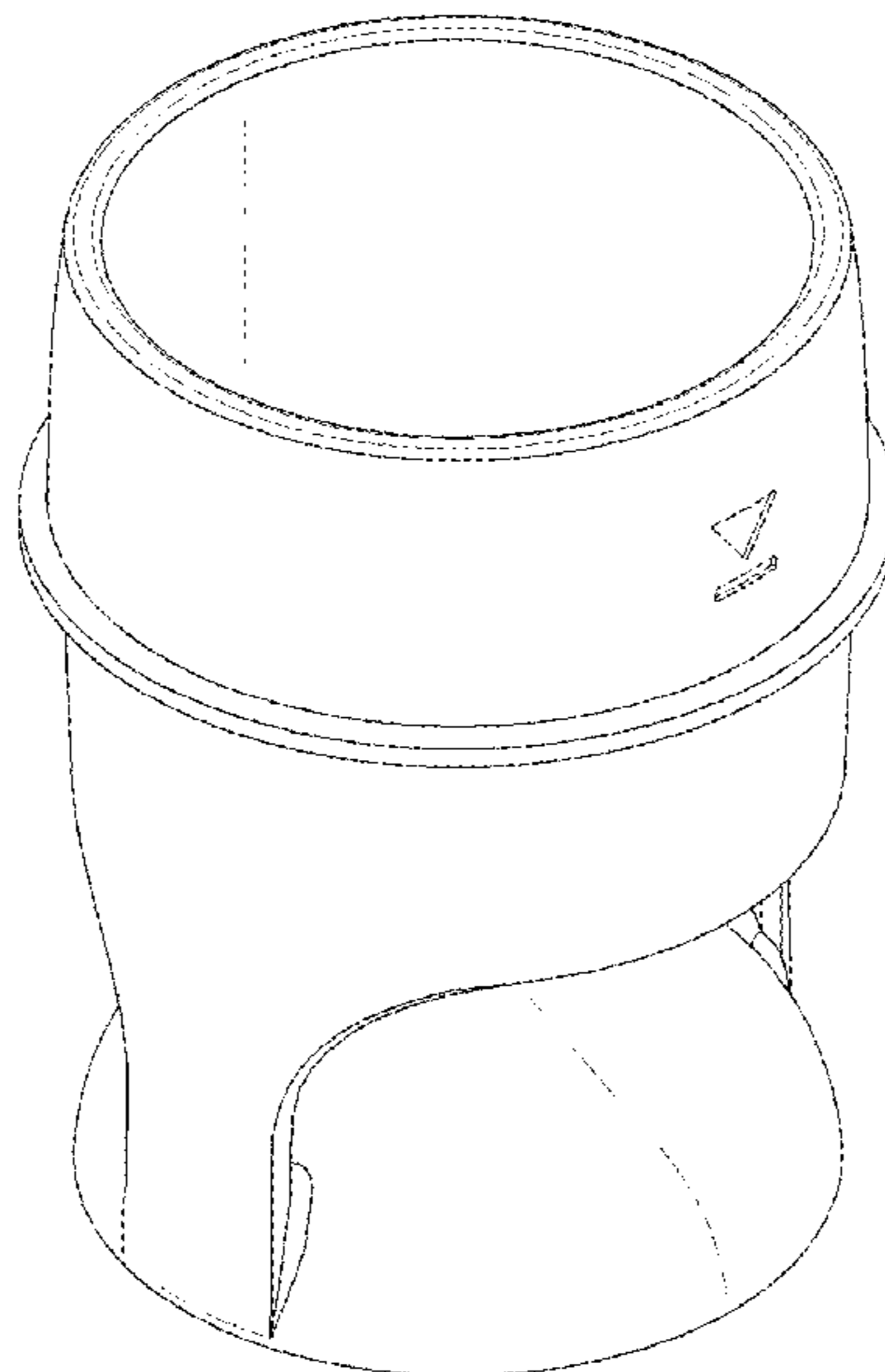
(57) **CLAIM**

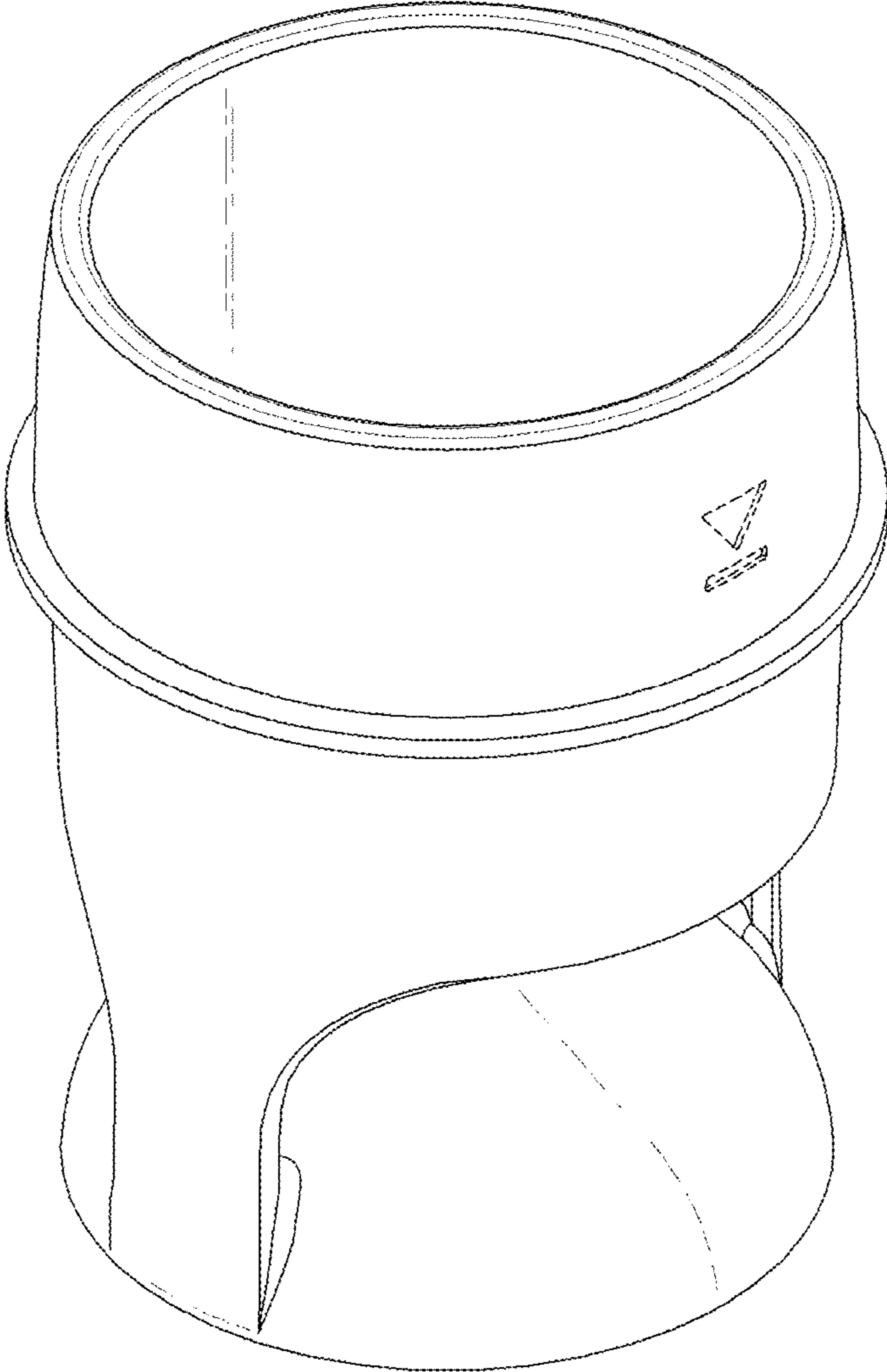
We claim the ornamental design for a cap for humidifier, as shown and described.

**DESCRIPTION**

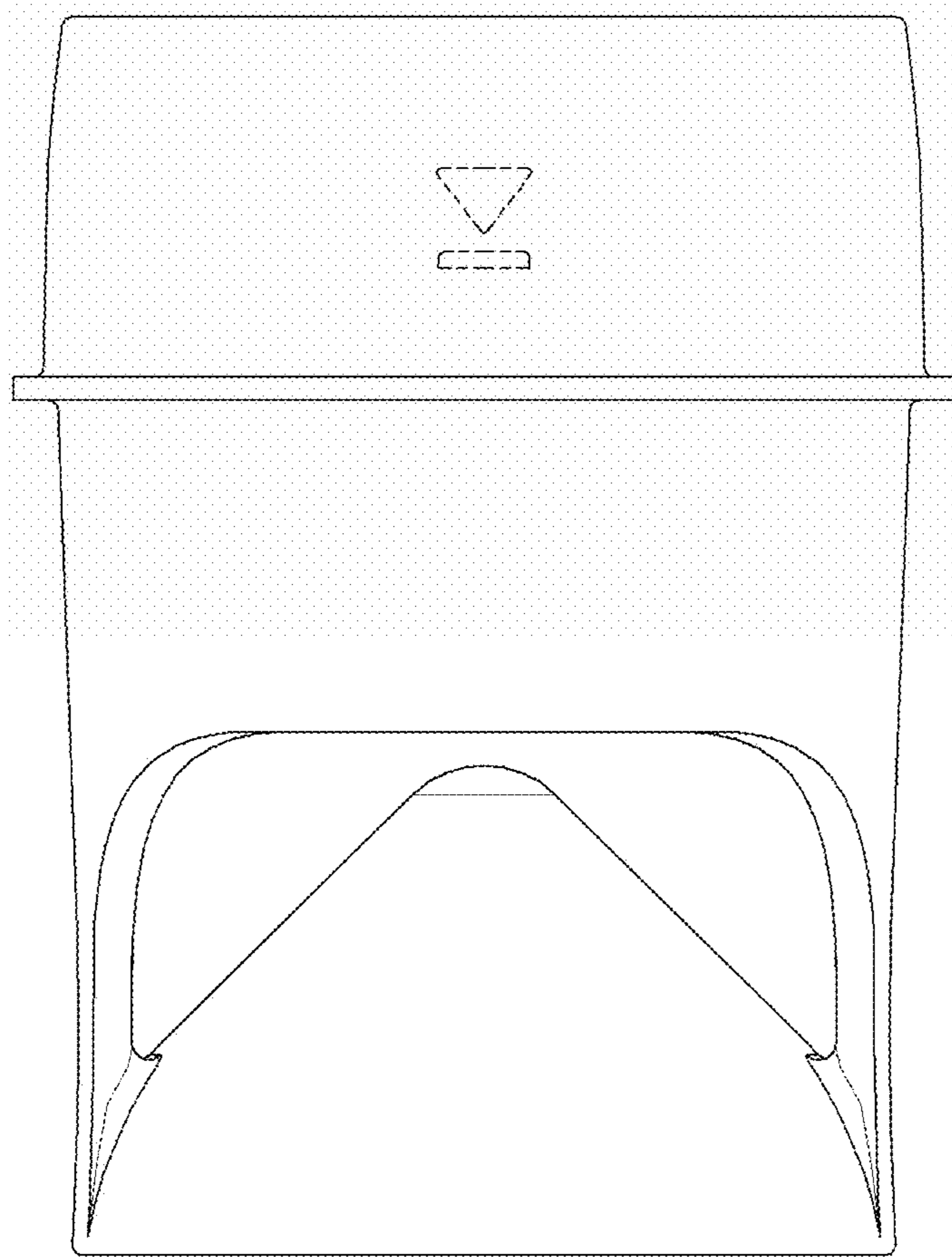
FIG. 1 is a perspective view of a cap for humidifier according to our new design;

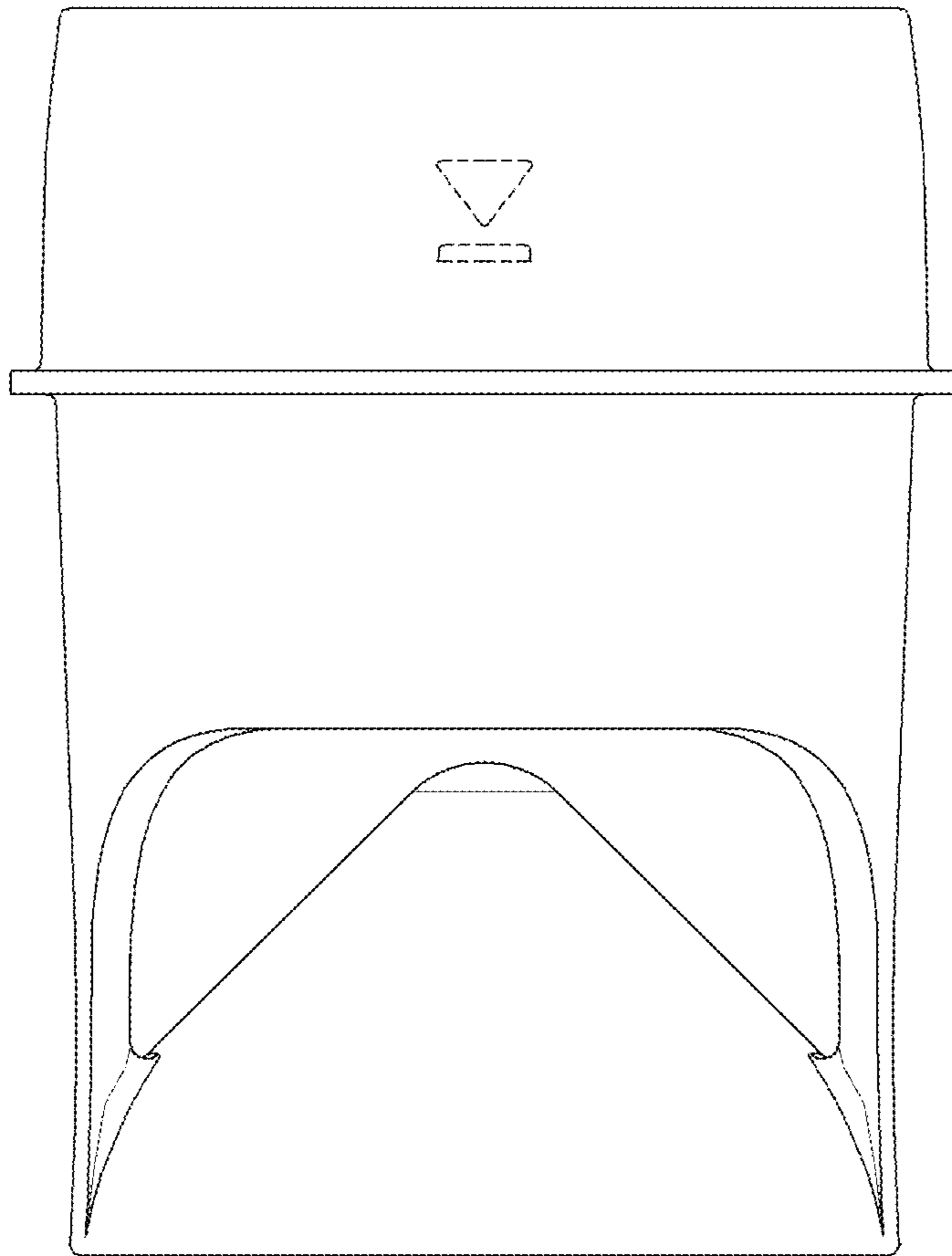

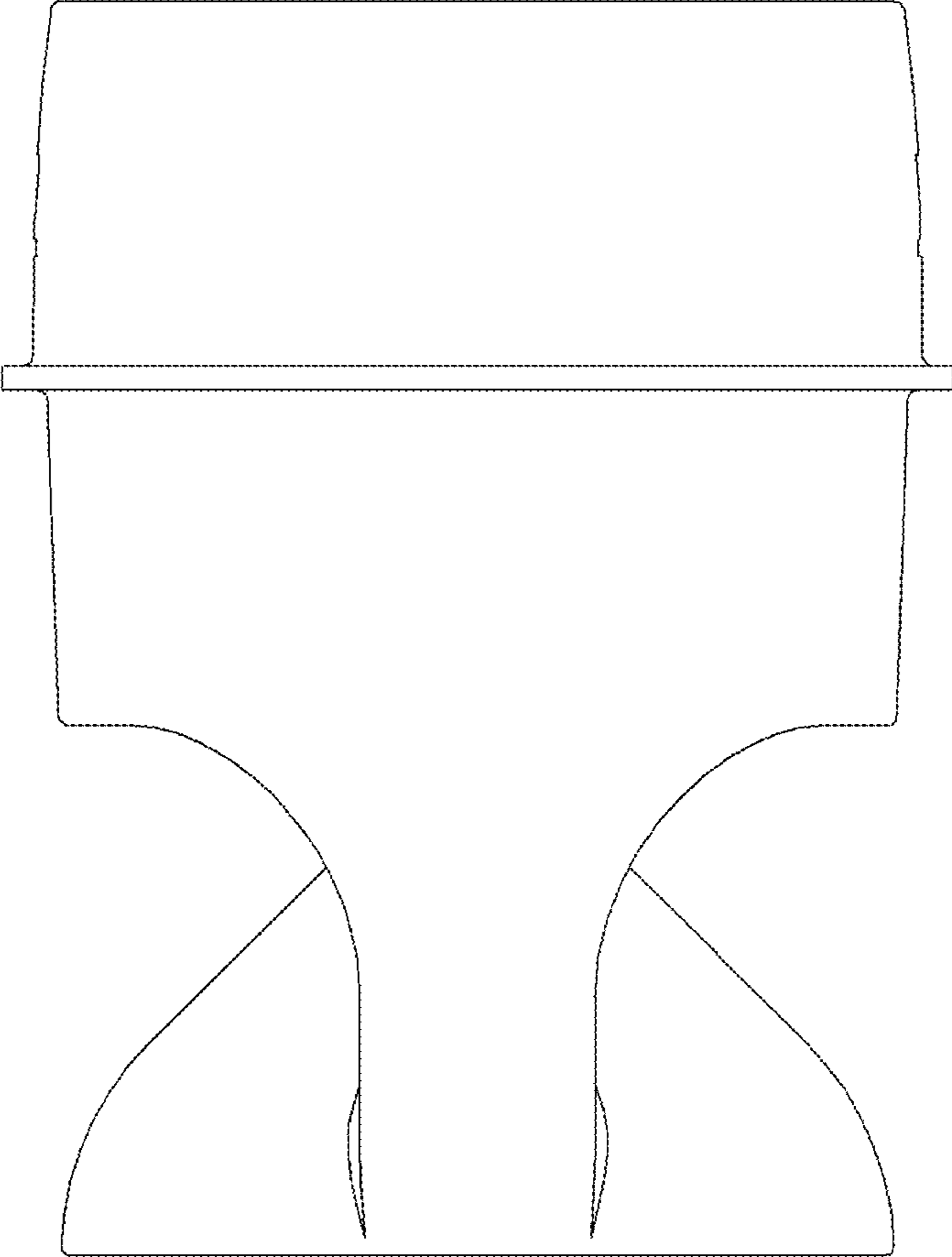

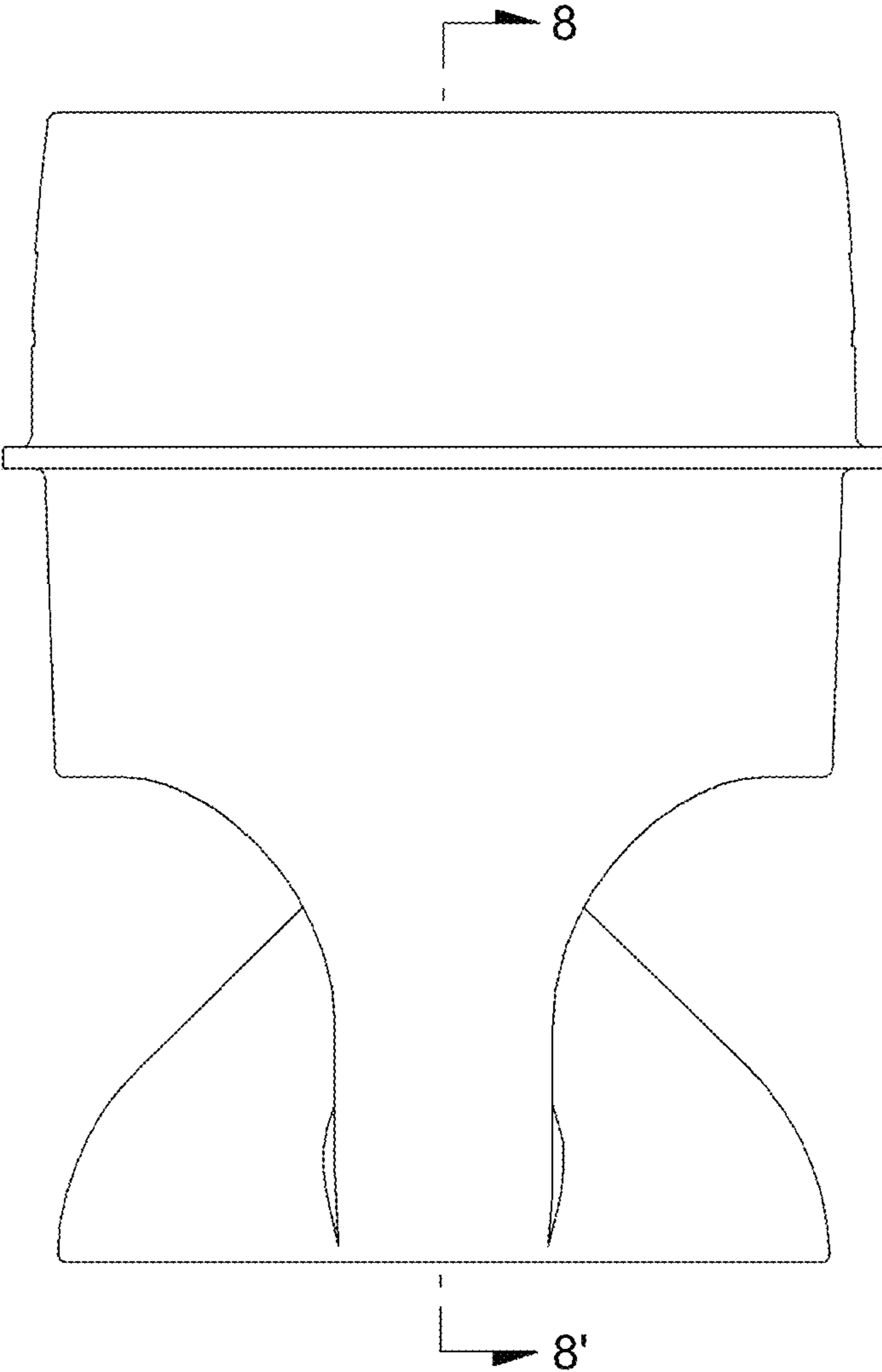
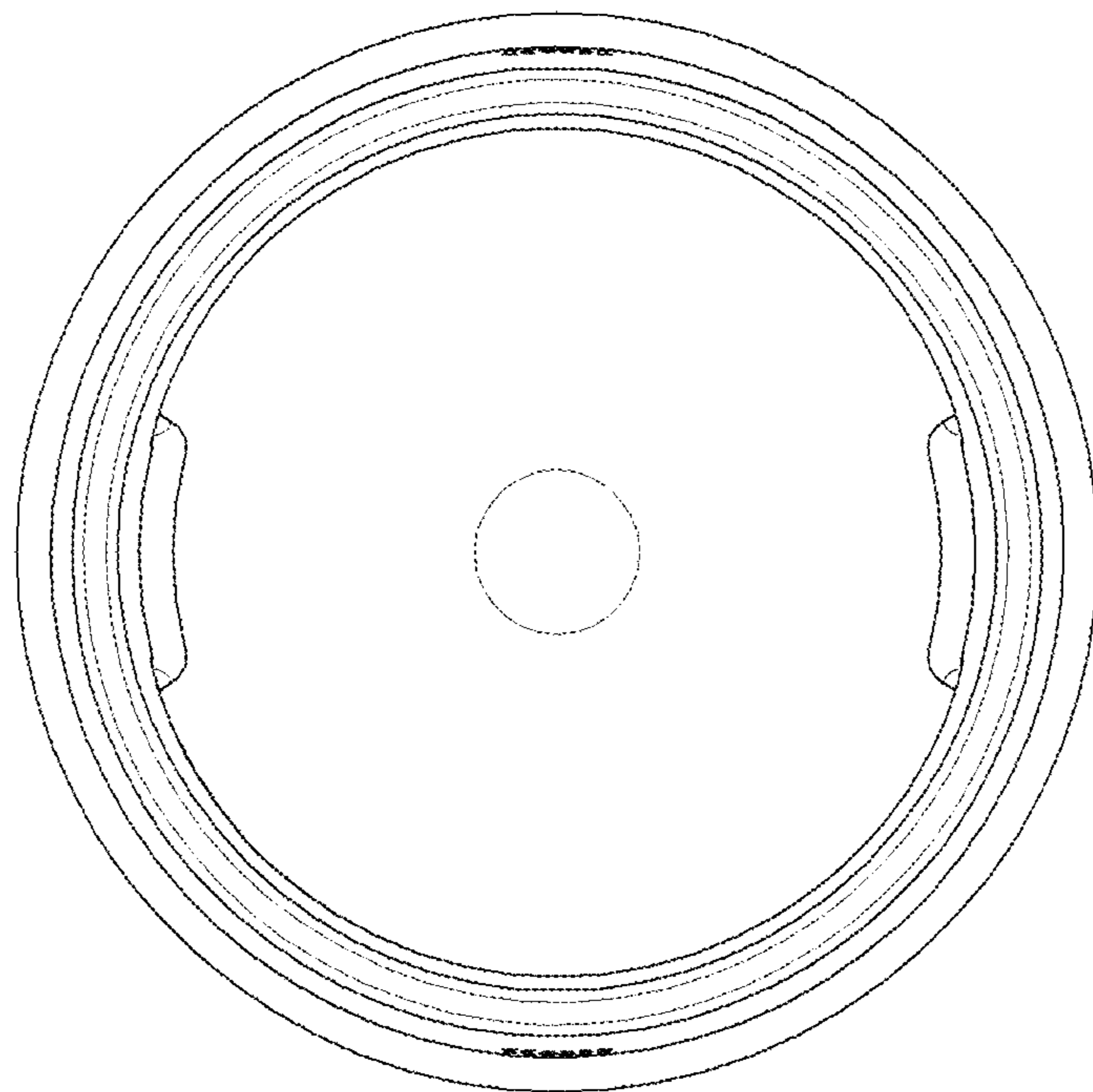
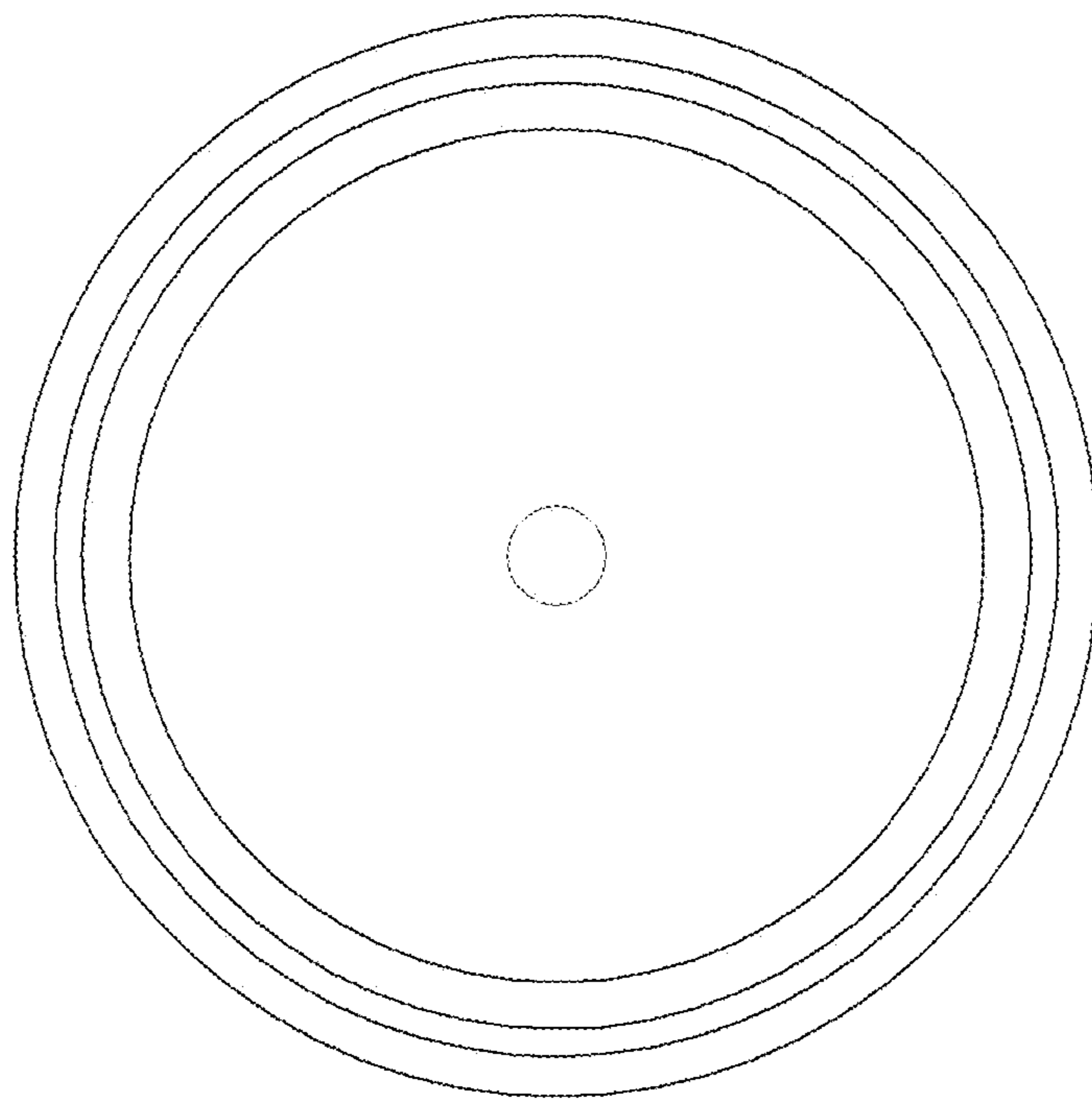

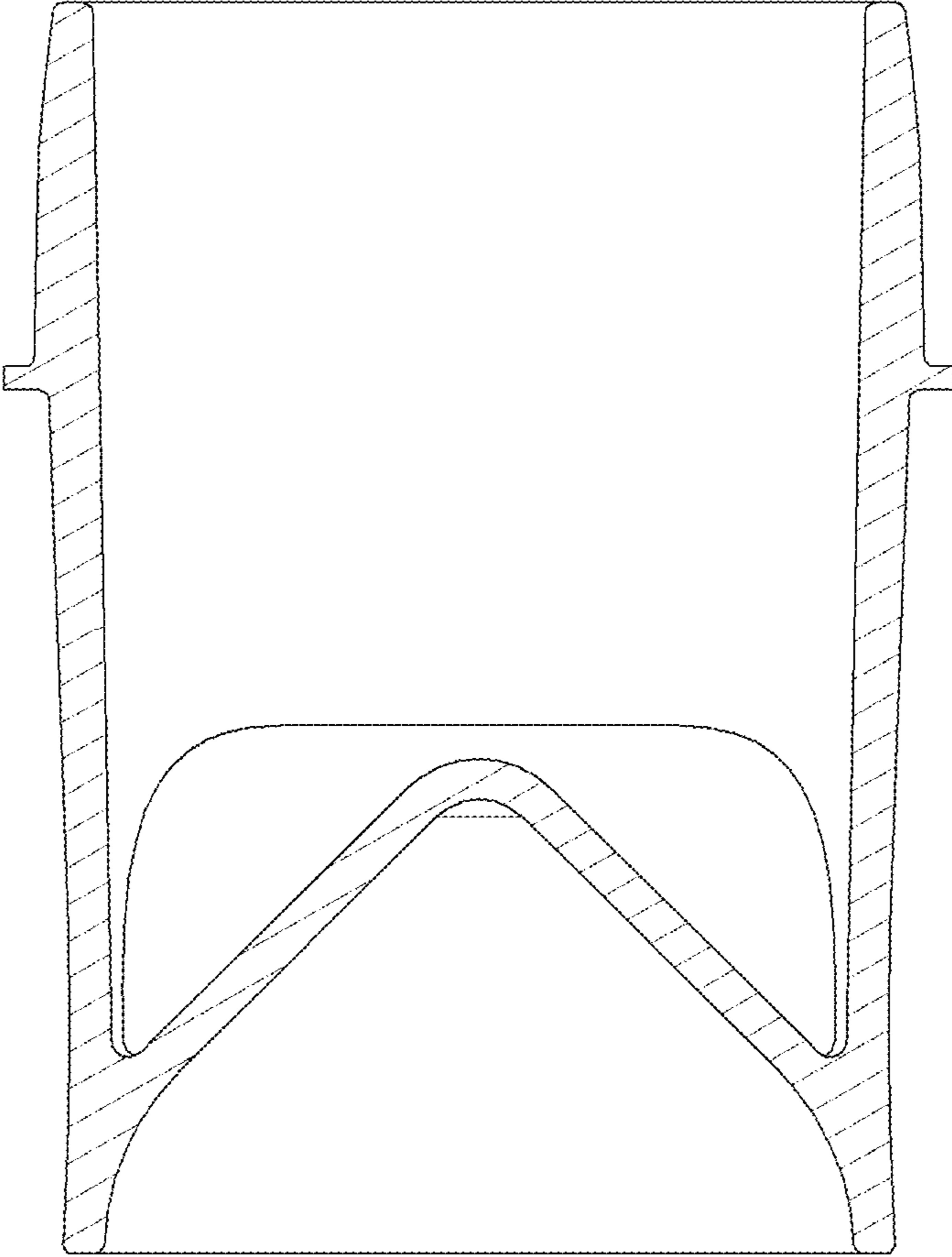
