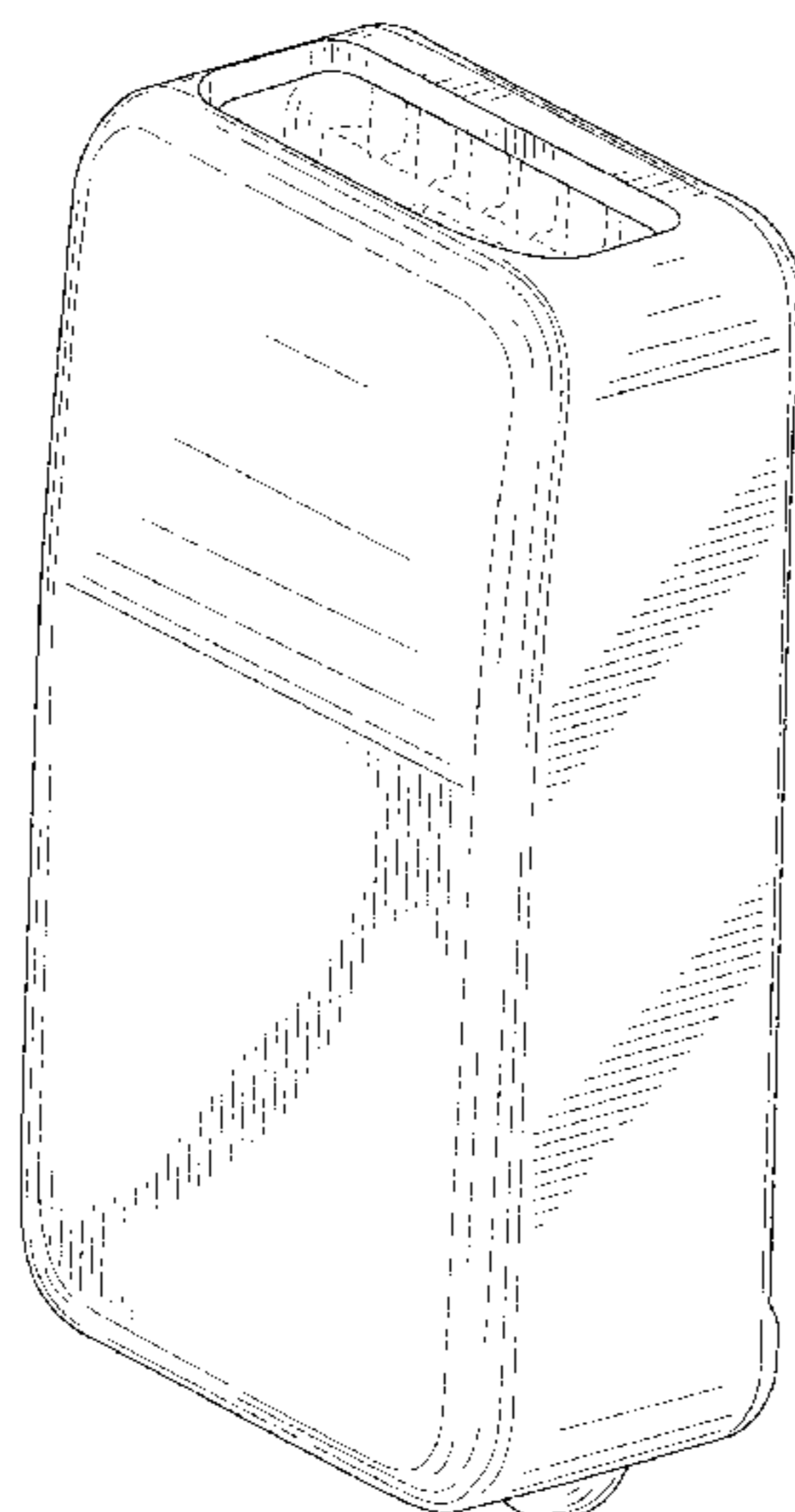
(57) **CLAIM**

The ornamental design for a medical device case, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear perspective view of a medical device case embodying the design of the present invention;  
 FIG. 2 is an enlarged partial top/front perspective view of the medical device case illustrated in FIG. 1;  
 FIG. 3 is a rear view of the medical device case illustrated in FIG. 1;  
 FIG. 4 is a front view of the medical device case illustrated in FIG. 1;  
 FIG. 5 is a left side view of the medical device case illustrated in FIG. 1;  
 FIG. 6 is a right side view of the medical device case illustrated in FIG. 1;  
 FIG. 7 is a top view of the medical device case illustrated in FIG. 1;  
 FIG. 8 is a bottom view of the medical device case illustrated in FIG. 1; and,  
 FIG. 9 is a front perspective view of the medical device case illustrated in FIG. 1, illustrating an exemplary medical device housed within the case.  
 The broken lines in FIG. 9 showing an exemplary medical device are for the purpose of illustrating environmental structure and form no part of the claimed design. The broken lines in FIGS. 1 and 7 represent portions of the medical device case that form no part of the claimed design.

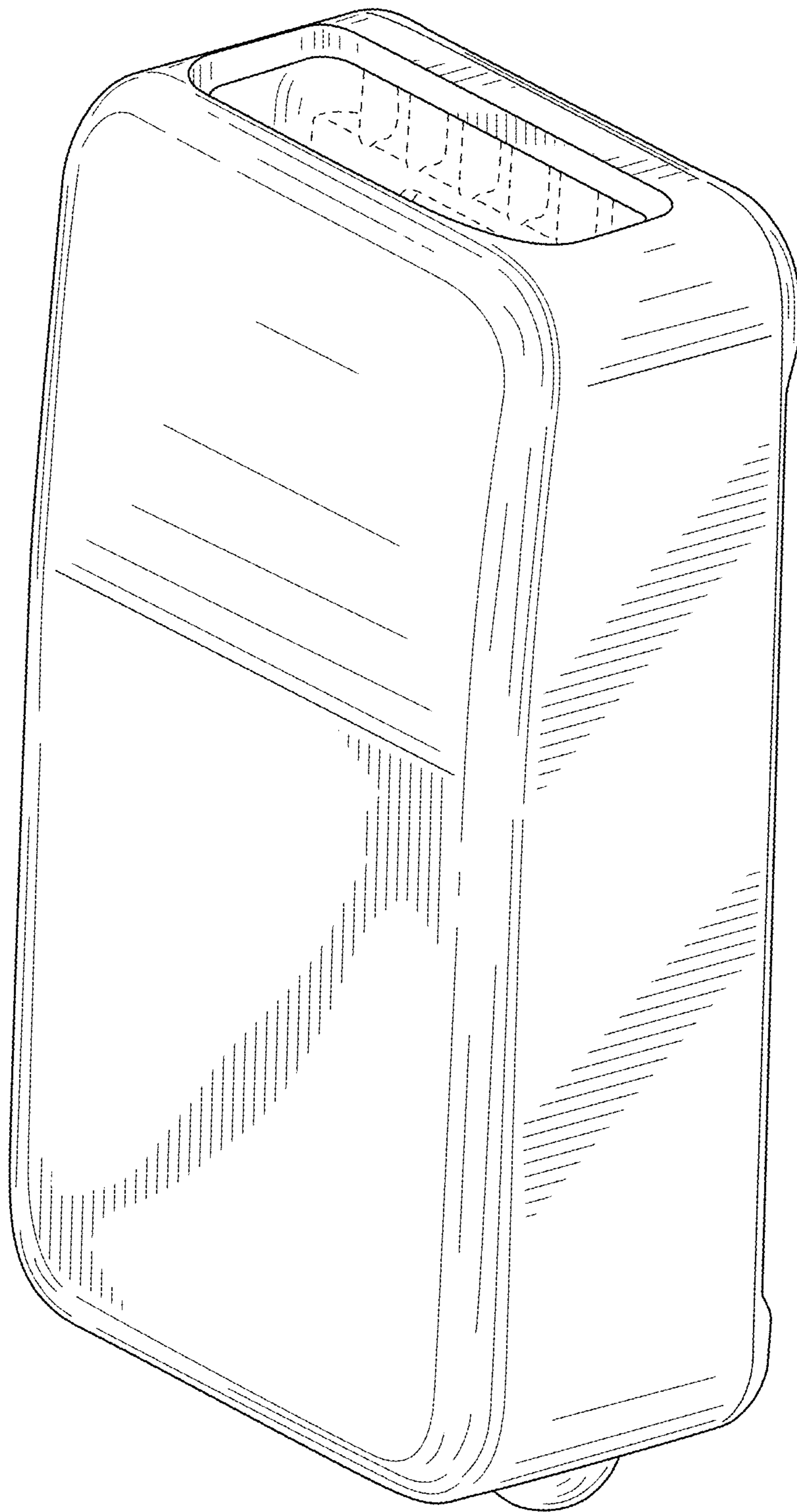

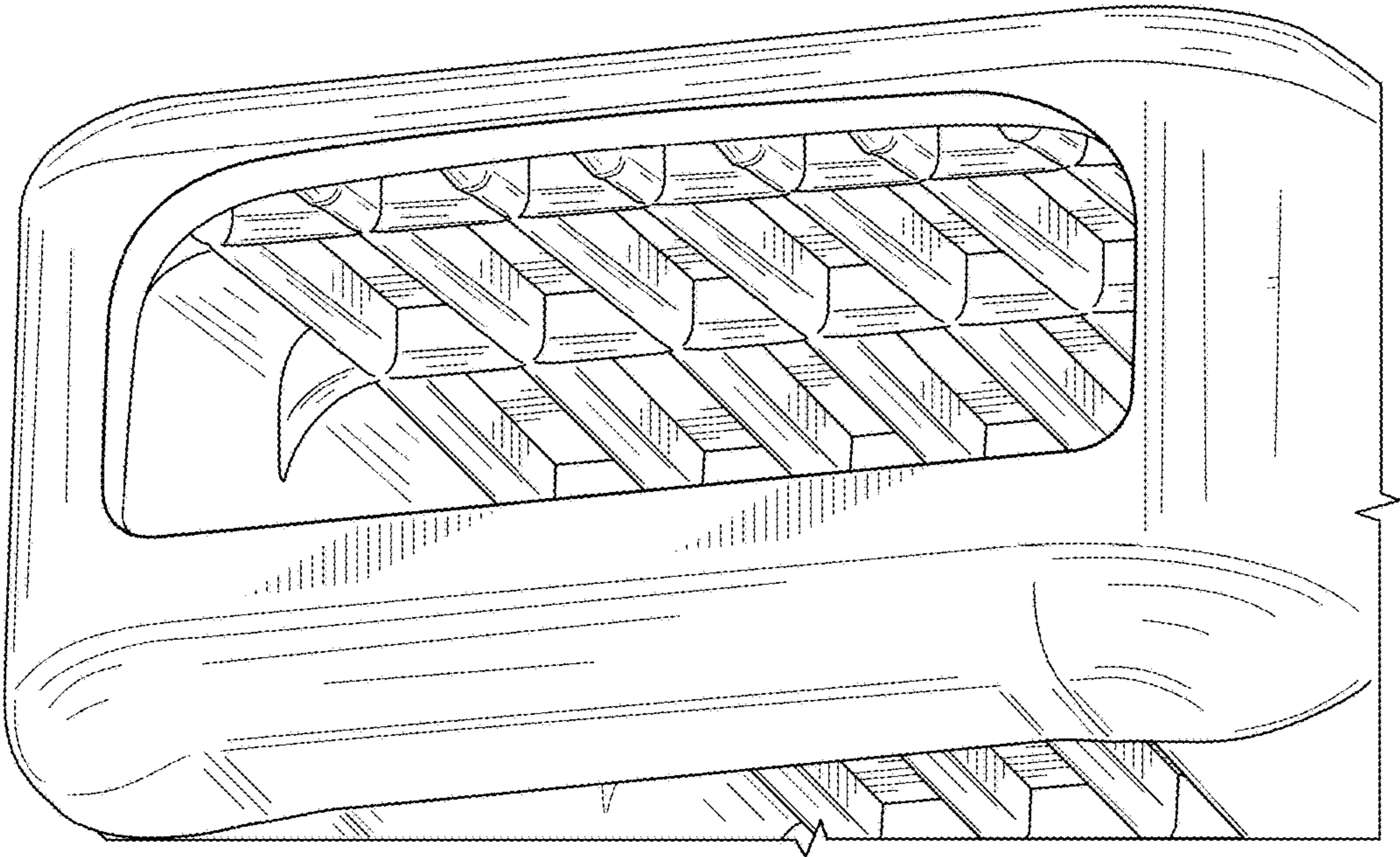
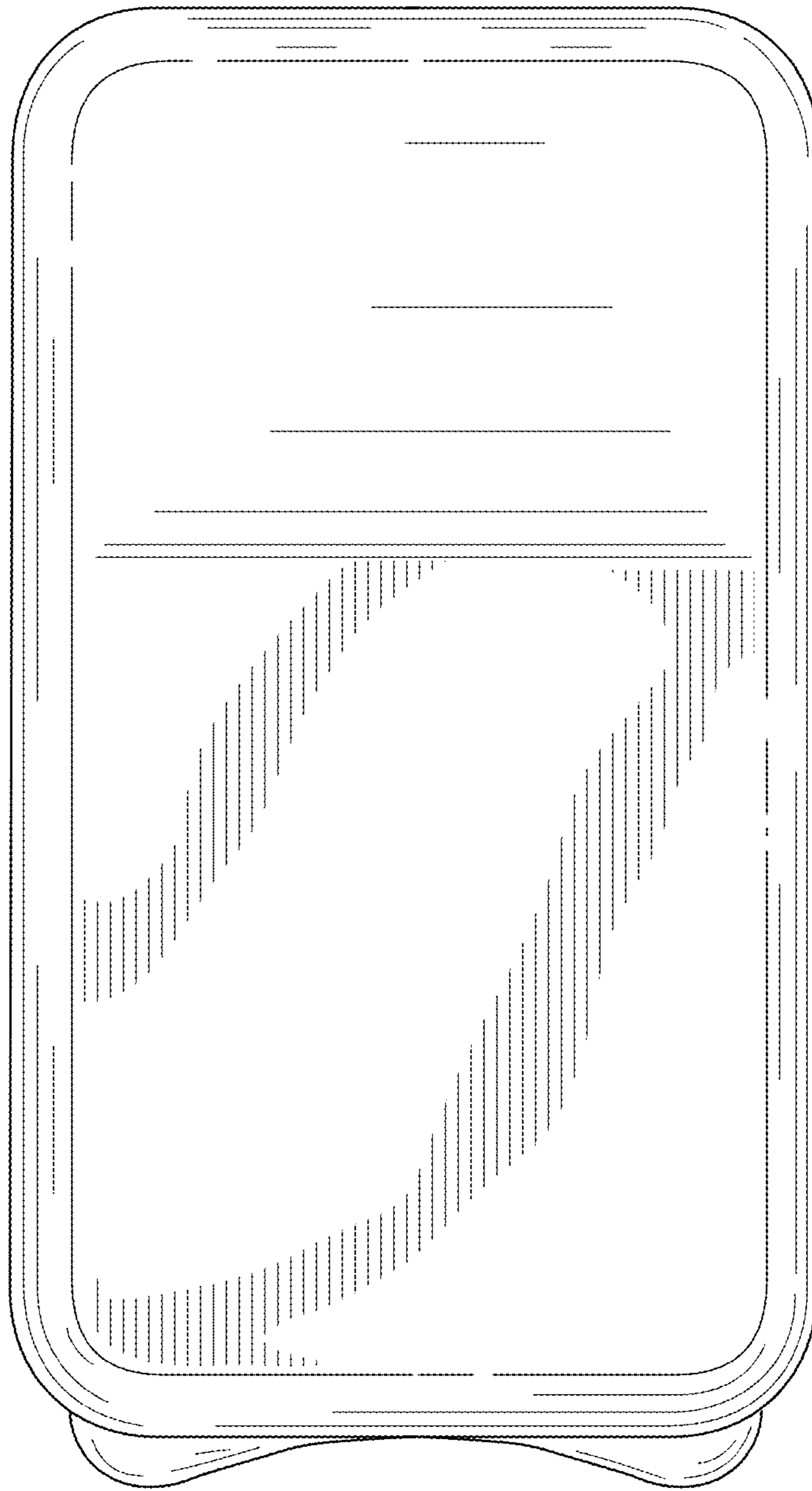
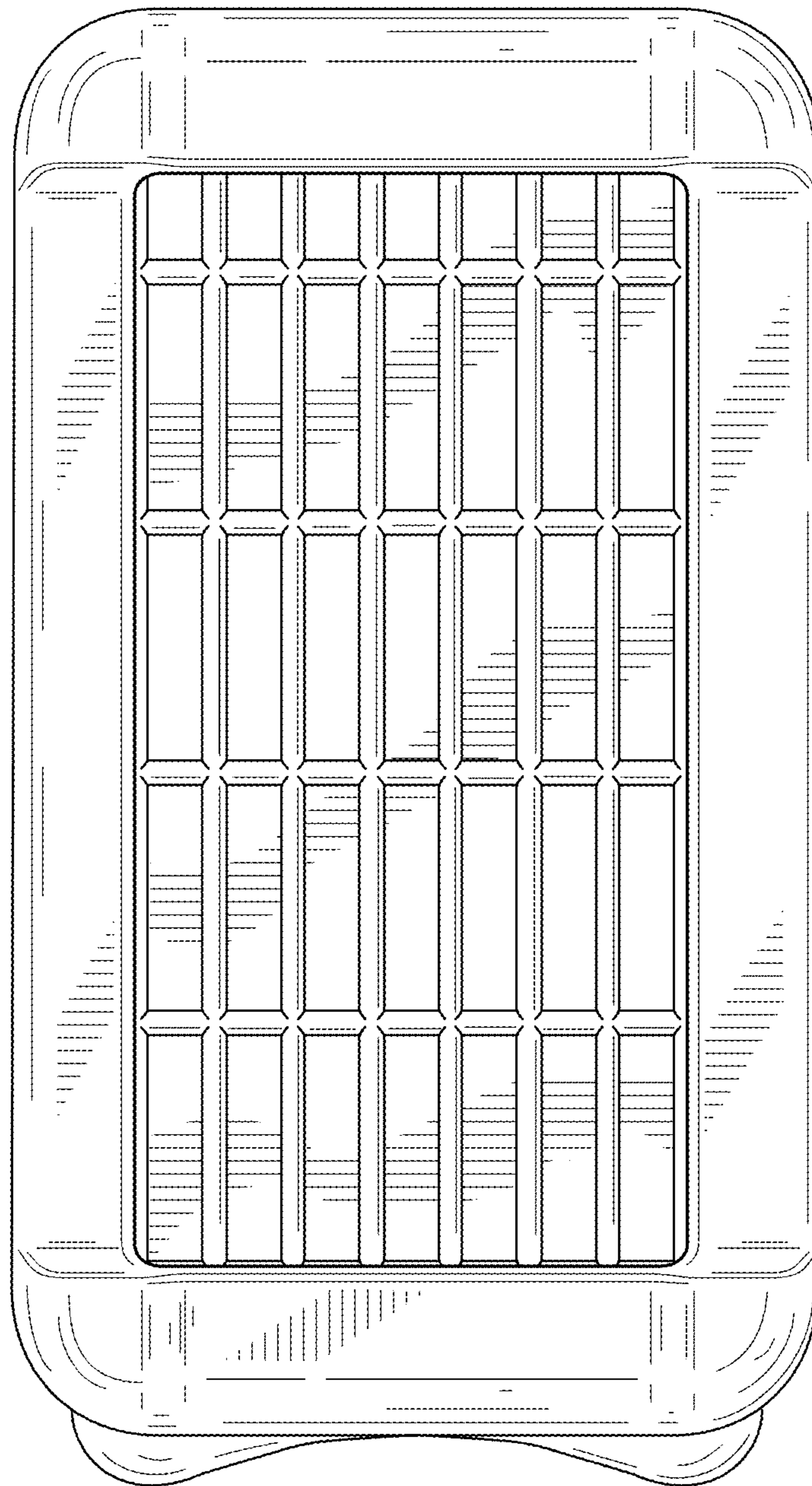

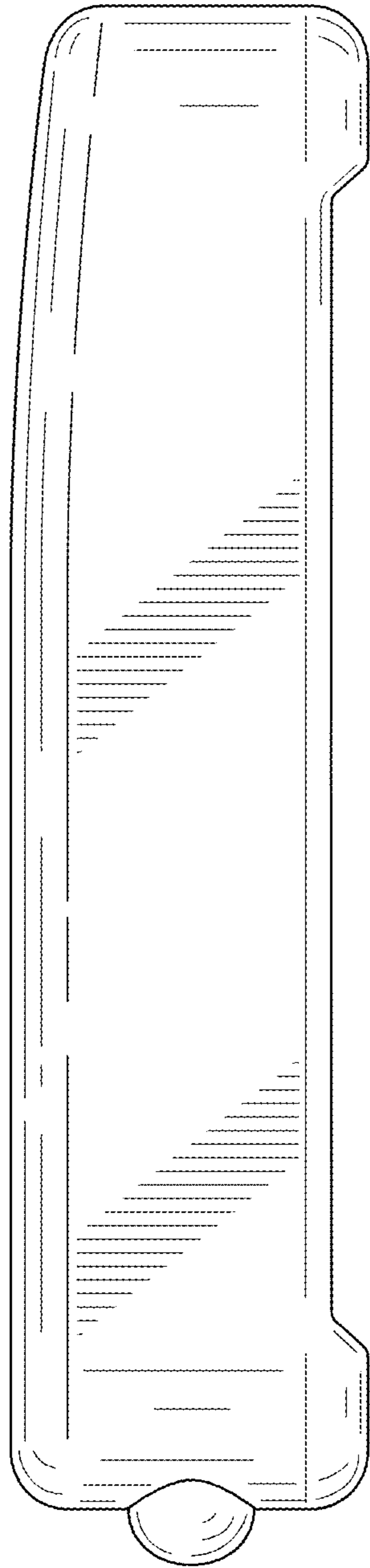




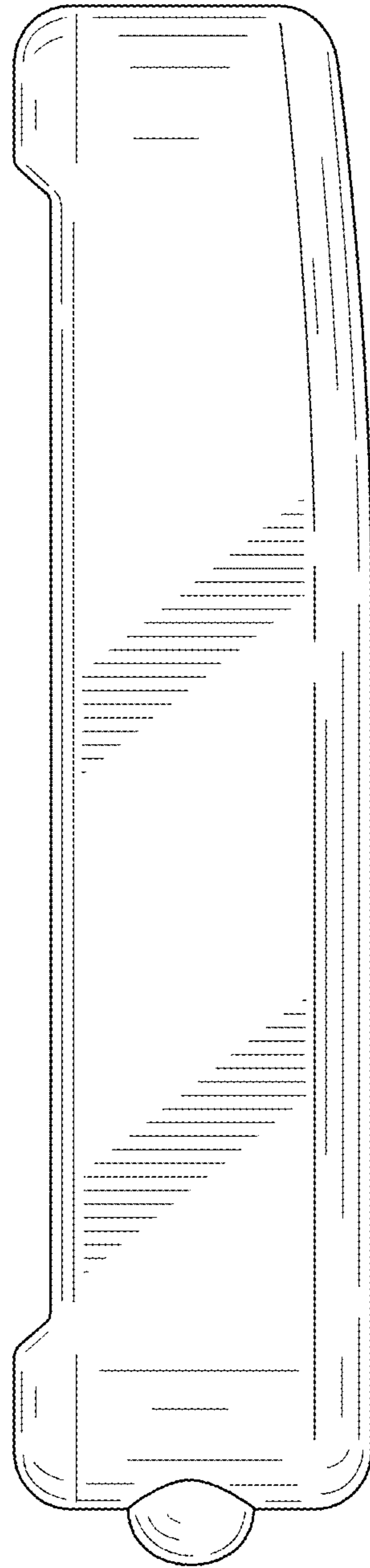

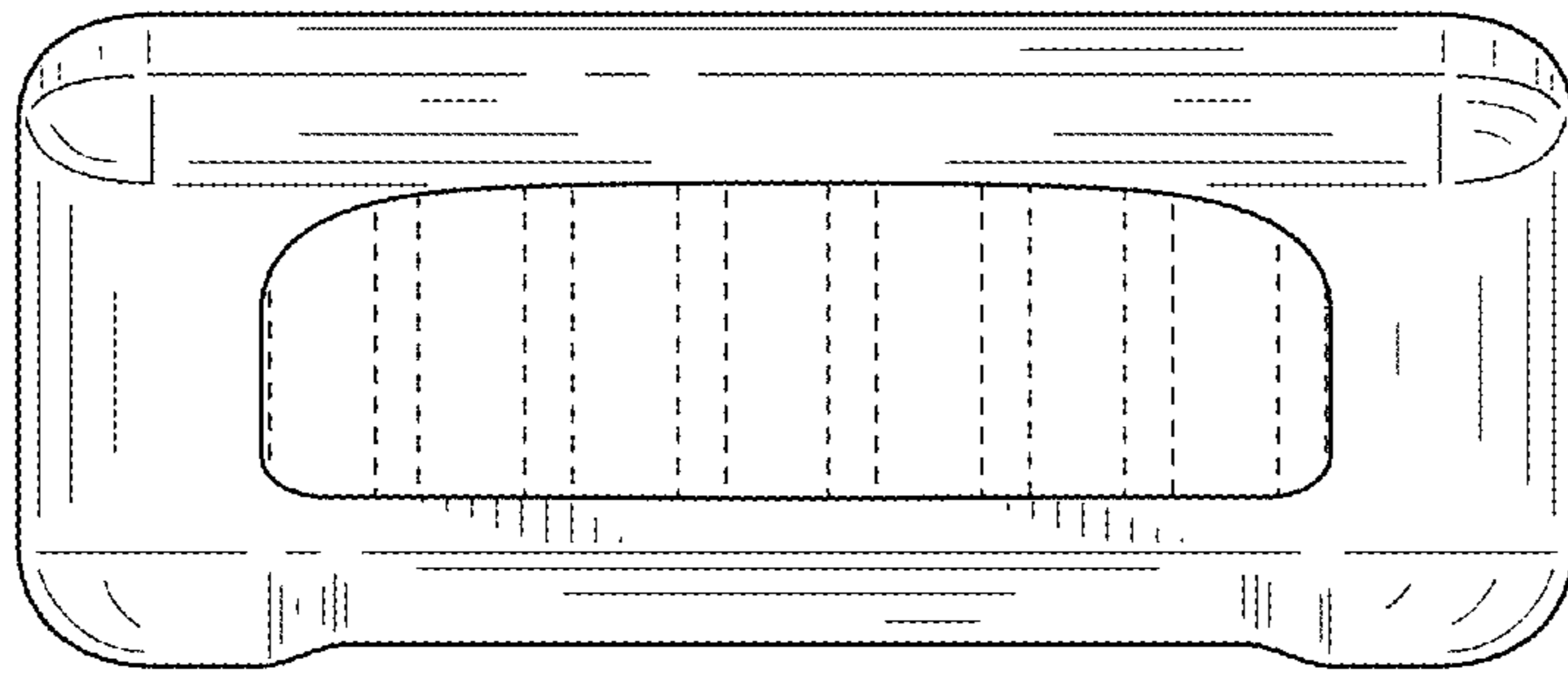

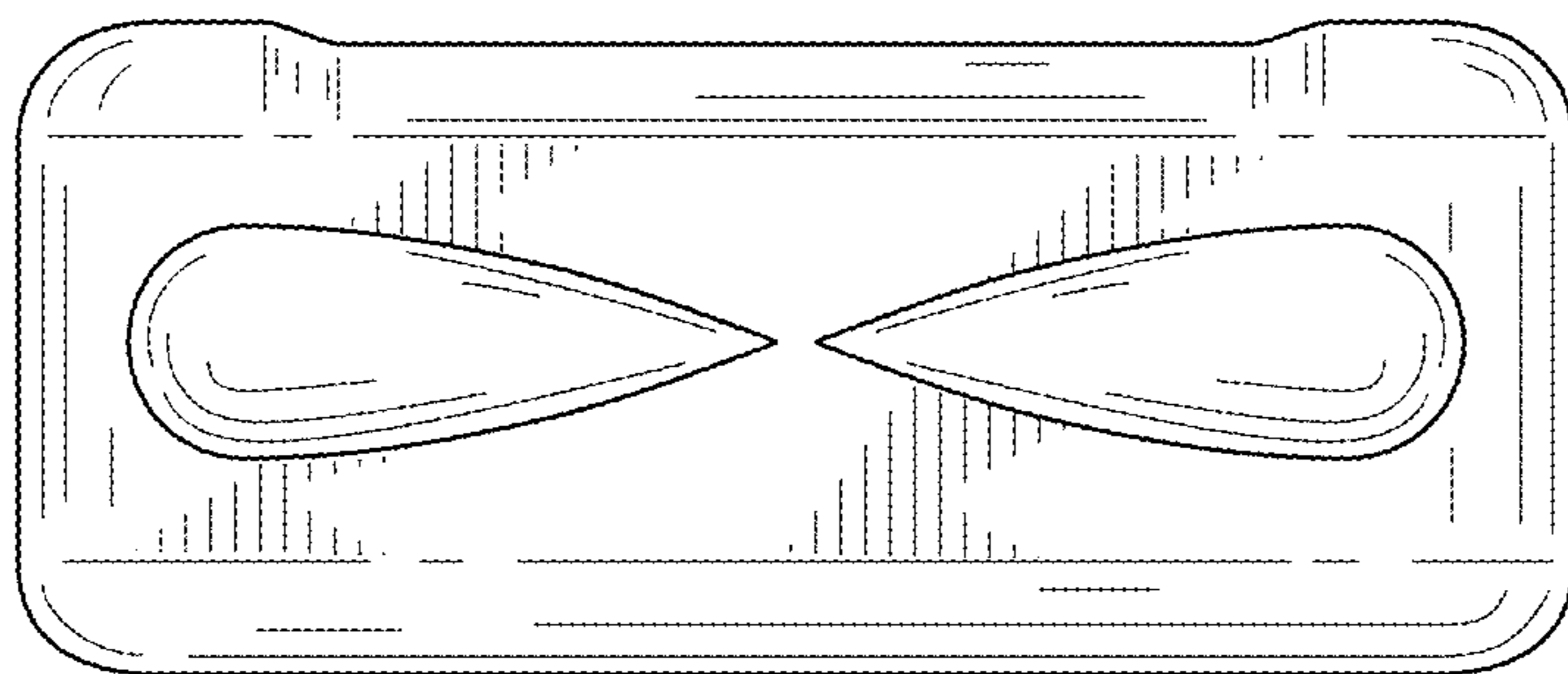

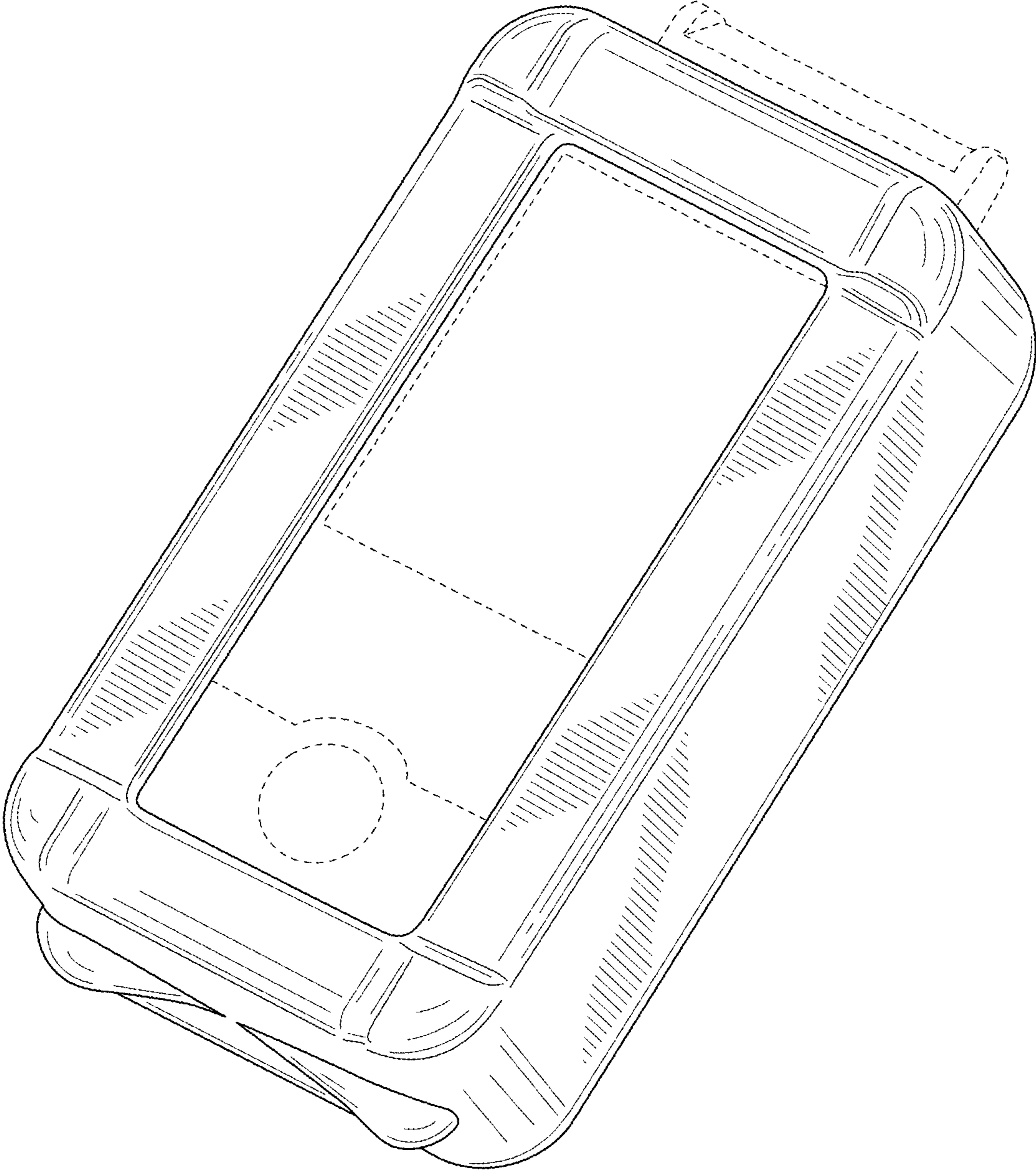
