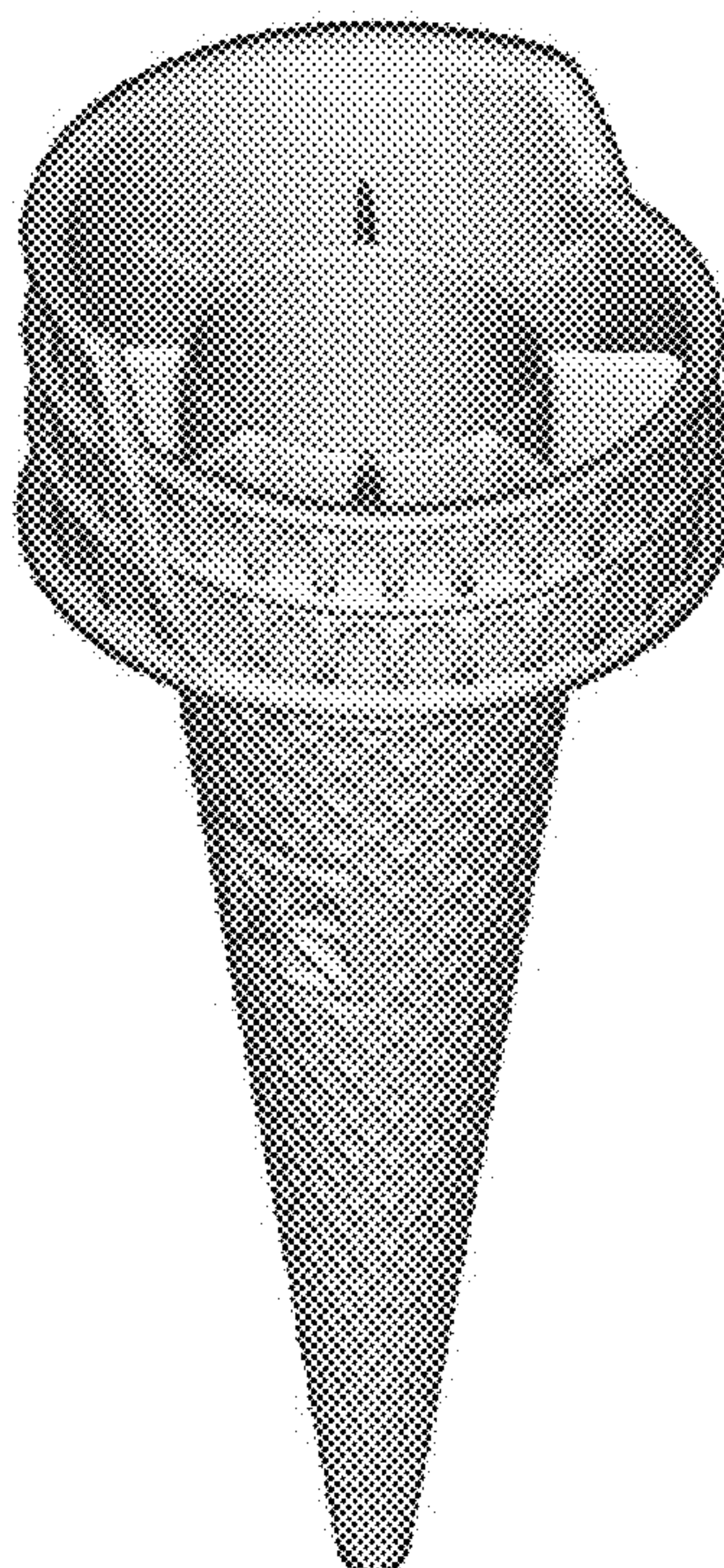

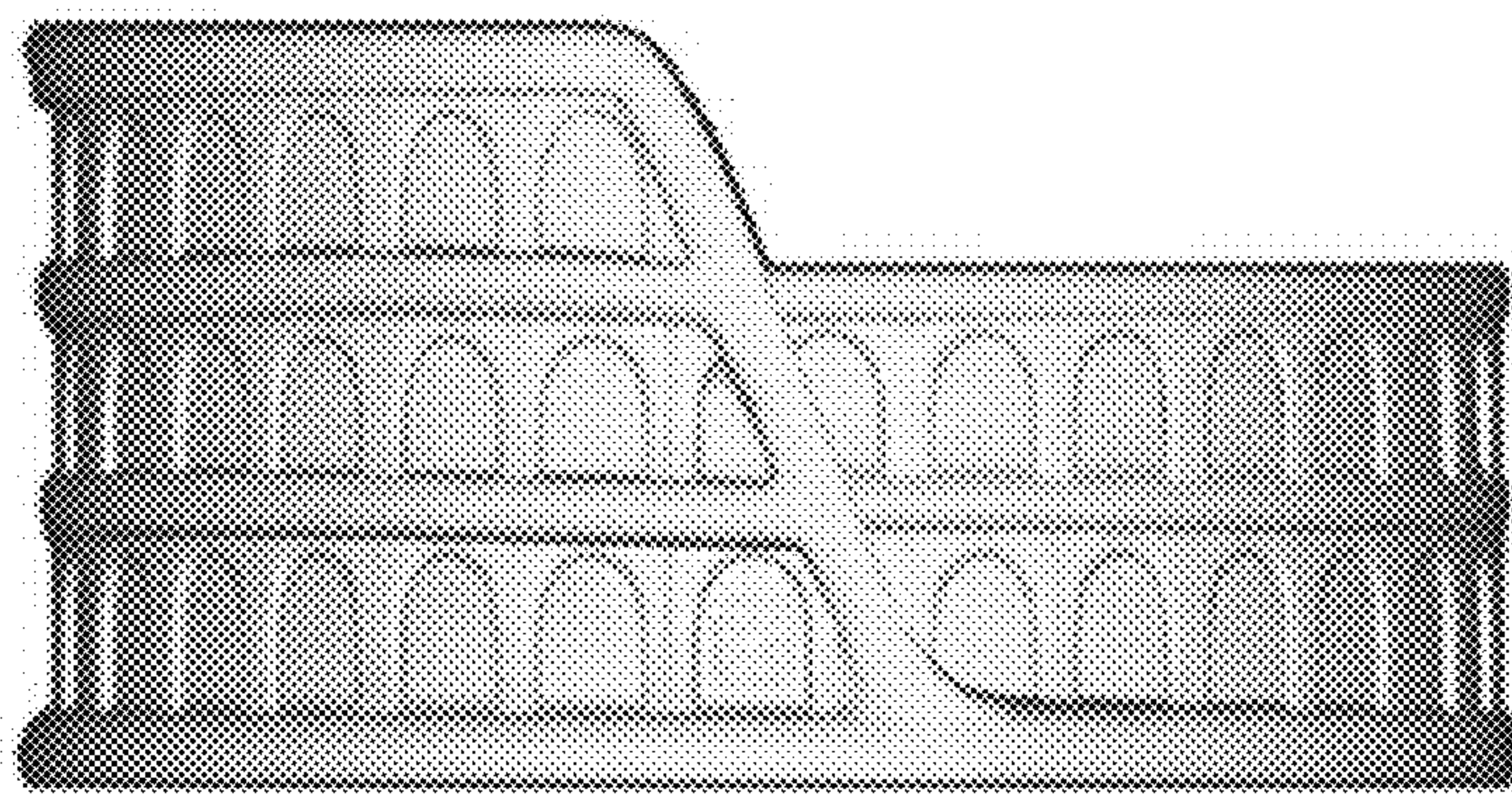

Cornet-shaped edible ice cream cornets reproducing the image of the Coliseum.

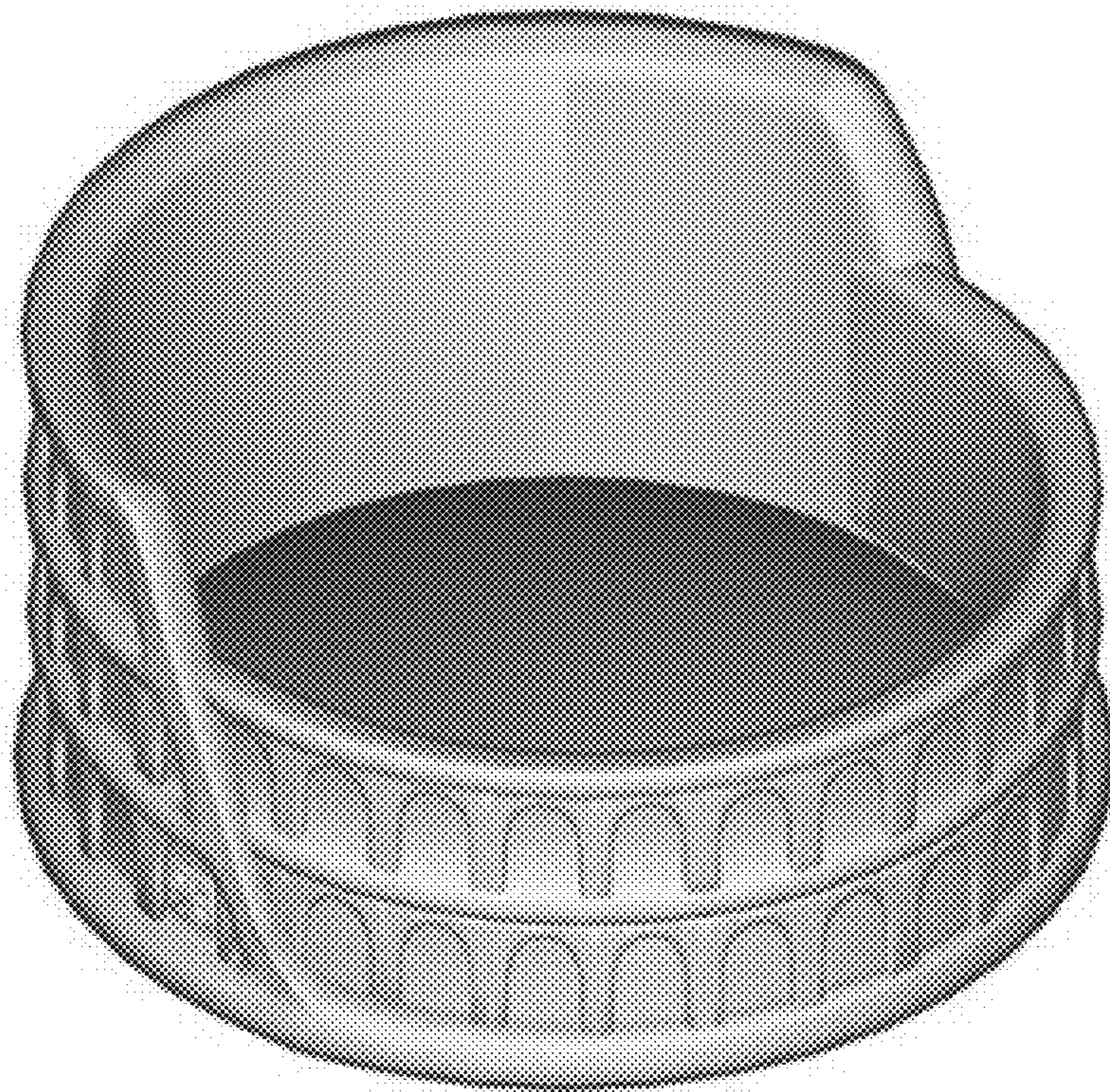

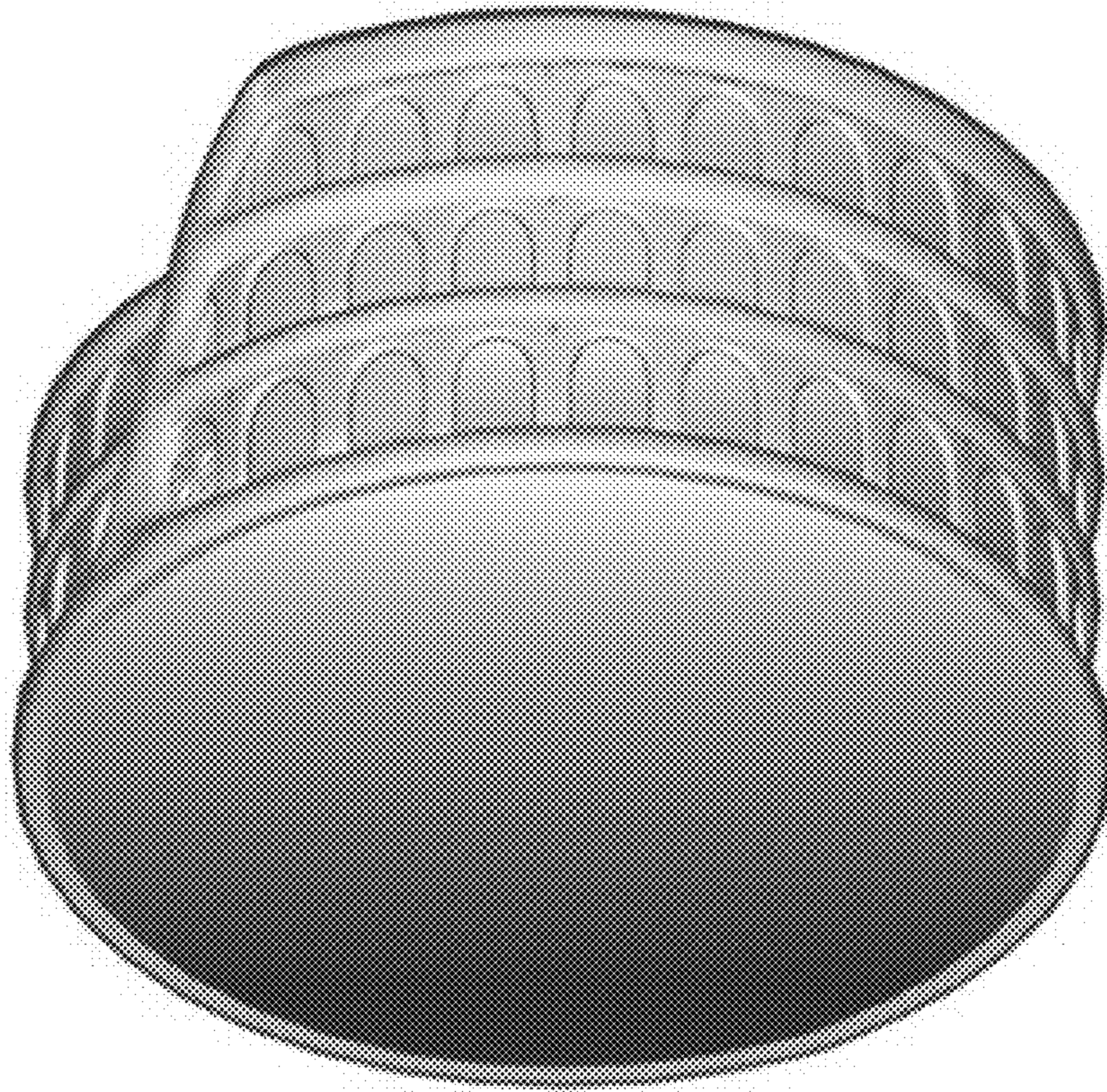

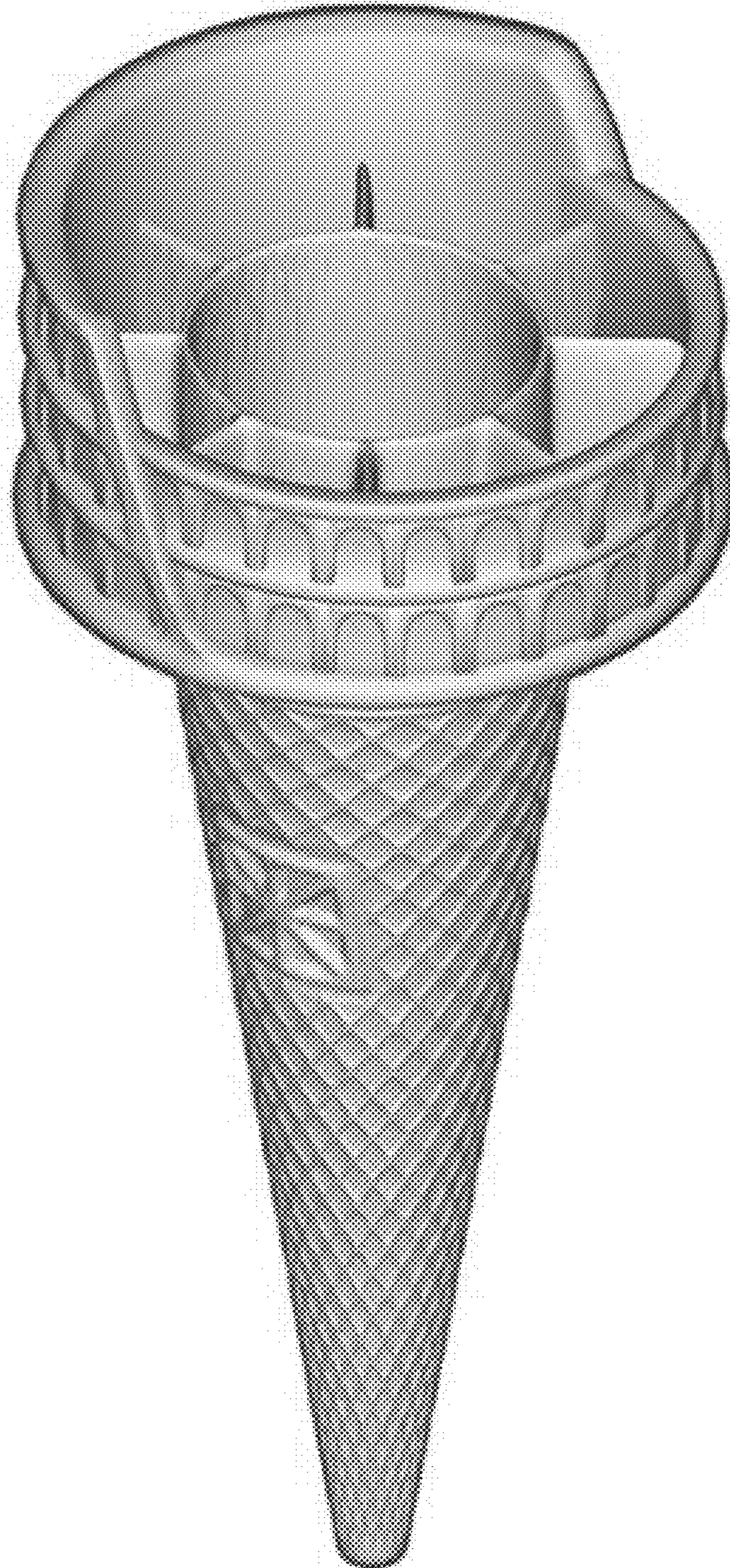

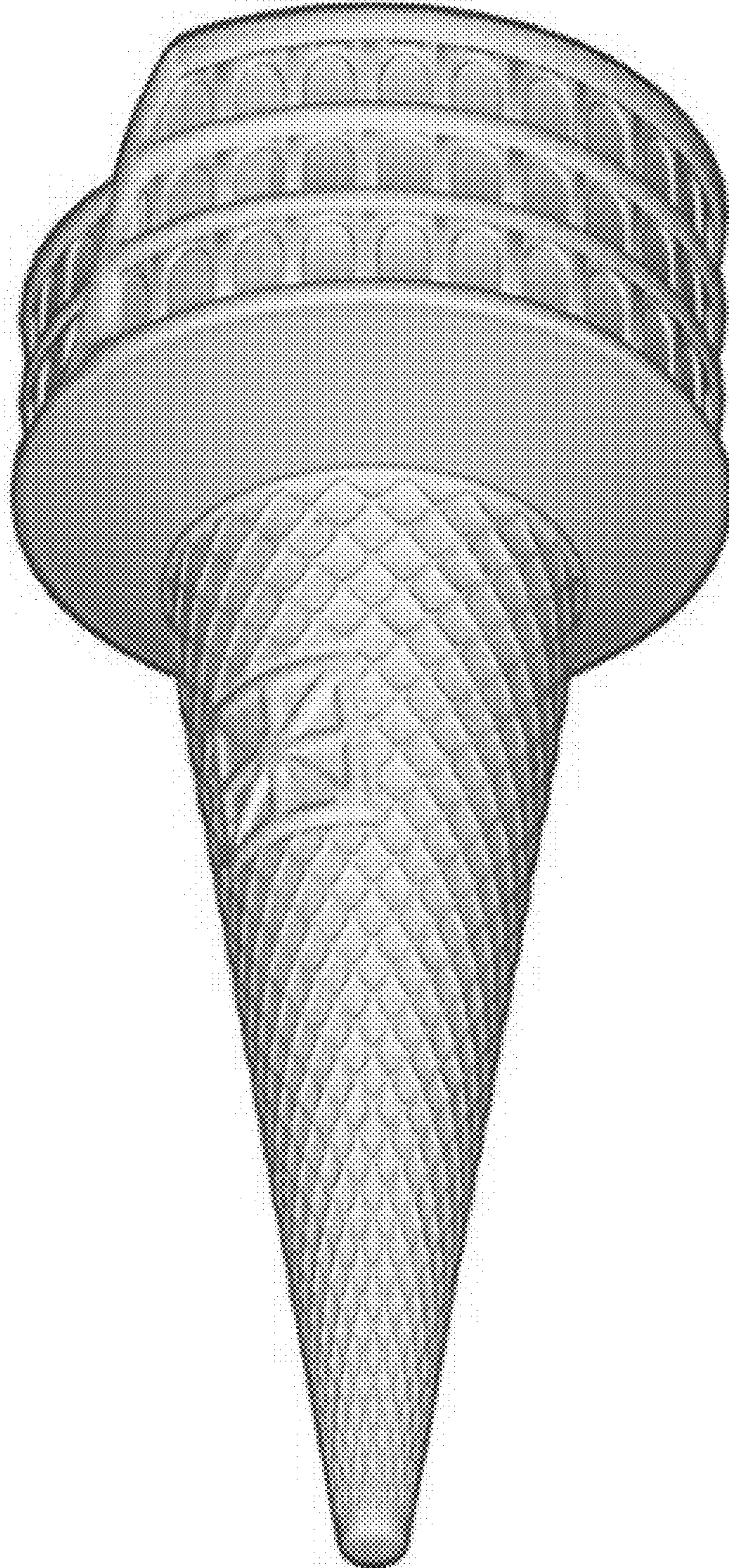
