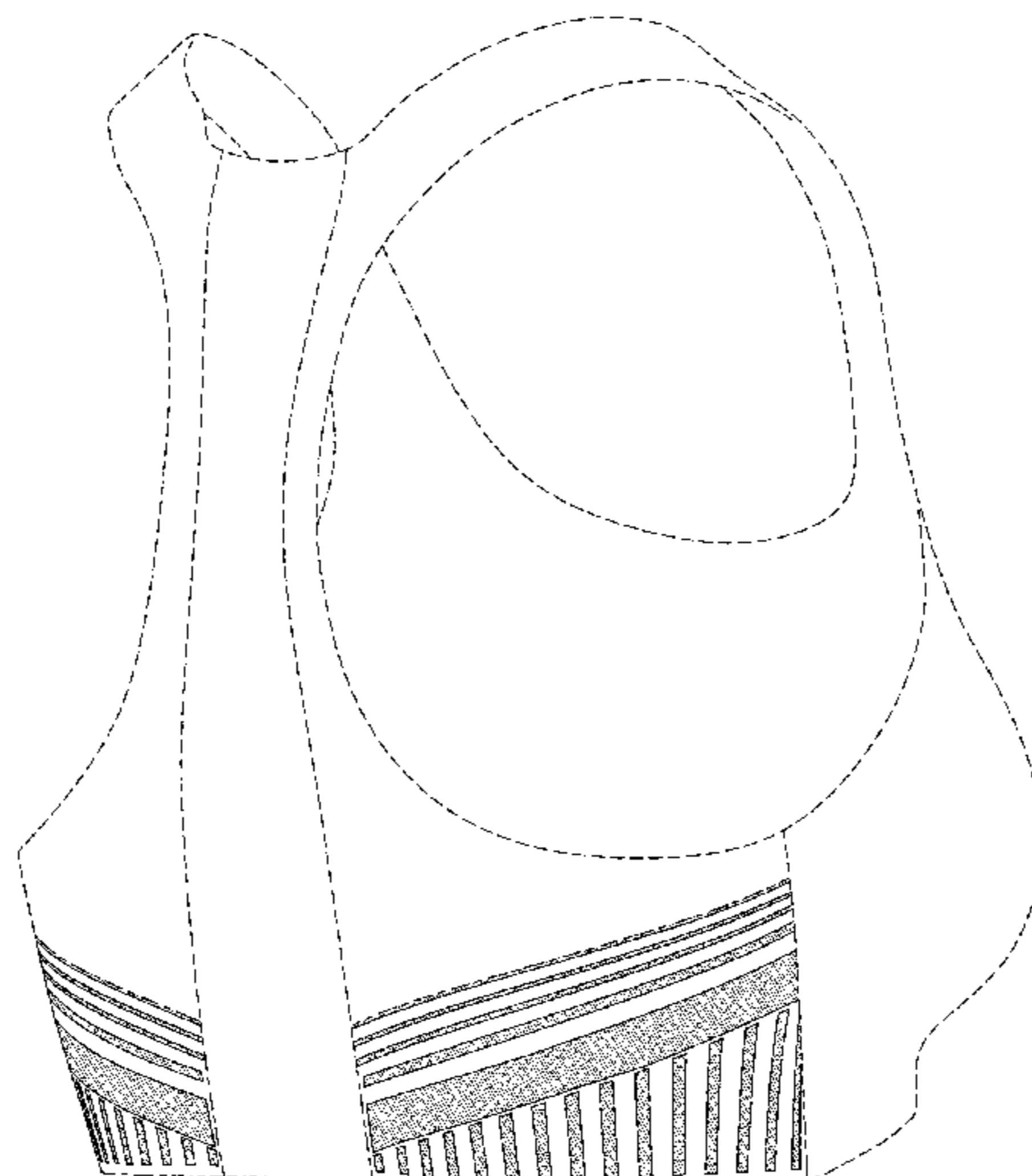
FIG. 1 is a rear perspective view of a garment showing my new design according to a first embodiment;

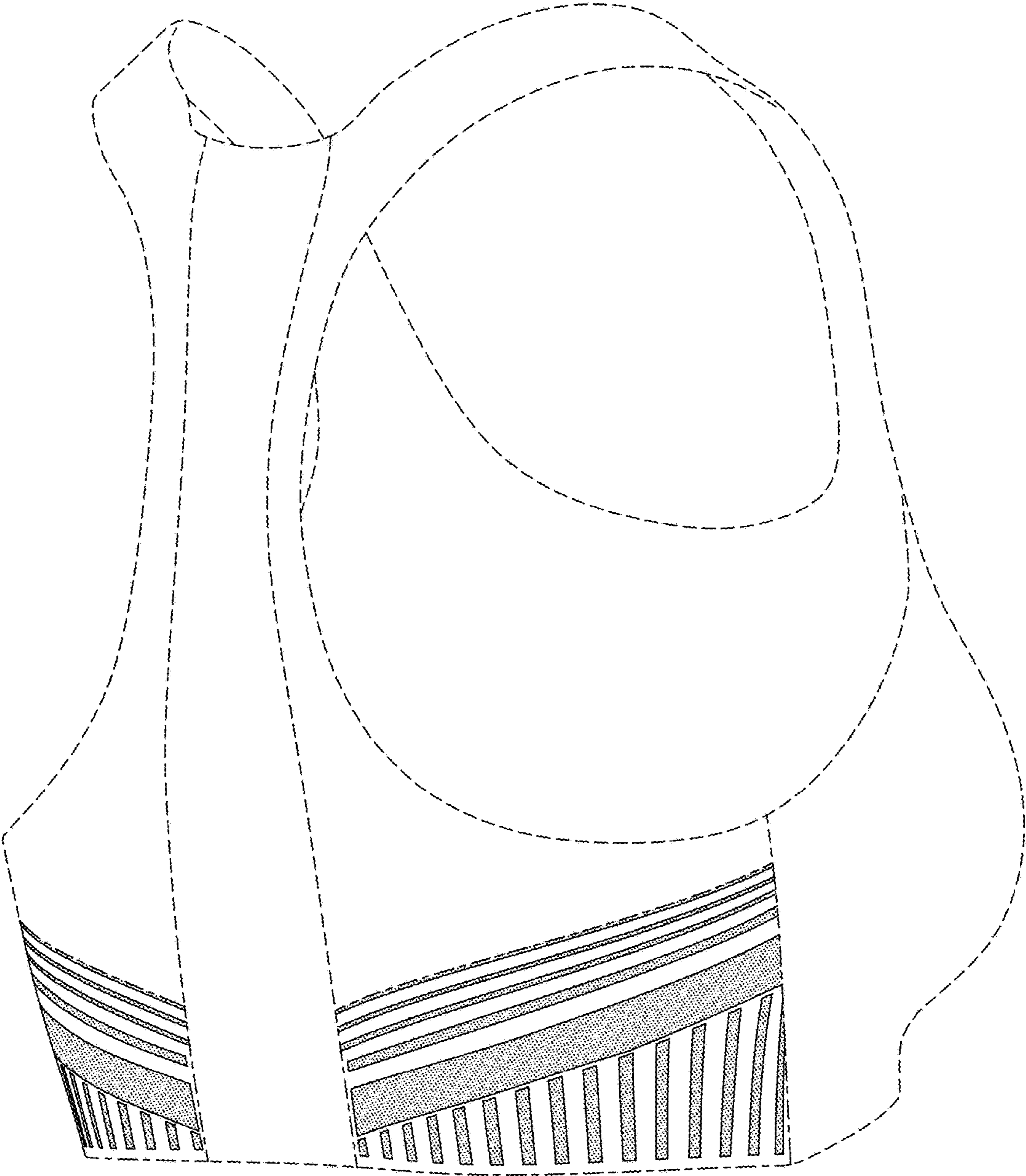

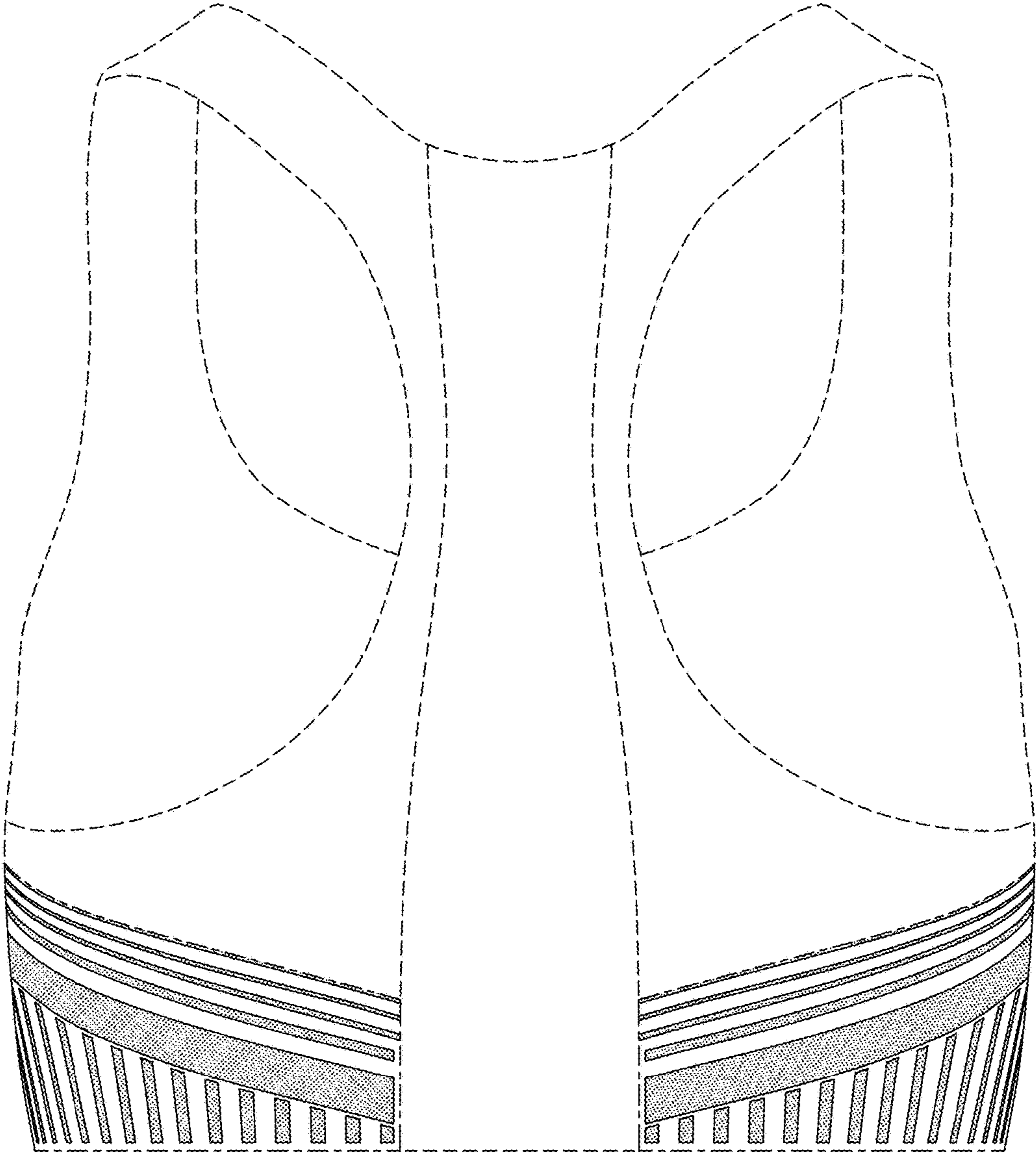

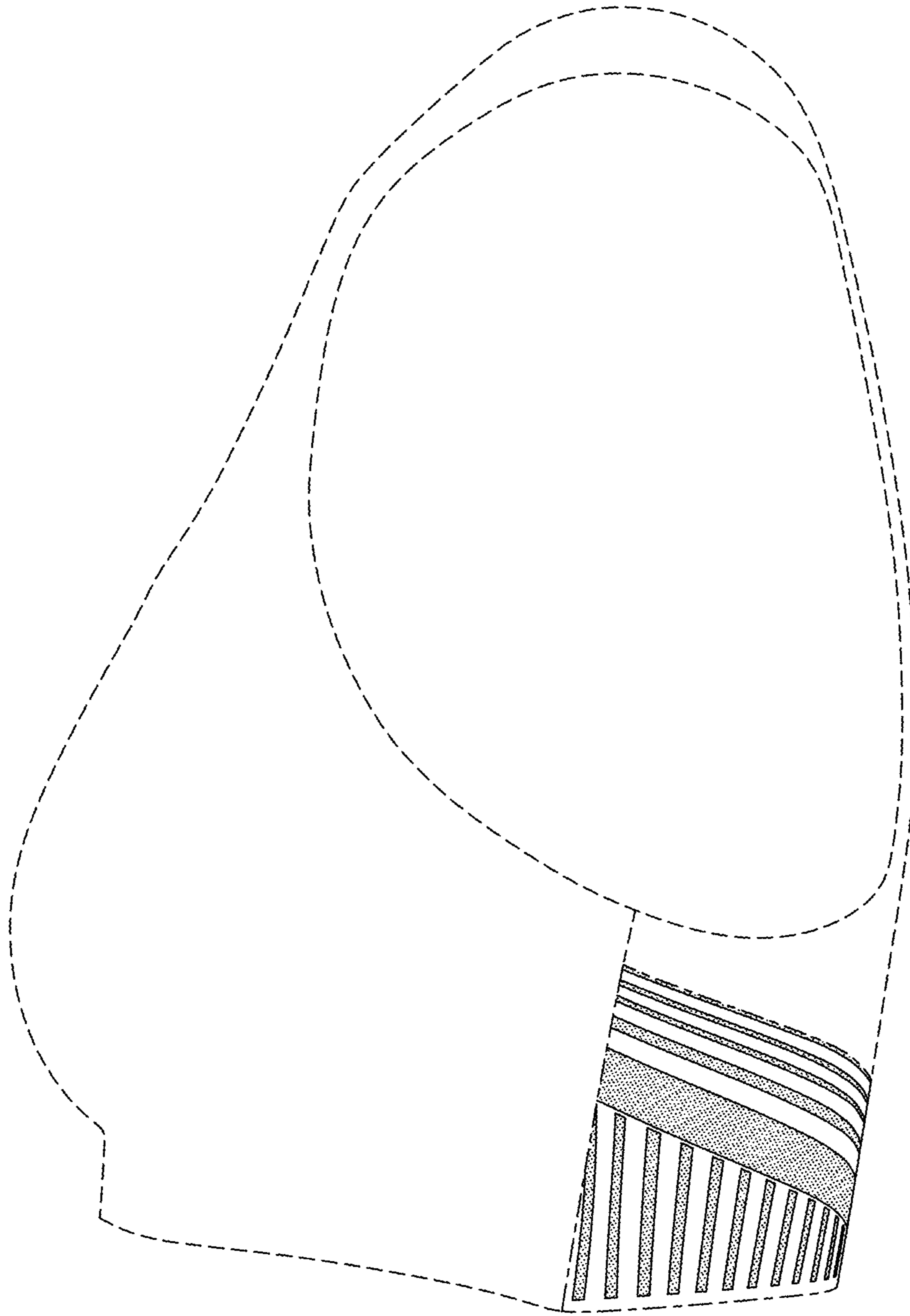

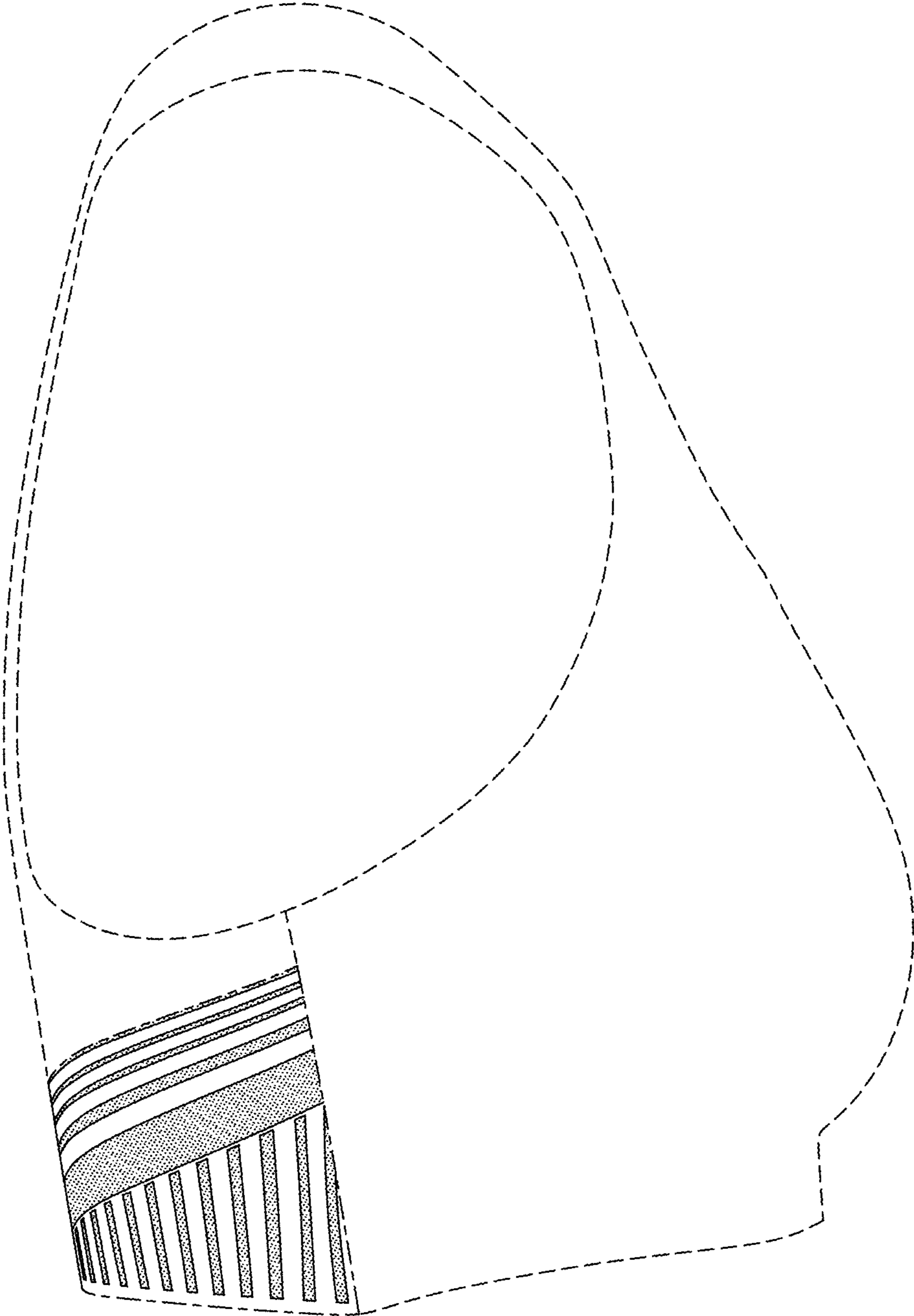

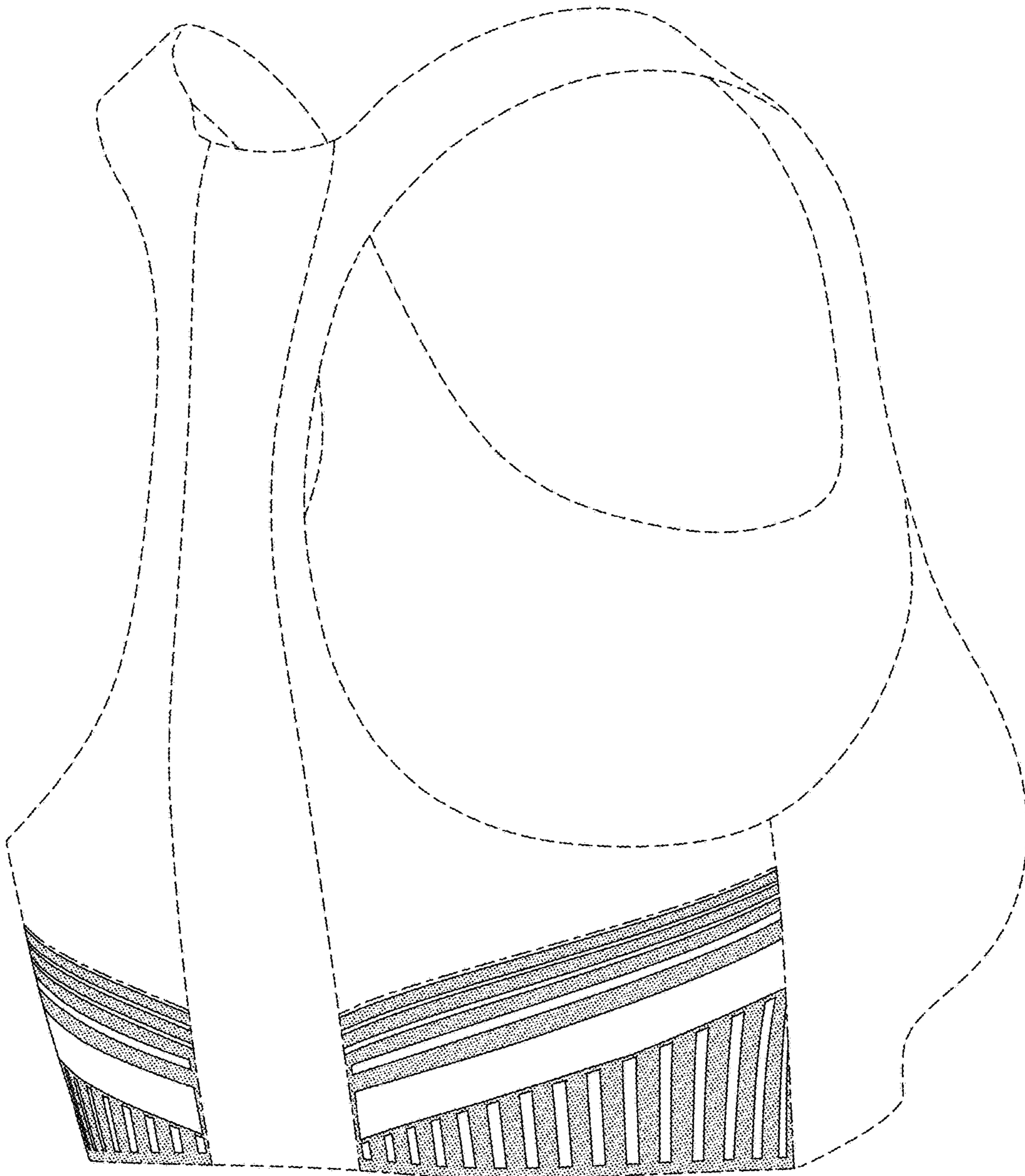

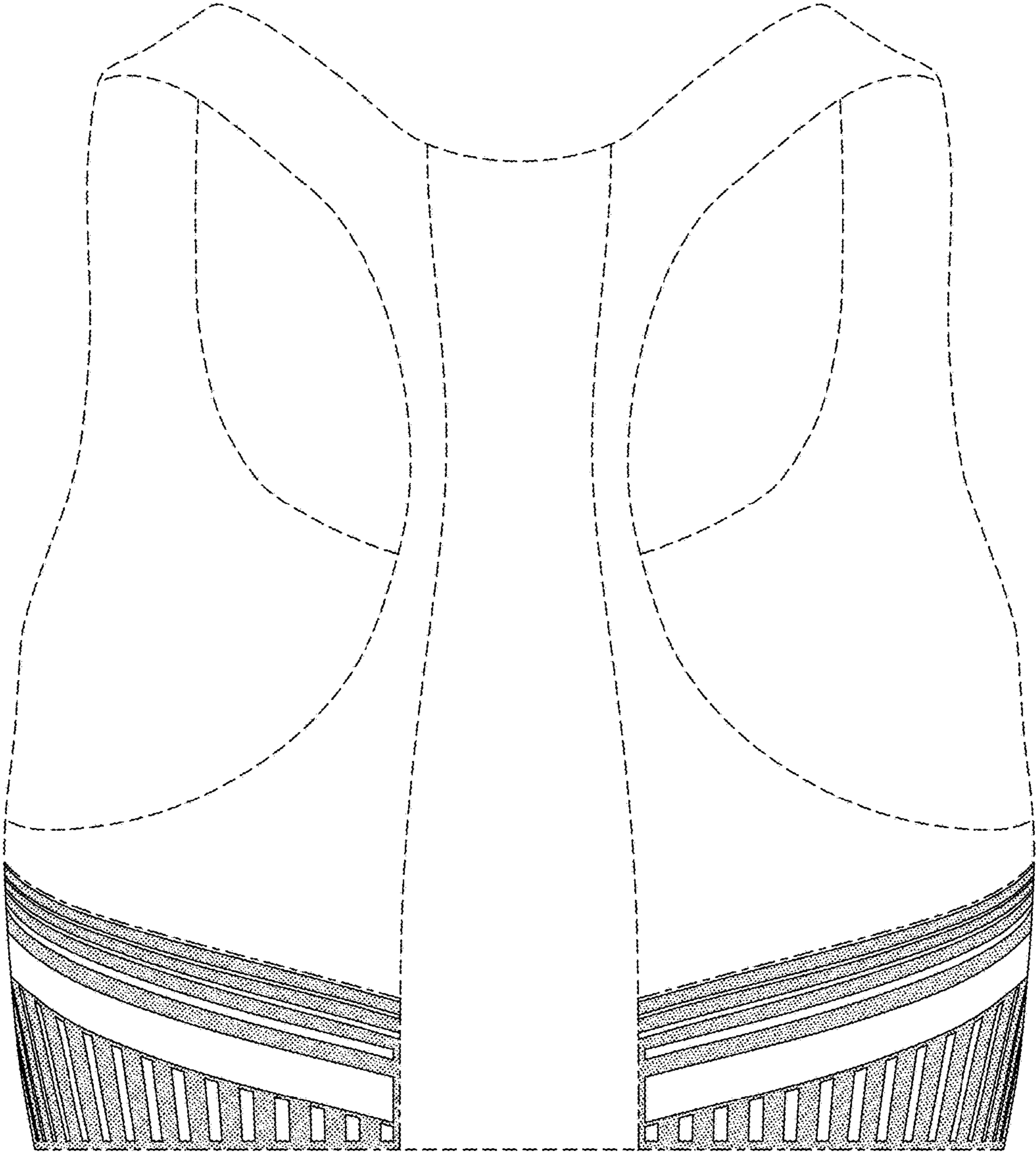

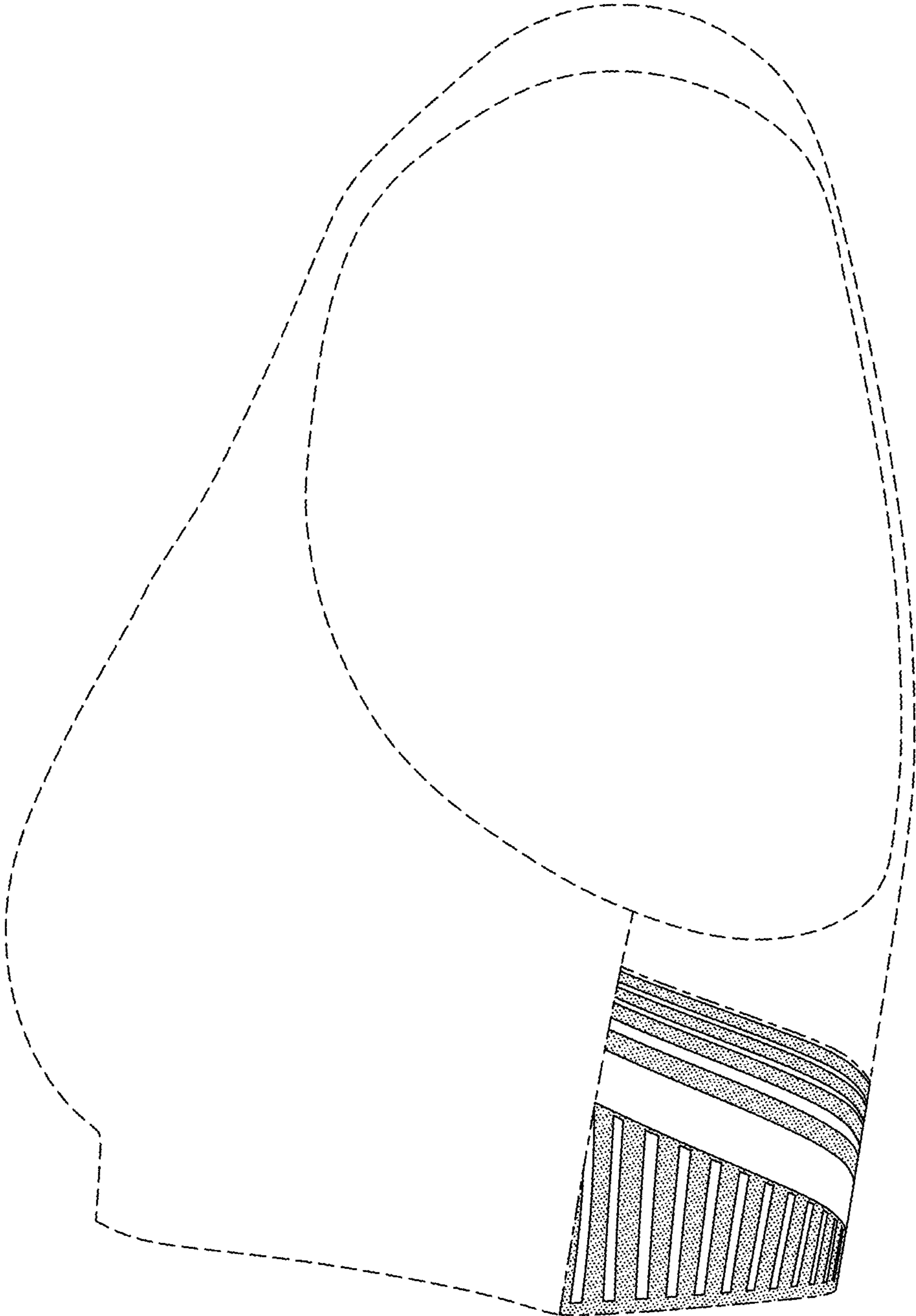

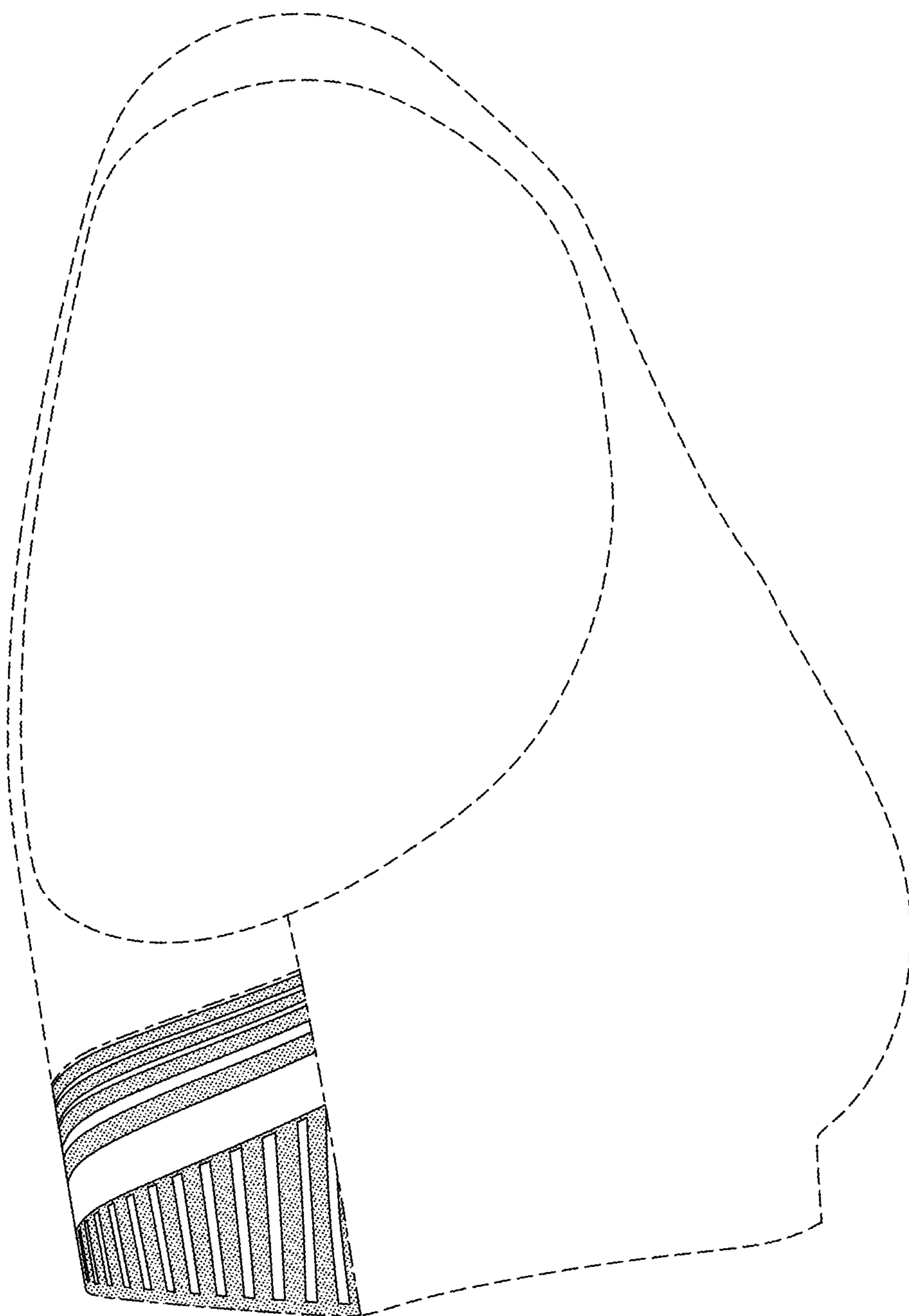
