**DESCRIPTION**

FIG. 1 is a front perspective view of a sleep sack;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a rear elevation view thereof;  
FIG. 4 is a left side elevation view thereof, the right side elevation being a mirror image thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom plan view thereof; and,  
FIG. 7 is a top plan view thereof shown in use.  
The broken lines showing of an infant in FIG. 7 depicts environmental subject matter that forms no part of the claimed design.

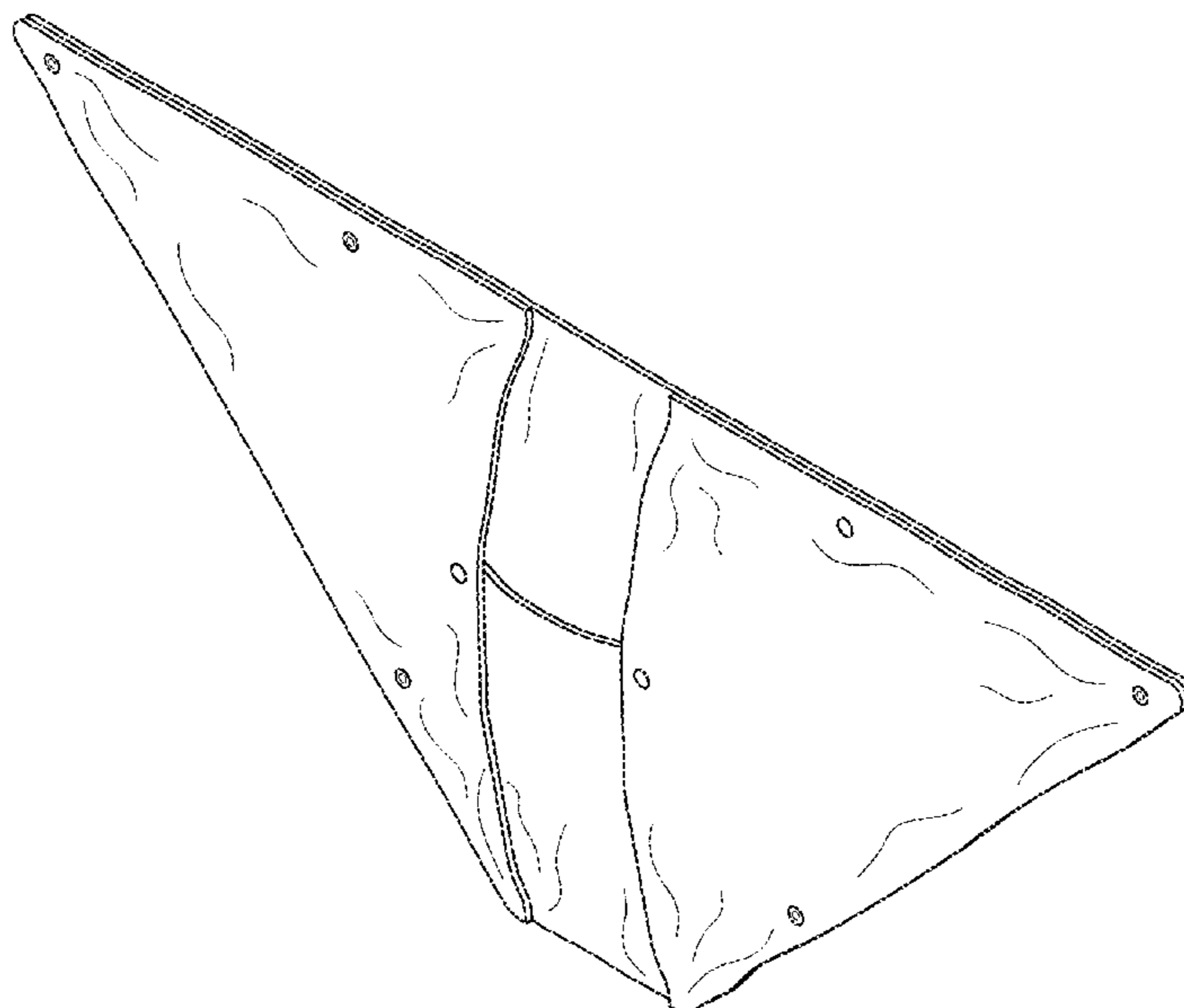
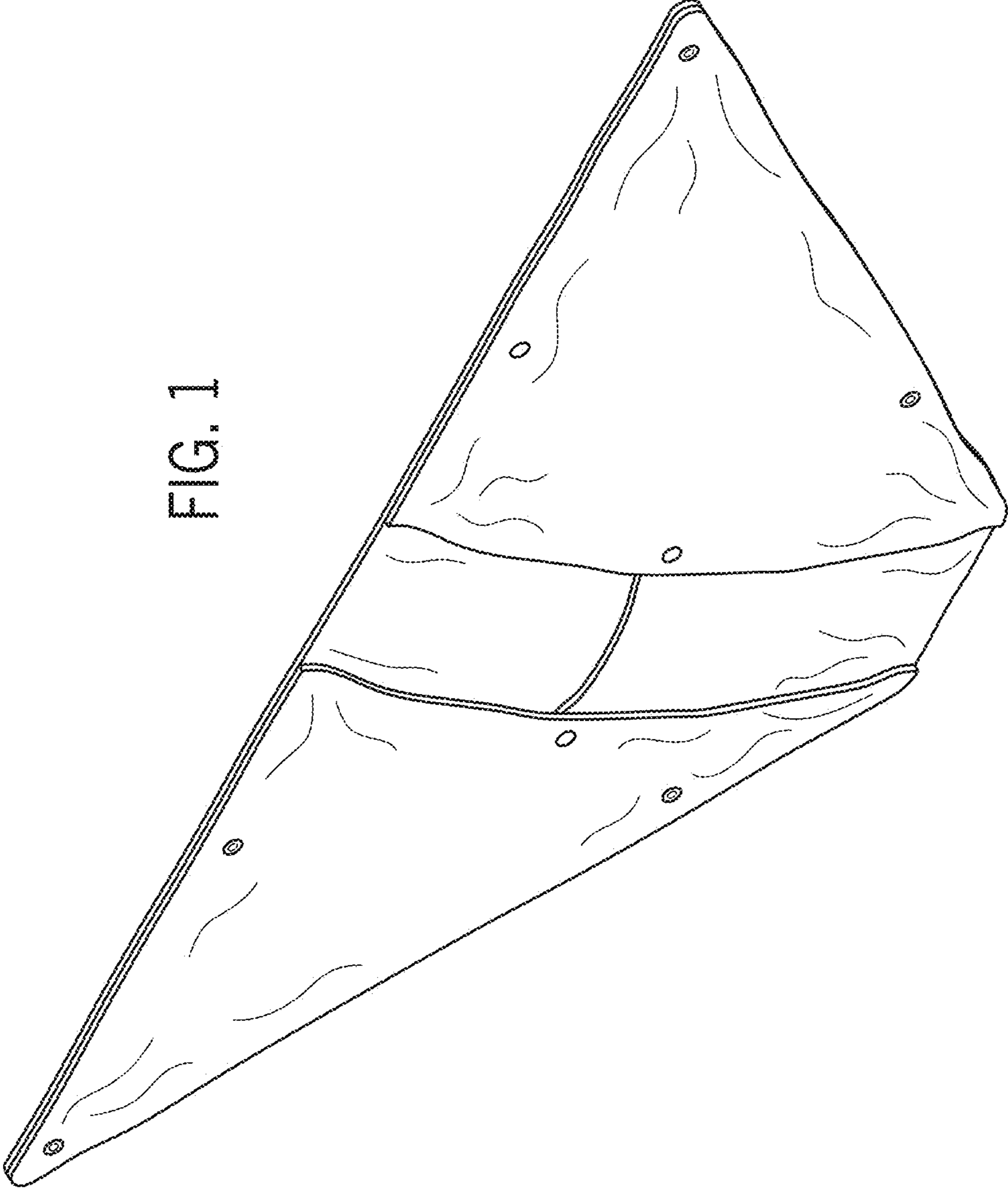

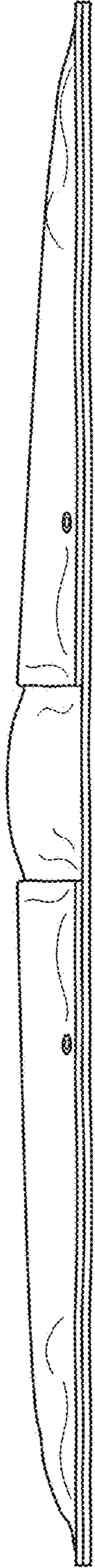

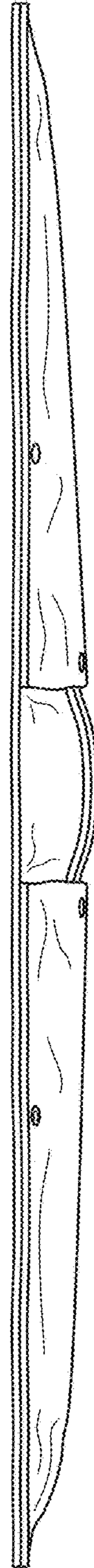

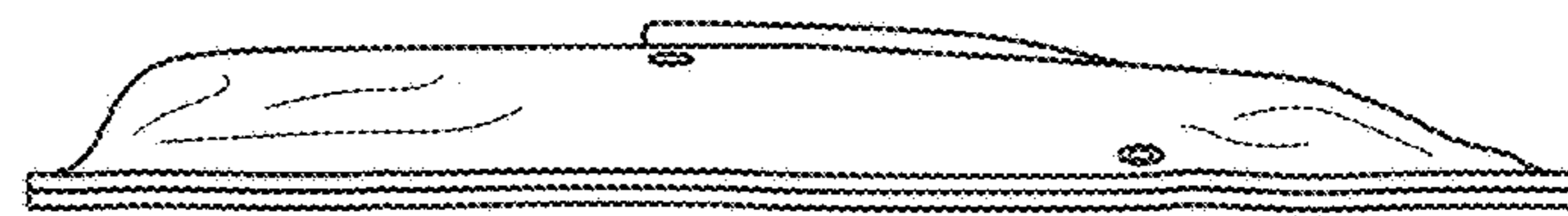

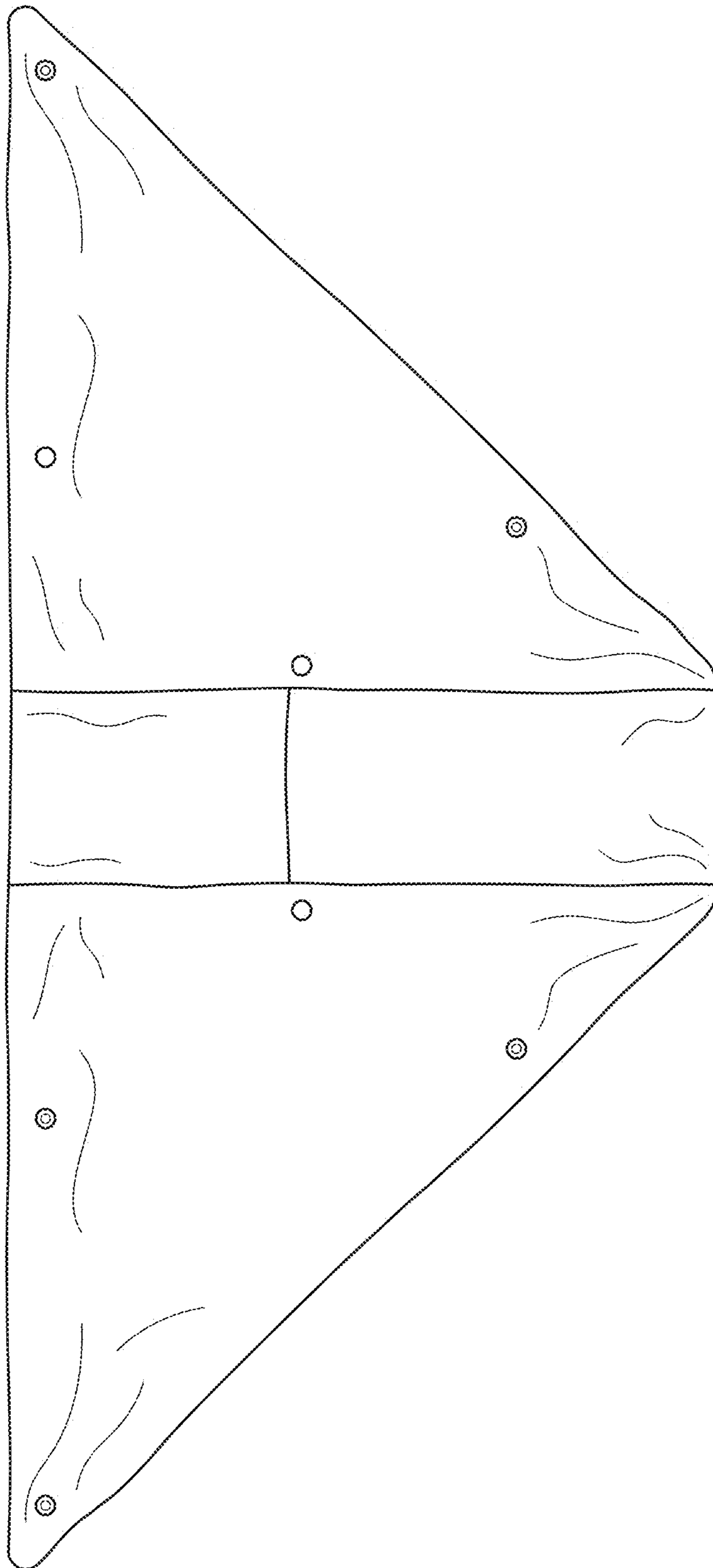

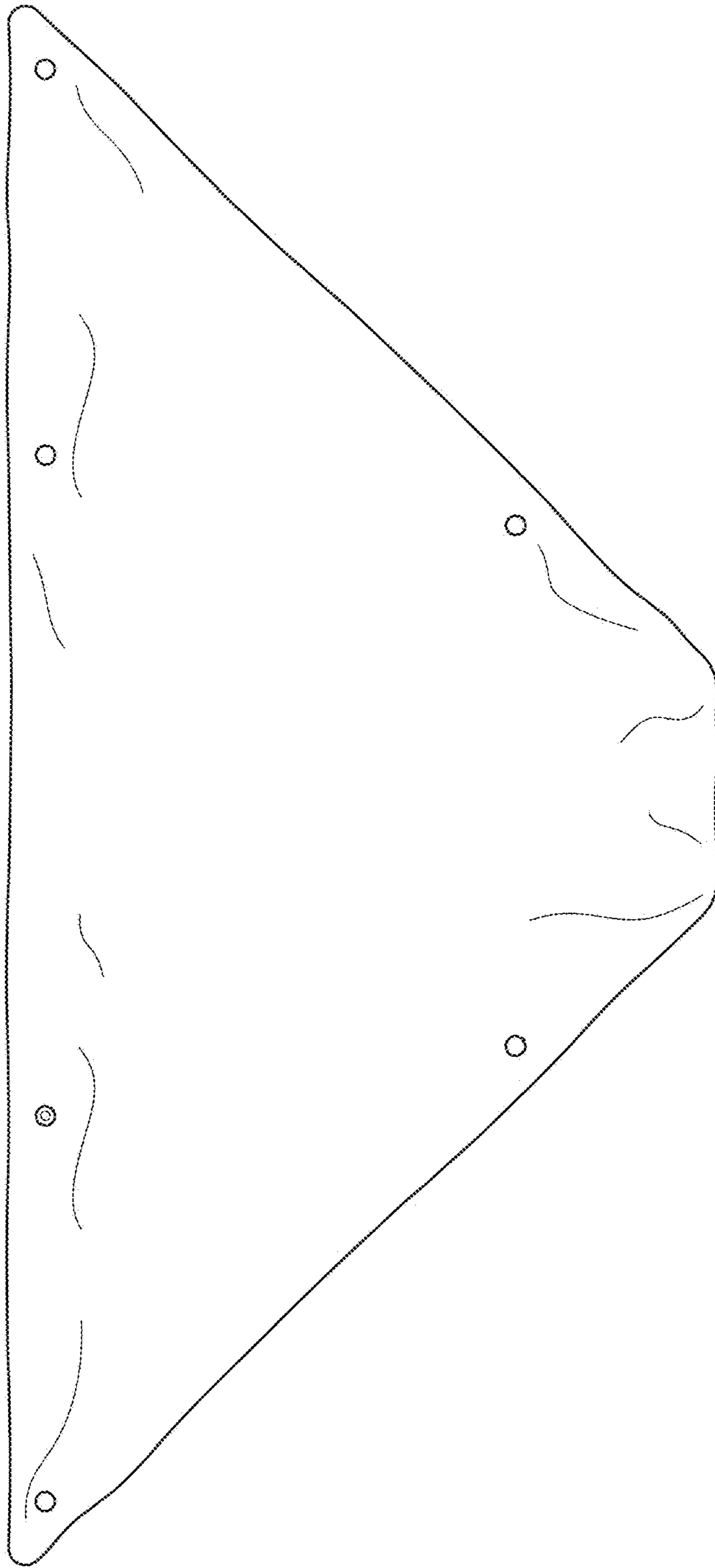

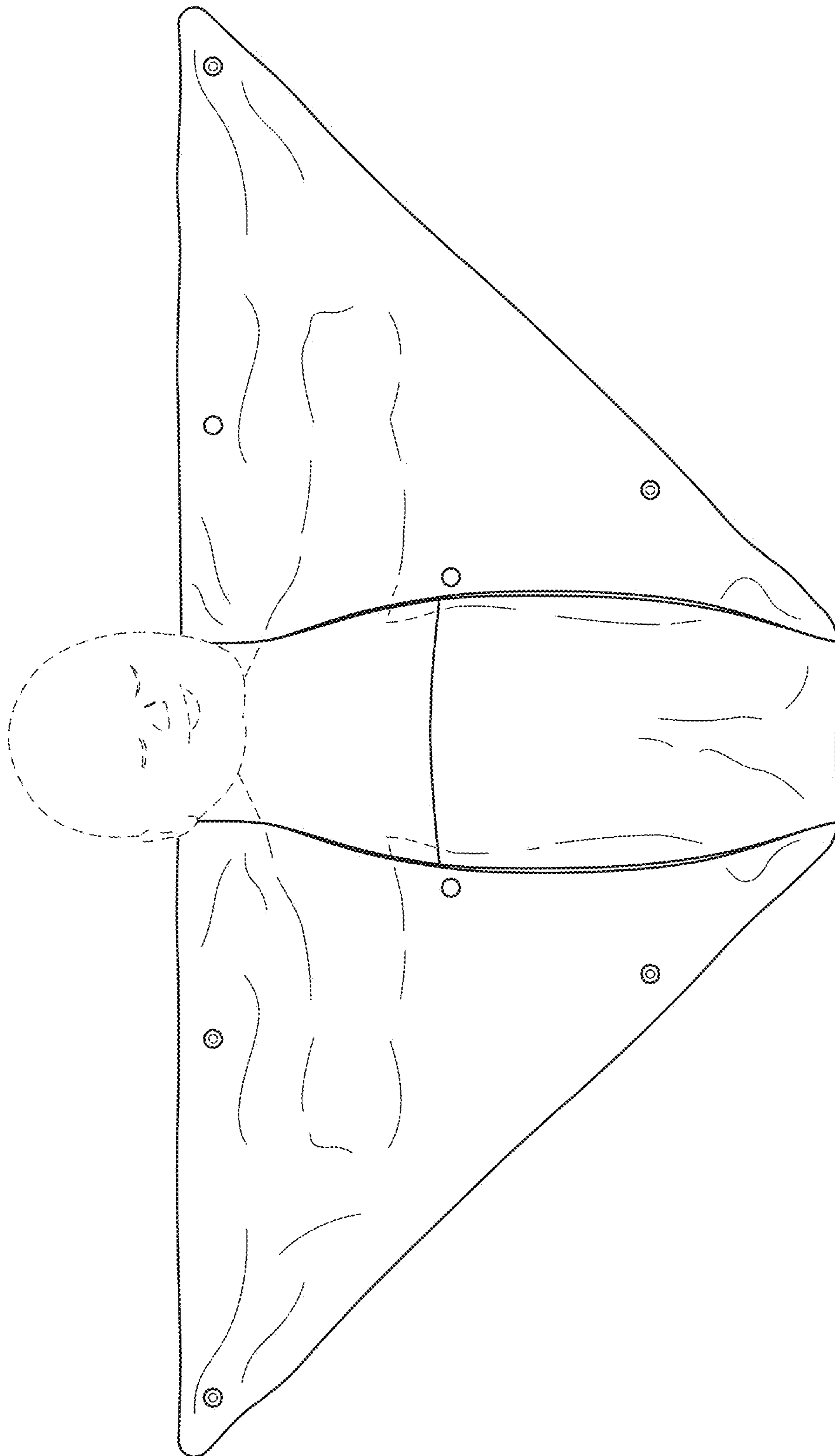
