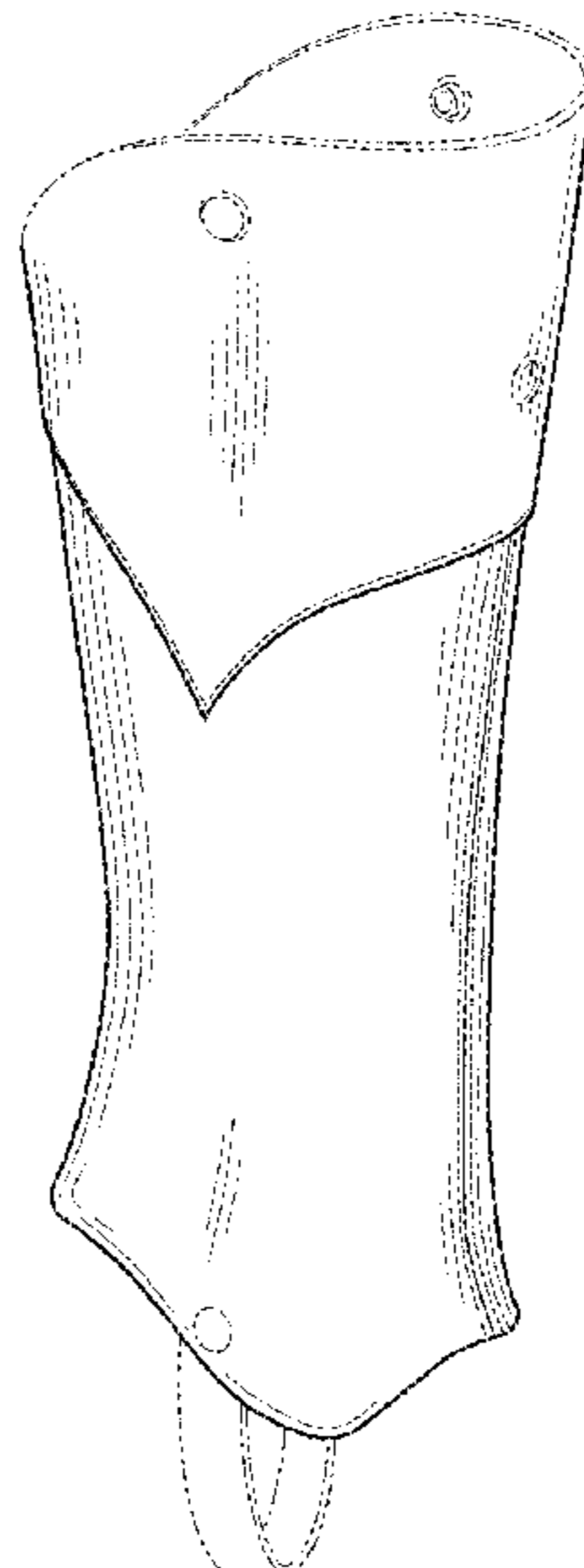
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of a clothing article according to the present invention. 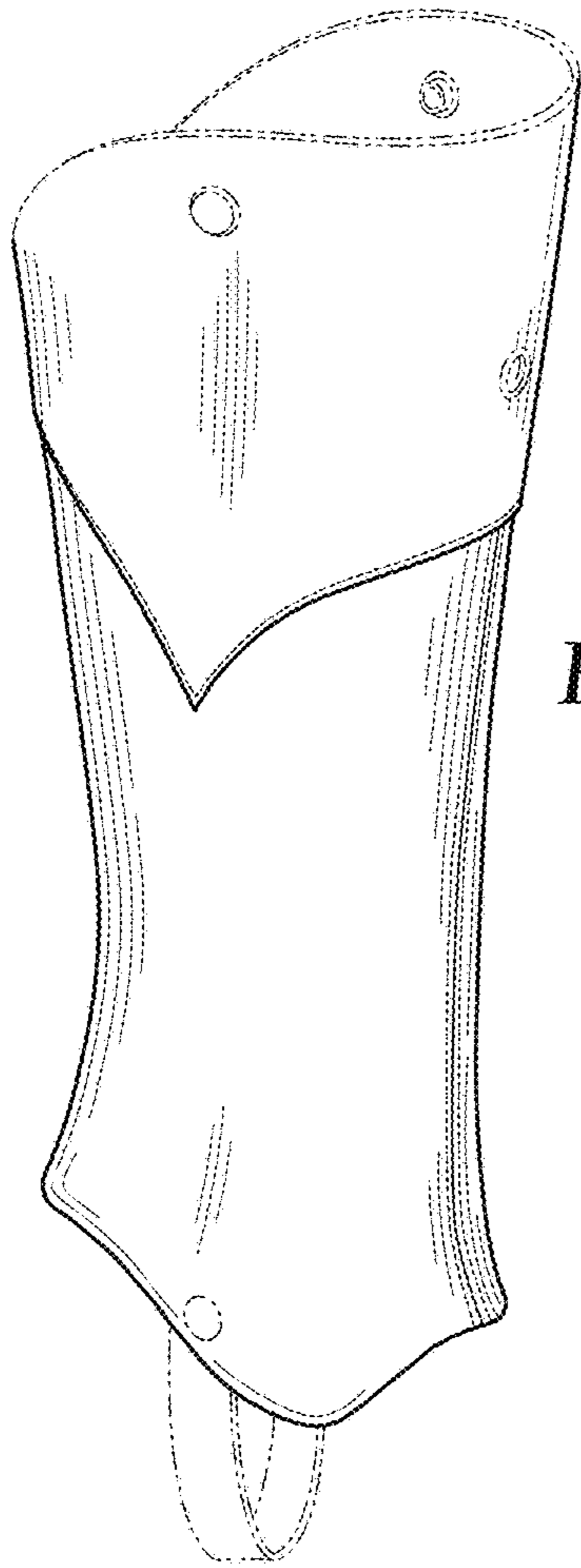

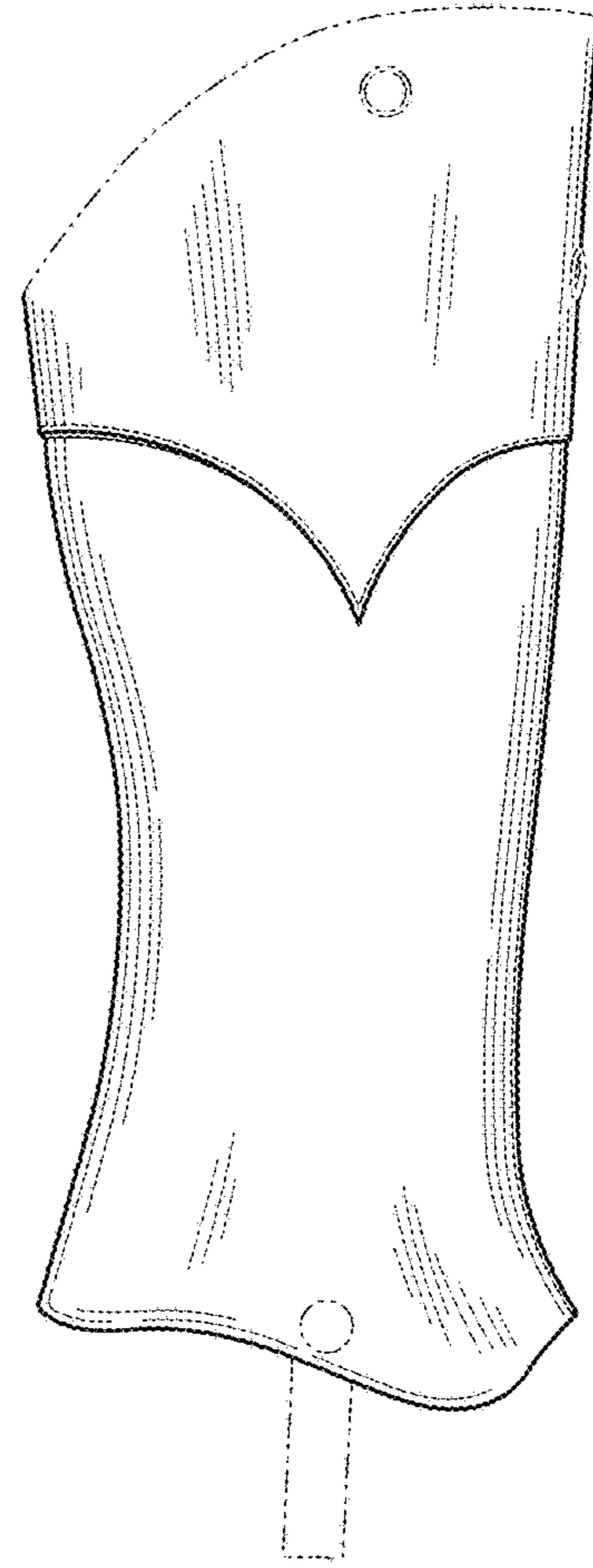

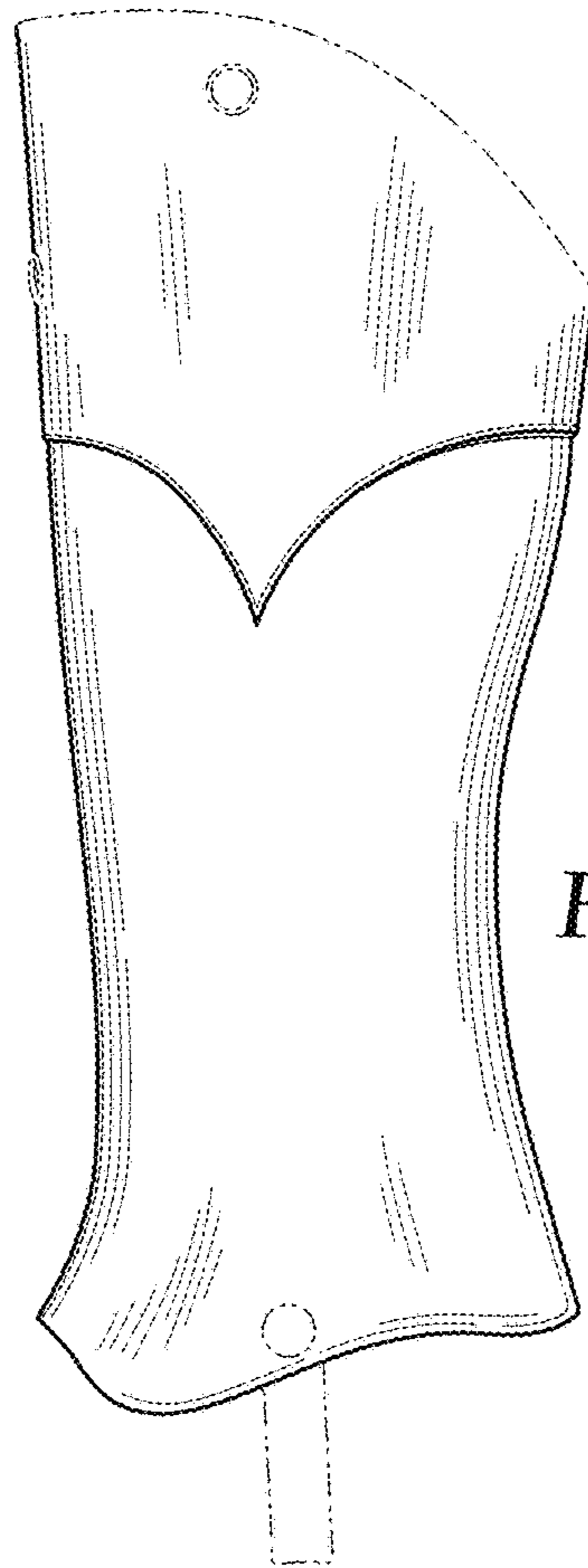

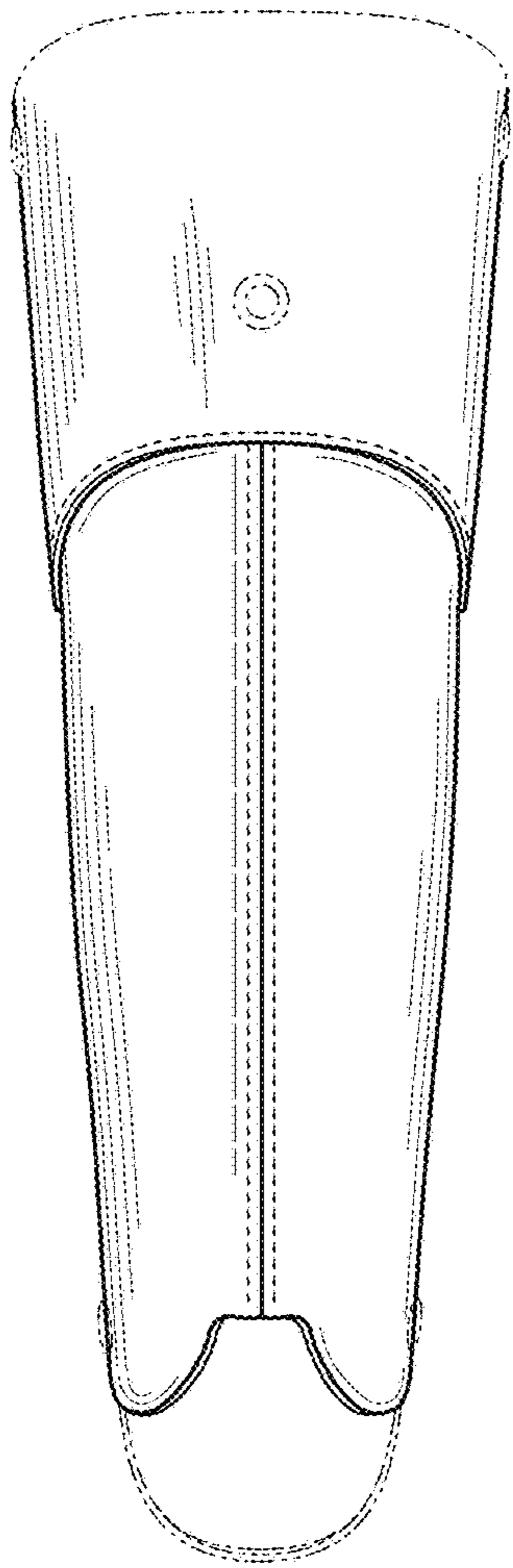

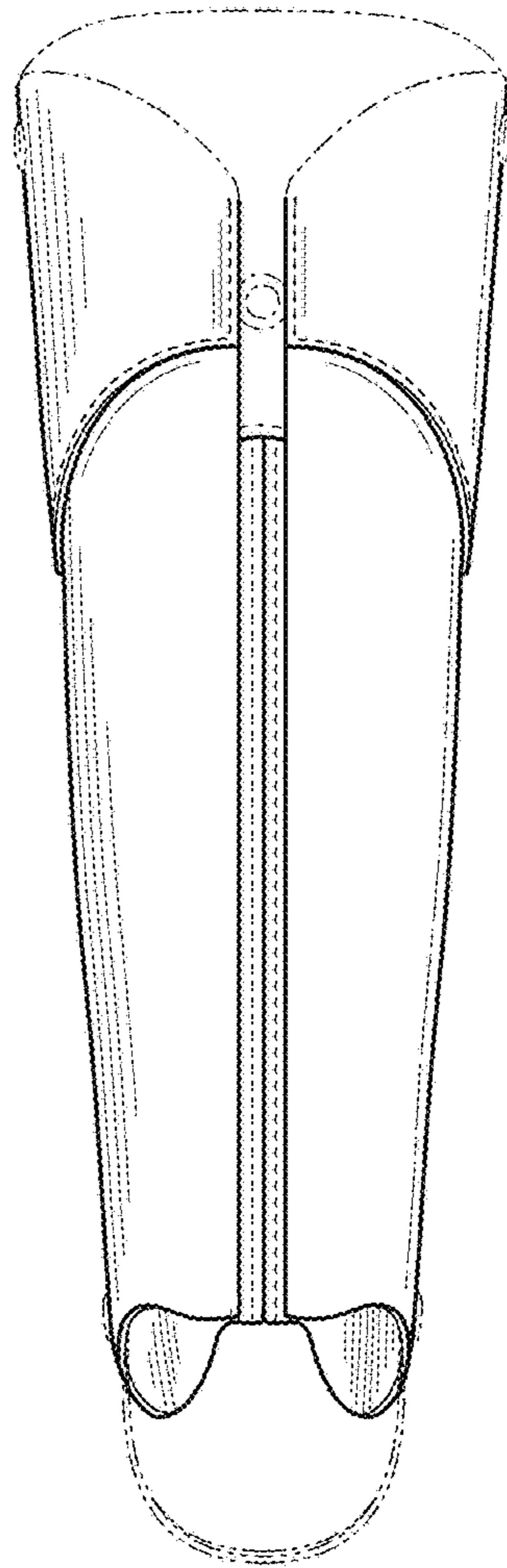

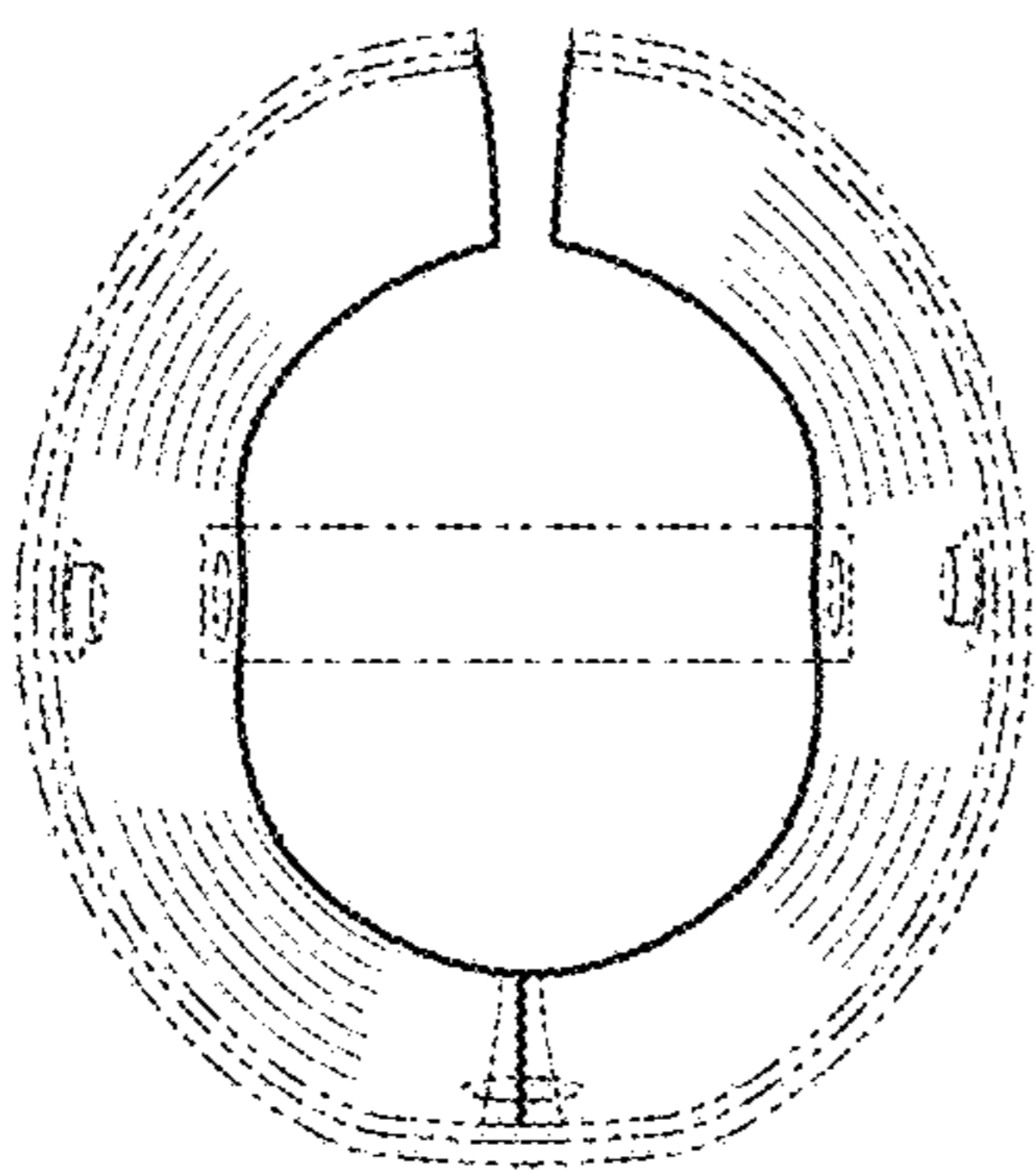

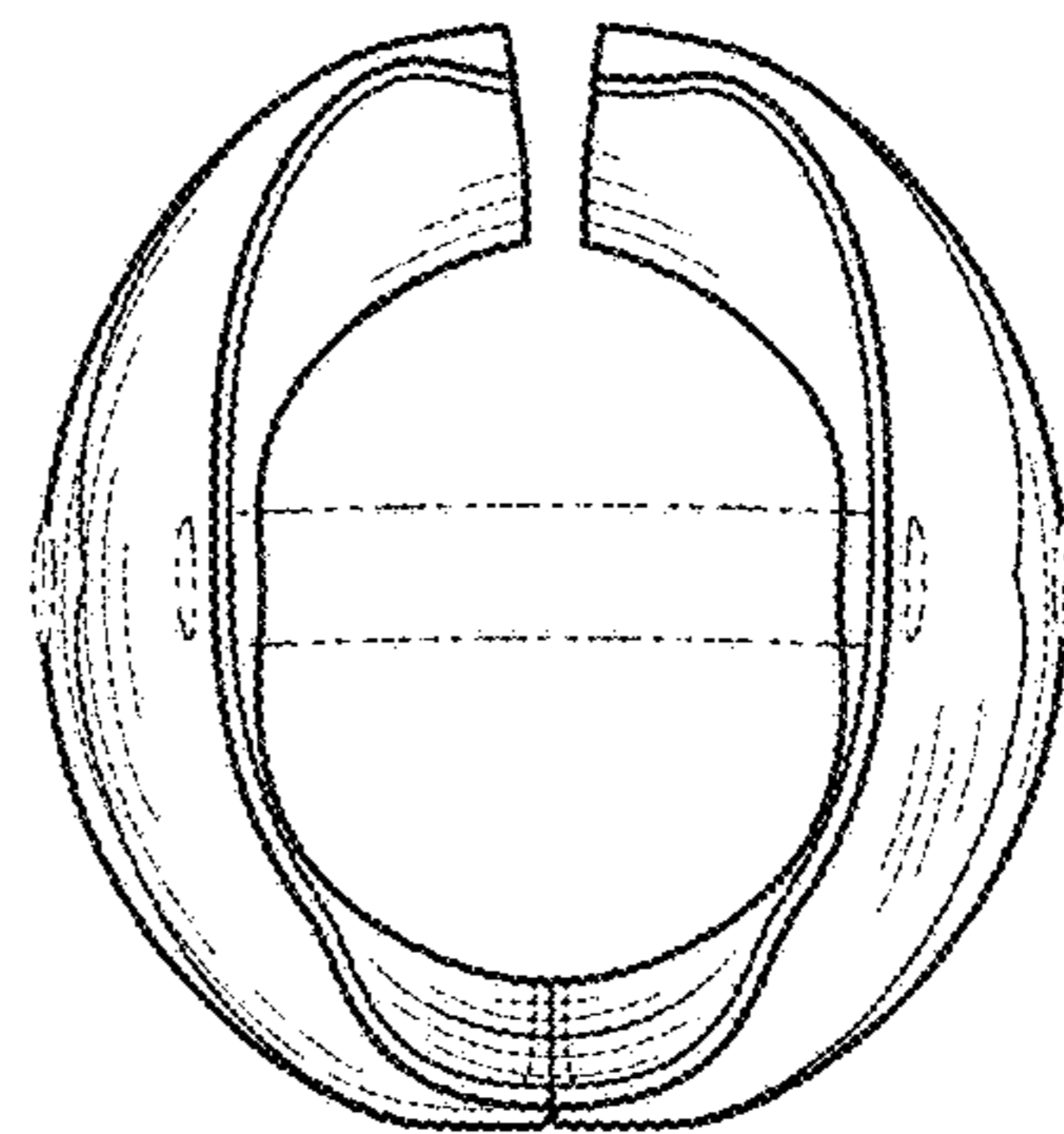
