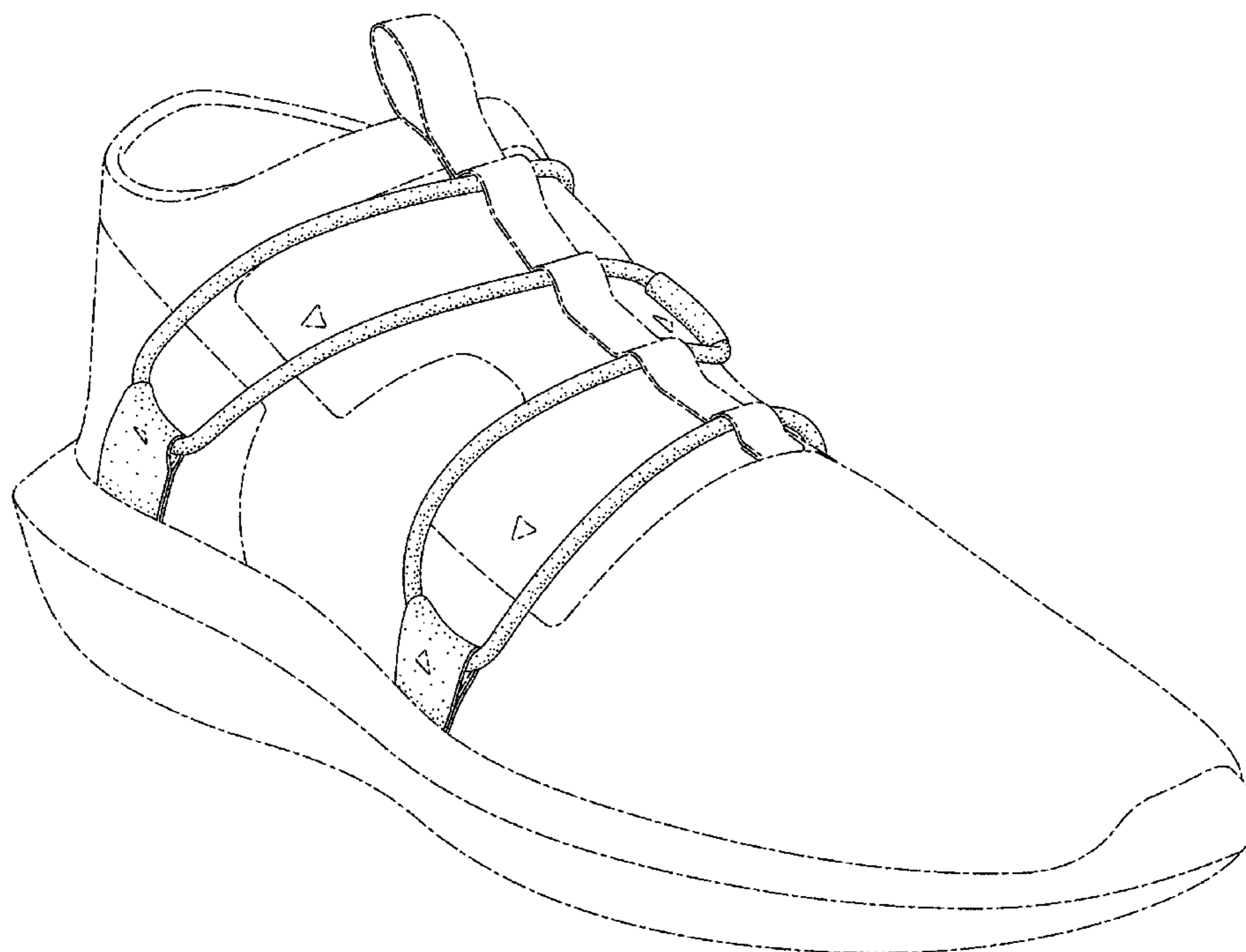
(57) **CLAIM**

The ornamental design for a shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe upper showing my new design;  
FIG. 2 is a side view thereof;  
FIG. 3 is a second side view thereof;  
FIG. 4 is a front view thereof;  
FIG. 5 is a top view thereof; and,  
FIG. 6 is a rear perspective view thereof.  
The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The broken line within the shaded area represents a feature that forms no part of the claimed design. The broken lines showing the remainder of the shoe represent unclaimed subject matter and form no part of the claimed design.

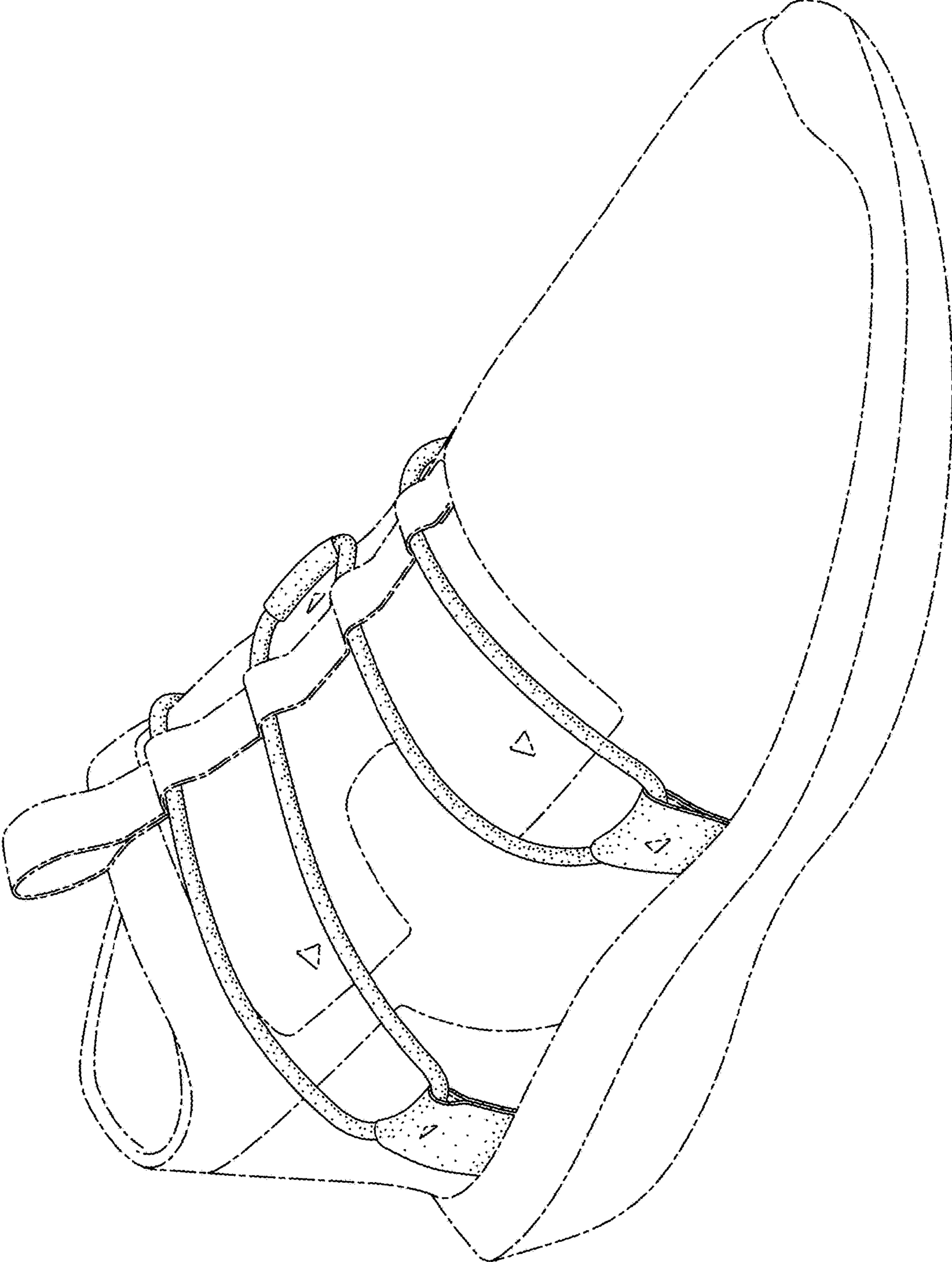

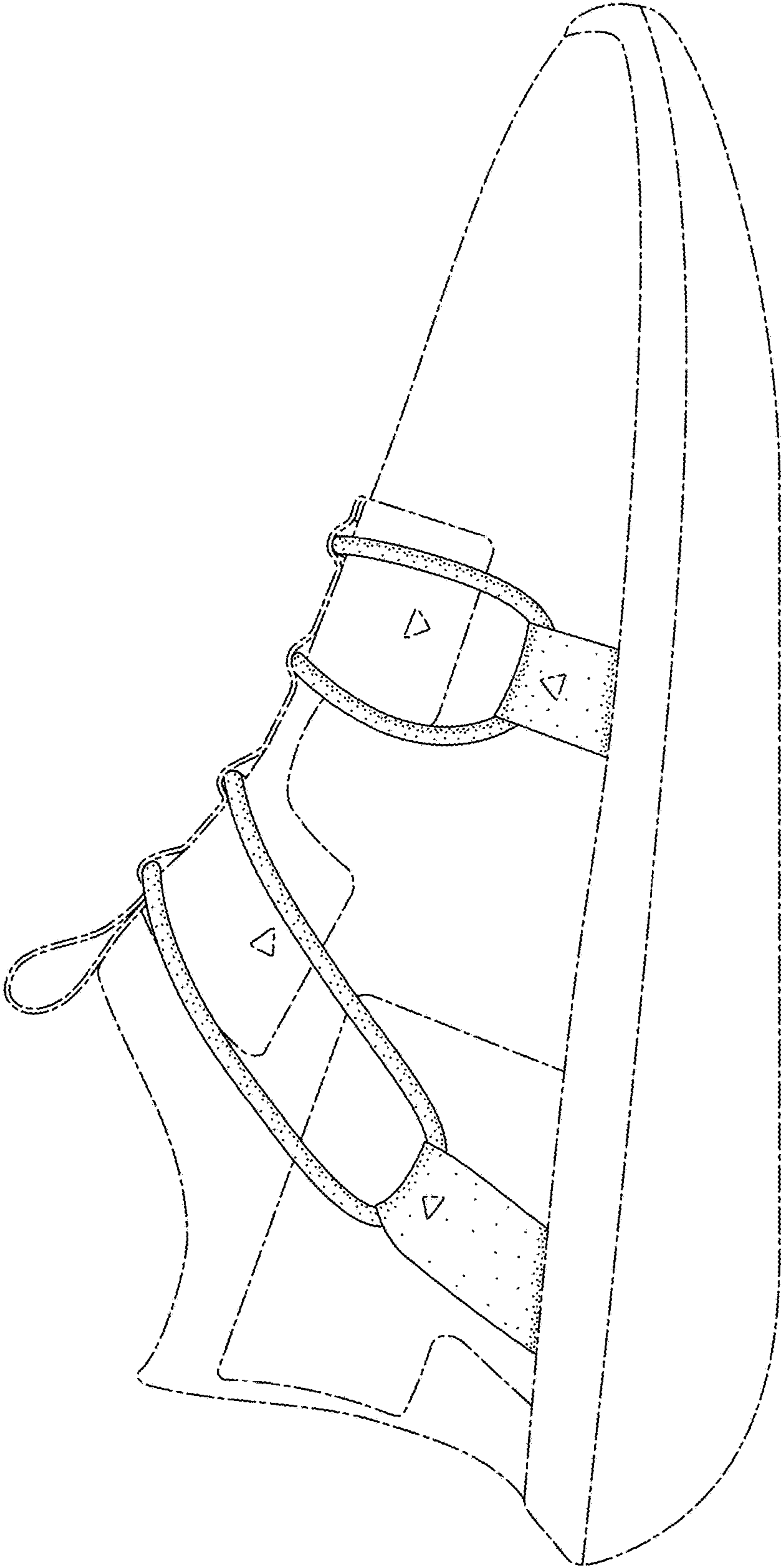

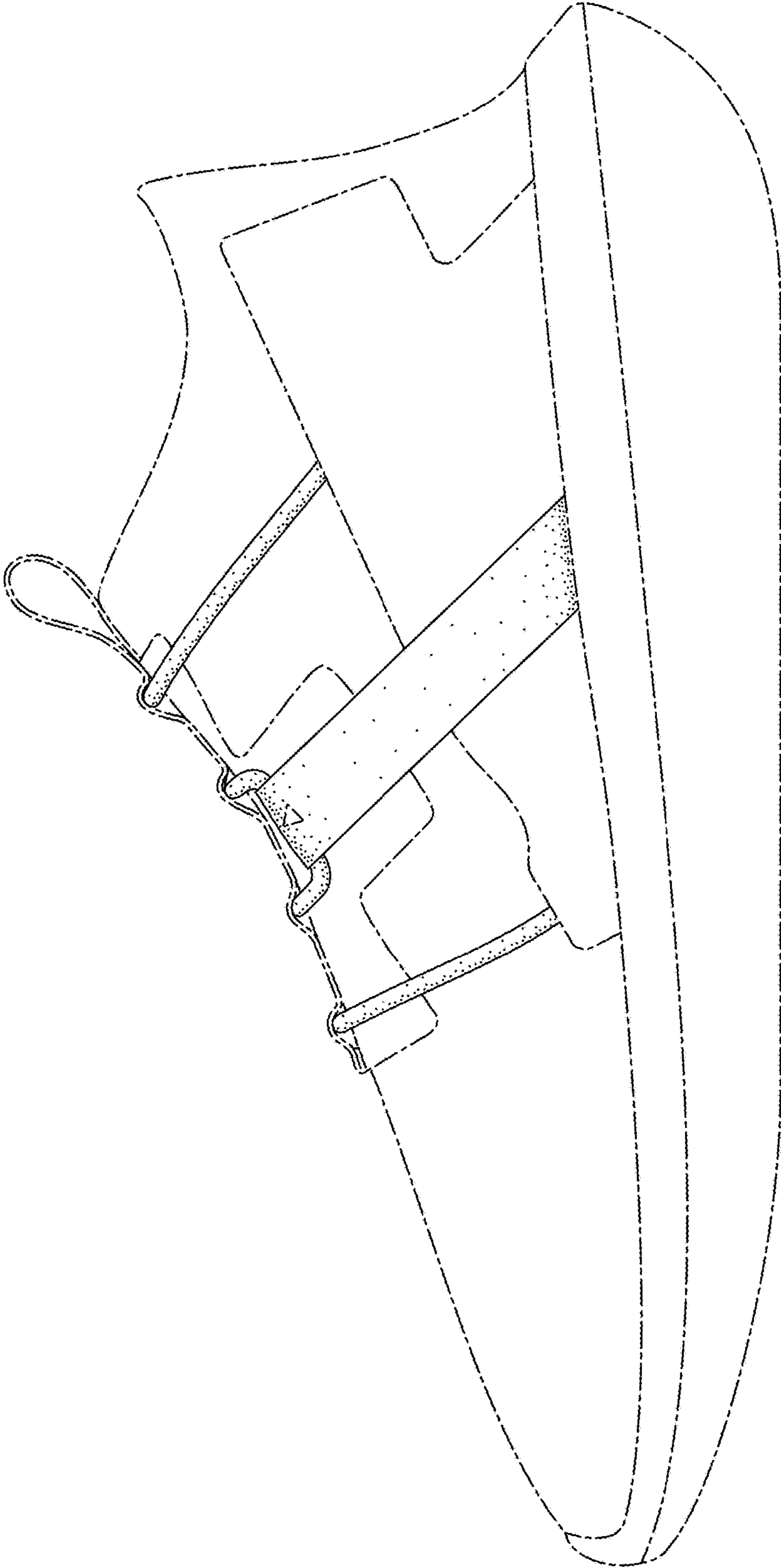

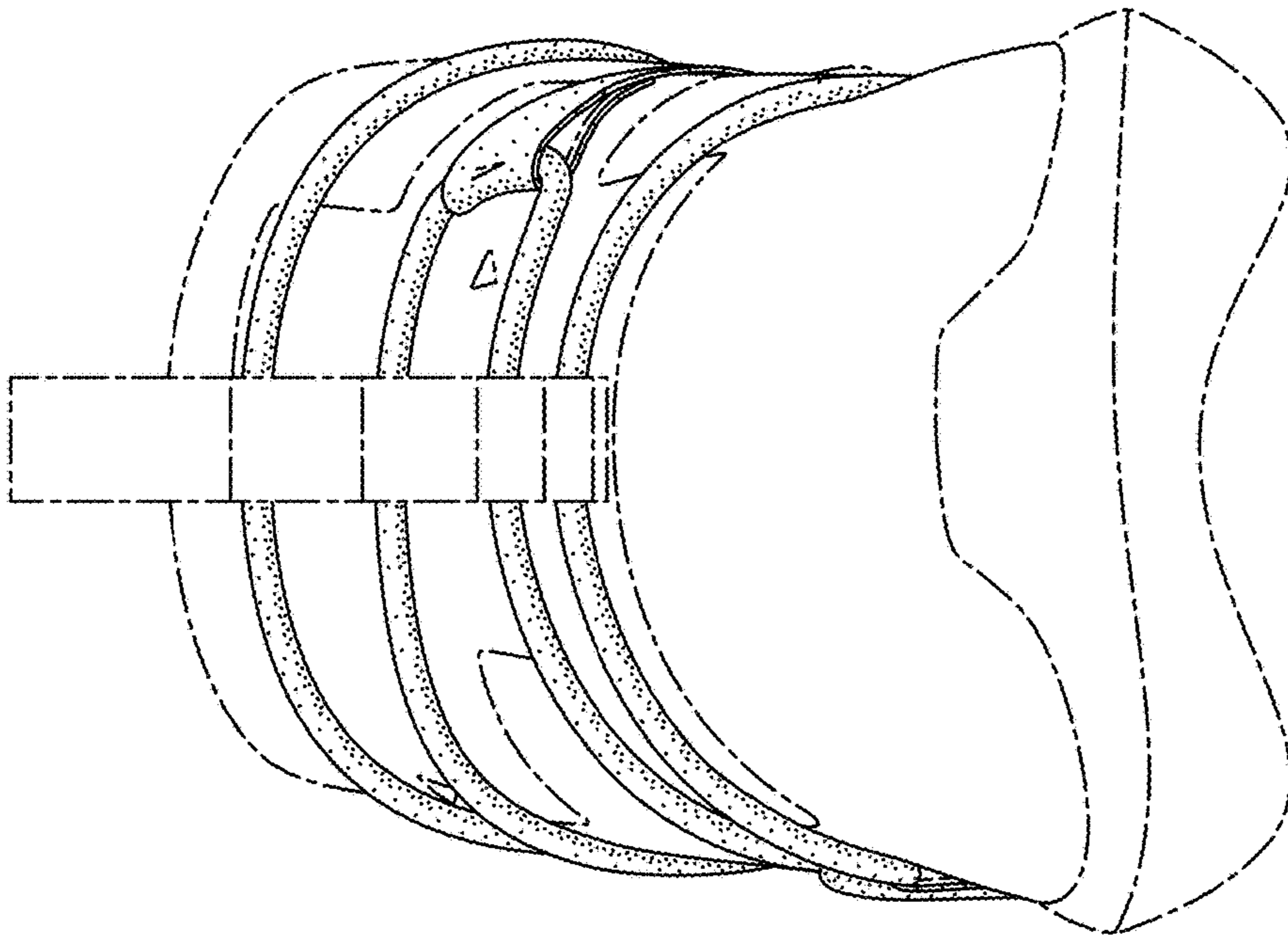

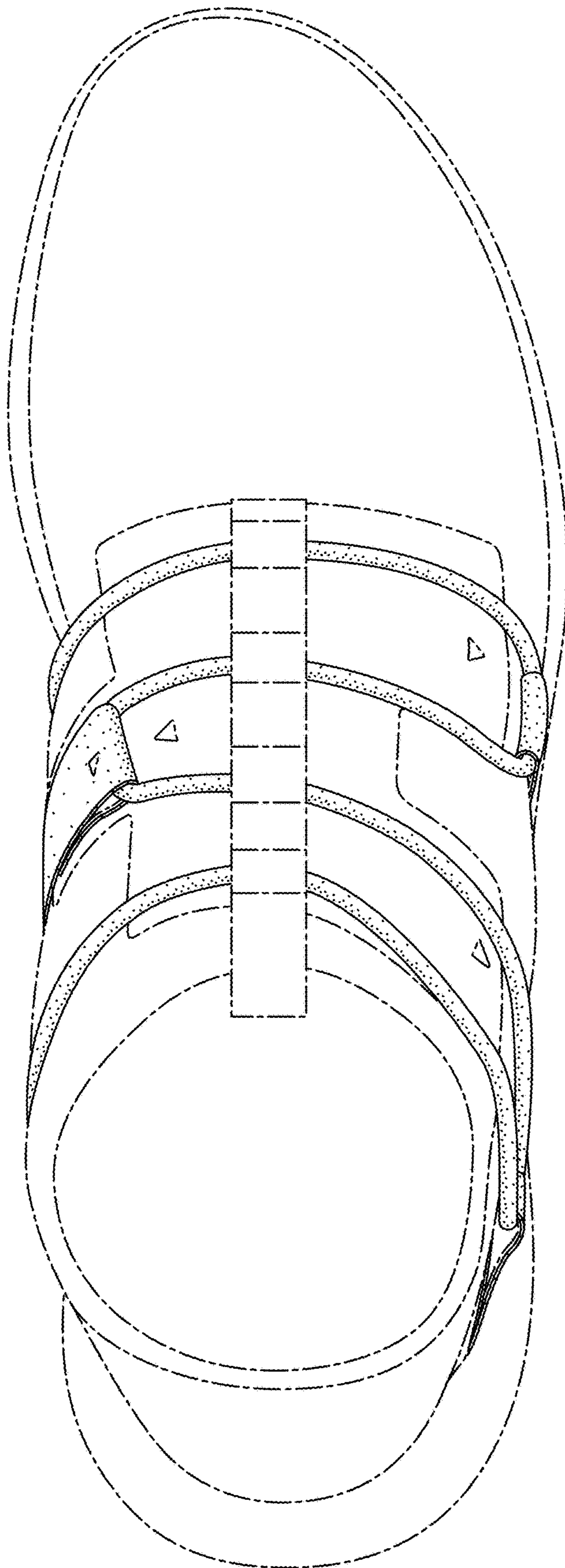

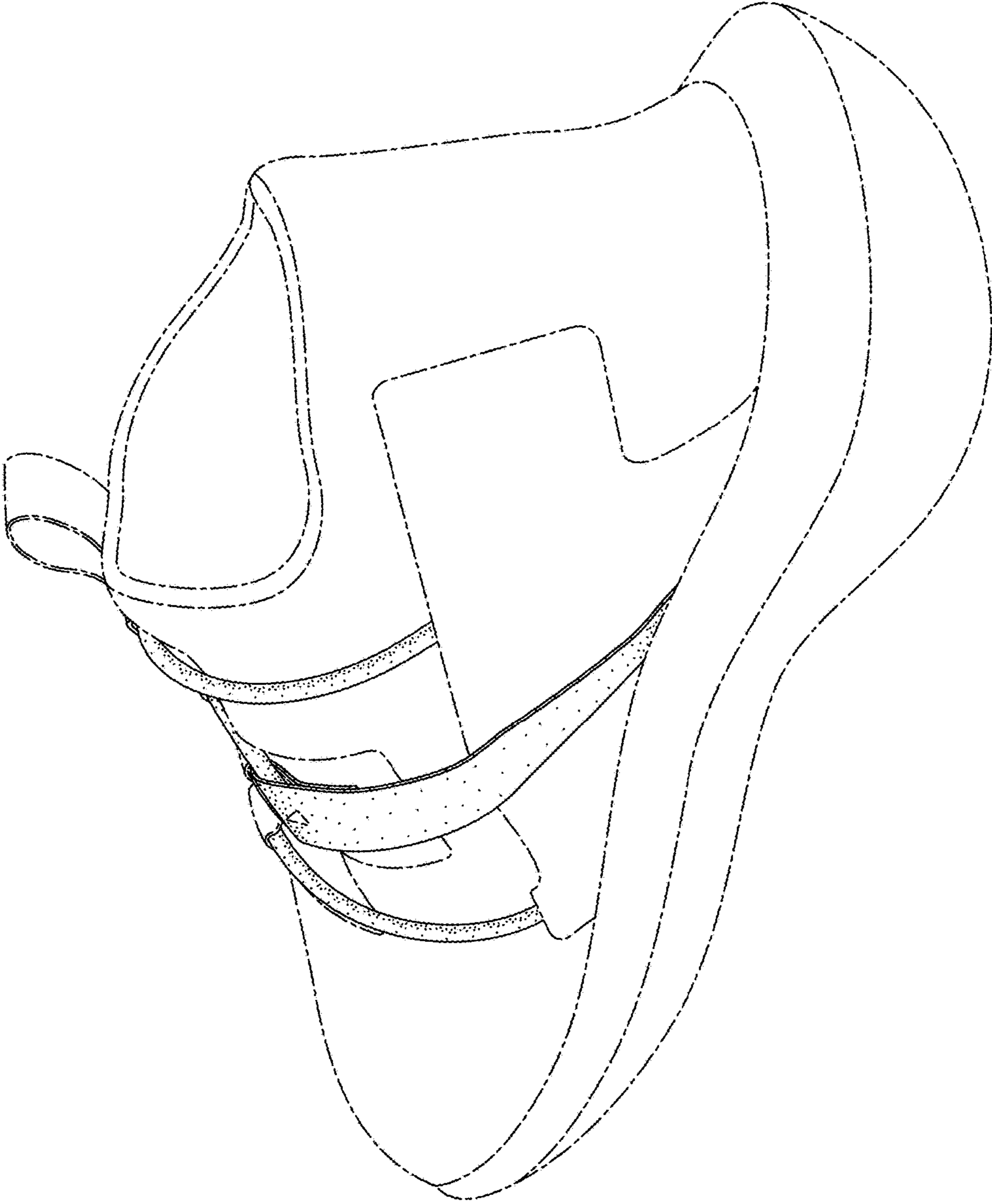
