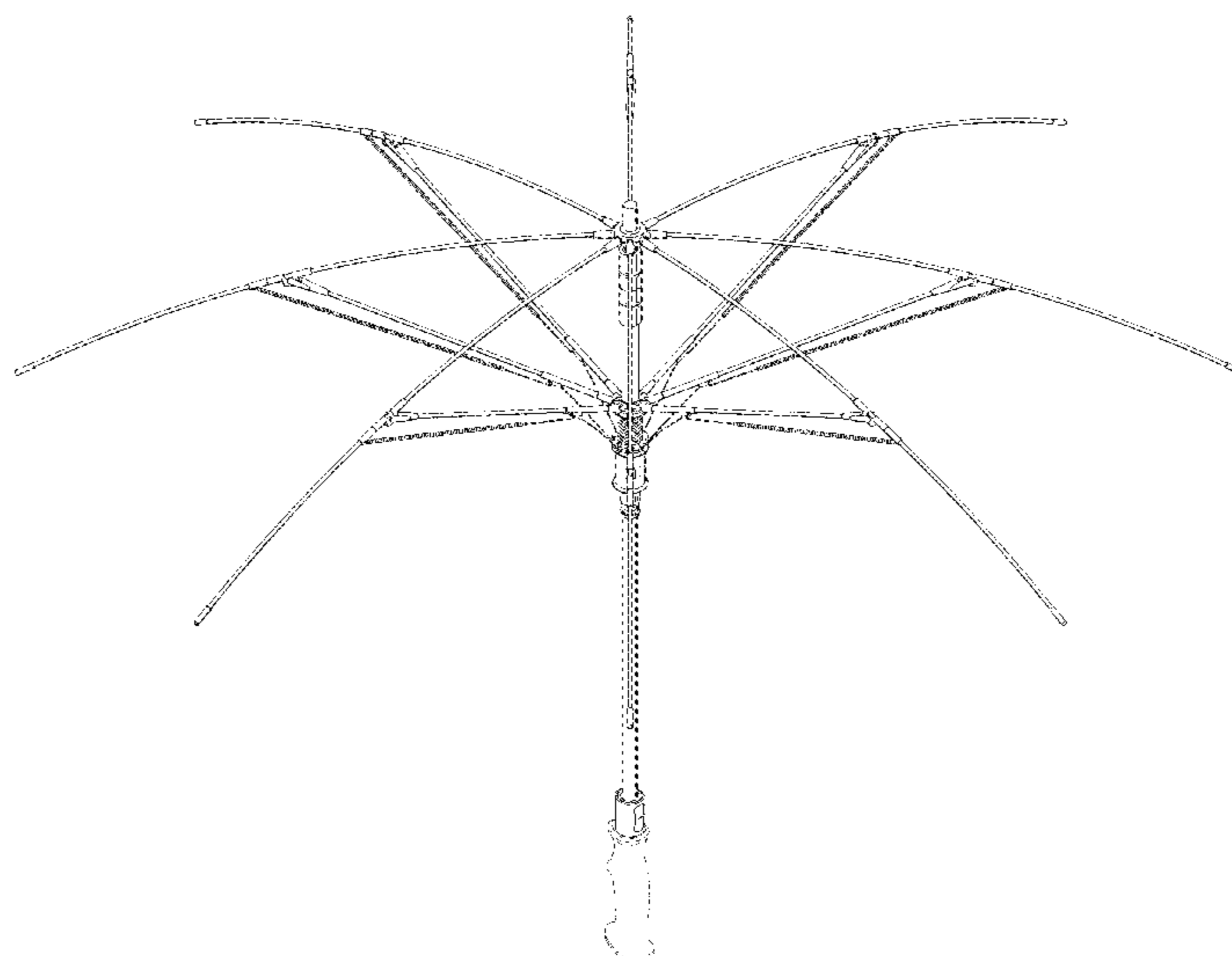

DESCRIPTION

FIG. 1 is a perspective view showing my new design for an umbrella frame of straight umbrella;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a left side elevation view thereof;
FIG. 5 is a right side elevation view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a perspective view of the umbrella frame of straight umbrella, shown in a collapsed position; and,
FIG. 9 is a perspective view of the umbrella frame of straight umbrella, shown in a second collapsed position.

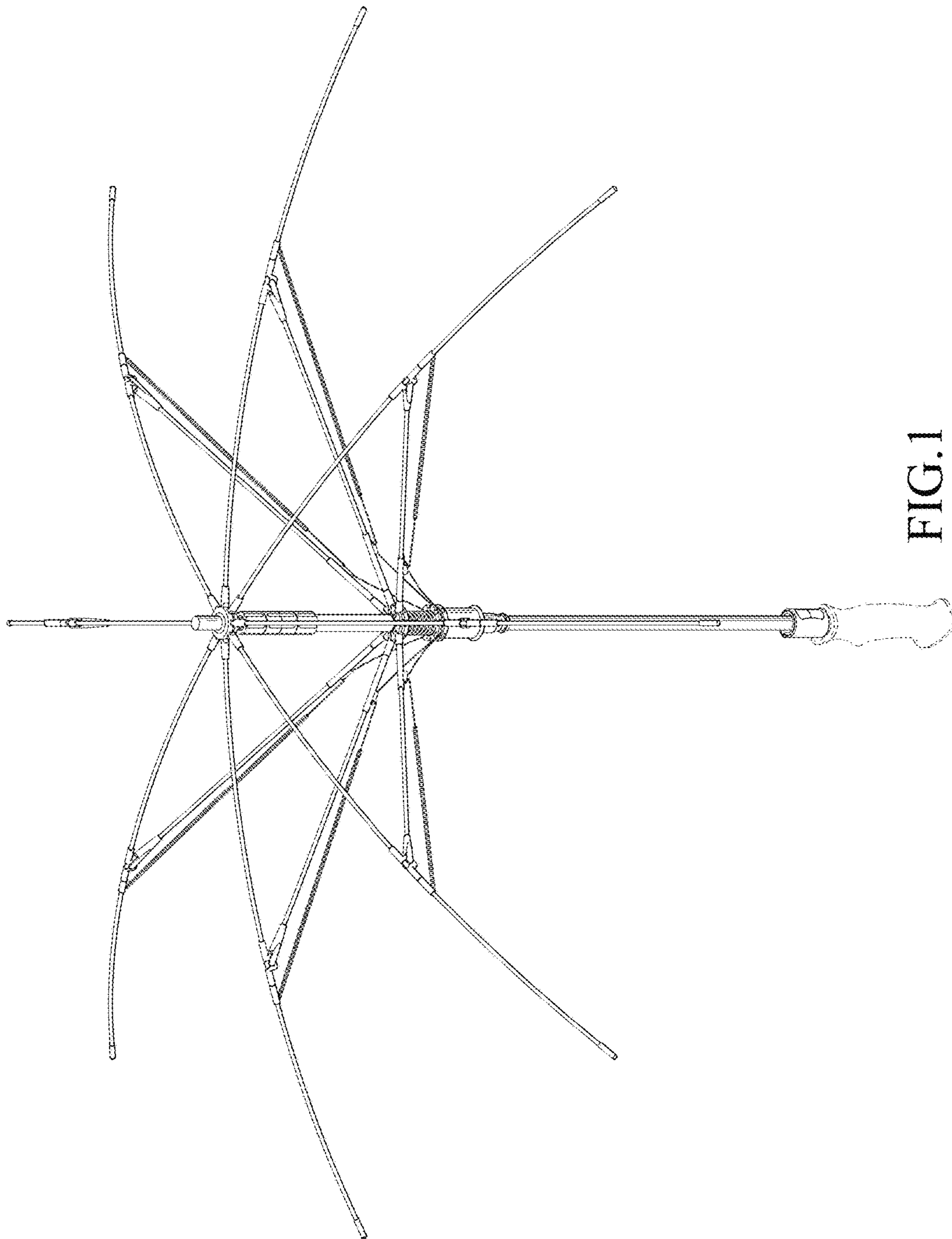

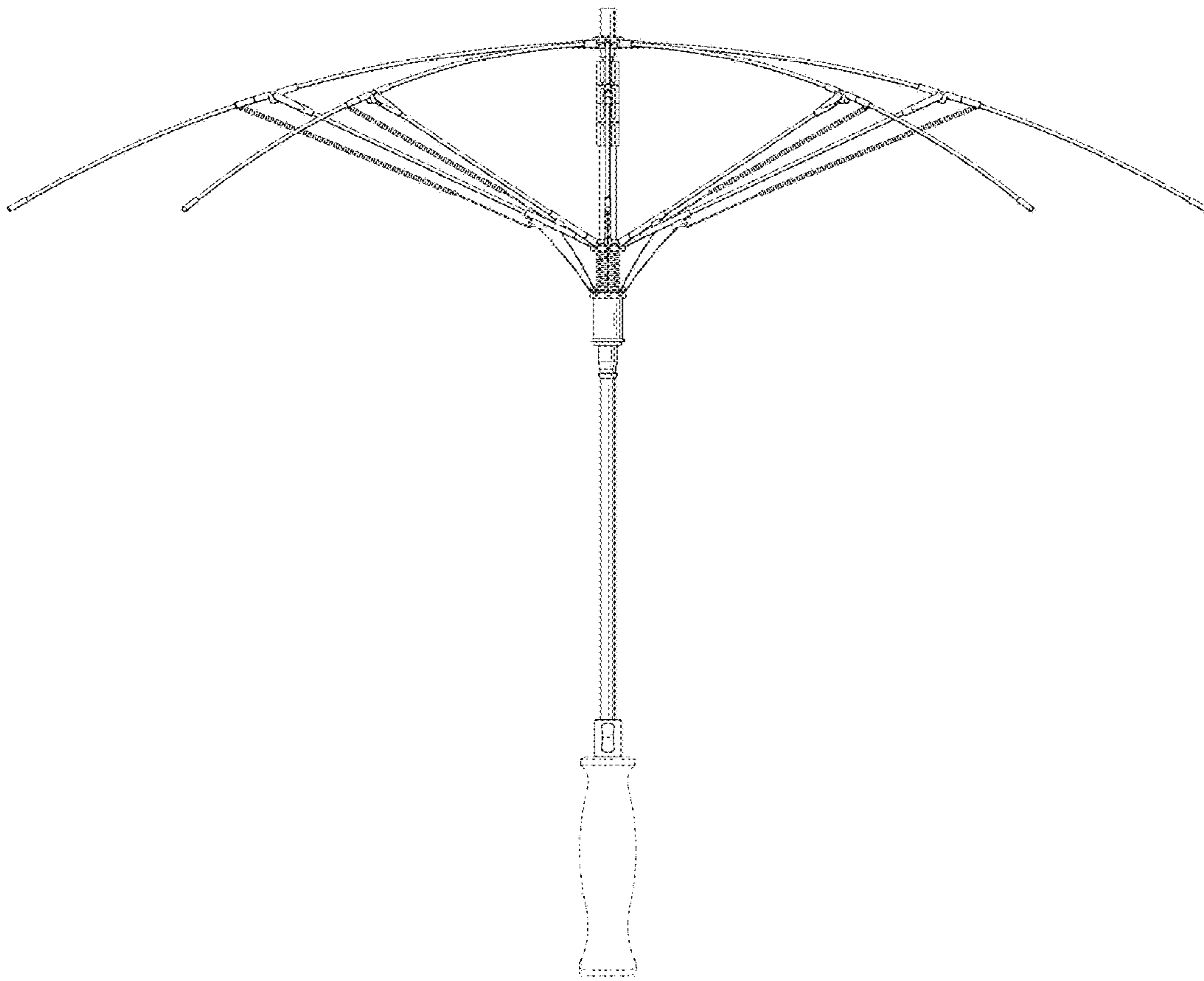

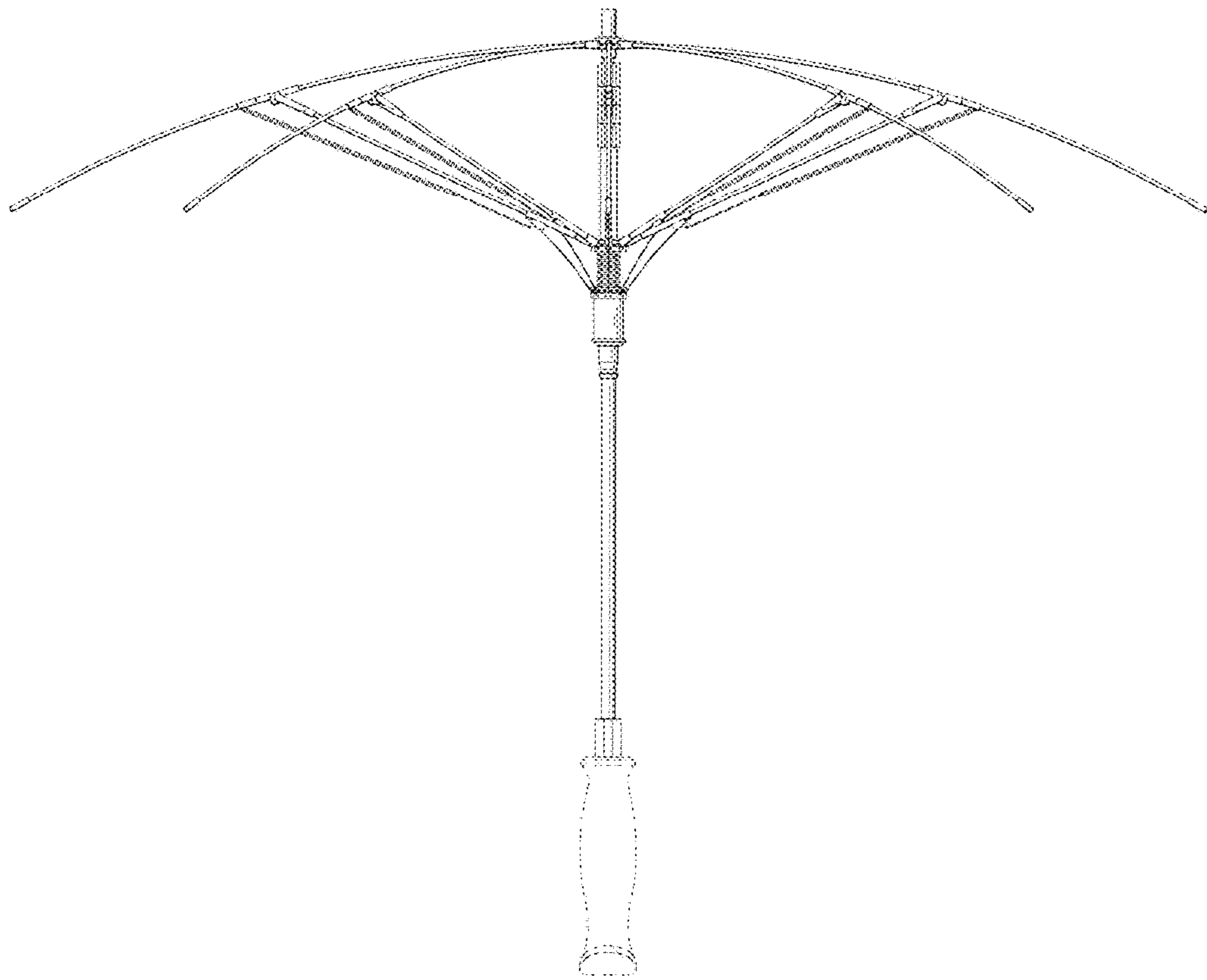

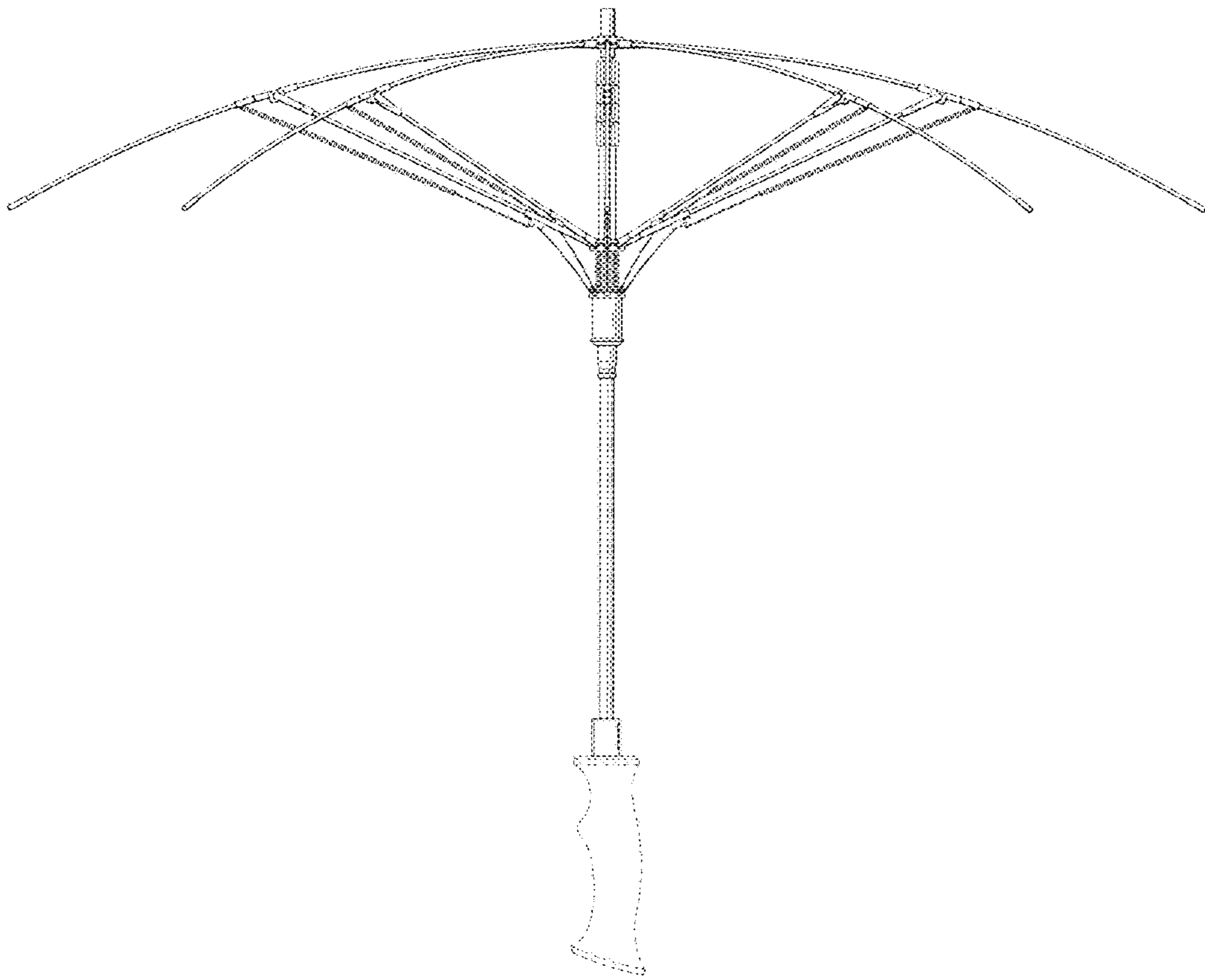

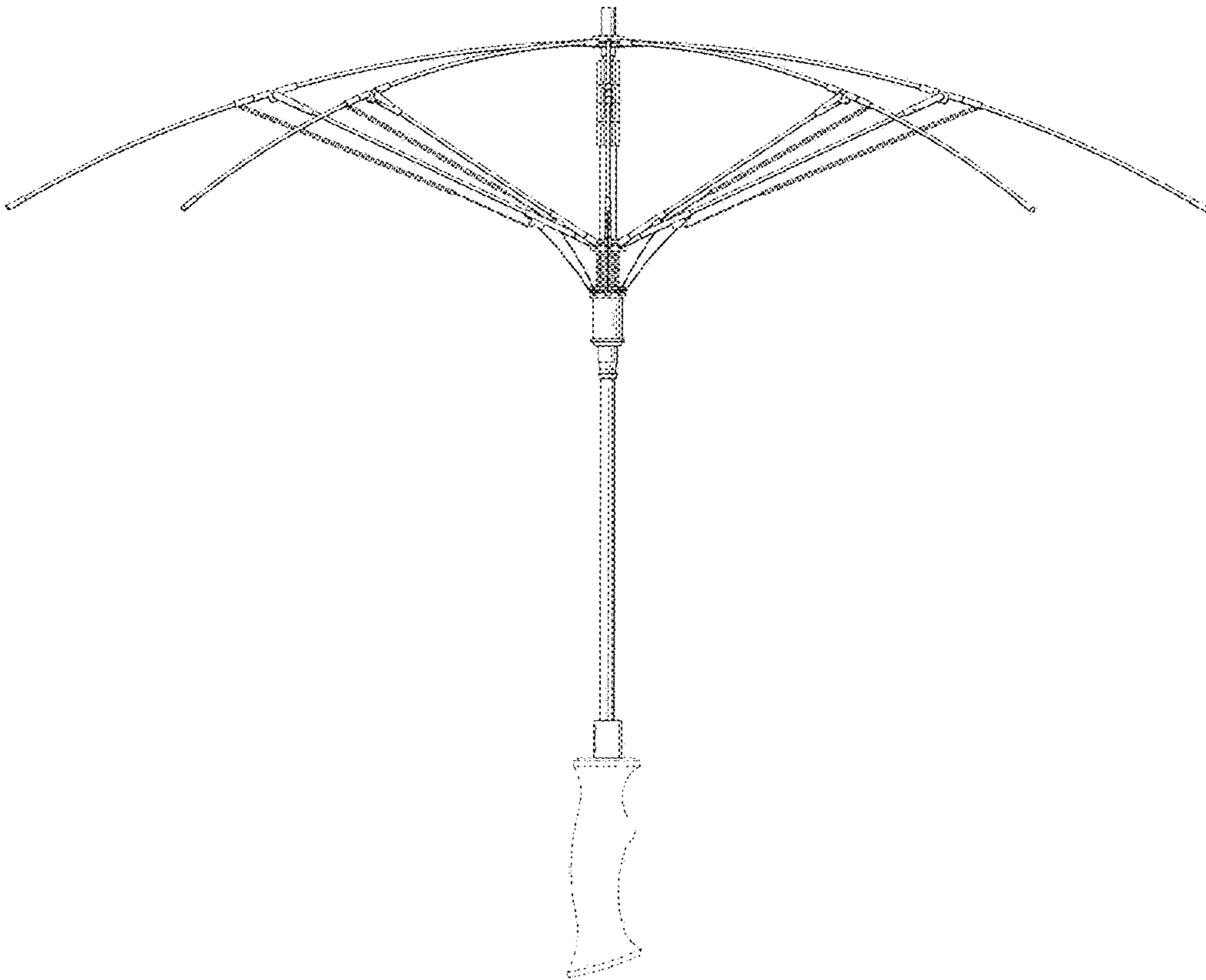

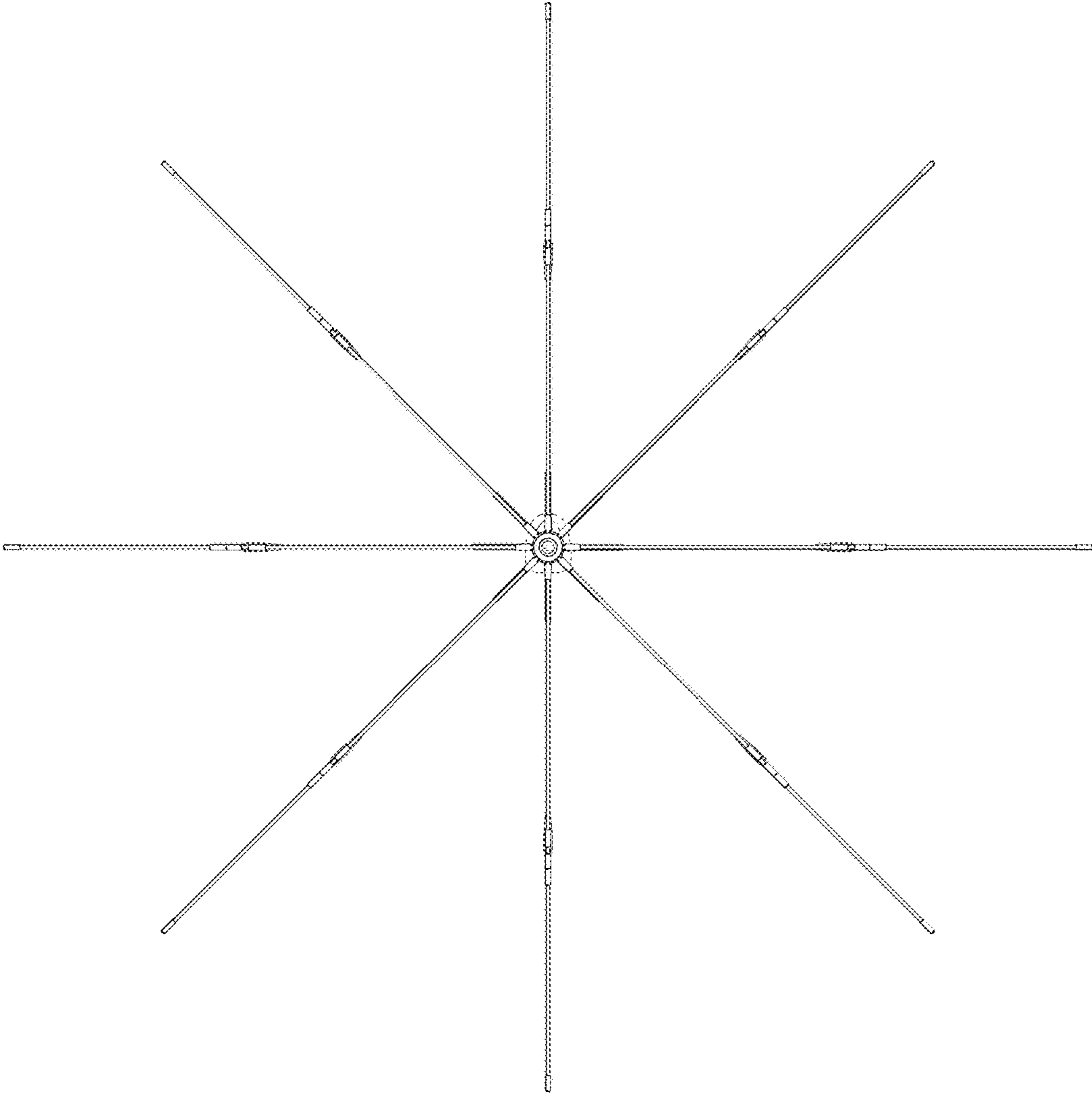

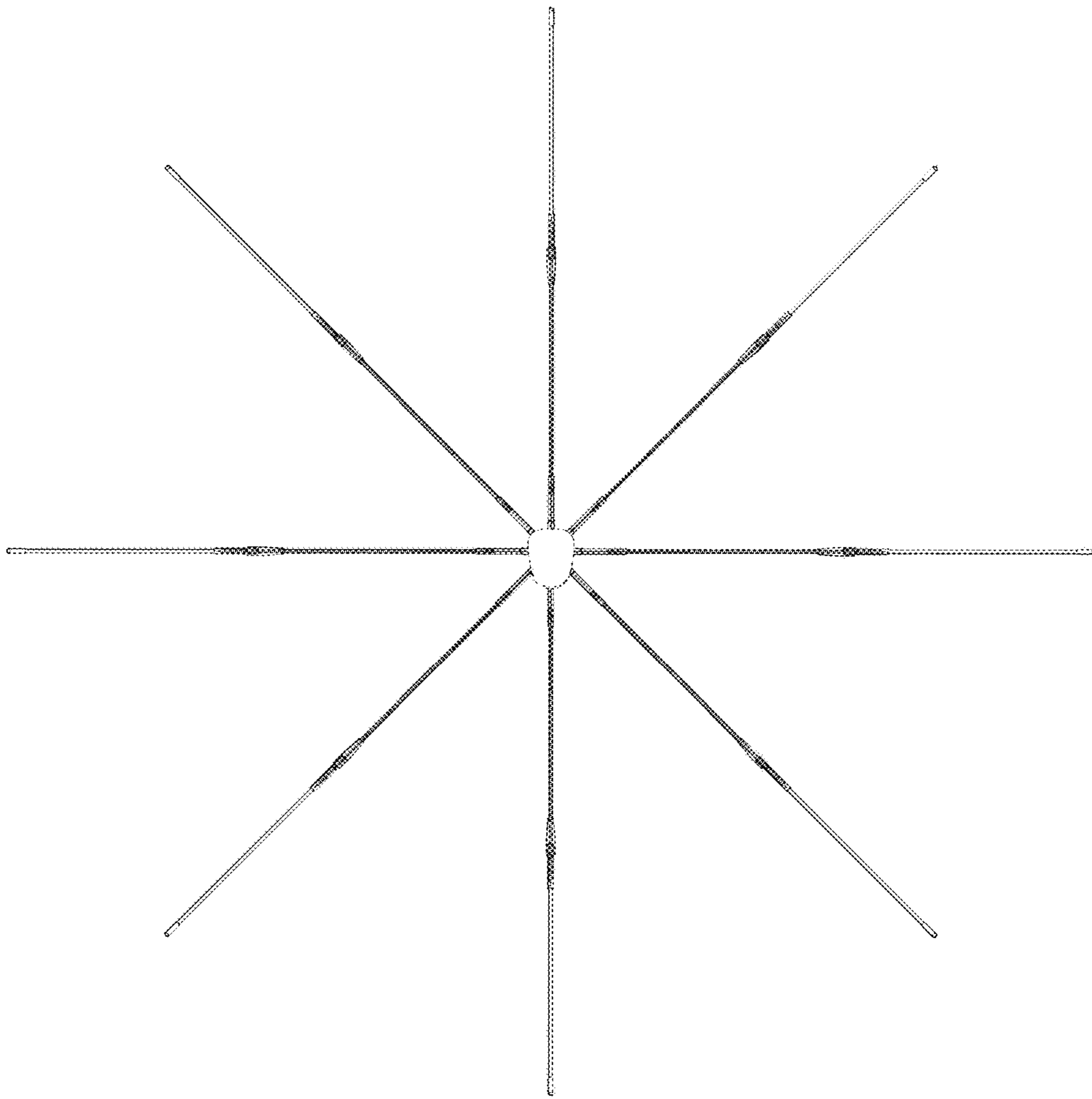

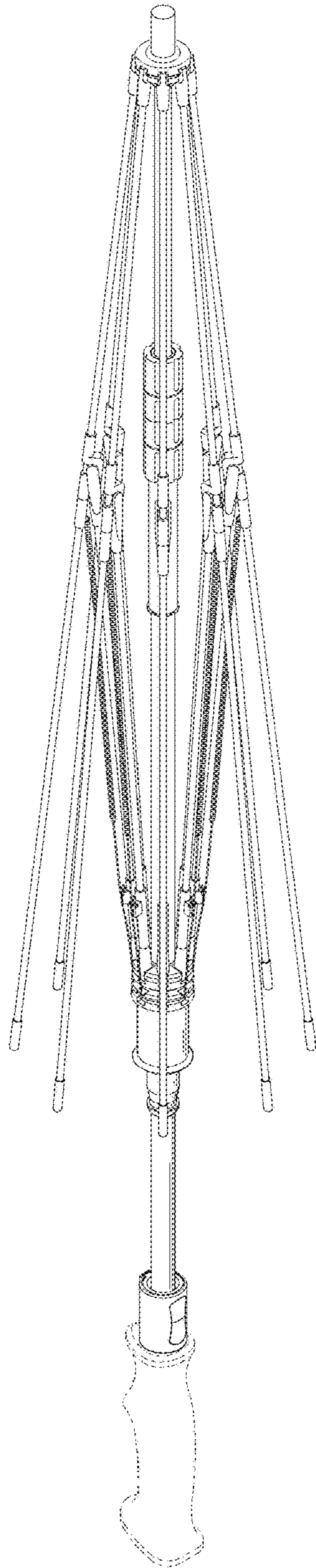

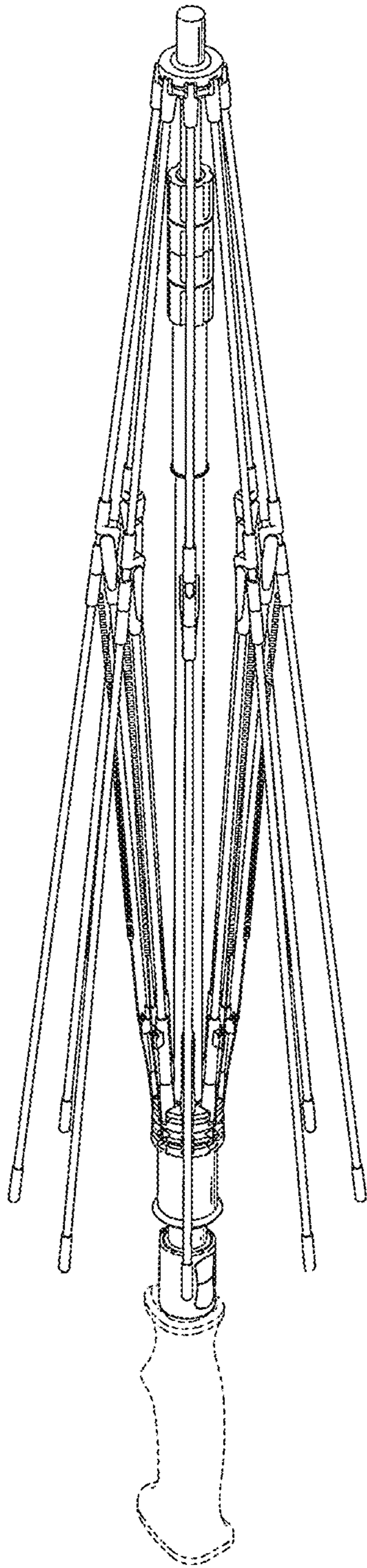
