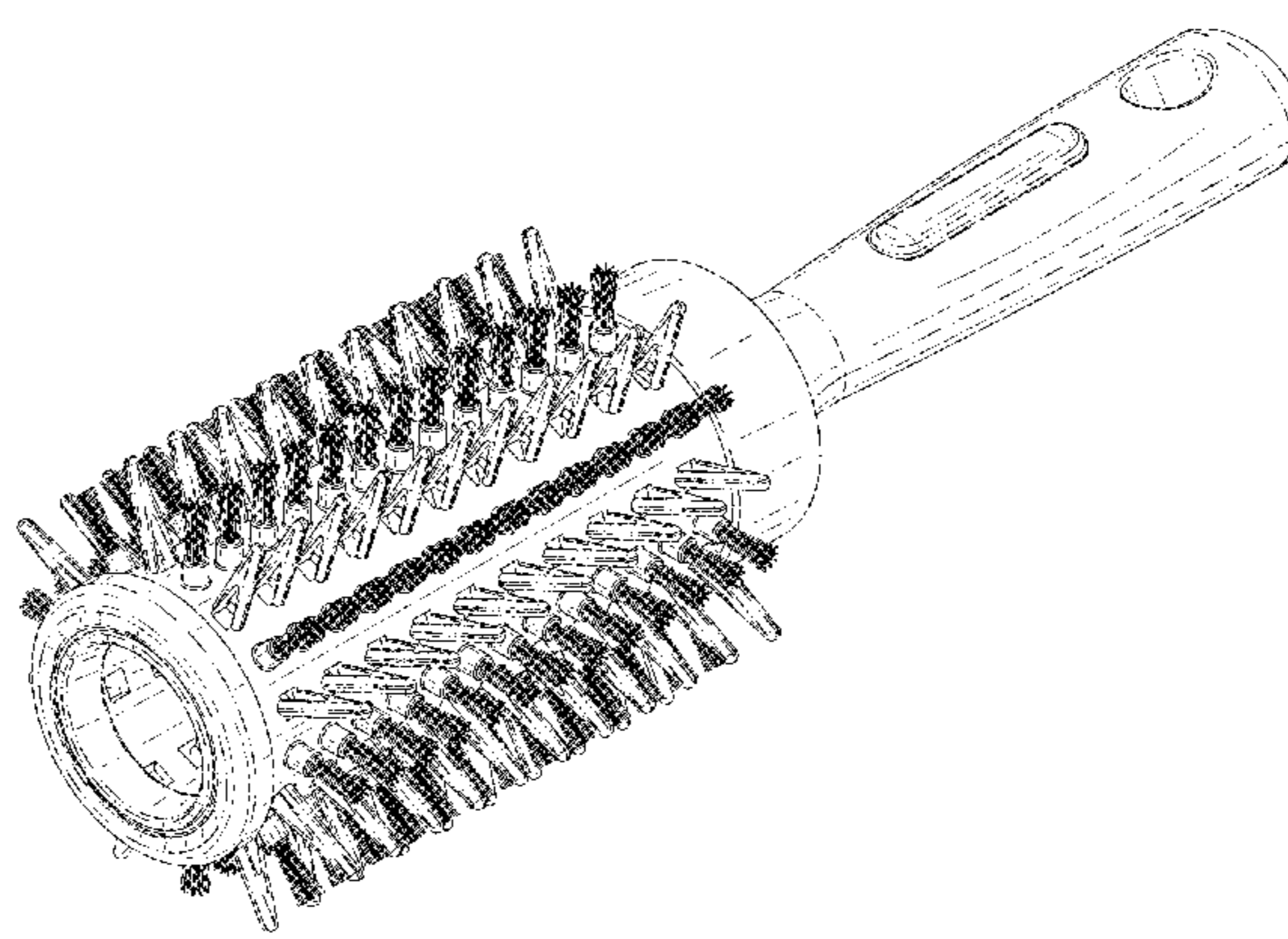
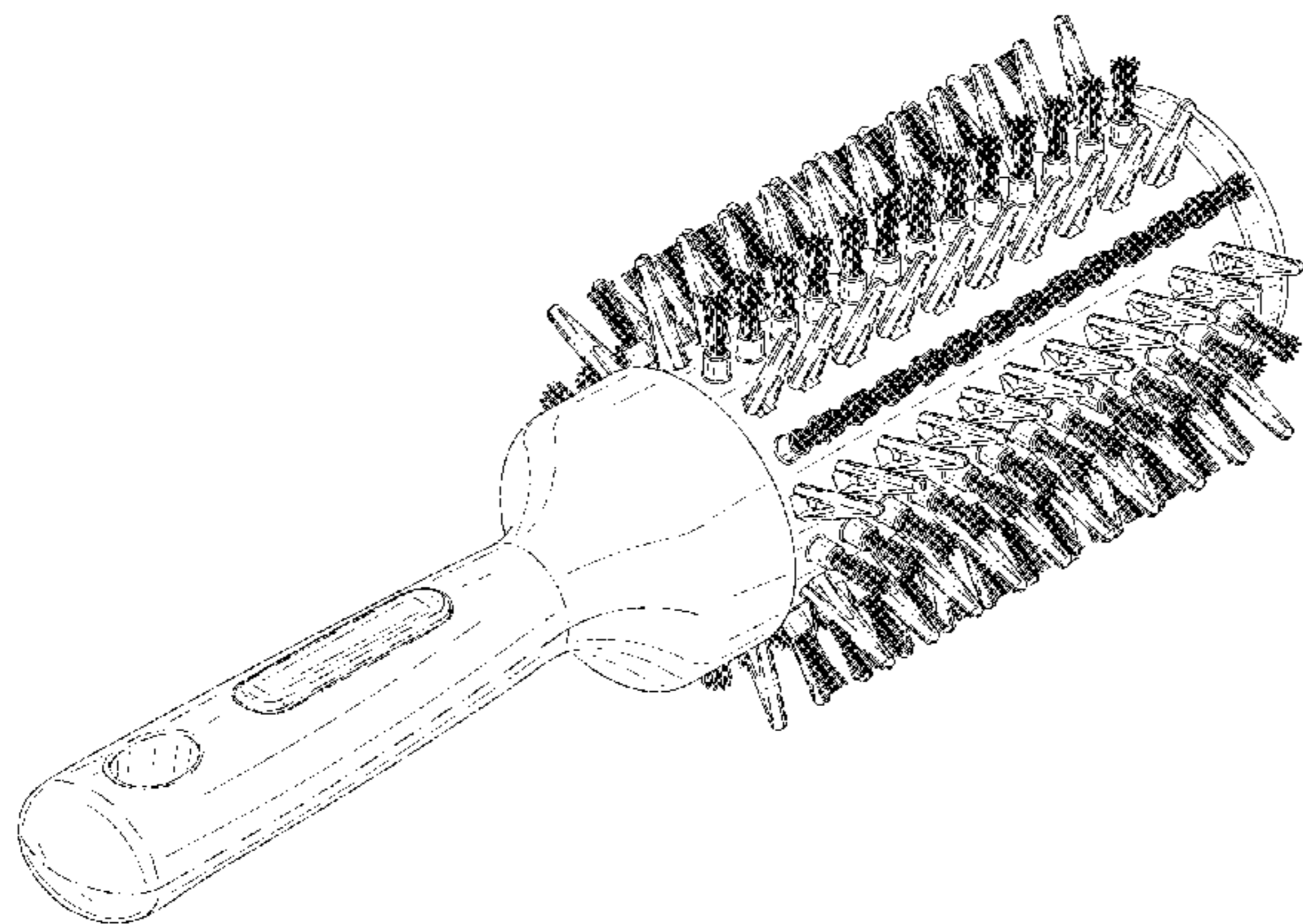
(57) **CLAIM**

The ornamental design for a hair brush, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom front perspective view of a new design for a hair brush according to the present invention;  
FIG. 2 is a top front perspective view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a first side elevational view thereof, wherein a second side elevational view is identical to and opposite of the first side elevational view;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.

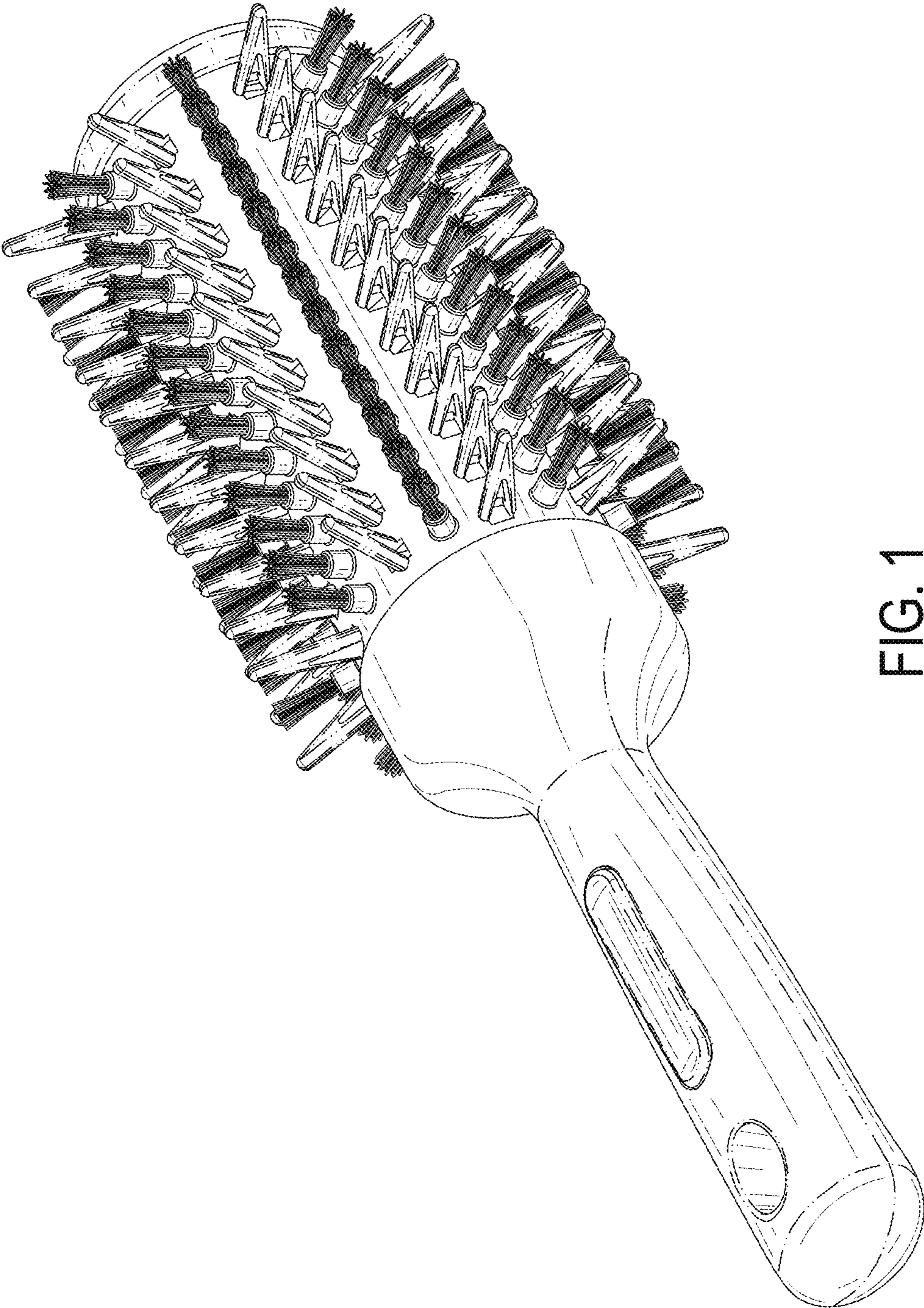

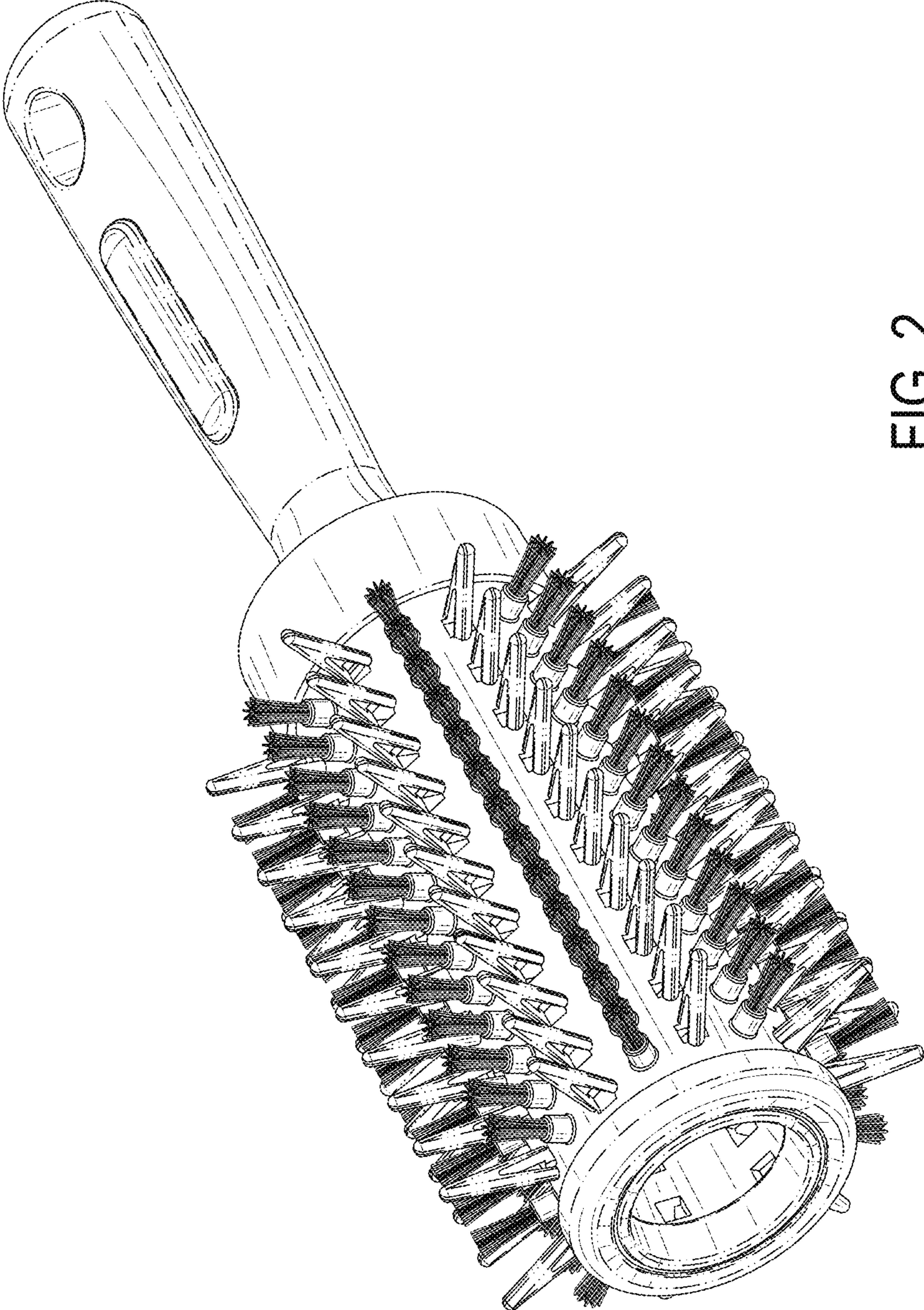

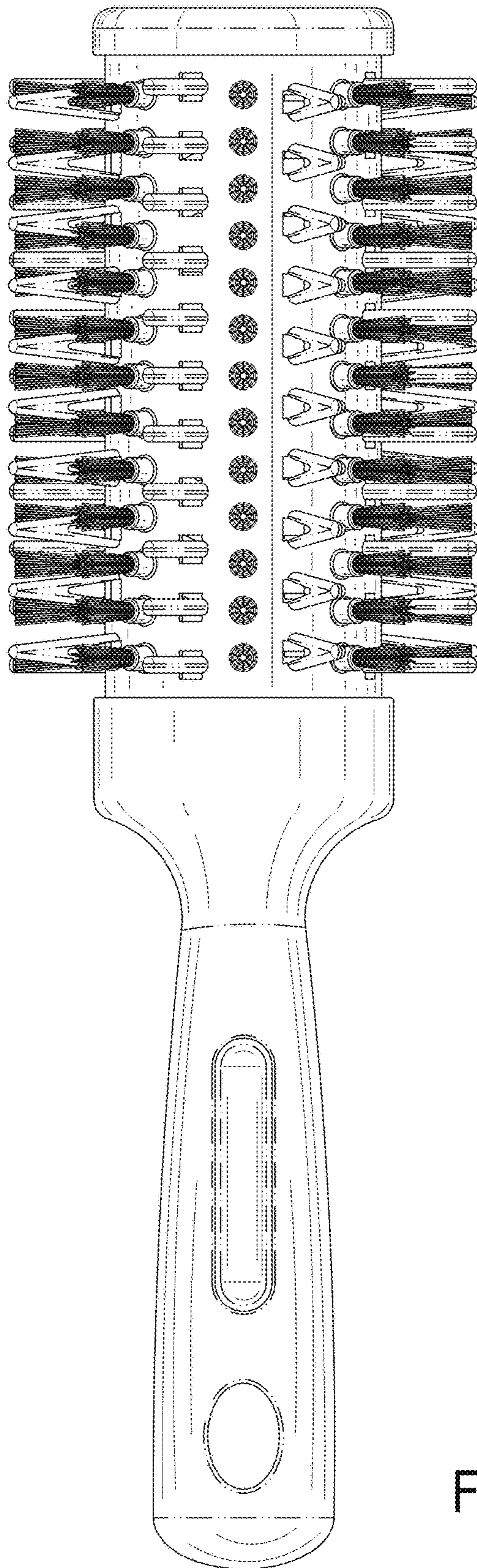

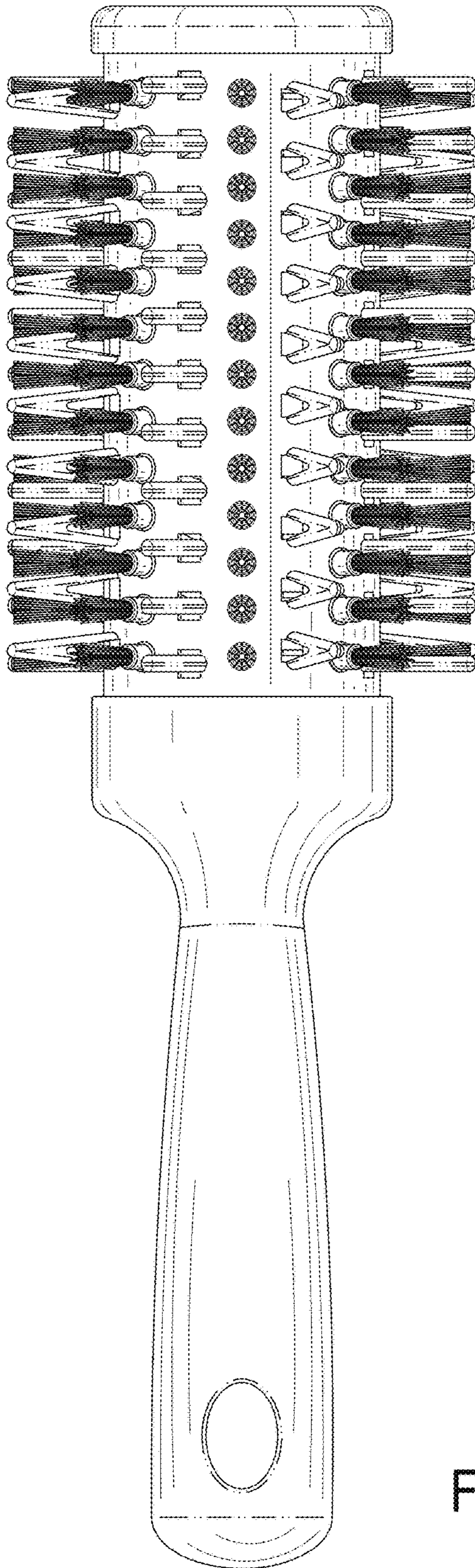

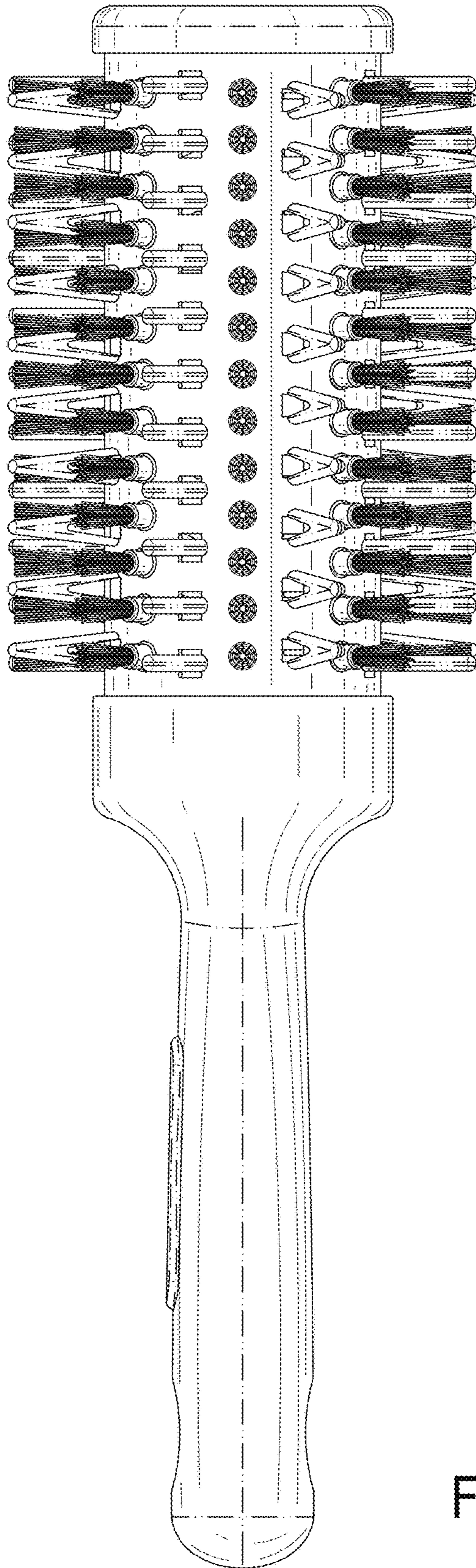

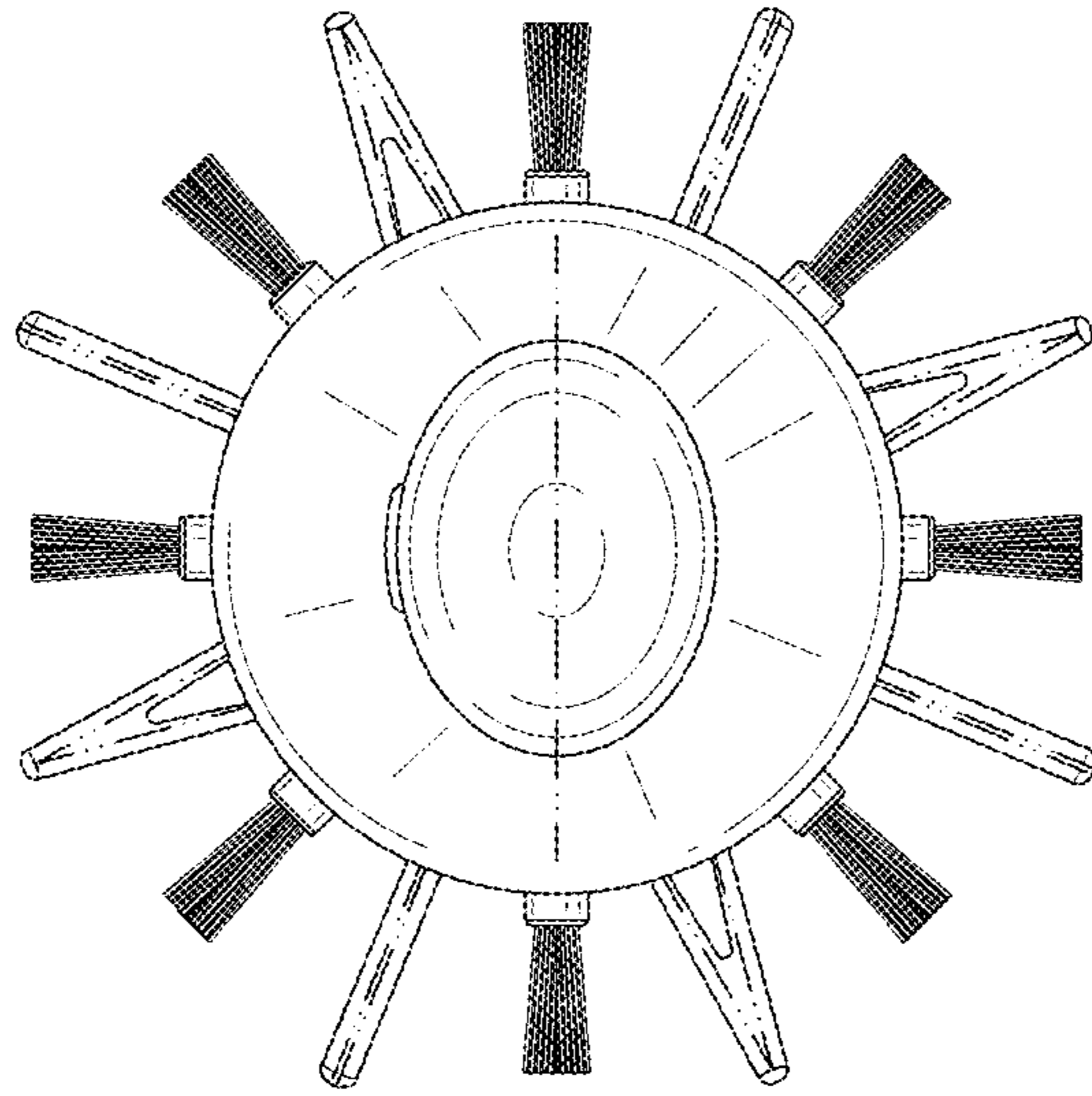

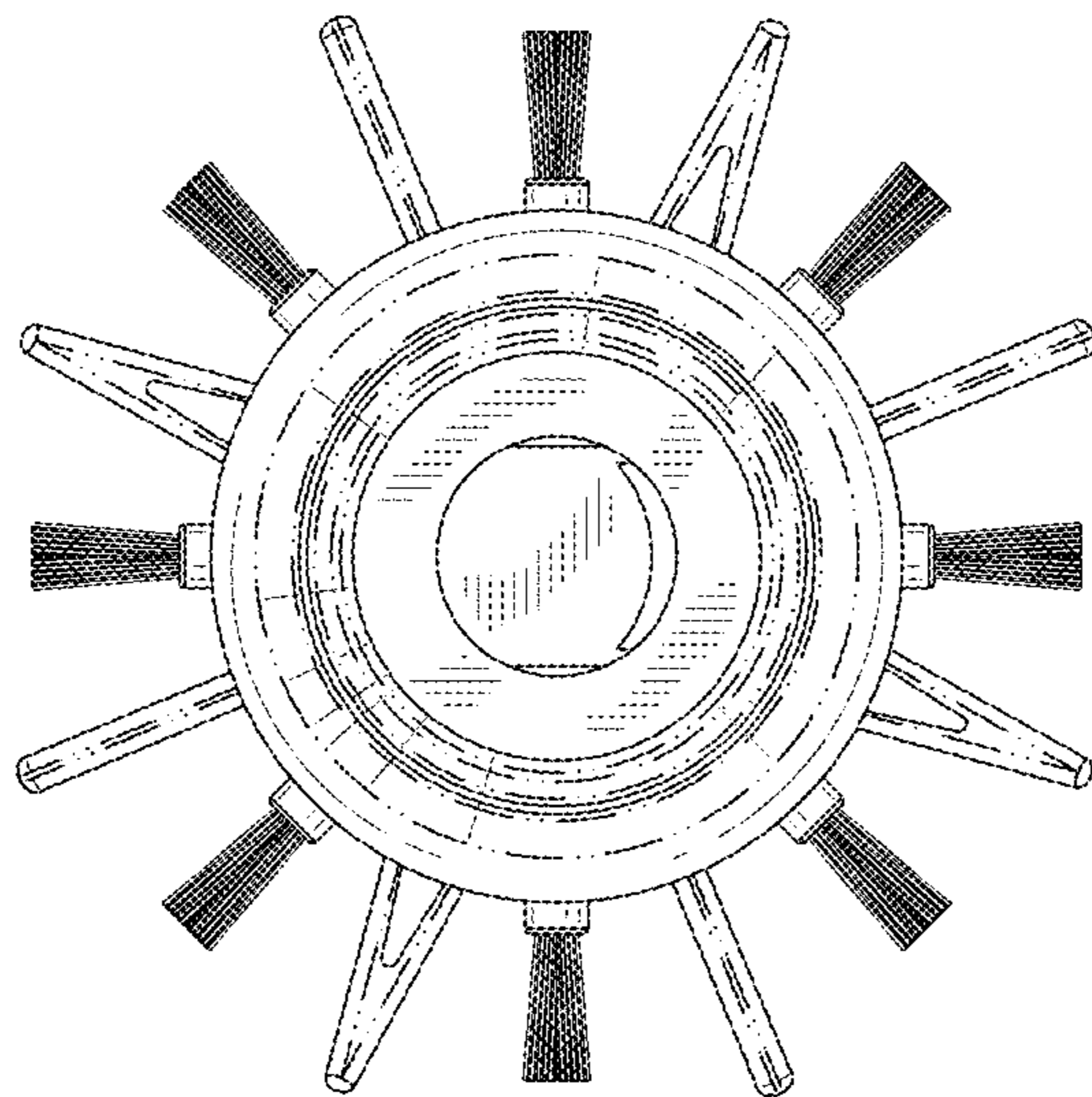
