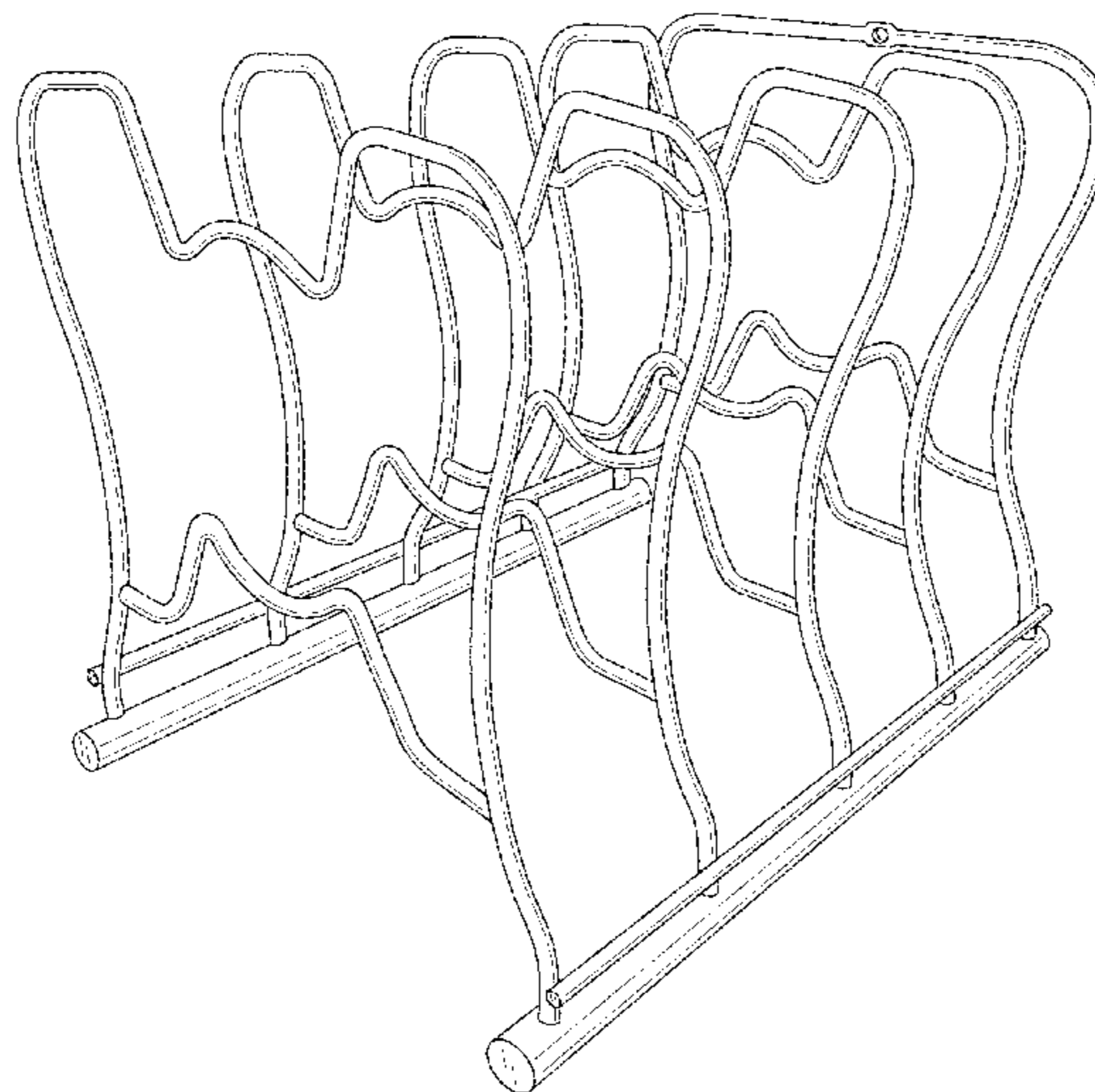
(57) **CLAIM**

The ornamental design for a kitchen utility rack with five vertical dividers, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a kitchen utility rack with five vertical dividers showing my new design;
 FIG. 2 is a front view thereof;
 FIG. 3 is a rear view thereof;
 FIG. 4 is a left side view thereof, the right side view being a mirror image;
 FIG. 5 is a top view thereof; and,

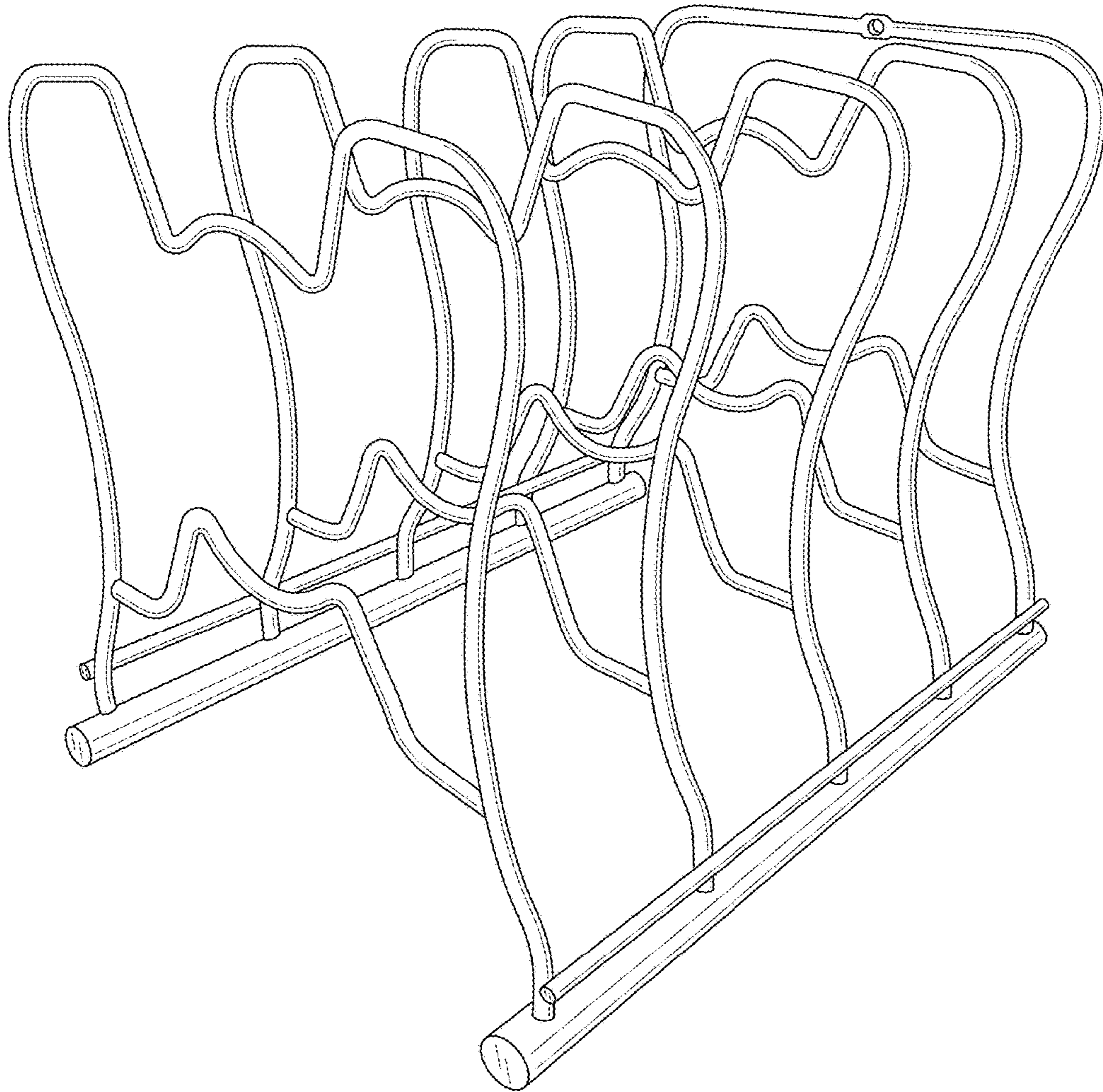

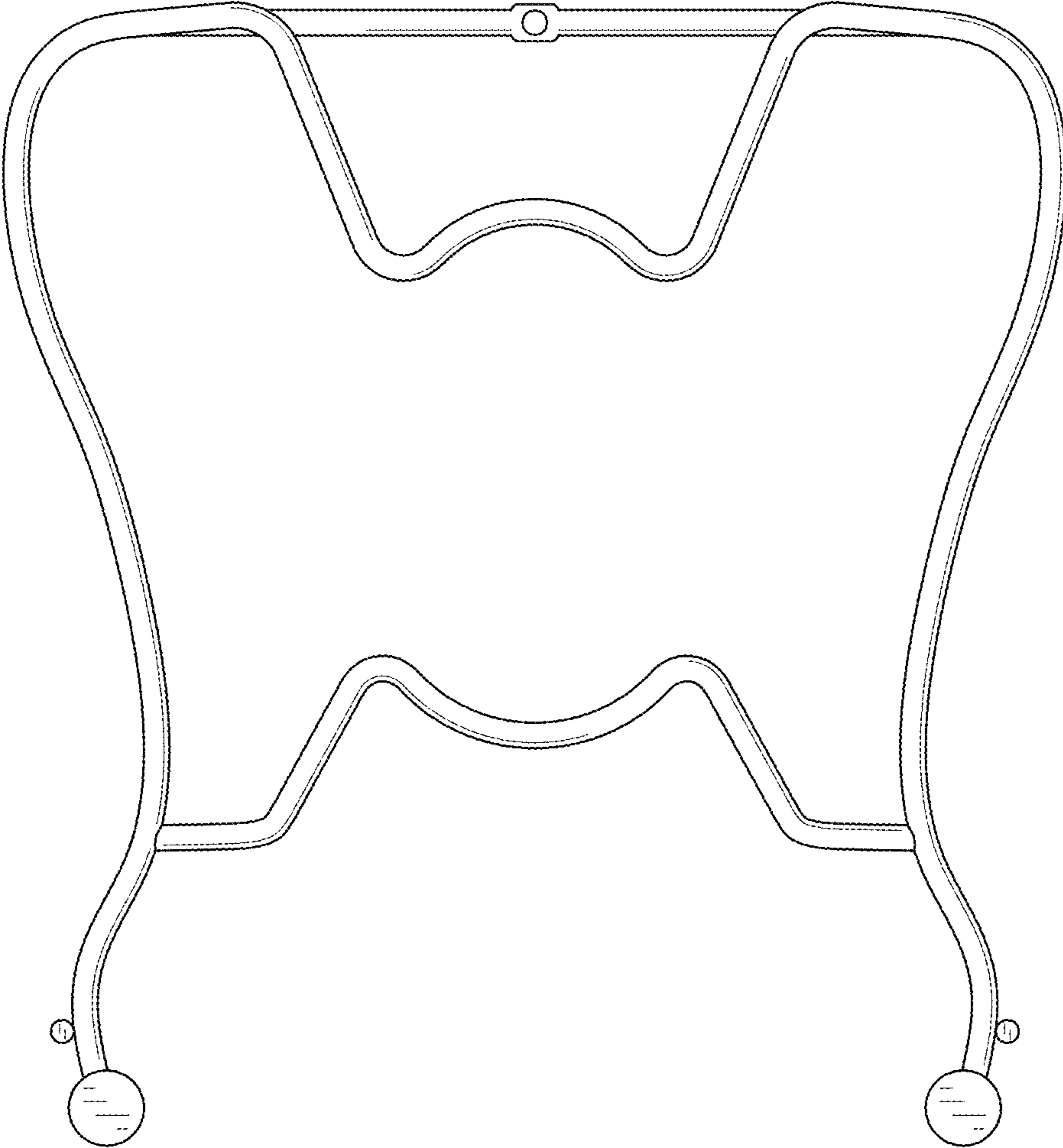

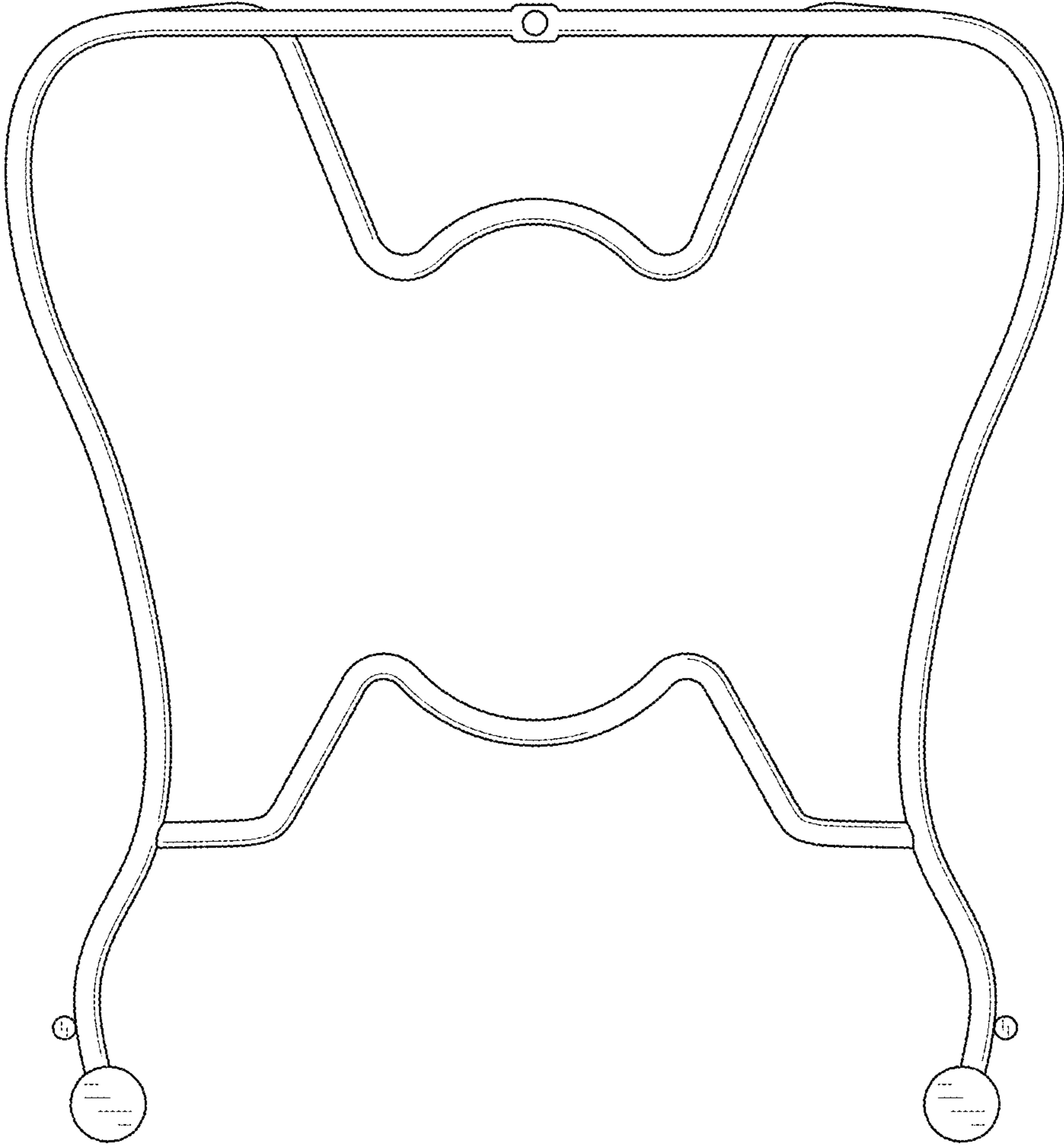

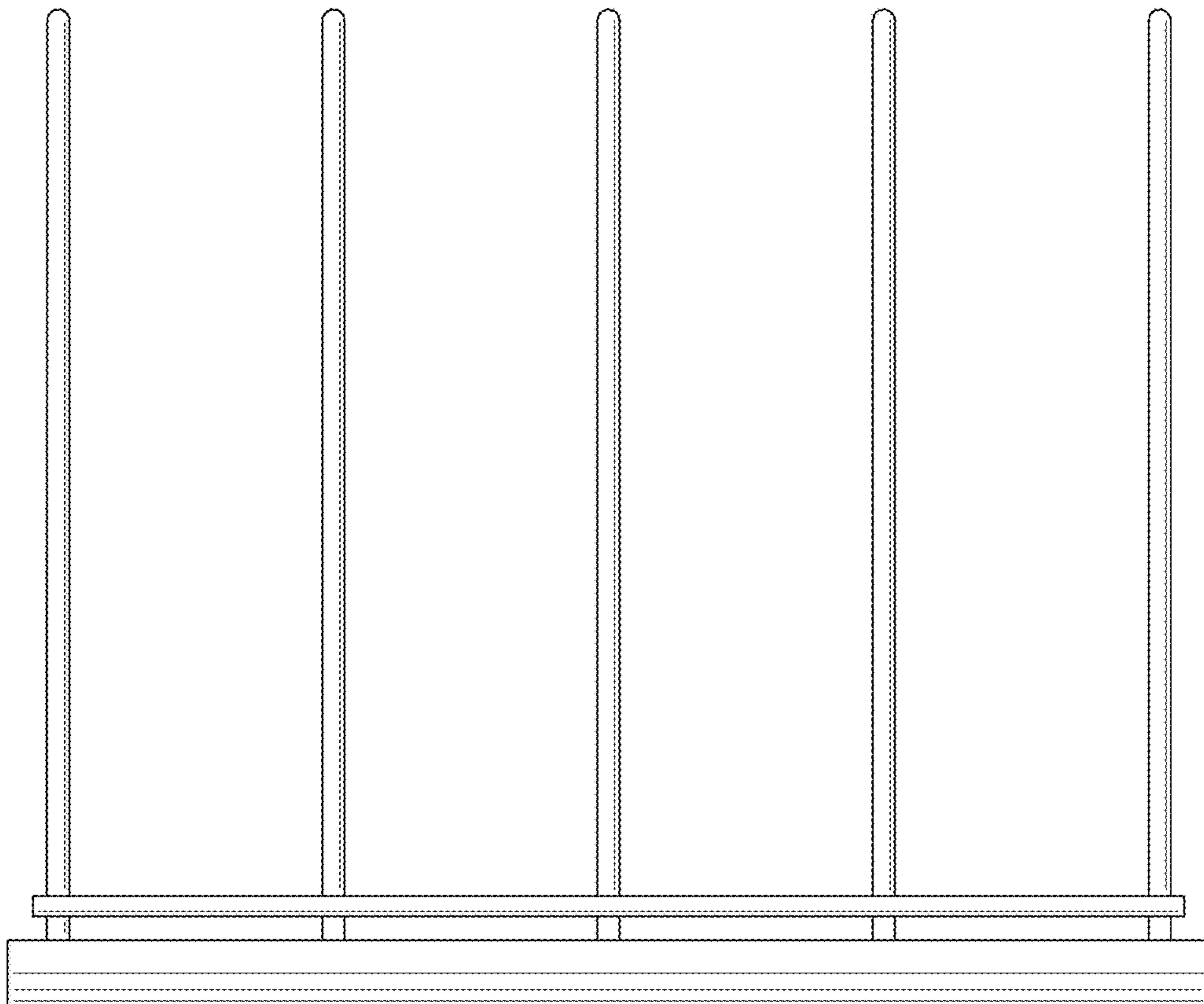

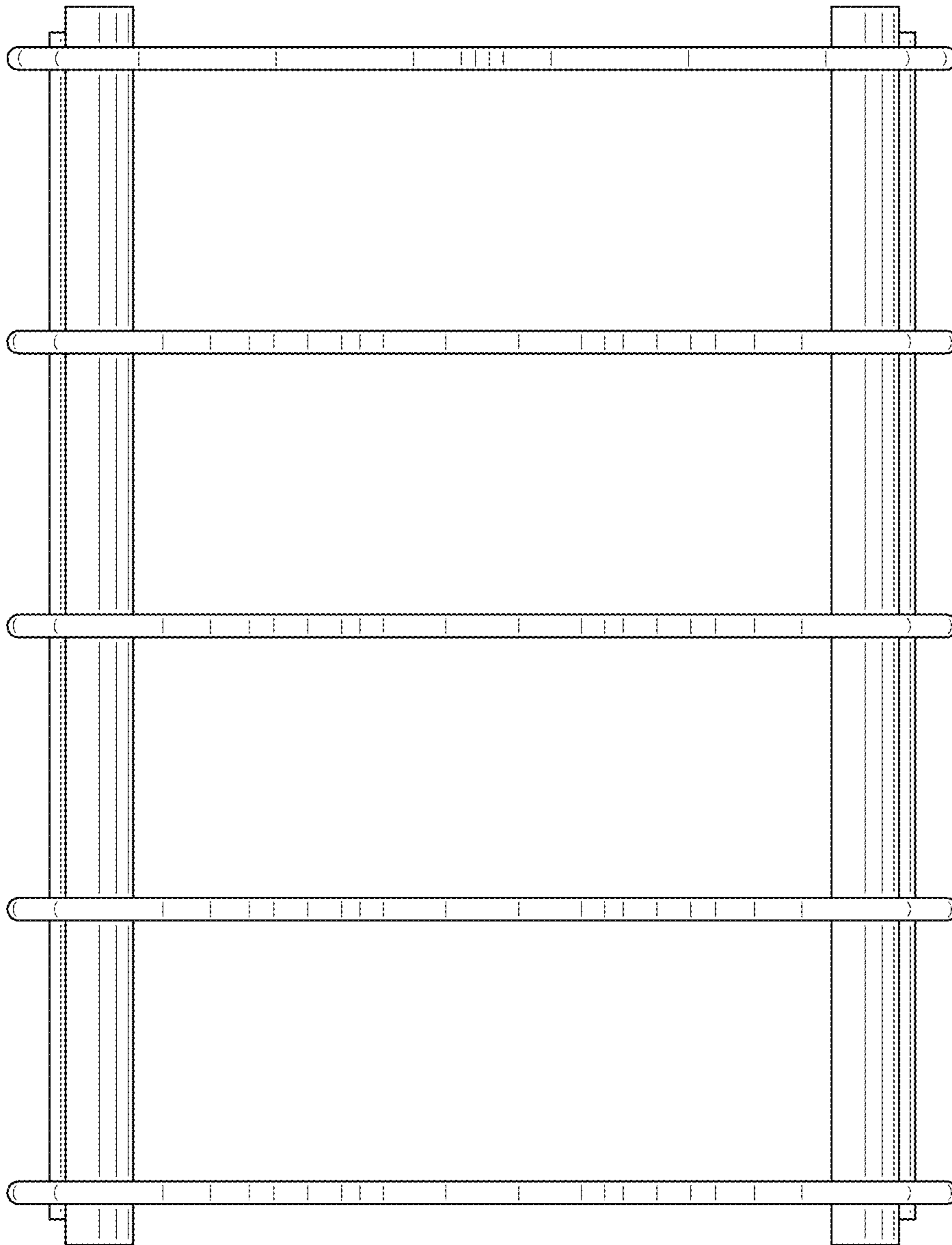

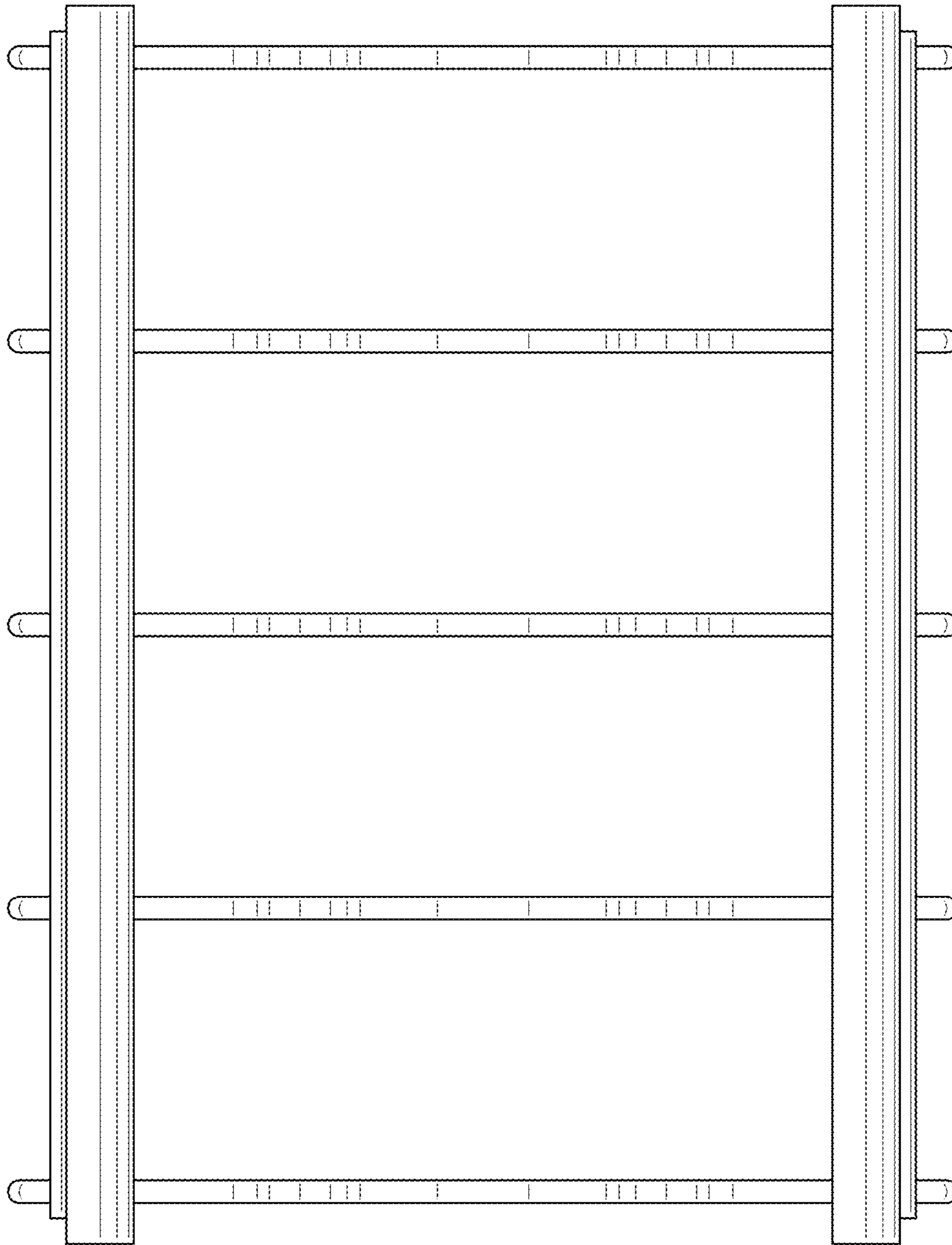
