DESCRIPTION

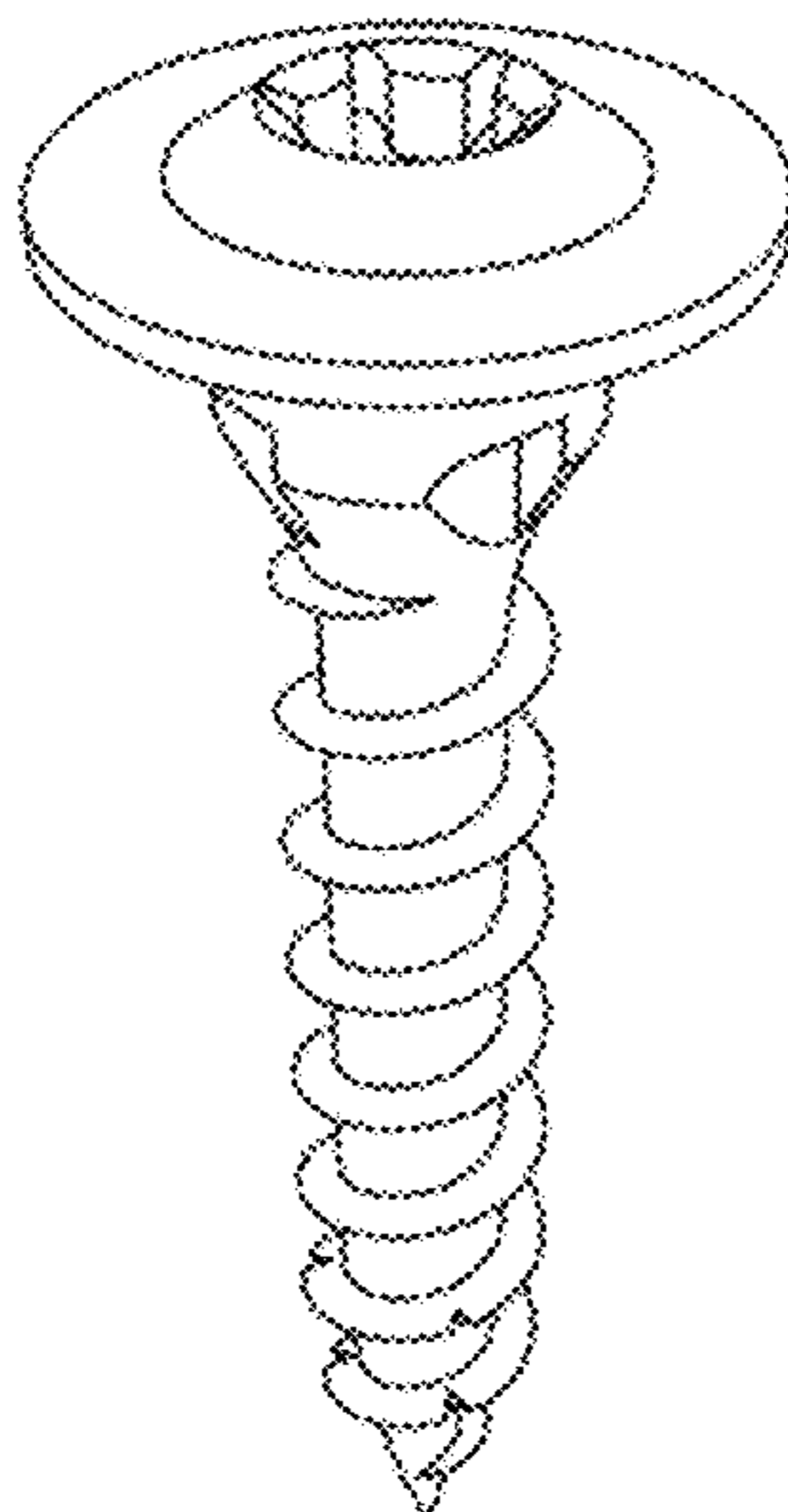
FIG. 1 is a top perspective view of a screw fastener of our new design.

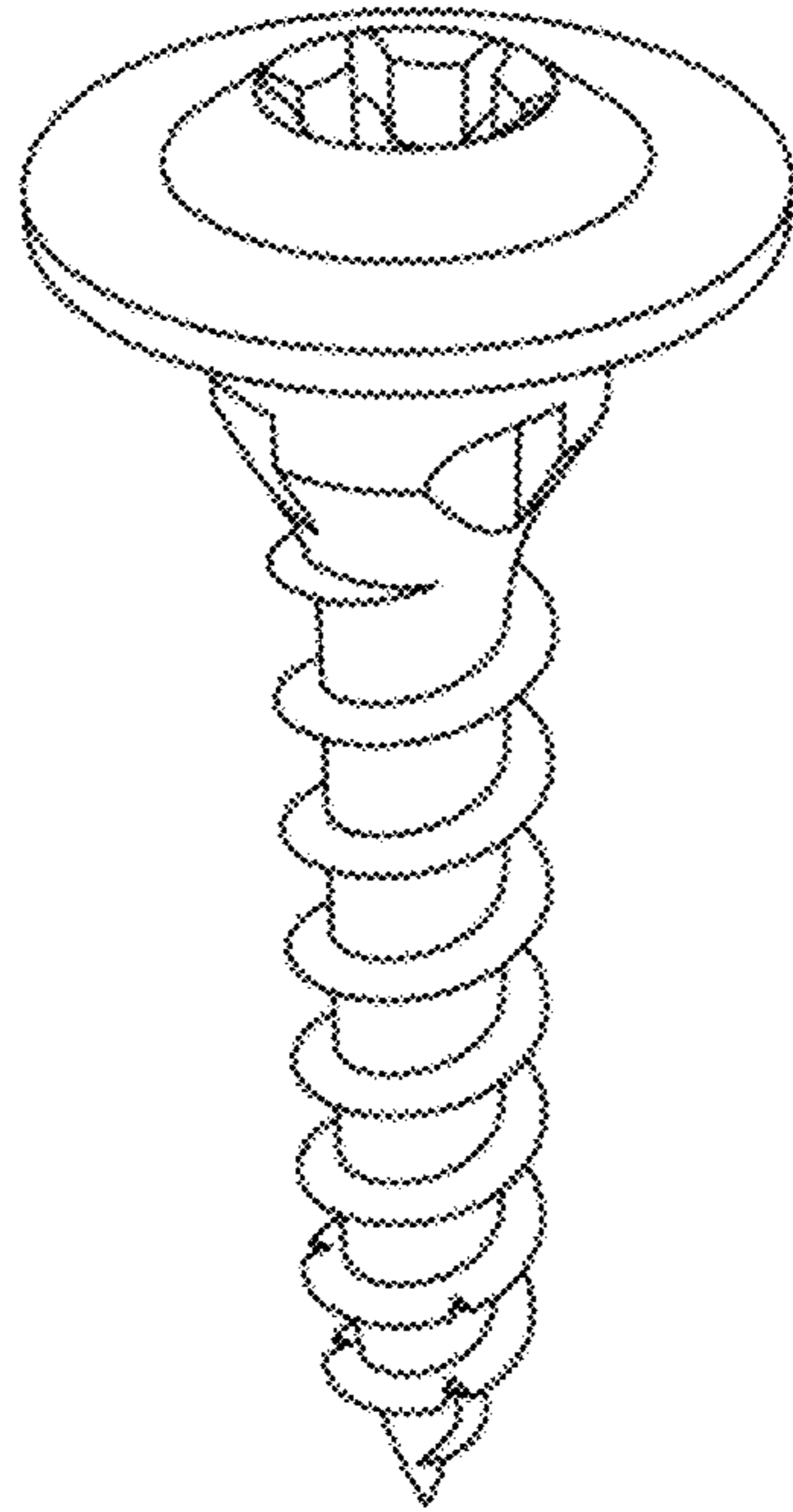

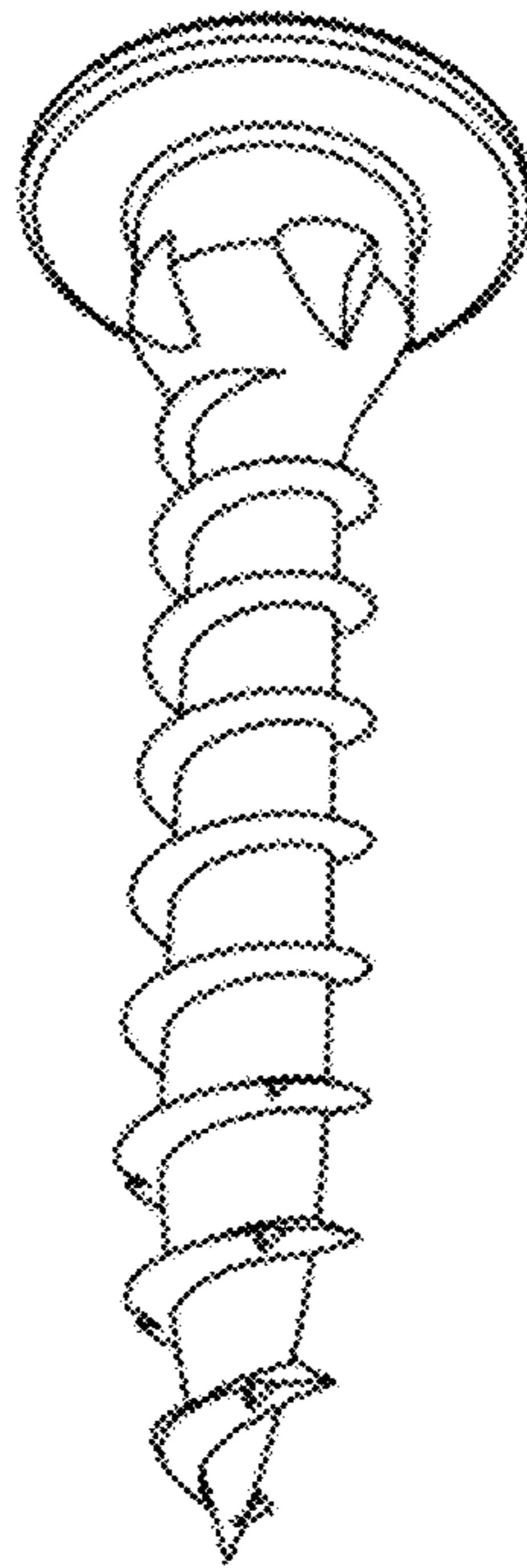

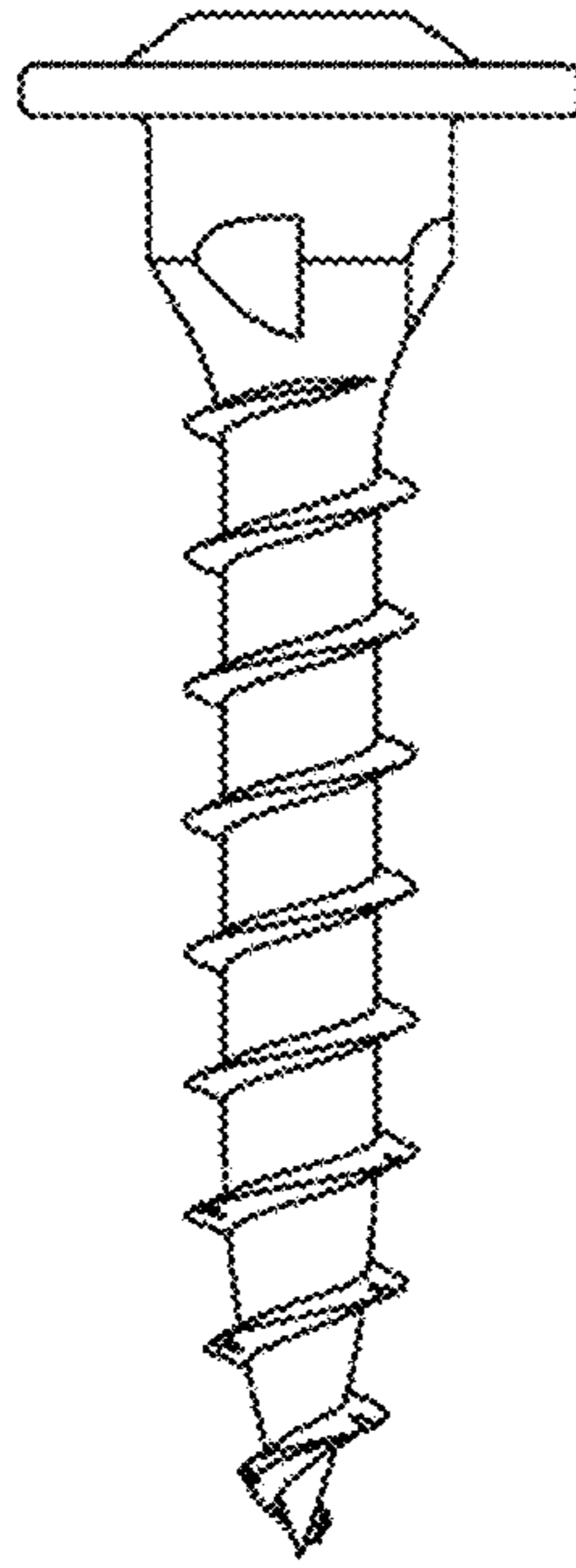

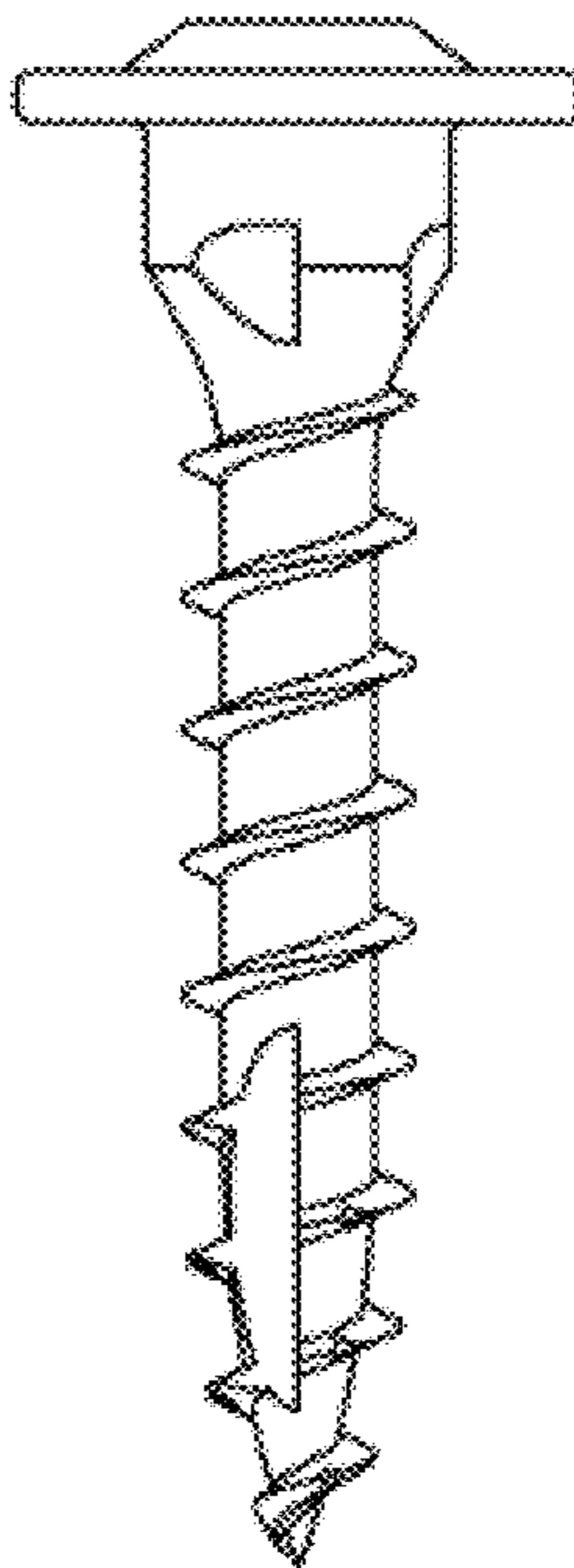

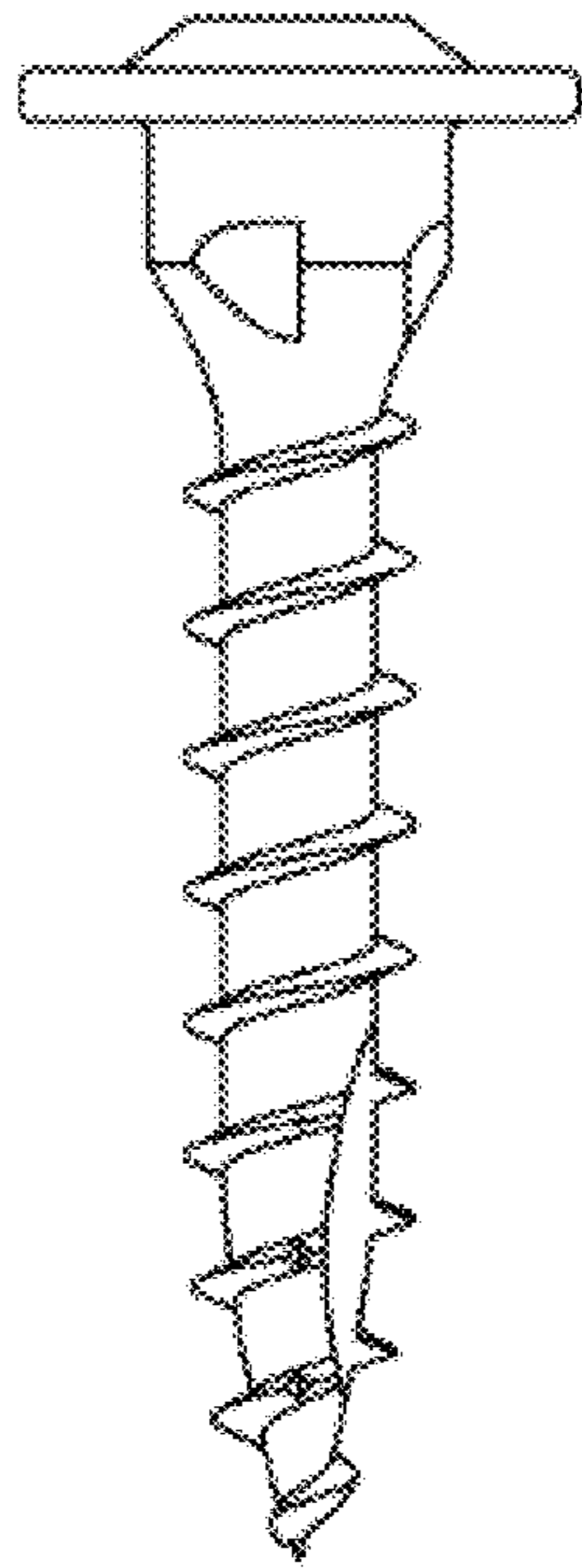

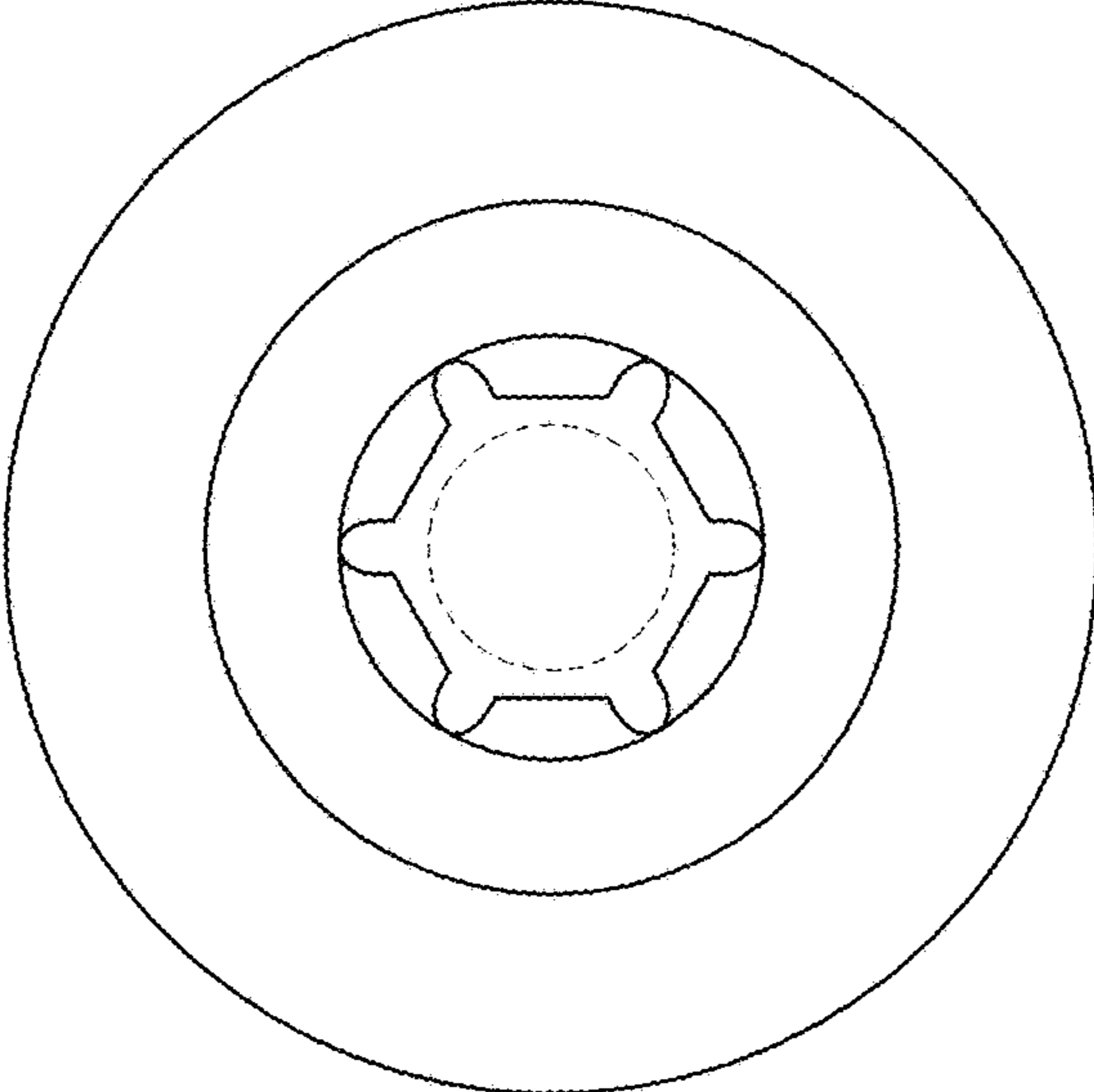

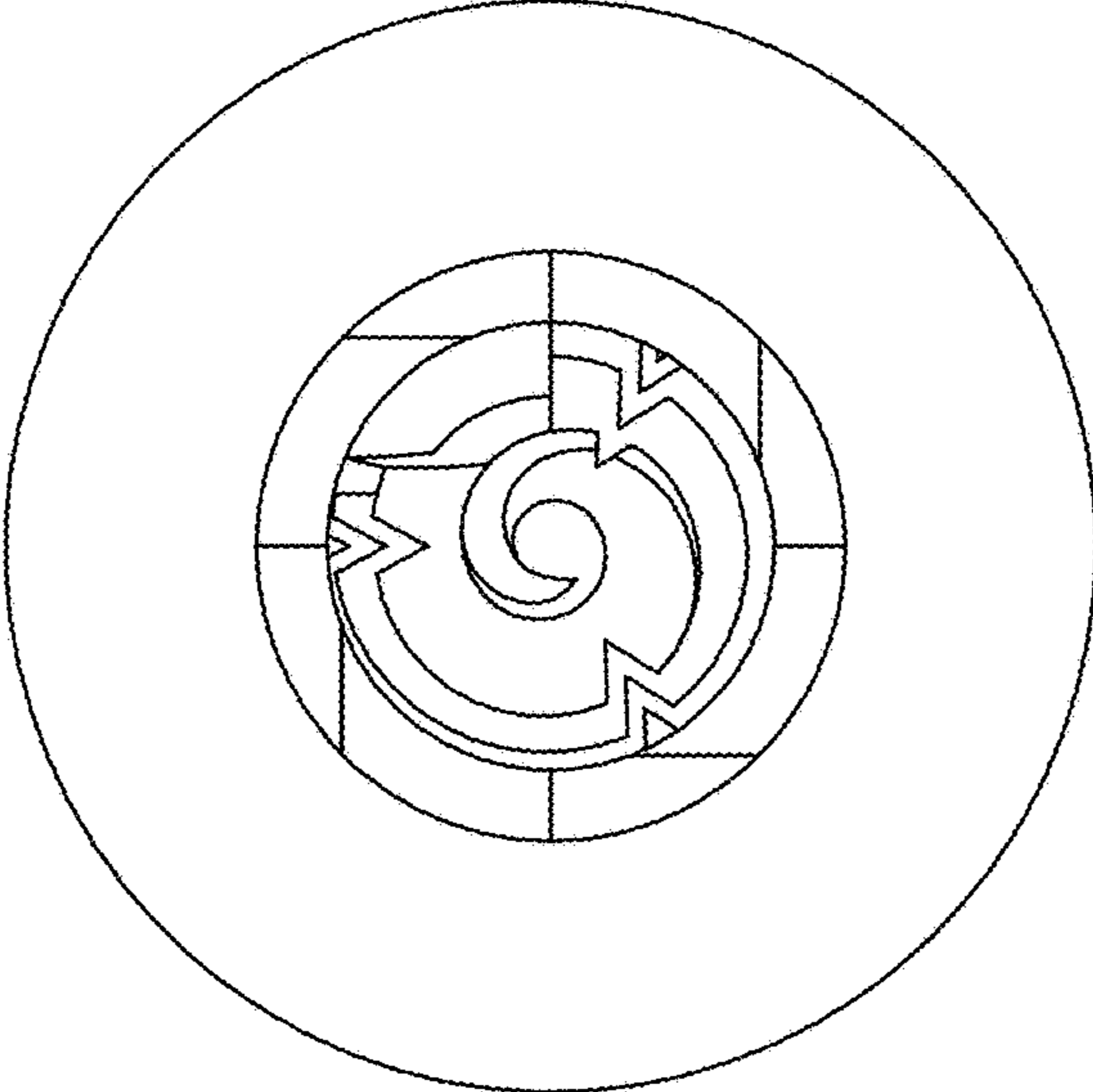
