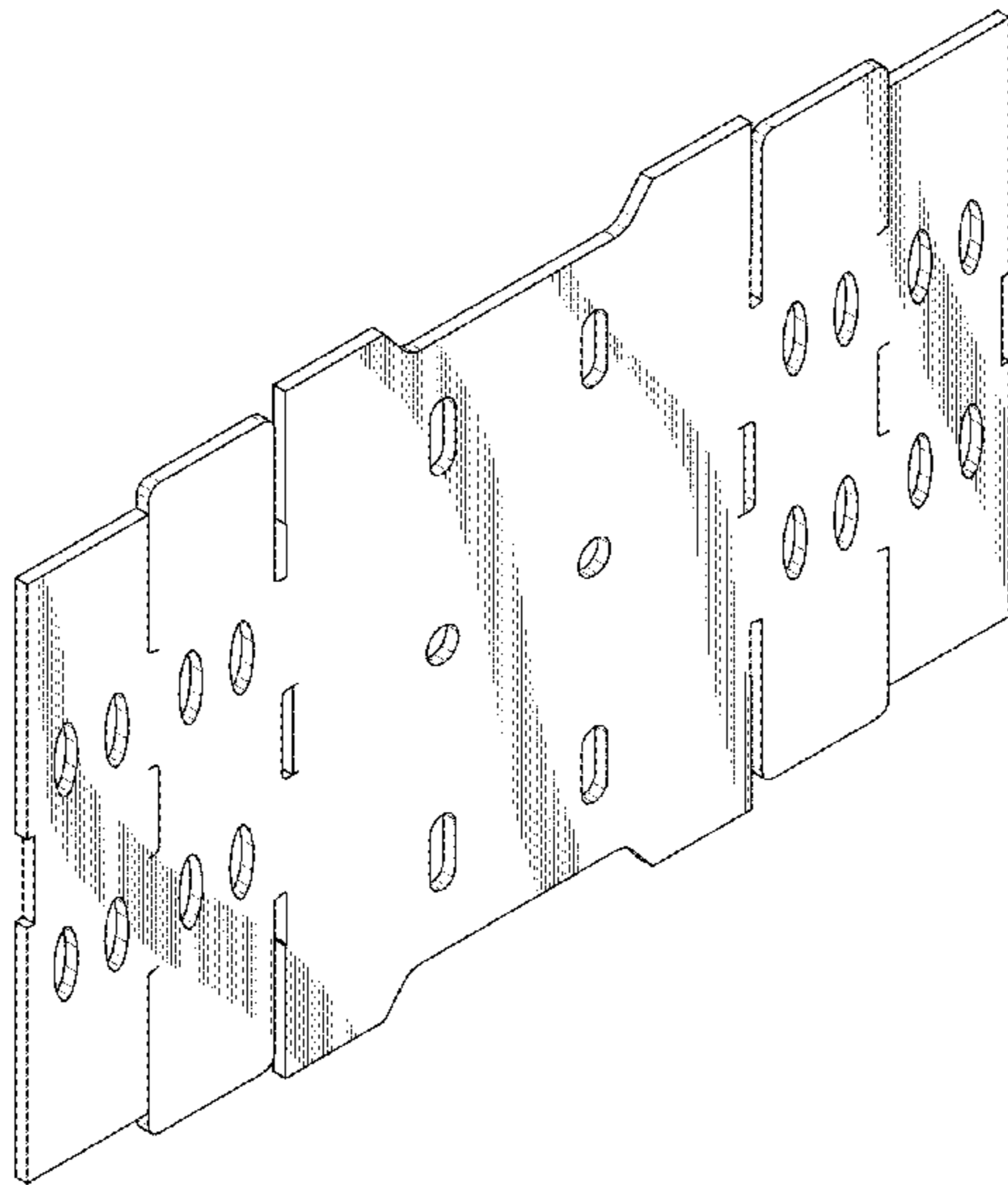

The ornamental design for a blank for a tray, as shown and described.

DESCRIPTION

FIG. 1 is a front view incorporating the new design (the back view is a mirror image of the front view and is not shown); FIG. 2 is a top view incorporating the new design (the bottom view is a mirror image of the top view and is not shown); FIG. 3 is a right side view incorporating the new design (the left side view is a mirror image of the right side view and is not shown); and, FIG. 4 is a top isometric view incorporating the new design.

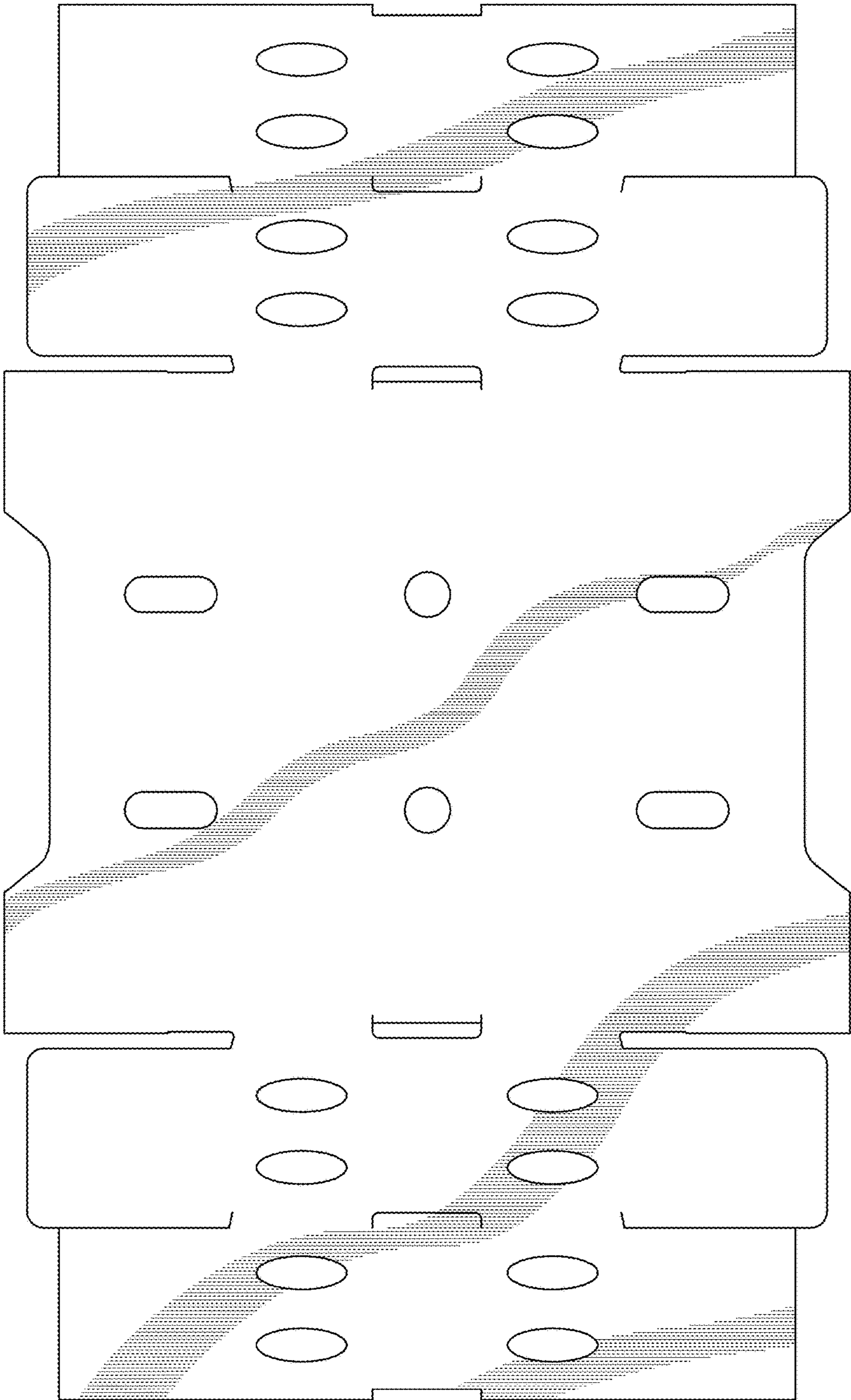

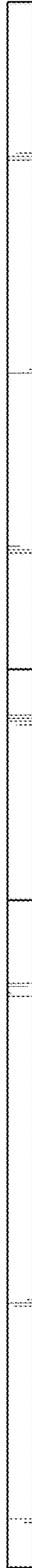
