DESCRIPTION

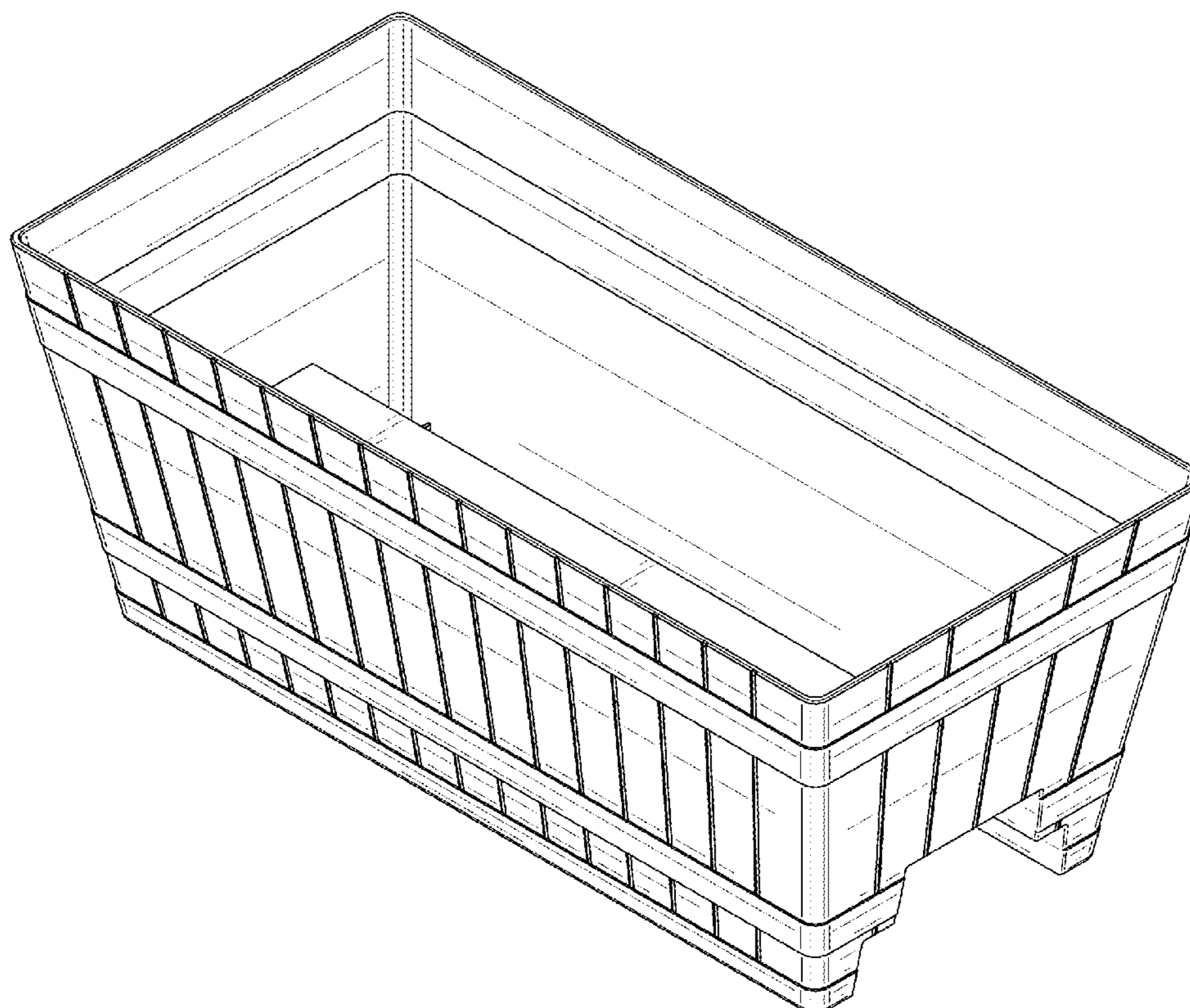
FIG. 1 is a perspective view showing a barrel rail planter in accordance with a new design;

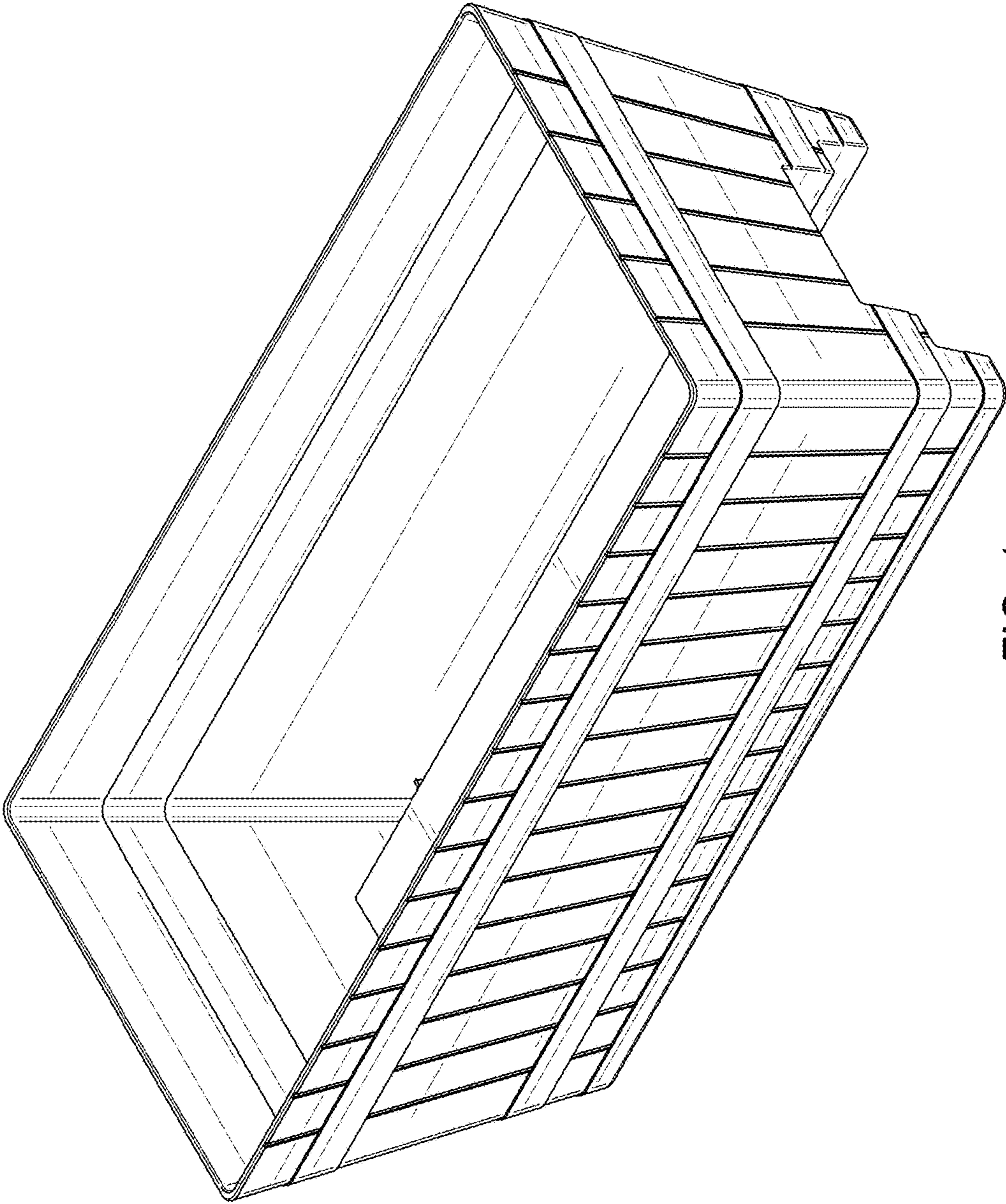

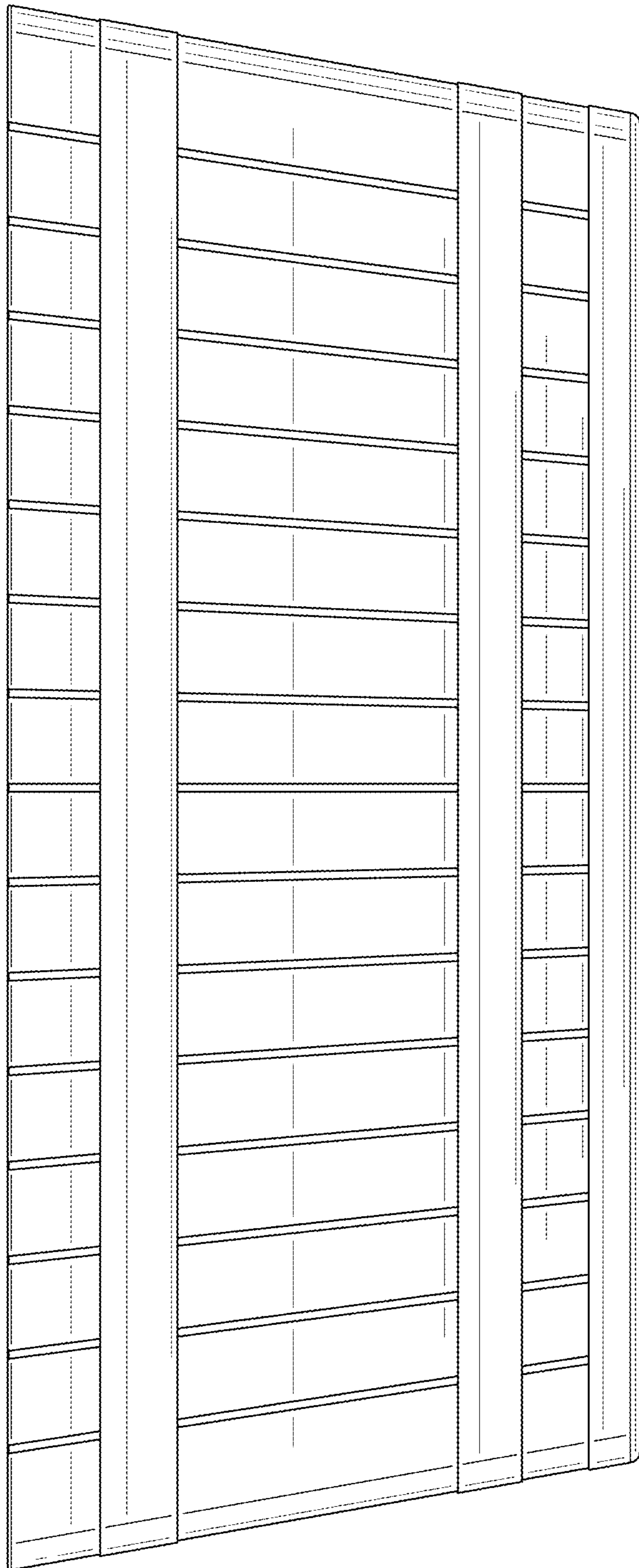

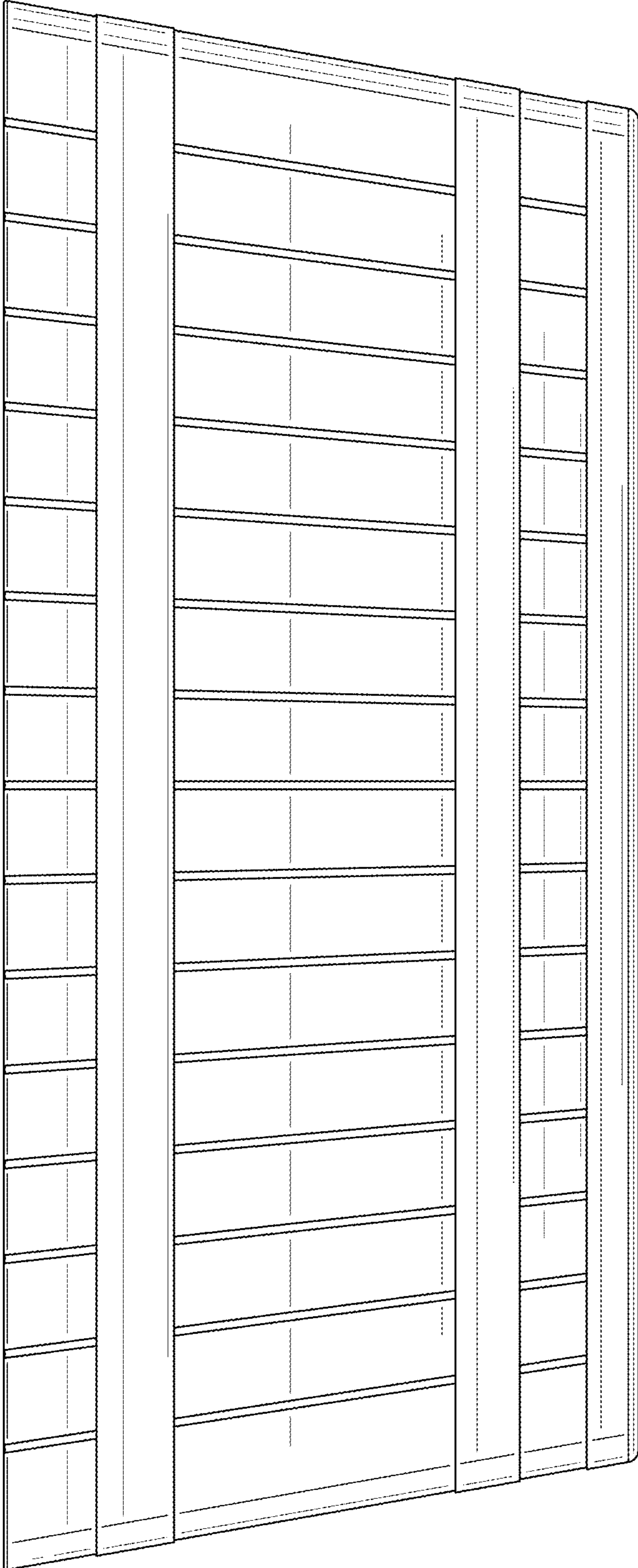

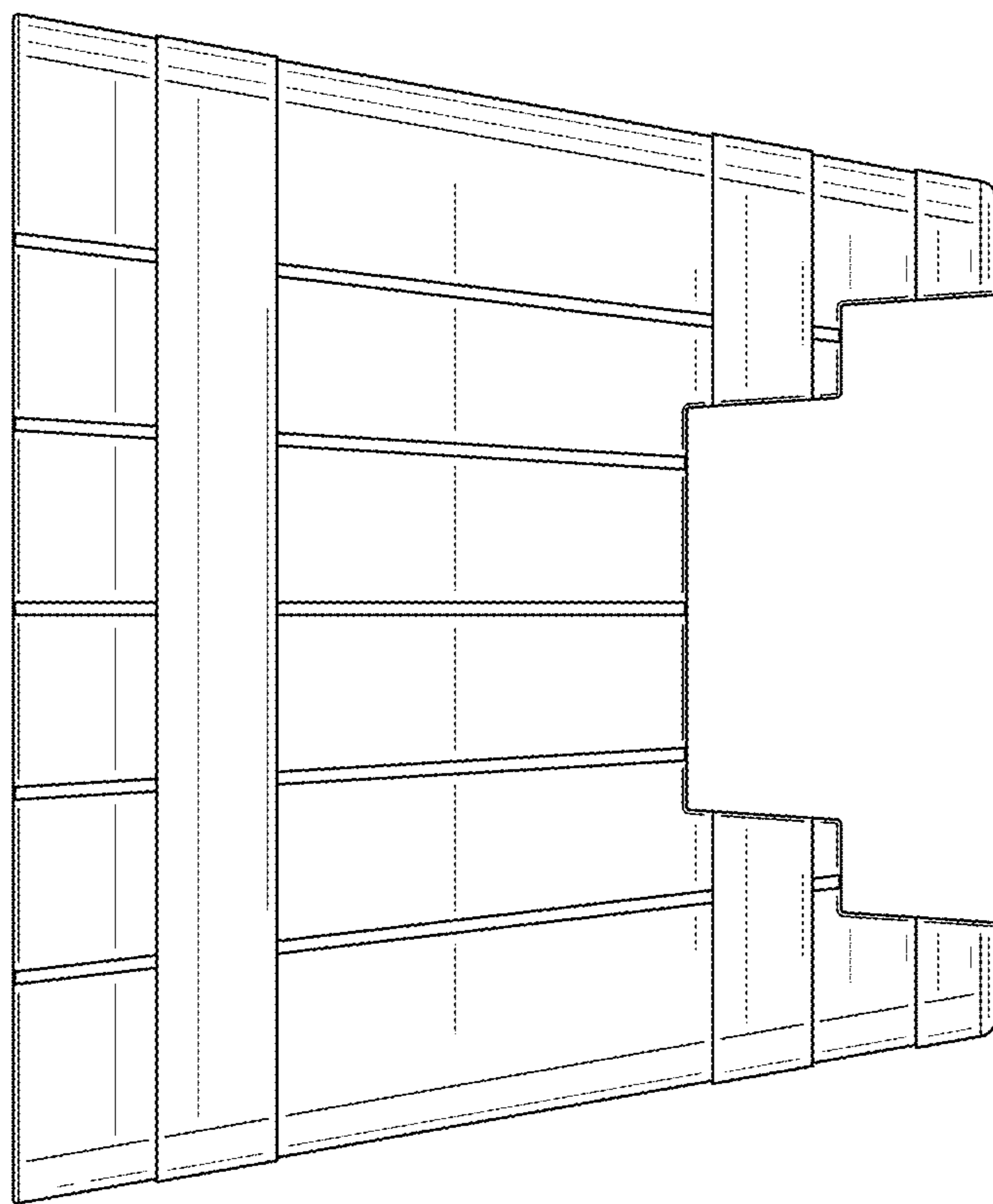

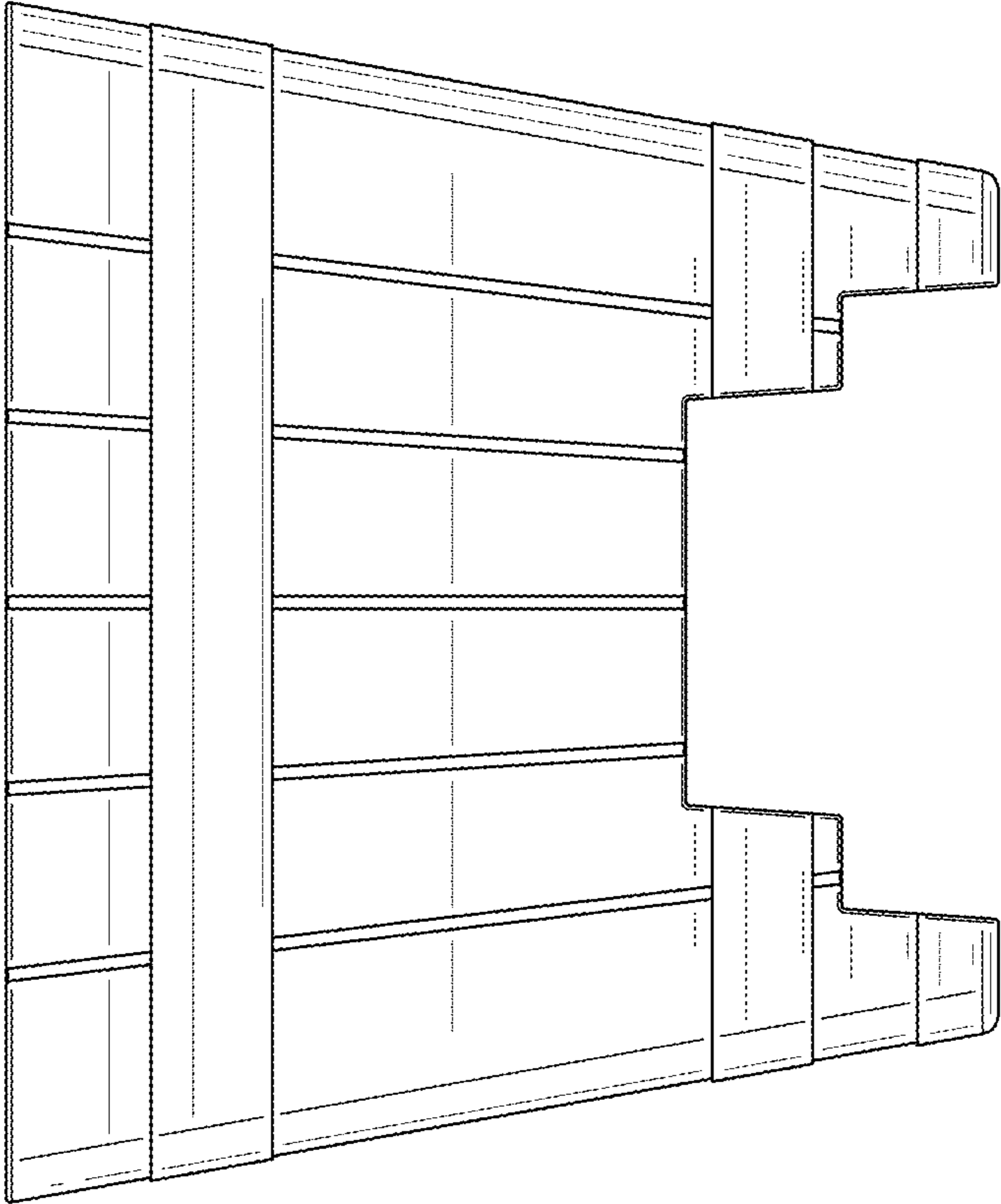

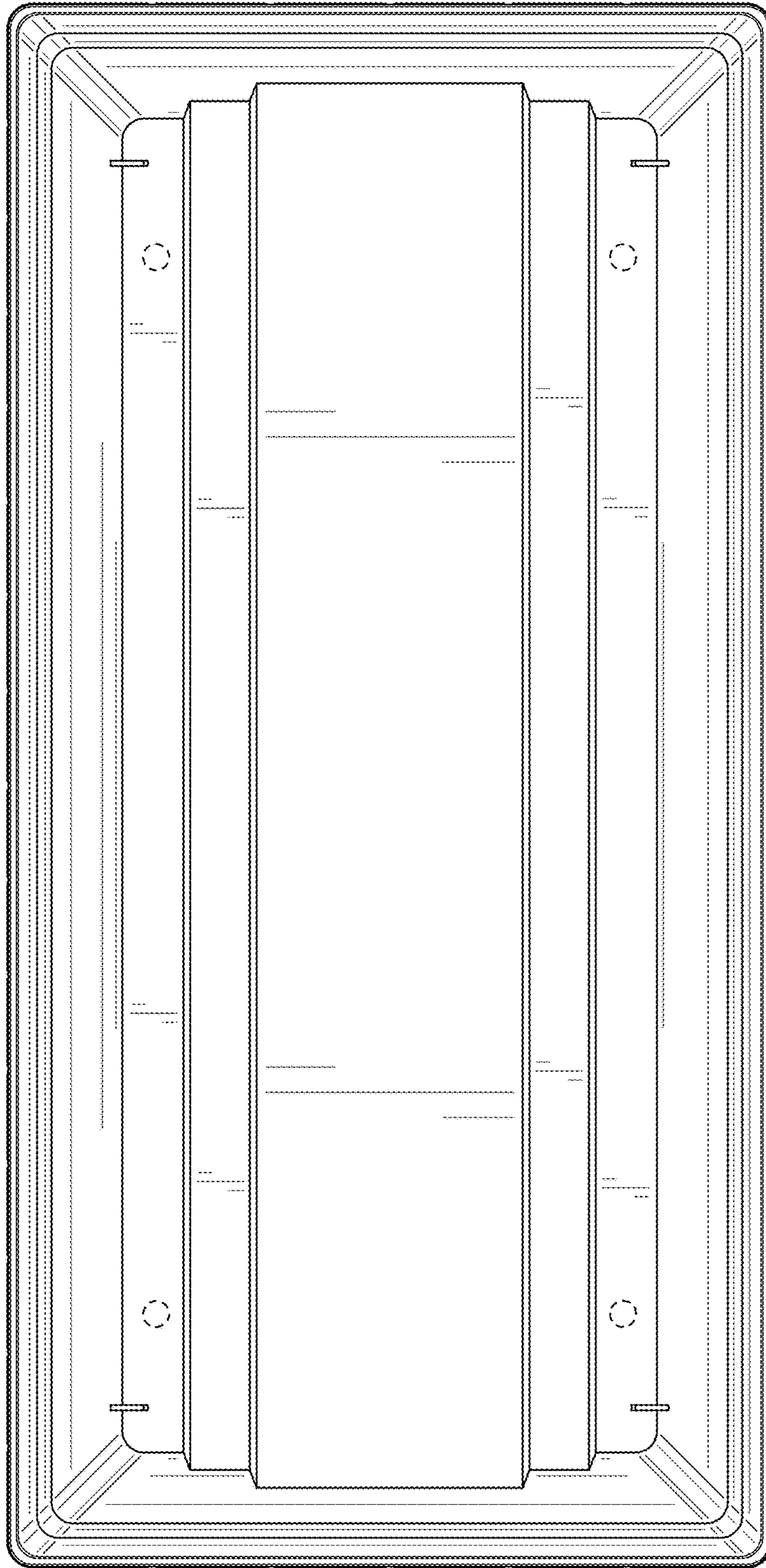

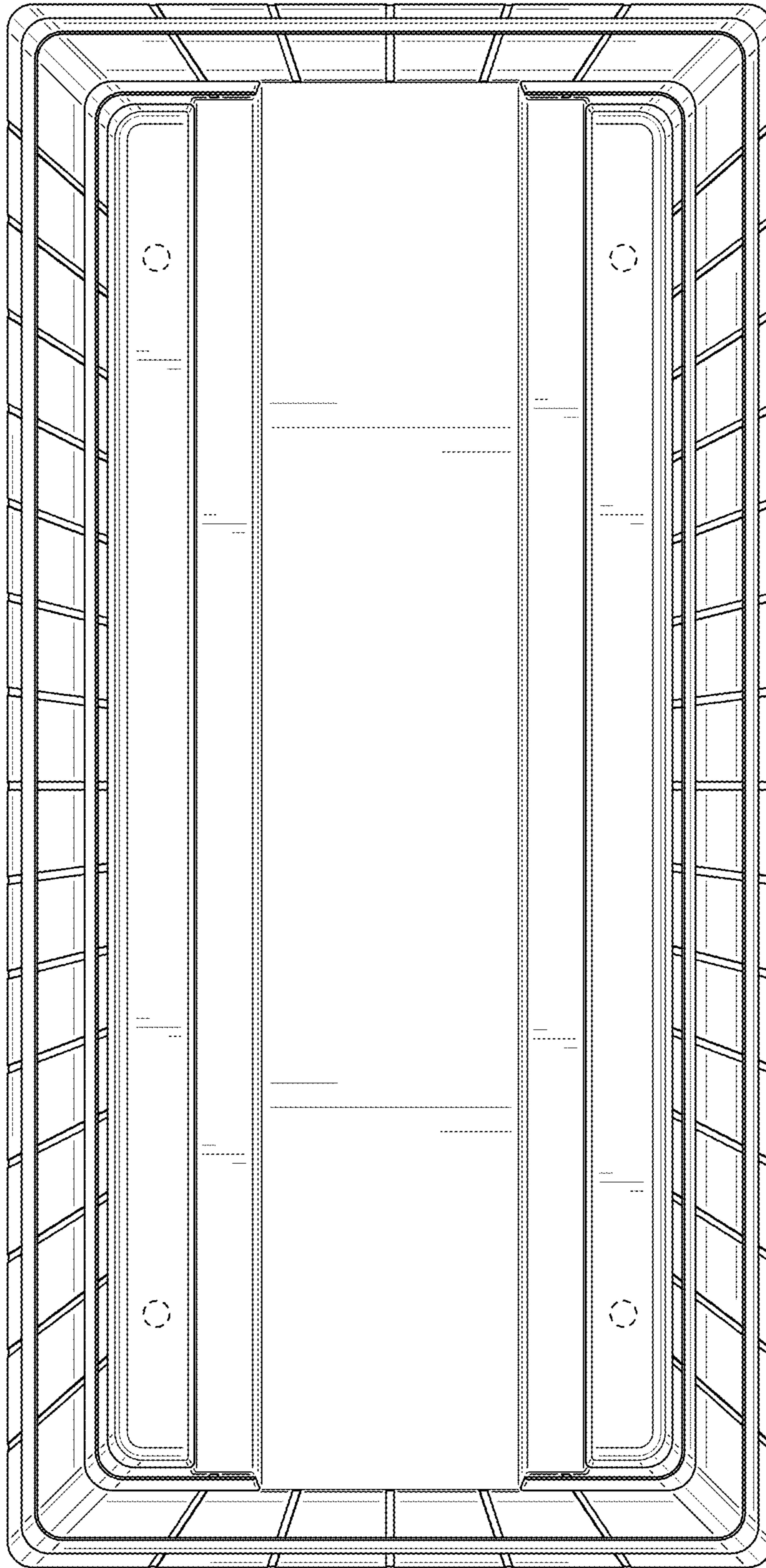
