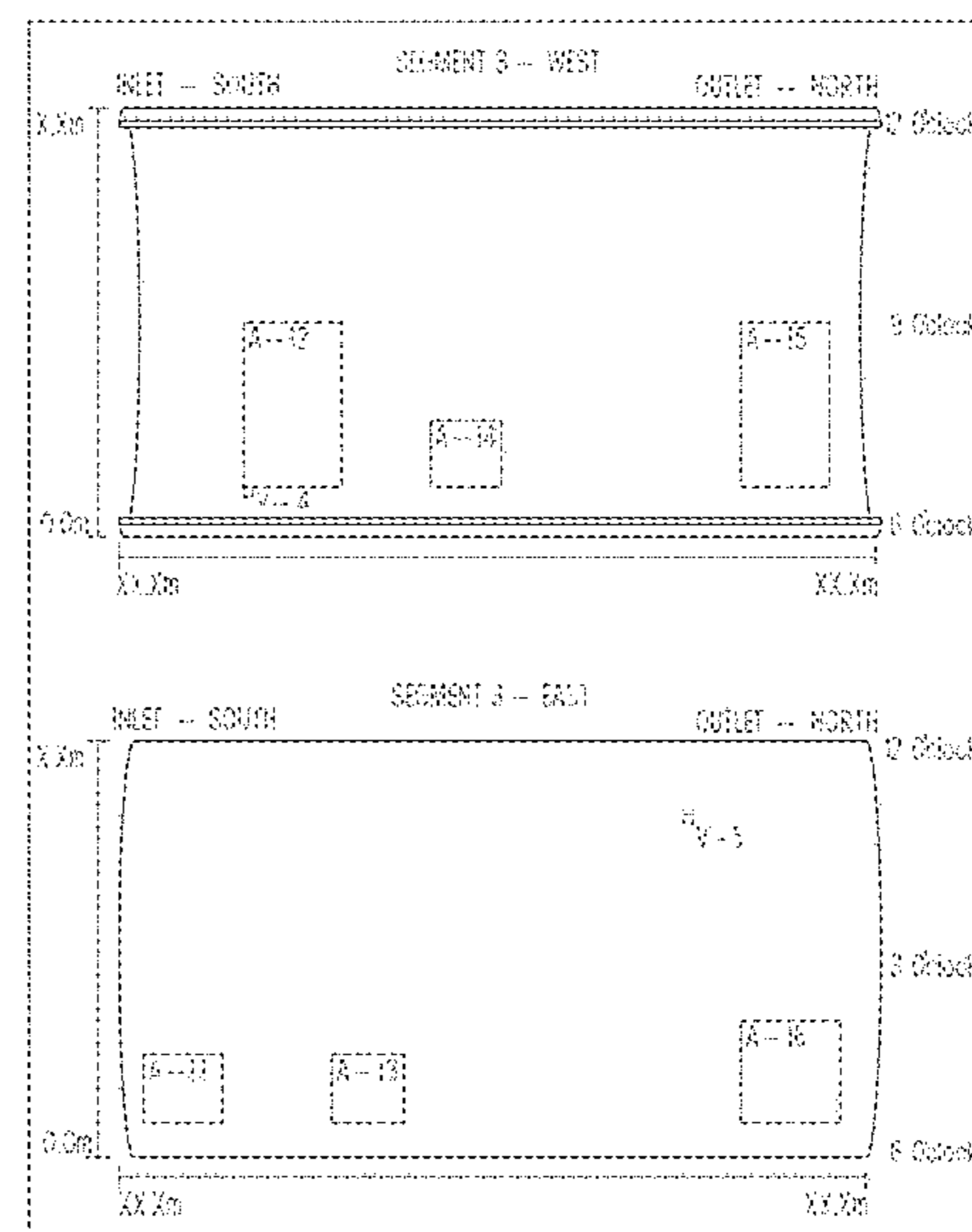
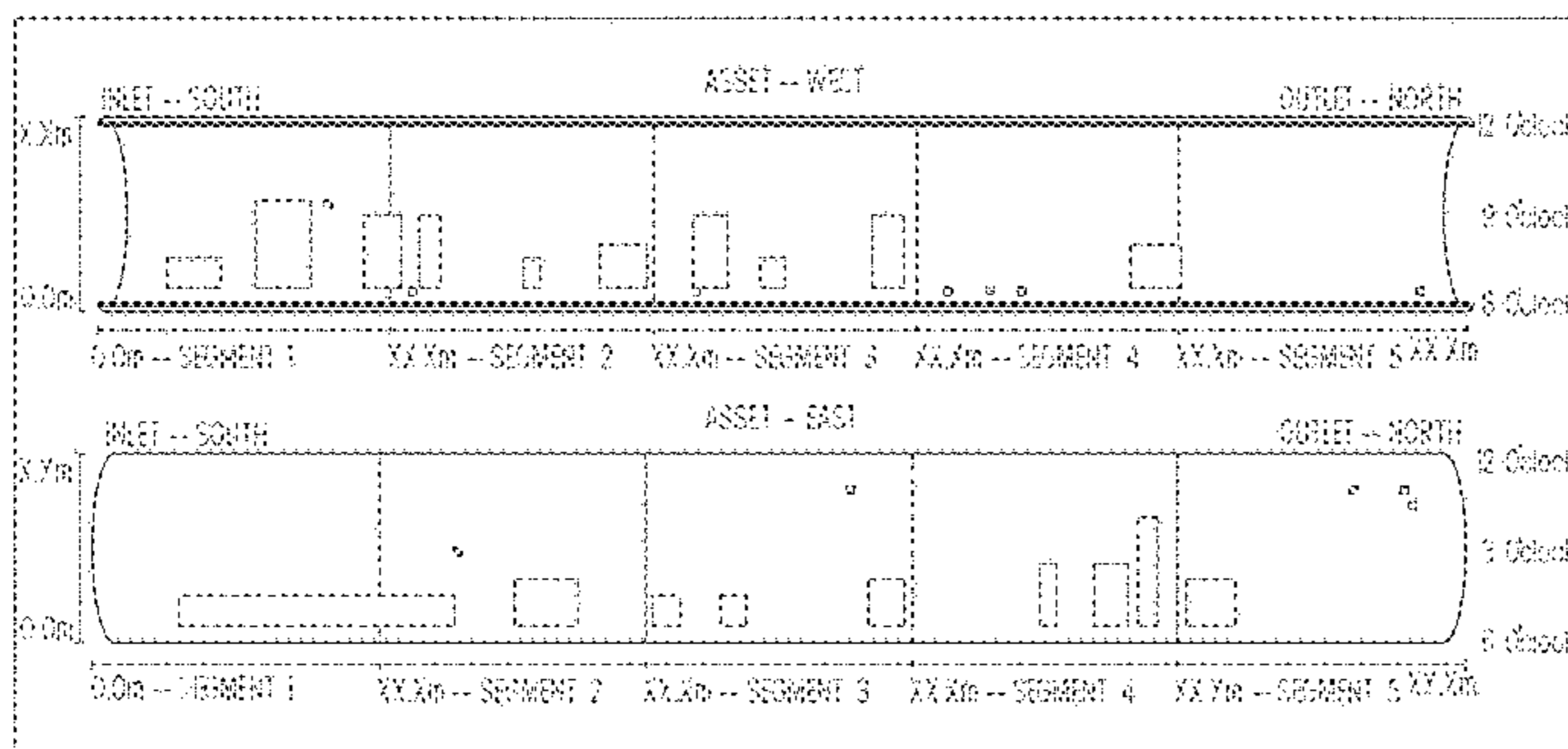
(57) **CLAIM**

The ornamental design for a display screen, or portion thereof, having graphical user interface, as shown and described.

DESCRIPTION

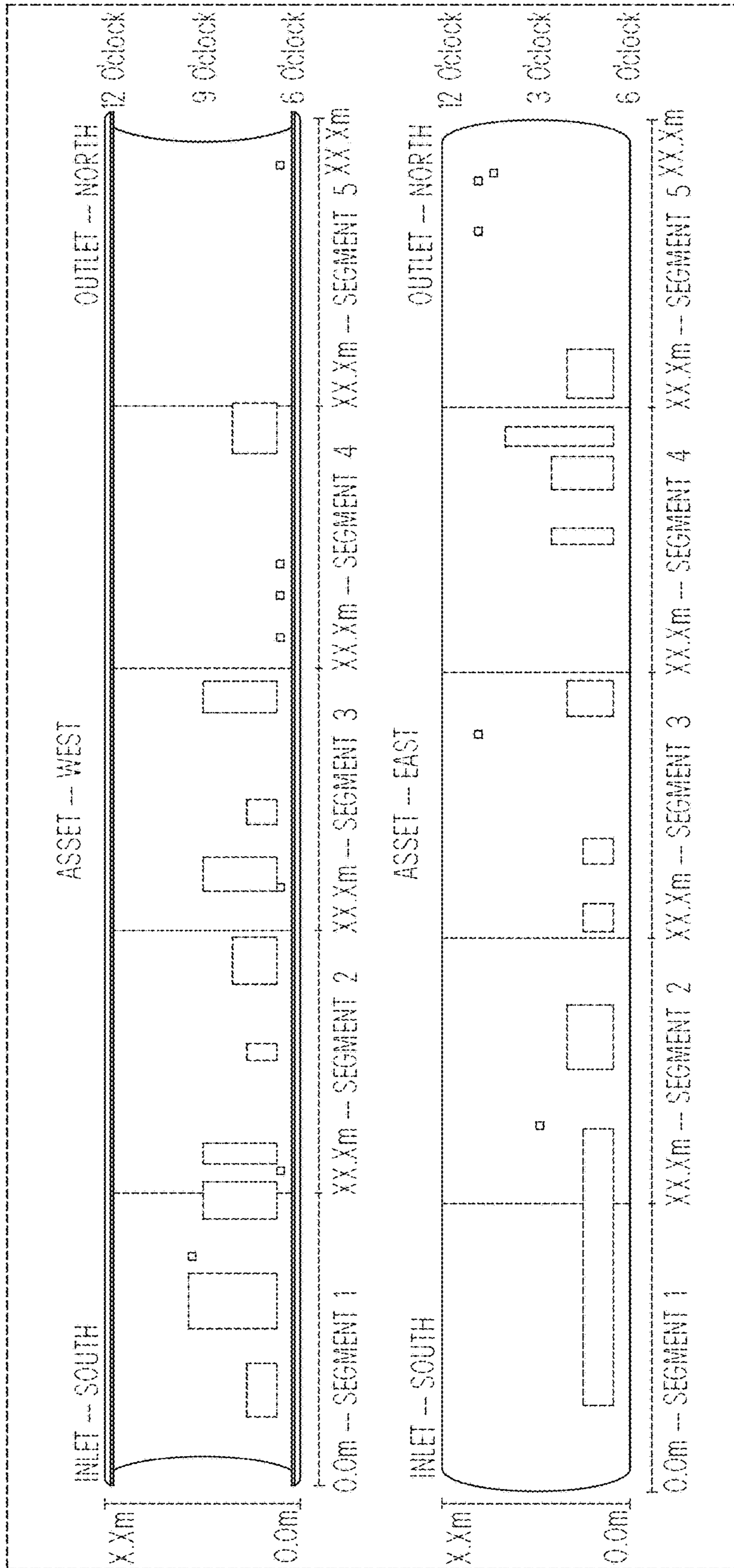
