The ornamental design for a printer, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and left side perspective view of a printer showing my new design;
FIG. 2 is a top, rear and right side perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a left side elevational view thereof;
FIG. 8 is a right side elevational view thereof; and,
FIG. 9 is an enlarged cross-sectional view thereof taken along lines IX-IX of FIG. 3, in which an internal structure thereof is omitted.

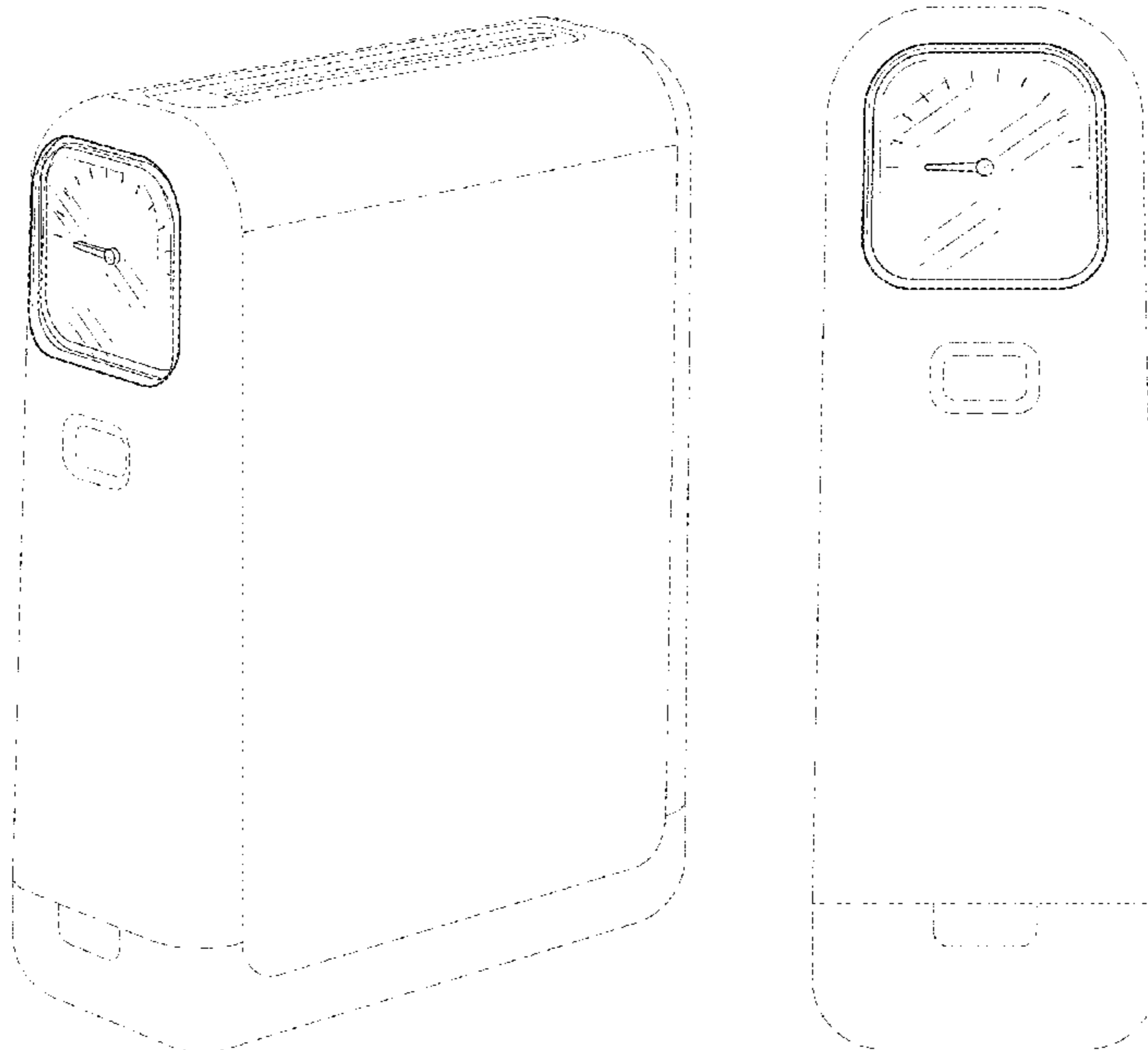

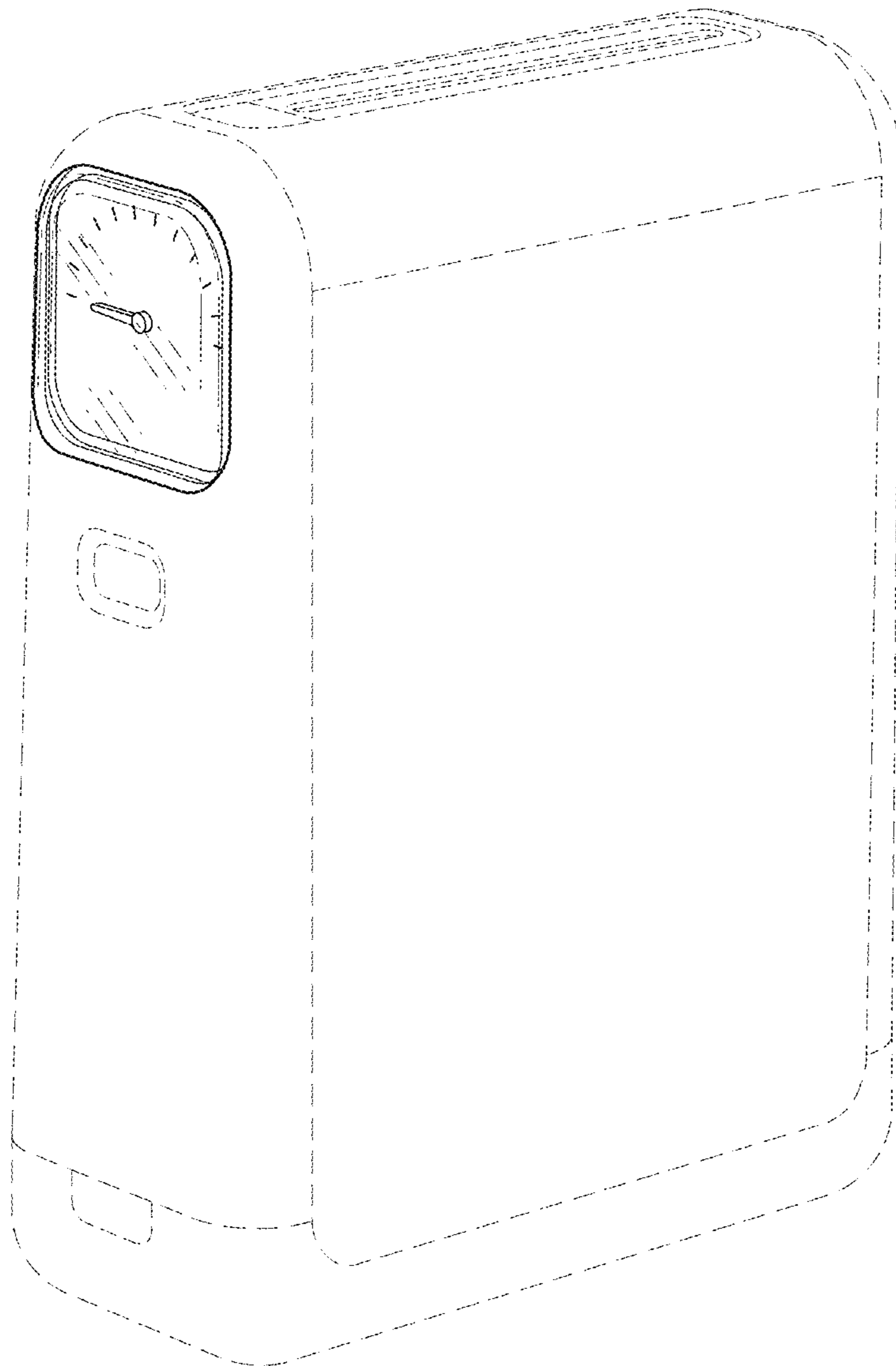

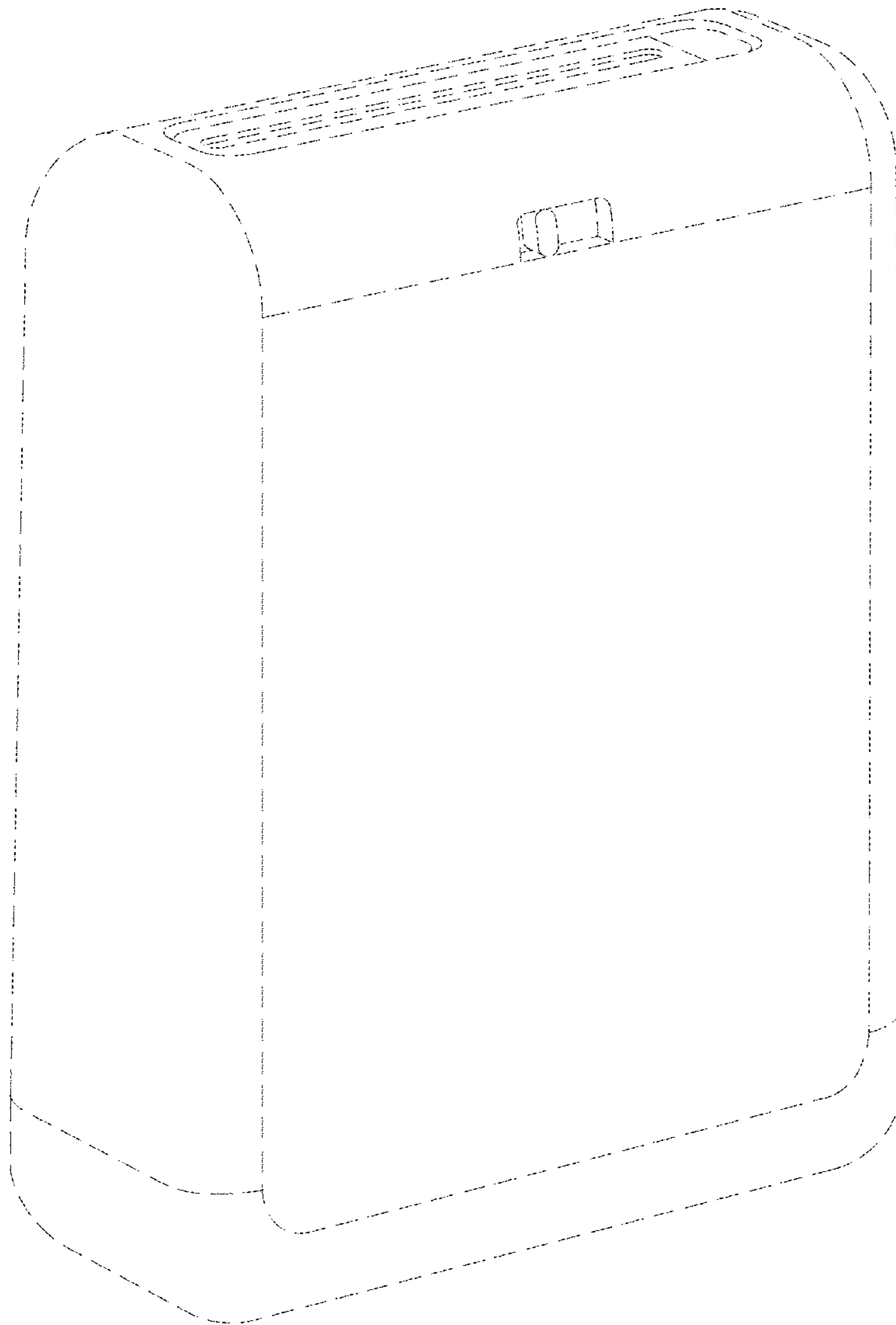

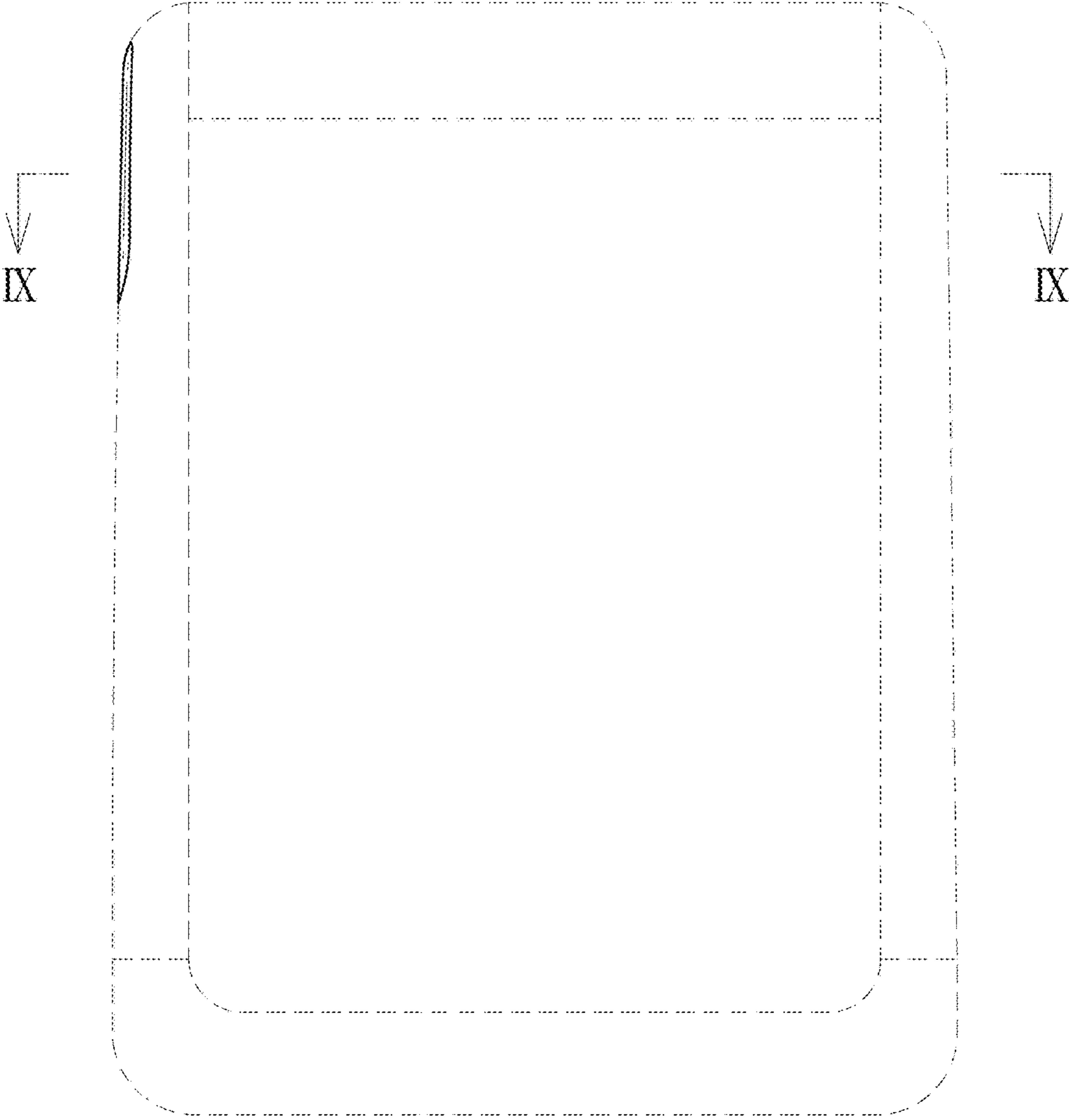

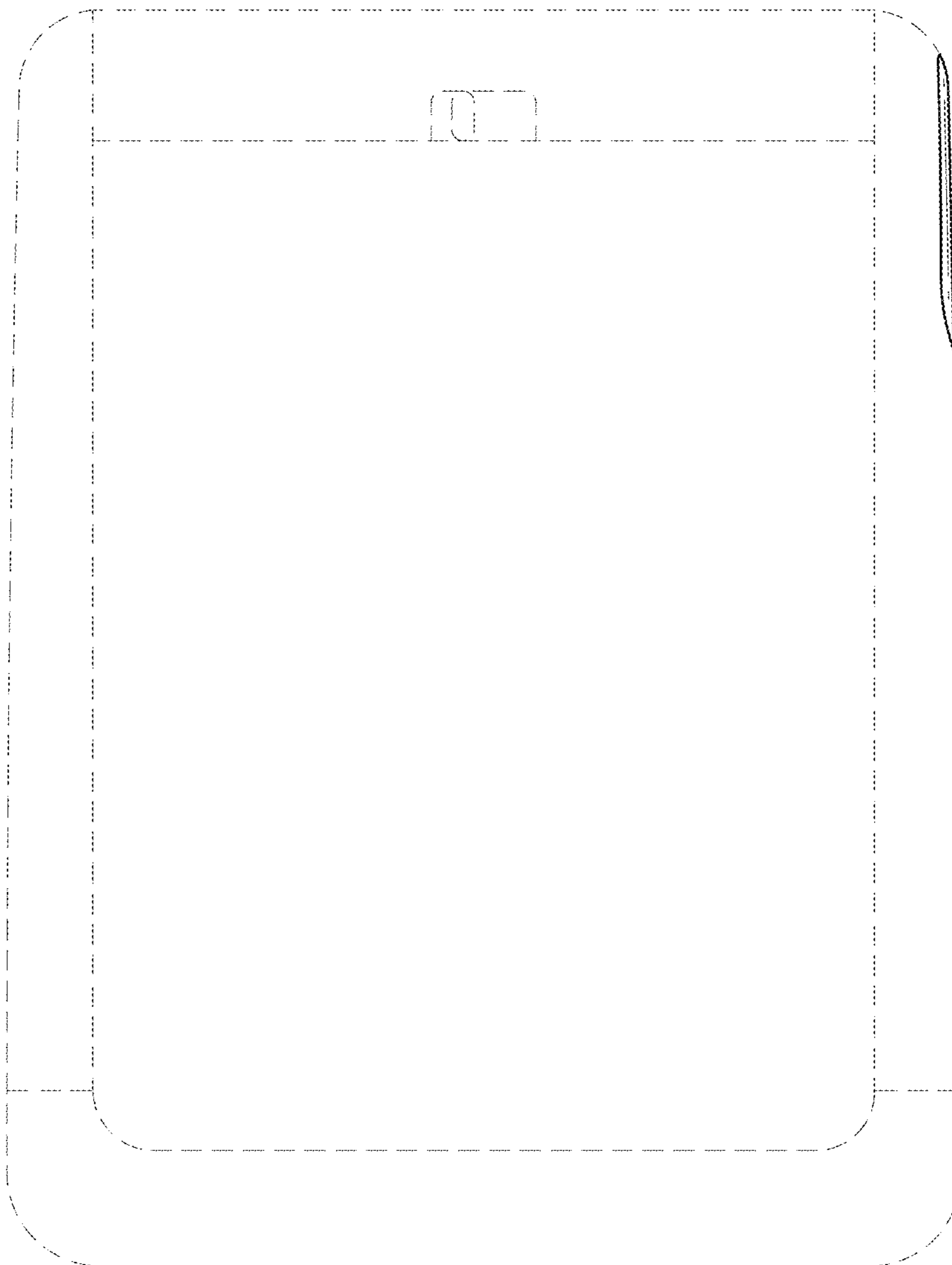

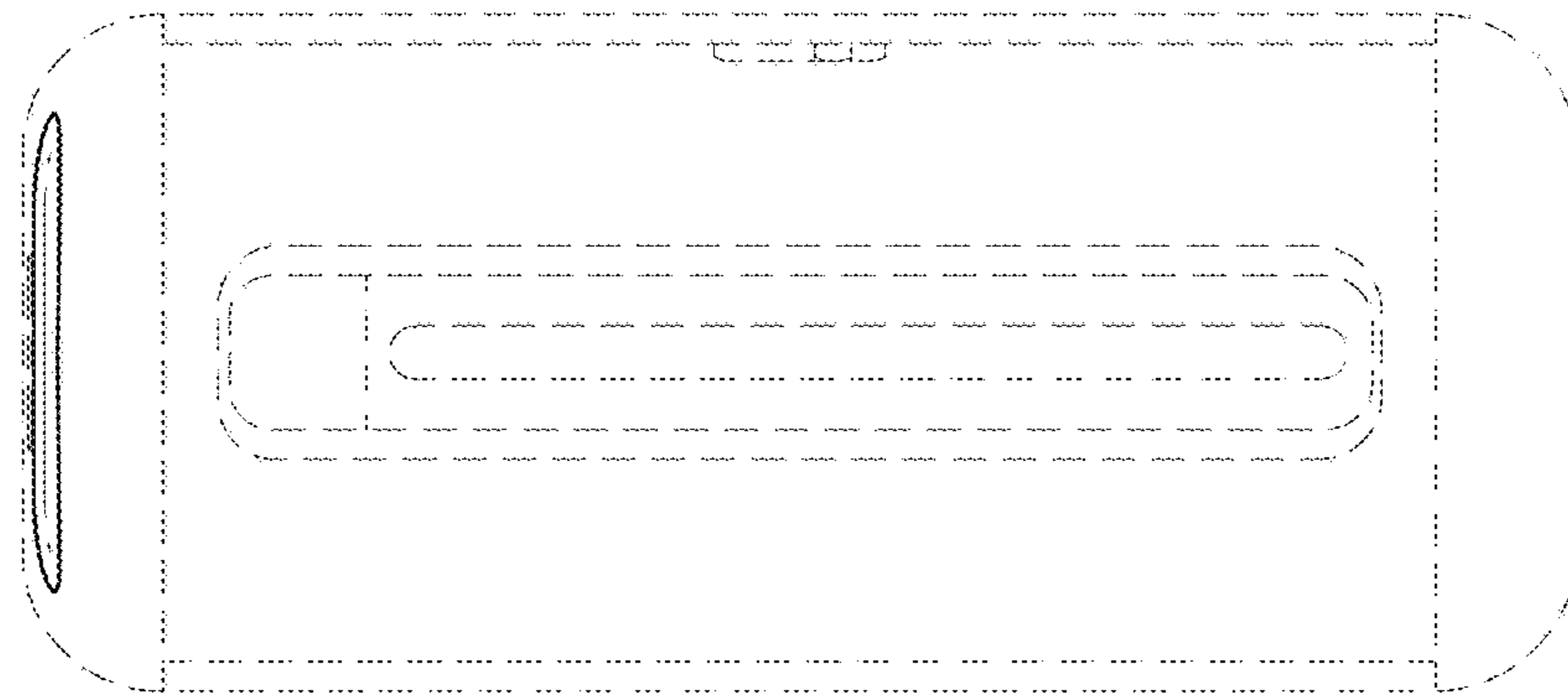

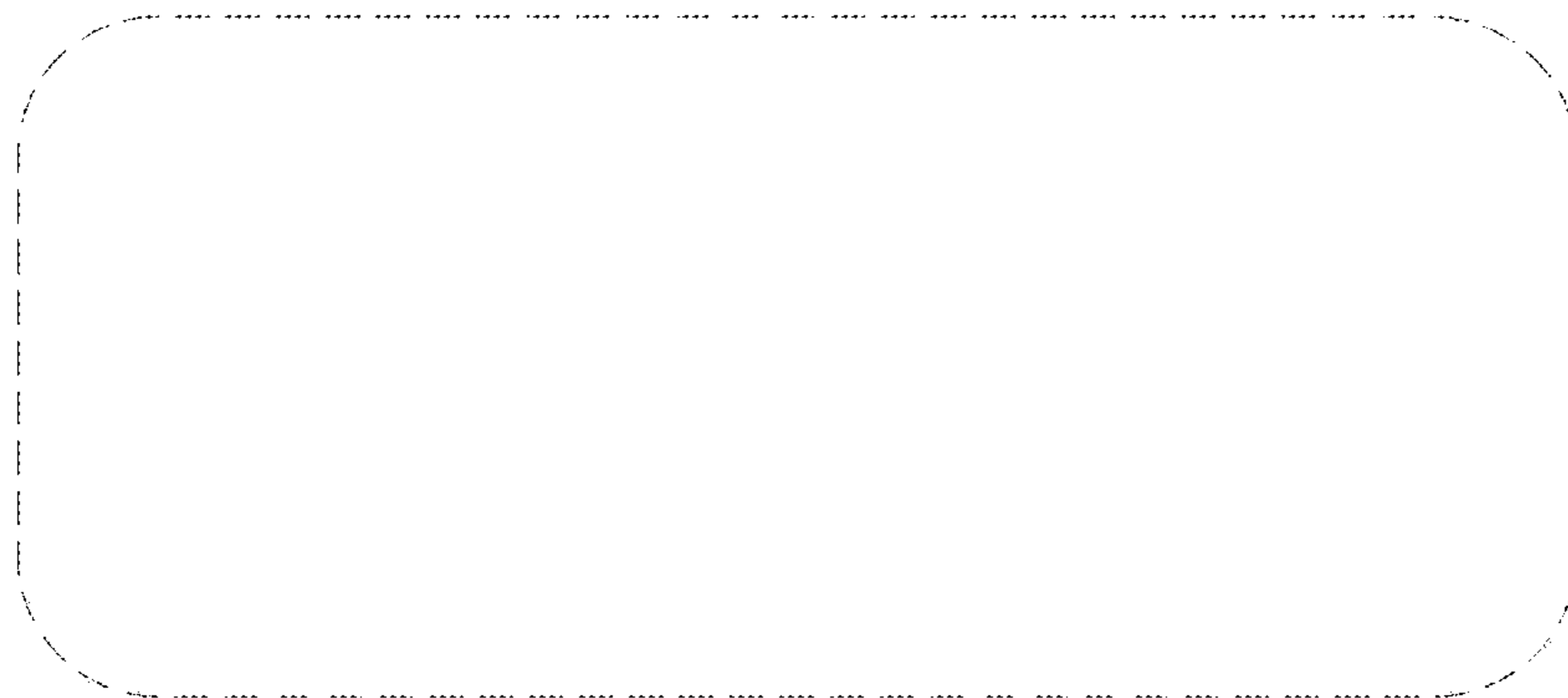

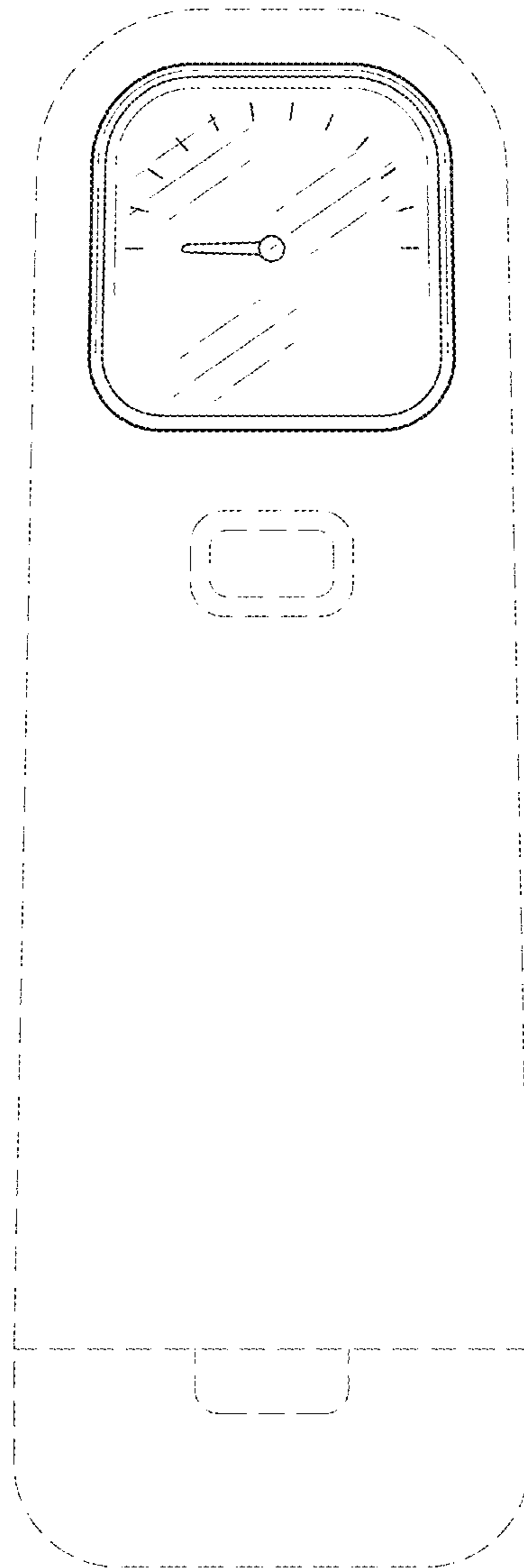

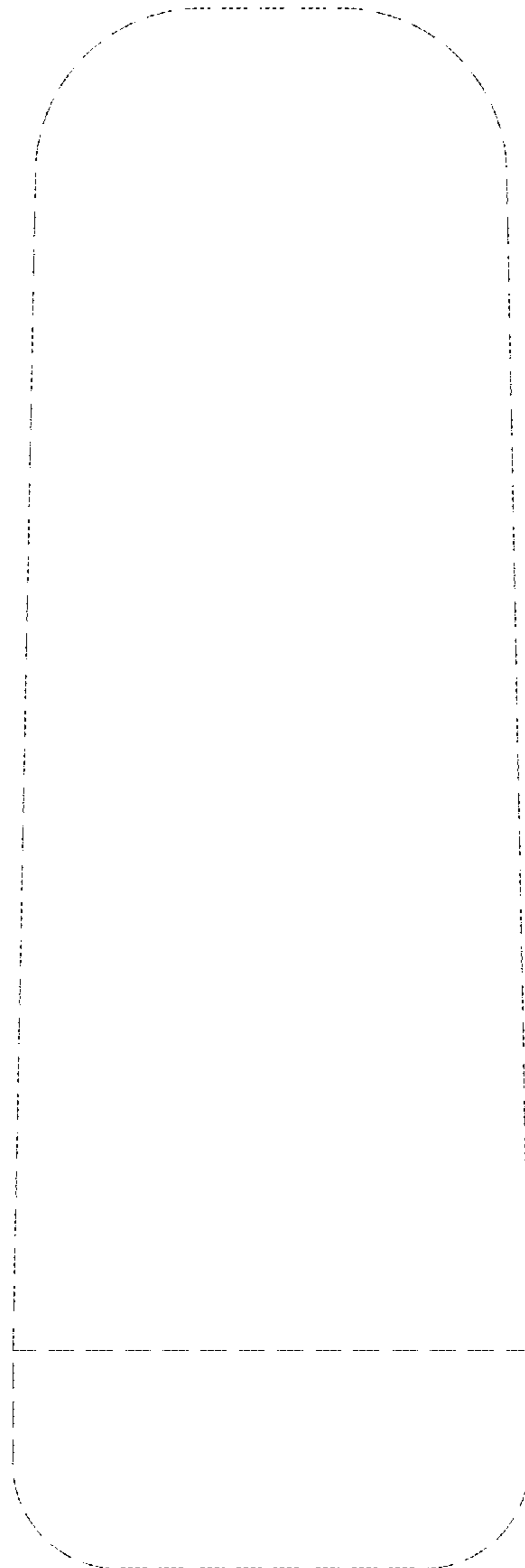
