DESCRIPTION

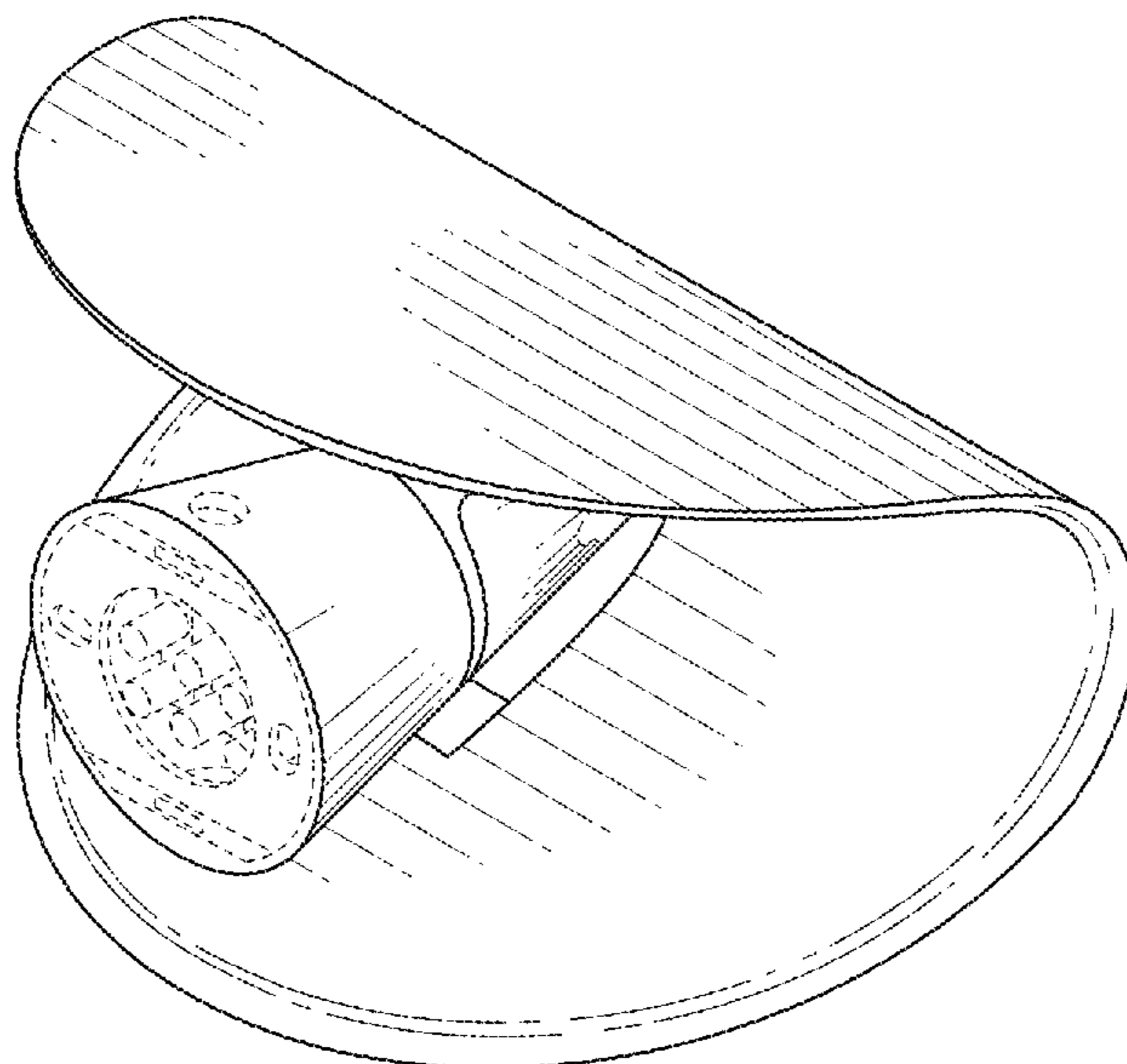
FIG. 1 is a perspective view of a lamp showing our new design;

The drawings include surface shading which represents contour and not surface ornamentation.

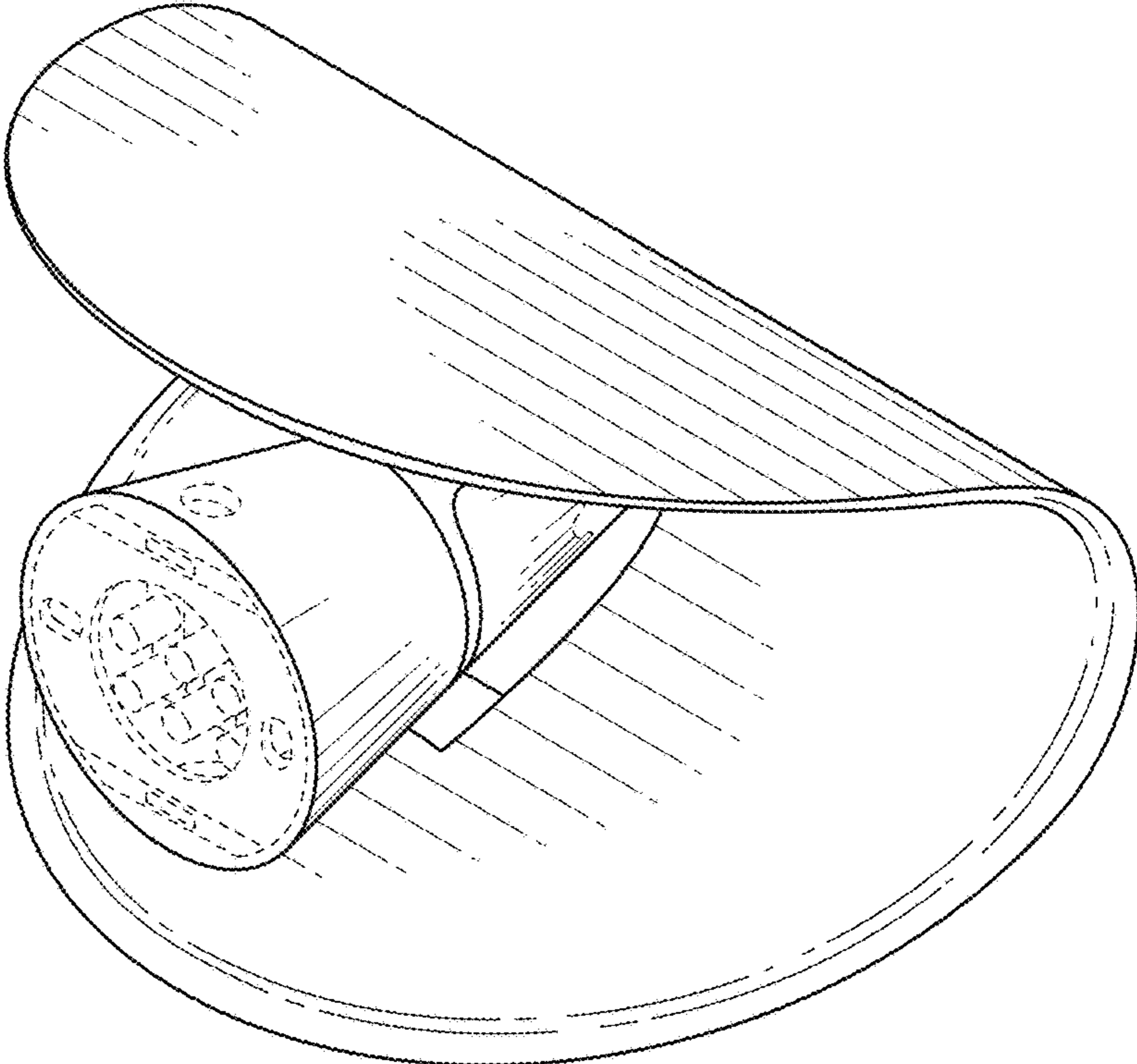

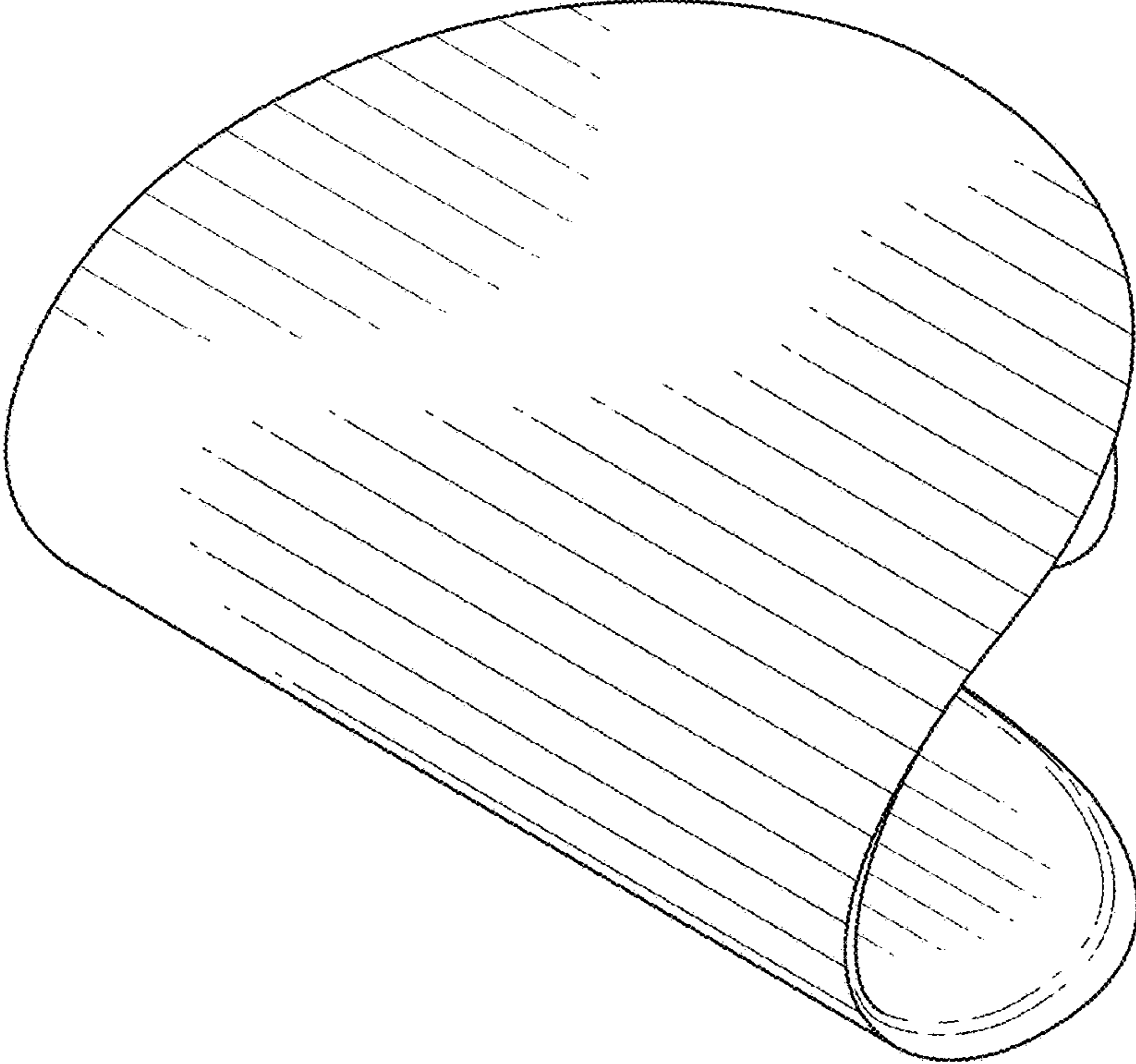

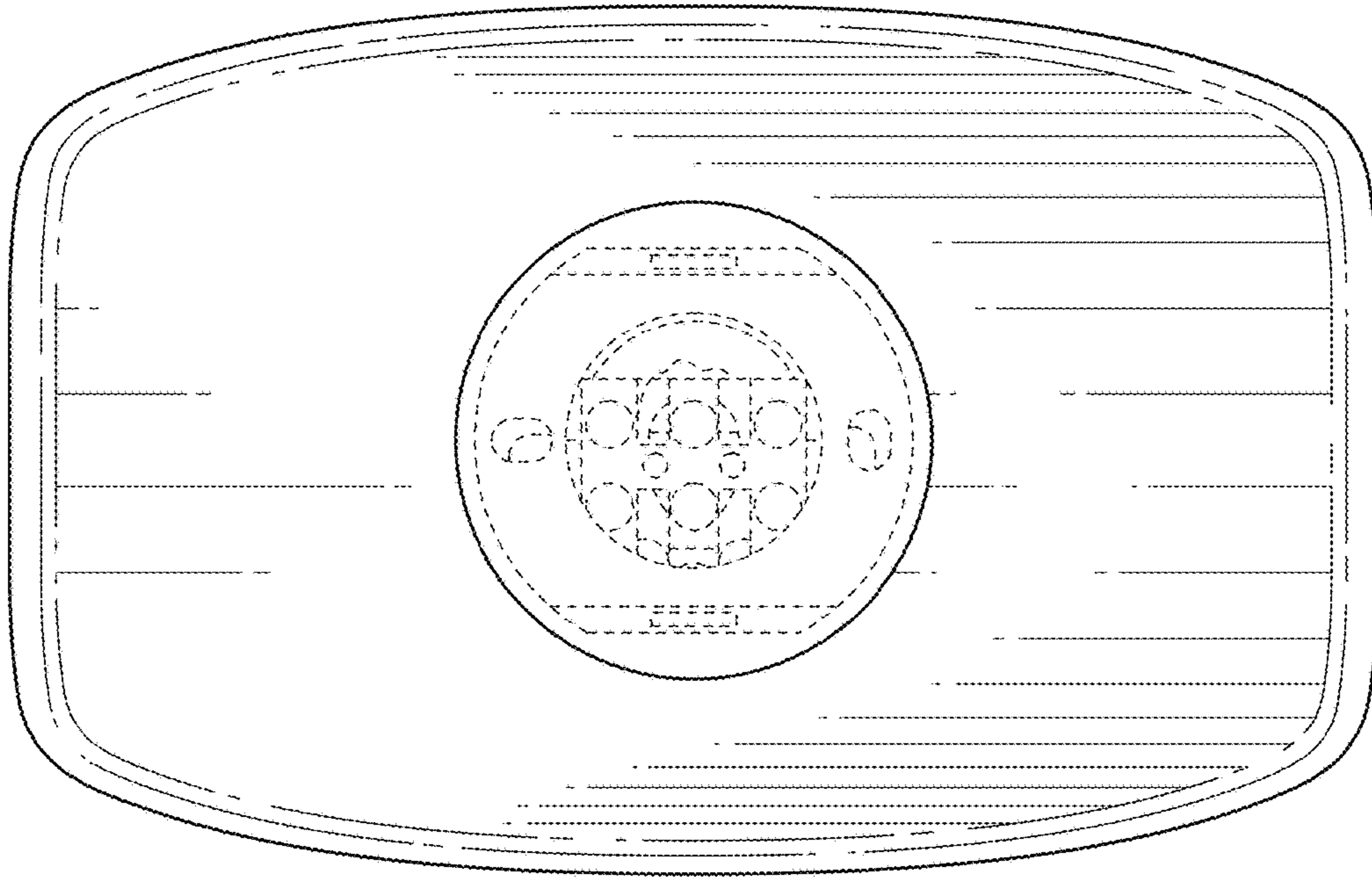

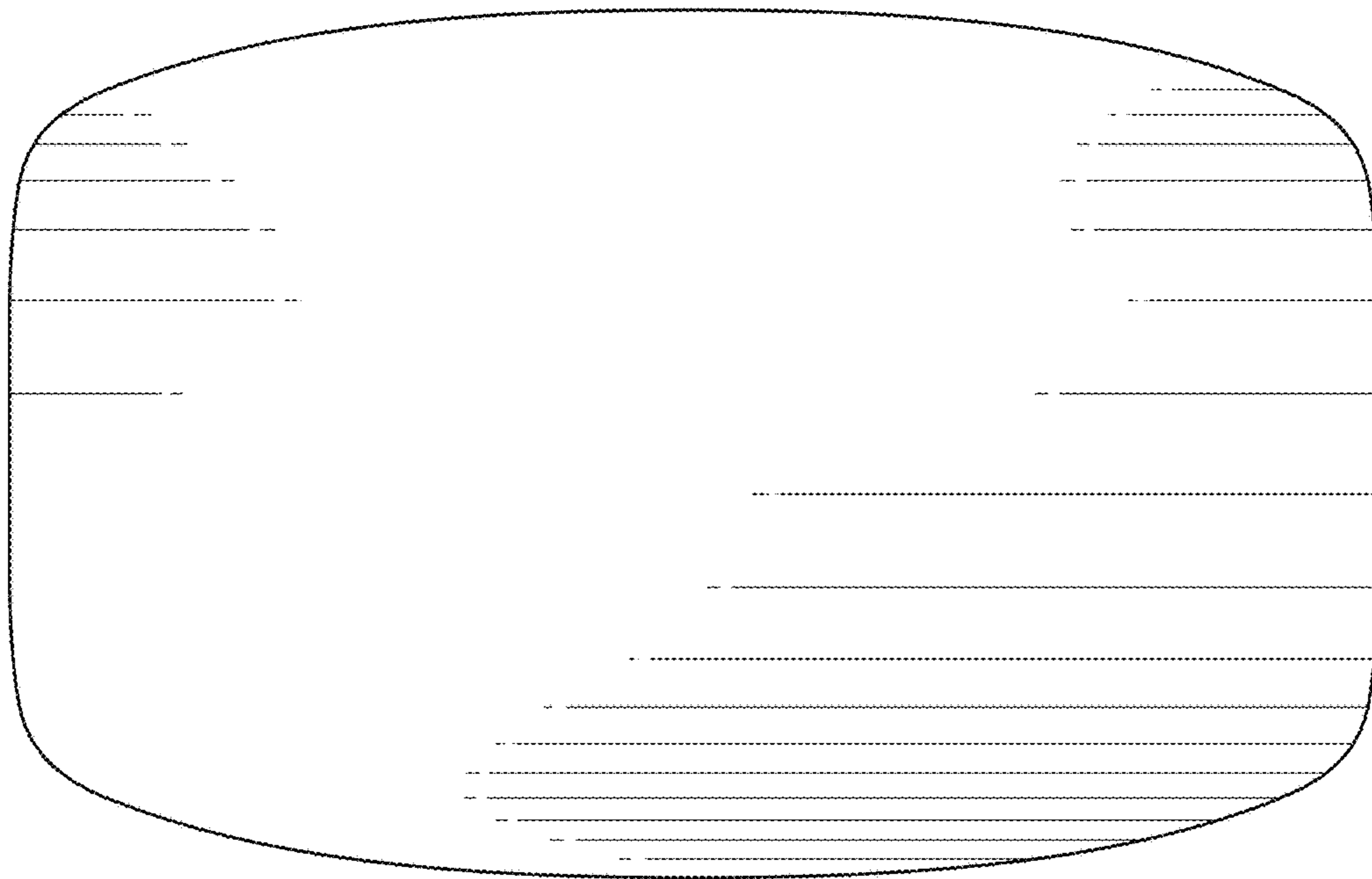

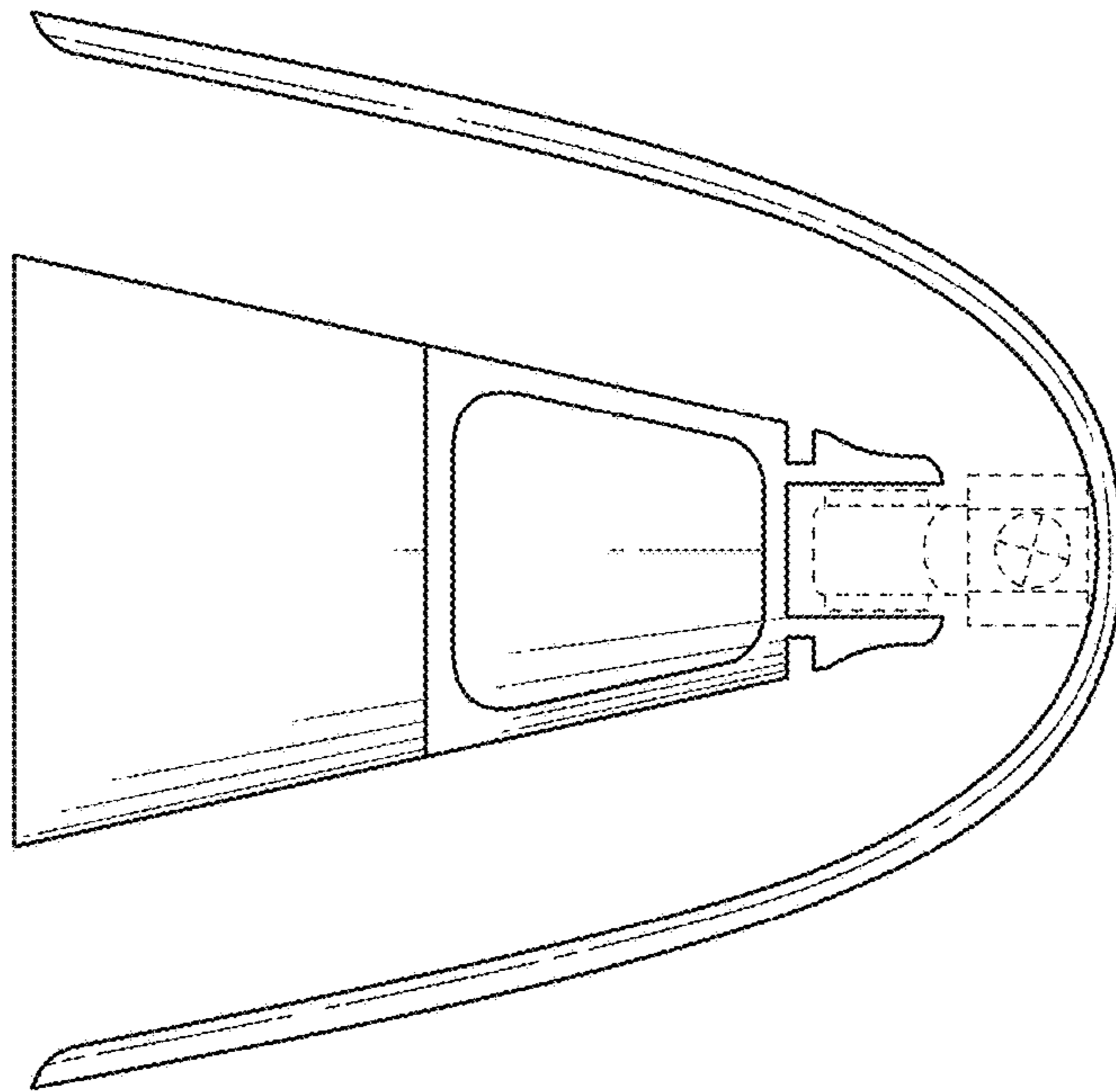

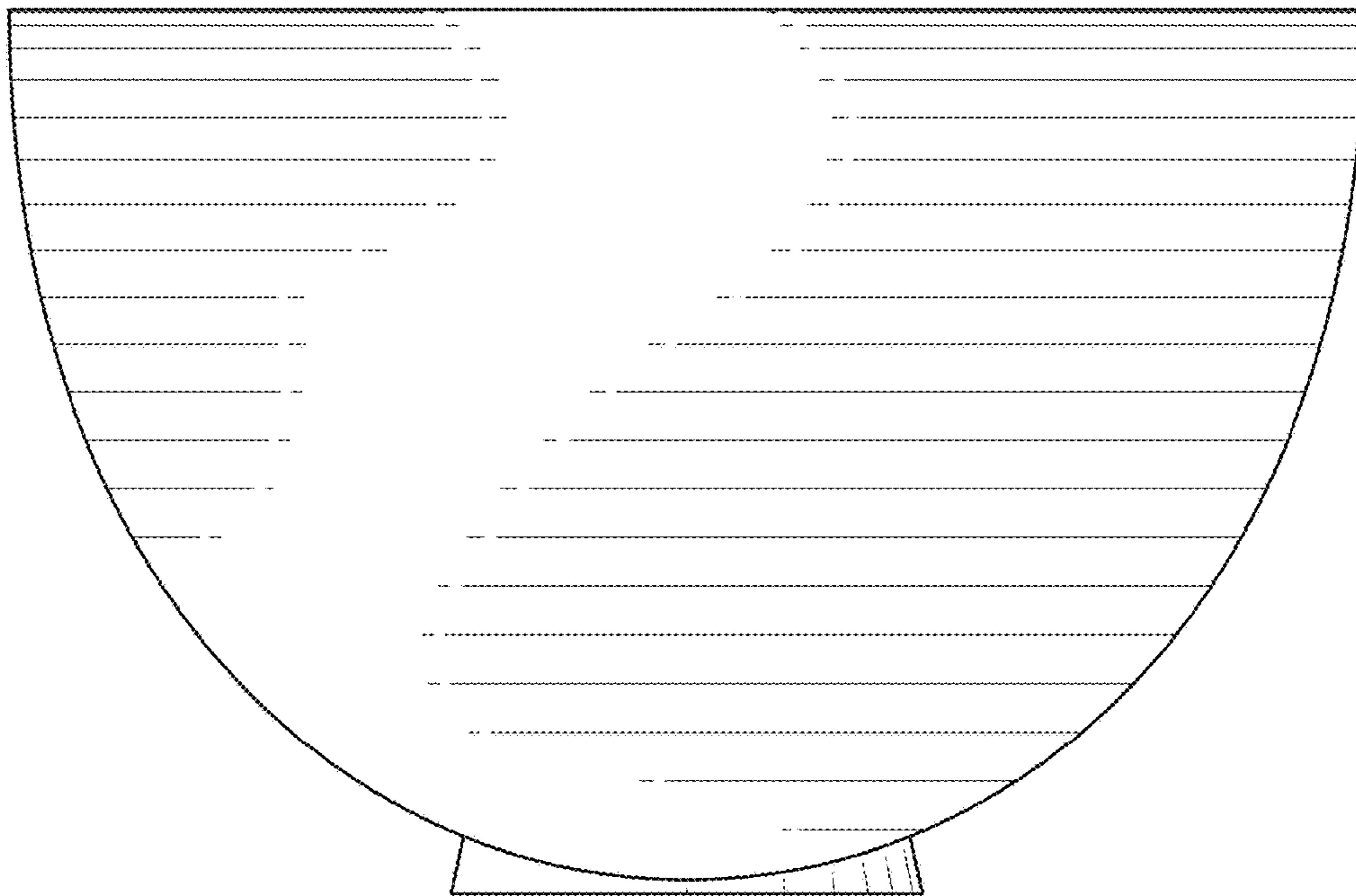

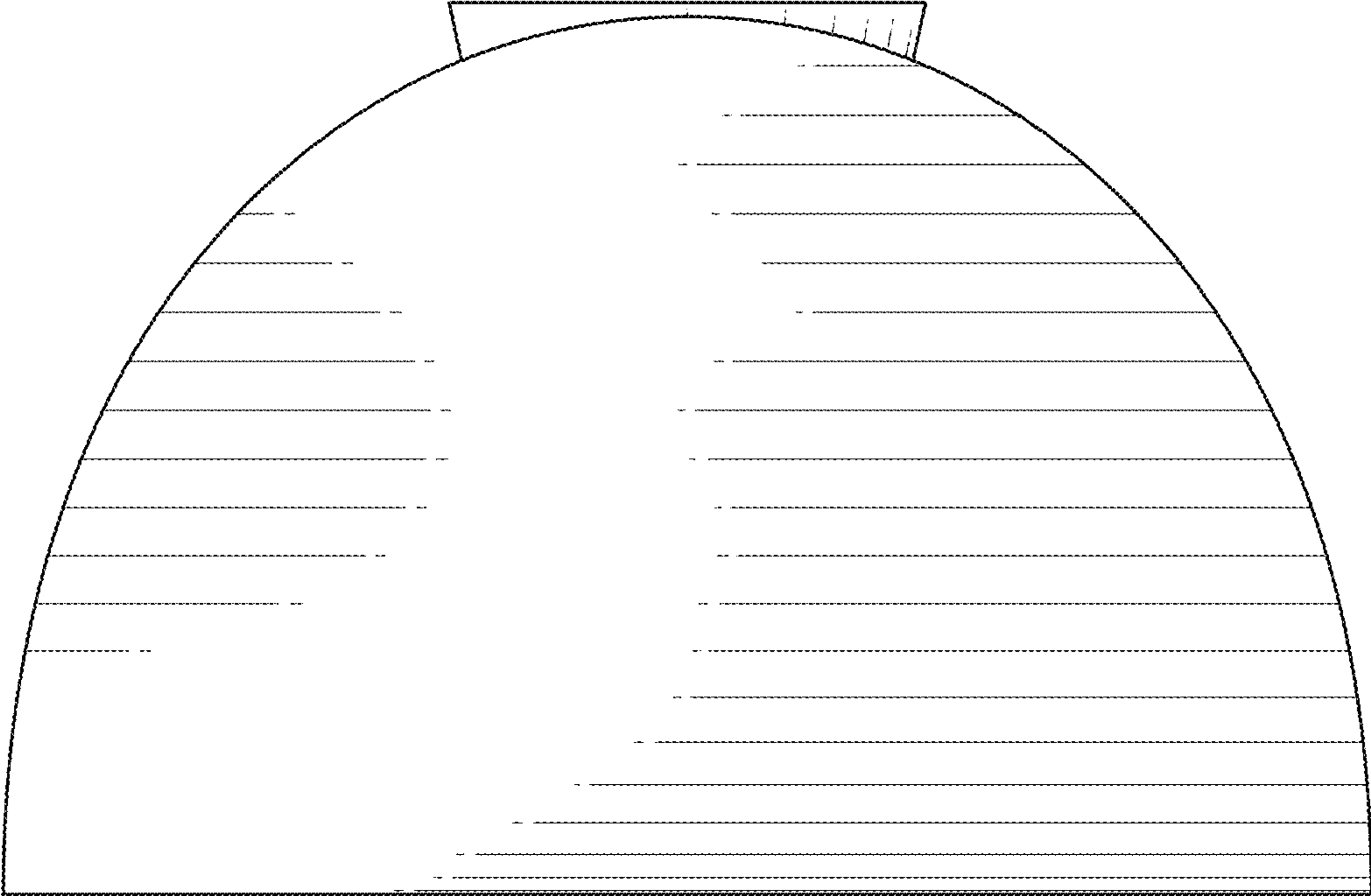
