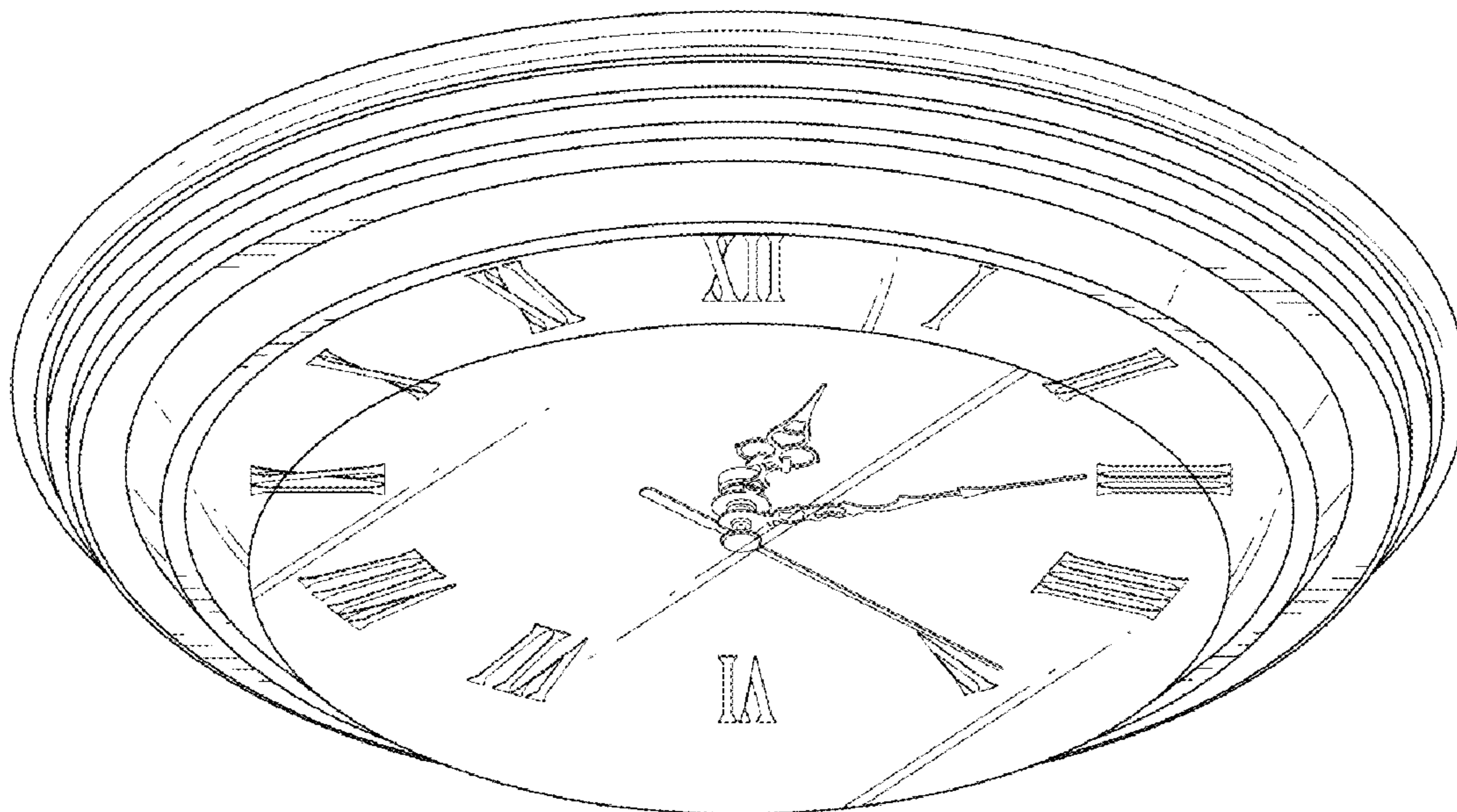
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front top perspective view of a ceiling fan light showing my new design;

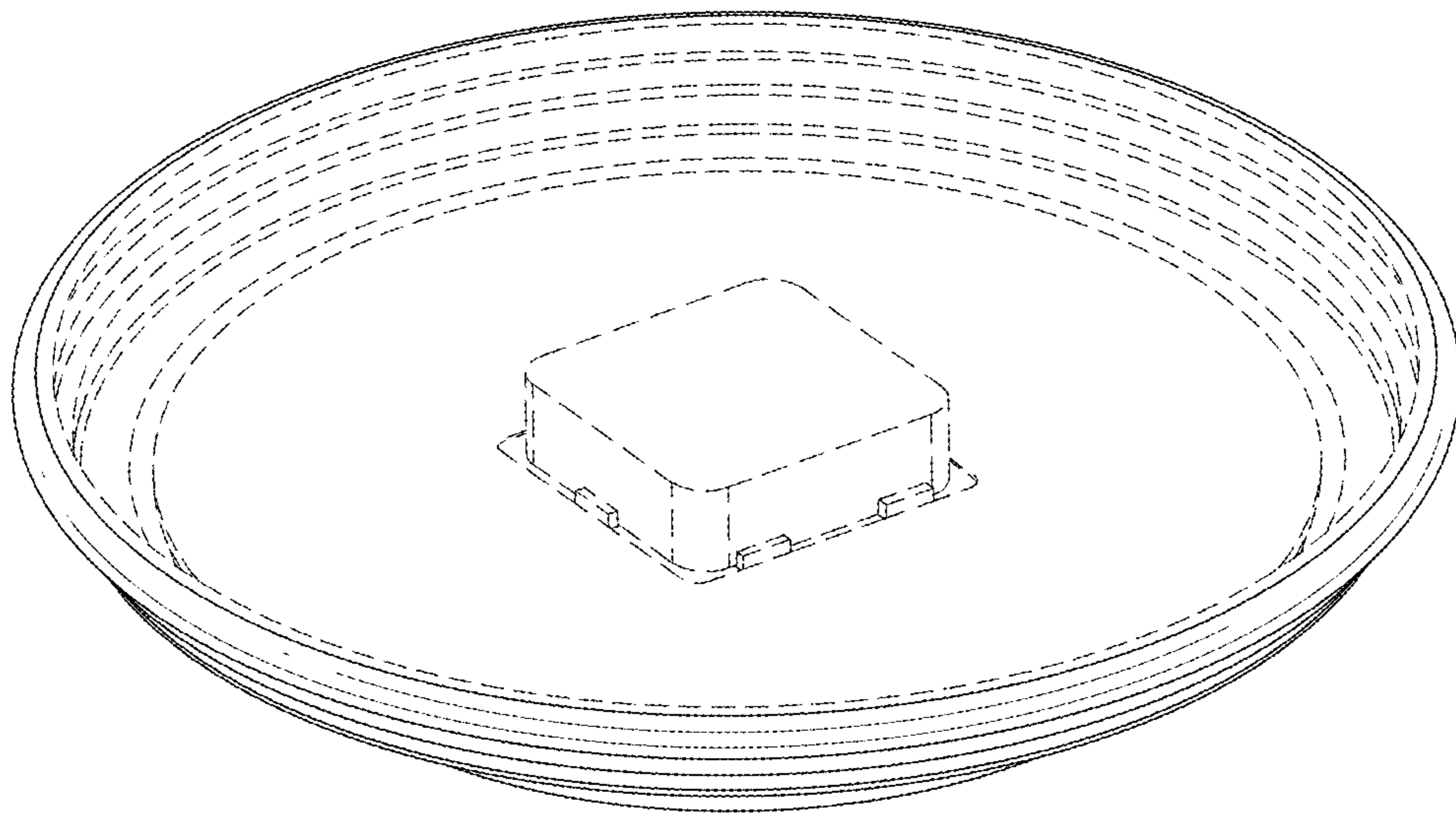

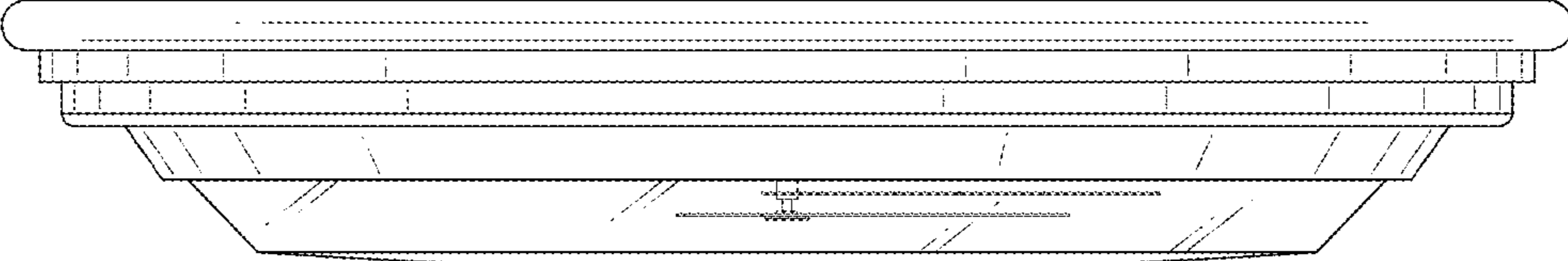

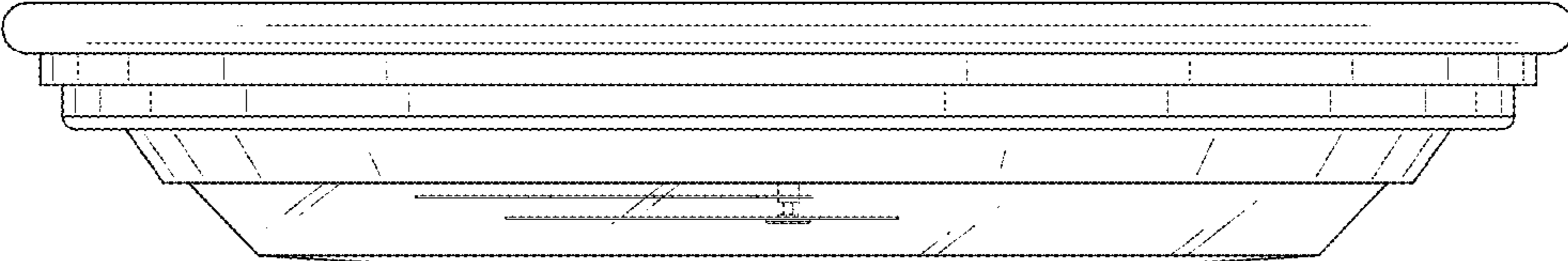

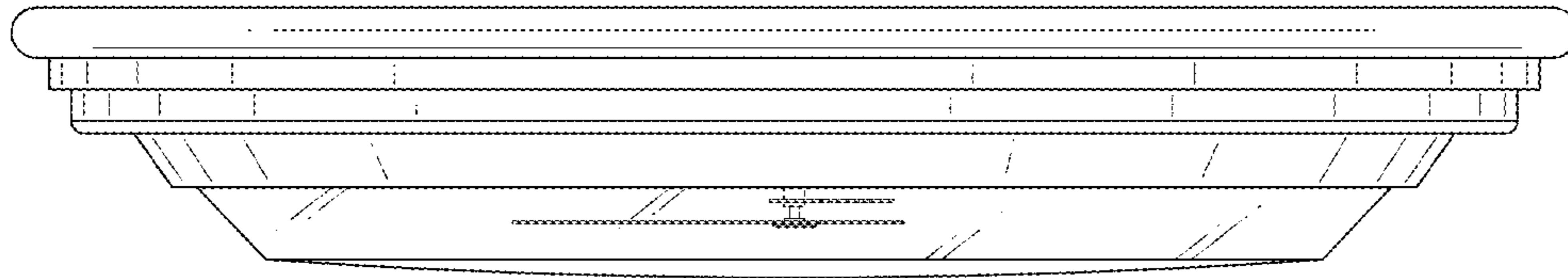

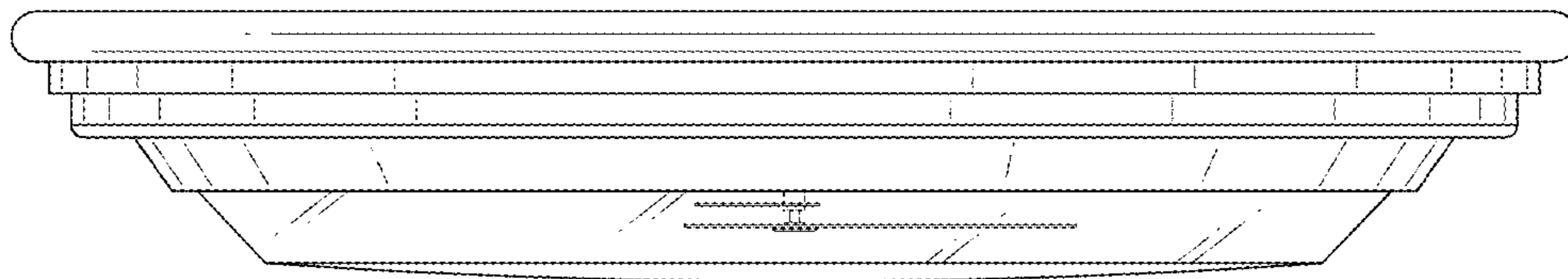

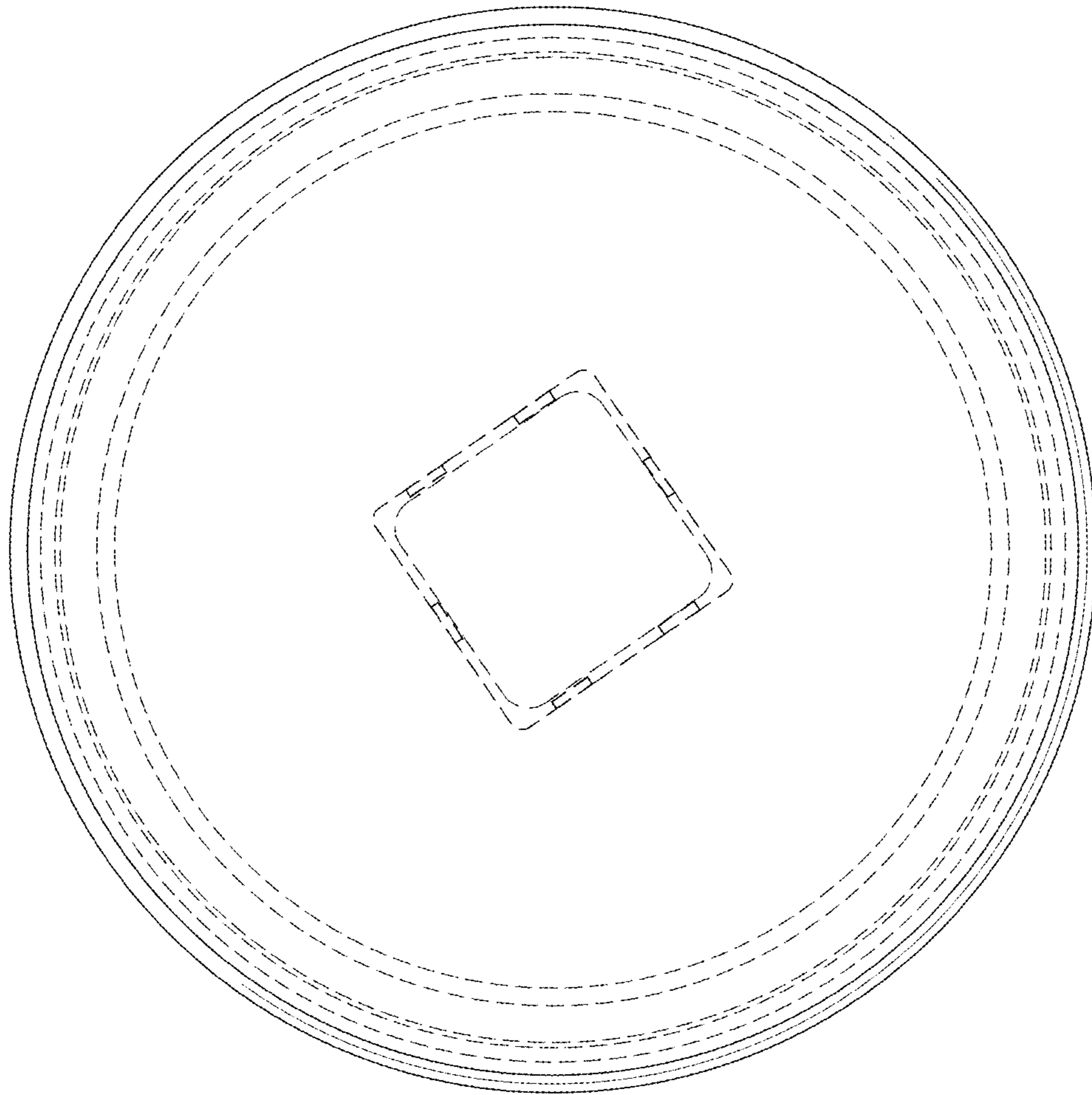

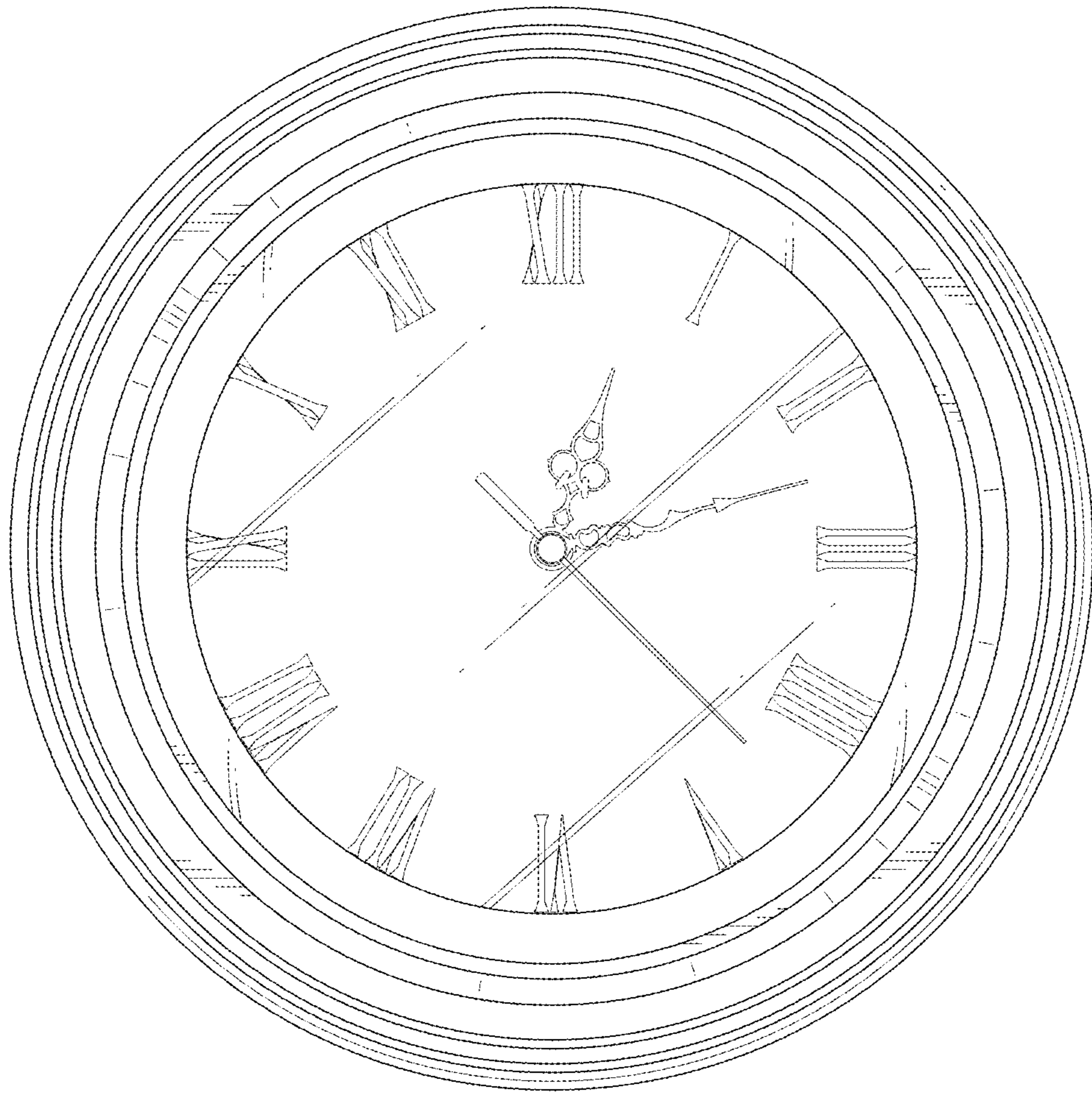

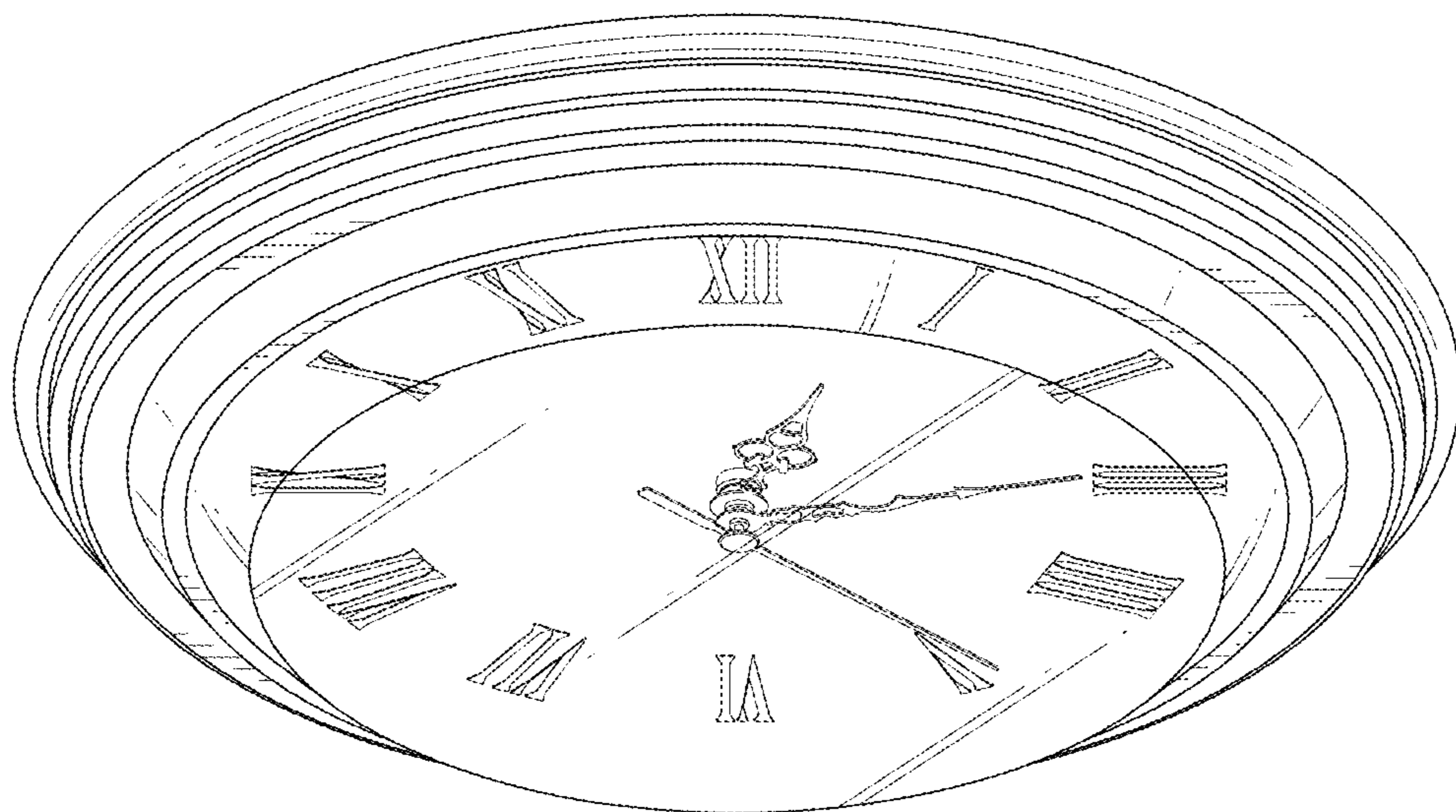
