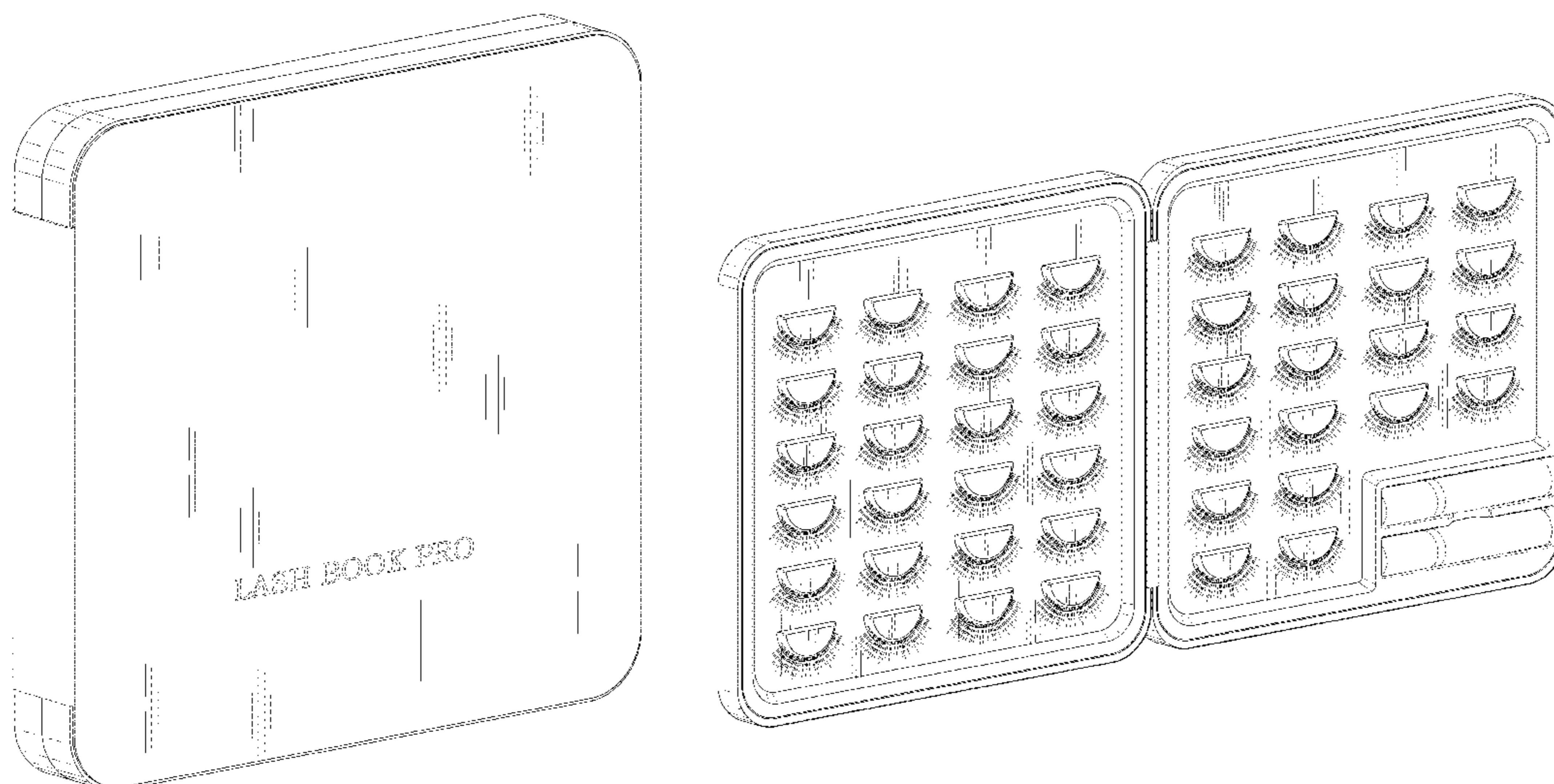
(57) **CLAIM**

The ornamental design for a false eye-lash case, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a false eye-lash case showing the new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof;  
FIG. 8 is another front perspective view of the false eye-lash case shown in FIG. 1 shown in an open position thereof;  
FIG. 9 is a front elevational view thereof;  
FIG. 10 is a rear elevational view thereof;  
FIG. 11 is a left side elevational view thereof;  
FIG. 12 is a right side elevational view thereof;  
FIG. 13 is a top plan view thereof;  
FIG. 14 is a bottom plan view thereof; and,  
FIG. 15 is another front perspective view thereof.

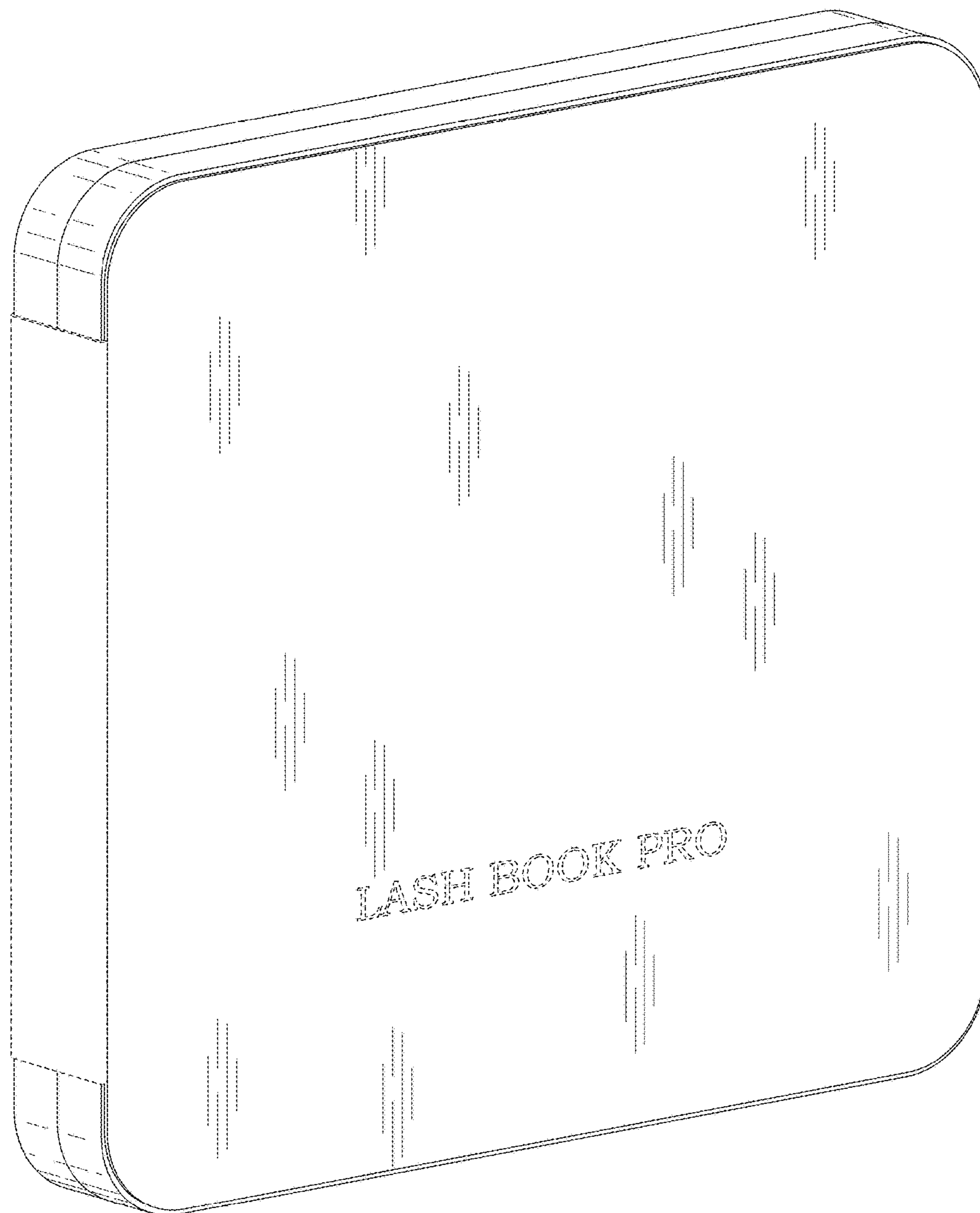

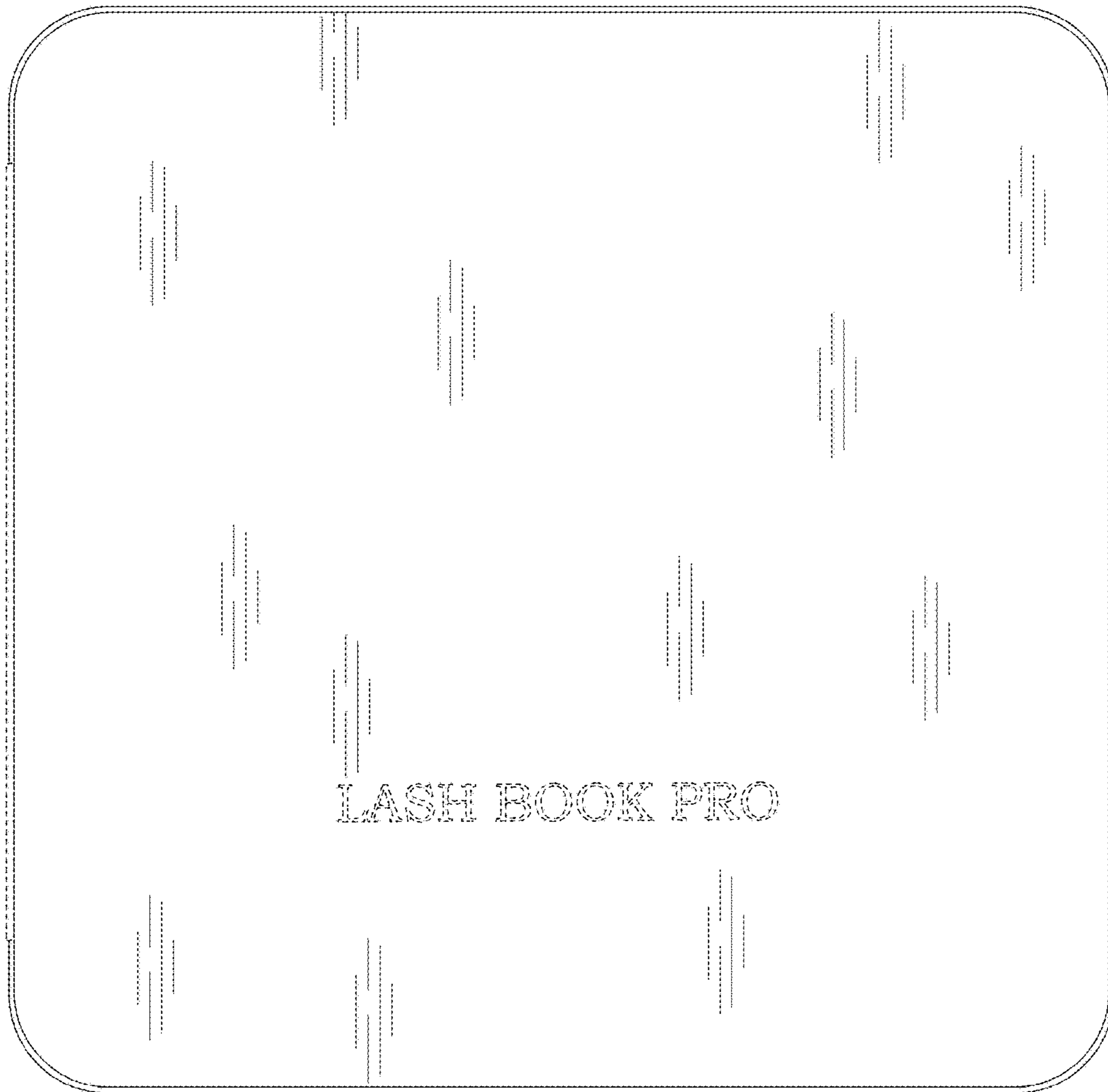

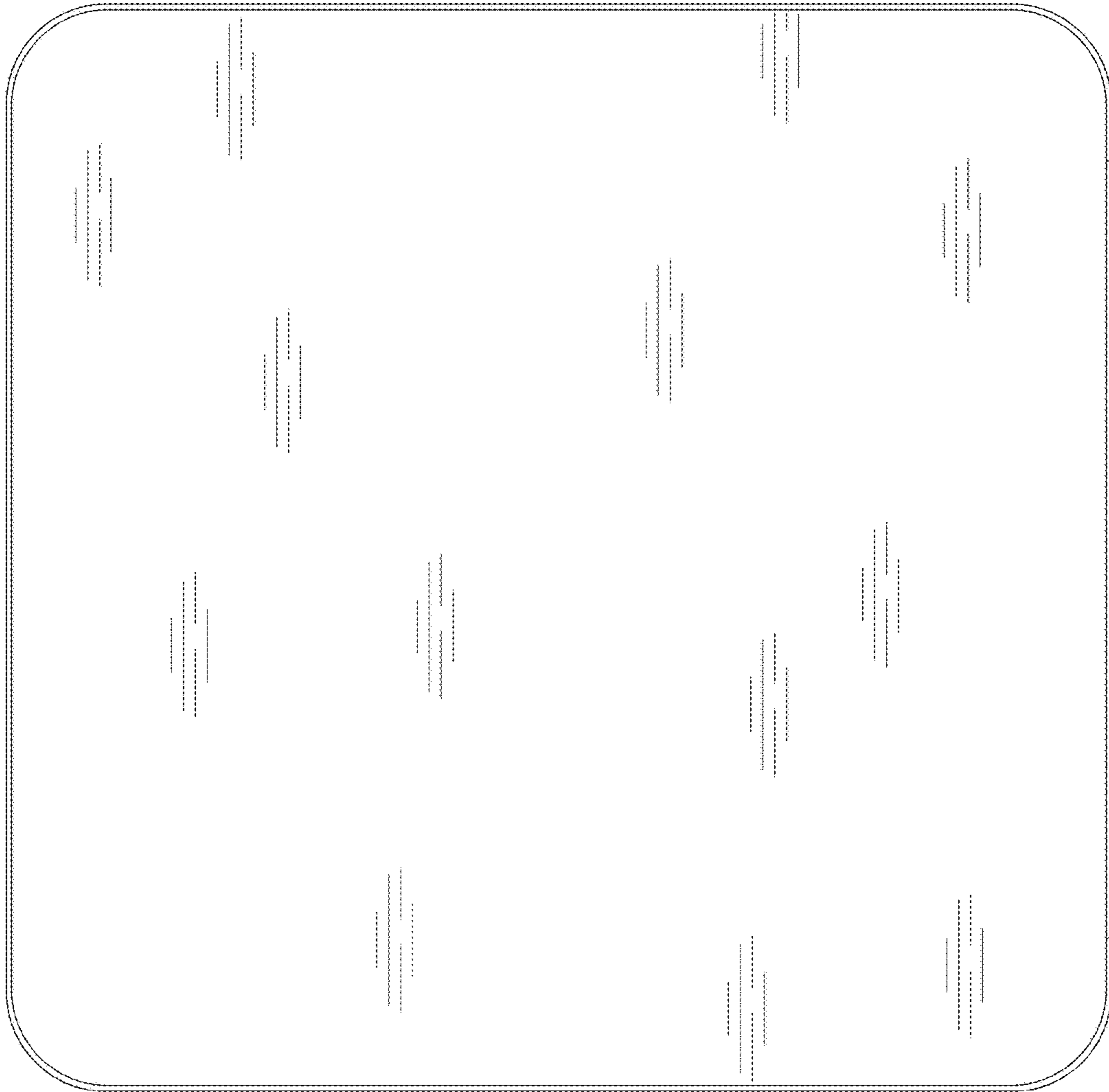

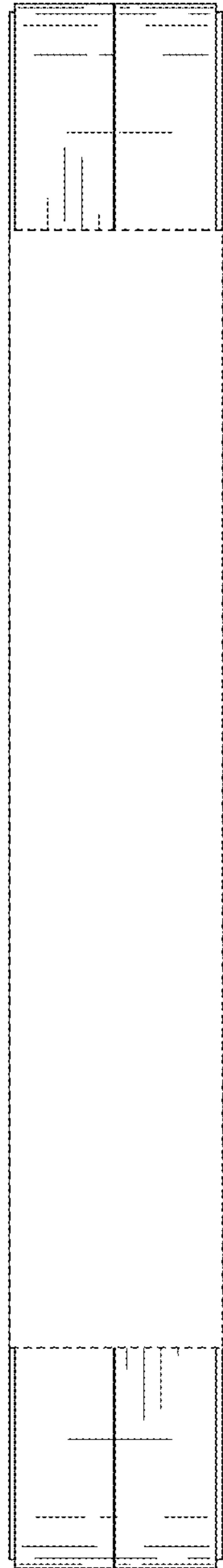

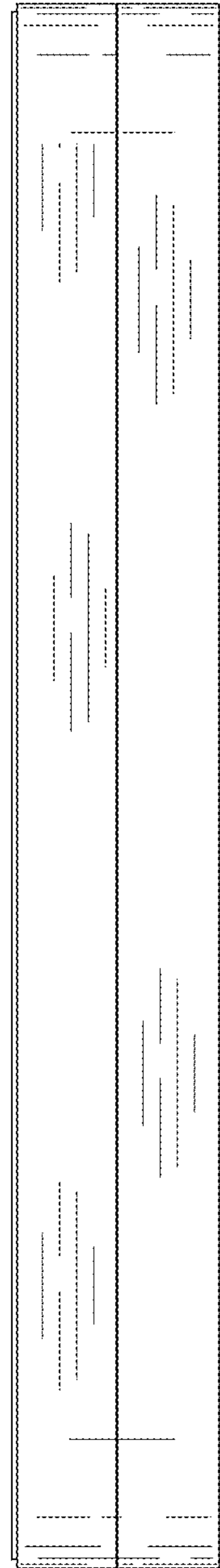

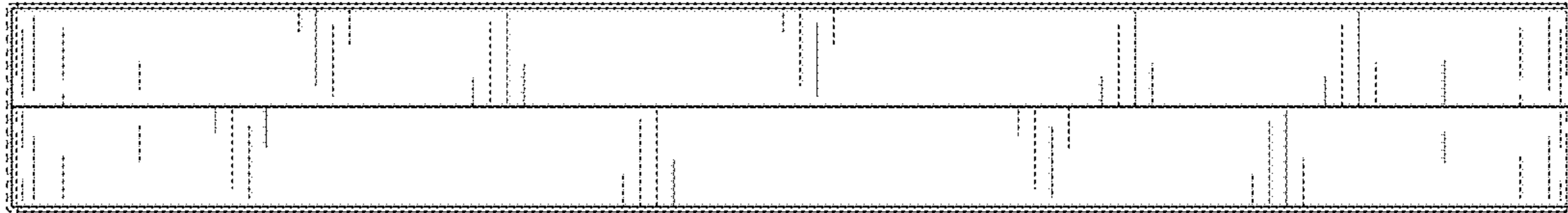

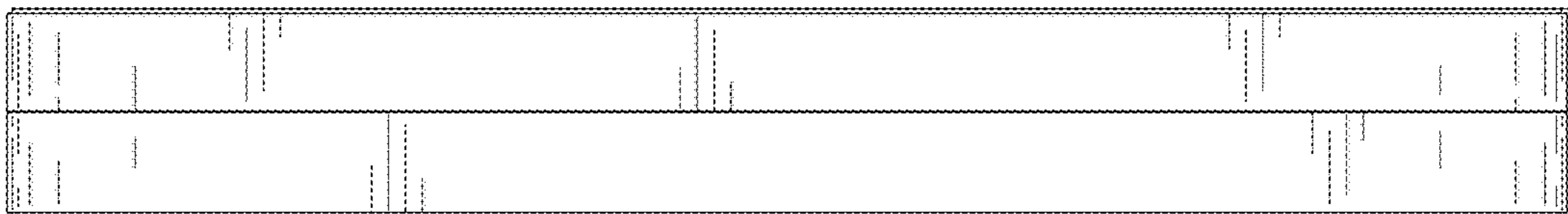

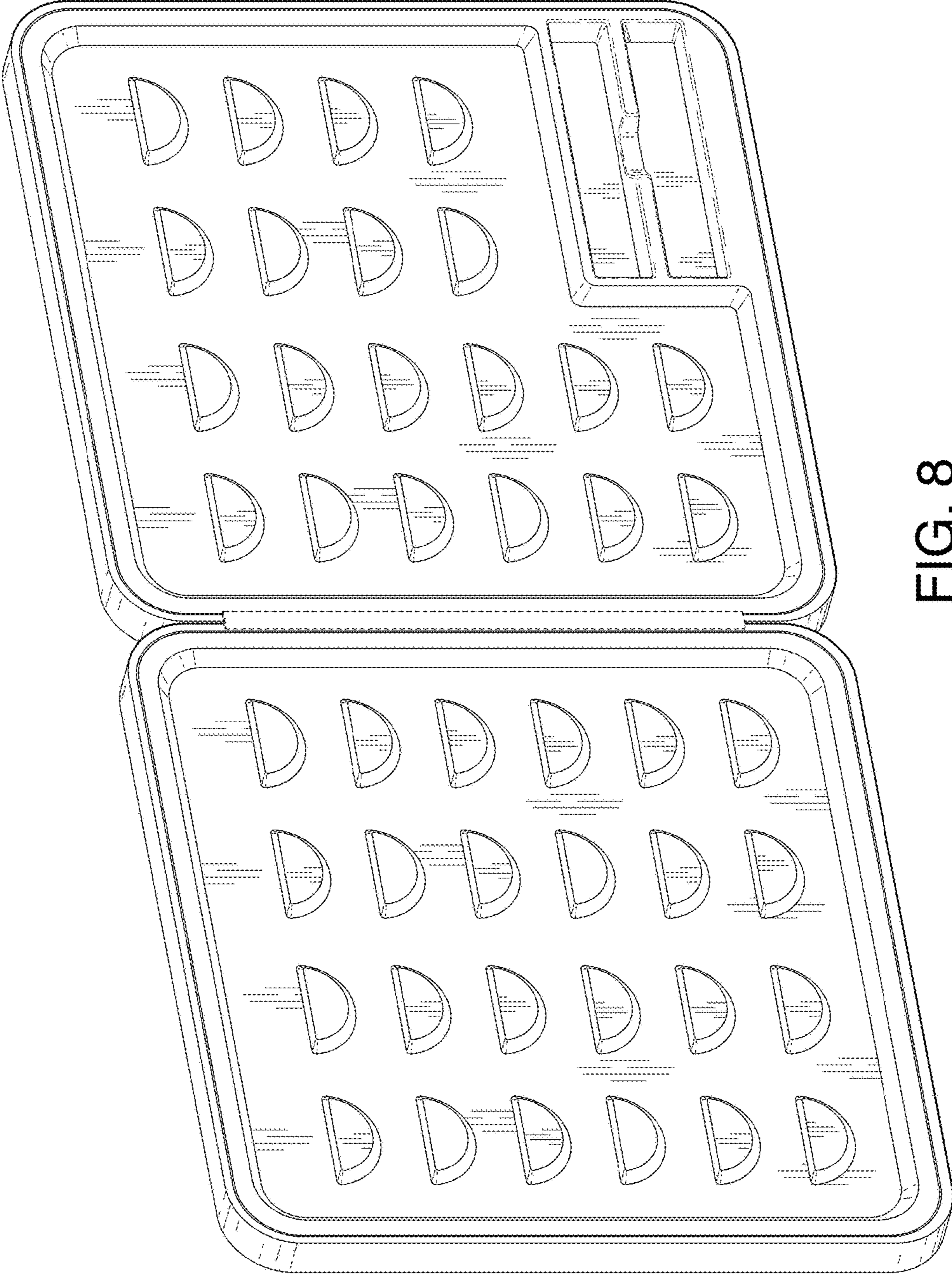

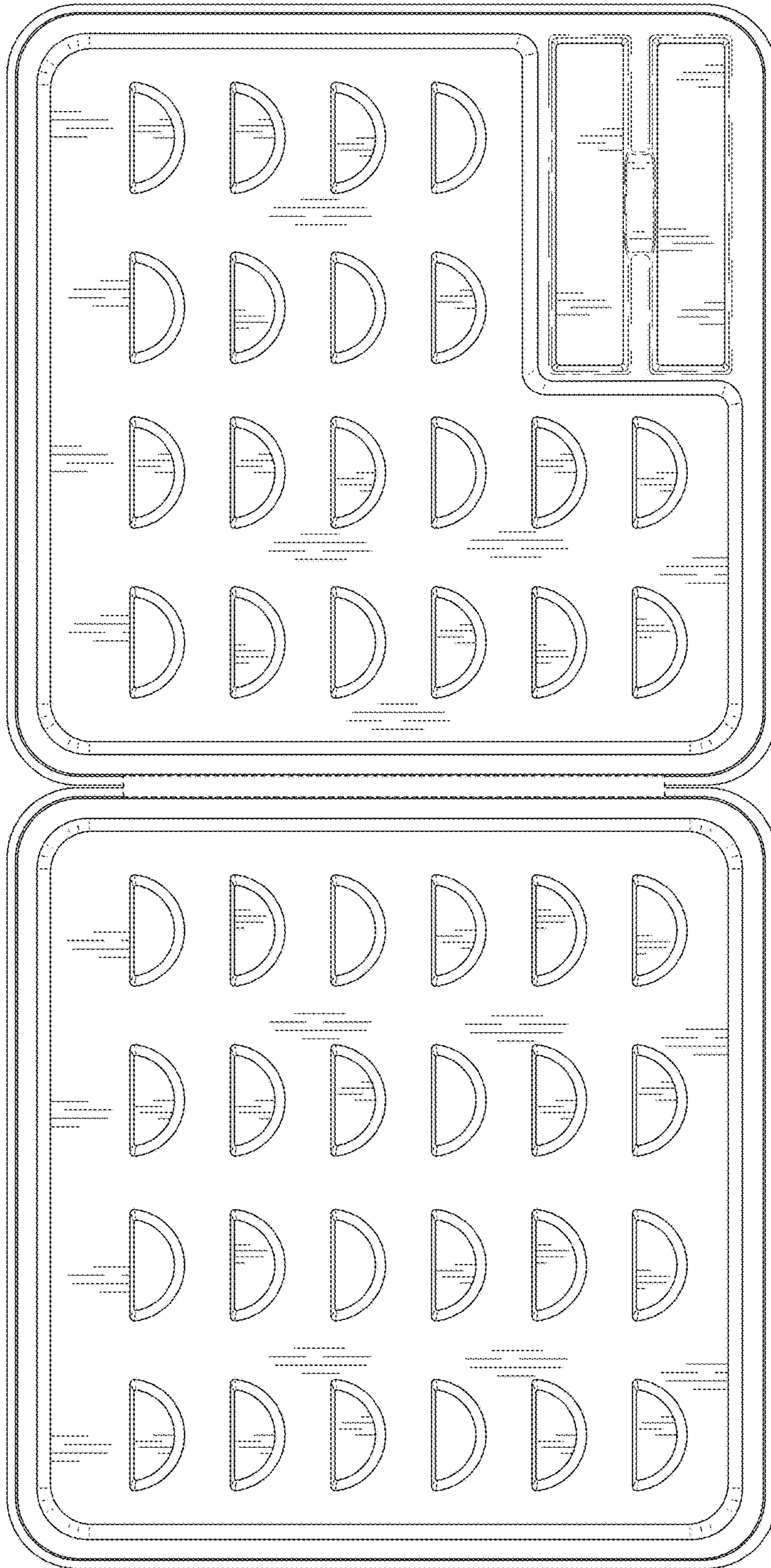

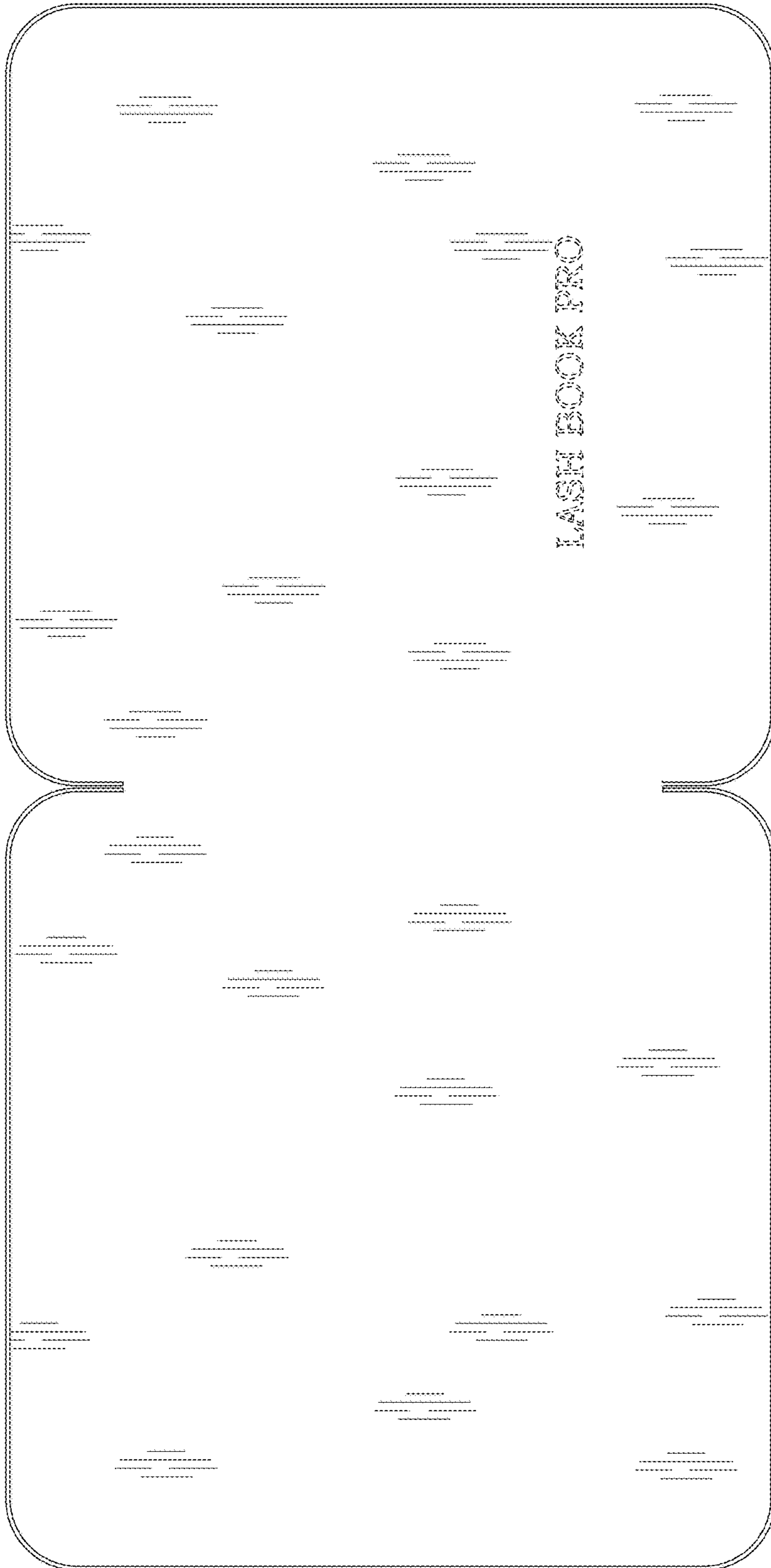

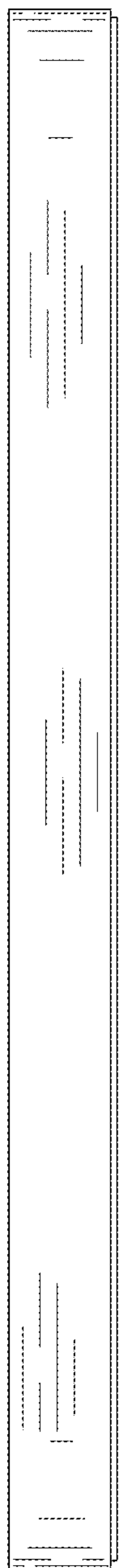

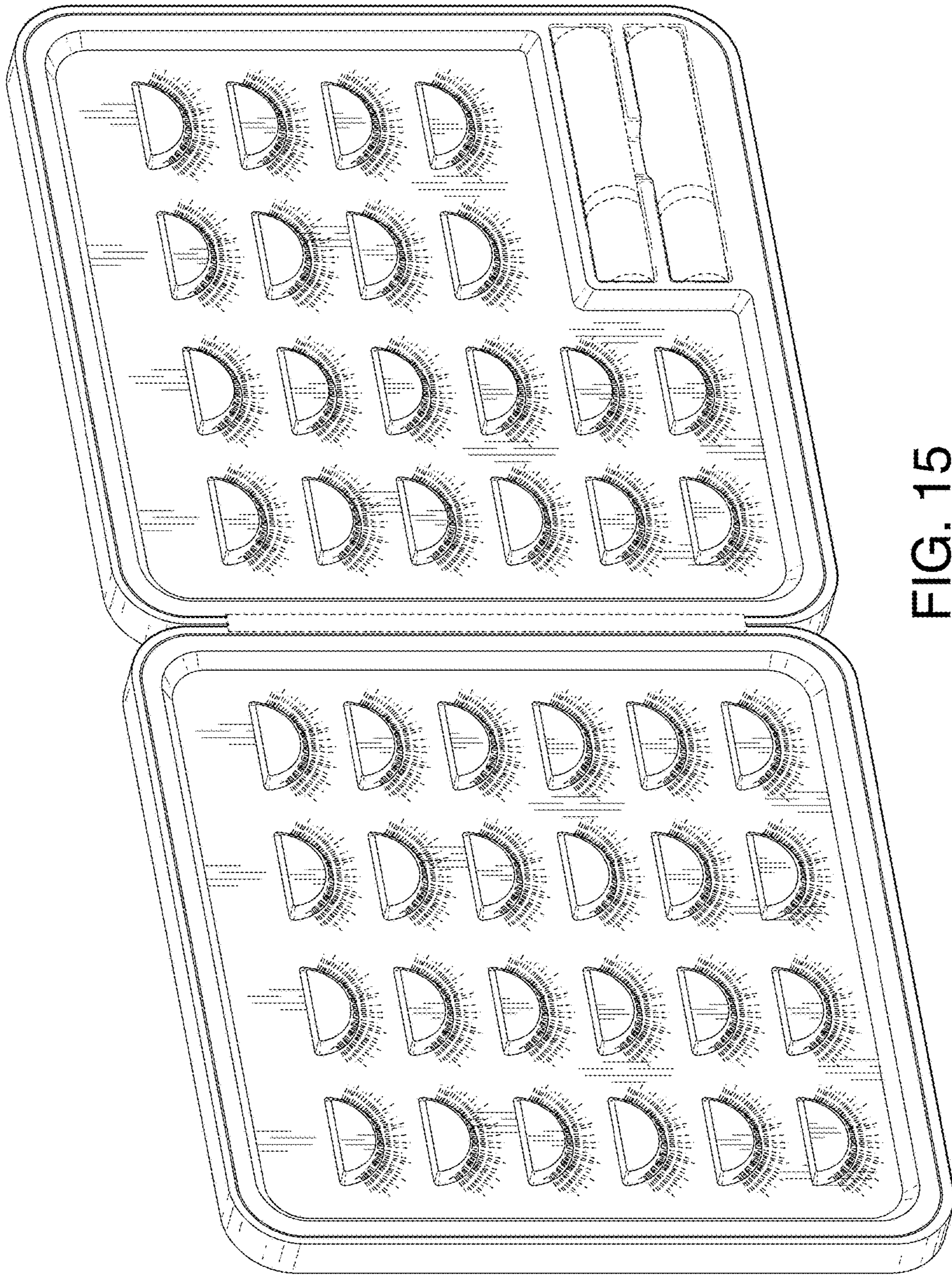
