(57) **CLAIM**

The ornamental design for an X-strap dog harness, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an X-strap dog harness showing my new design; and,

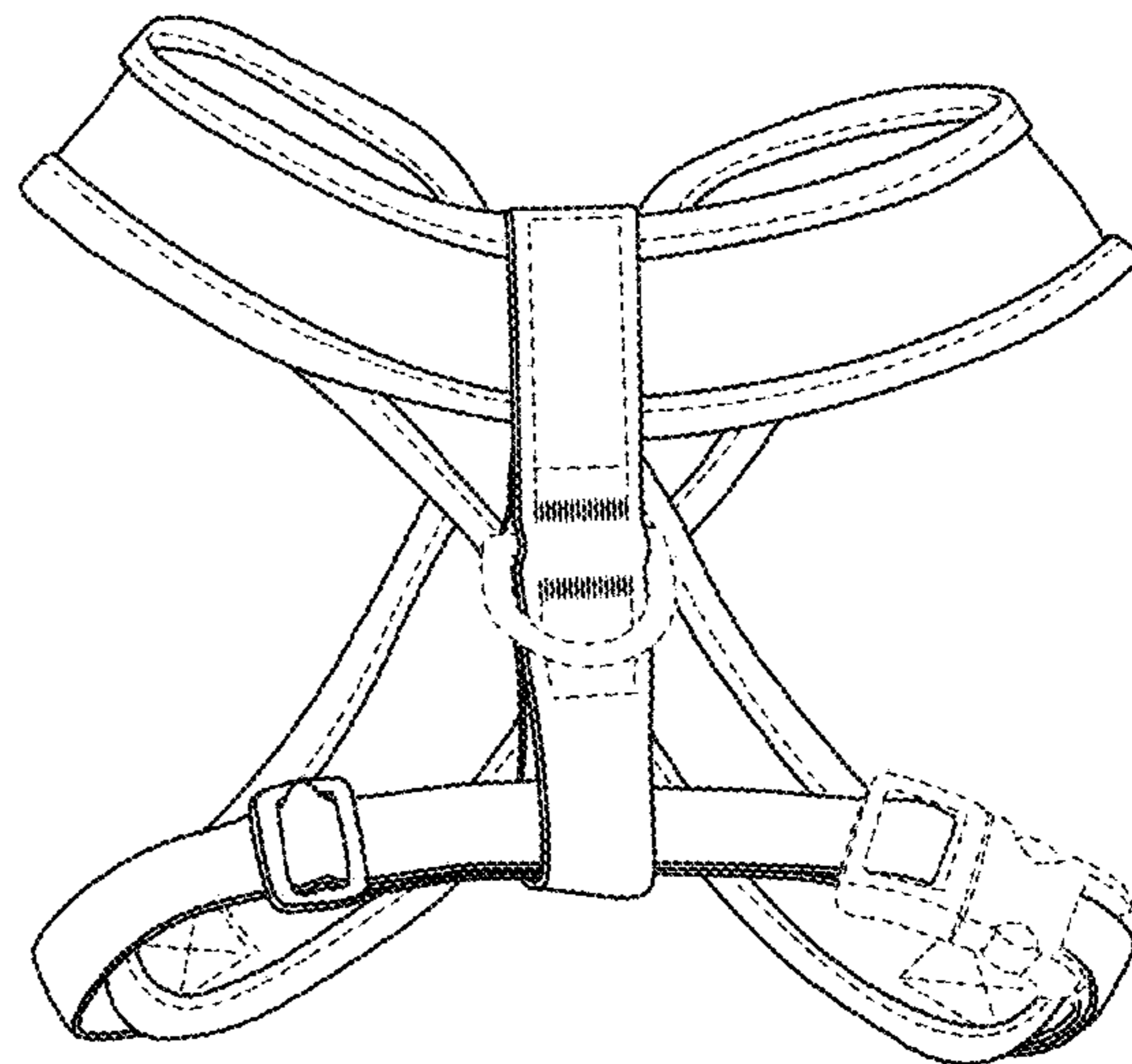
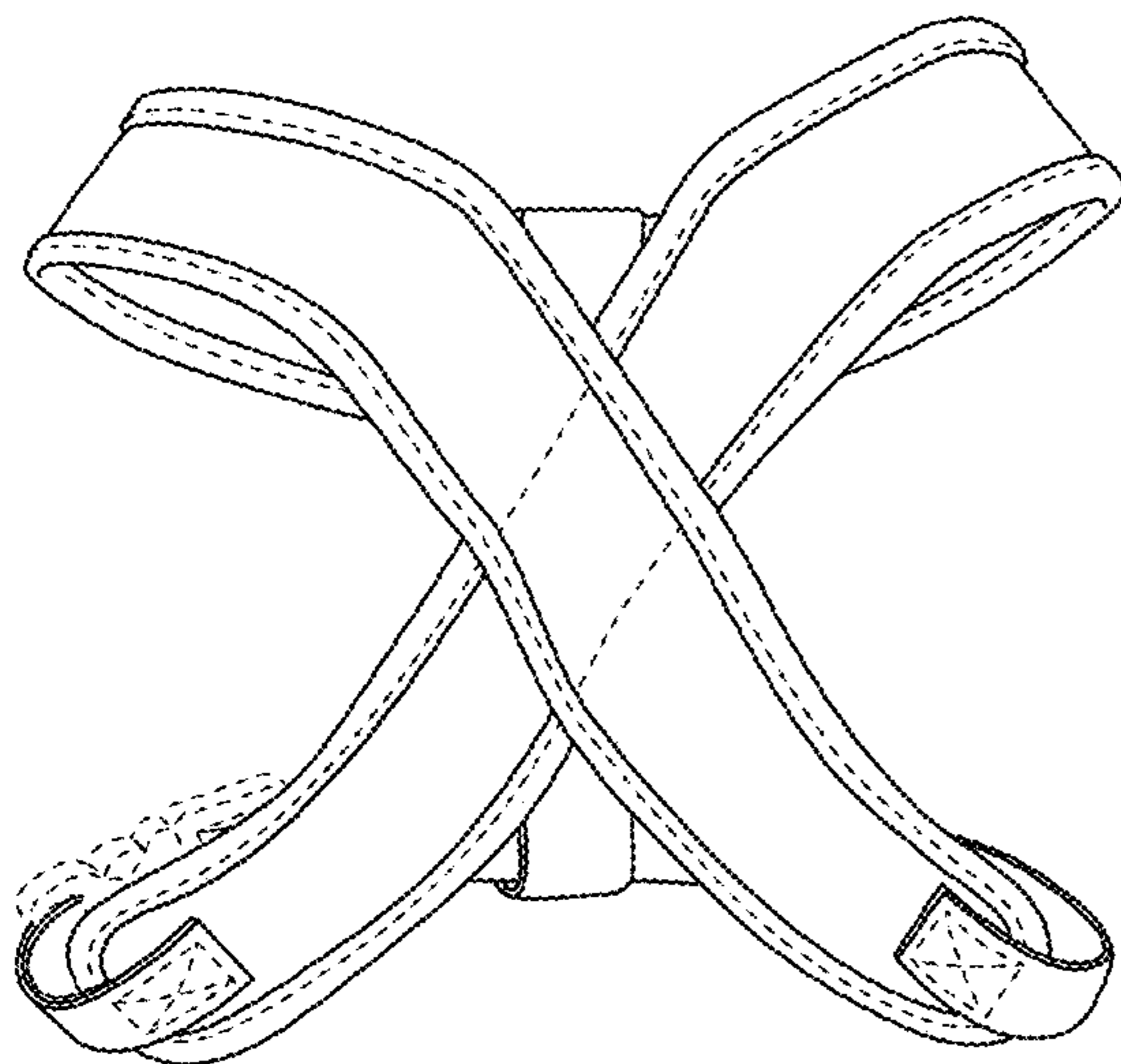

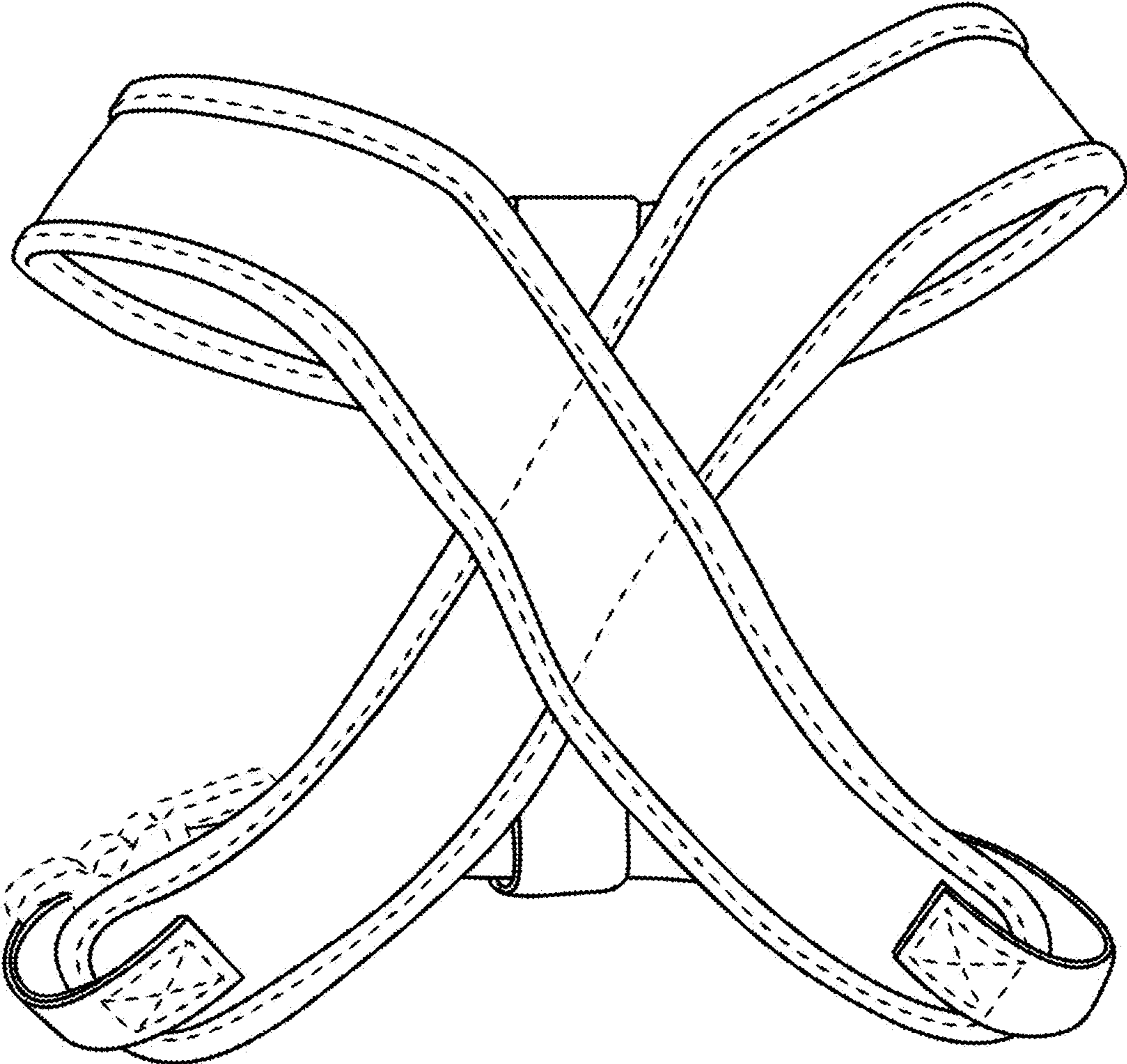
