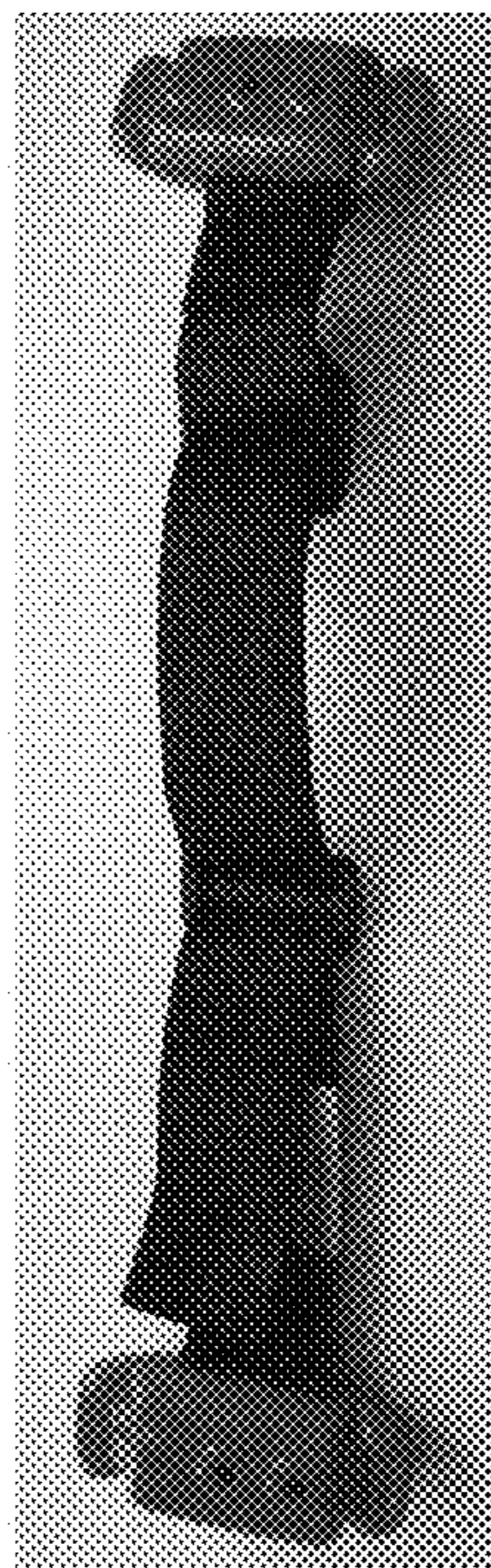
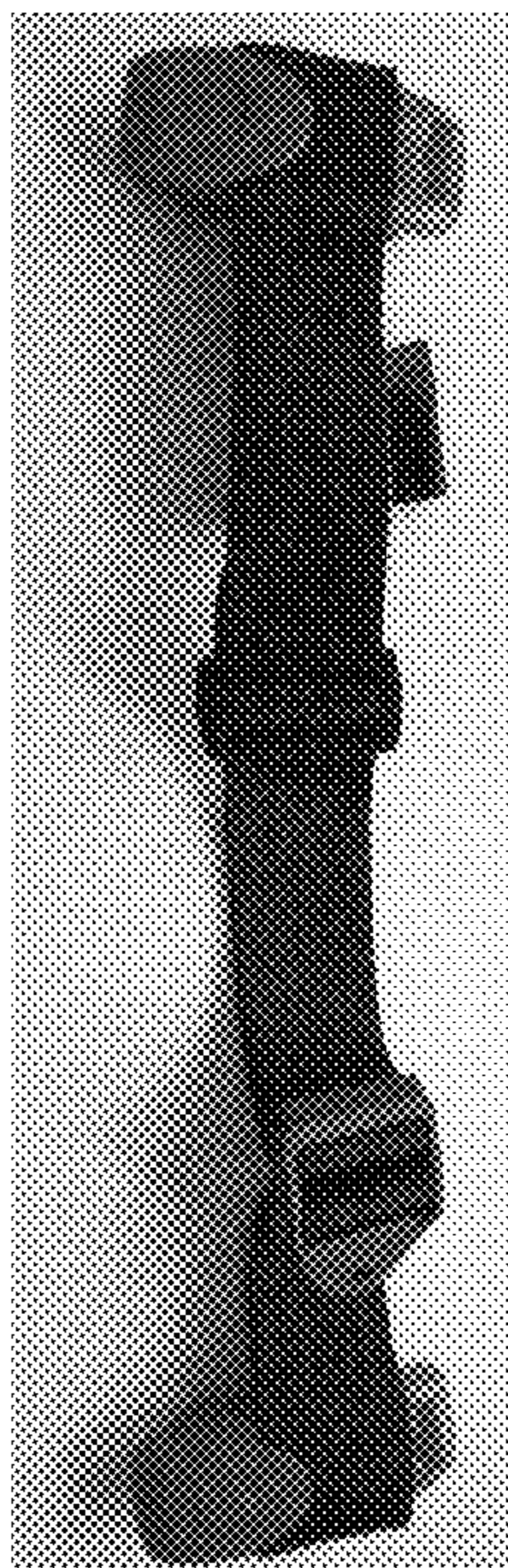
The ornamental design for a safety belt for the seats of vehicles, as shown and described.
