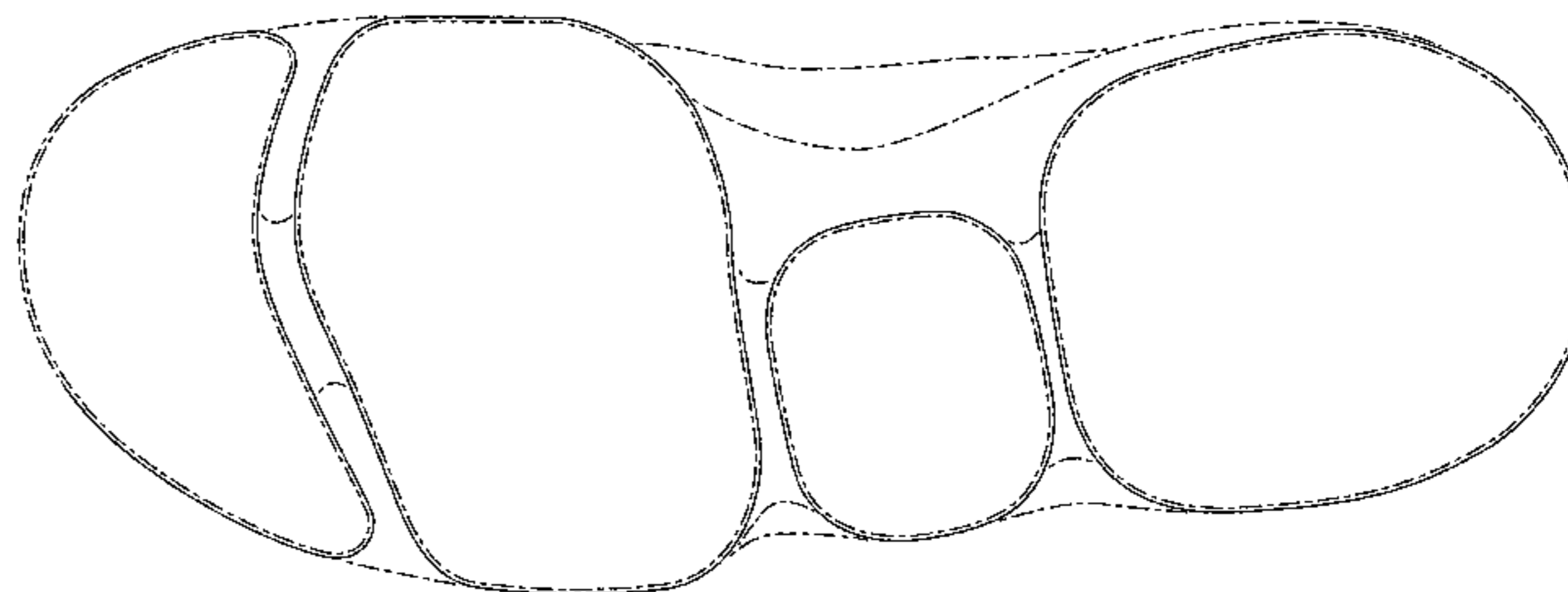
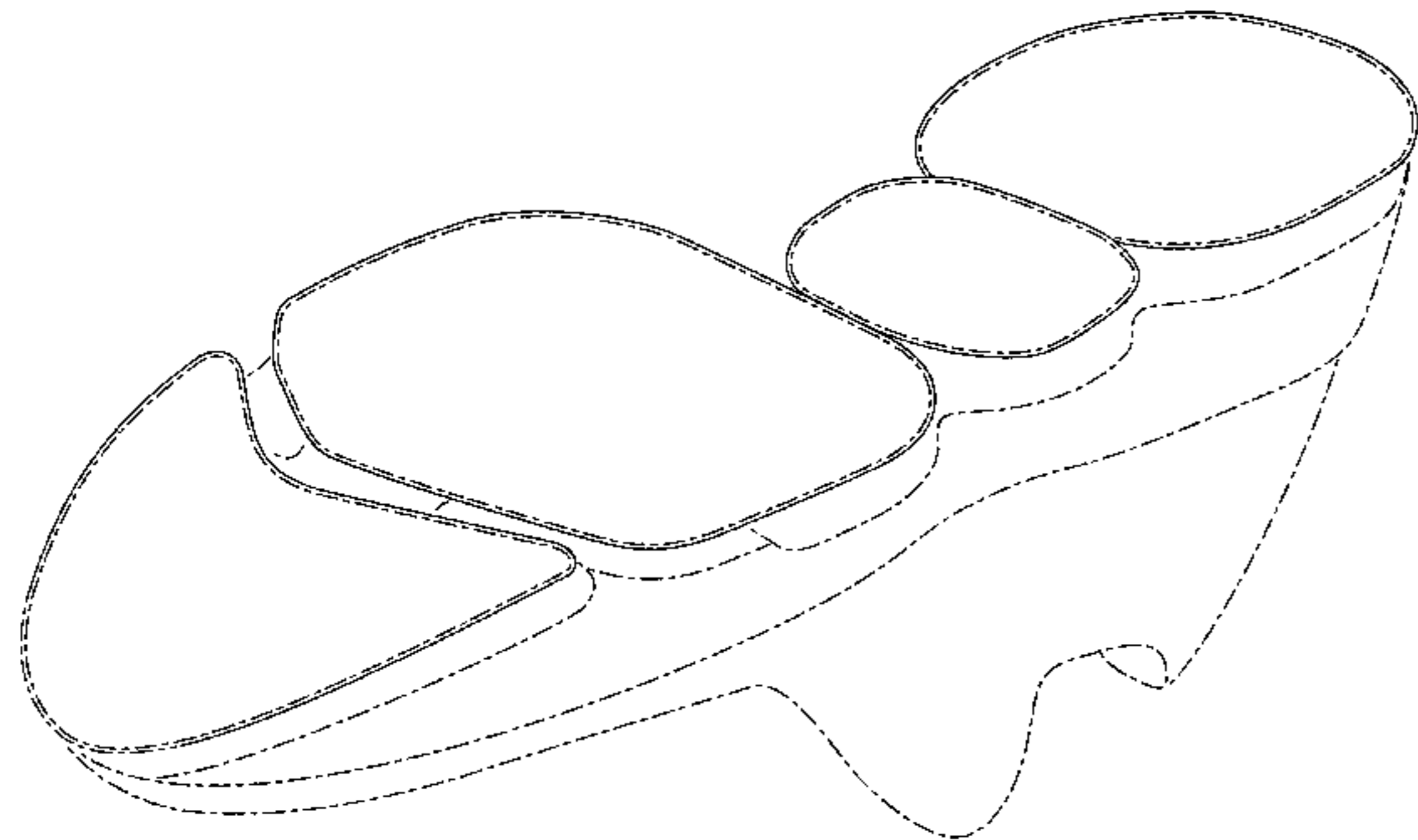
(57) **CLAIM**

The ornamental design for a shoe outsole, as shown and described.

**DESCRIPTION**

FIG. 1 is a front bottom perspective view of a shoe outsole showing my new design;  
FIG. 2 is a bottom view thereof;  
FIG. 3 is a rear bottom perspective view thereof;  
FIG. 4 is a second front bottom perspective view thereof; and,  
FIG. 5 is a second rear bottom perspective view thereof.  
The broken lines immediately adjacent to the solid line outsole pod lines and the unshaded area therein form no part of the claimed design. The broken lines showing the remainder of the shoe represent unclaimed subject matter and form no part of the claimed design.

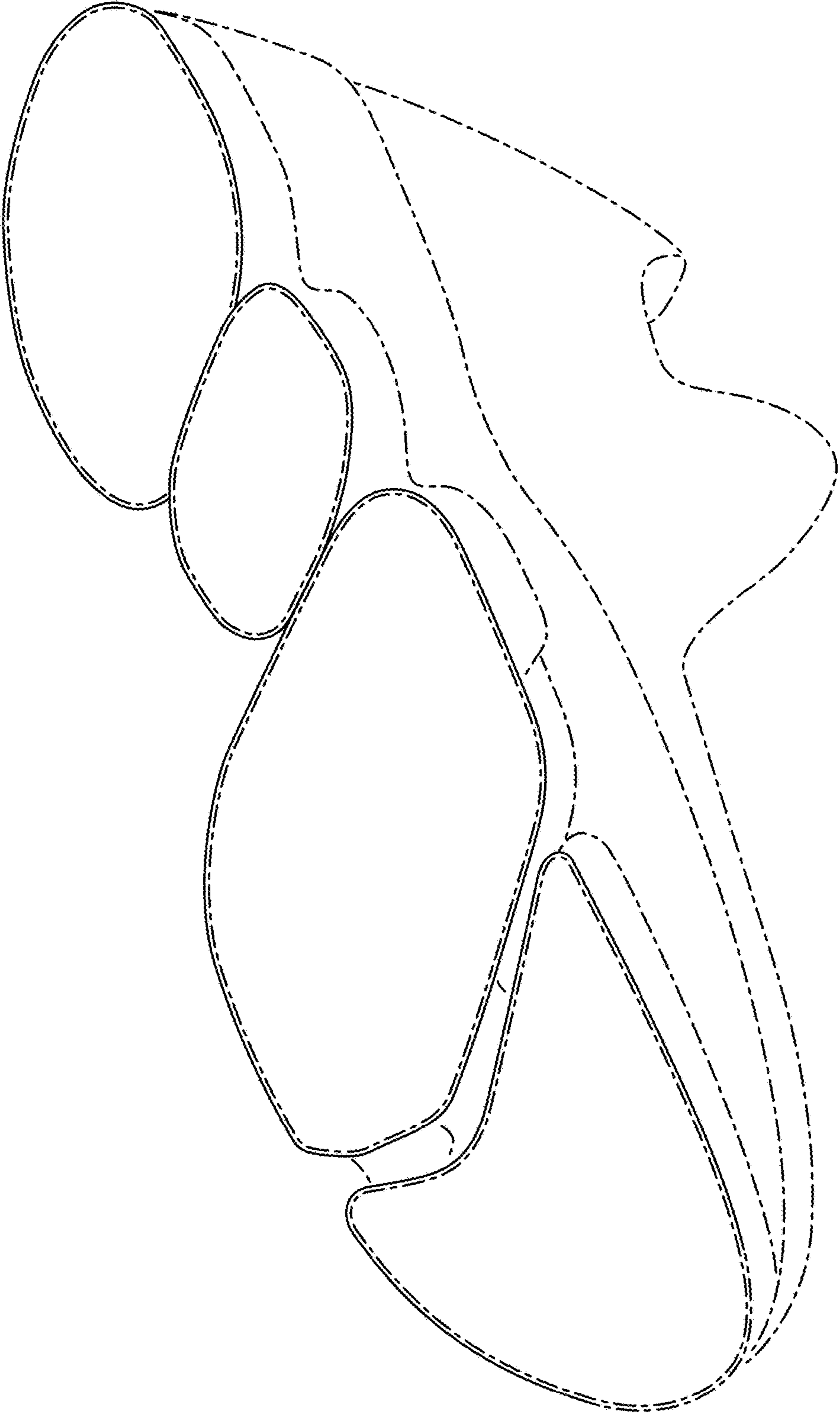

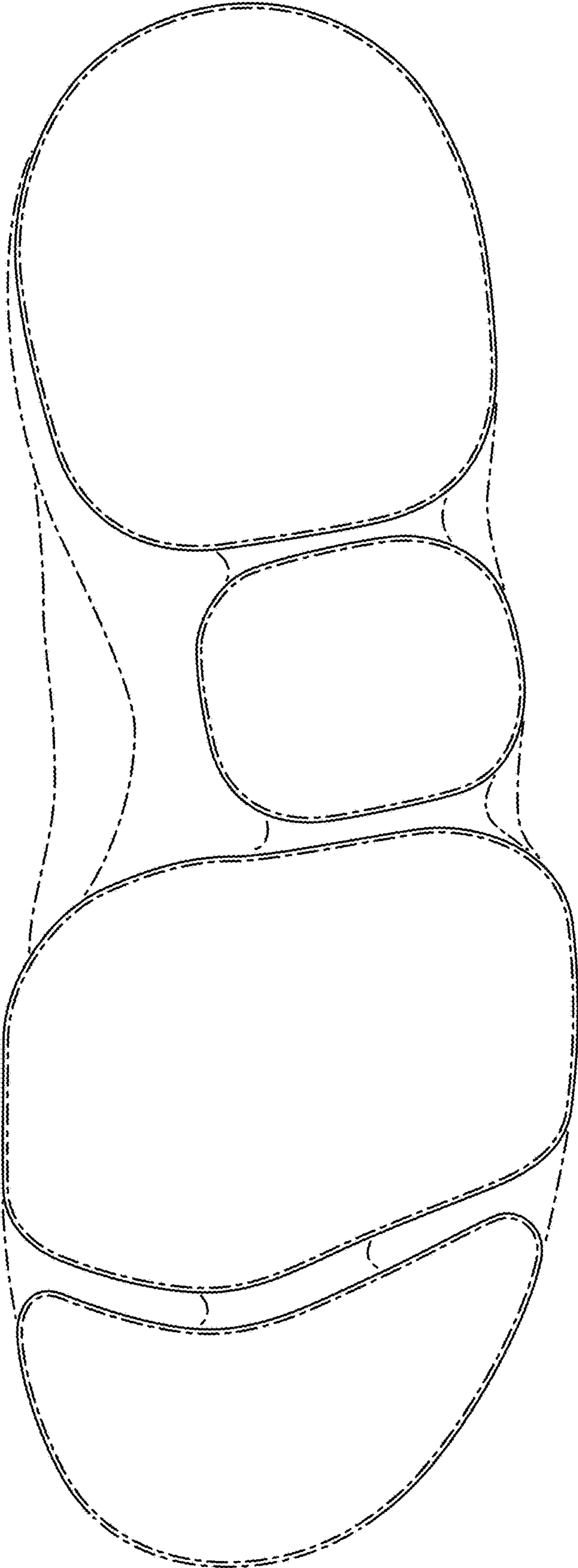

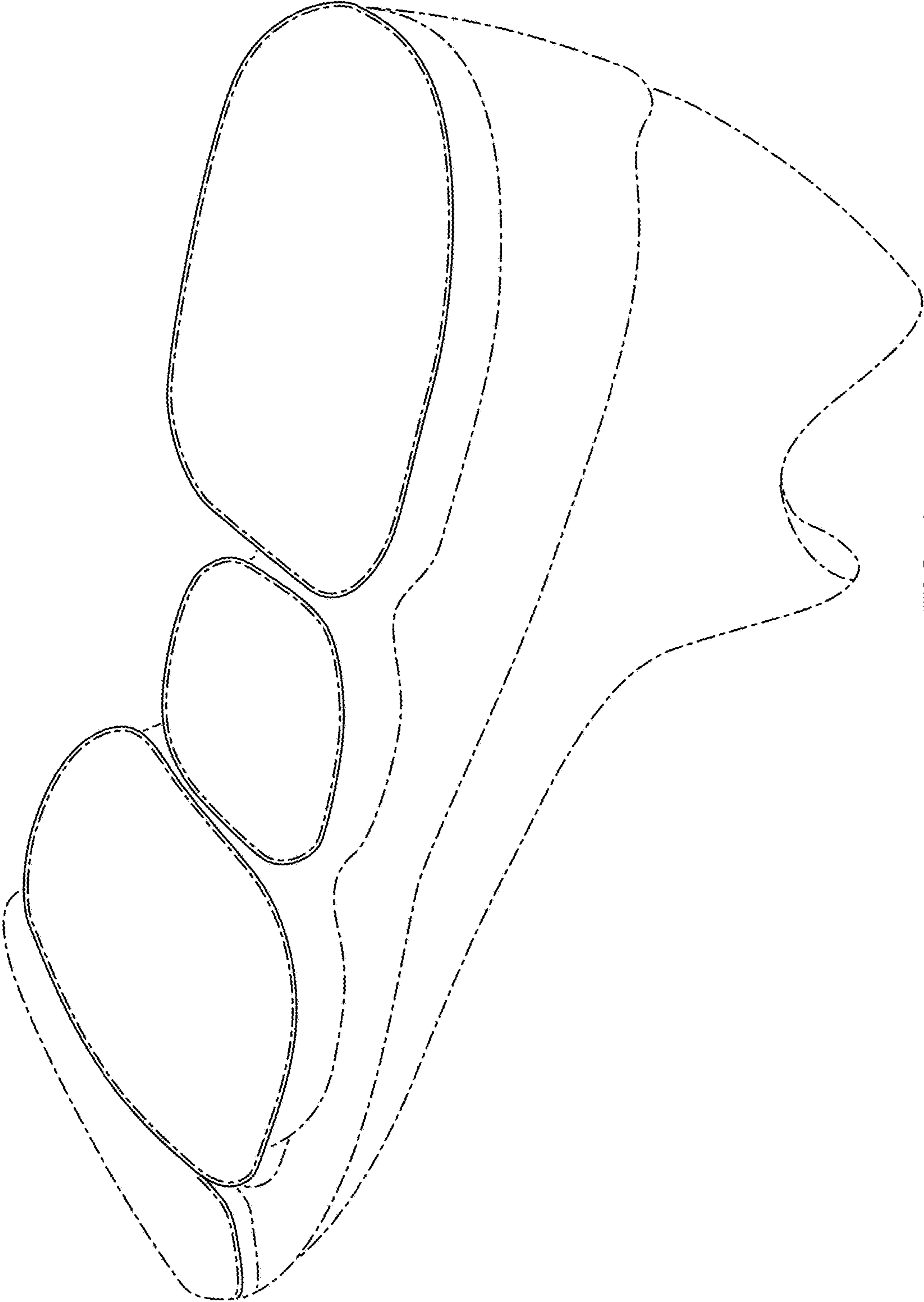

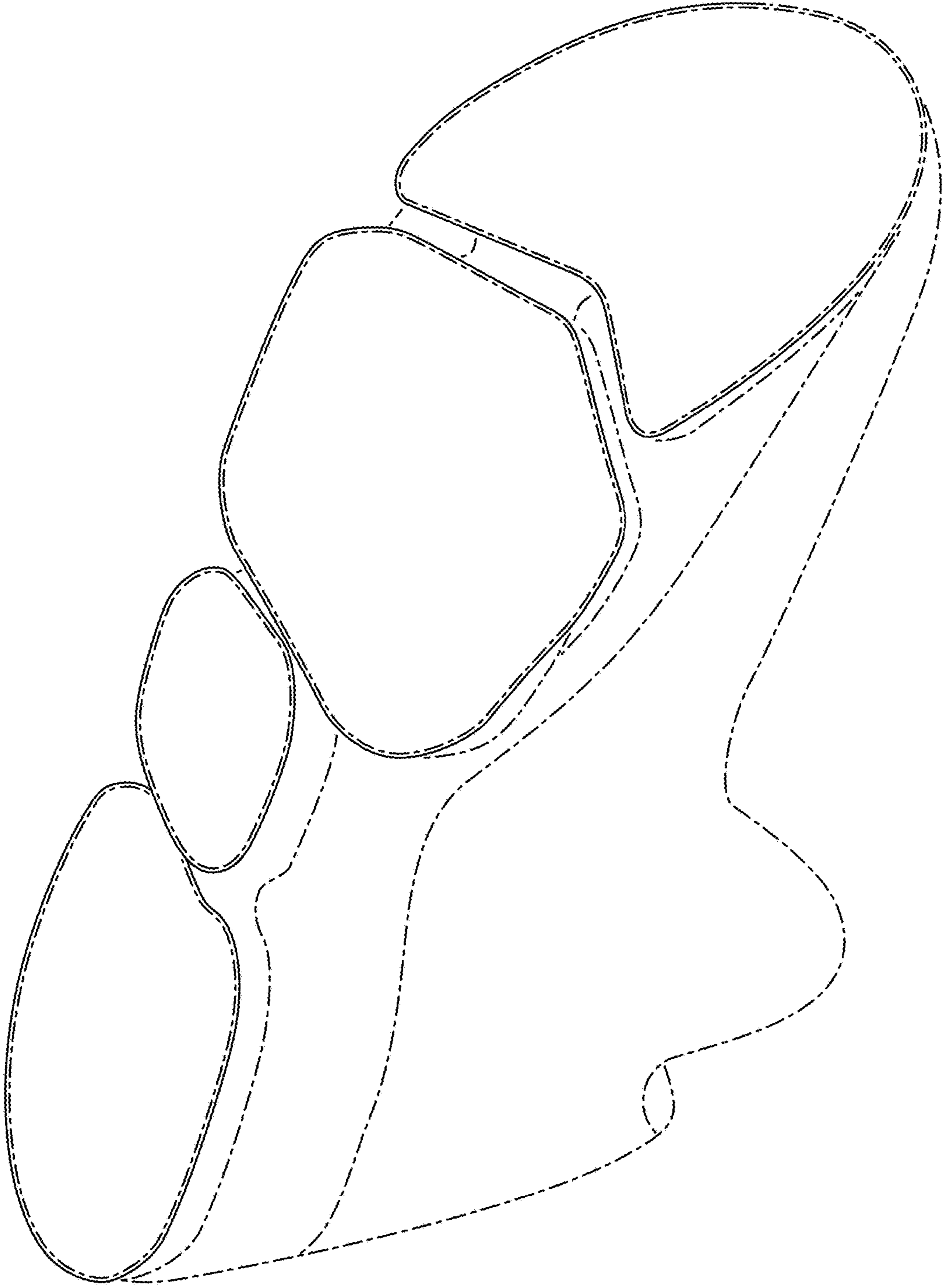

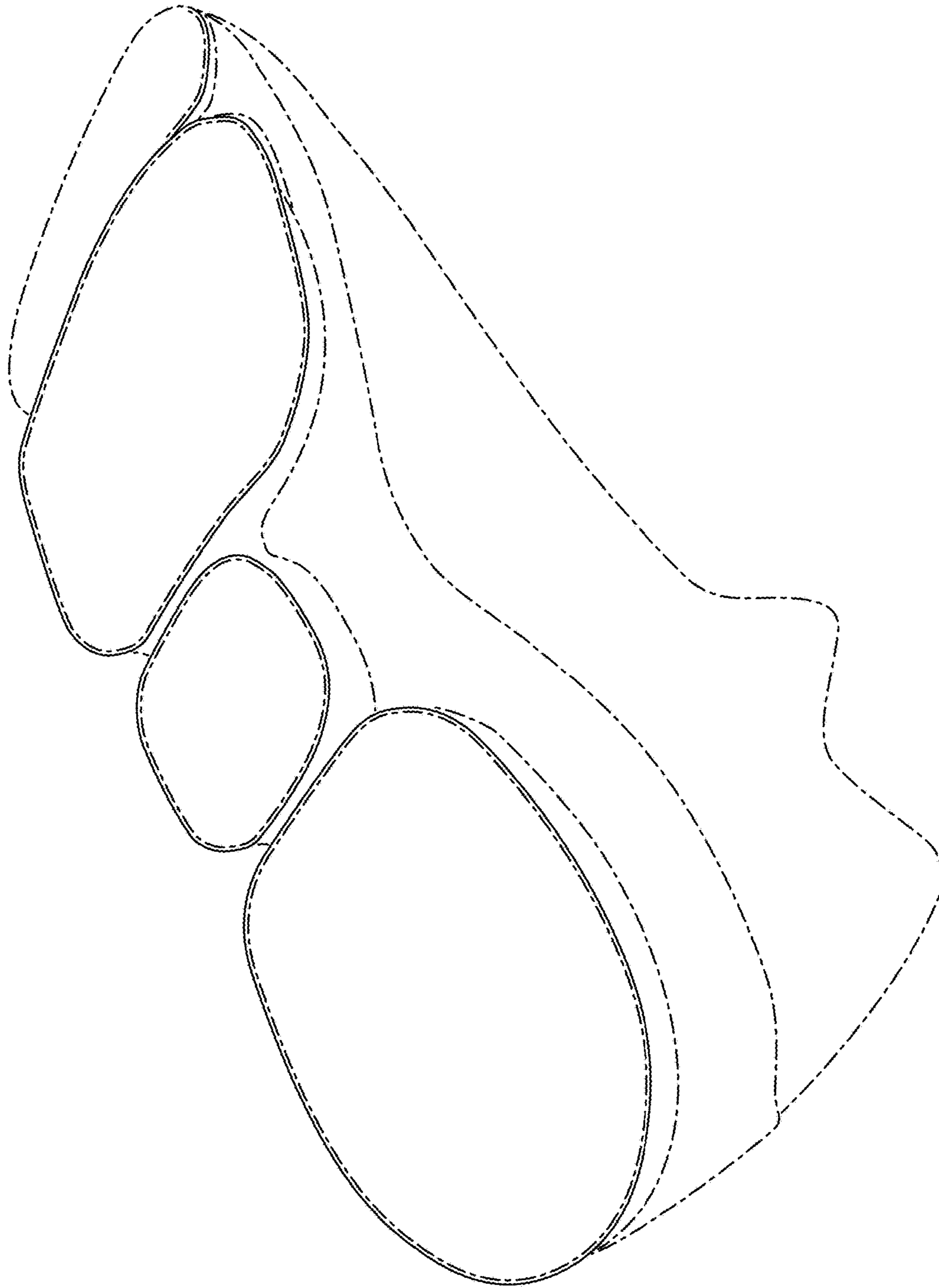
