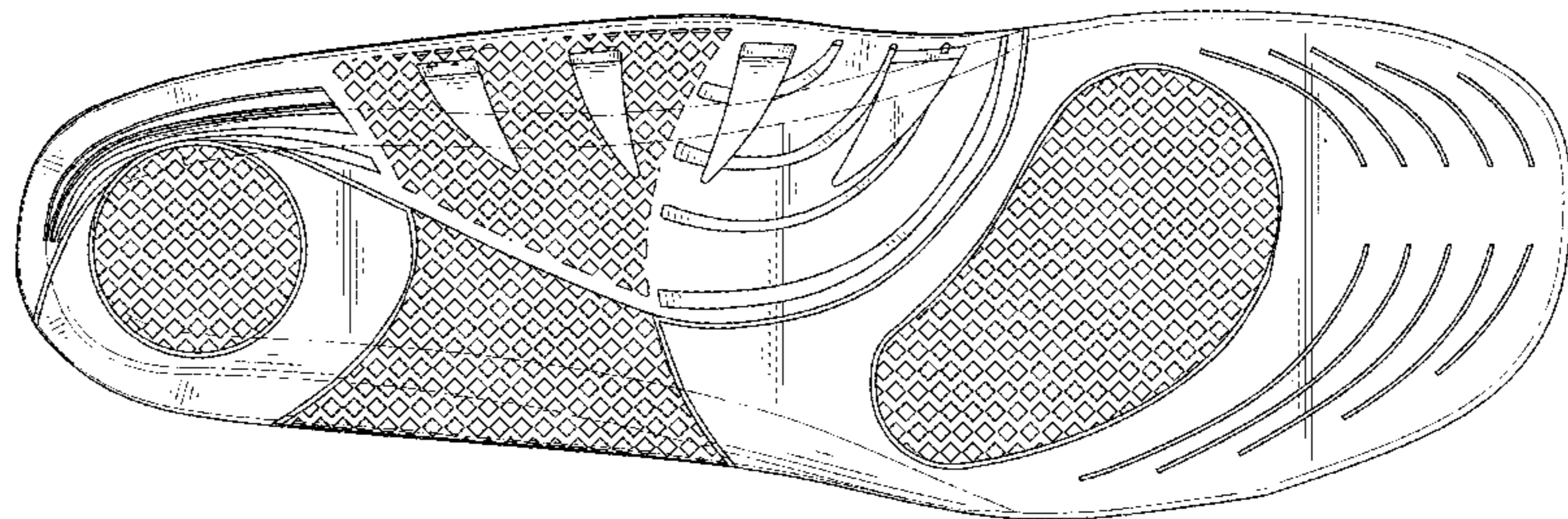
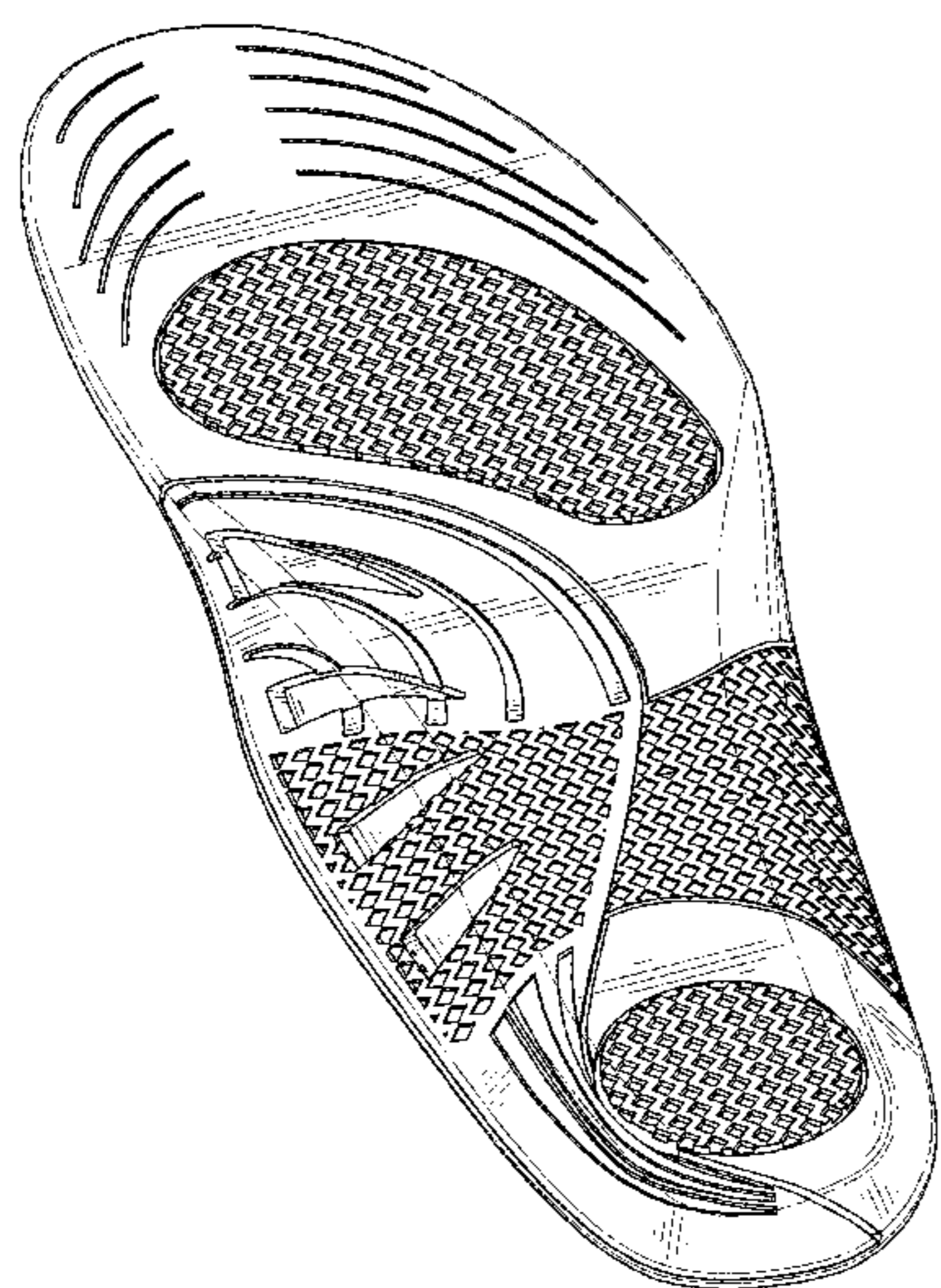
(57) **CLAIM**

The ornamental design for a sport insole, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear perspective view of the sport insole showing my new design;

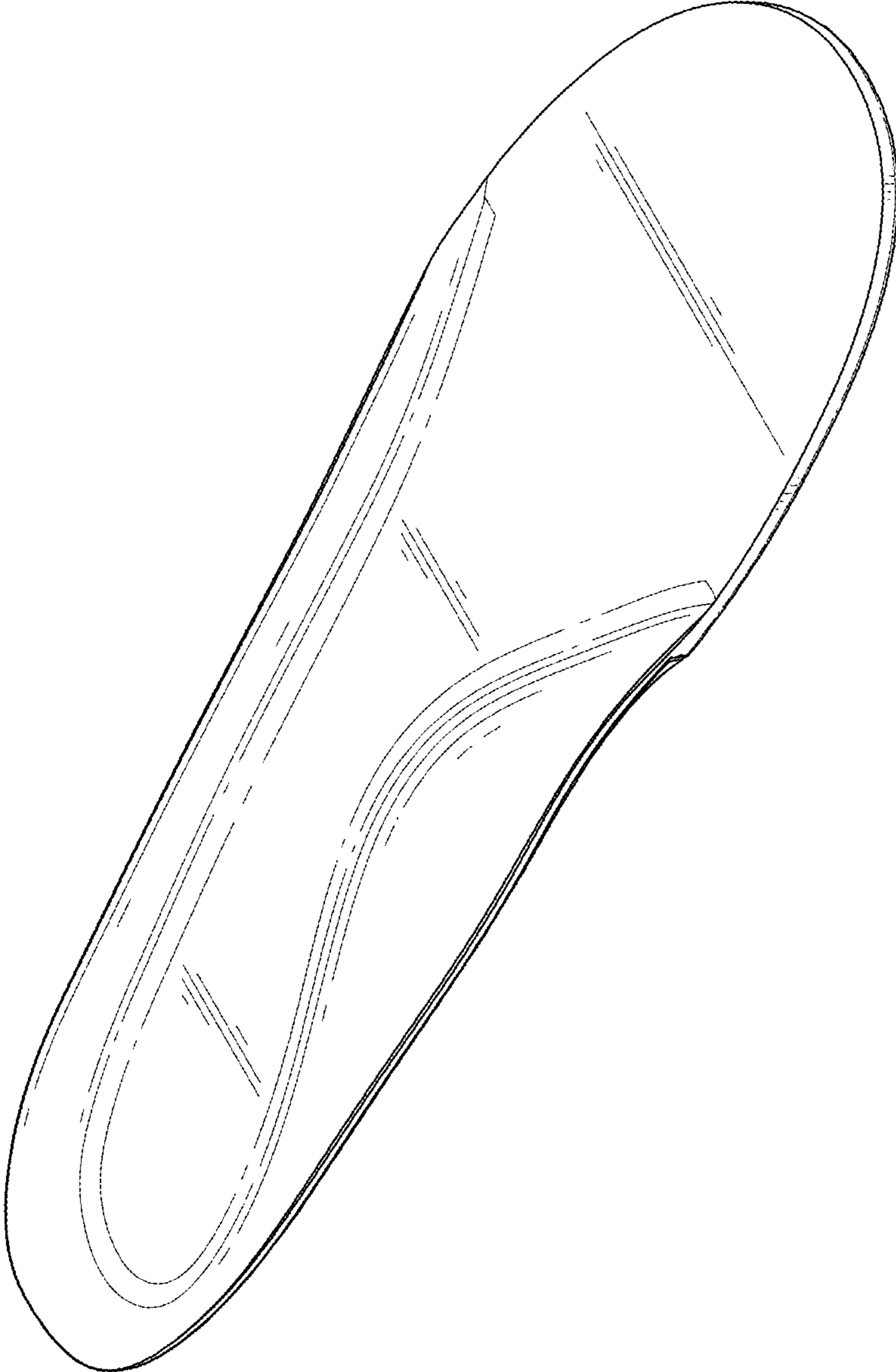

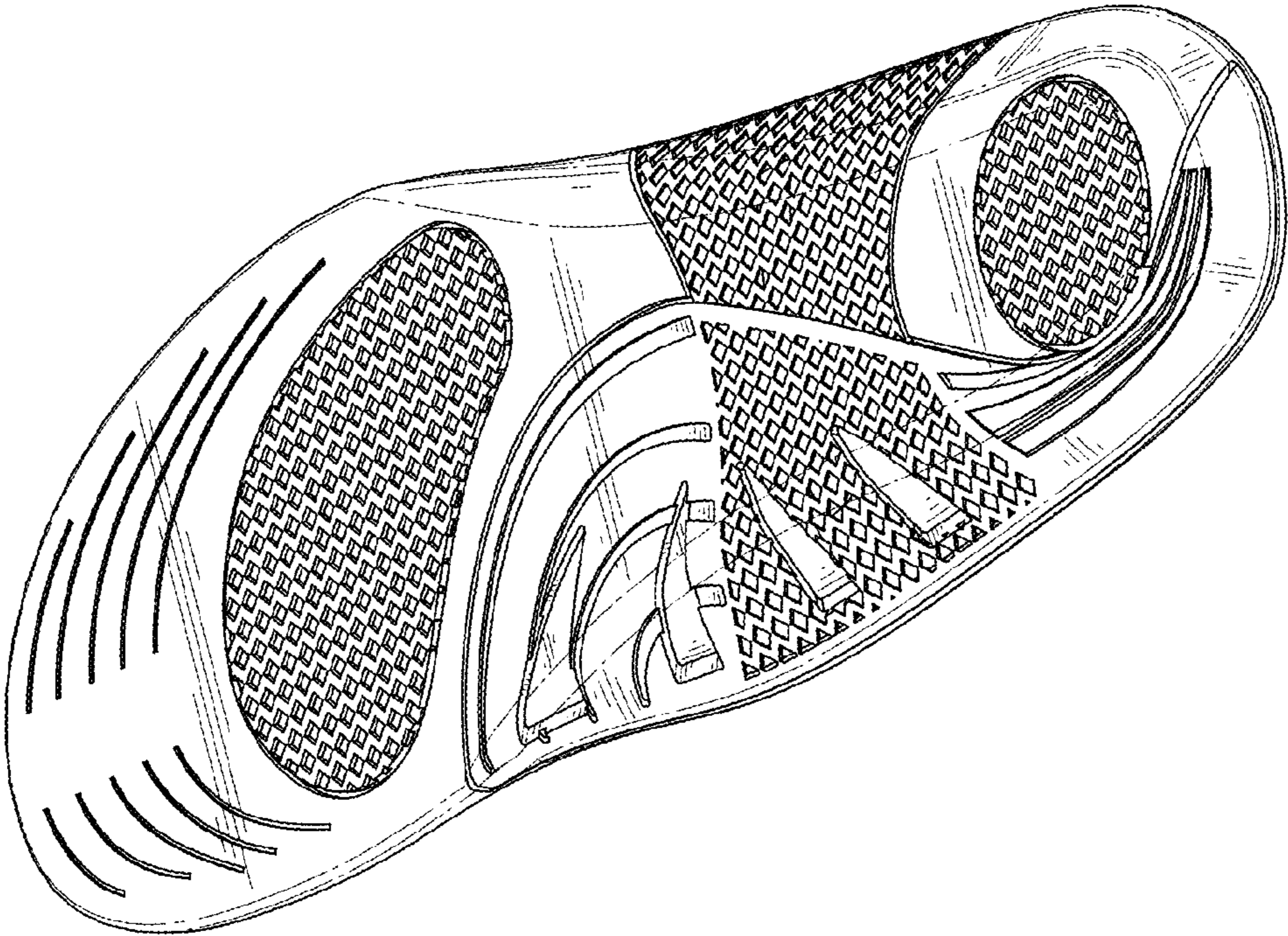

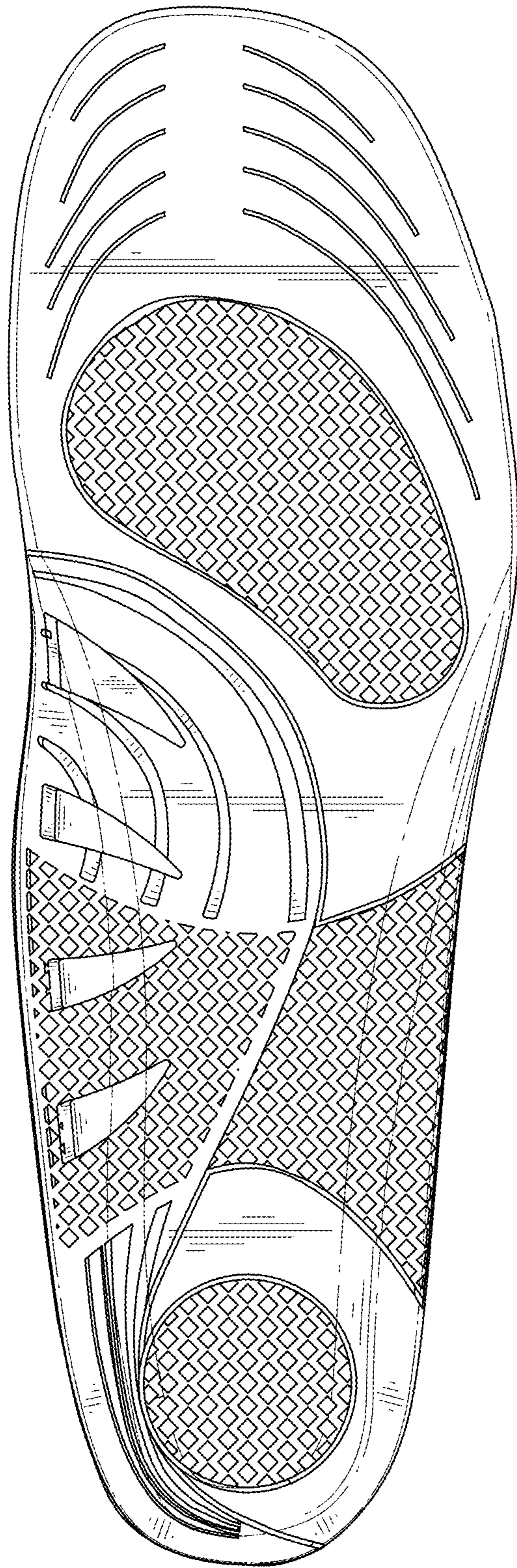

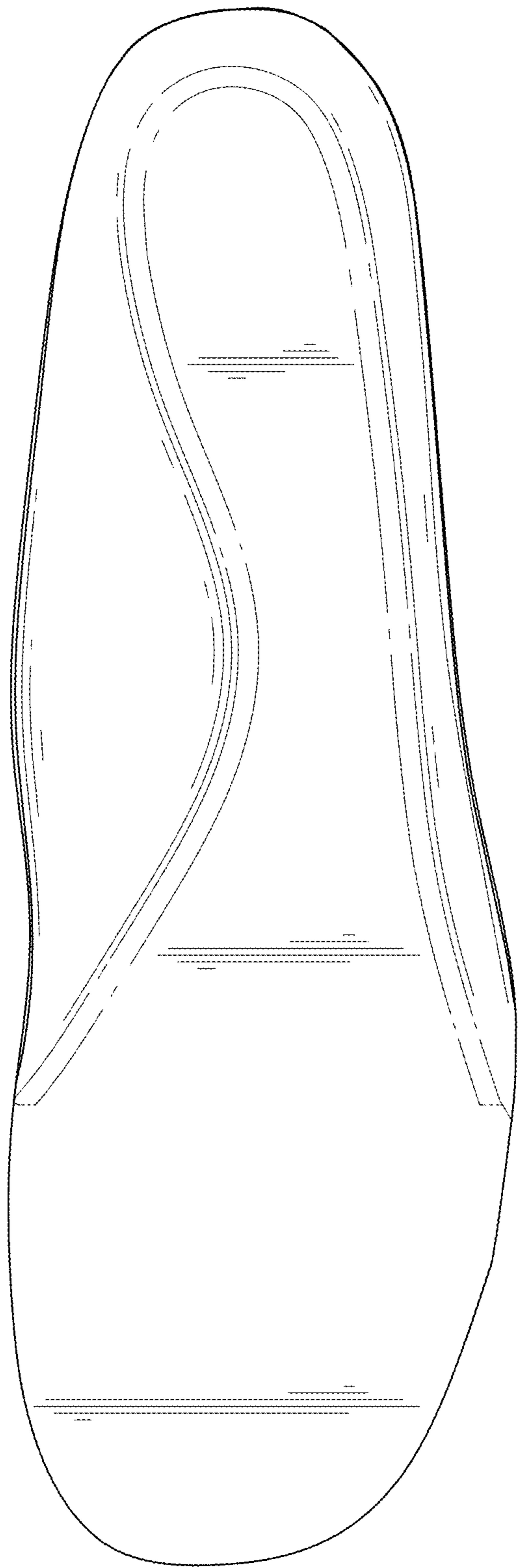

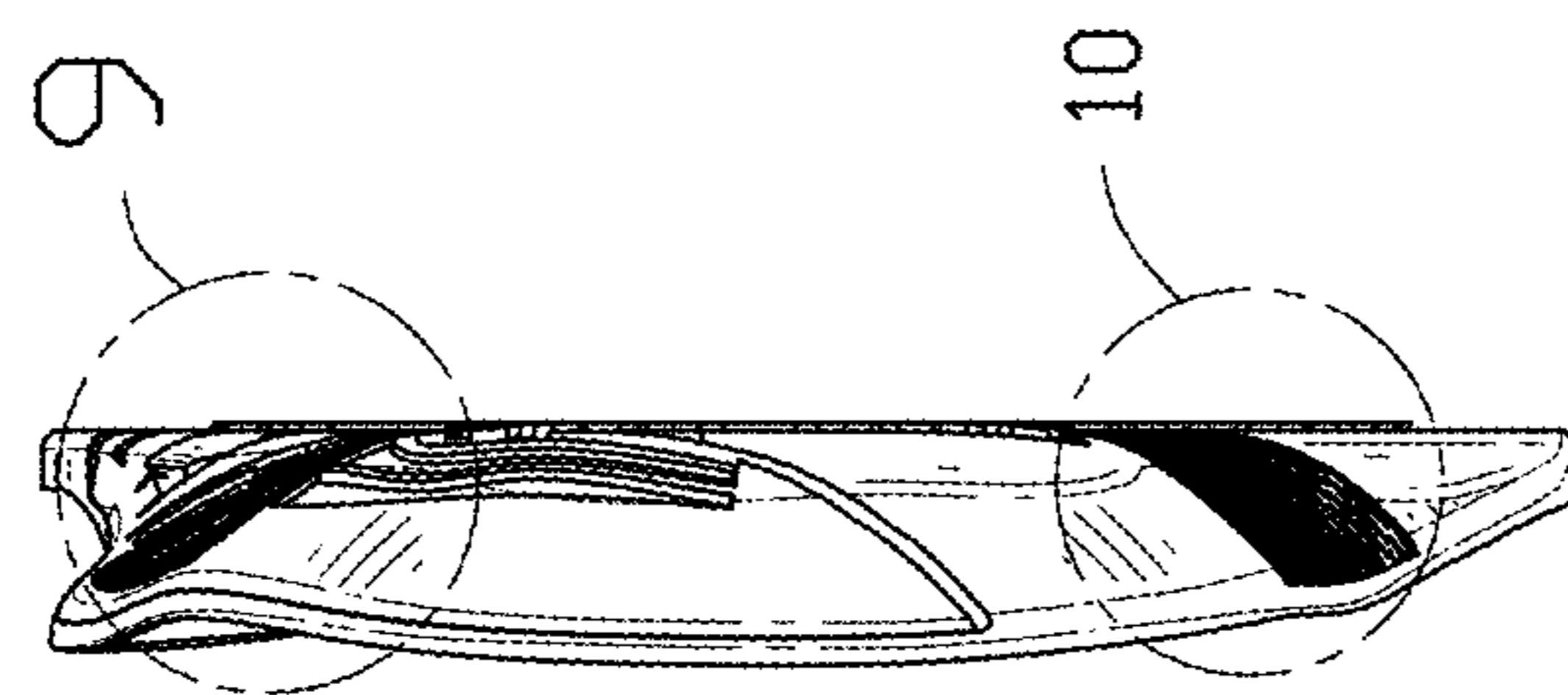

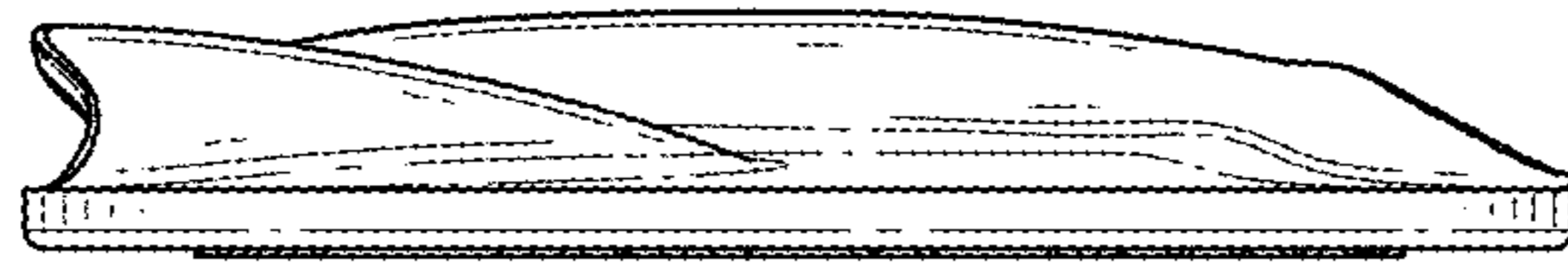

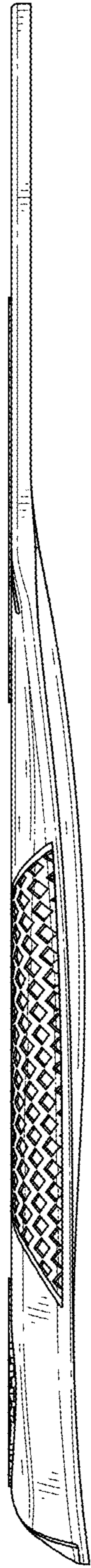

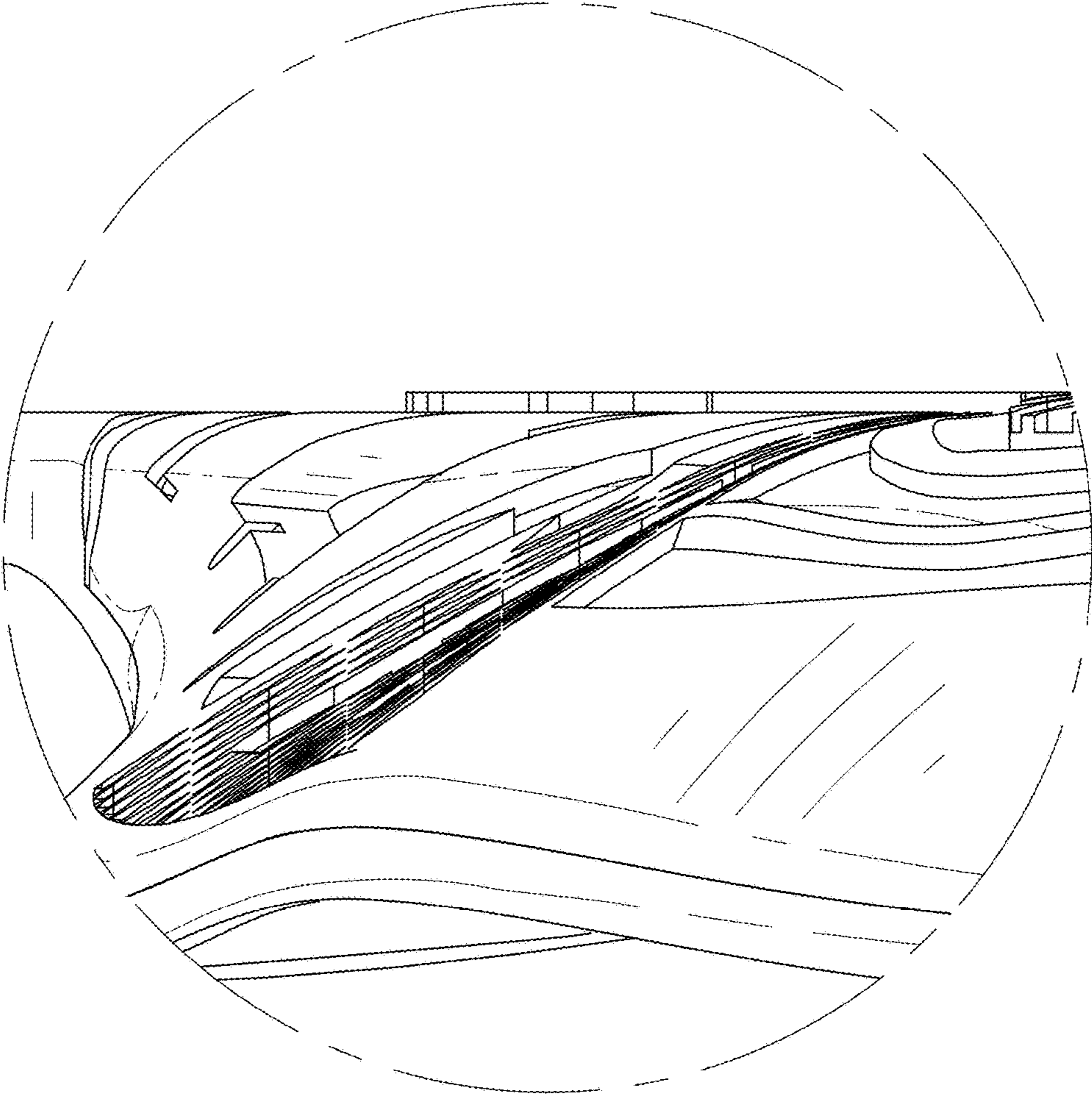

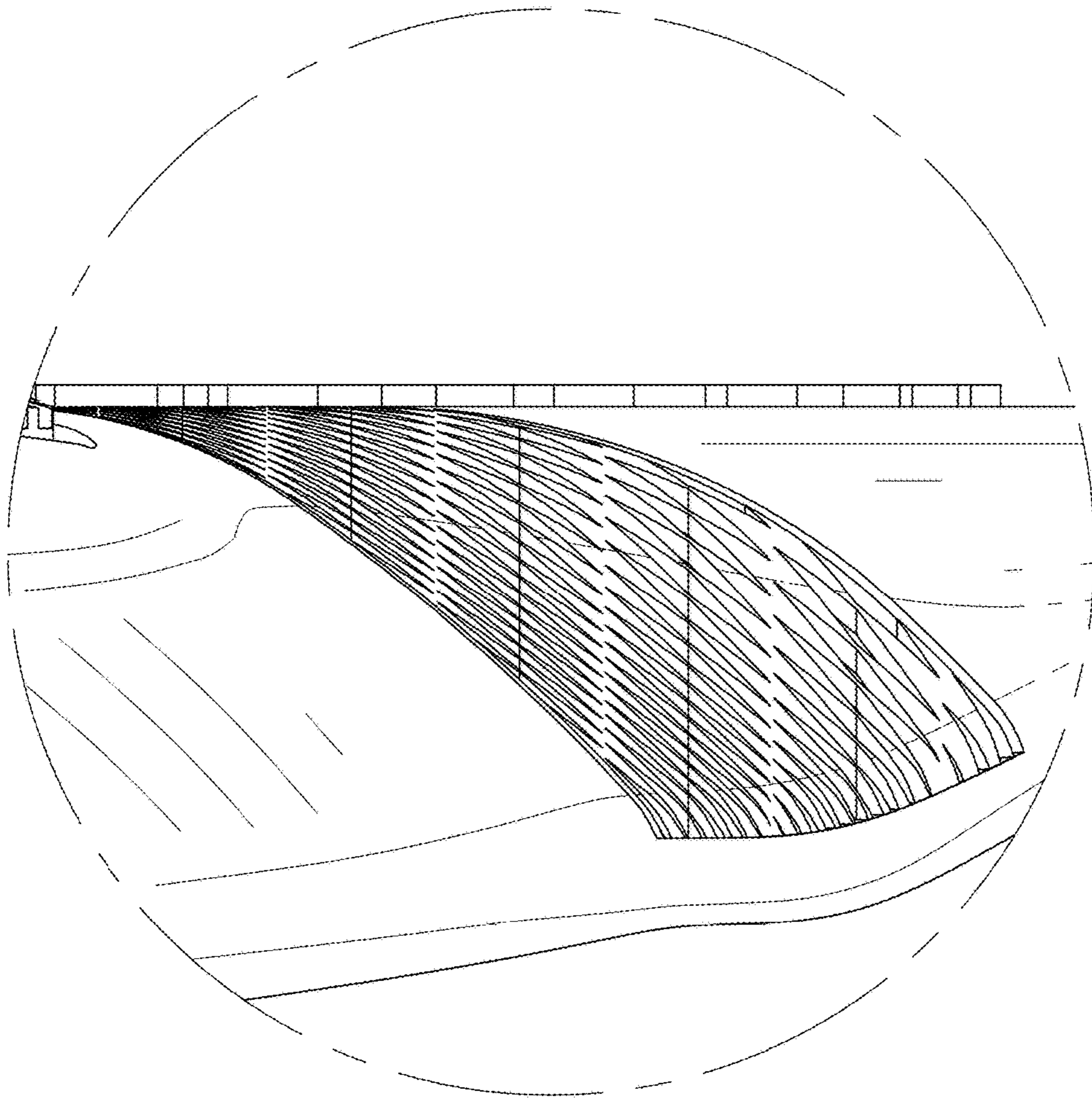
