FIG. 1 is a front view of the disposable plate with attached foil sheet.

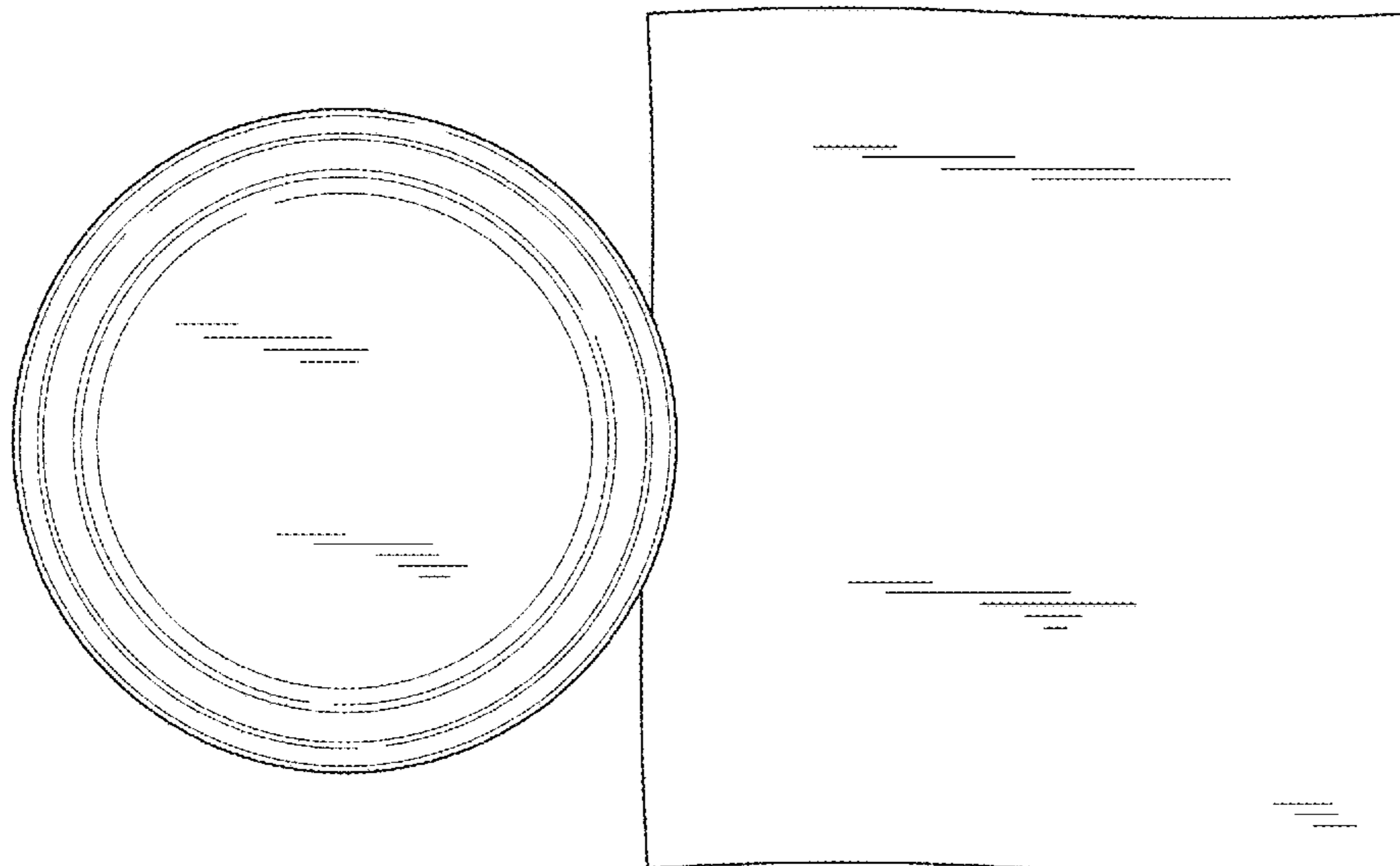
FIG. 2 is a left side view of the claimed design.

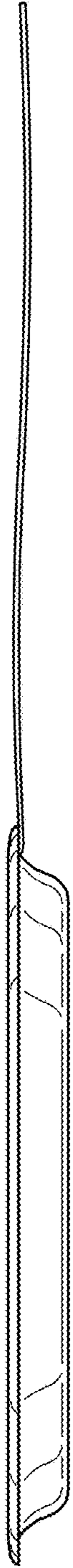

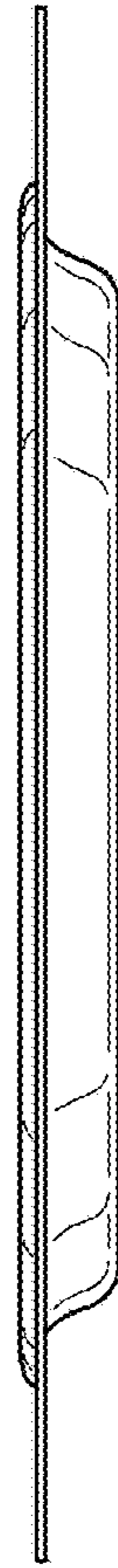

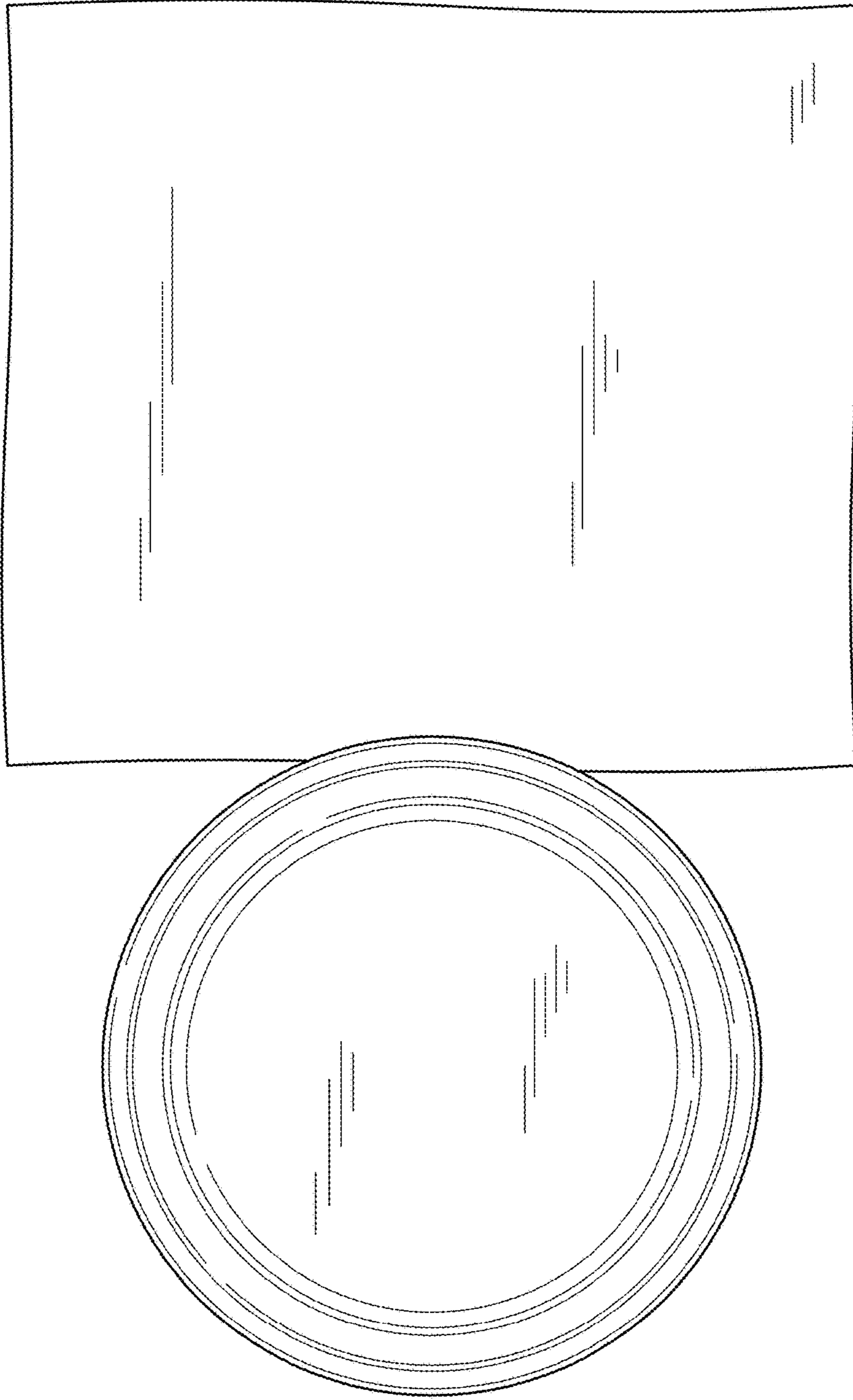

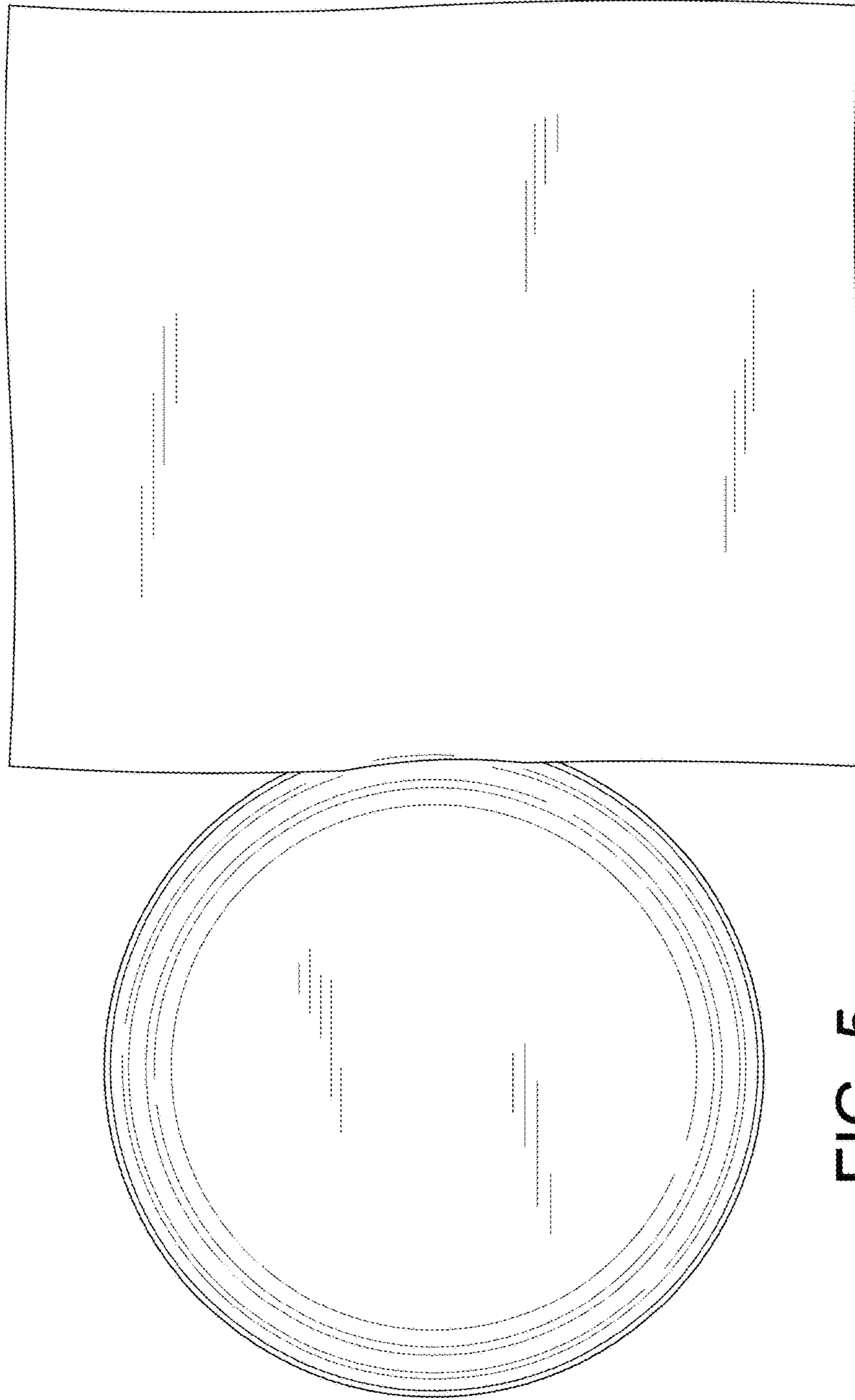
