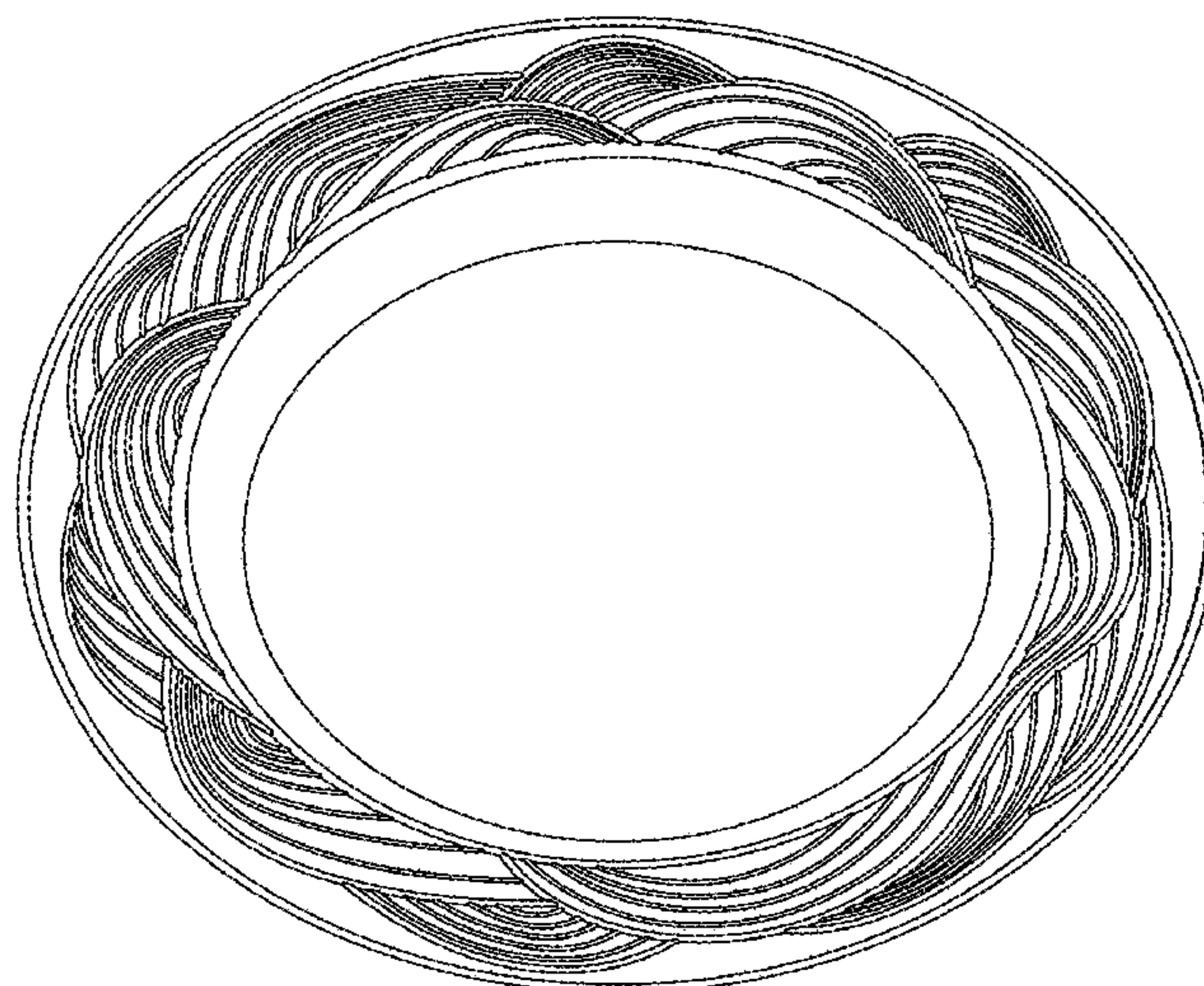
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top perspective view of a plate.  
FIG. 2 is a side elevational view of the plate of FIG. 1, with all sides being identical.  
FIG. 3 is a top plan view of the plate of FIG. 1; and,  
FIG. 4 is a bottom plan view of the plate of FIG. 1.

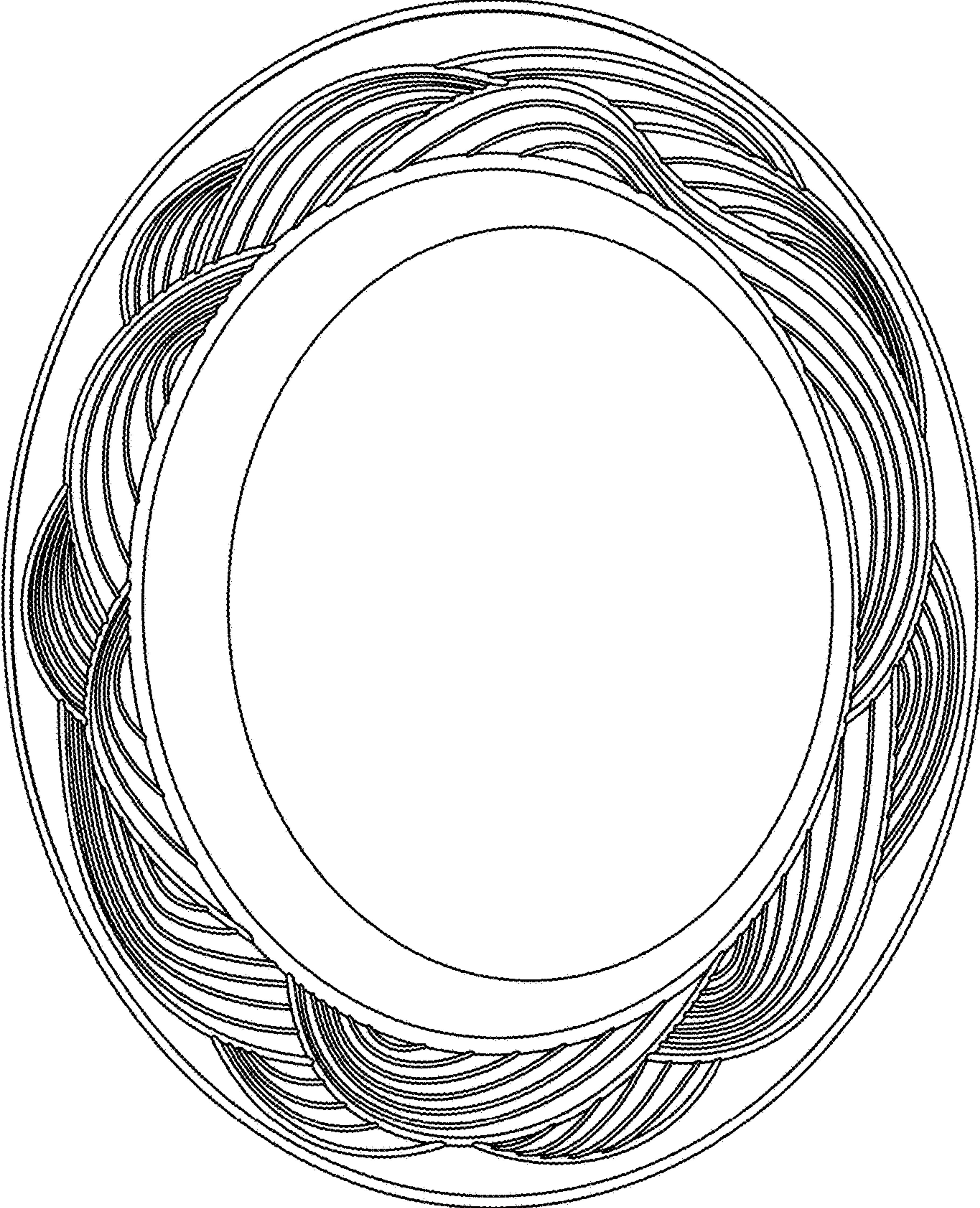

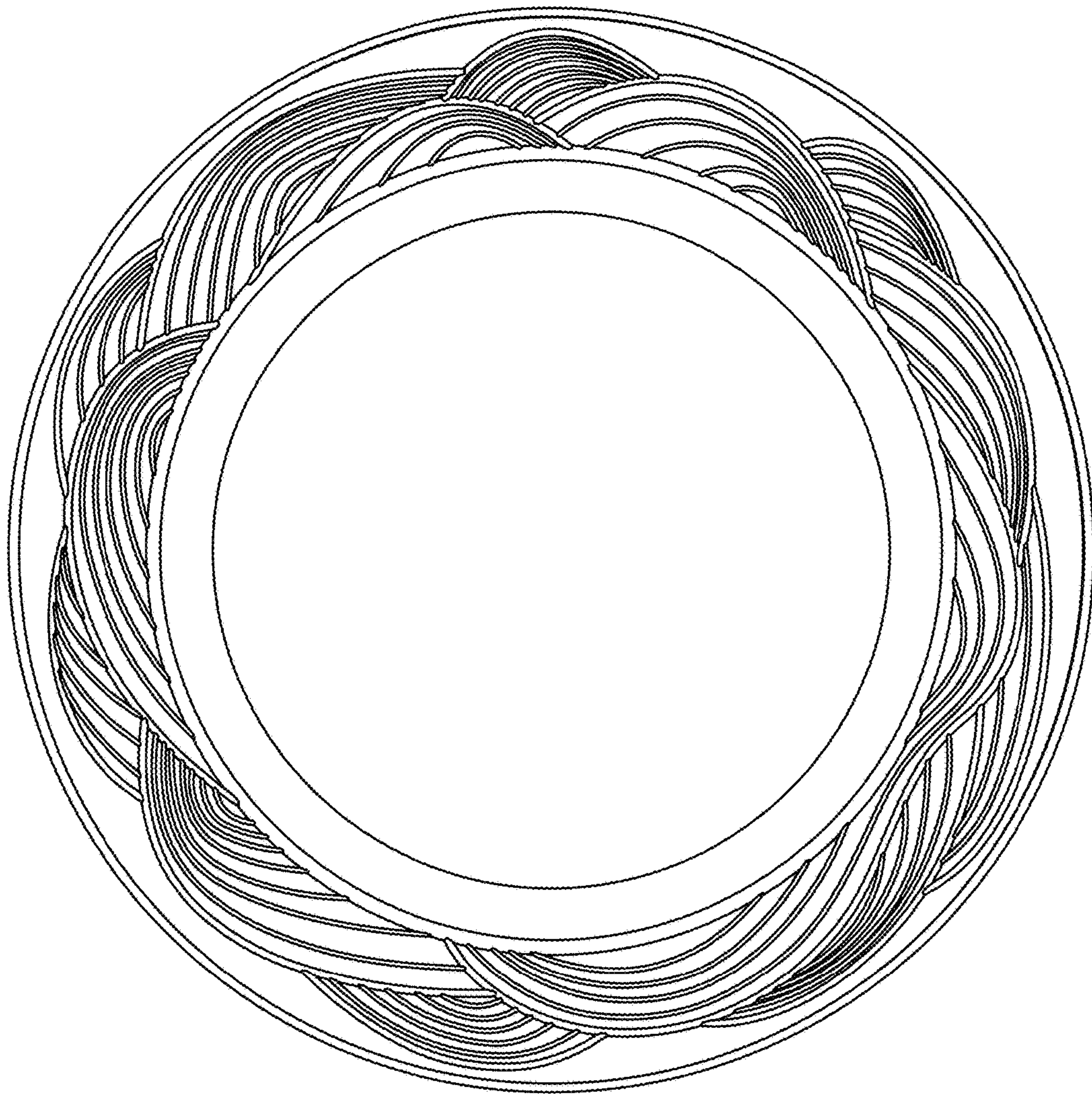

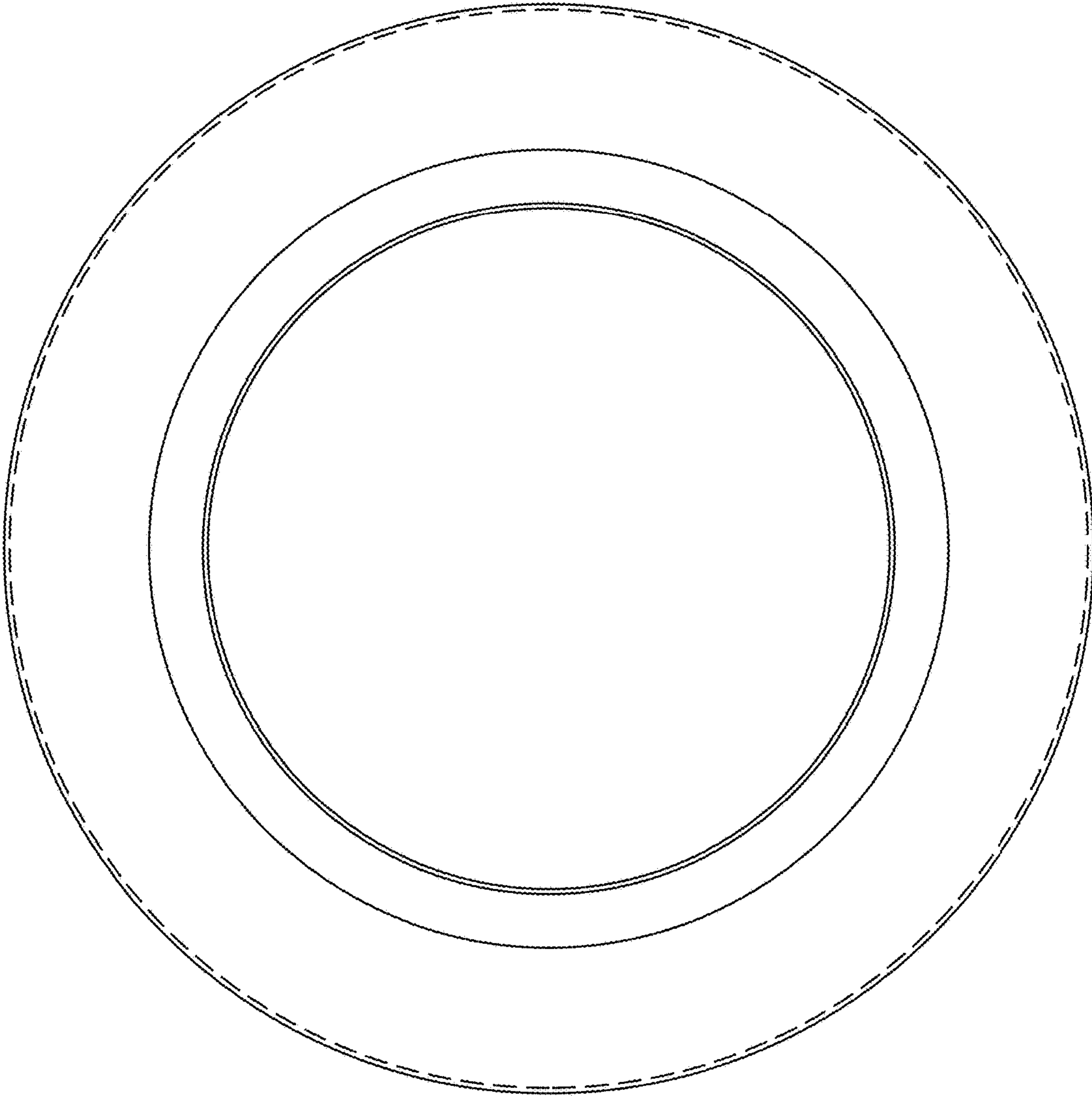
