**DESCRIPTION**

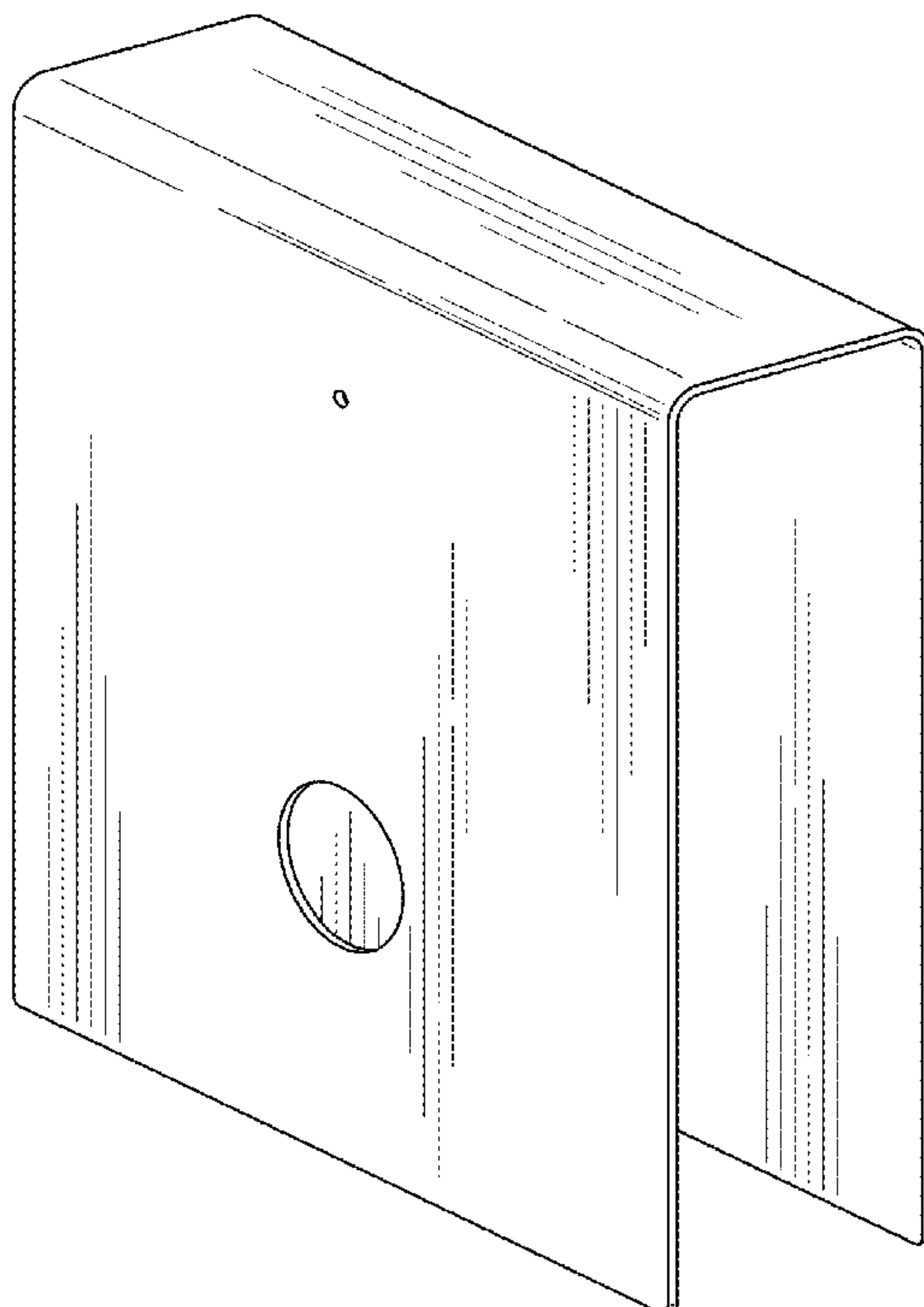
FIG. 1 is a perspective view of a hanging bracket with hole showing my new design;

FIG. 6 is a top plan view thereof;

FIG. 8 is a perspective view thereof, showing the hanging bracket with hole installed in an exemplary ceiling structure. The broken lines showing portions of the ceiling structure are included for the purpose of illustrating environmental structure and form no part of the claimed design.

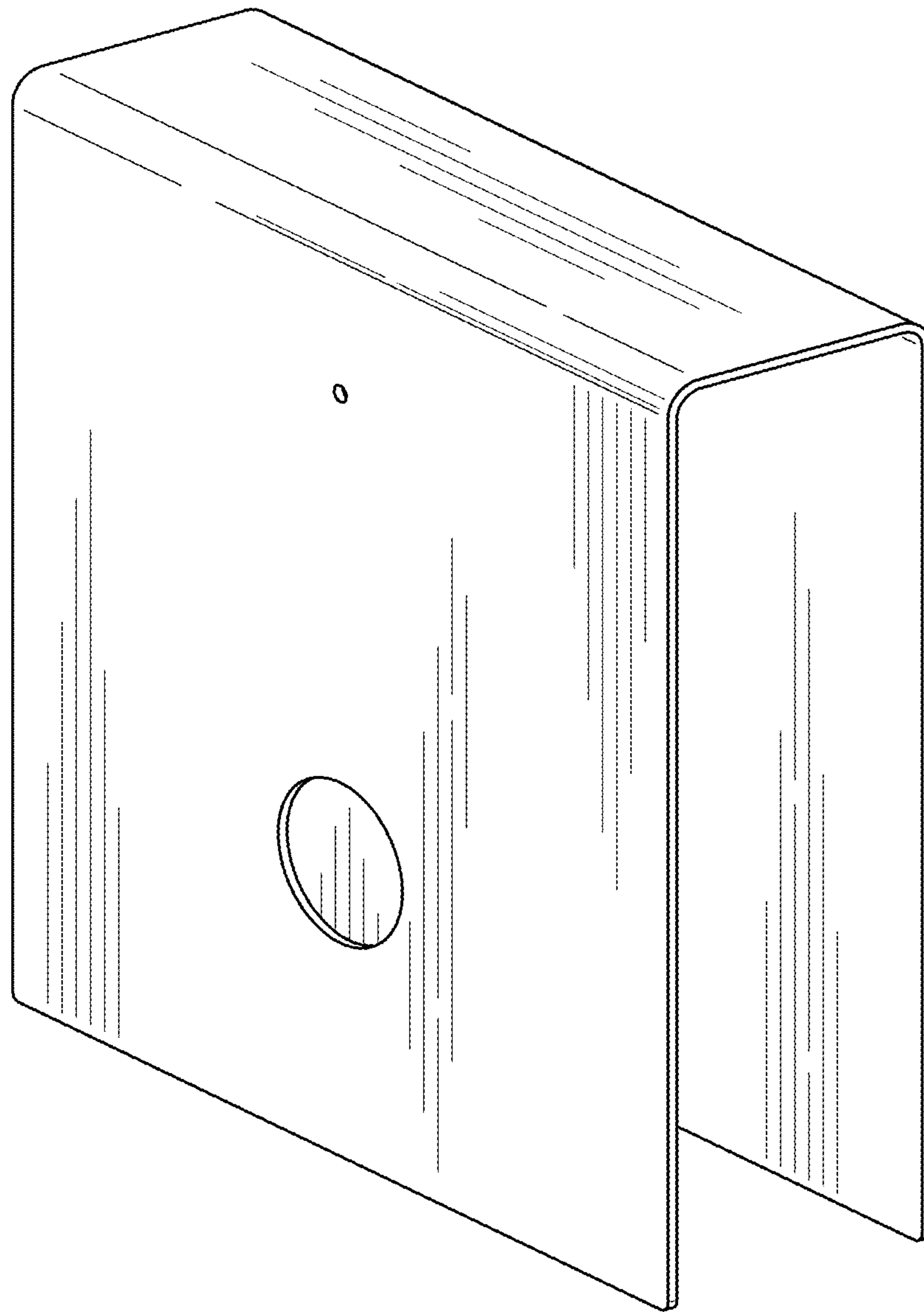

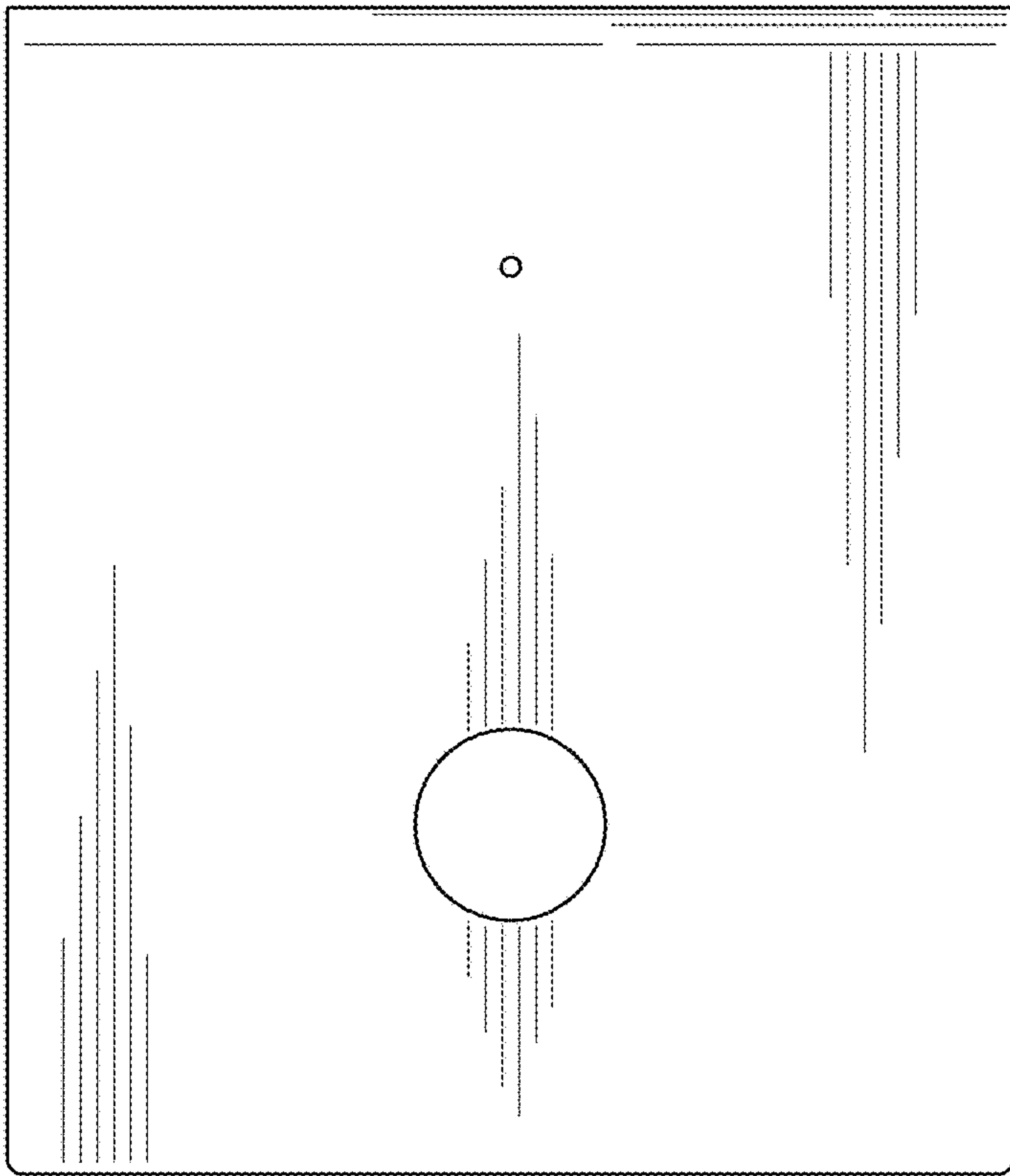

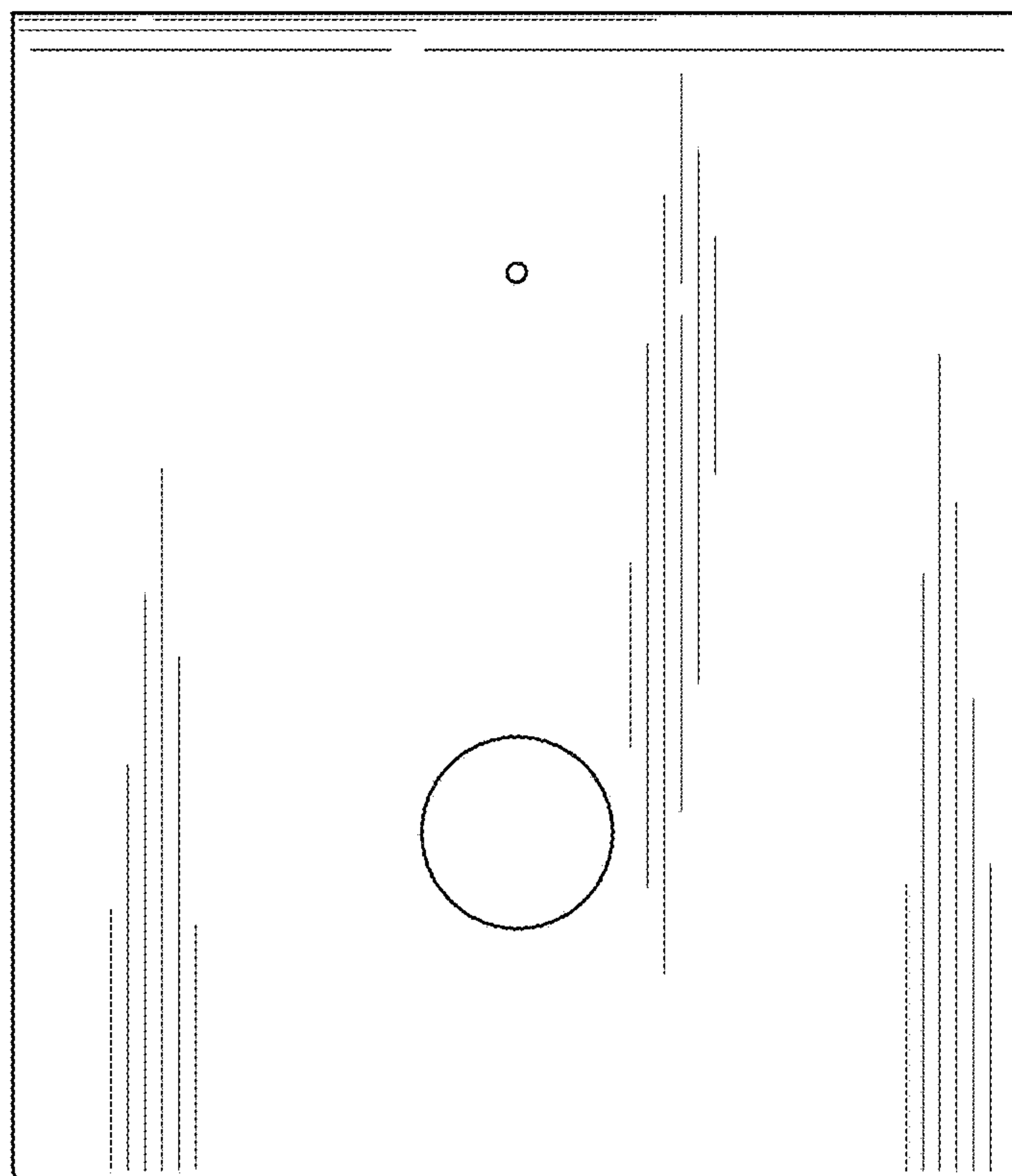

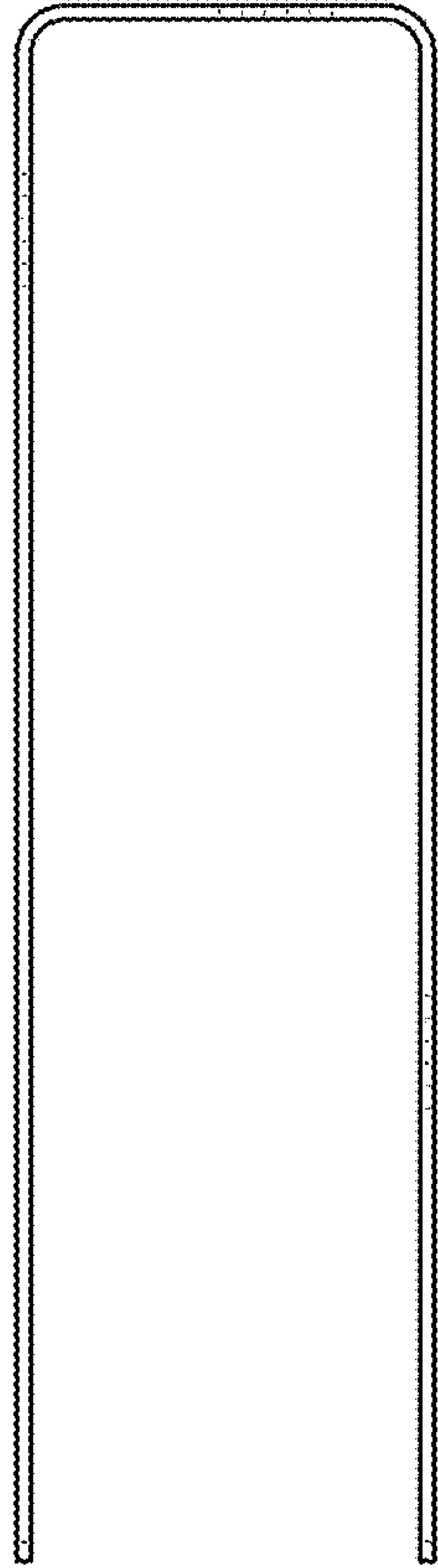

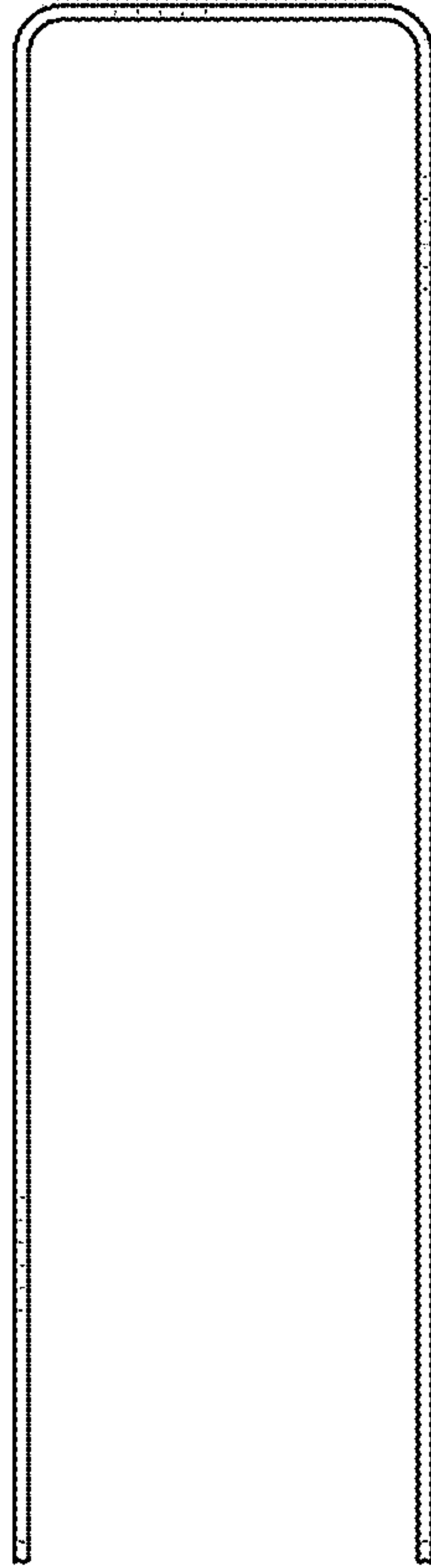

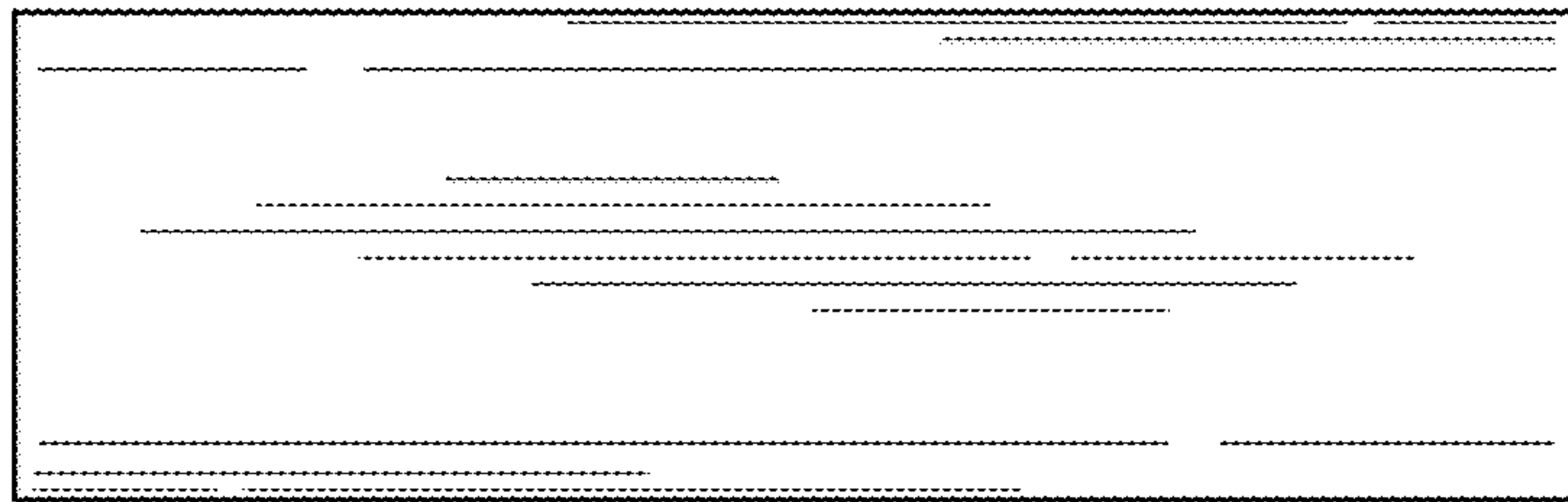

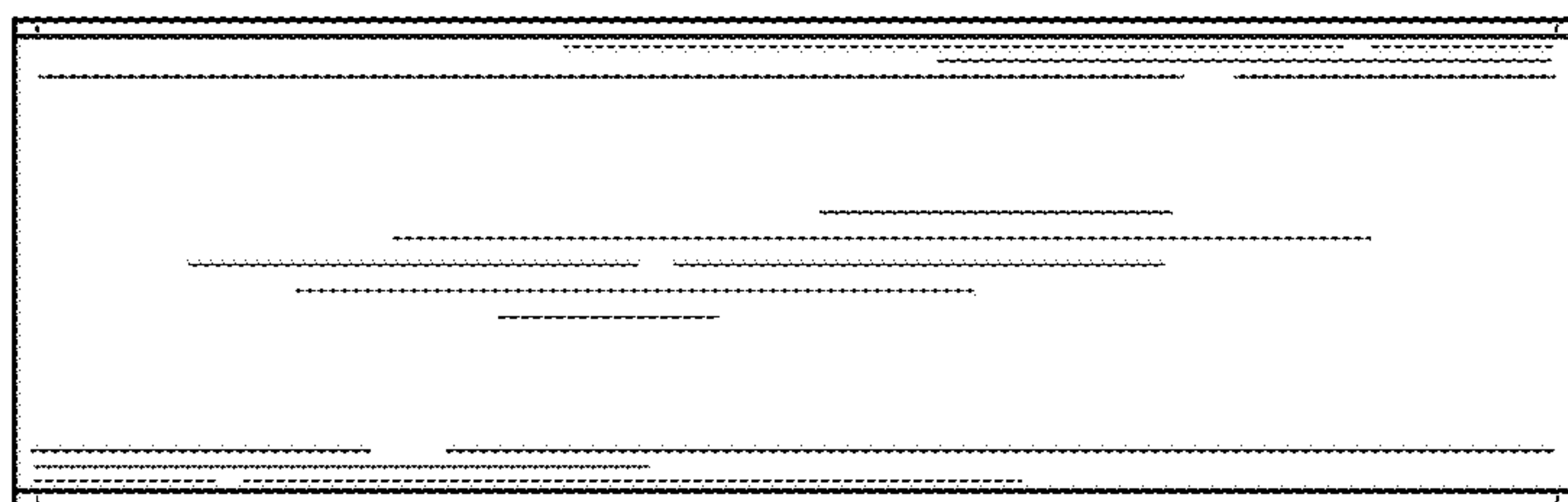

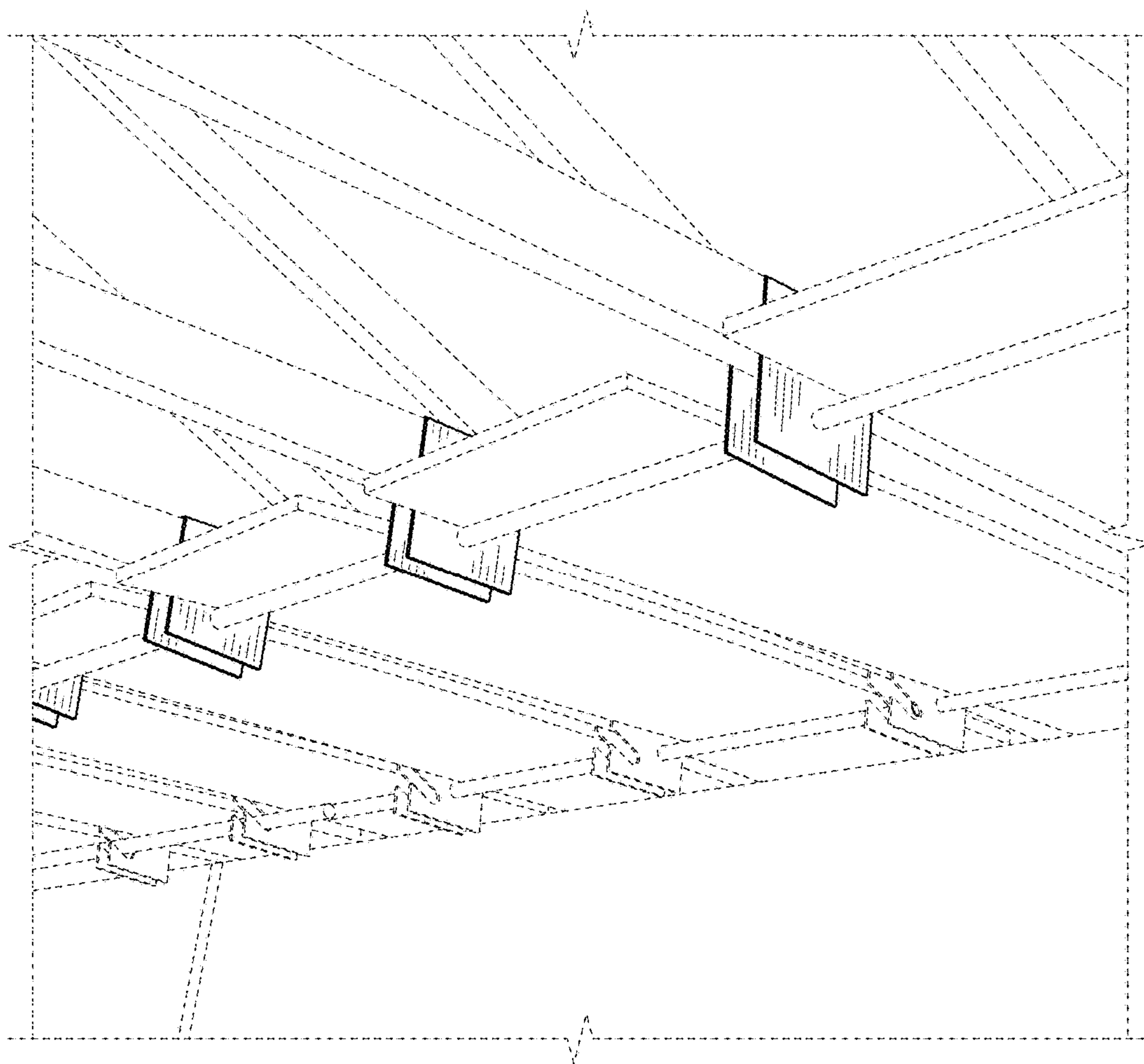
