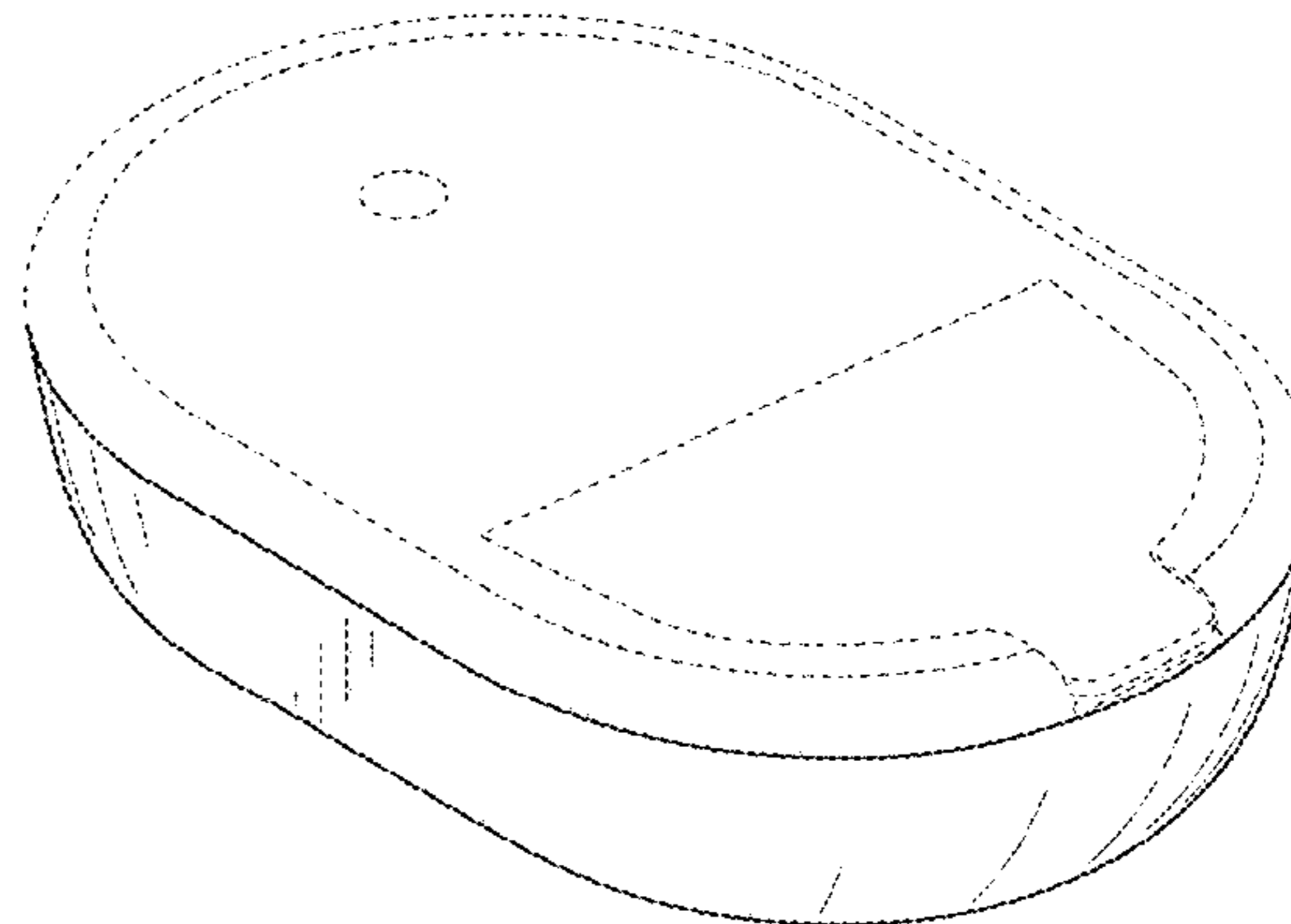
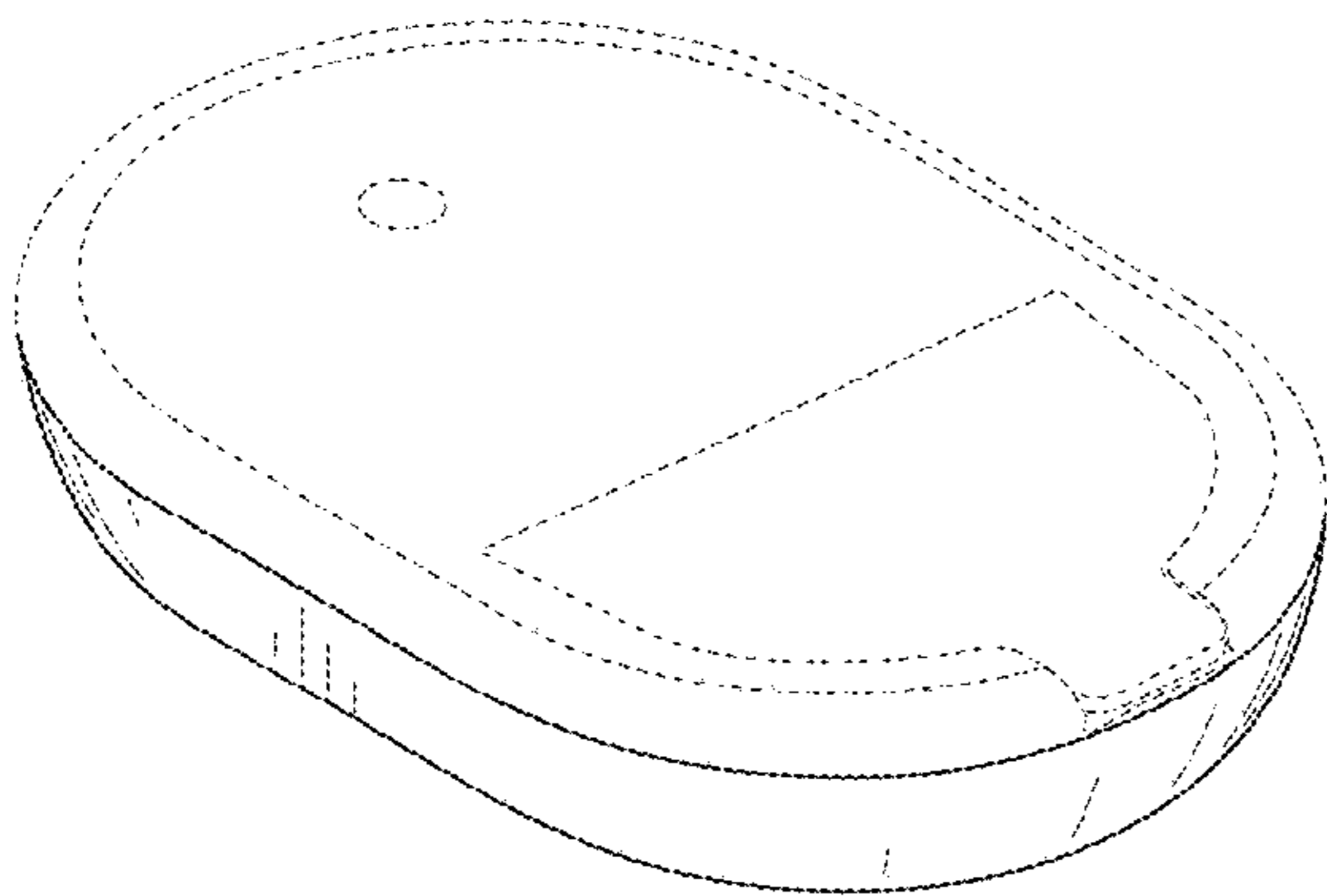
(57) **CLAIM**

The ornamental design for a container for a confectionery, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of a first embodiment of a container for a confectionery showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a front right perspective view of the container for a confectionery of FIG. 1, showing a portion of the lid portion thereof in an alternate position; FIG. 9 is a front right perspective view of a second embodiment of a container for a confectionery showing our new design; FIG. 10 is a front elevation view thereof; FIG. 11 is a rear elevation view thereof; FIG. 12 is a left side elevation view thereof; FIG. 13 is a right side elevation view thereof; FIG. 14 is a top plan view thereof; FIG. 15 is a bottom plan view thereof; and, FIG. 16 is a front right perspective view of the container for a confectionery of FIG. 9, showing a portion of the lid portion thereof in an alternate position. The broken lines appearing in FIGS. 1-16 represent environmental subject matter only and form no part of the claimed design.

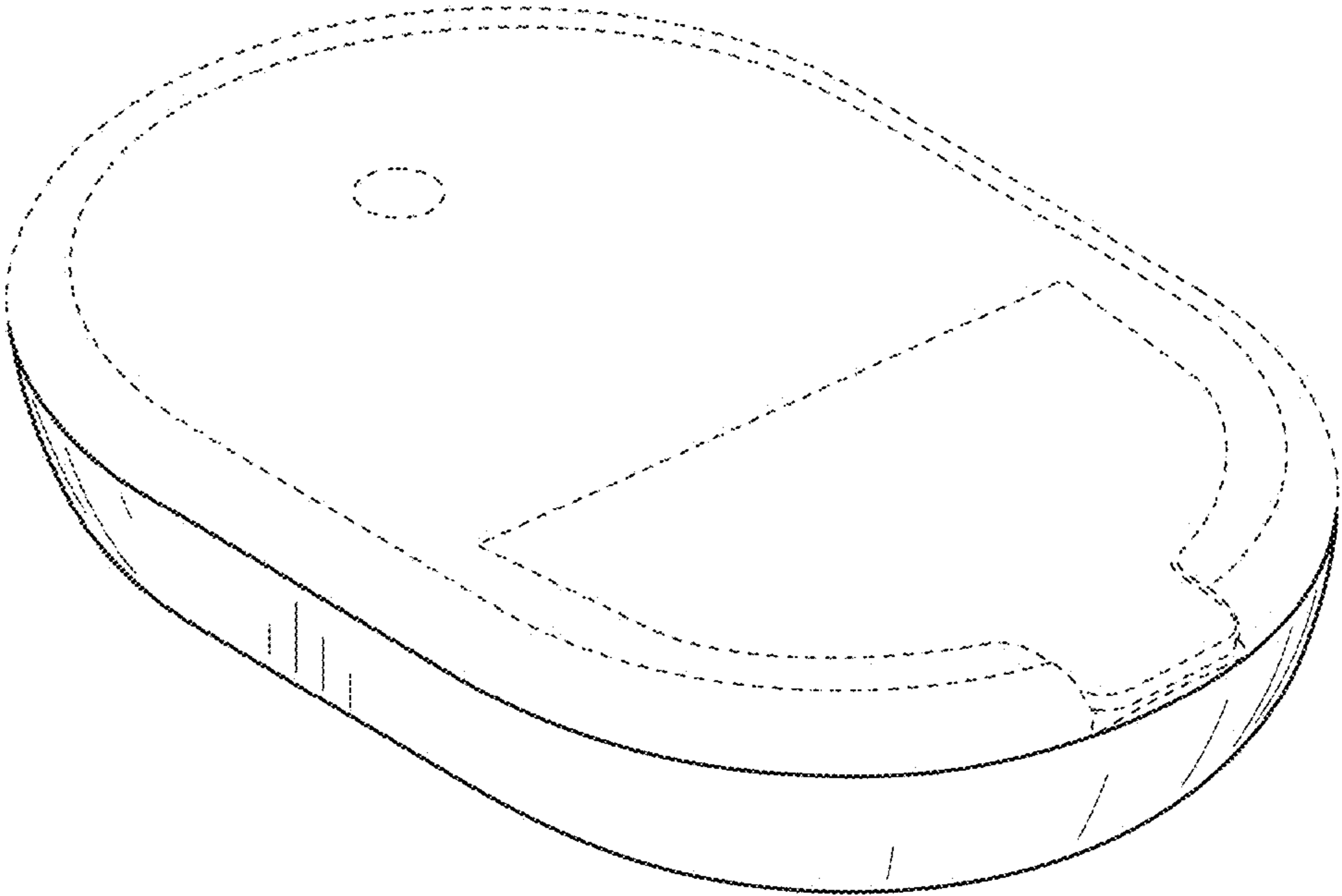

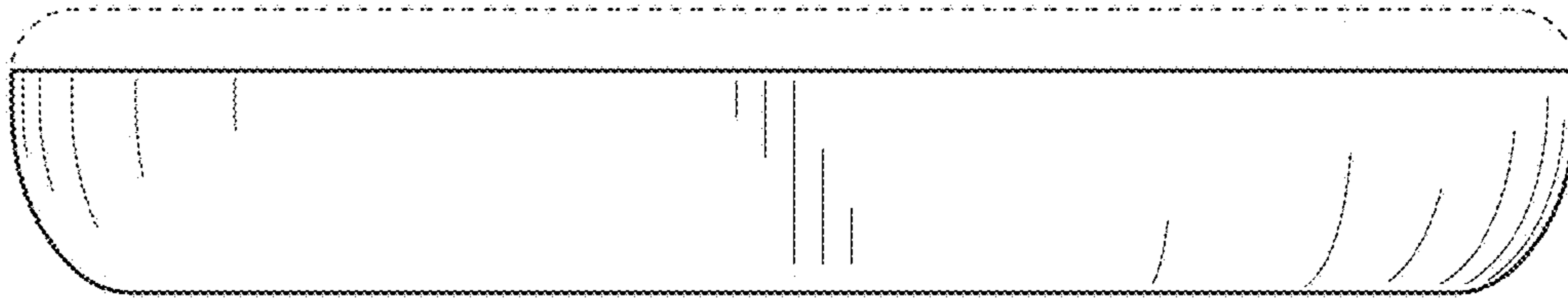

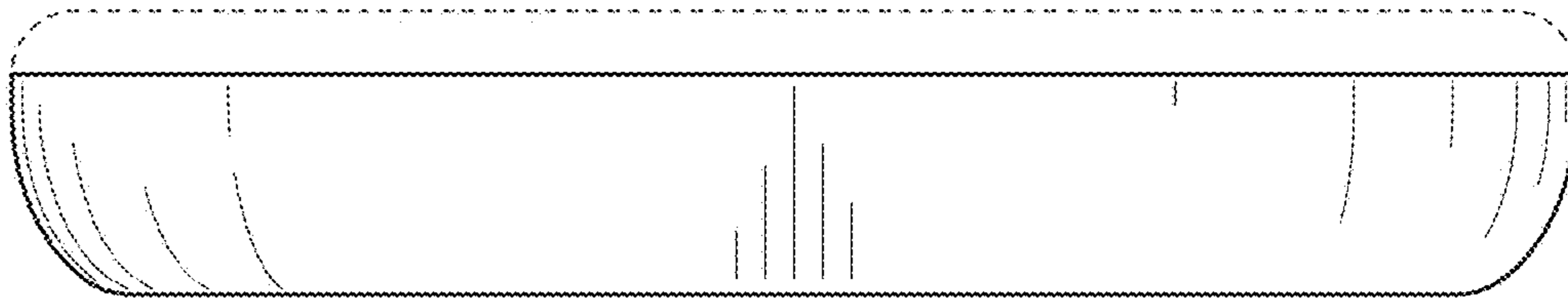

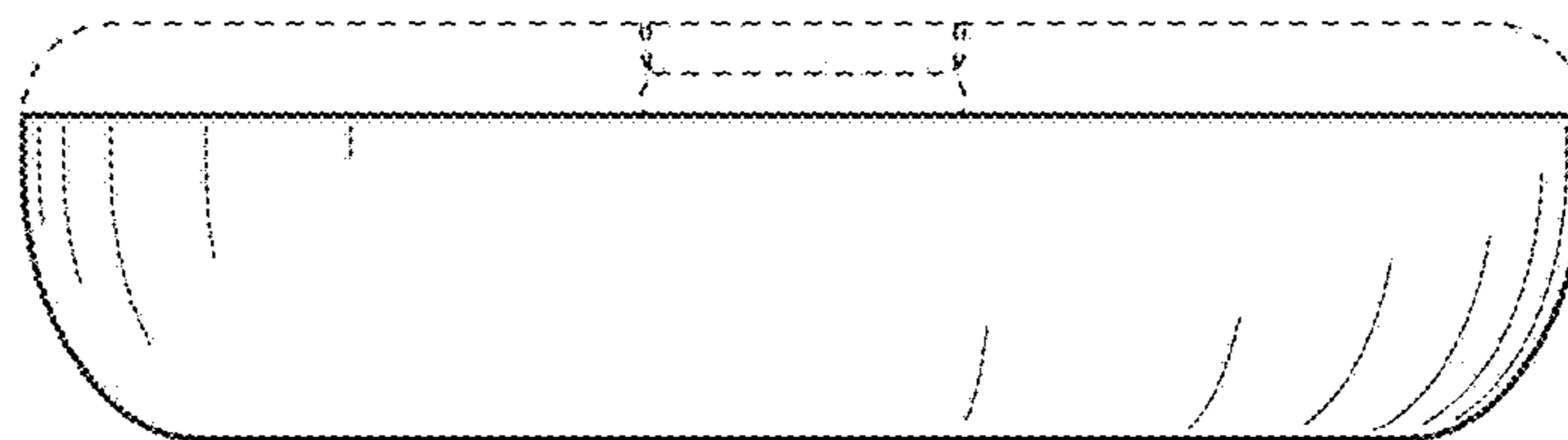

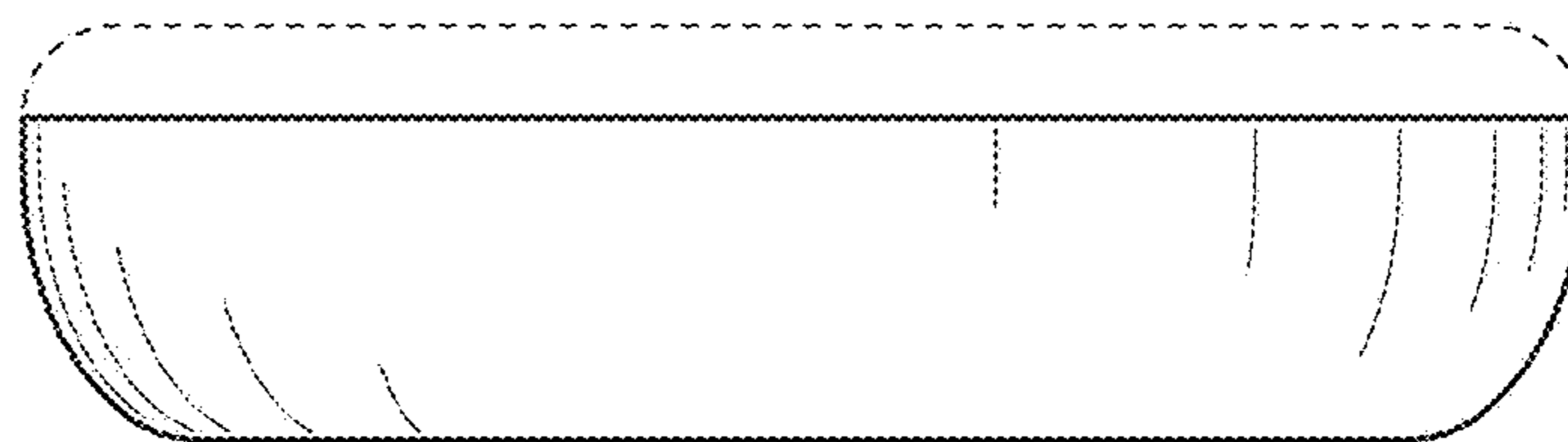

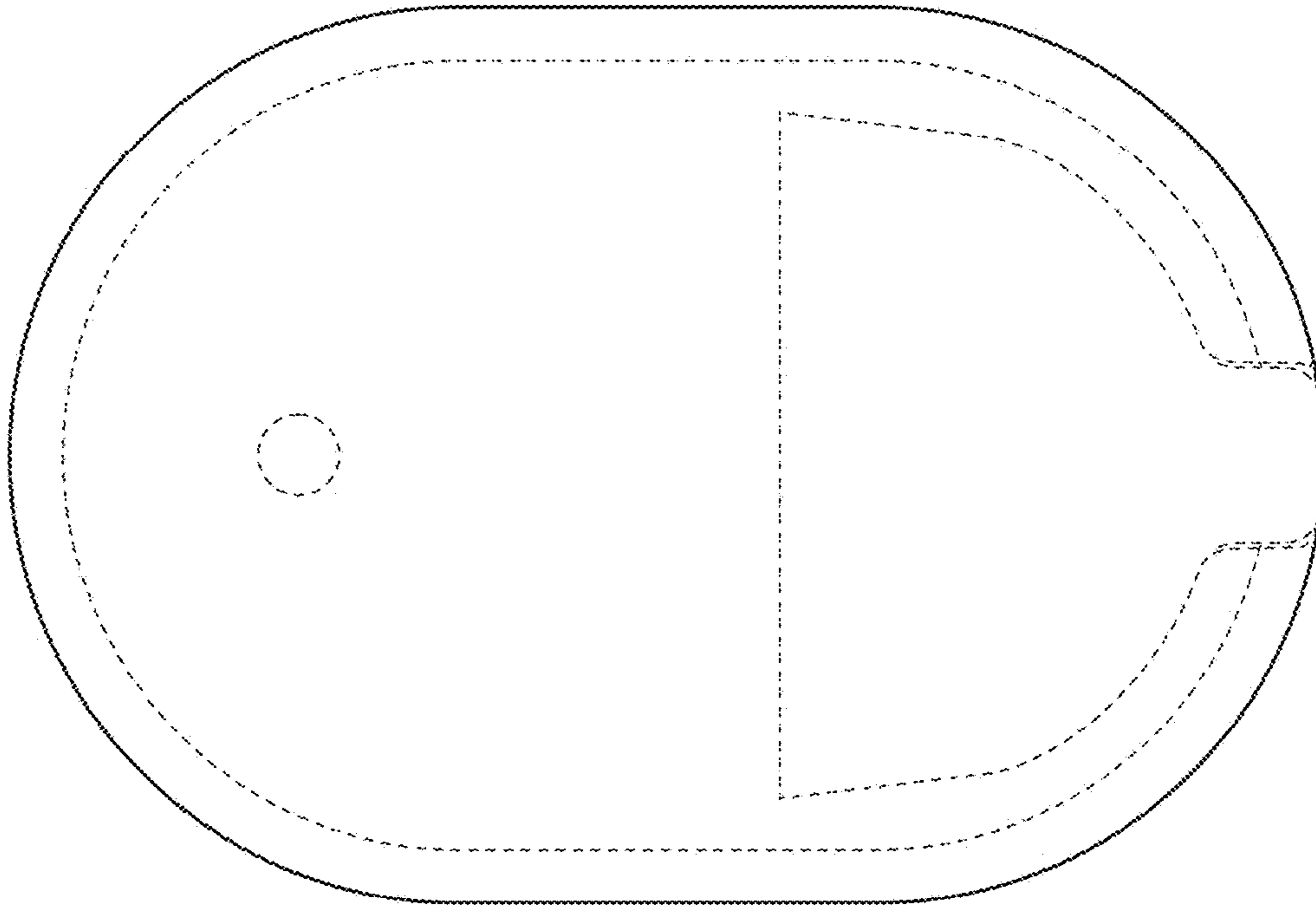

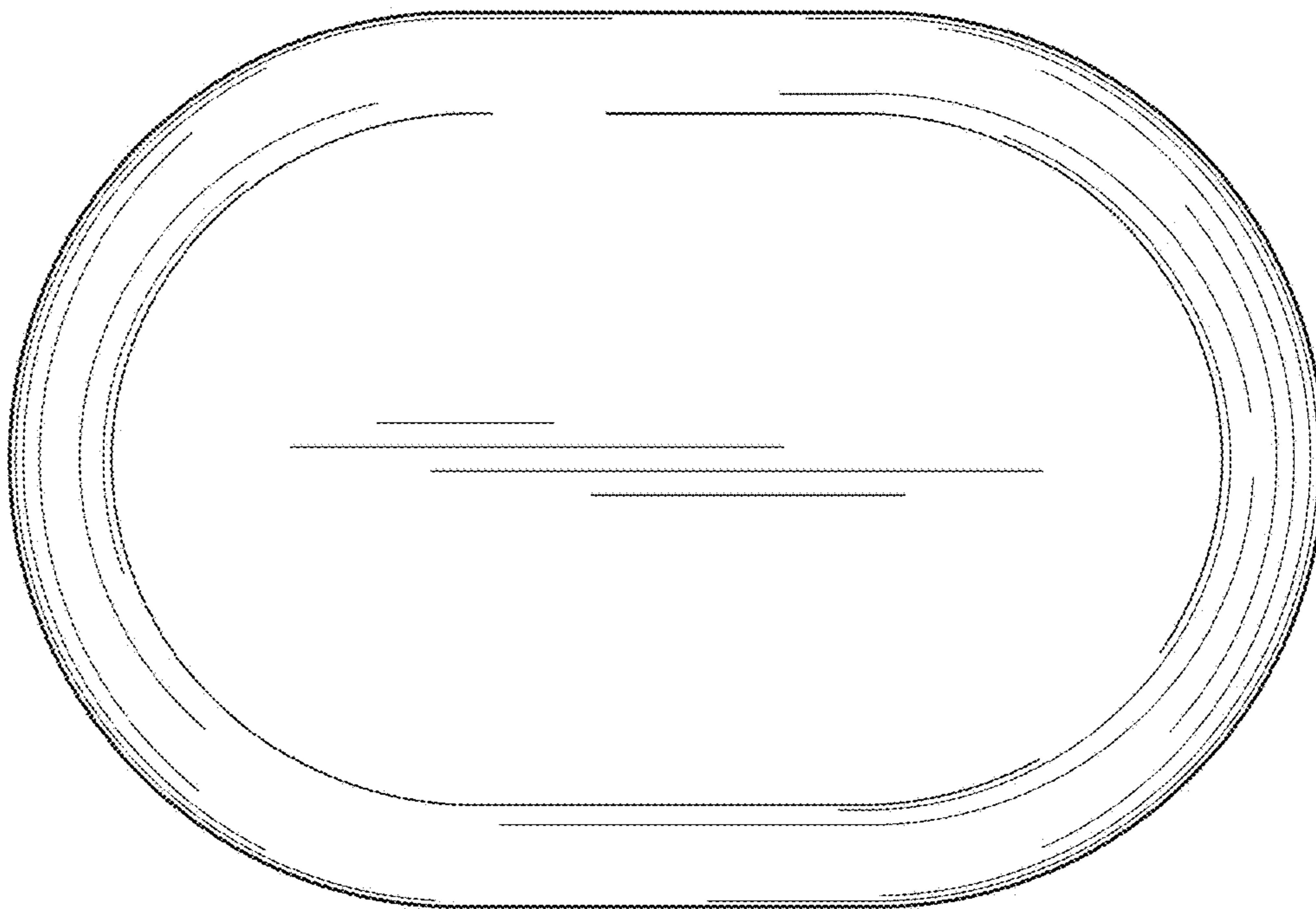

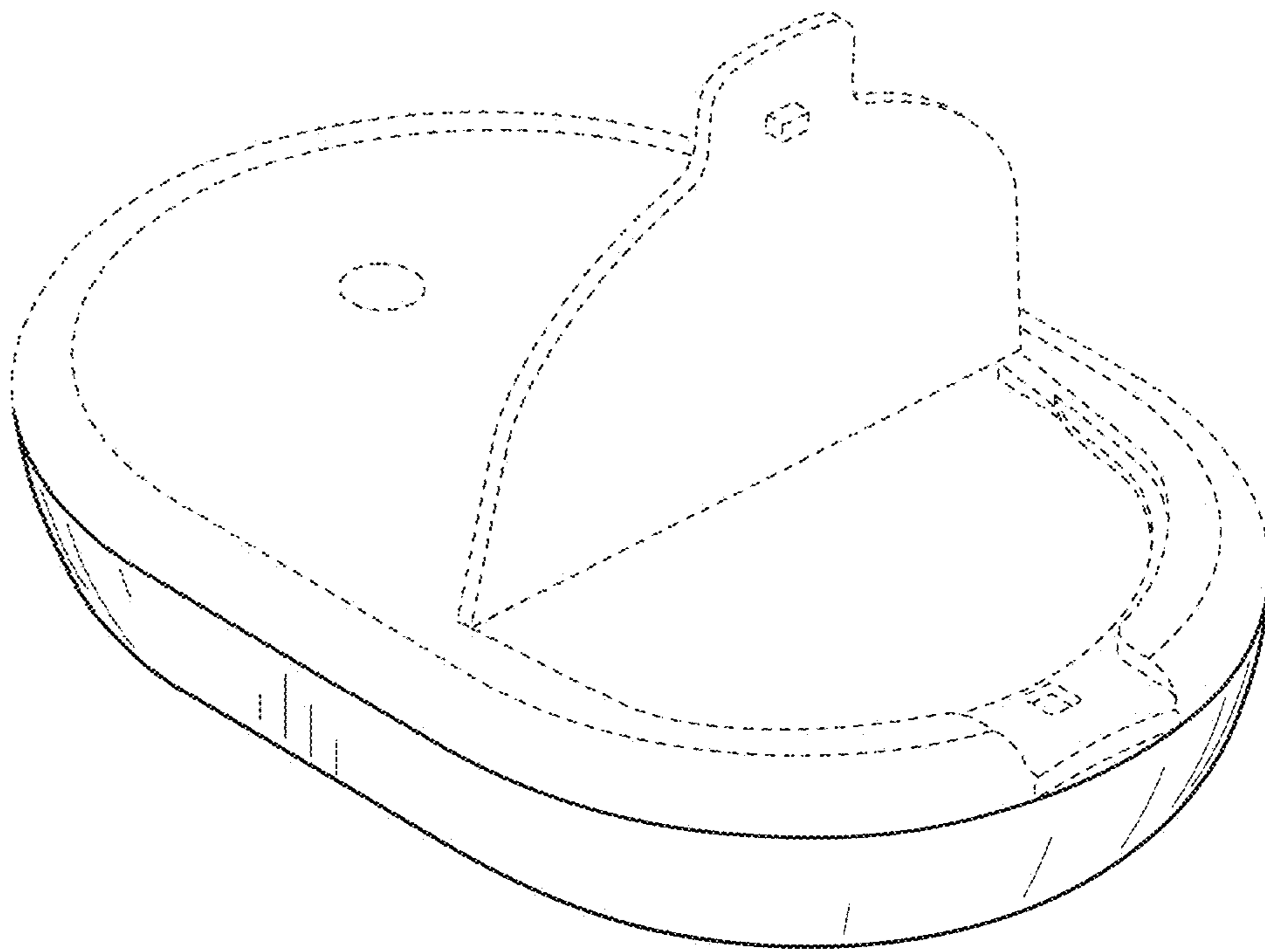

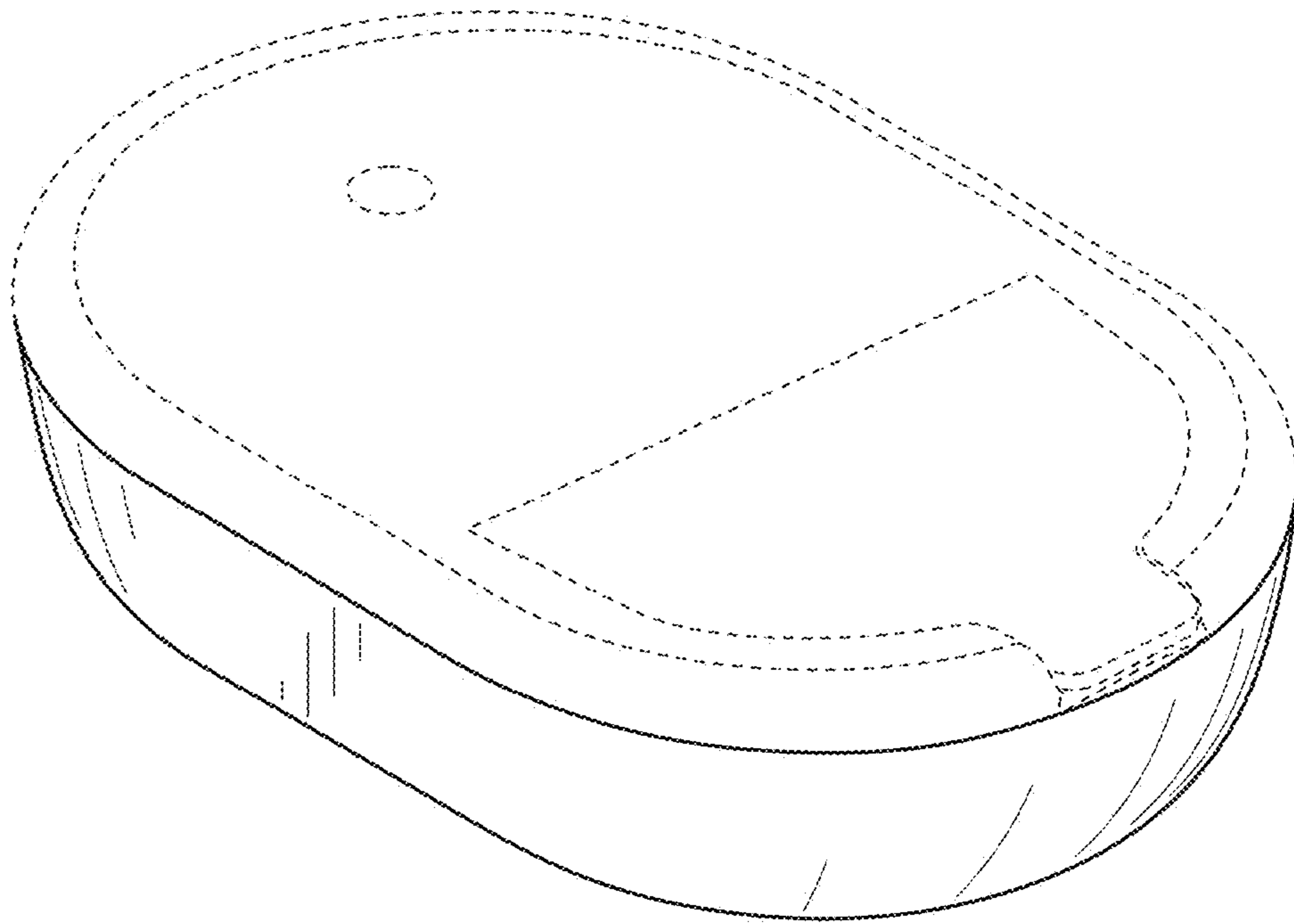

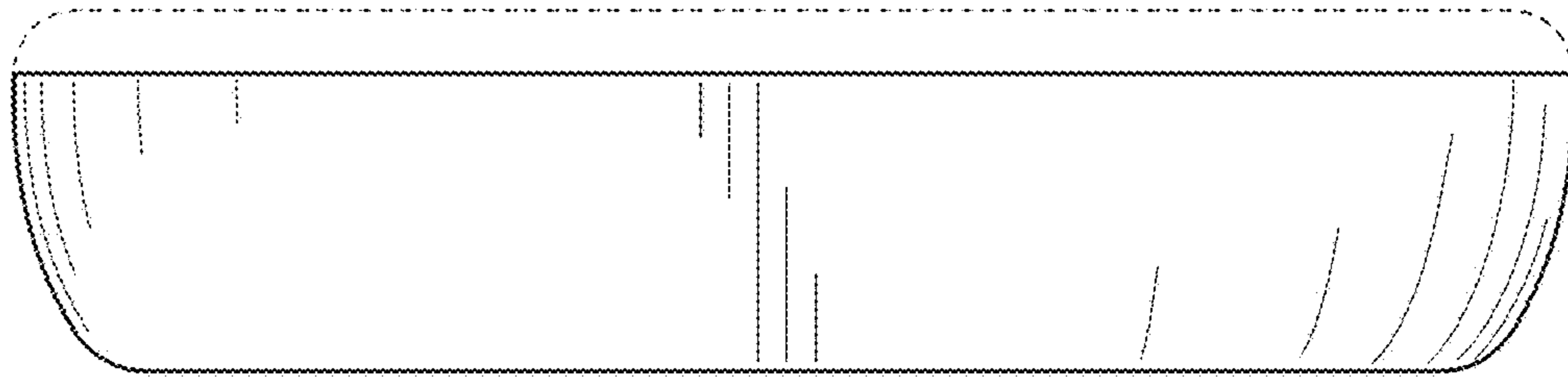

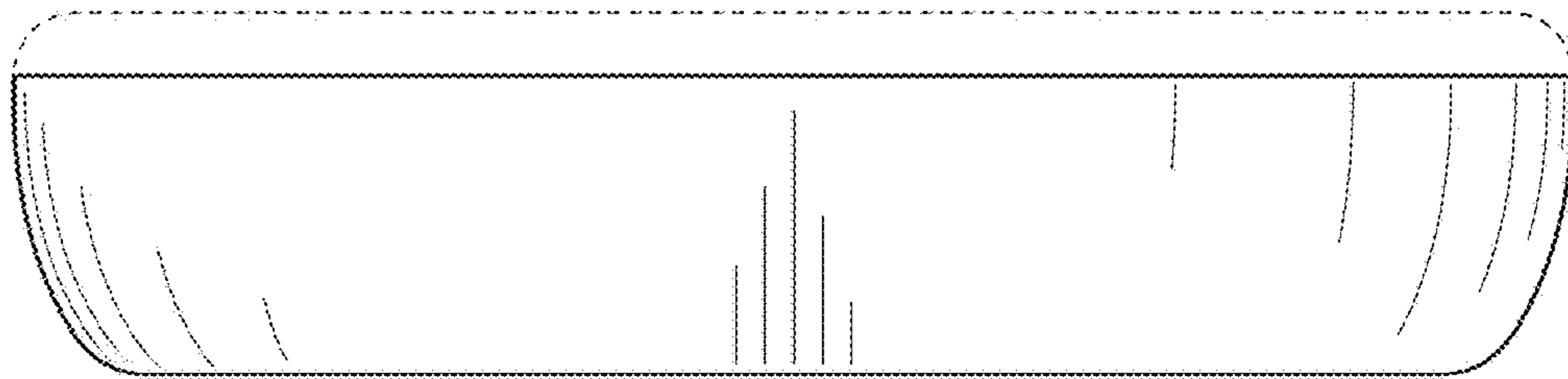

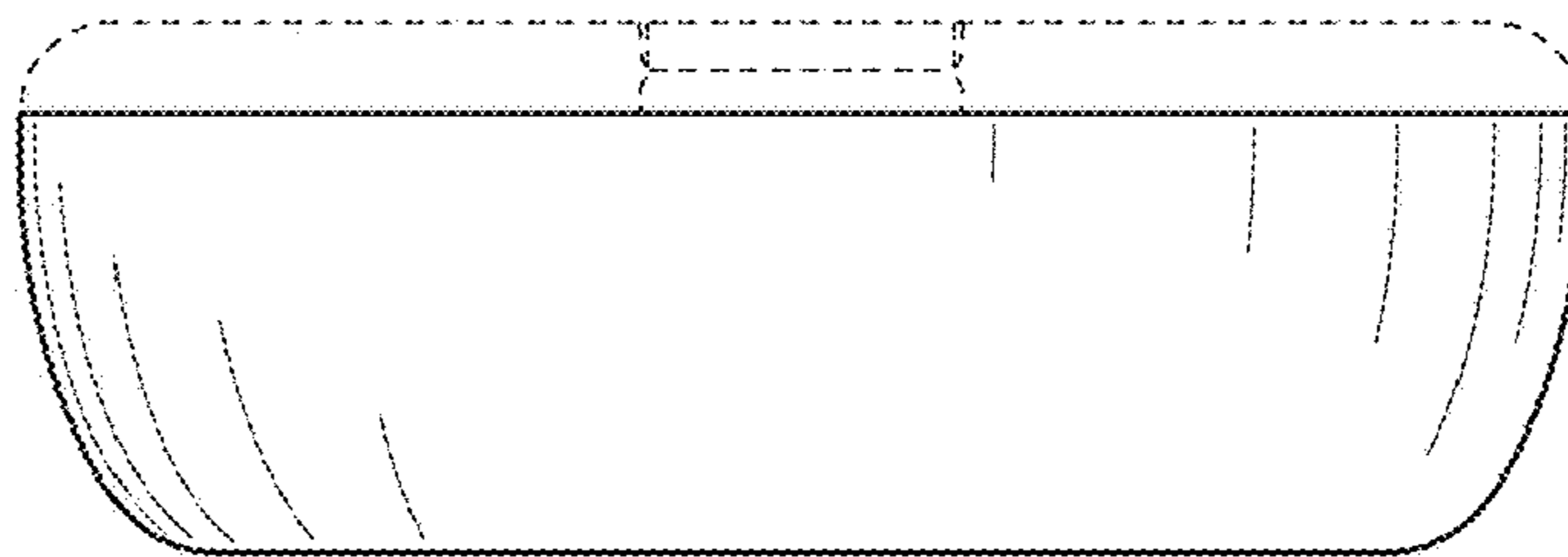

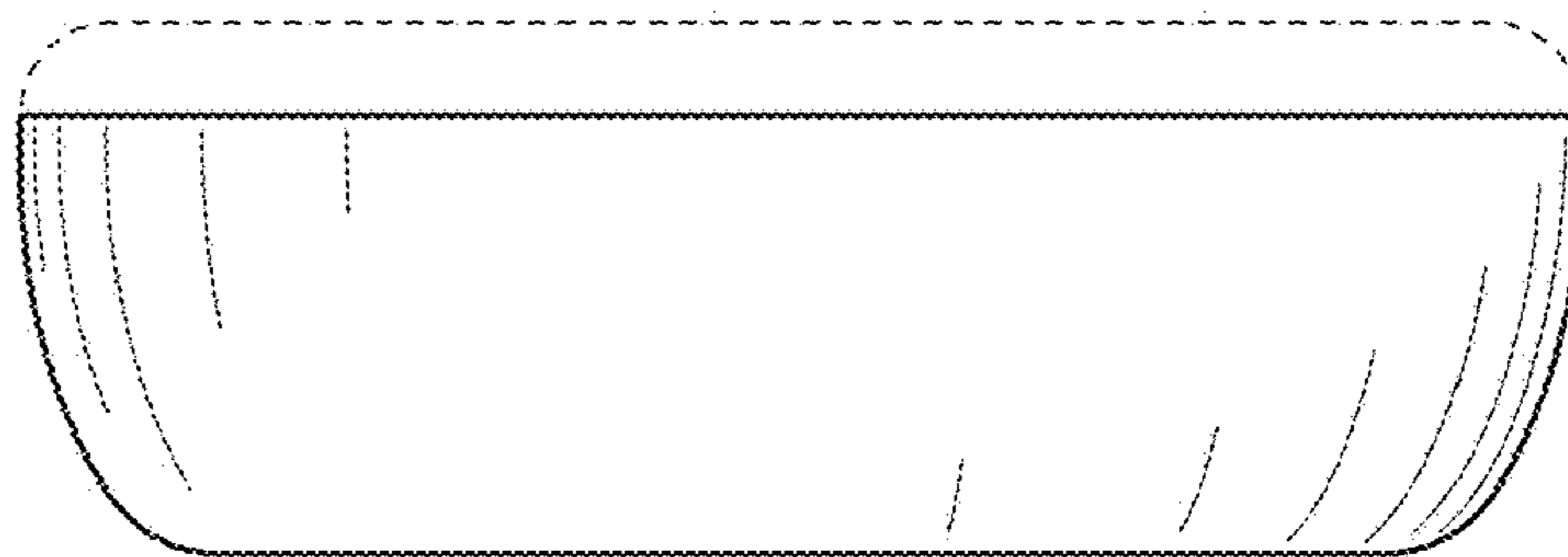

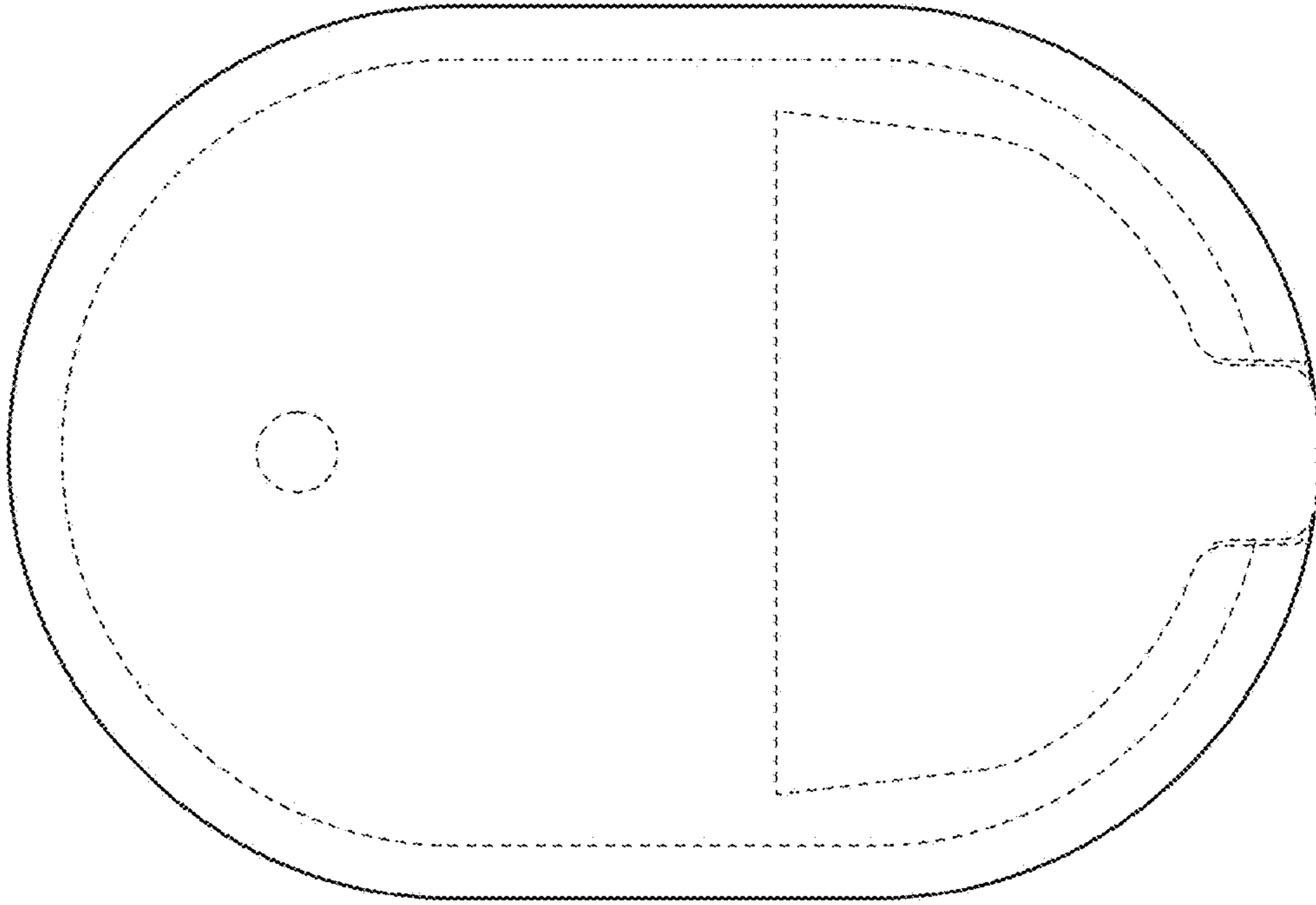

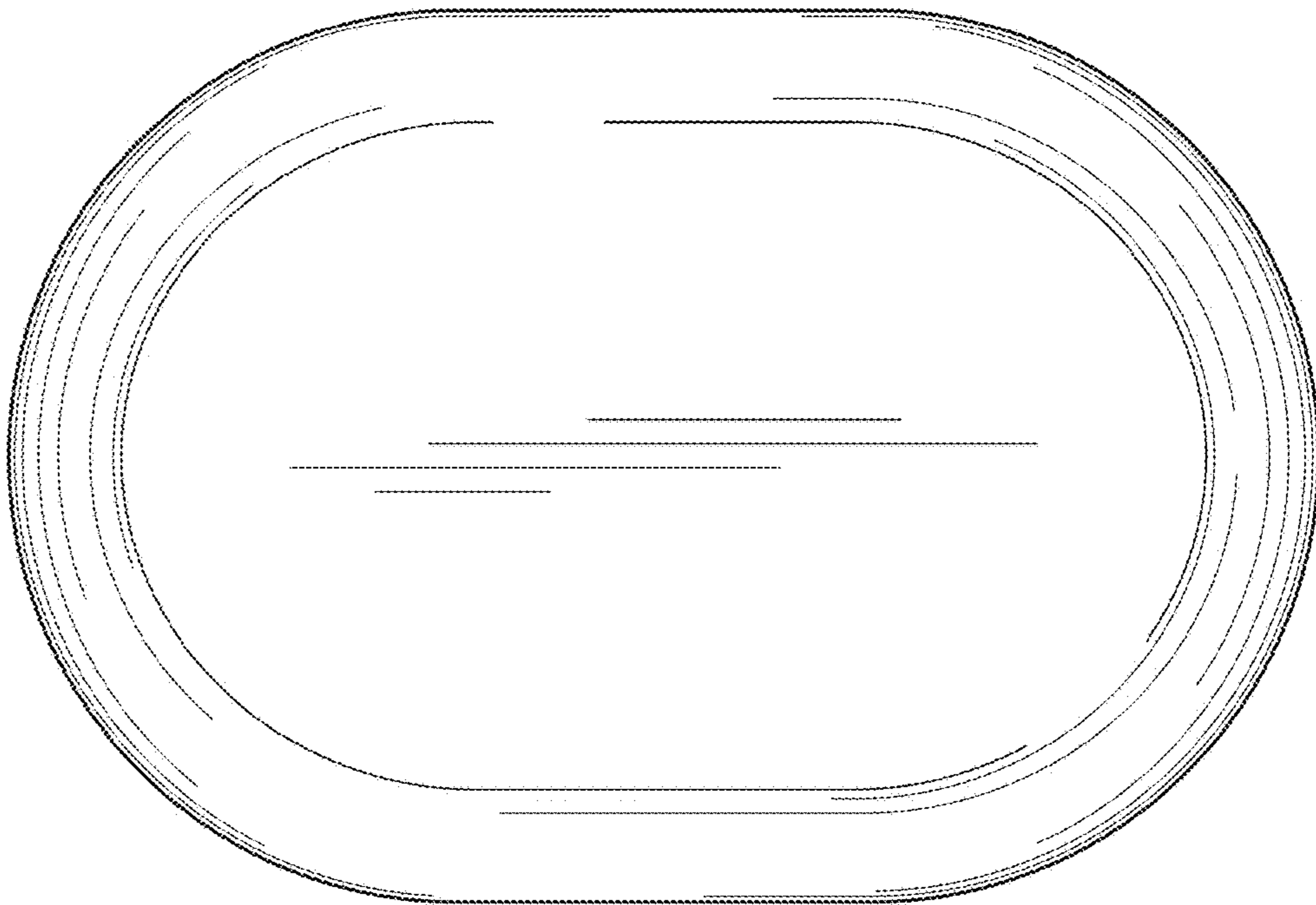

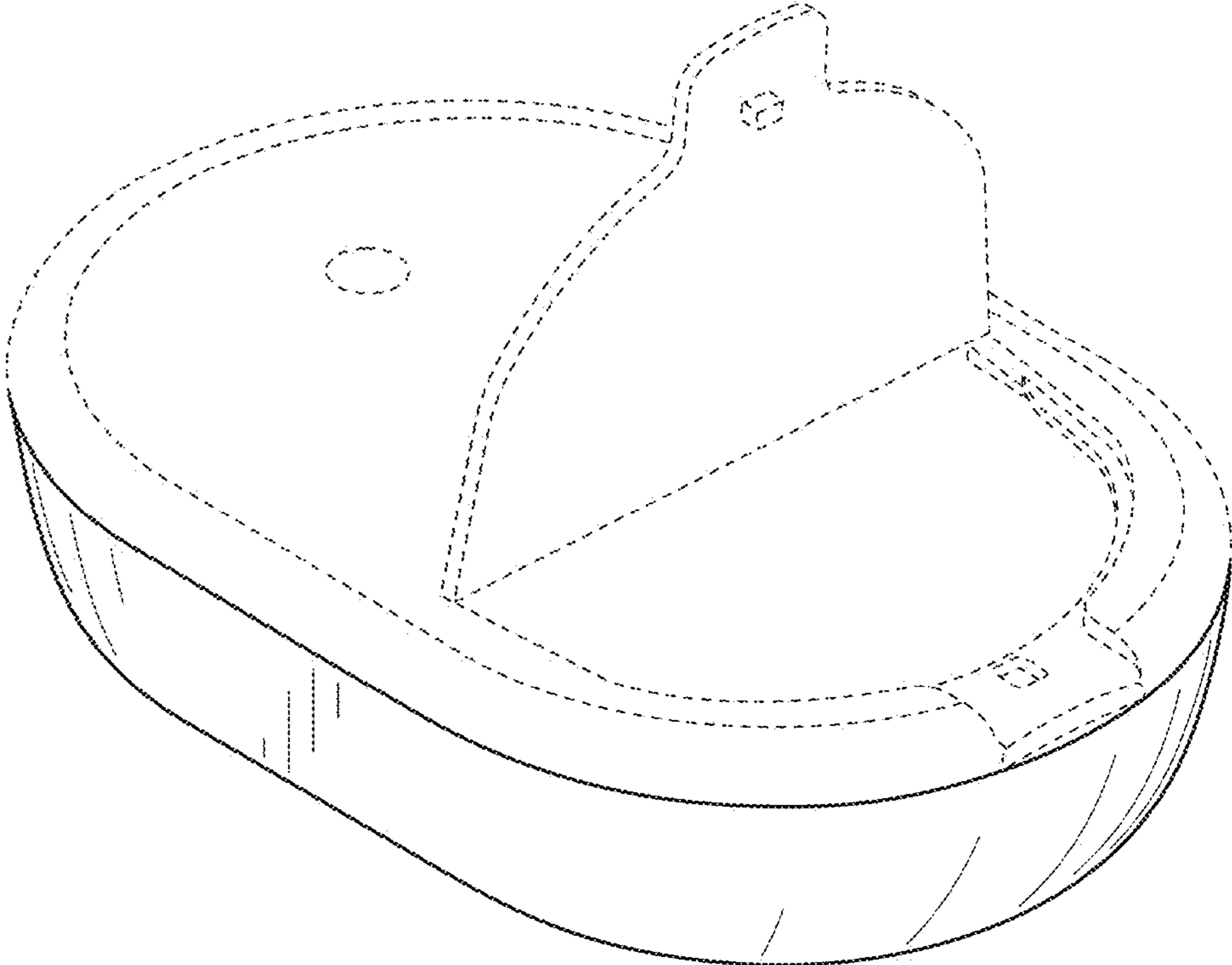
